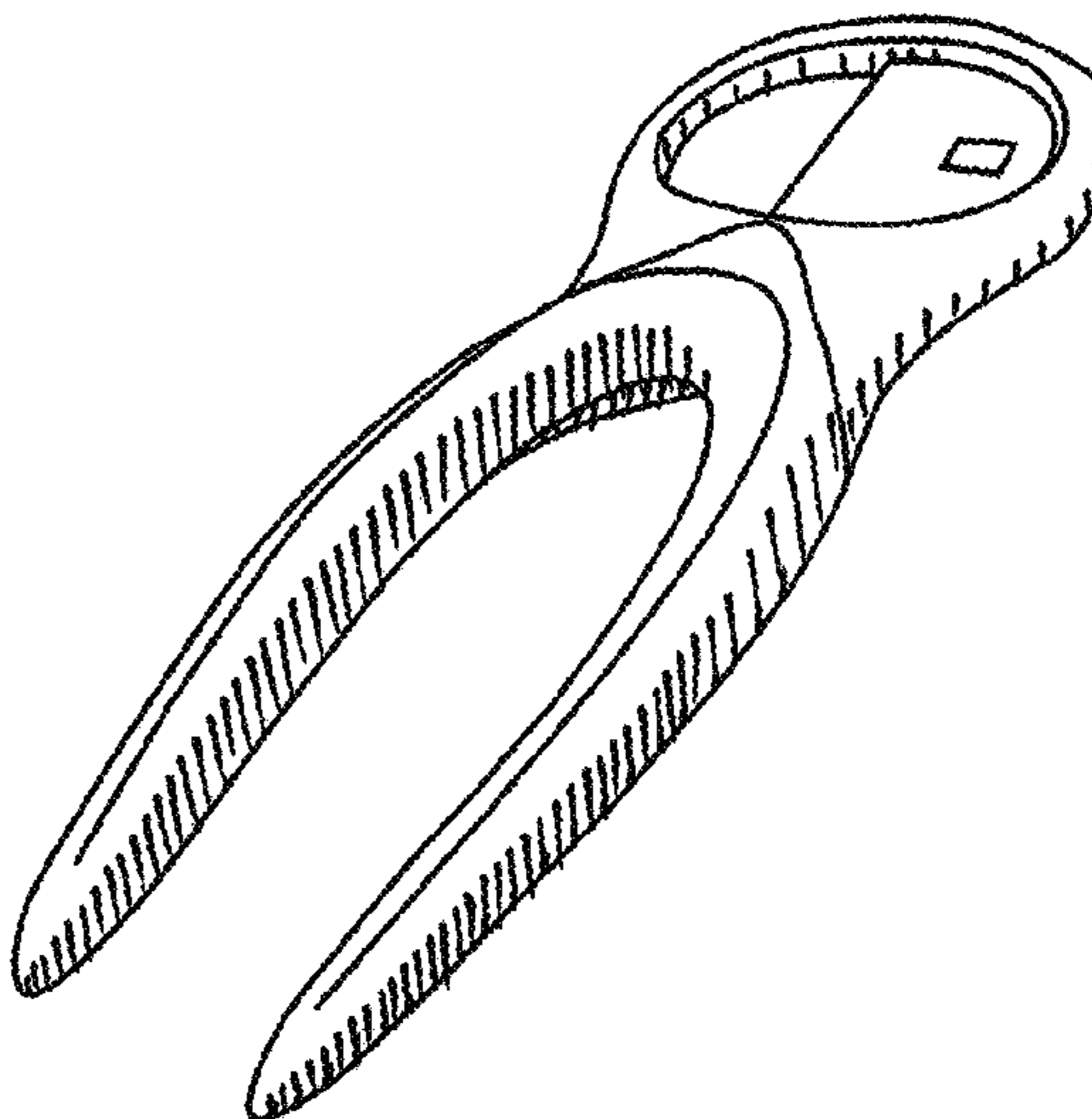
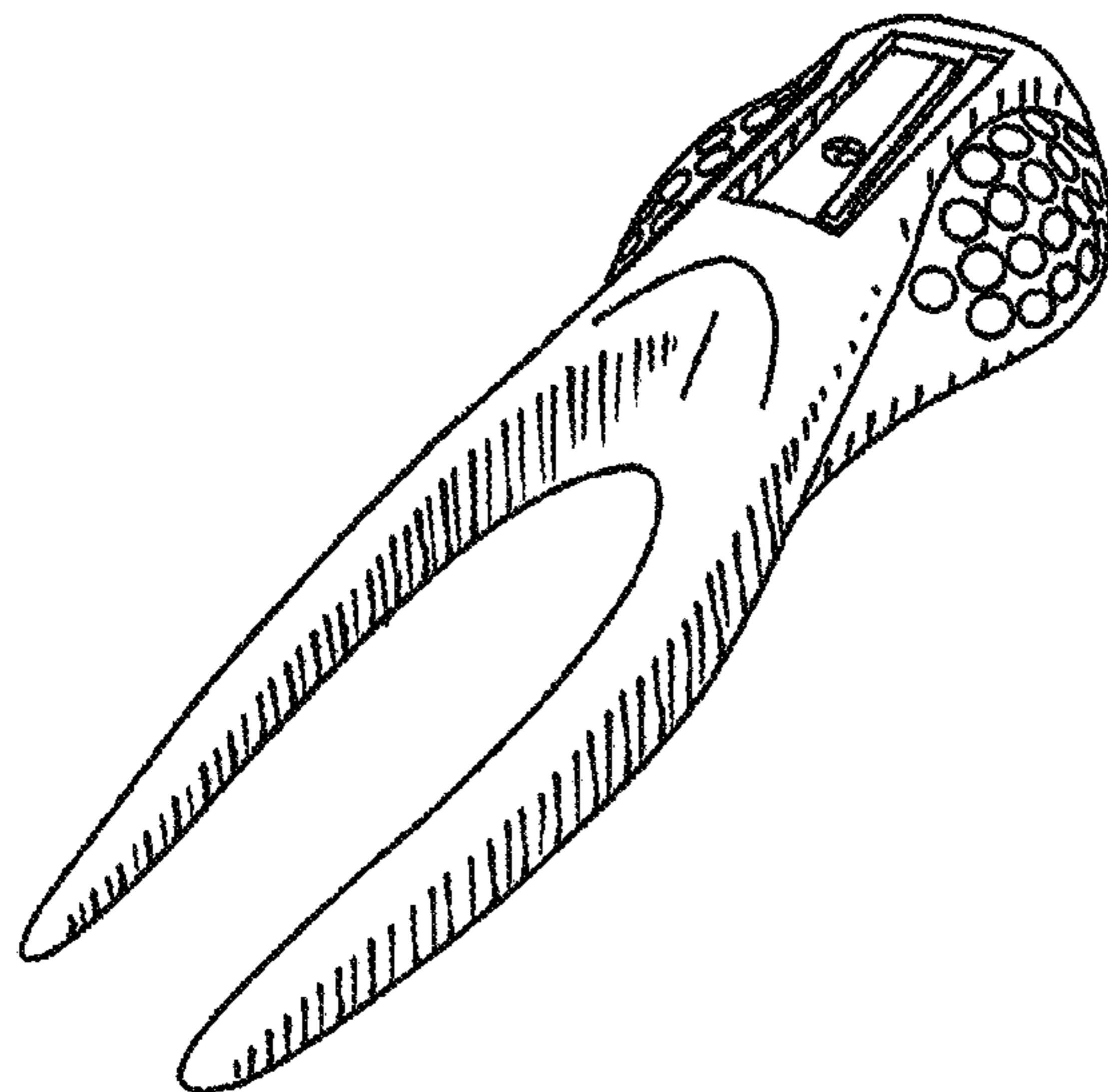
(57) **CLAIM**

The ornamental design for a divot repair tool, as shown and described.

DESCRIPTION

FIG. 1 is a first bottom perspective view of a first variant of a divot repair tool in accordance with the present design;
 FIG. 2 is a second bottom perspective view of the divot repair tool shown in FIG. 1;
 FIG. 3 is a first top perspective view of a divot repair tool shown in FIG. 1 without the ball marker;
 FIG. 4 is a second top perspective view of the divot repair tool shown in FIG. 1;
 FIG. 5 is a first side view of the divot repair tool shown in FIG. 1;
 FIG. 6 is a second side view of the divot repair tool shown in FIG. 1;
 FIG. 7 is a bottom view of the divot repair tool shown in FIG. 1;

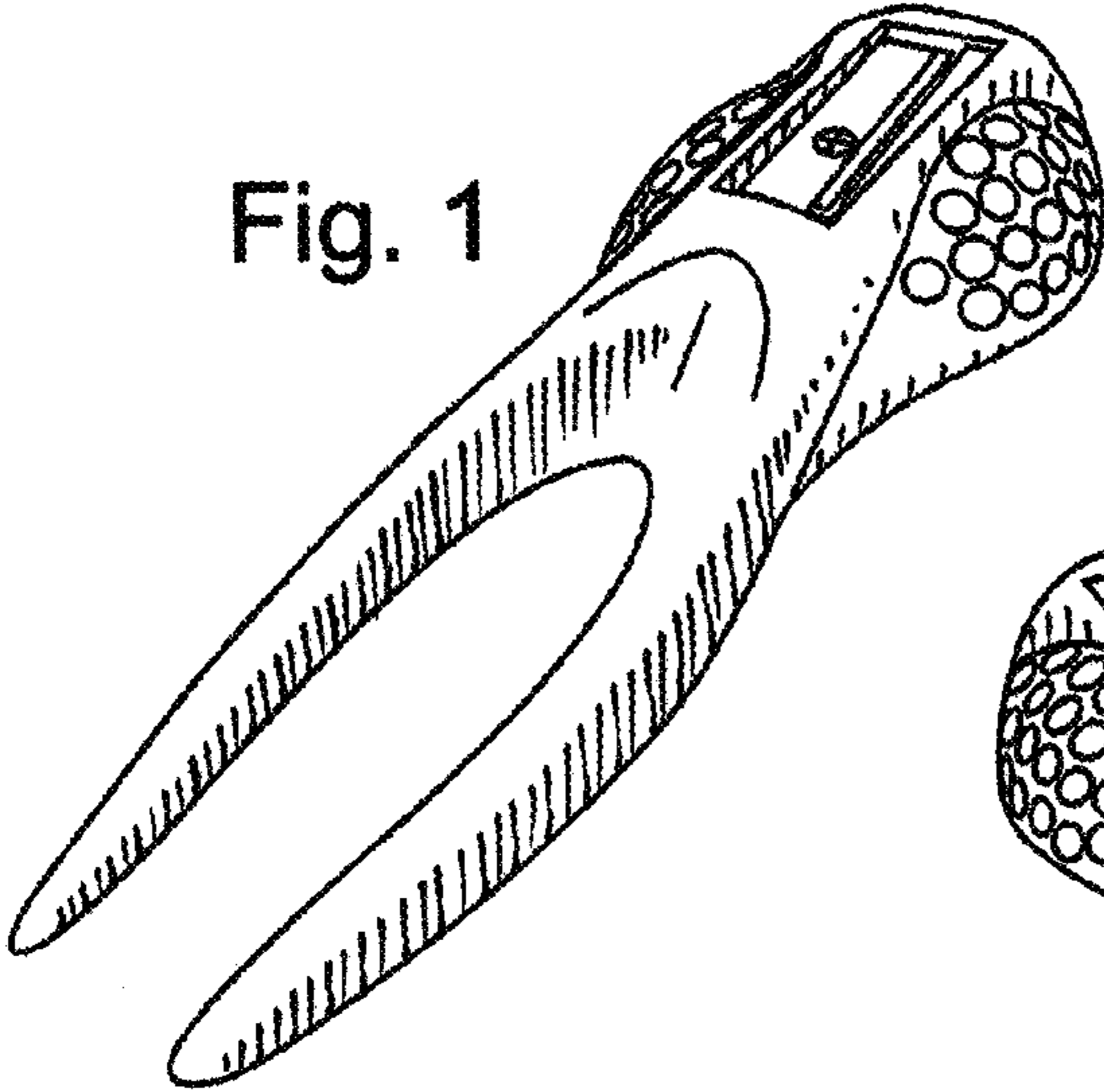

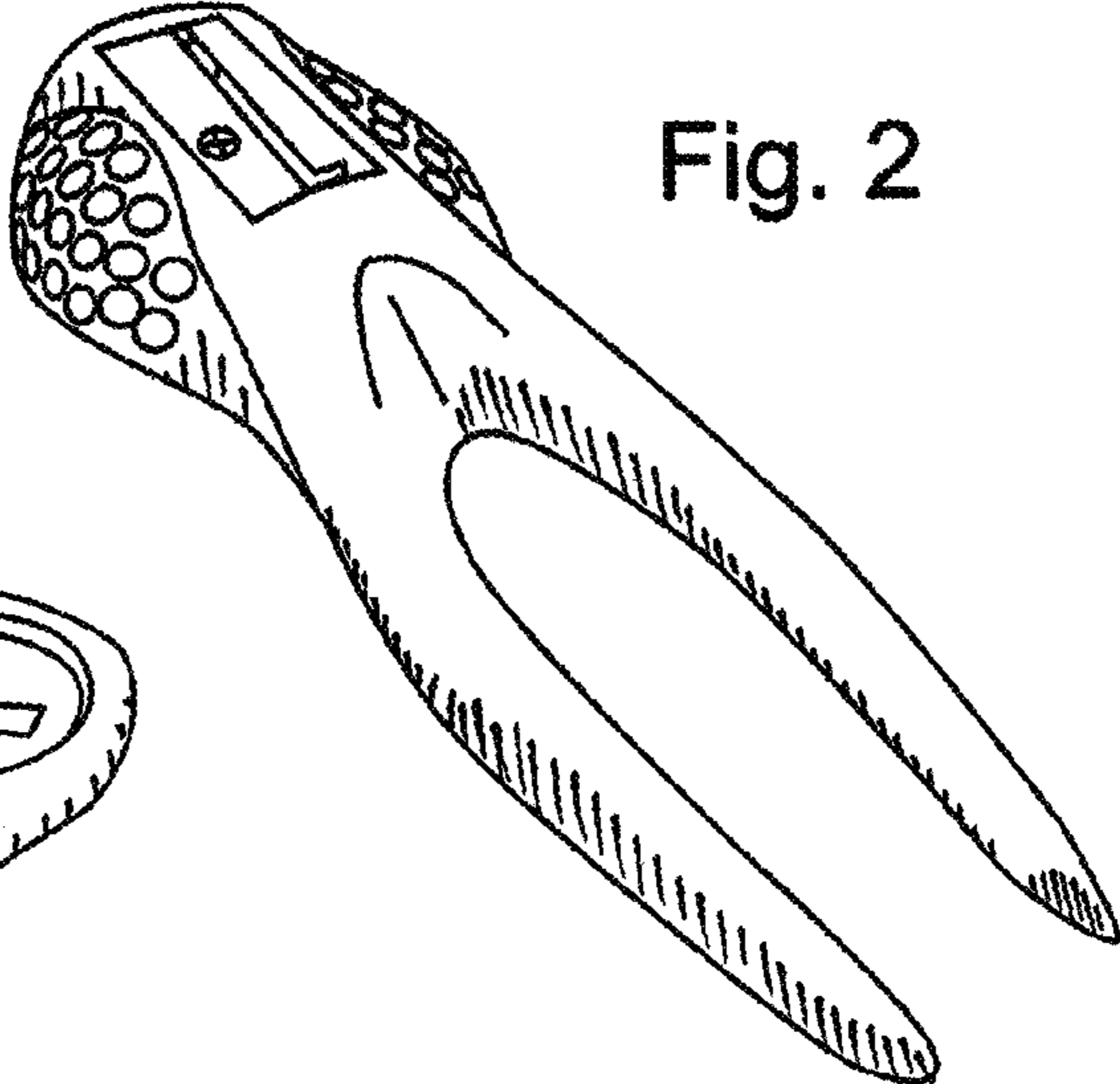

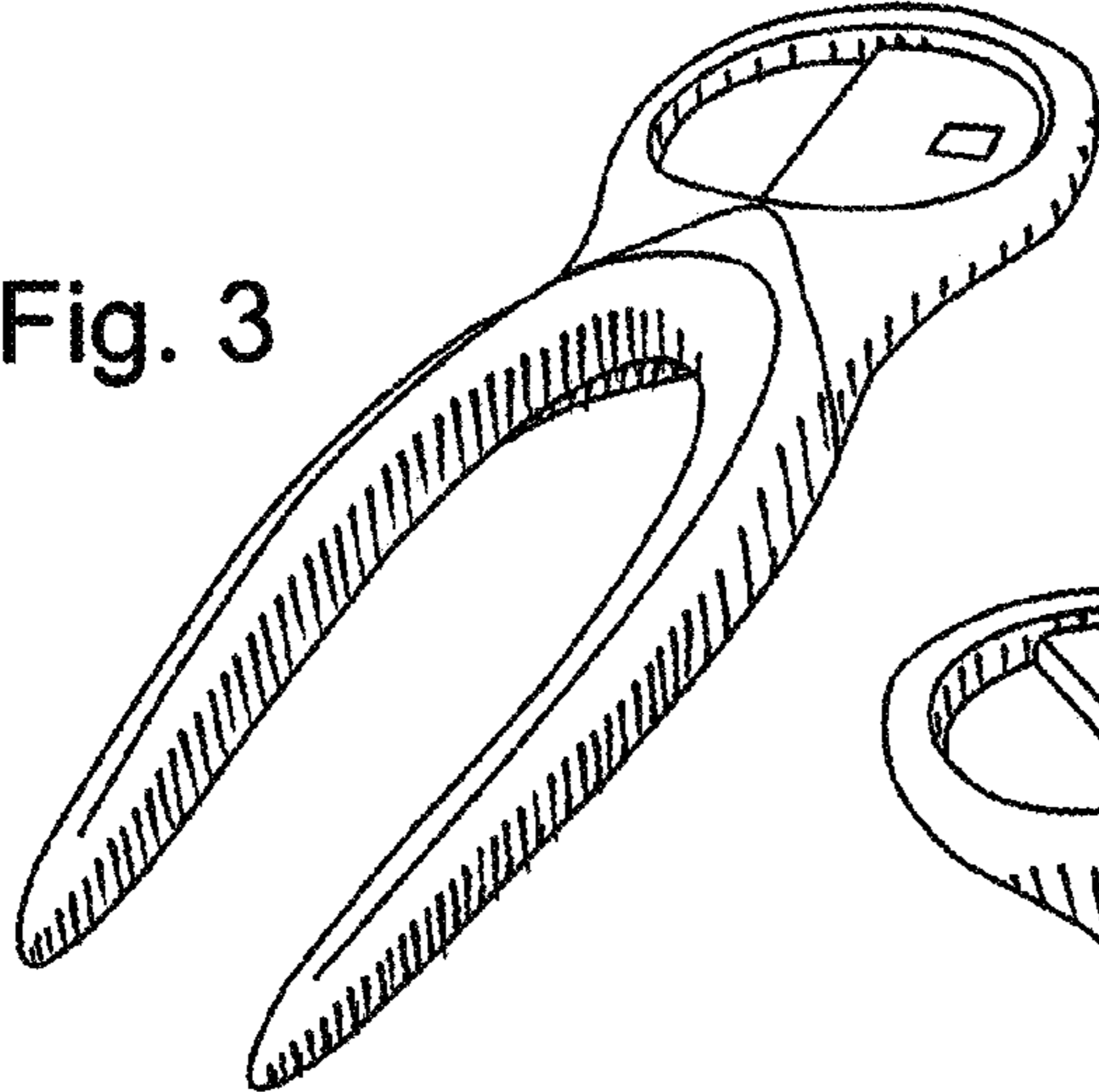

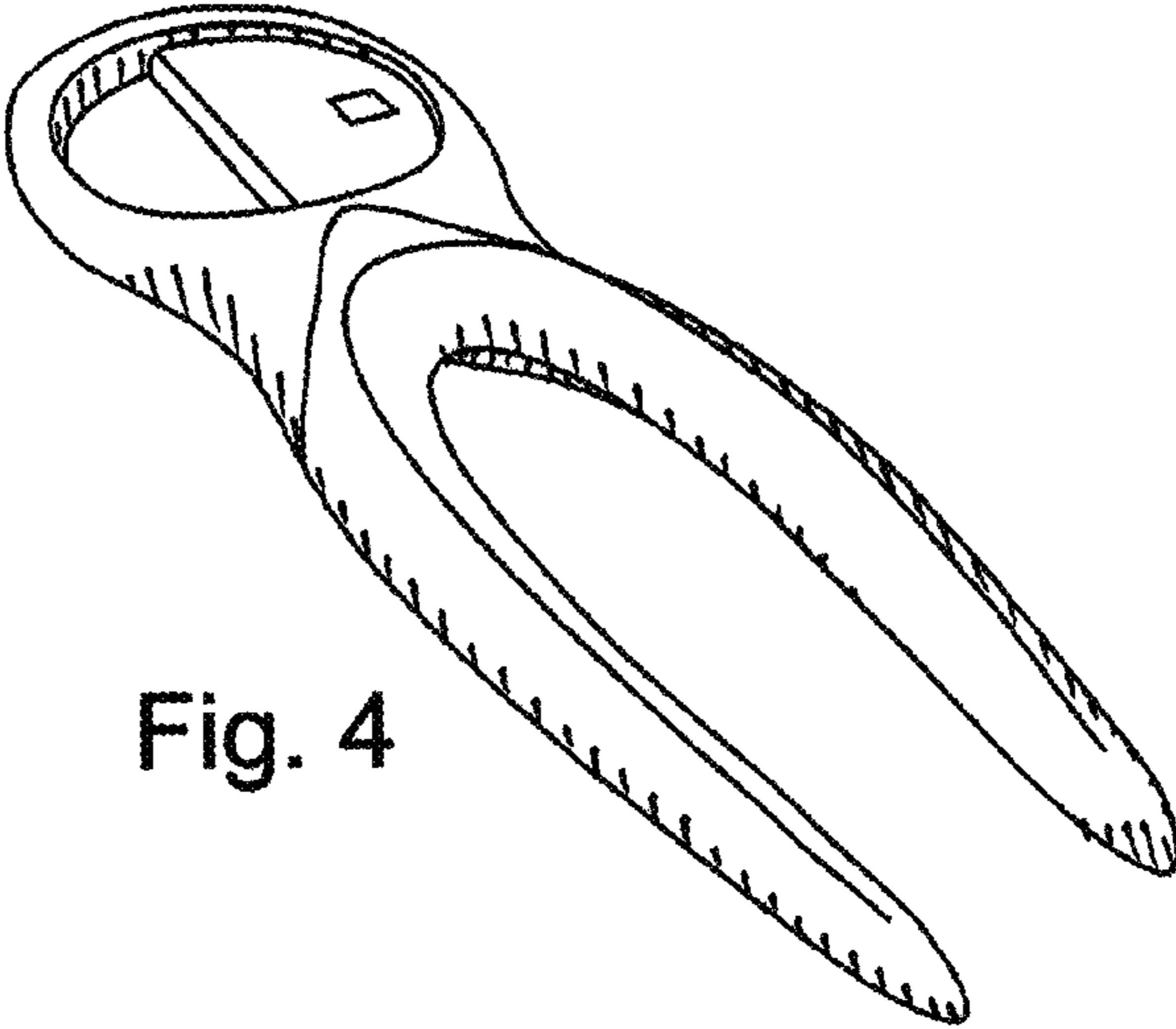

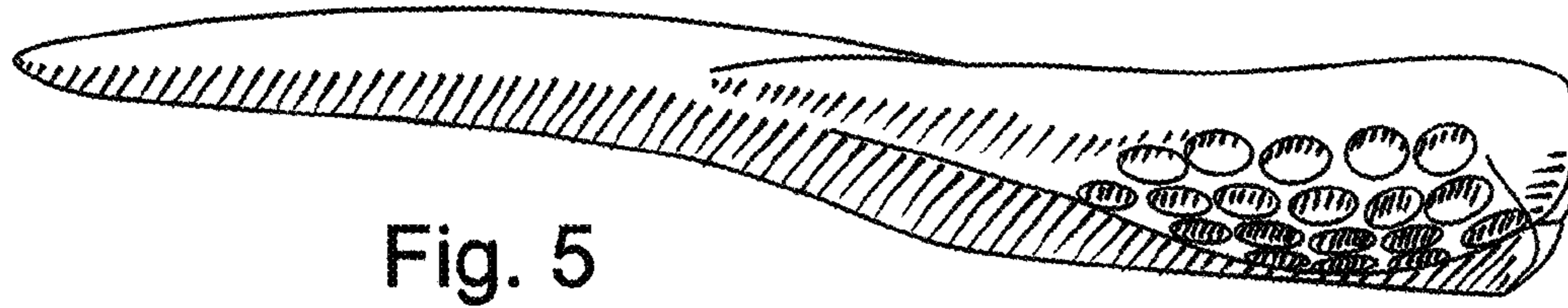

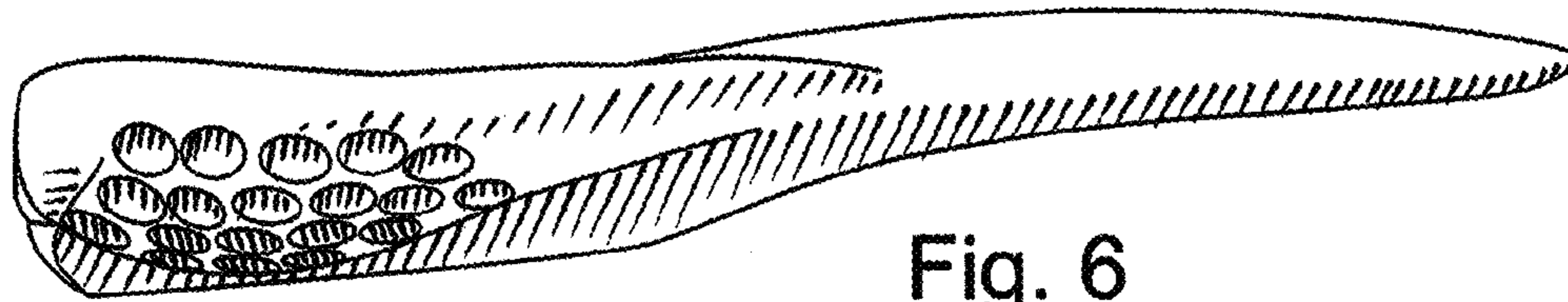

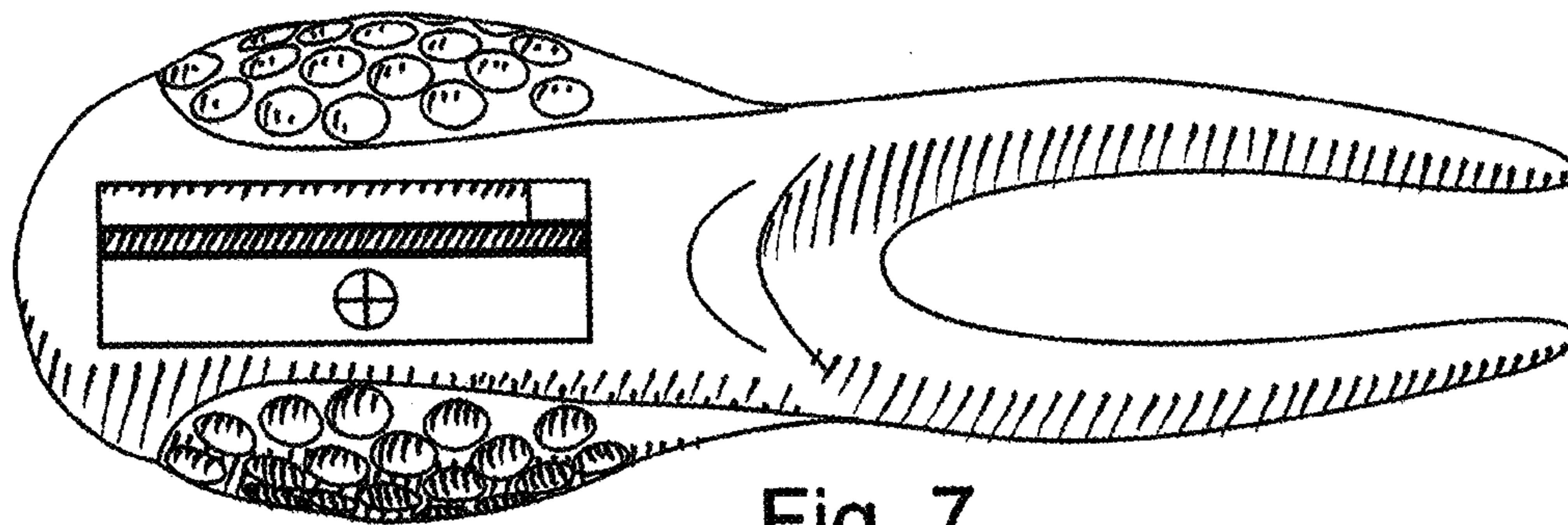

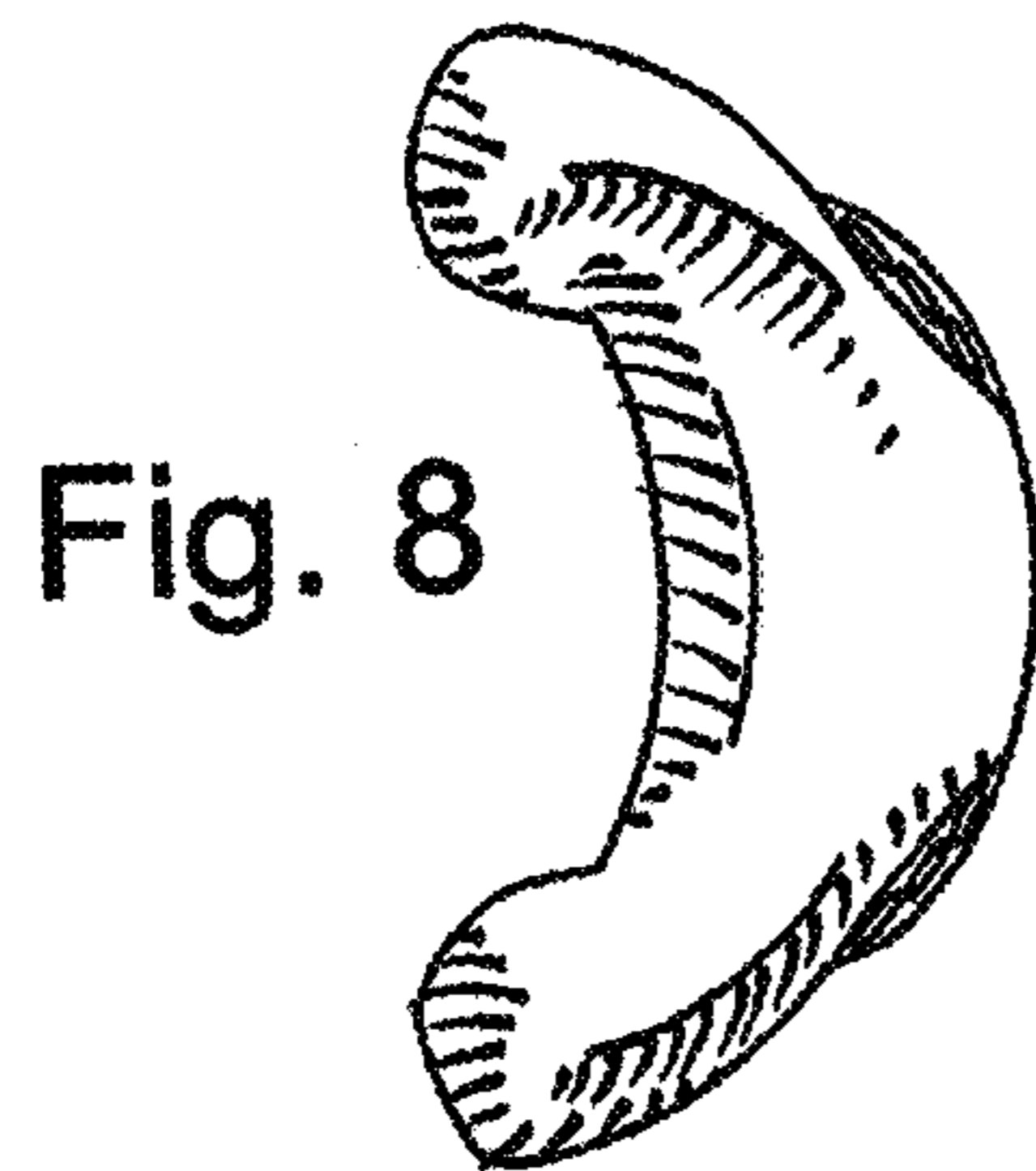

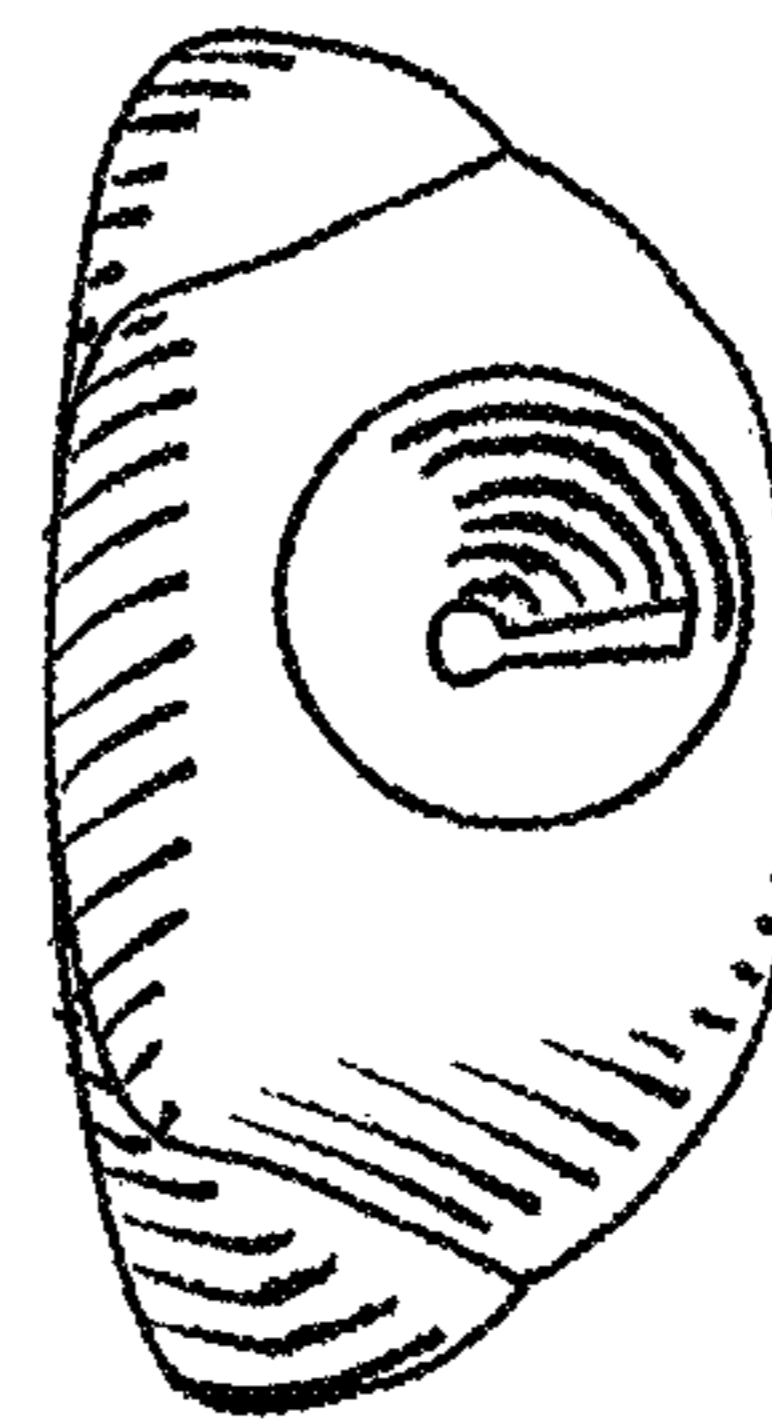

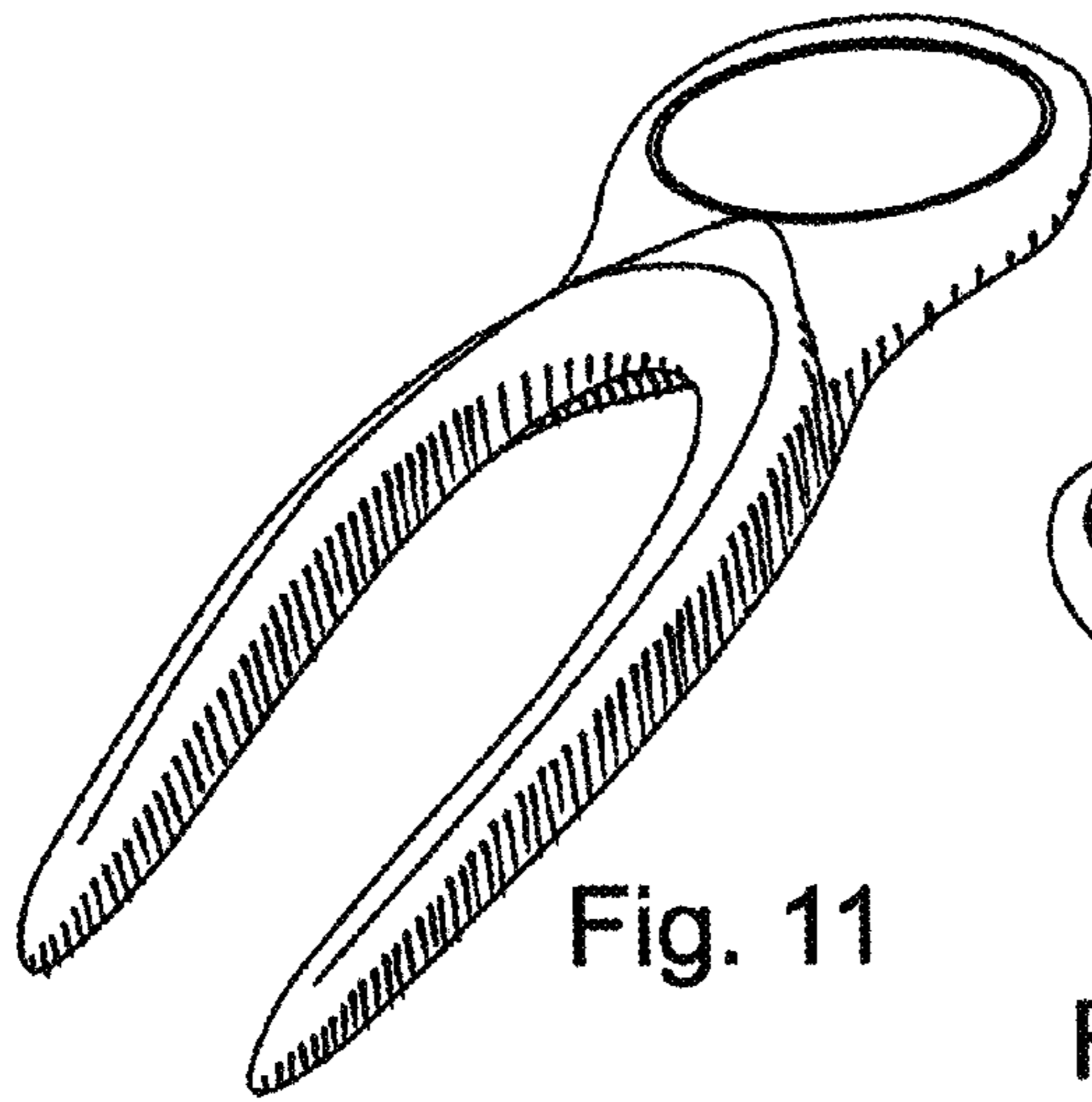
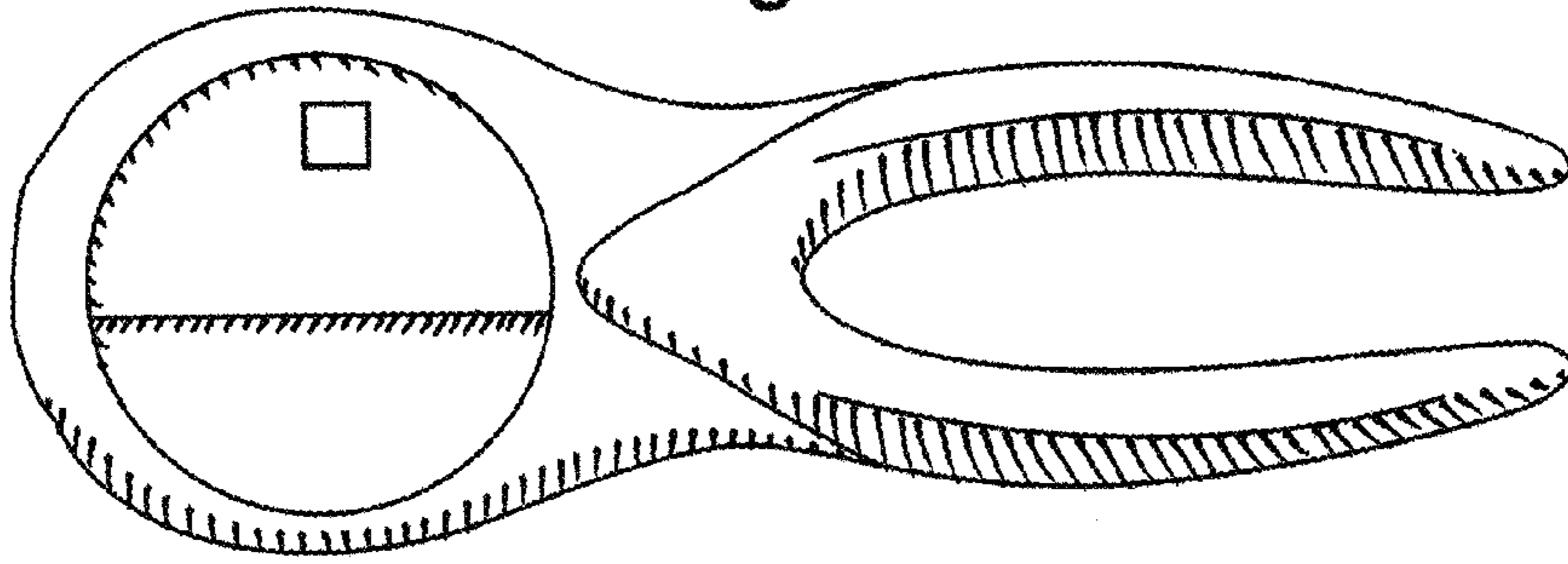

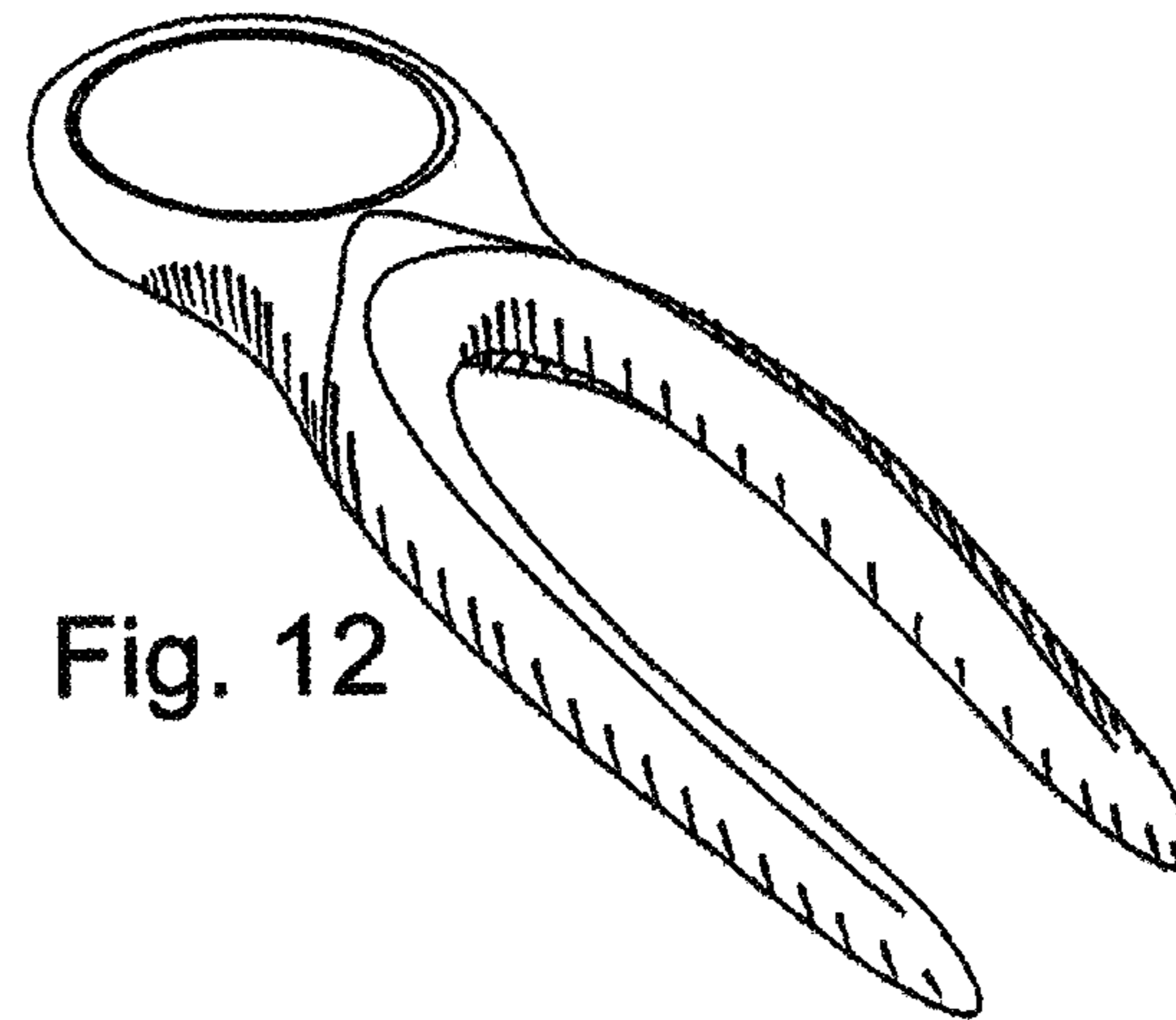

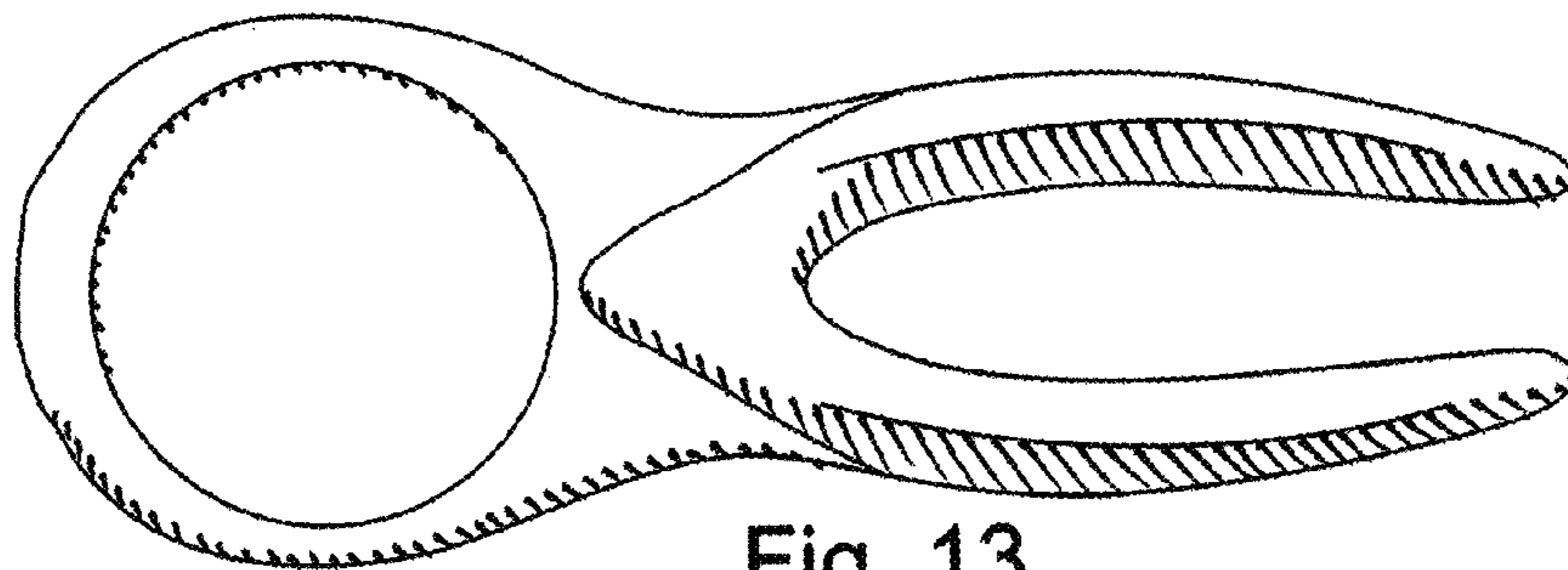
