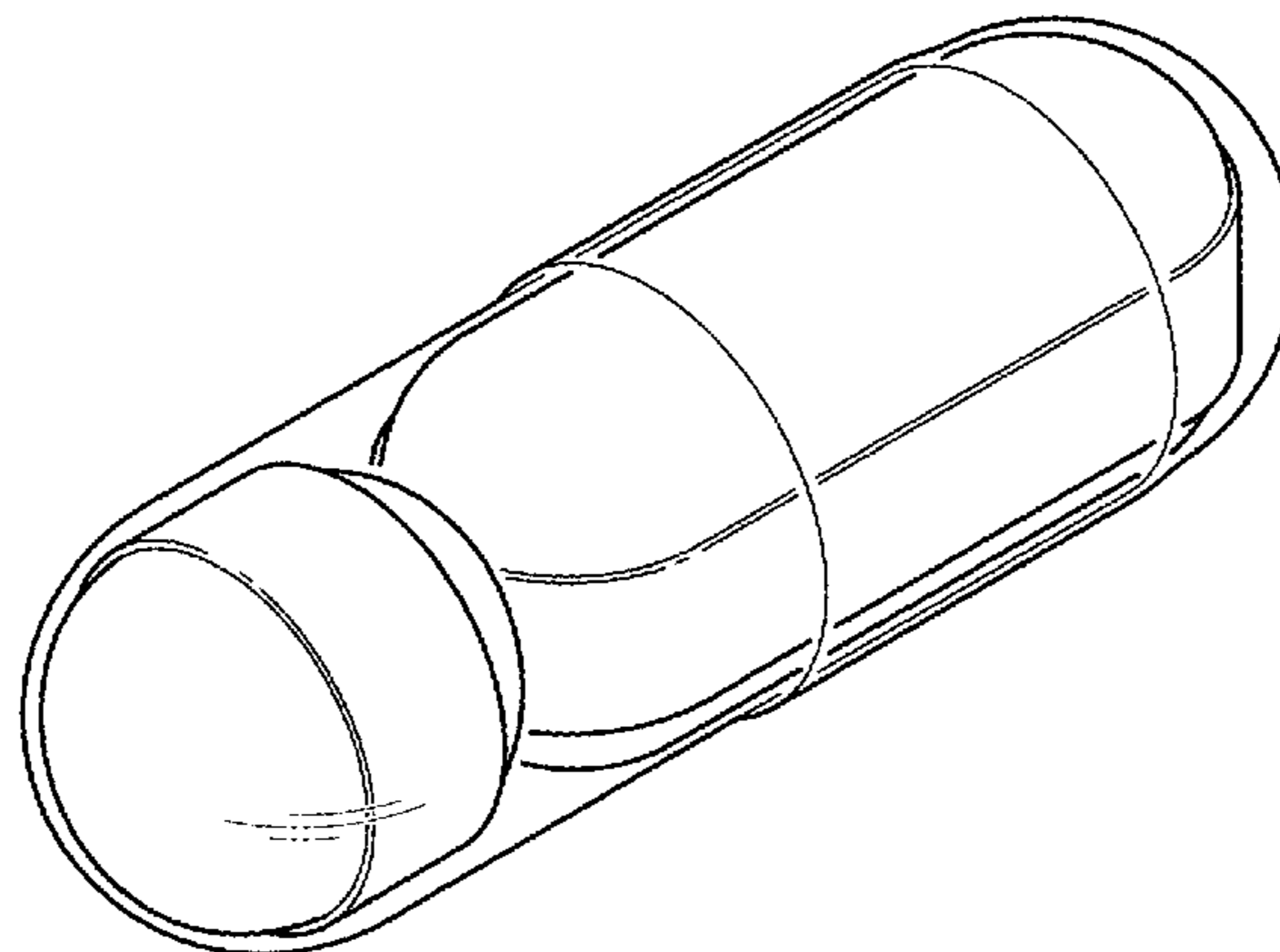
(57) **CLAIM**

The ornamental designs for two-tablet capsule, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a two-tablet capsule of the present invention;  
FIG. 2 is a top view of the capsule of FIG. 1, the bottom view being a mirror image thereof;  
FIG. 3 is a side view of the capsule of FIG. 1, the other side view being a mirror image thereof;  
FIG. 4 is a front view of the capsule of FIG. 1;  
FIG. 5 is a back view of the capsule of FIG. 1;  
FIG. 6 is a perspective view of a second embodiment thereof;  
FIG. 7 is a top view of the capsule of FIG. 6, the bottom view being a mirror image thereof;  
FIG. 8 is a side view of the capsule of FIG. 6, the other side view being a mirror image thereof;  
FIG. 9 is a front view of the capsule of FIG. 6;  
FIG. 10 is a back view of the capsule of FIG. 6;  
FIG. 11 is a perspective view of a third embodiment thereof;  
FIG. 12 is top view of the capsule of FIG. 11, the bottom view being a mirror image thereof;  
FIG. 13 is a side view of the capsule of FIG. 11, the other side view being a mirror image thereof;  
FIG. 14 is a front view of the capsule of FIG. 11; and,  
FIG. 15 is a back view of the capsule of FIG. 11.

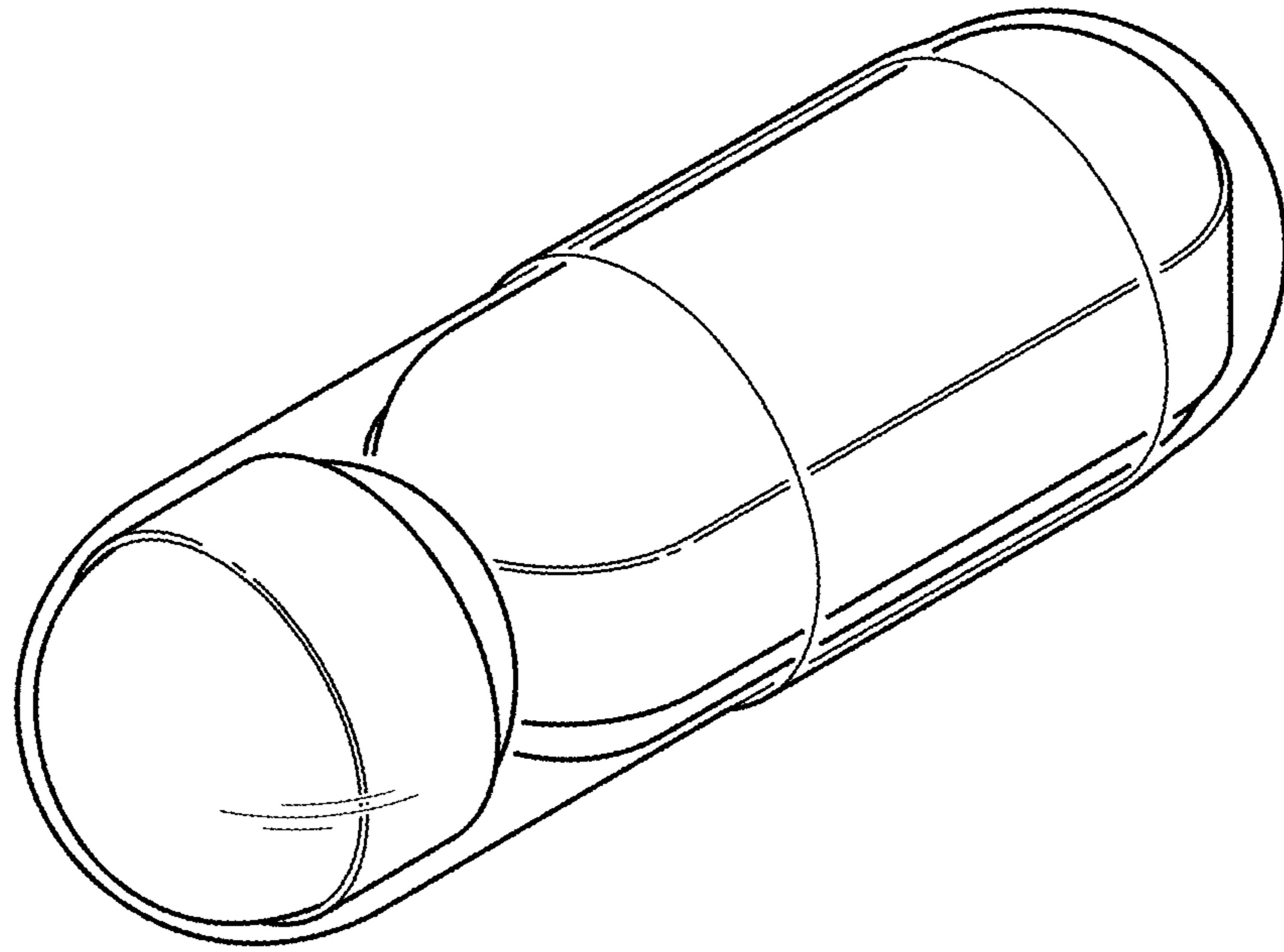

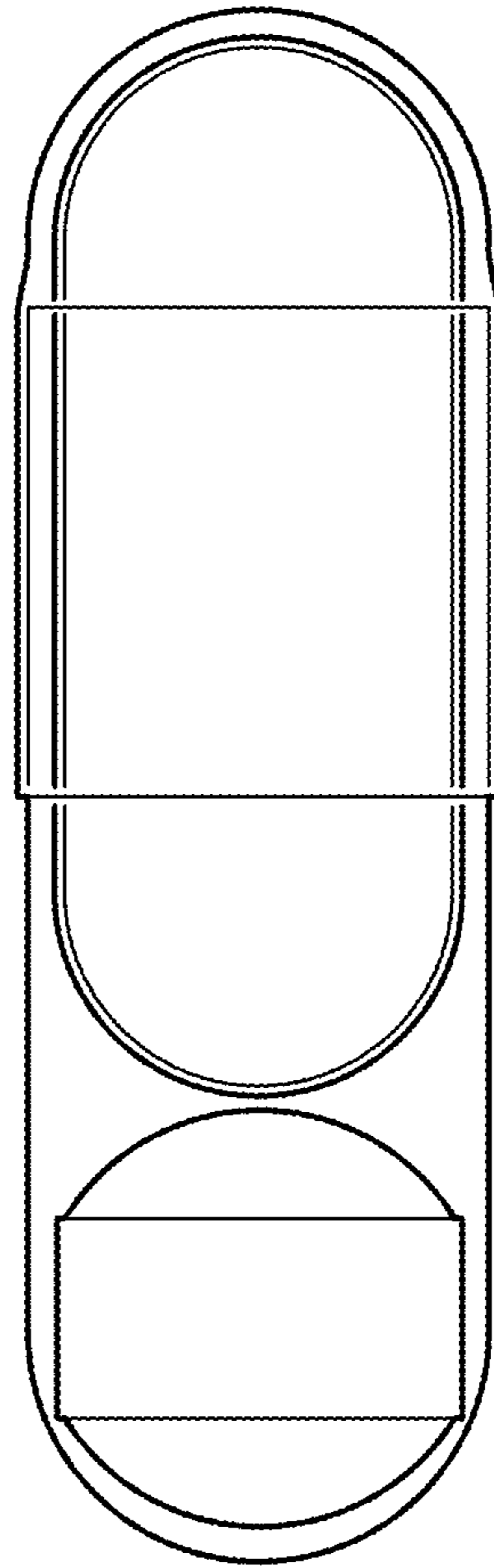

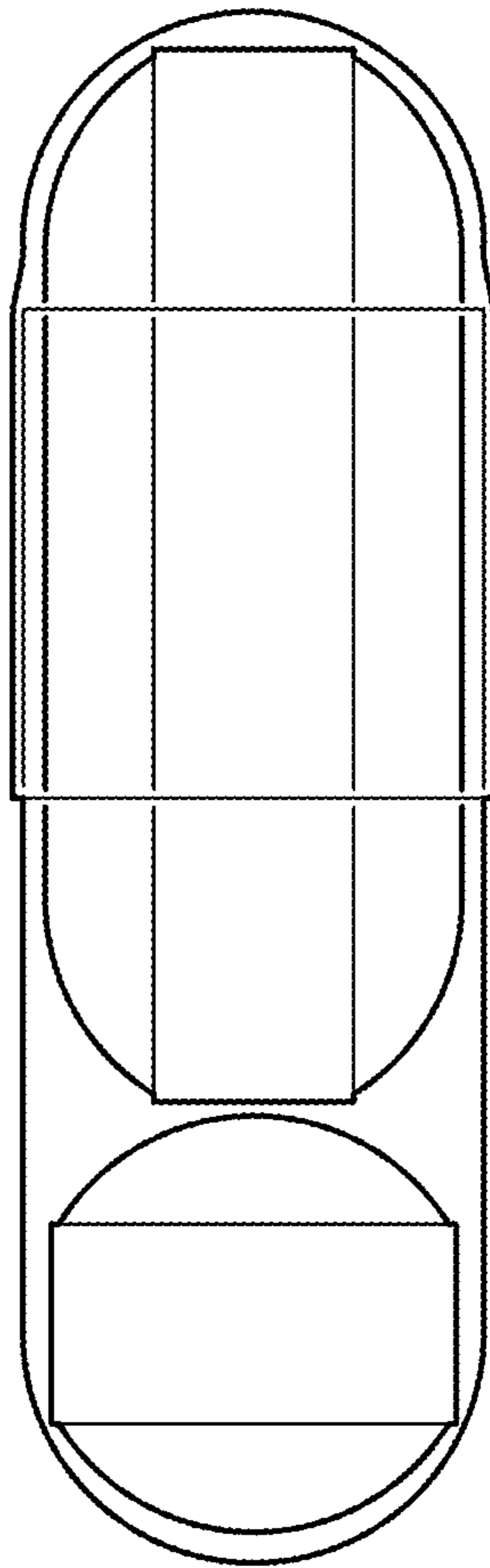

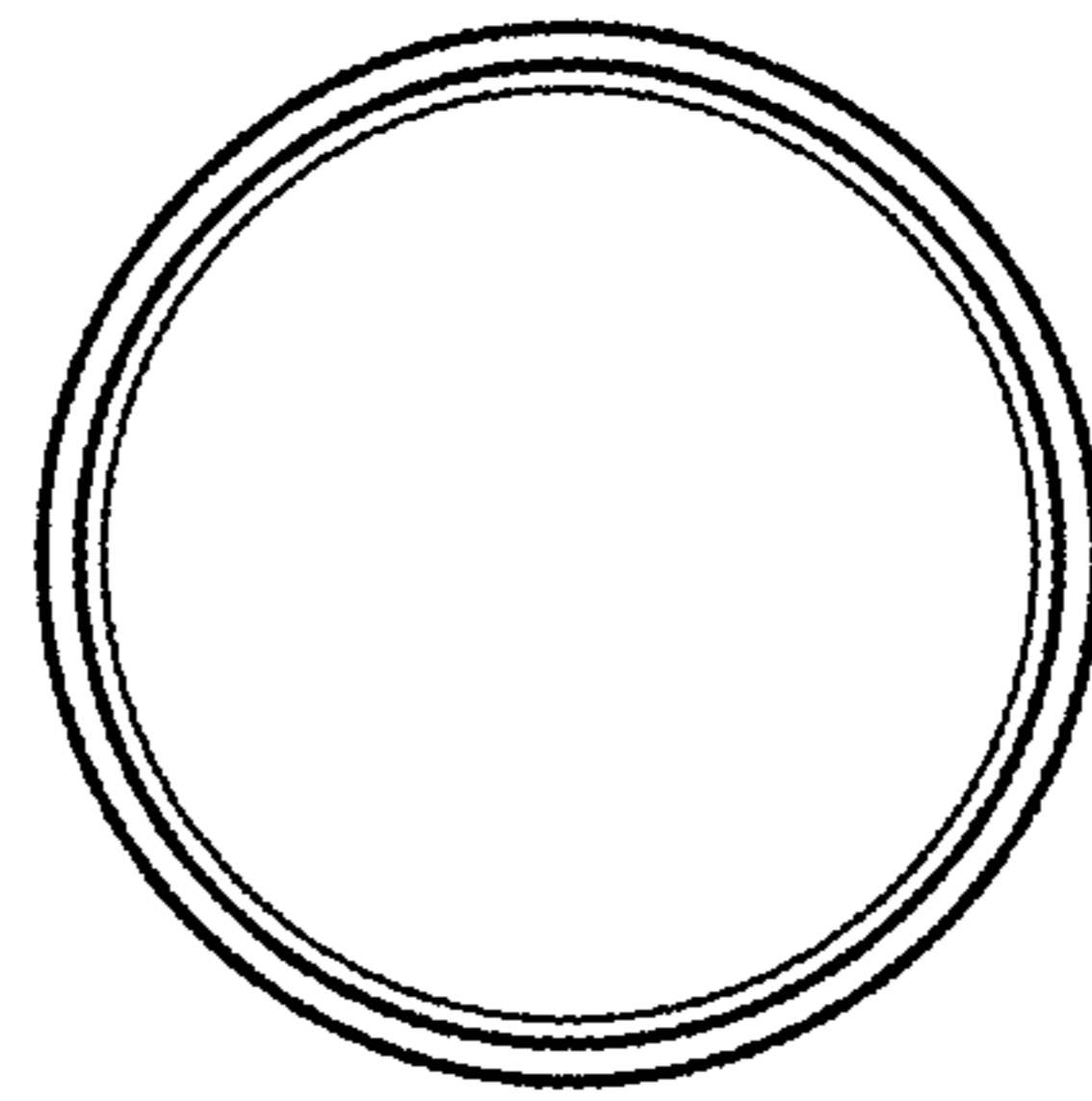

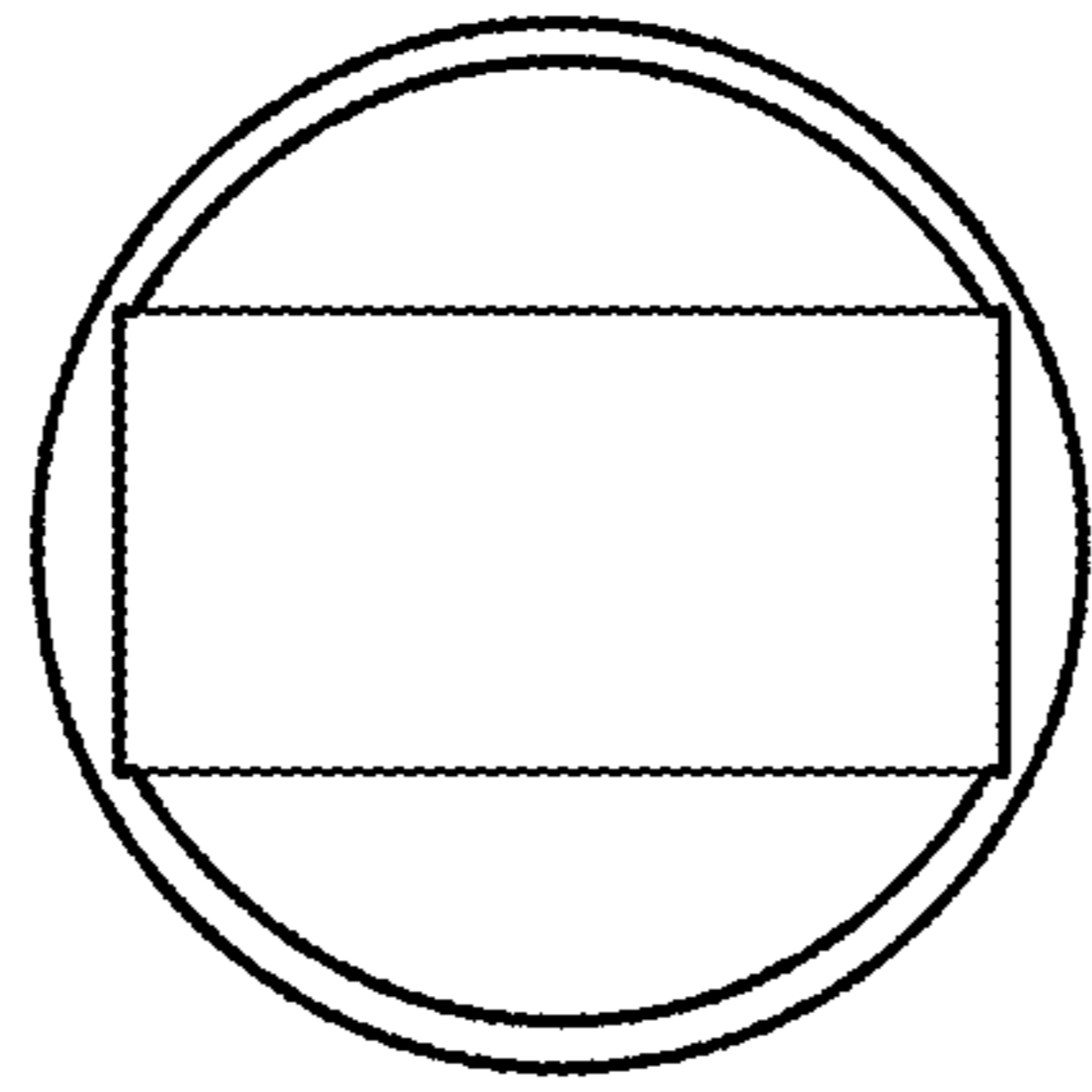

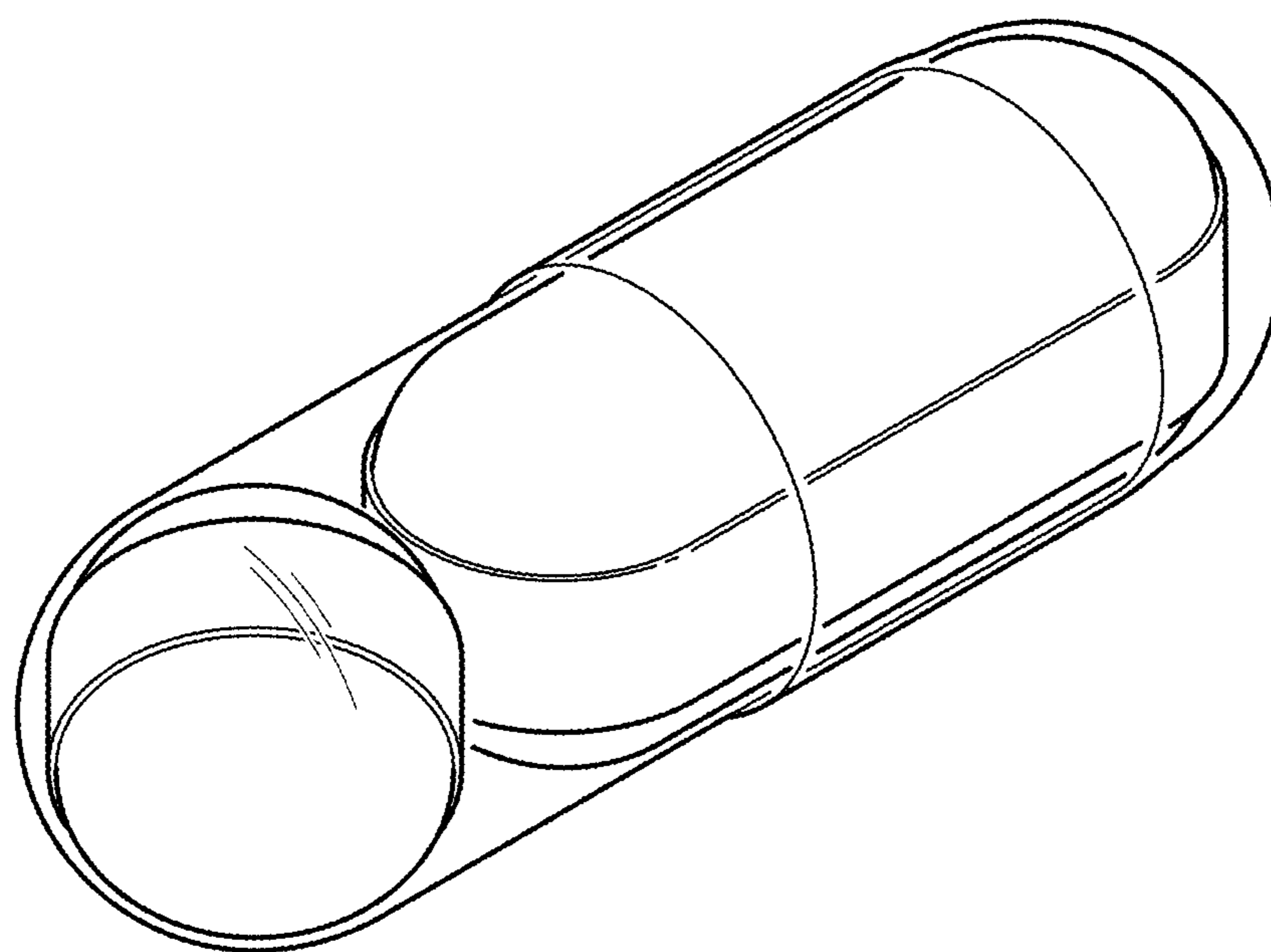

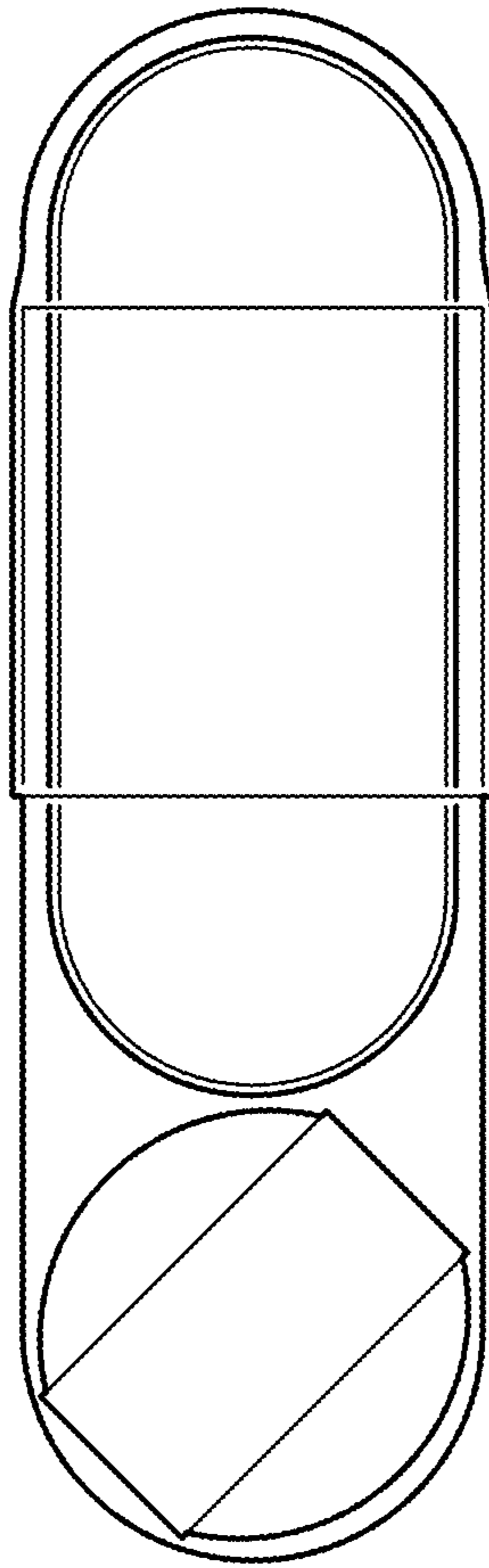

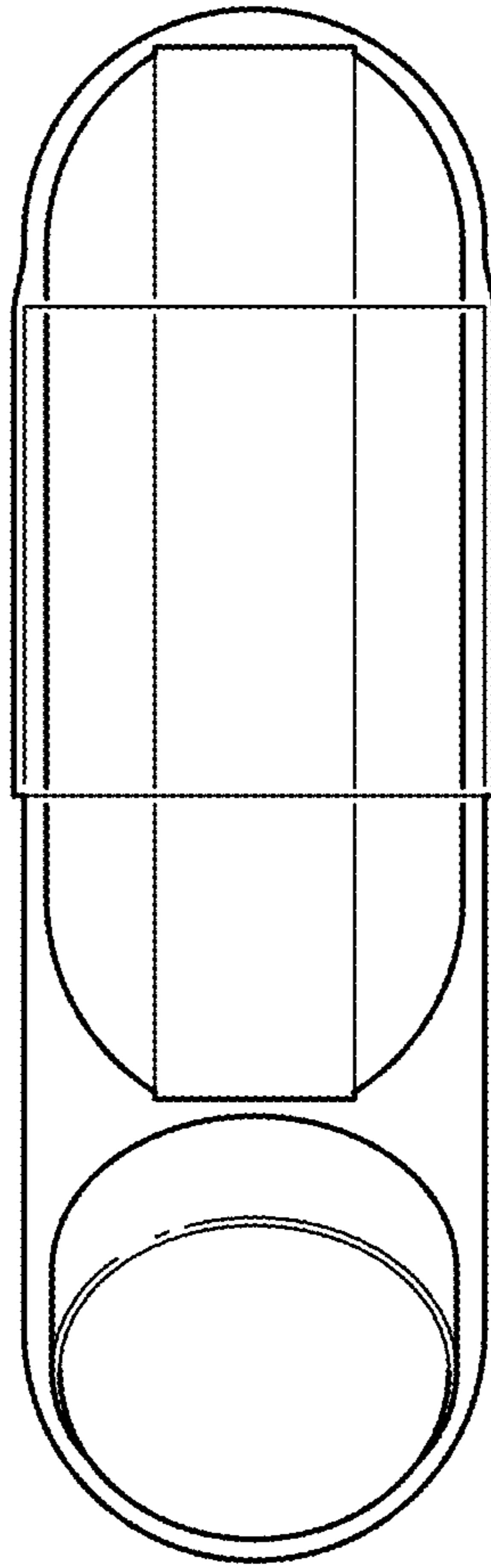

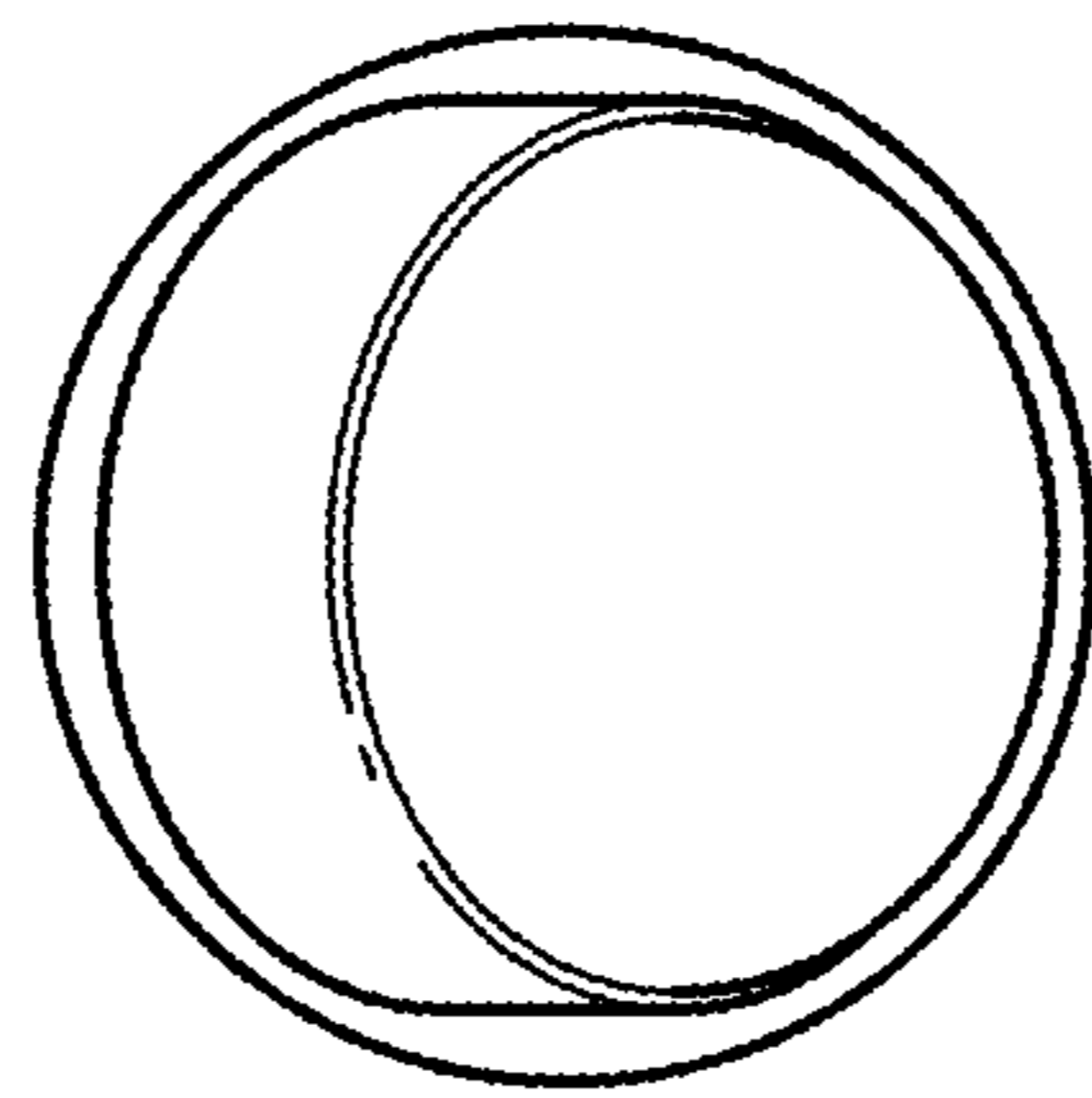

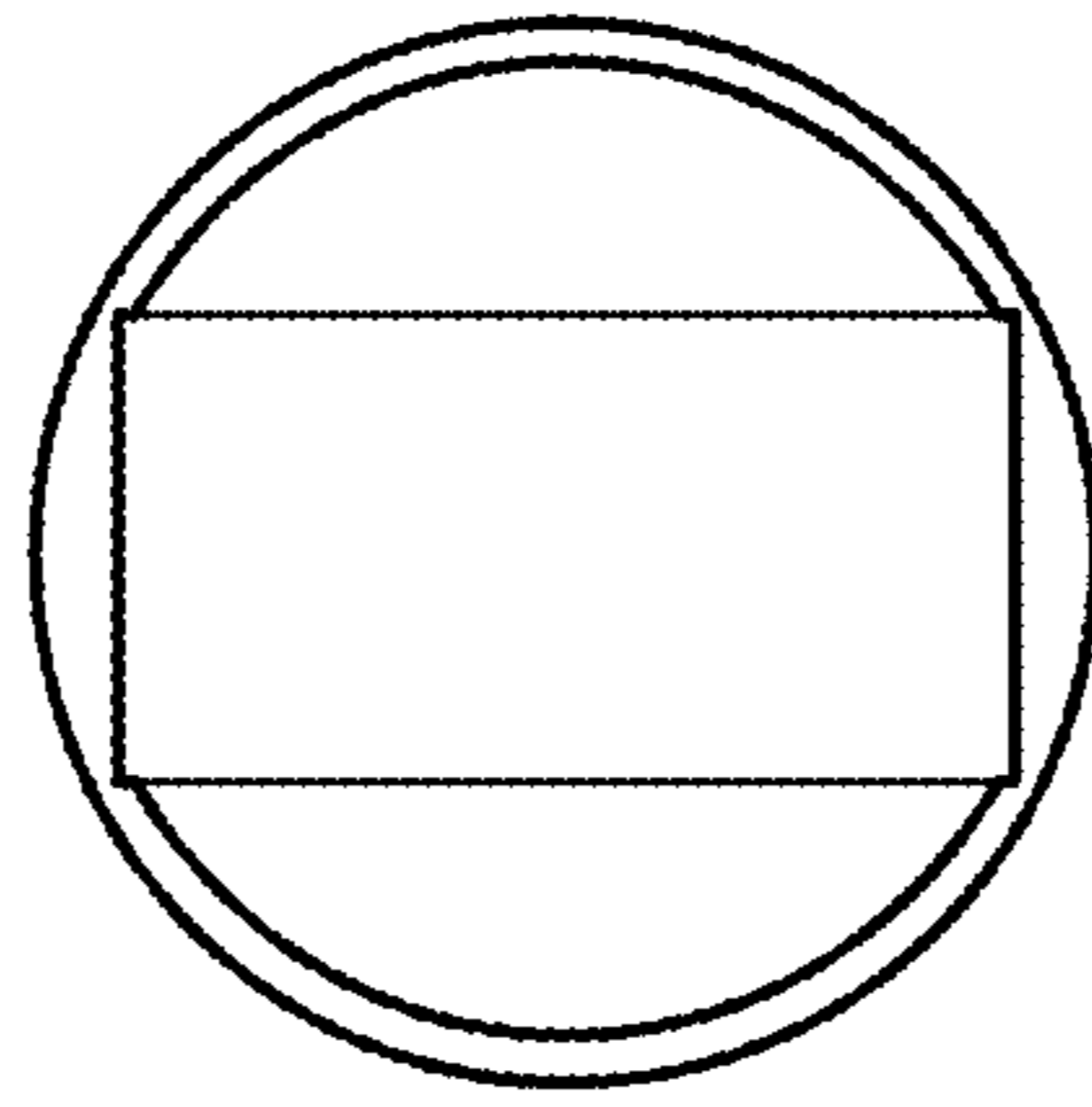

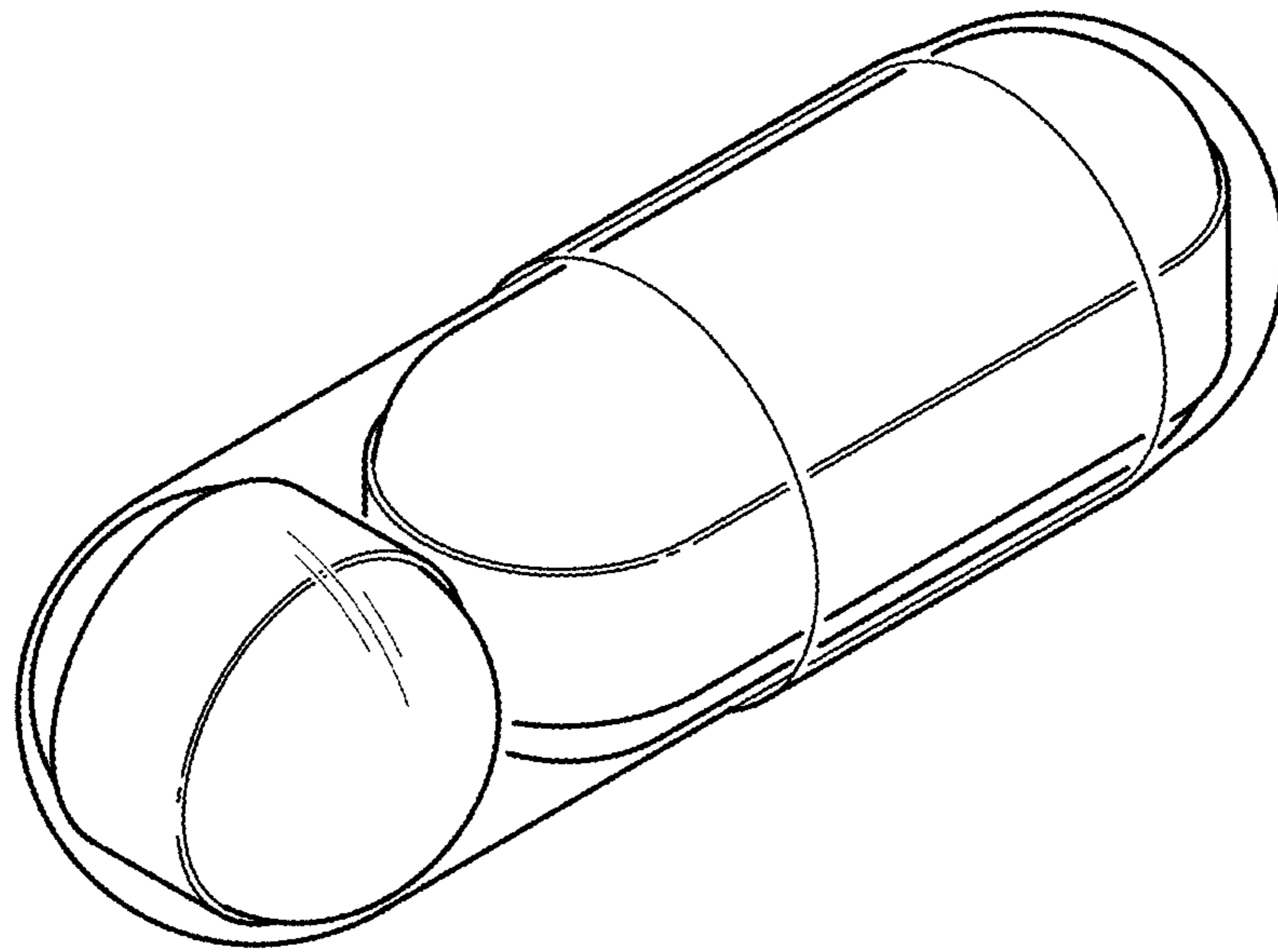

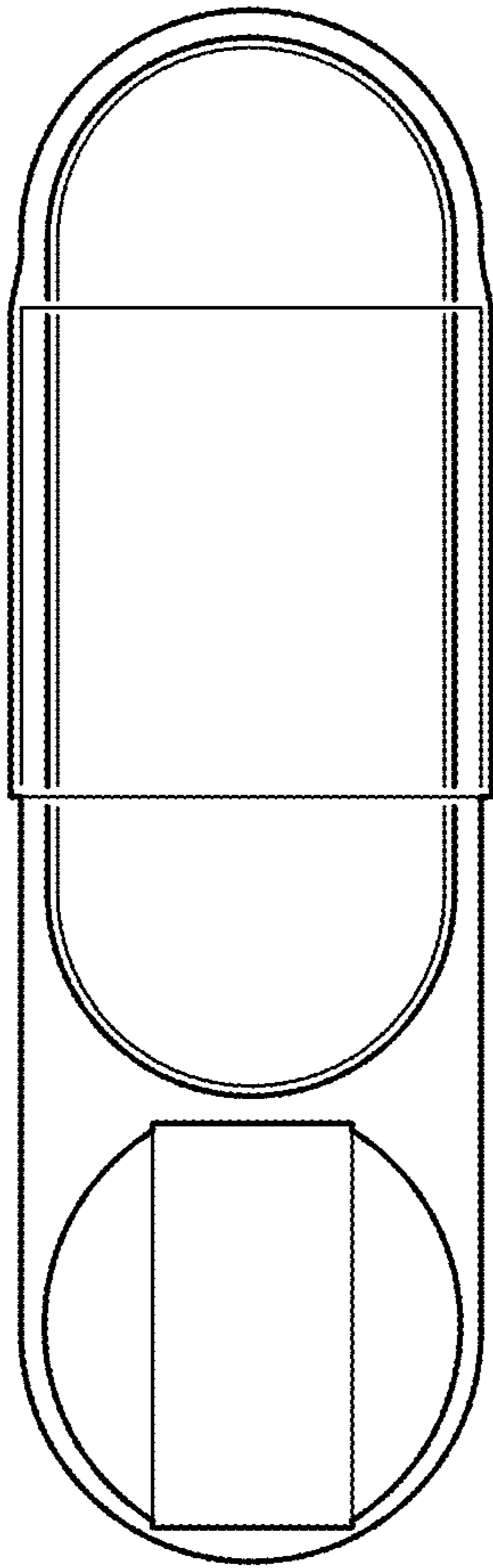

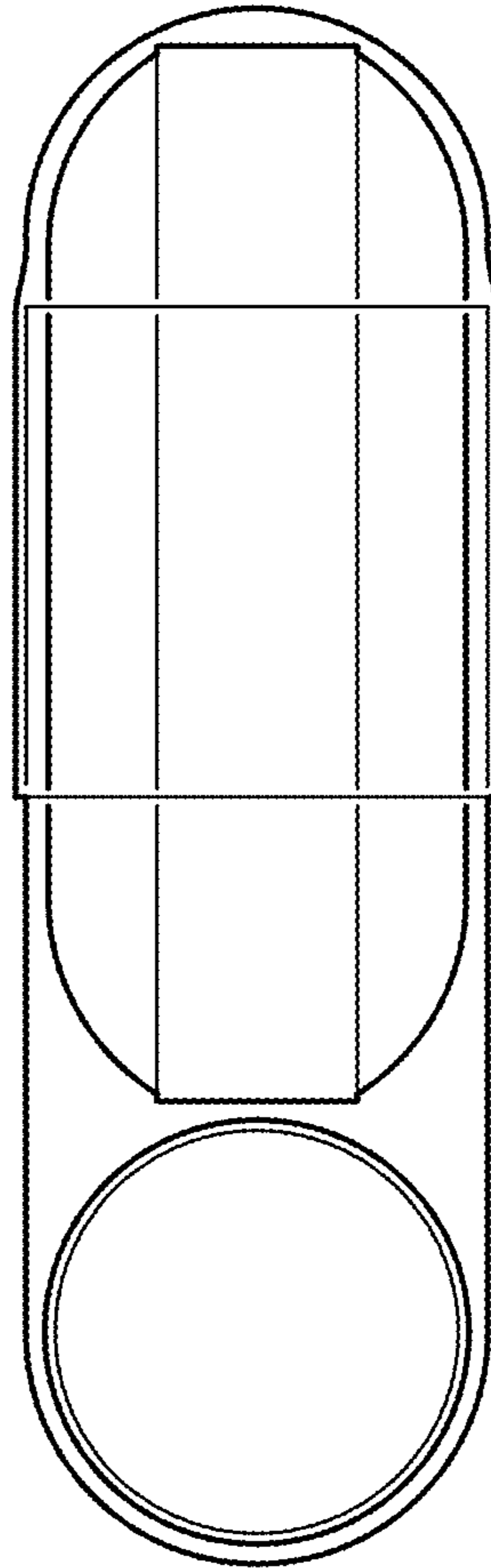

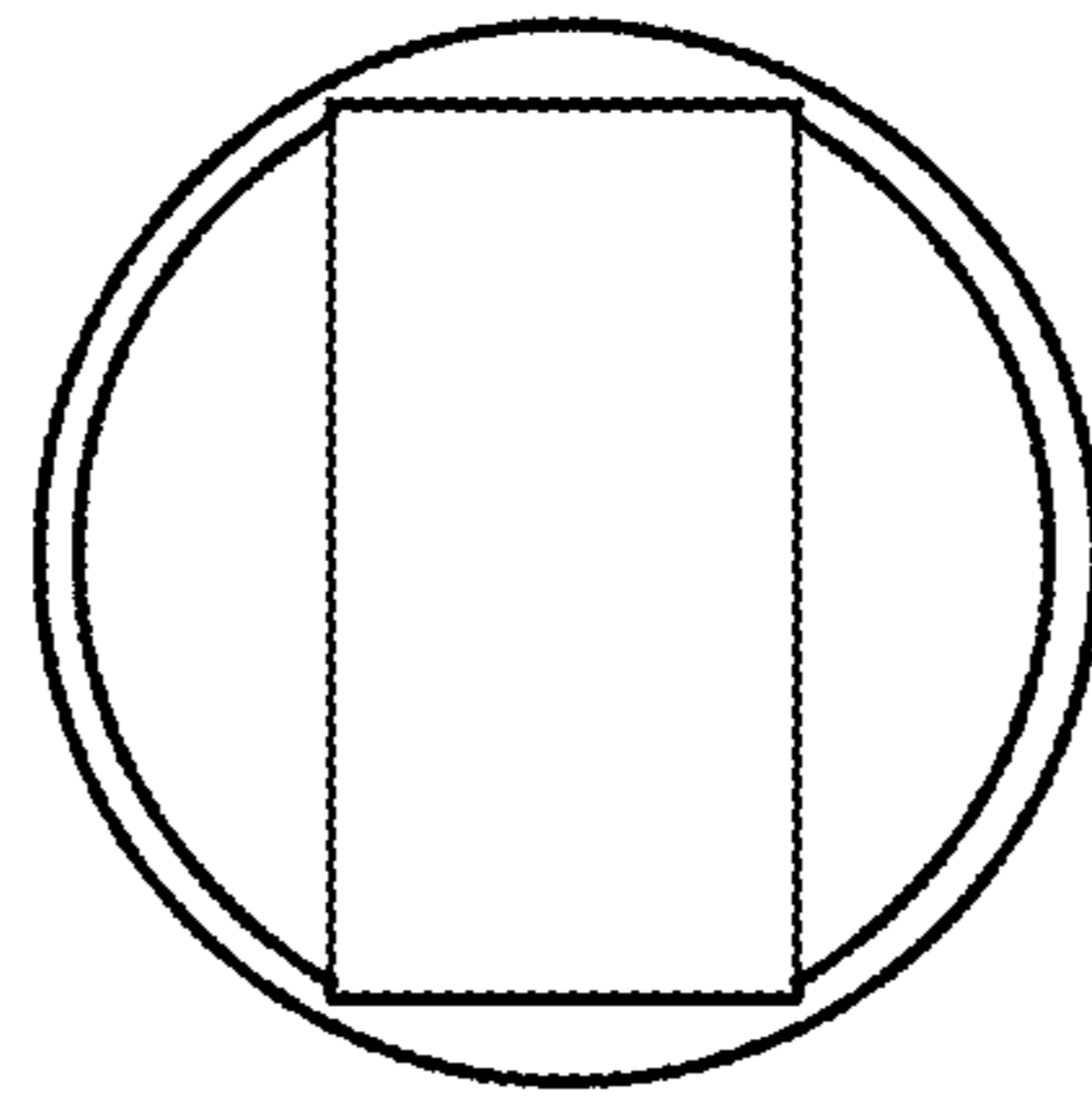

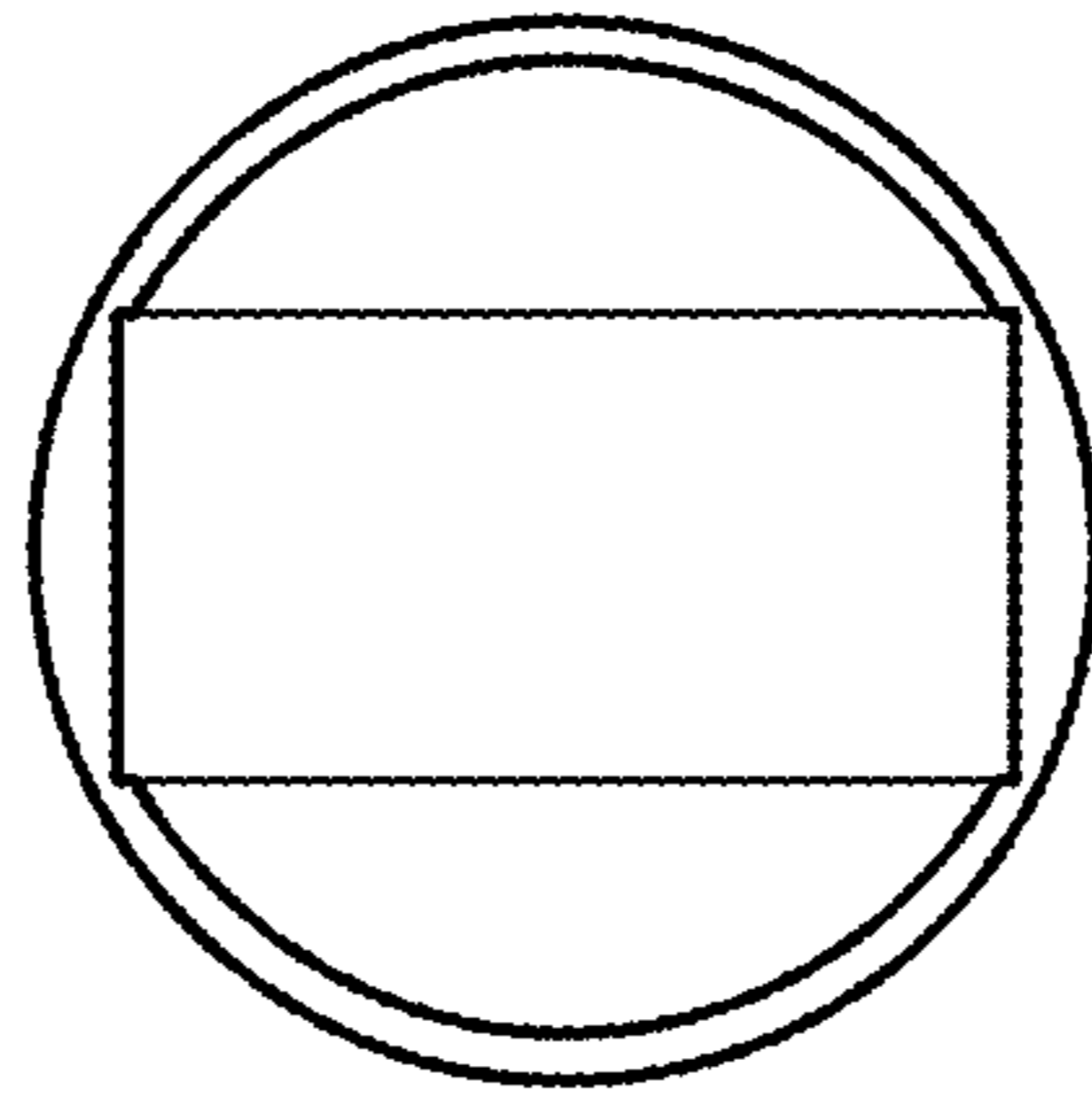
