claimed design.

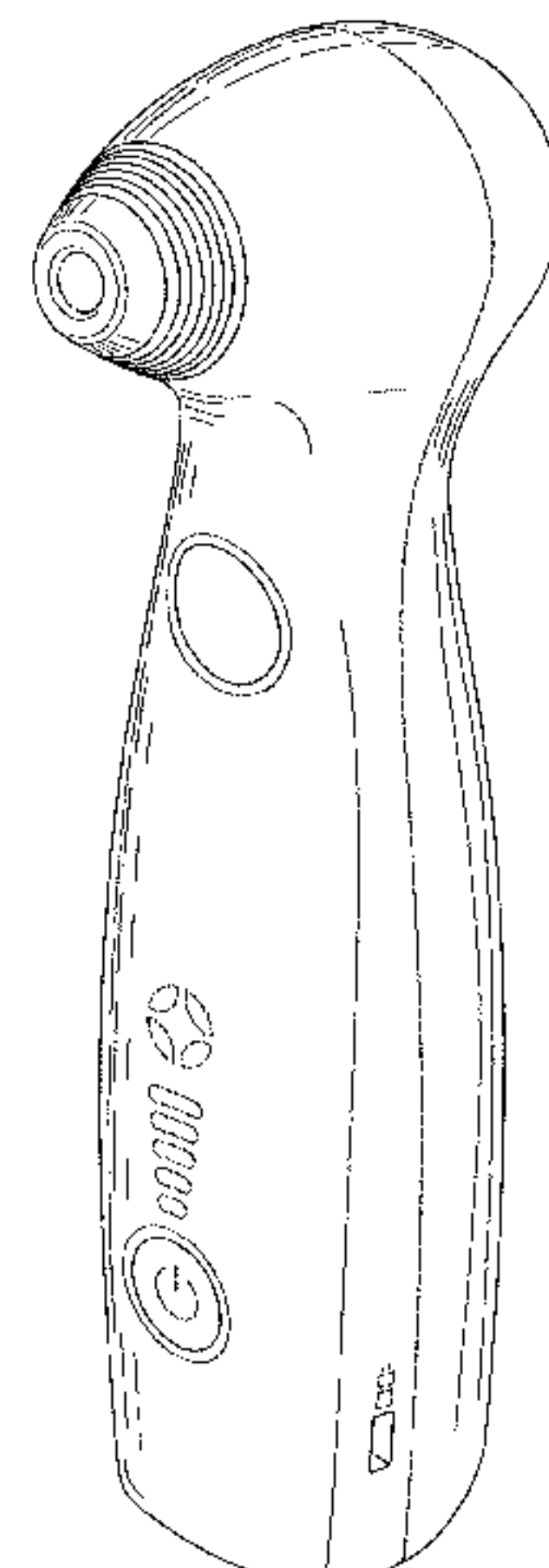

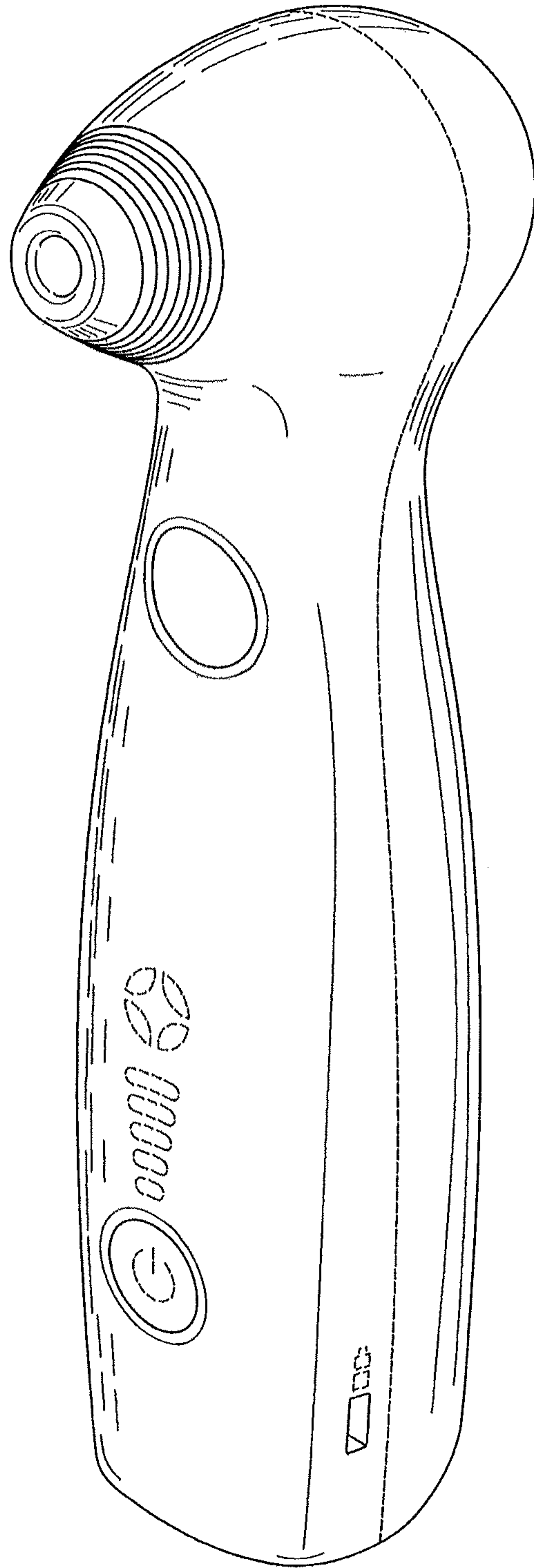

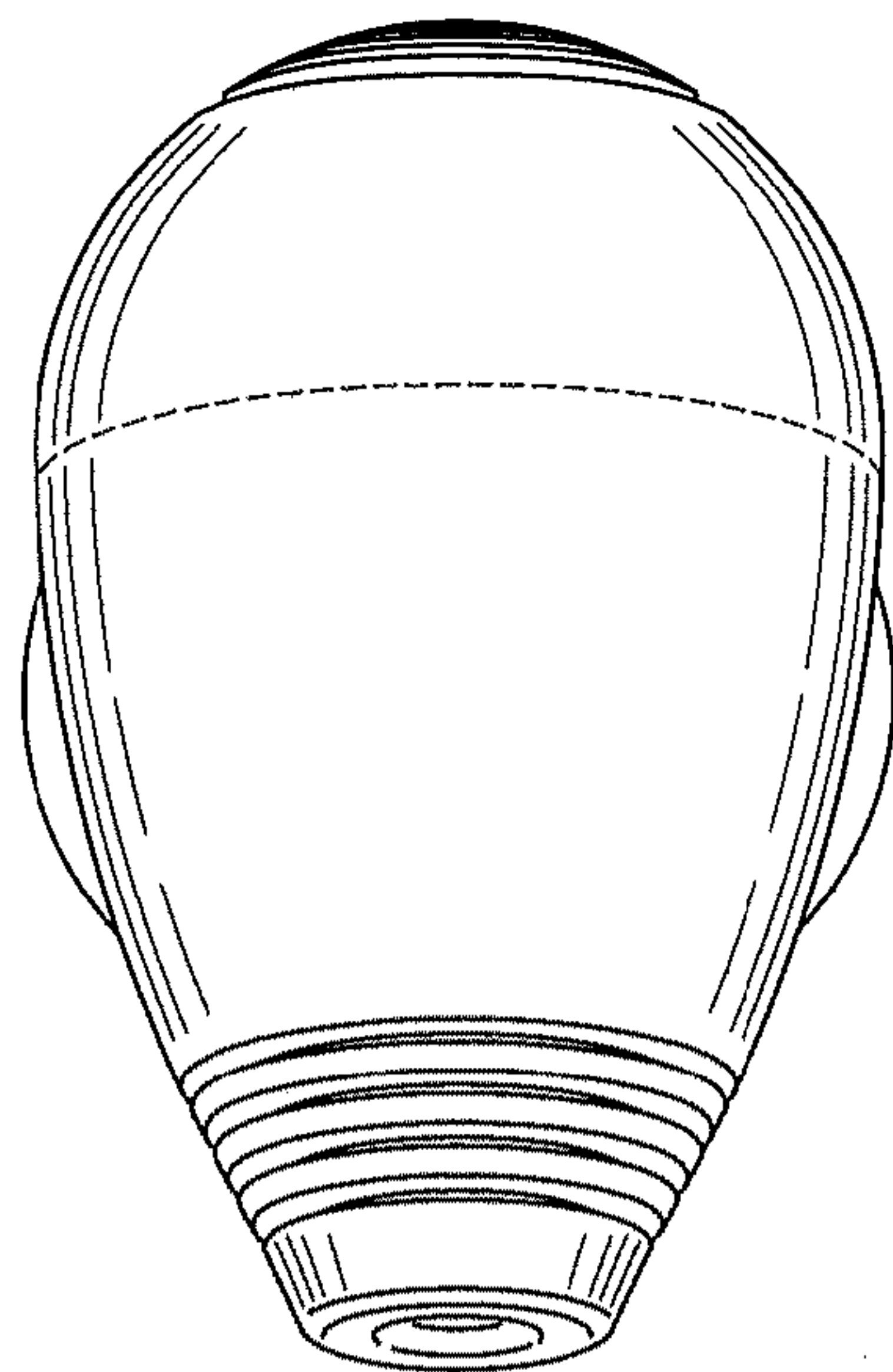

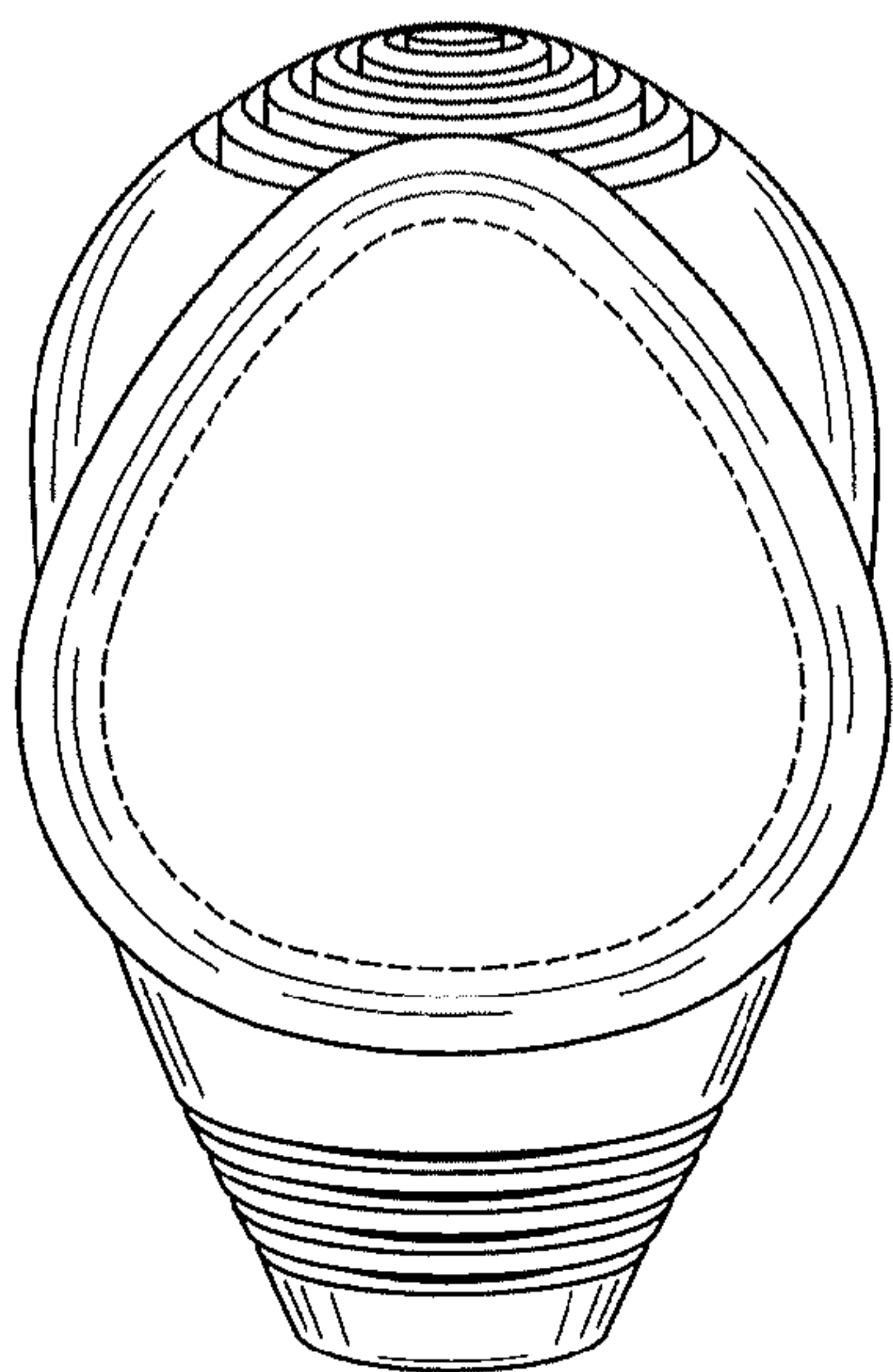

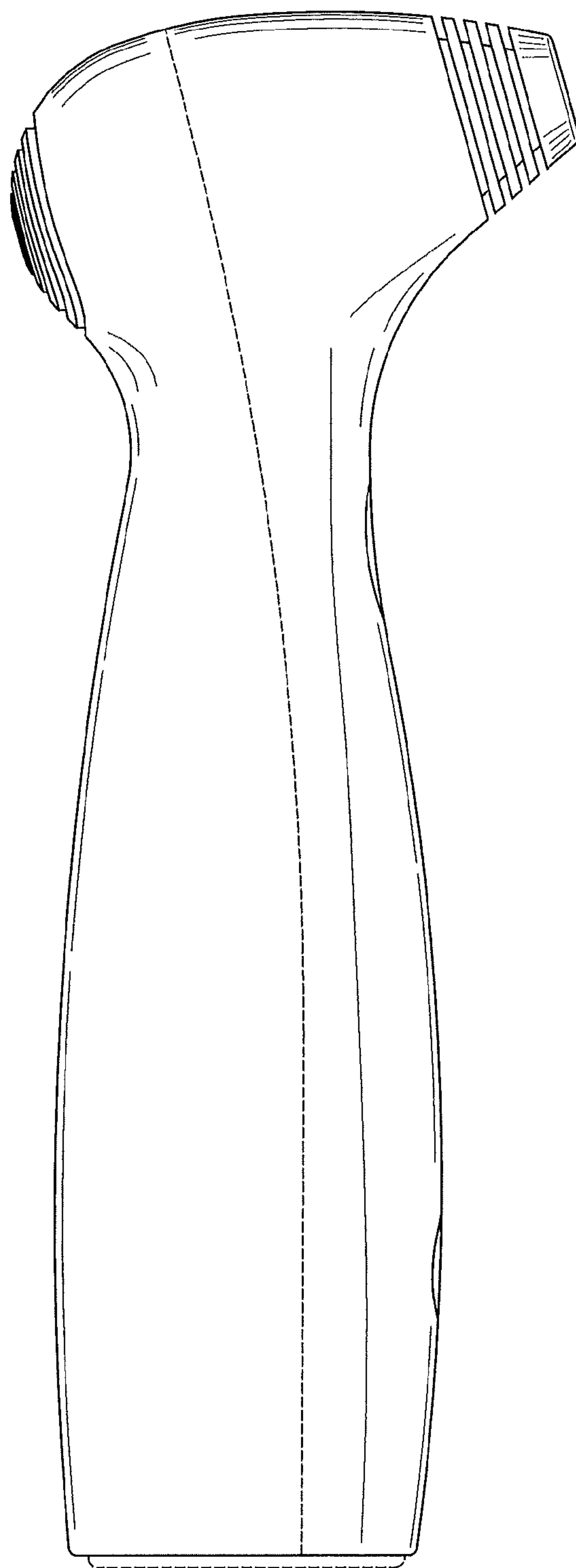

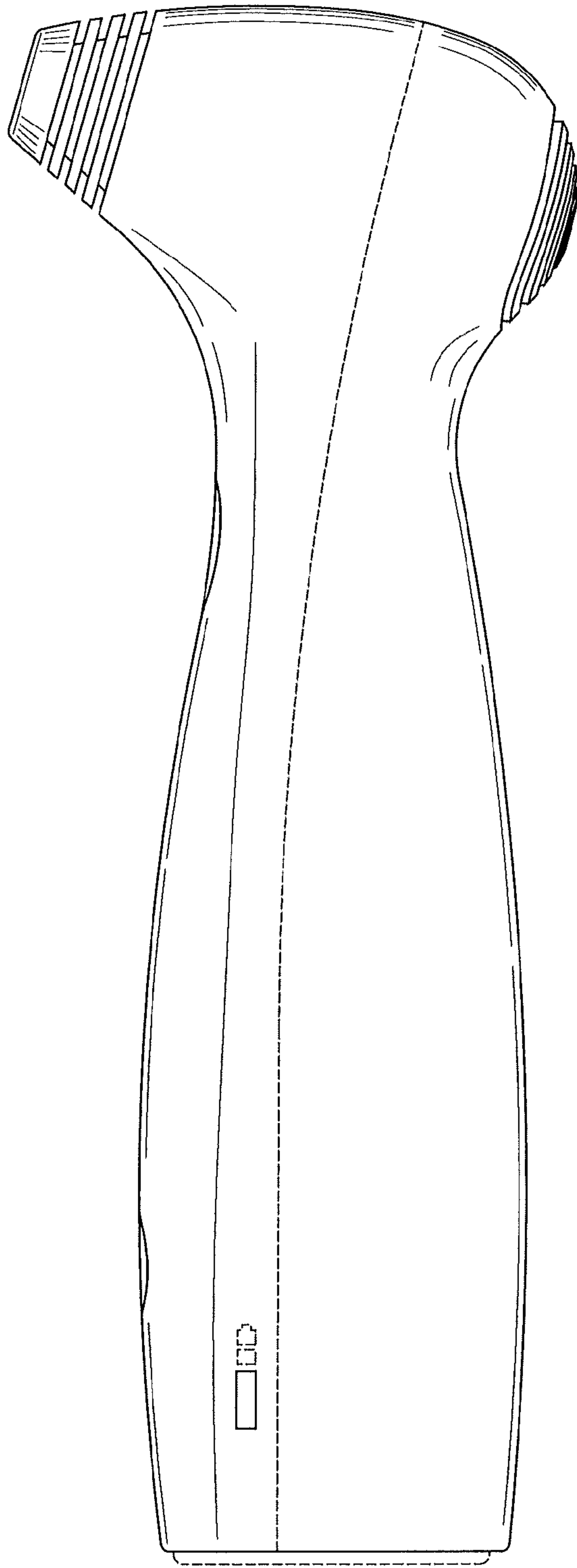

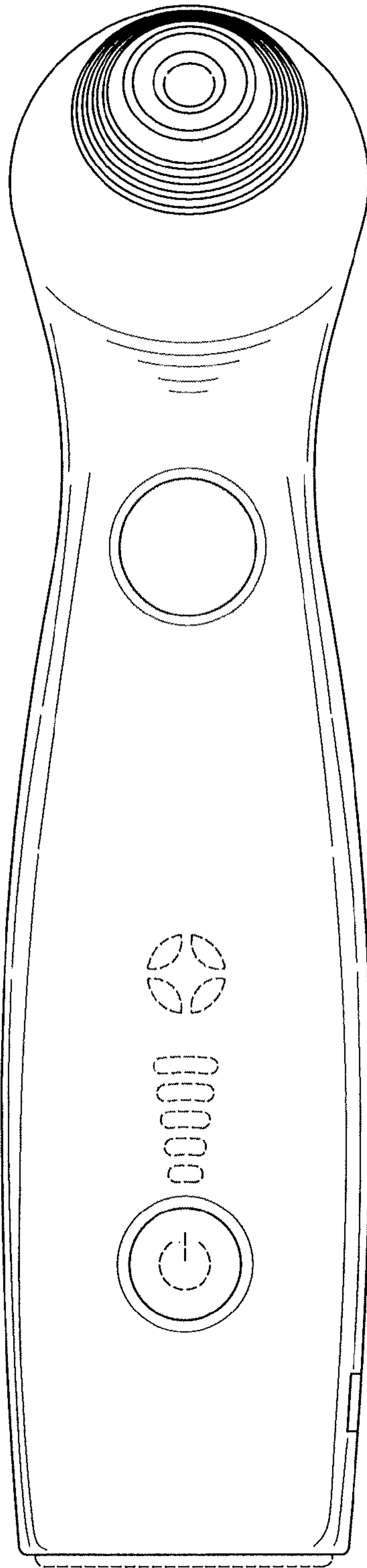

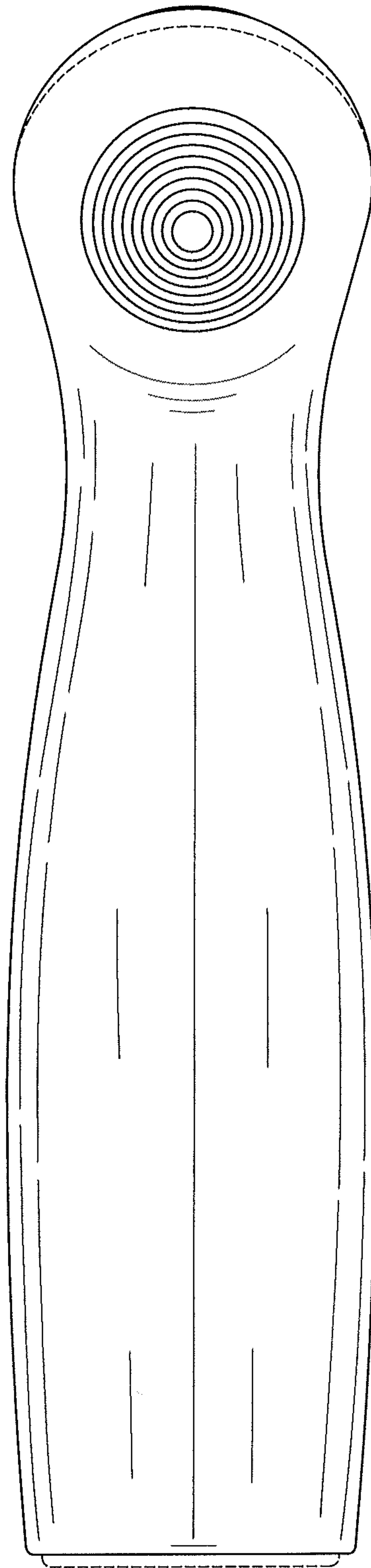
