described.

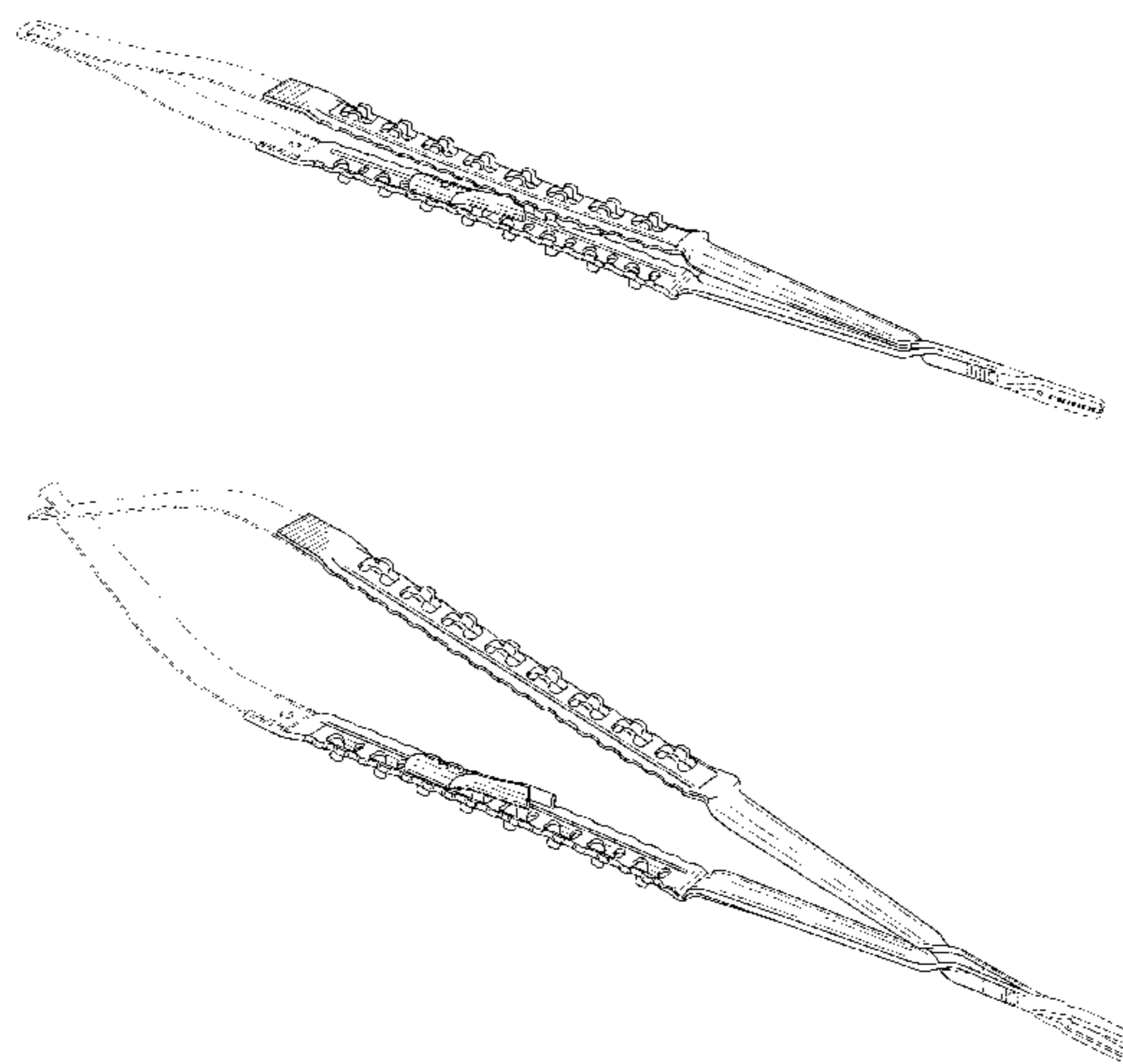
DESCRIPTION

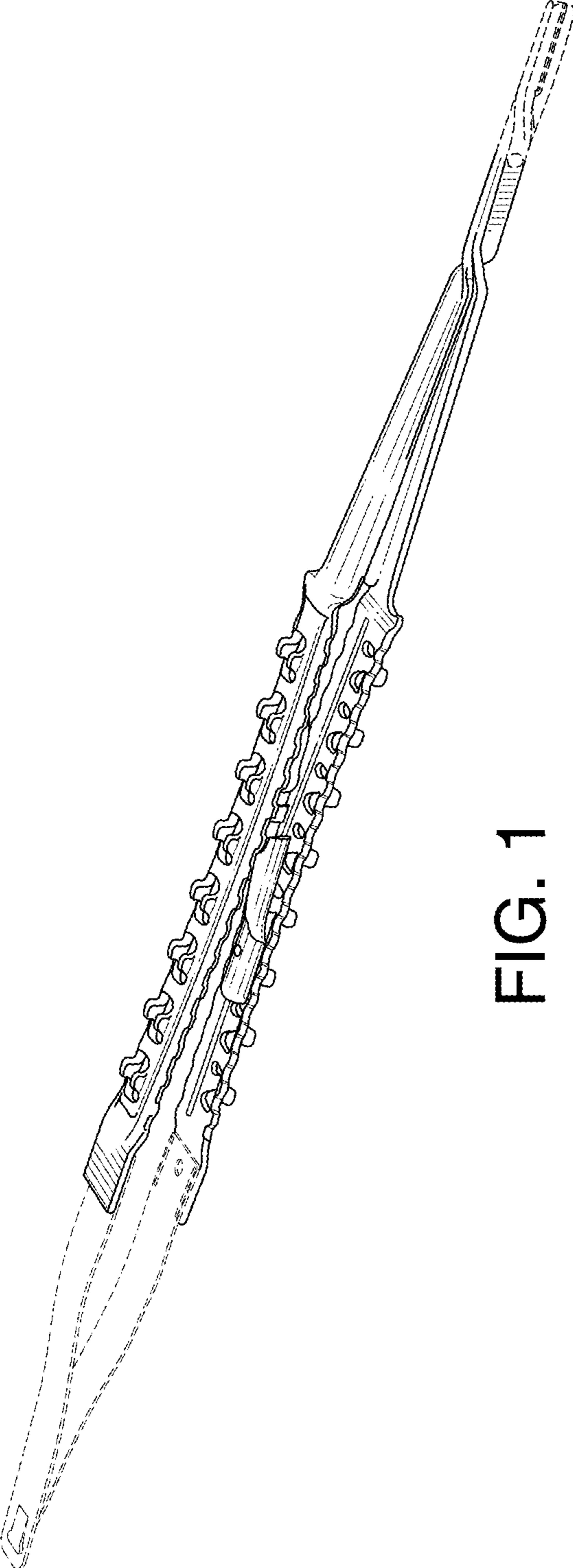

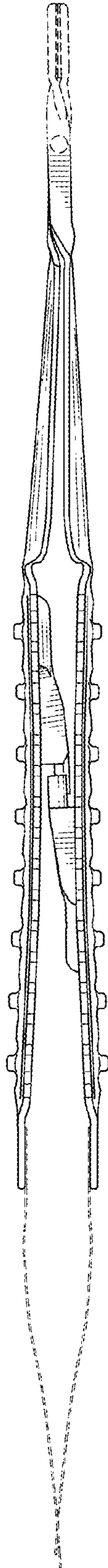

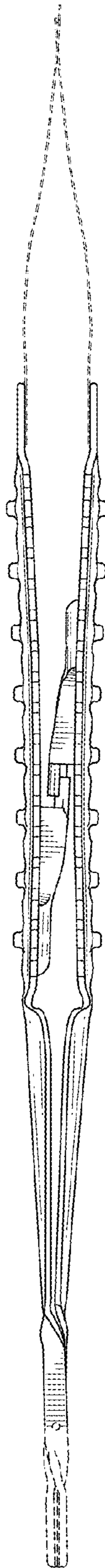

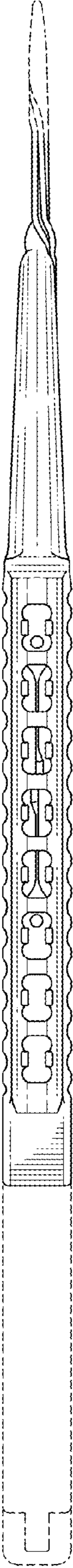

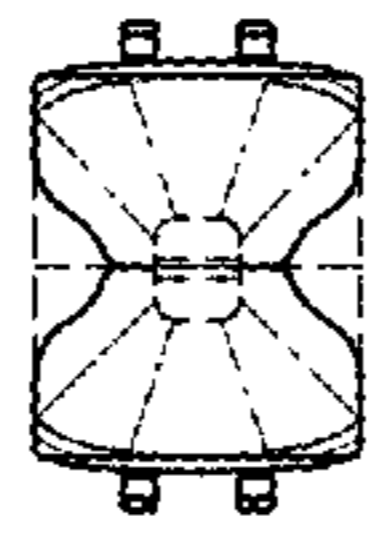

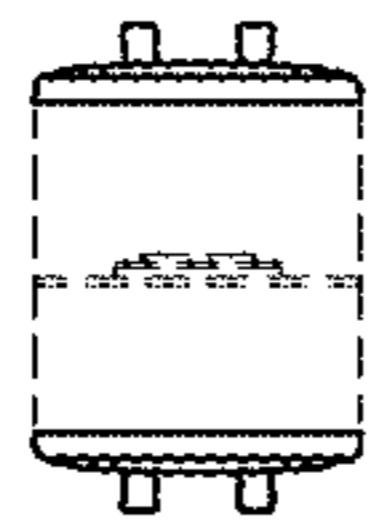

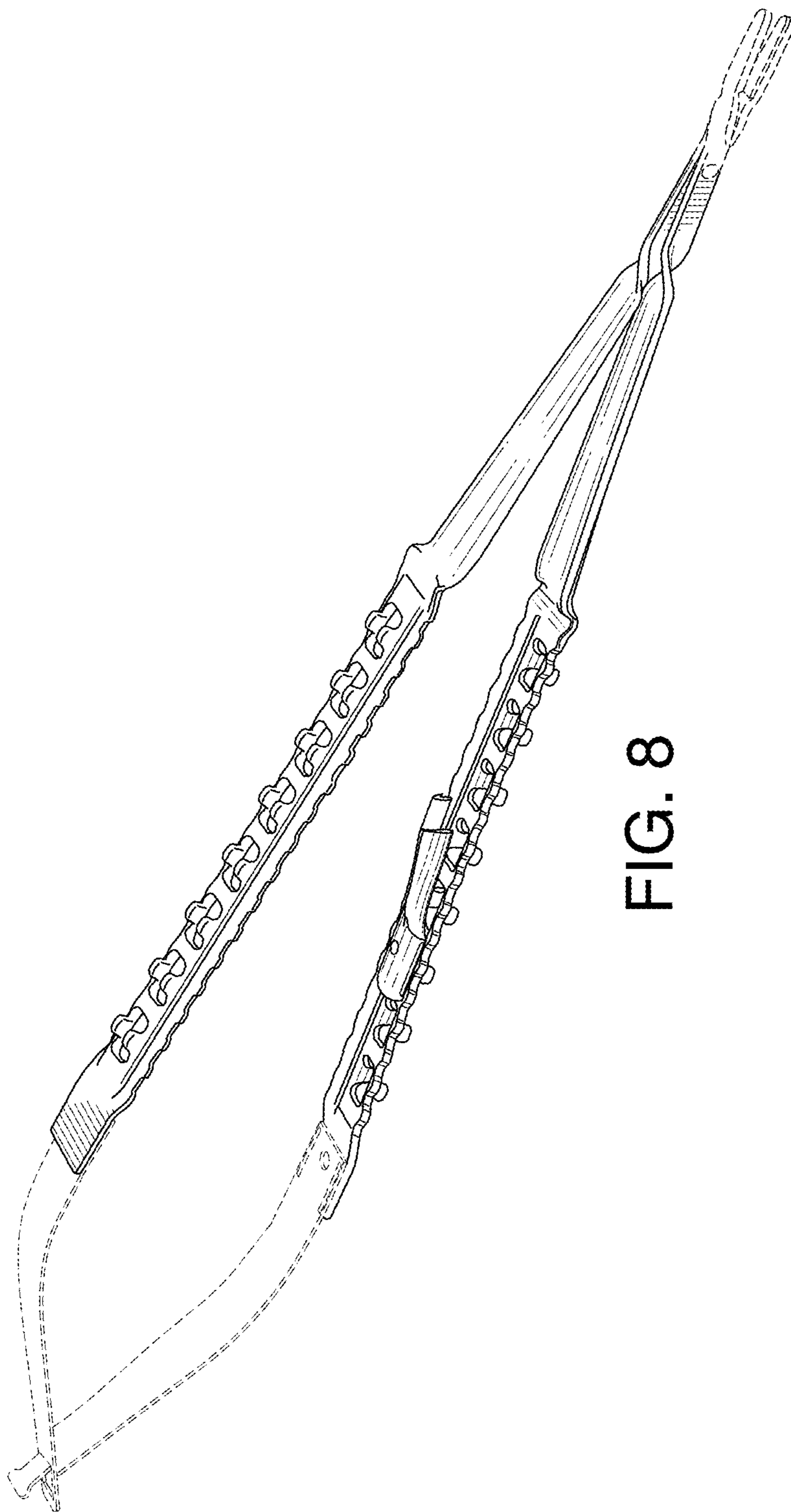

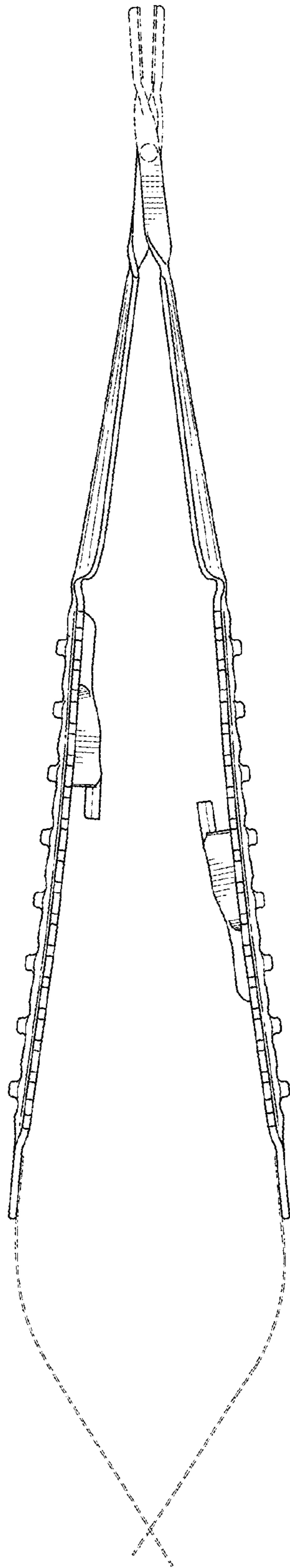

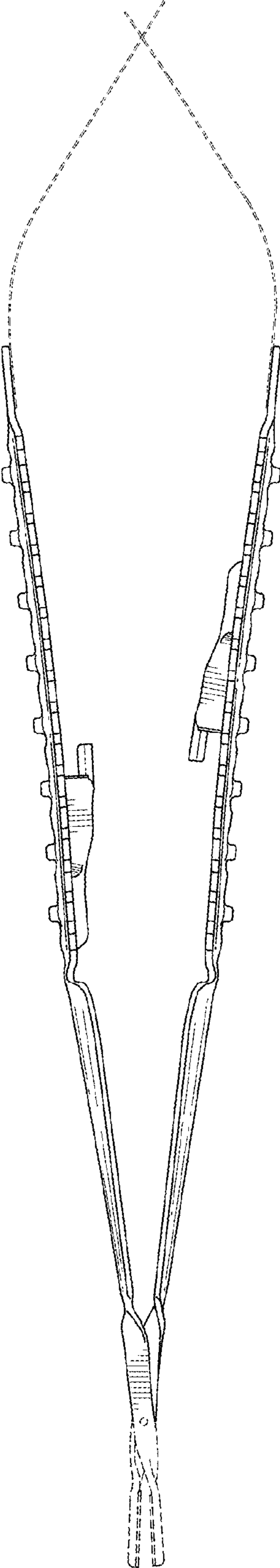

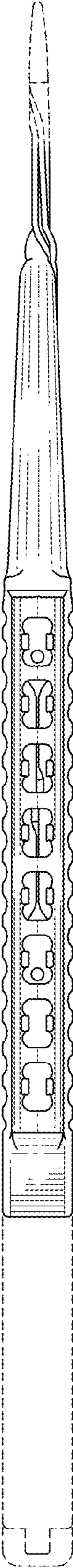

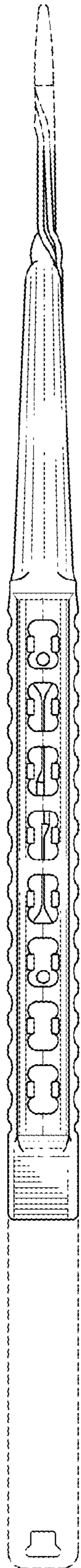

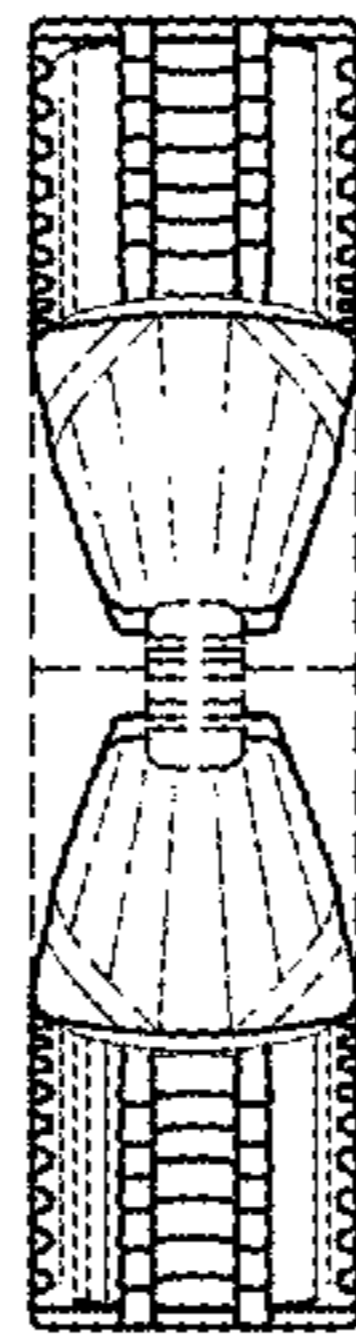
