FIG. 11 is a right side view of a second embodiment of the pet treat;

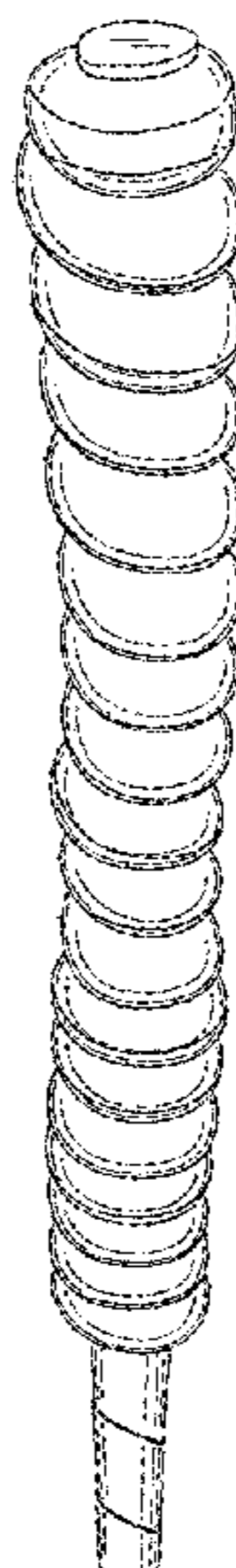
FIG. 12 is a front view of the second embodiment of the pet treat;

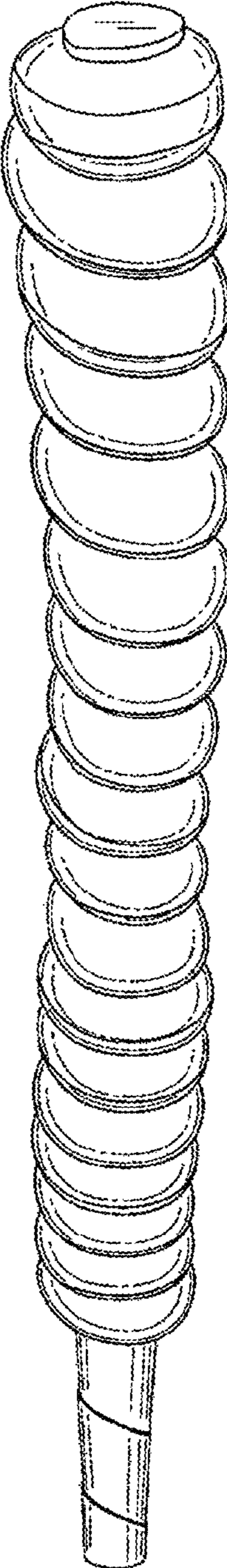

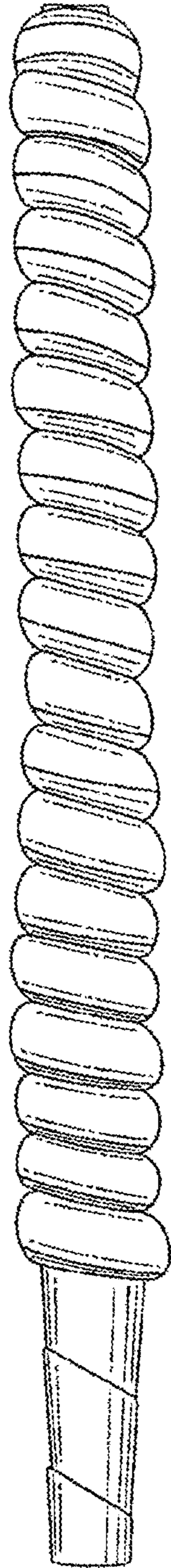

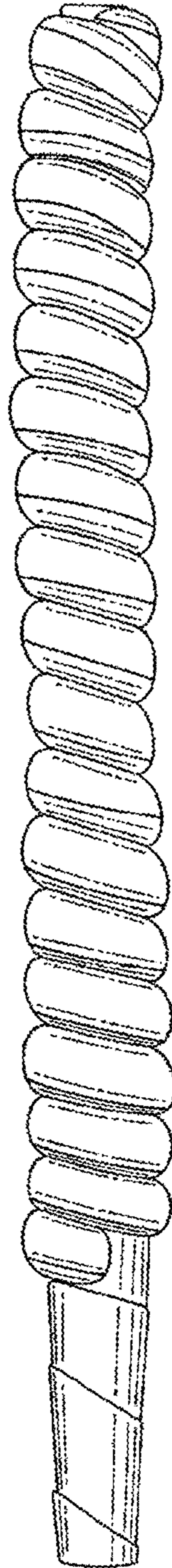

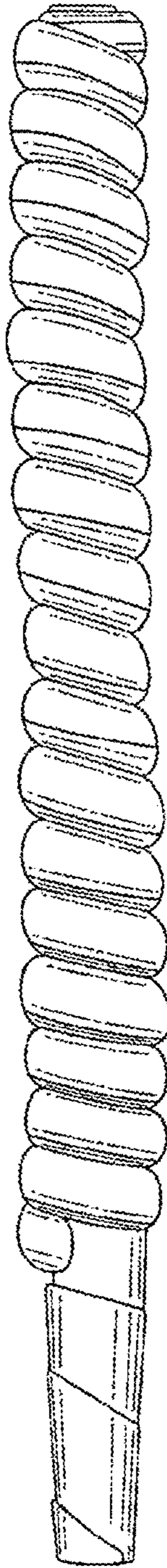

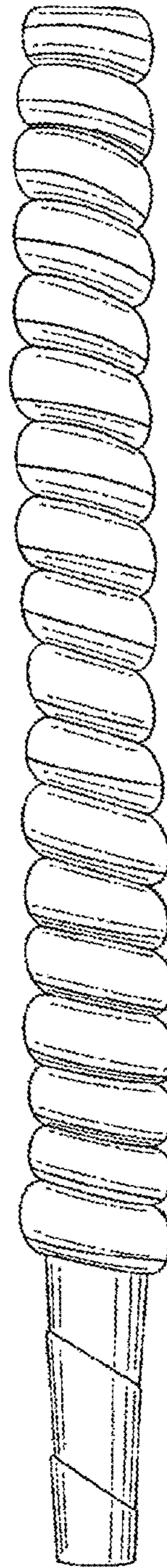

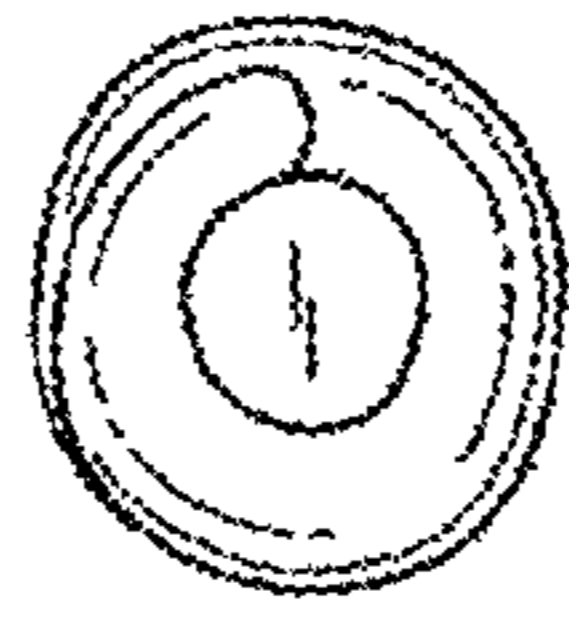

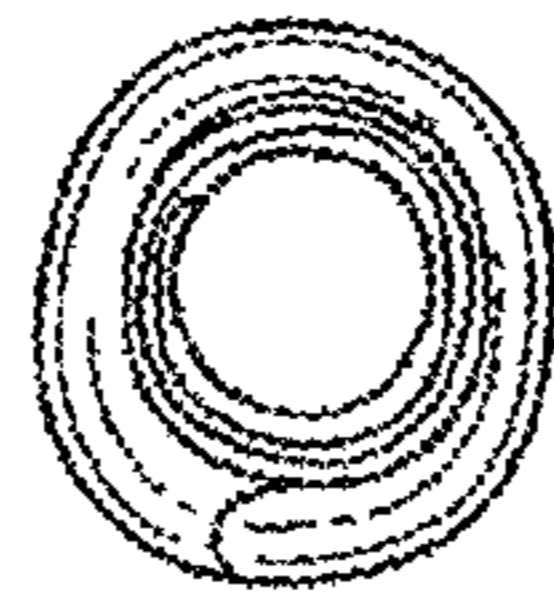

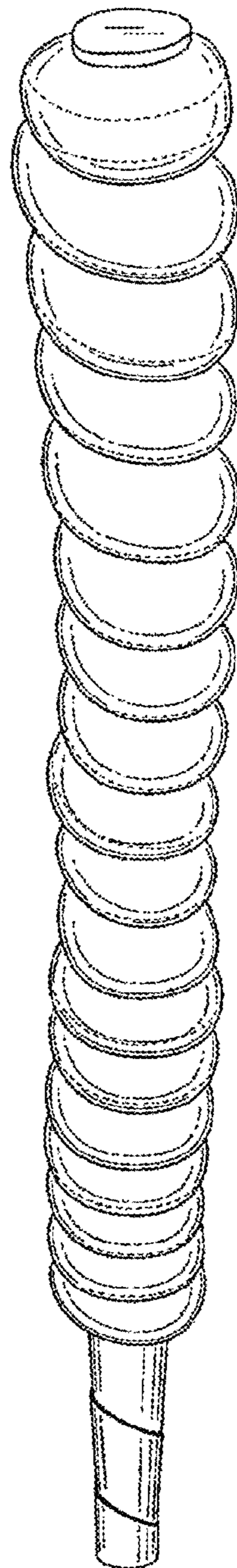

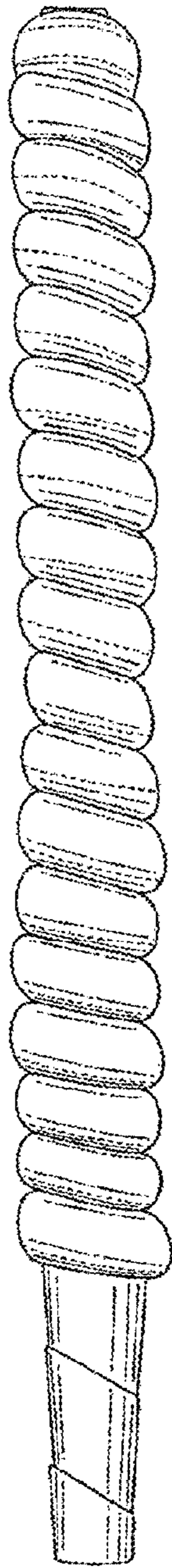

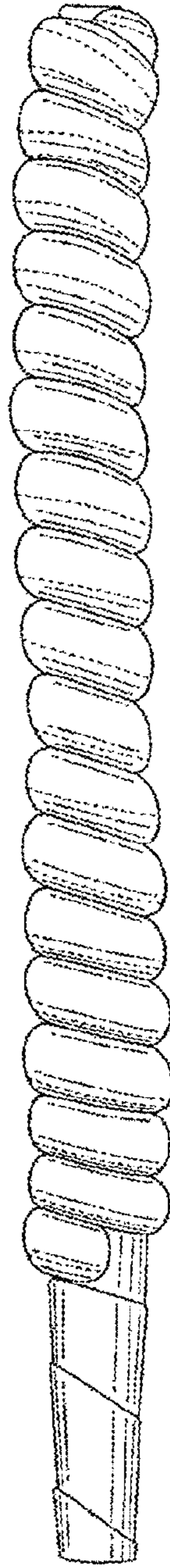

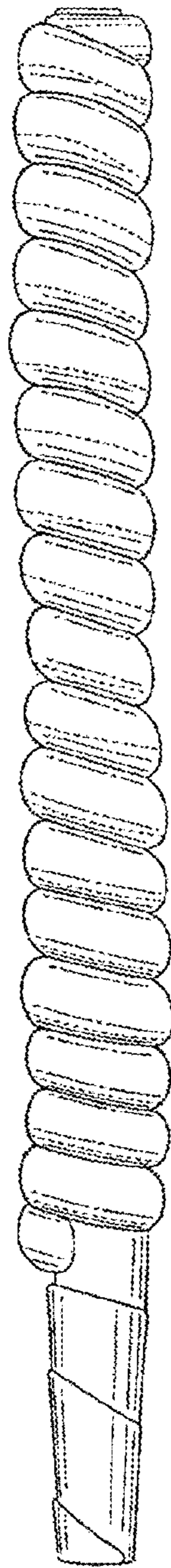

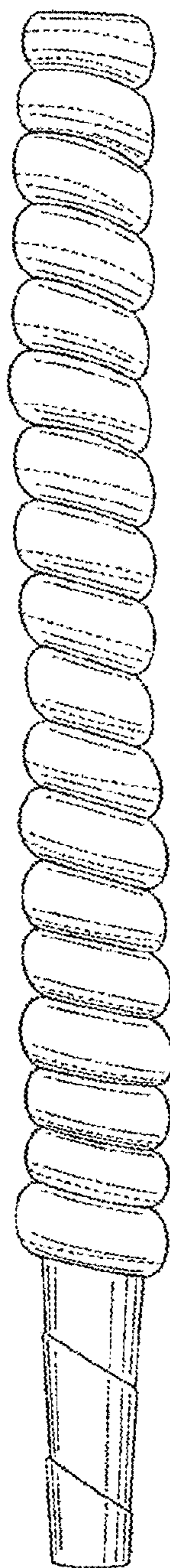

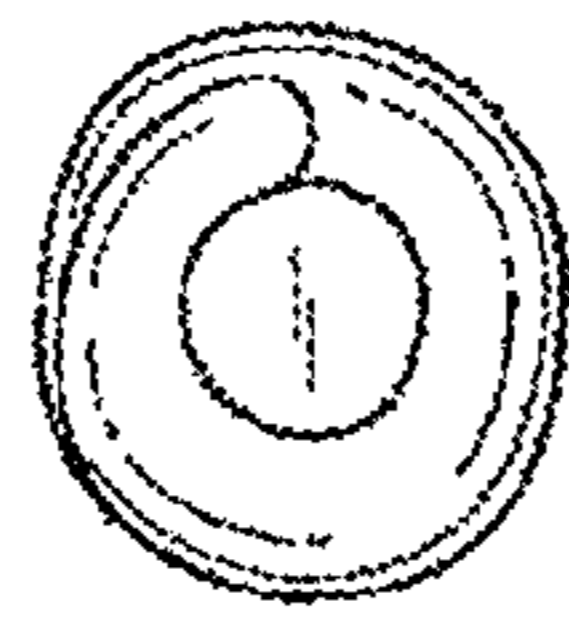
