The ornamental design for a necktie, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a necktie showing my new design,

FIG. 2 is a back elevational view thereof,

FIG. 3 is a right side elevational view thereof,

FIG. 4 is a top view thereof,

FIG. 5 is a bottom view thereof,

FIG. 6 is a front view of the necktie shown in a position of use; and

FIG. 7 is a front view of the necktie shown in a second position of use.

FIG. 10 is a front elevational view thereof,

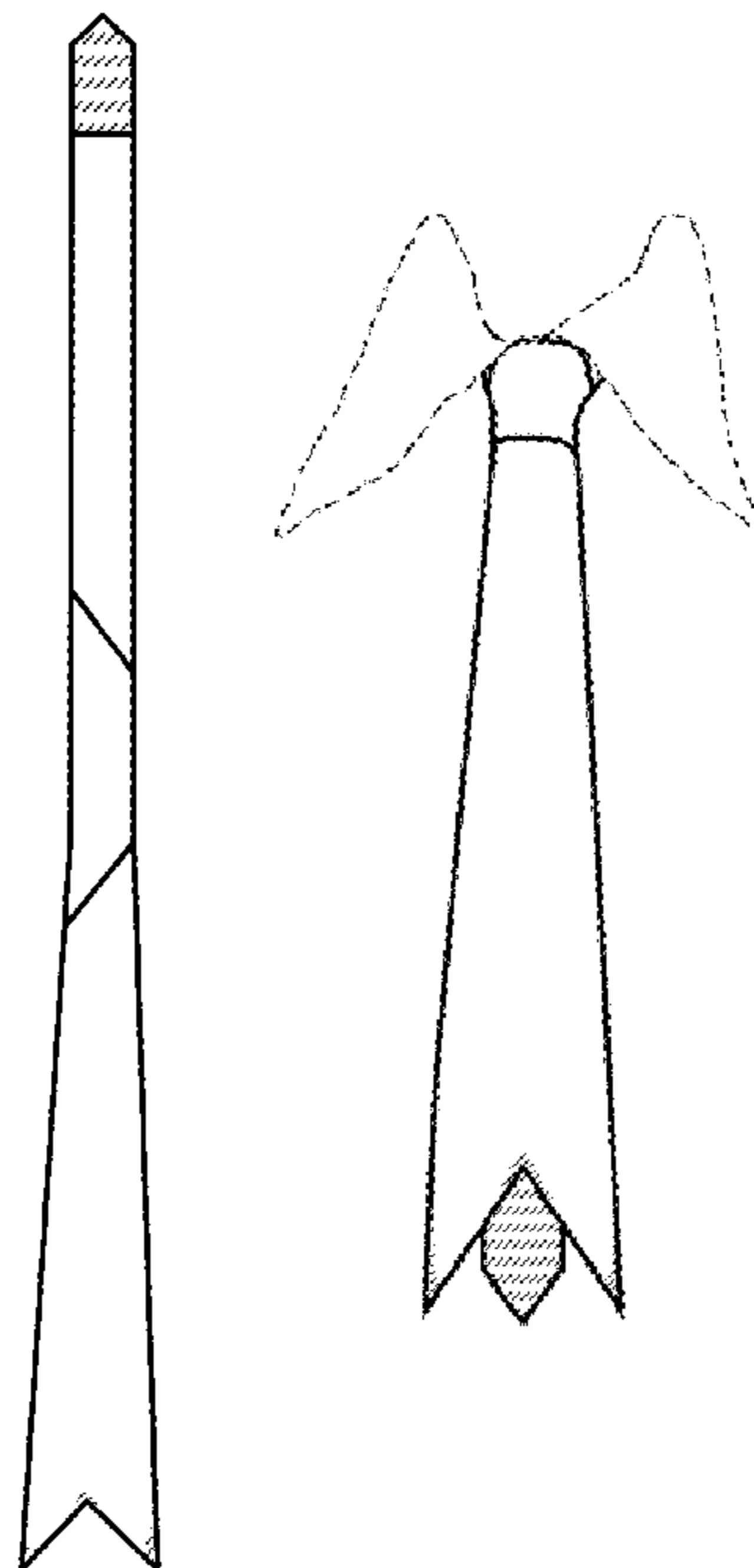
FIG. 11 is a back elevational view thereof; and,

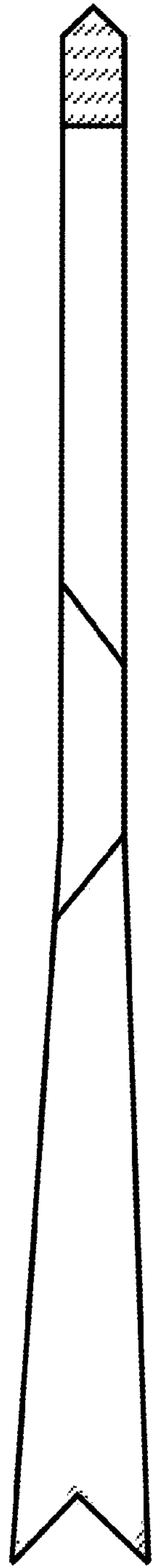

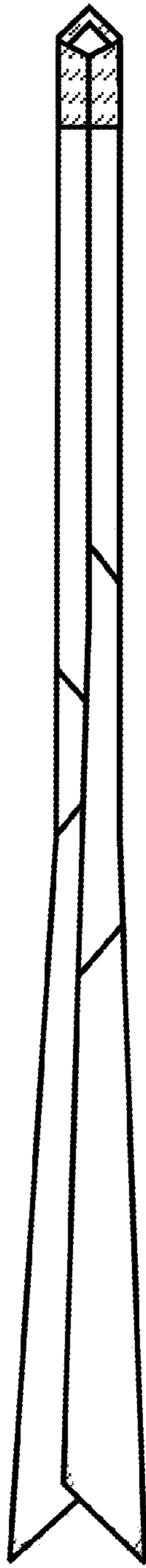

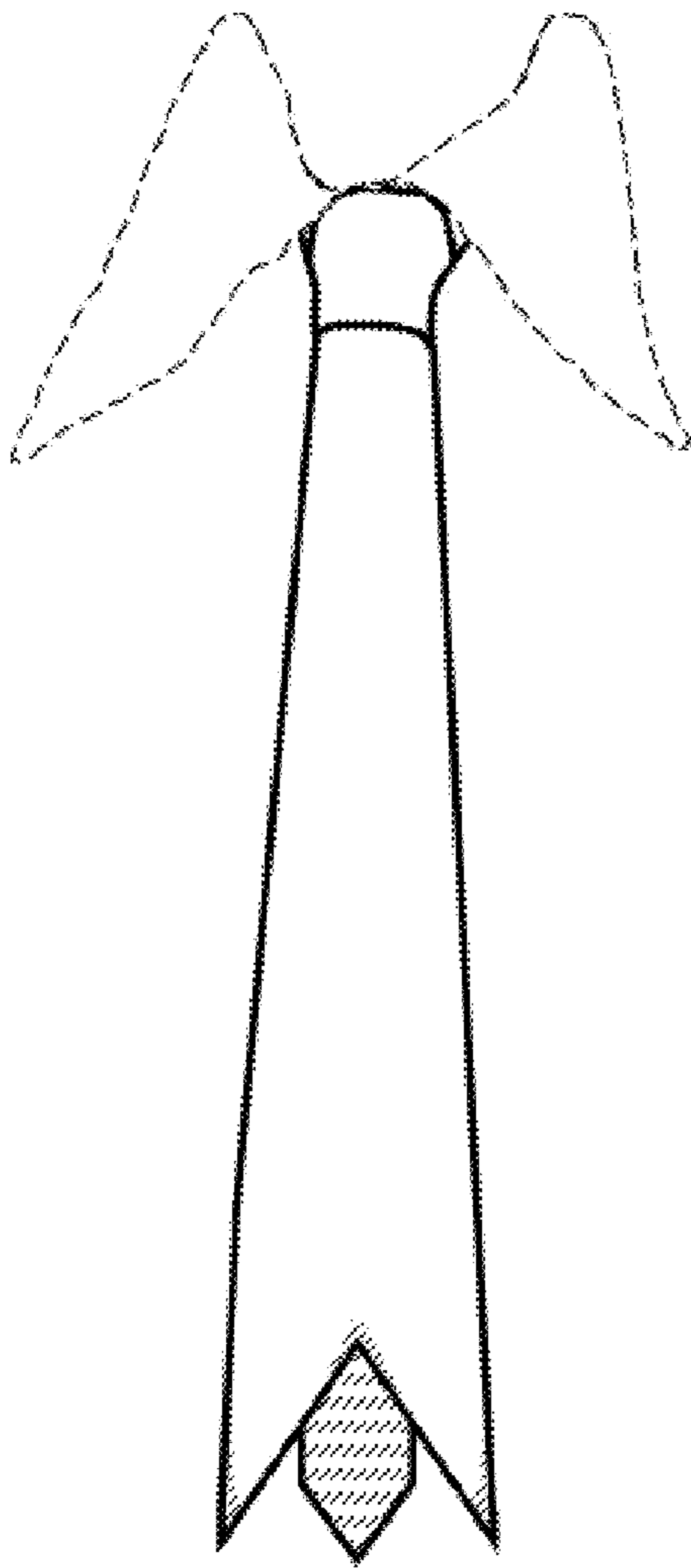

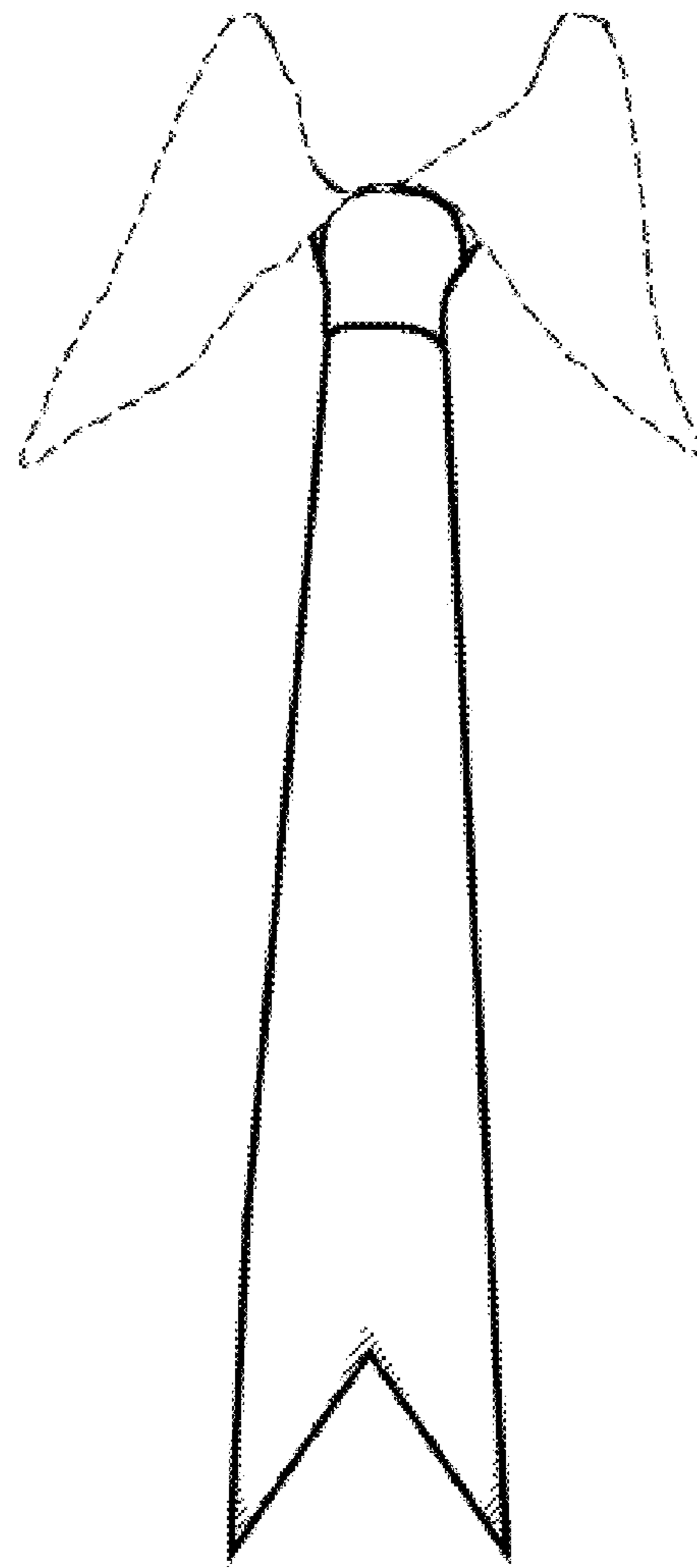

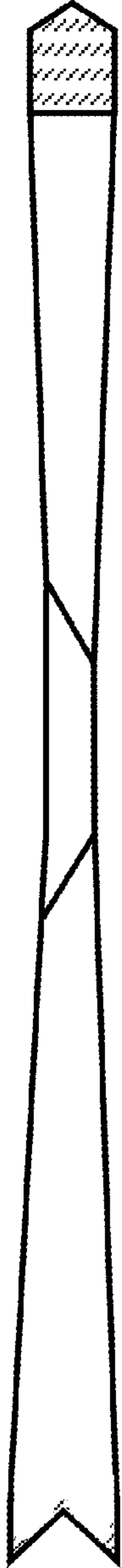

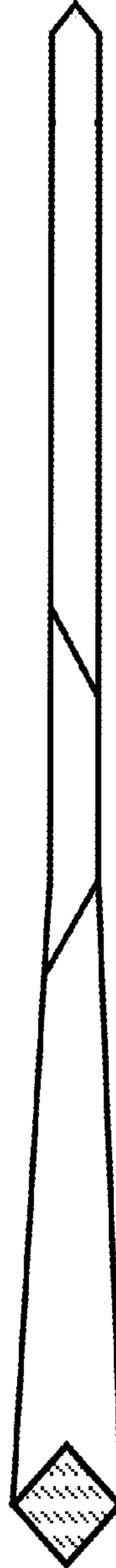

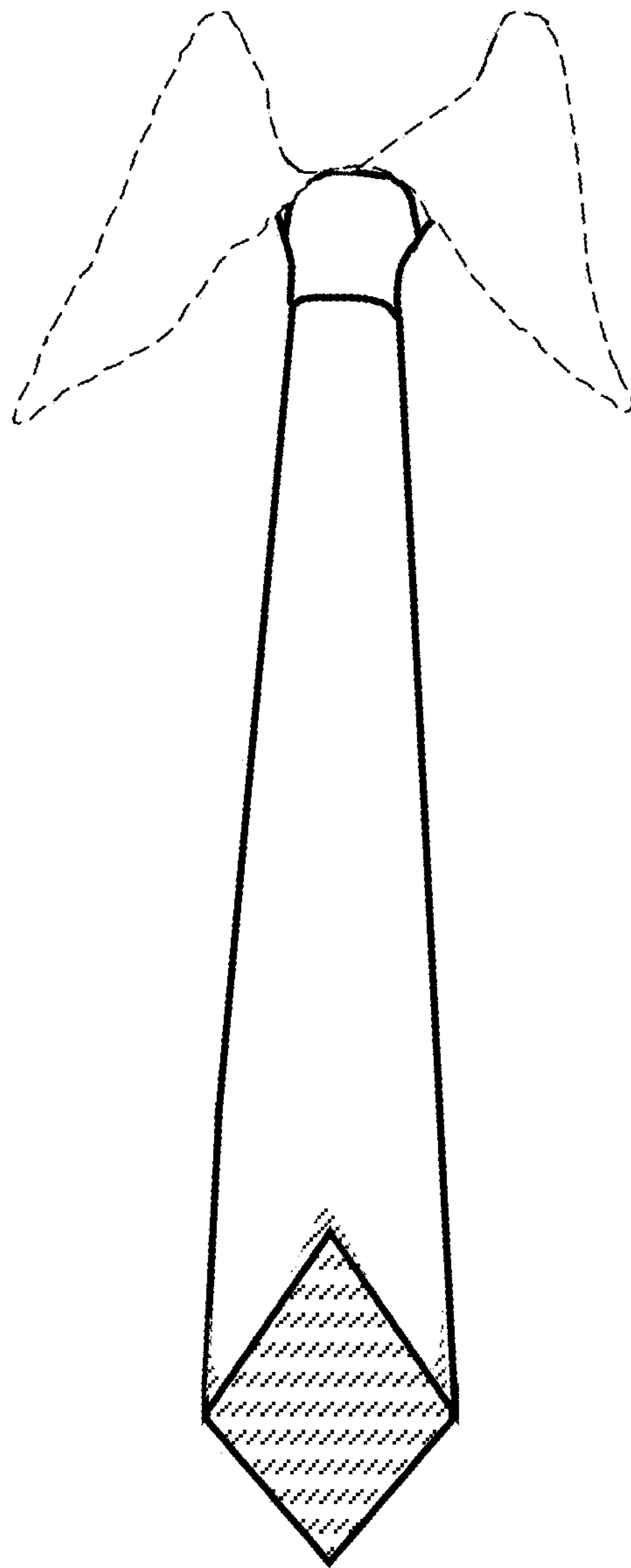
