DESCRIPTION

FIG. 4 is a left side elevation view of a torso bib of the present invention, showing the new, original, and ornamental design;

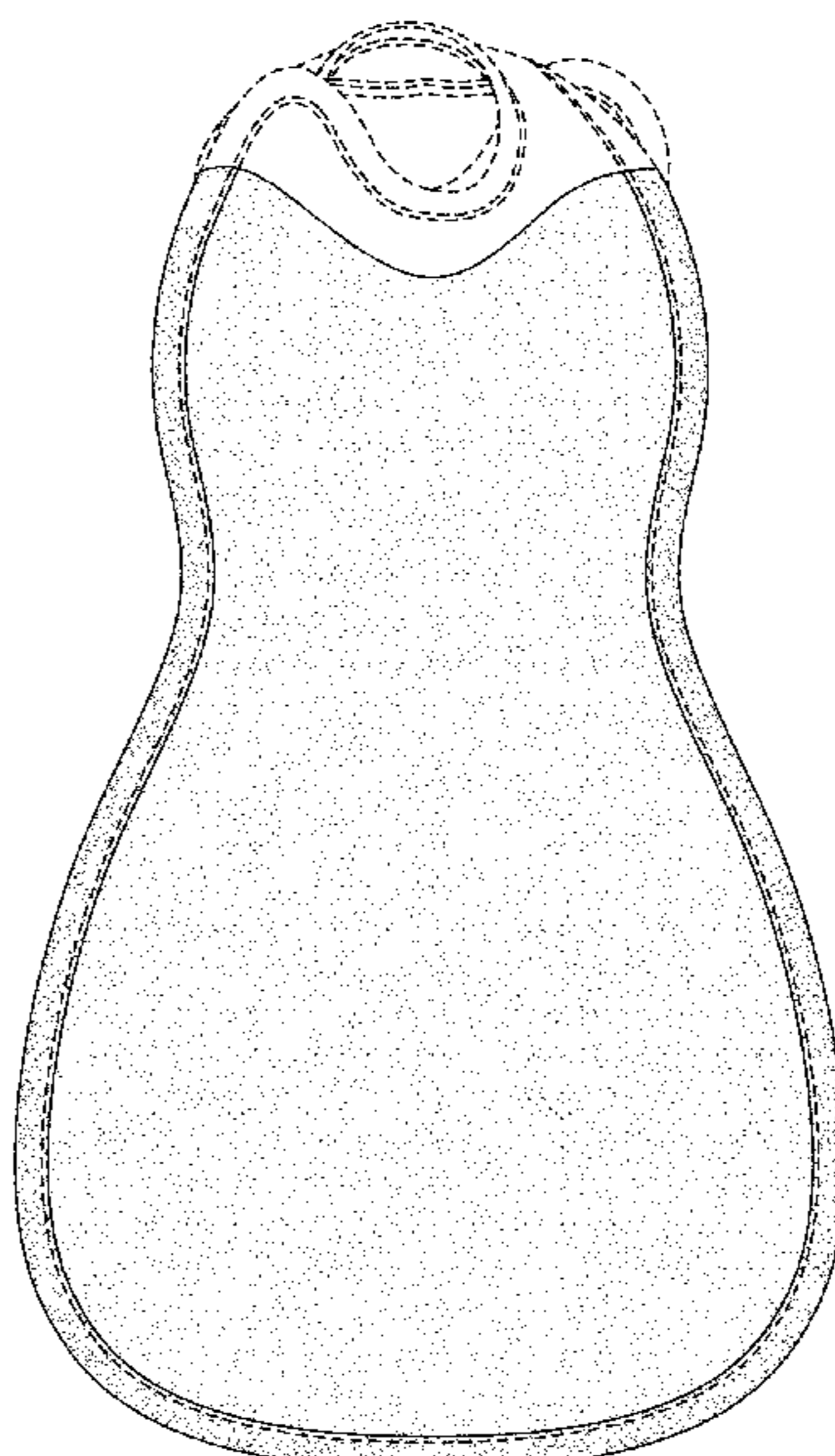
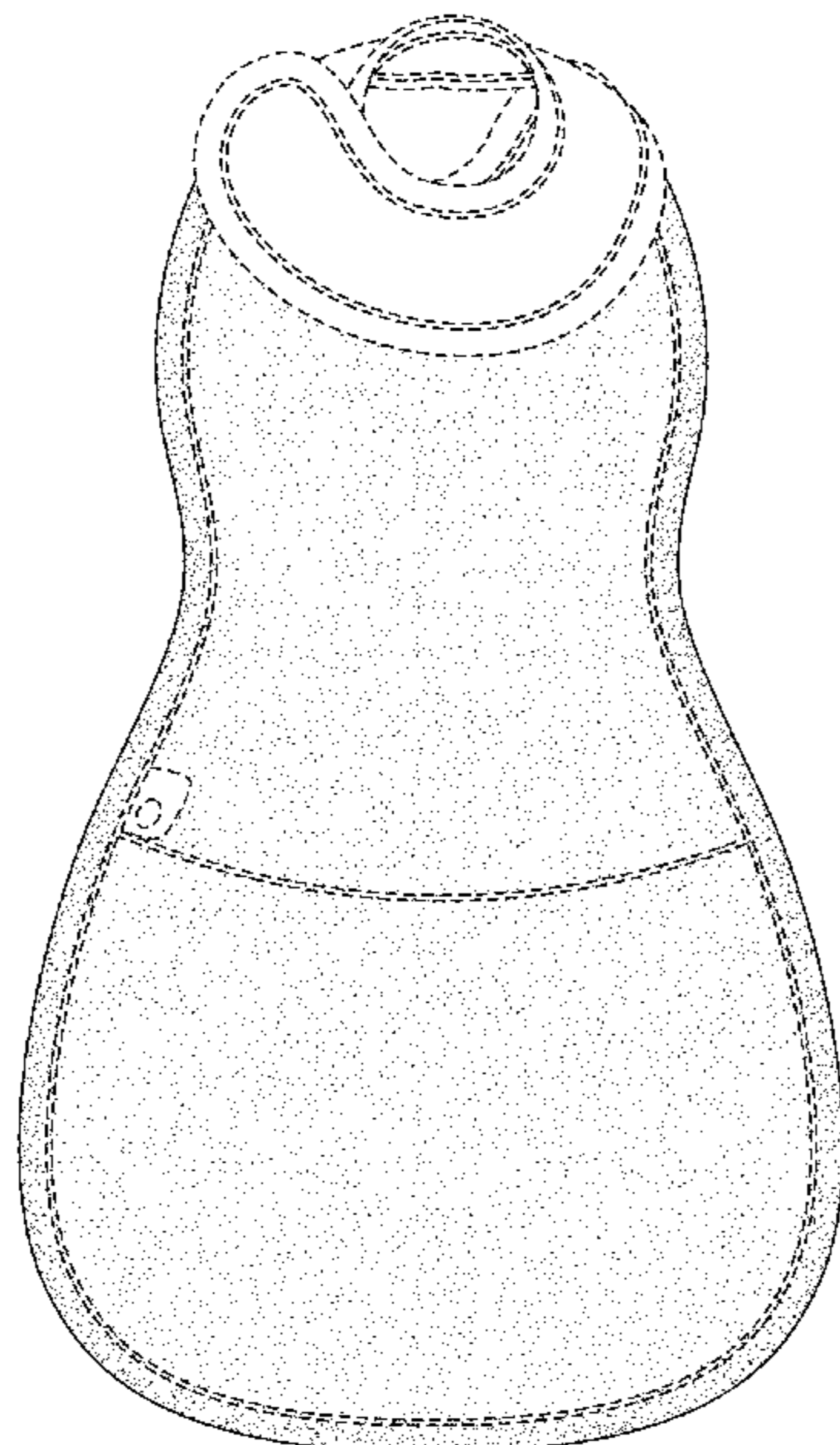
FIG. 5 is a right side elevation view of a torso bib of the present invention, showing the new, original, and ornamental design.

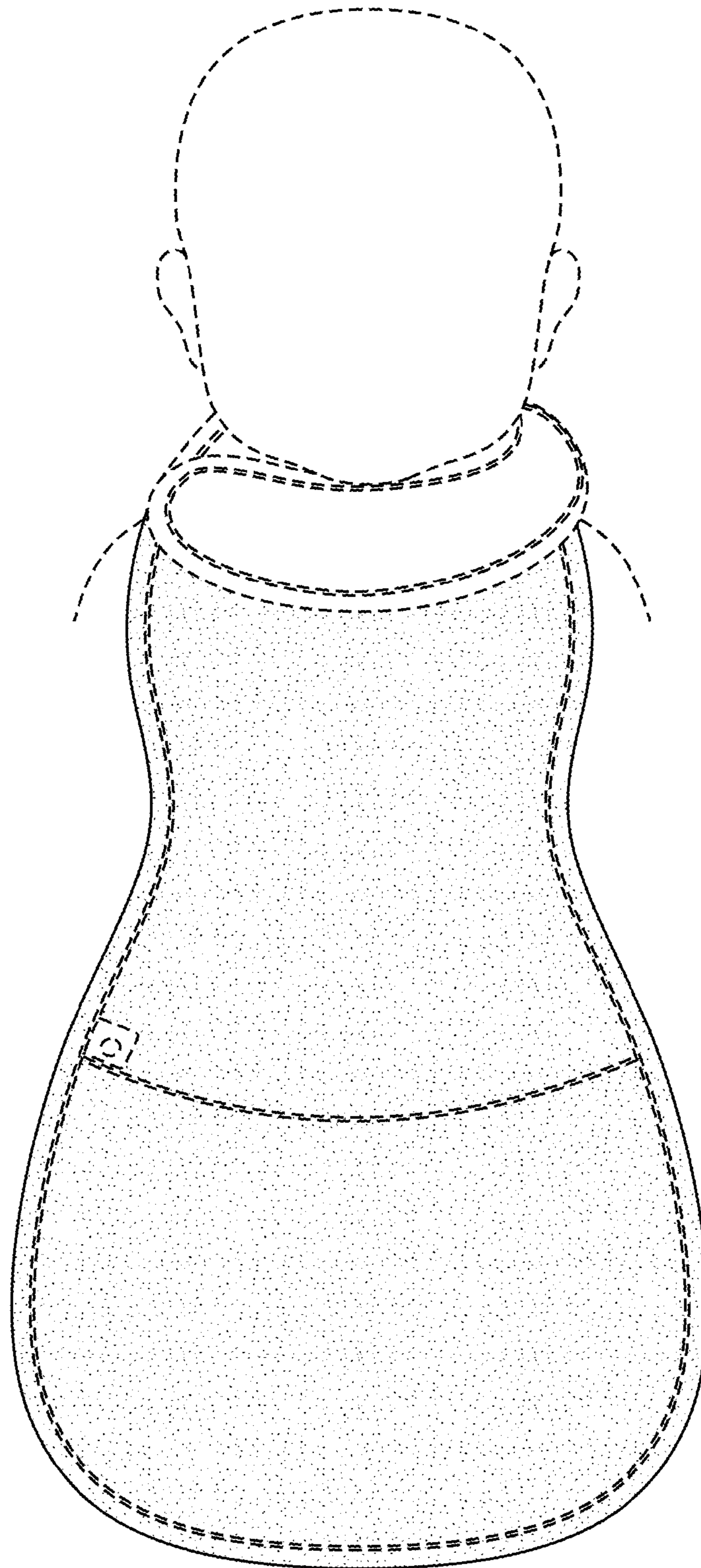

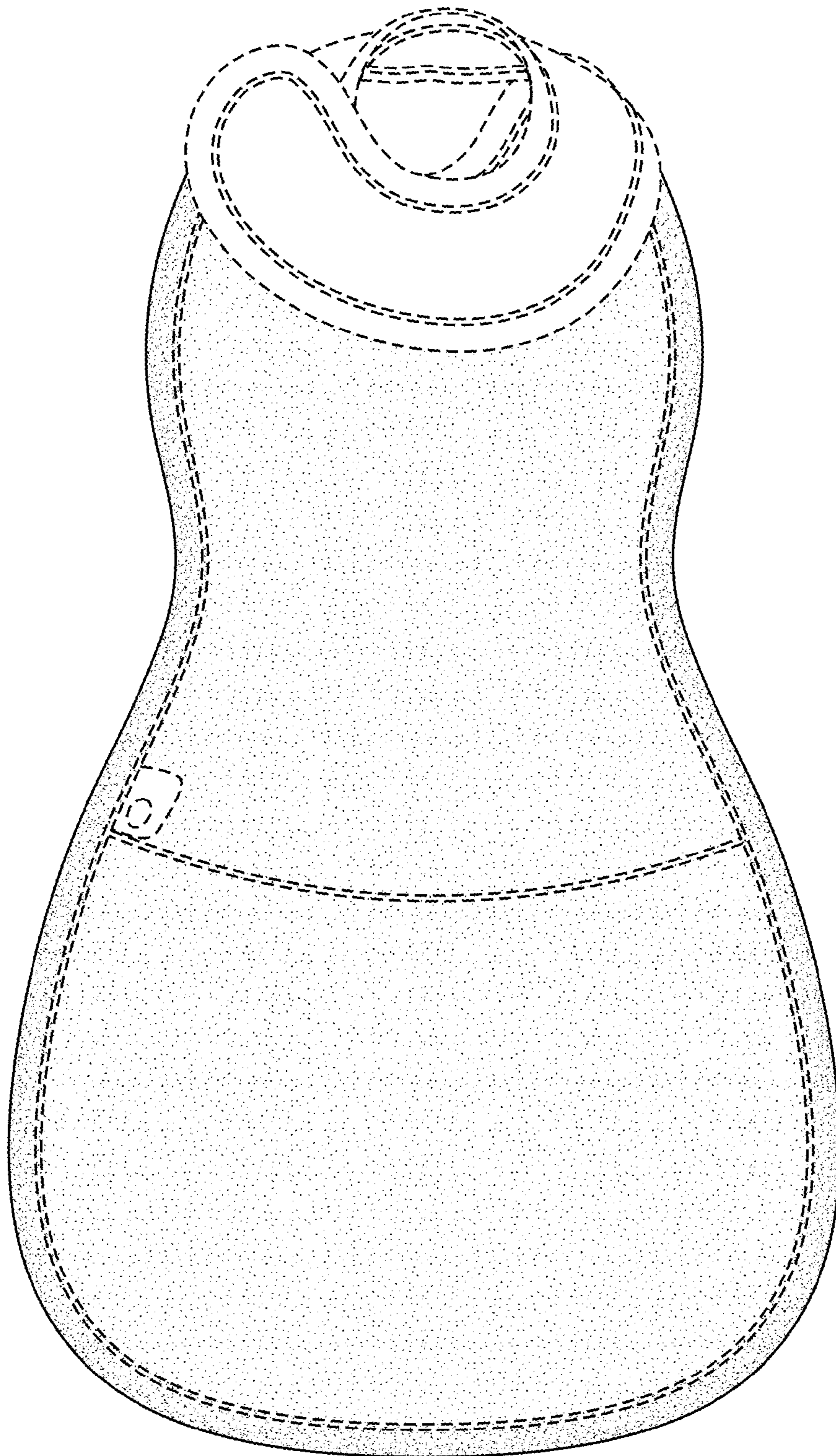

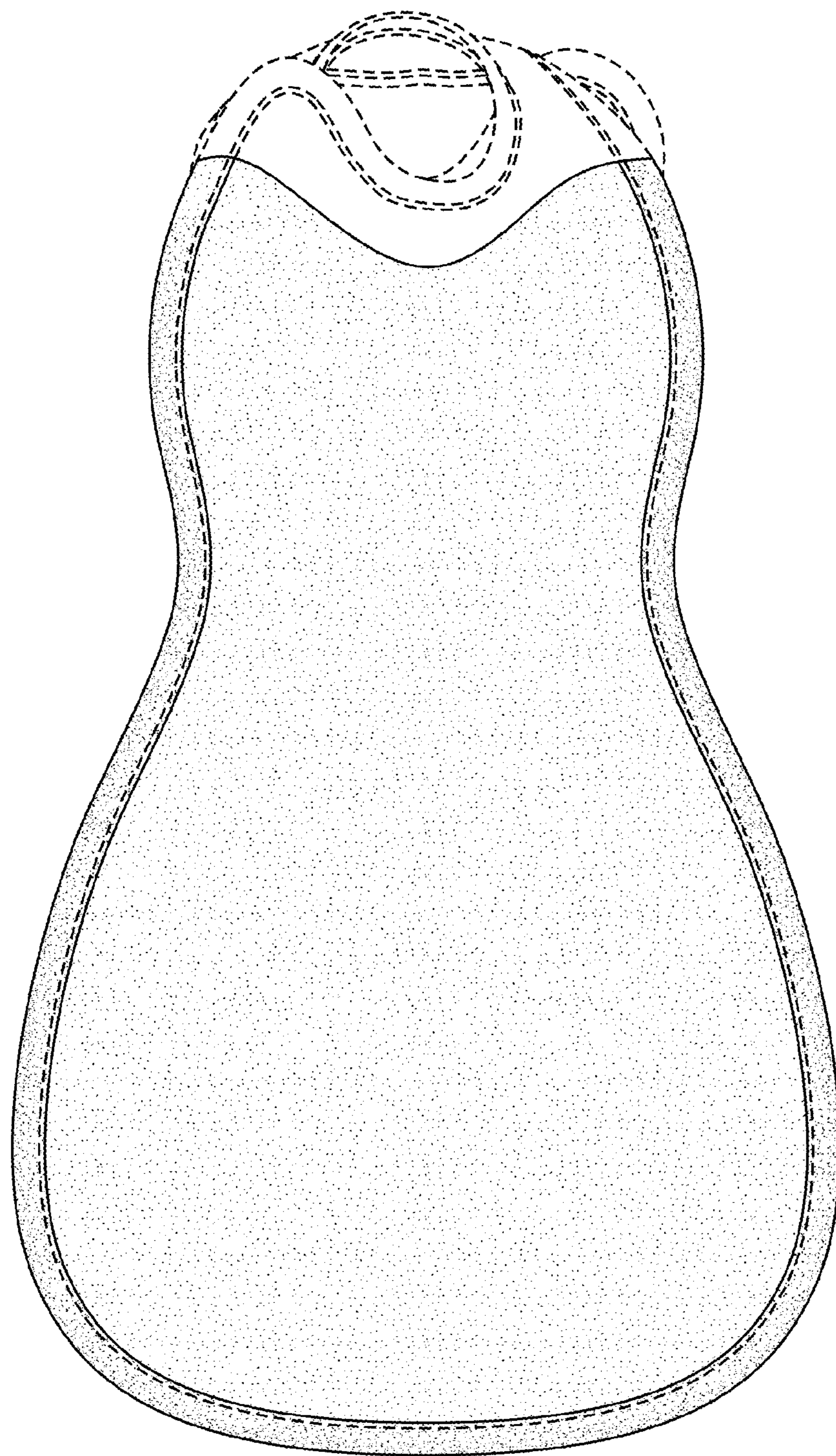

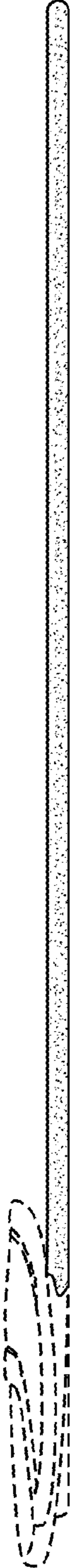
