The ornamental design for a surgical scrub cap with hair bun cover, as shown and described.

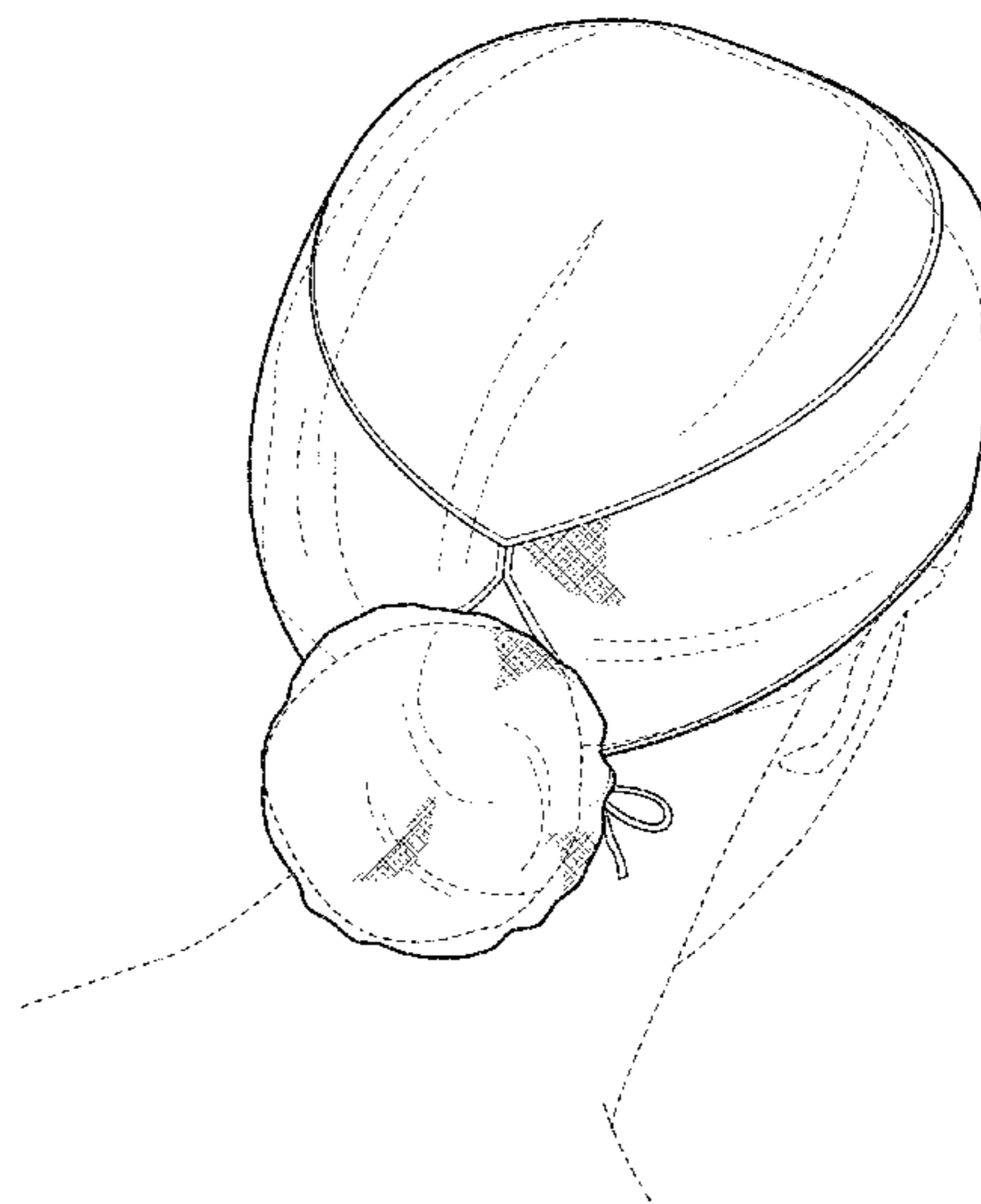
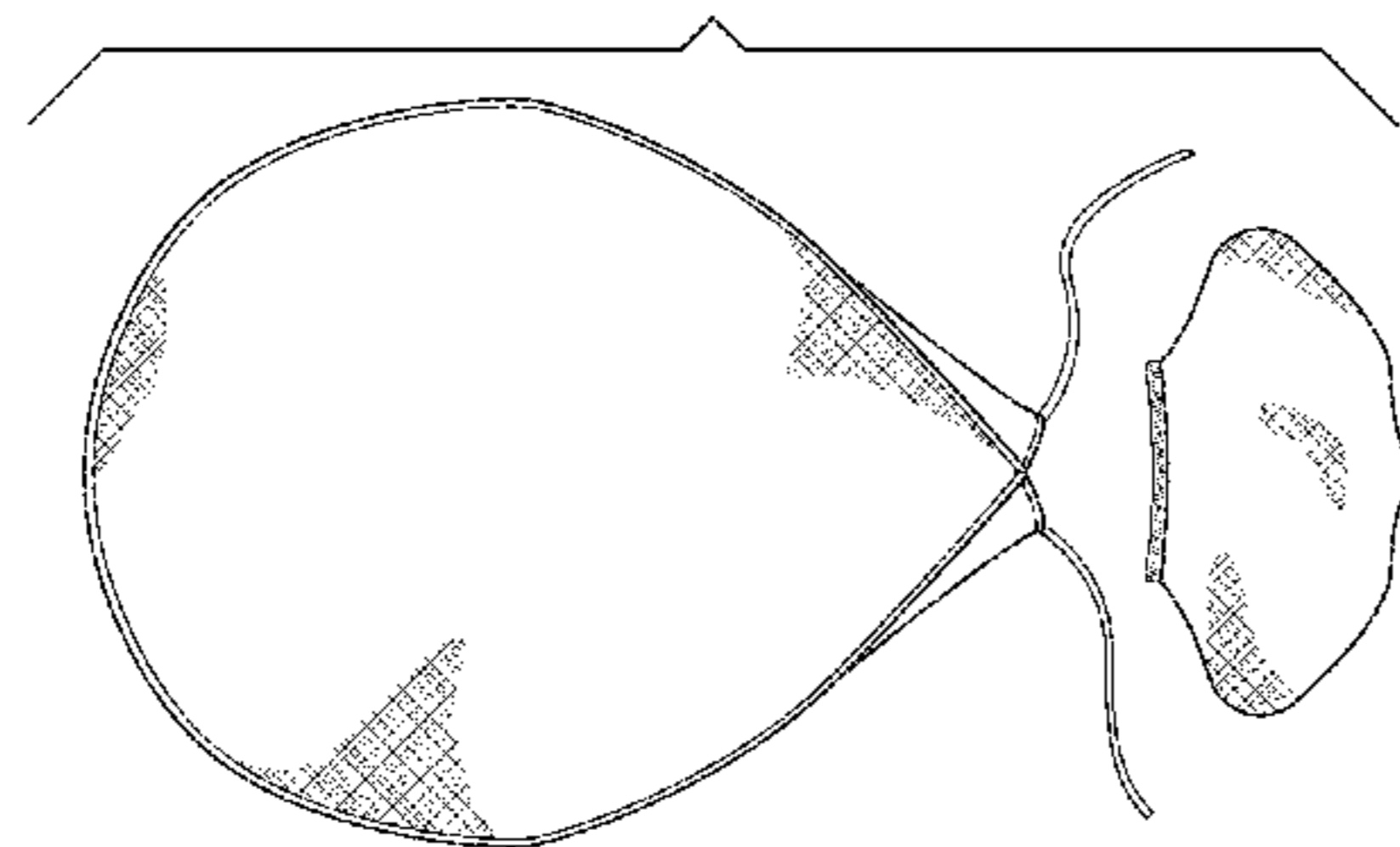
DESCRIPTION

FIG. 1 is a top plan exploded view of the surgical scrub cap with hair bun cover, which embodies my design; FIG. 2 is a bottom plan exploded view thereof; FIG. 3 is a rear elevation exploded view thereof; FIG. 4 is a front elevation exploded view thereof; FIG. 5 is a left side elevation exploded view thereof; FIG. 6 is a right side elevation exploded view thereof; and, FIG. 7 is a rear perspective view showing my new design in a position of use.

The broken lines showing a partial human figure illustrate environmental subject matter included to depict how the claimed design may appear when worn and forms no part of the claimed design.

The hatching shown on the claimed design illustrates netting.

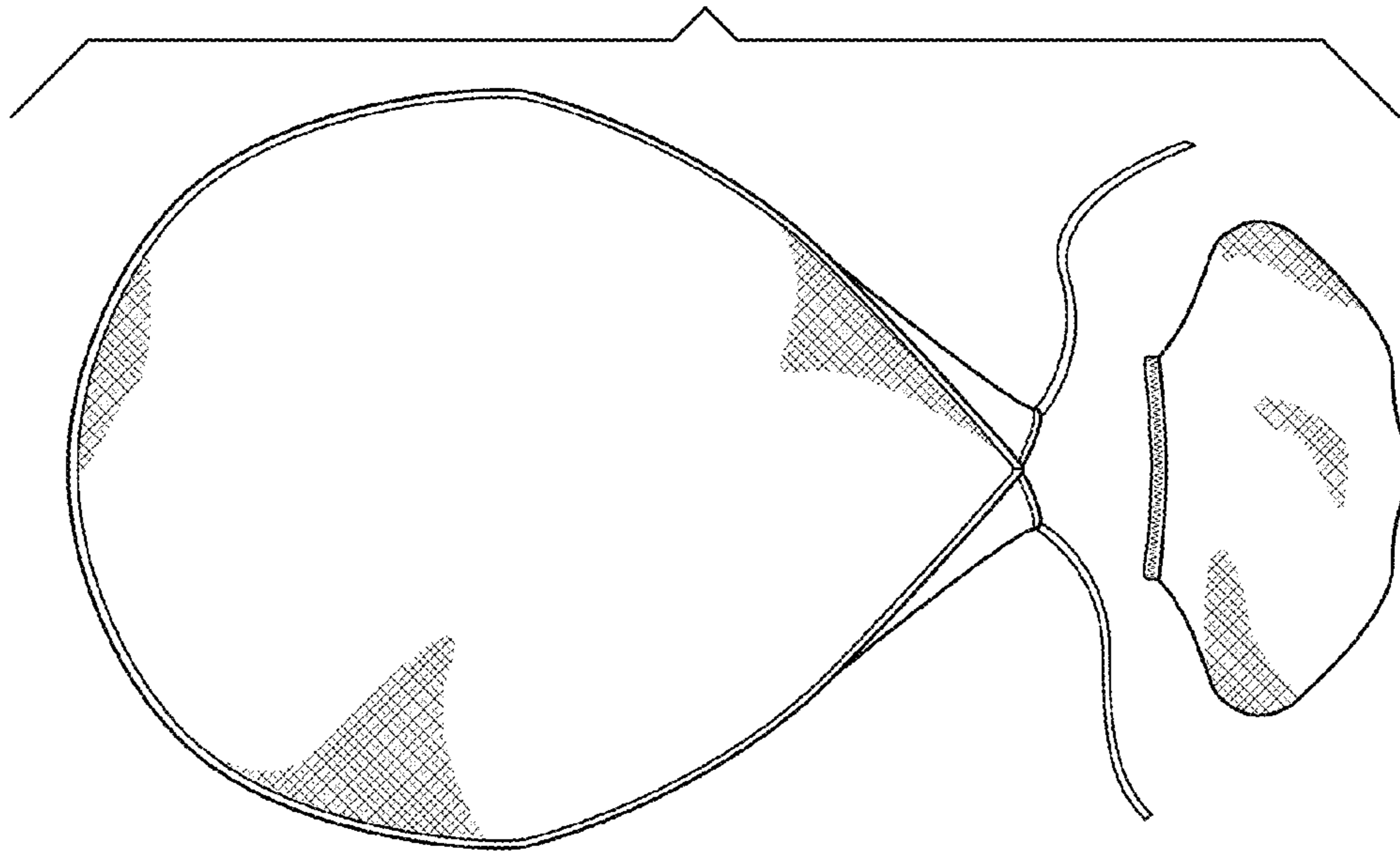

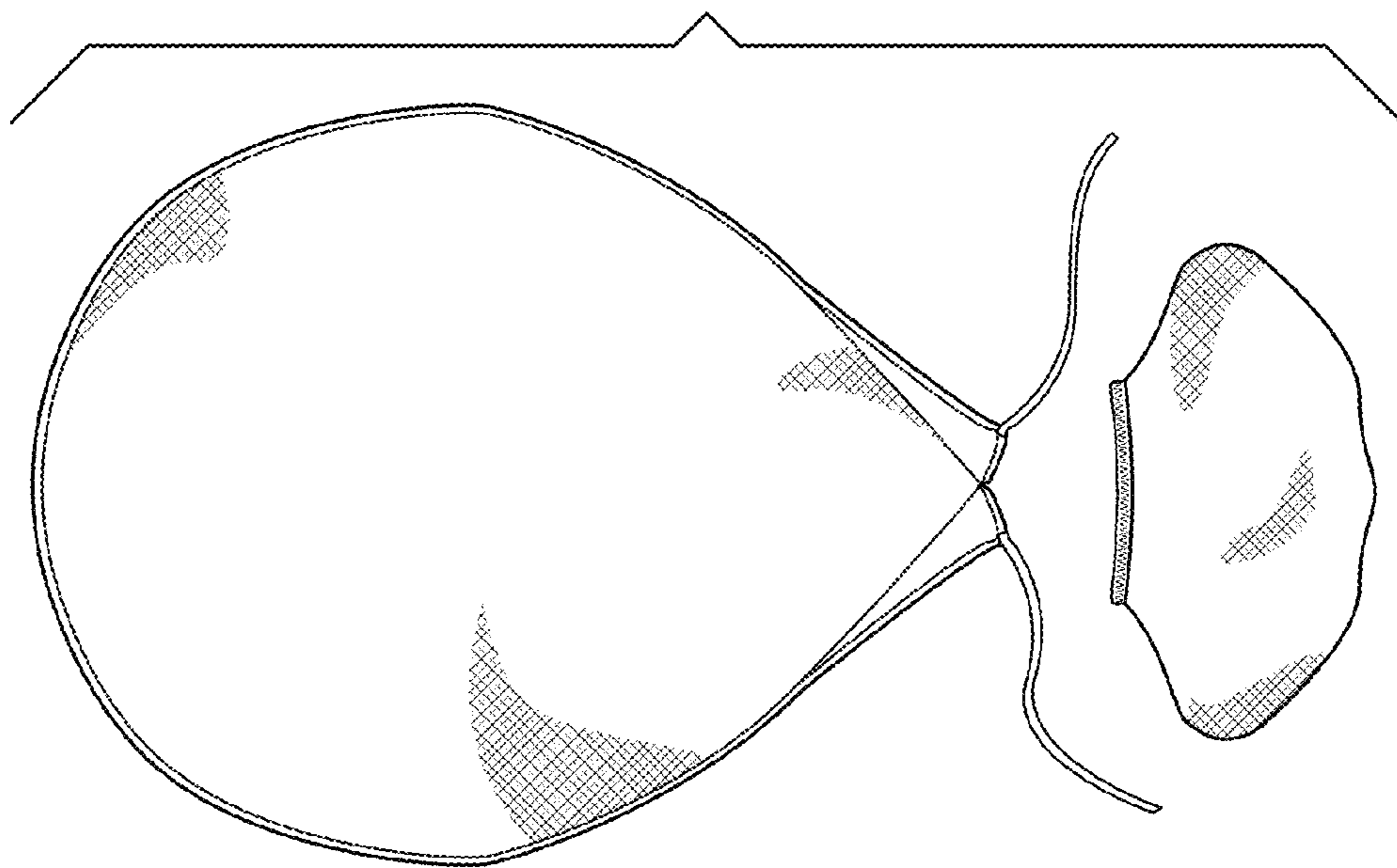

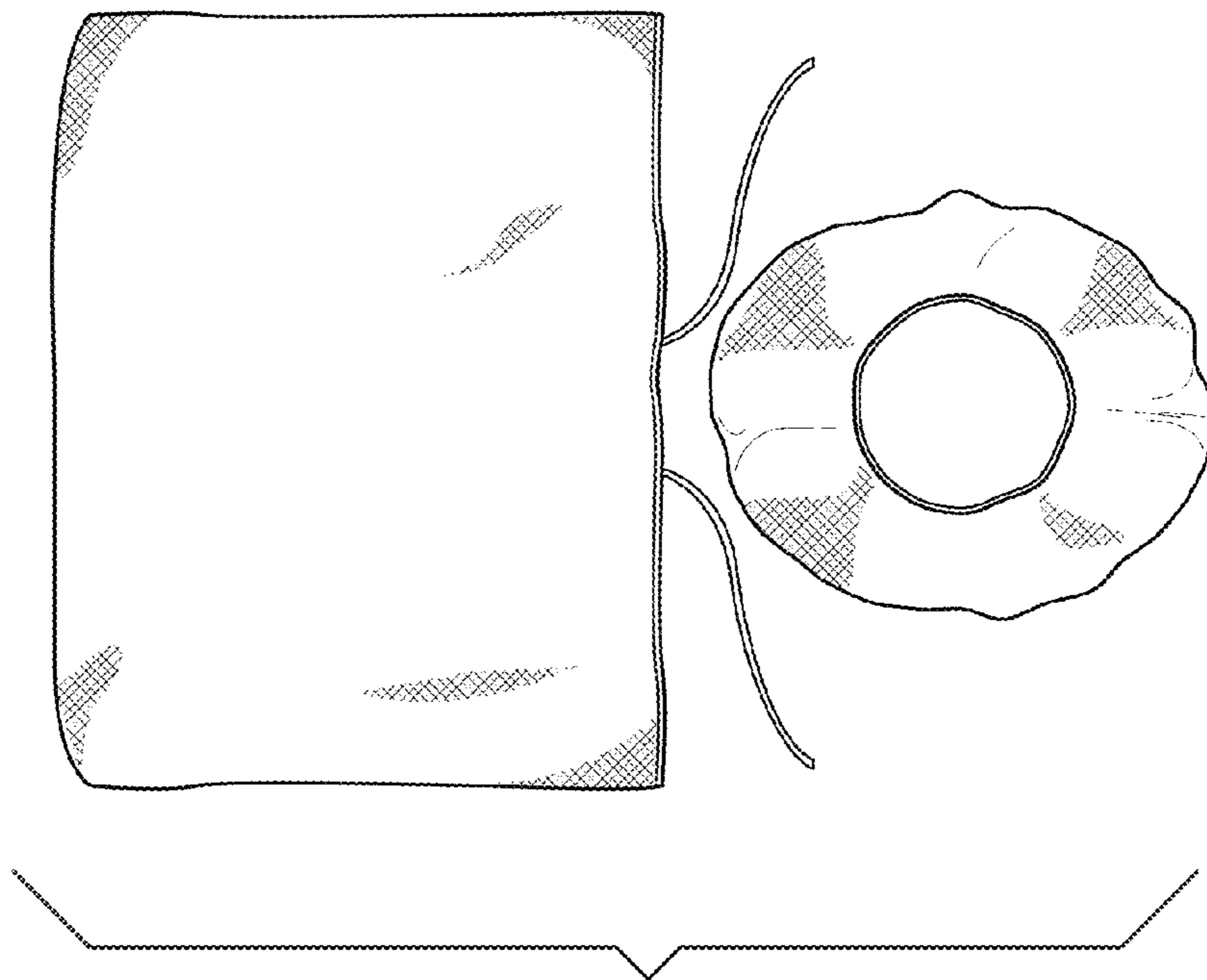

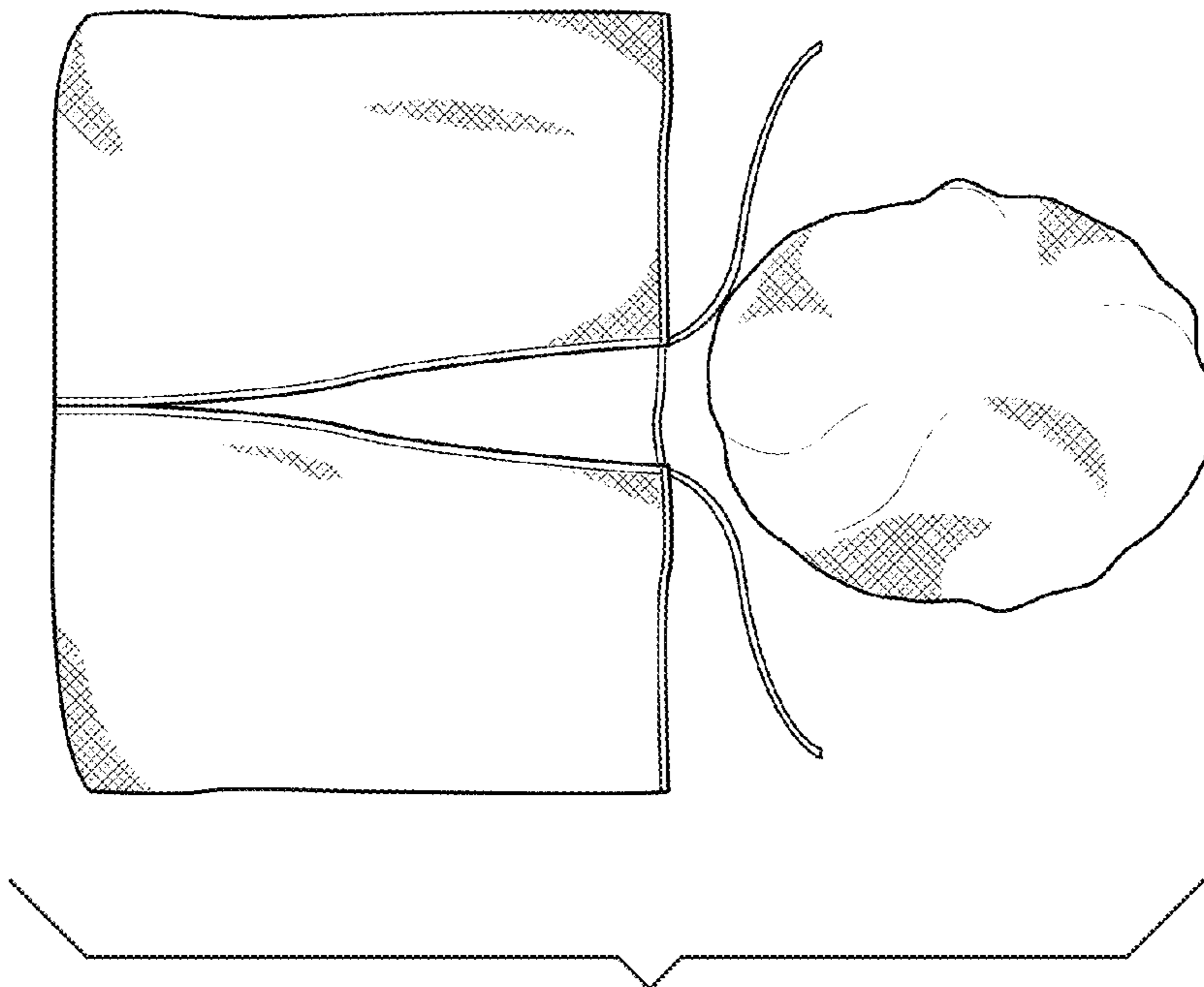

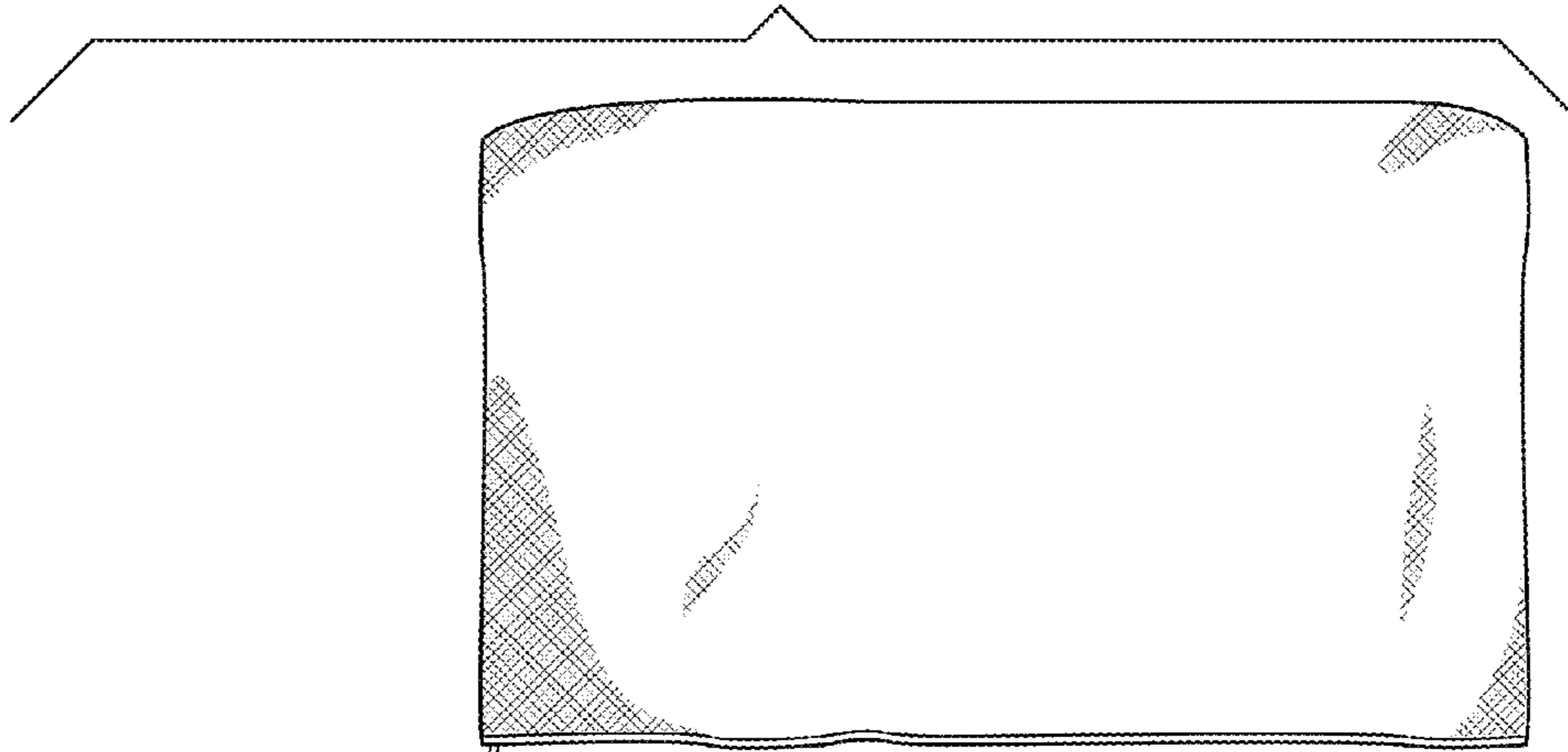

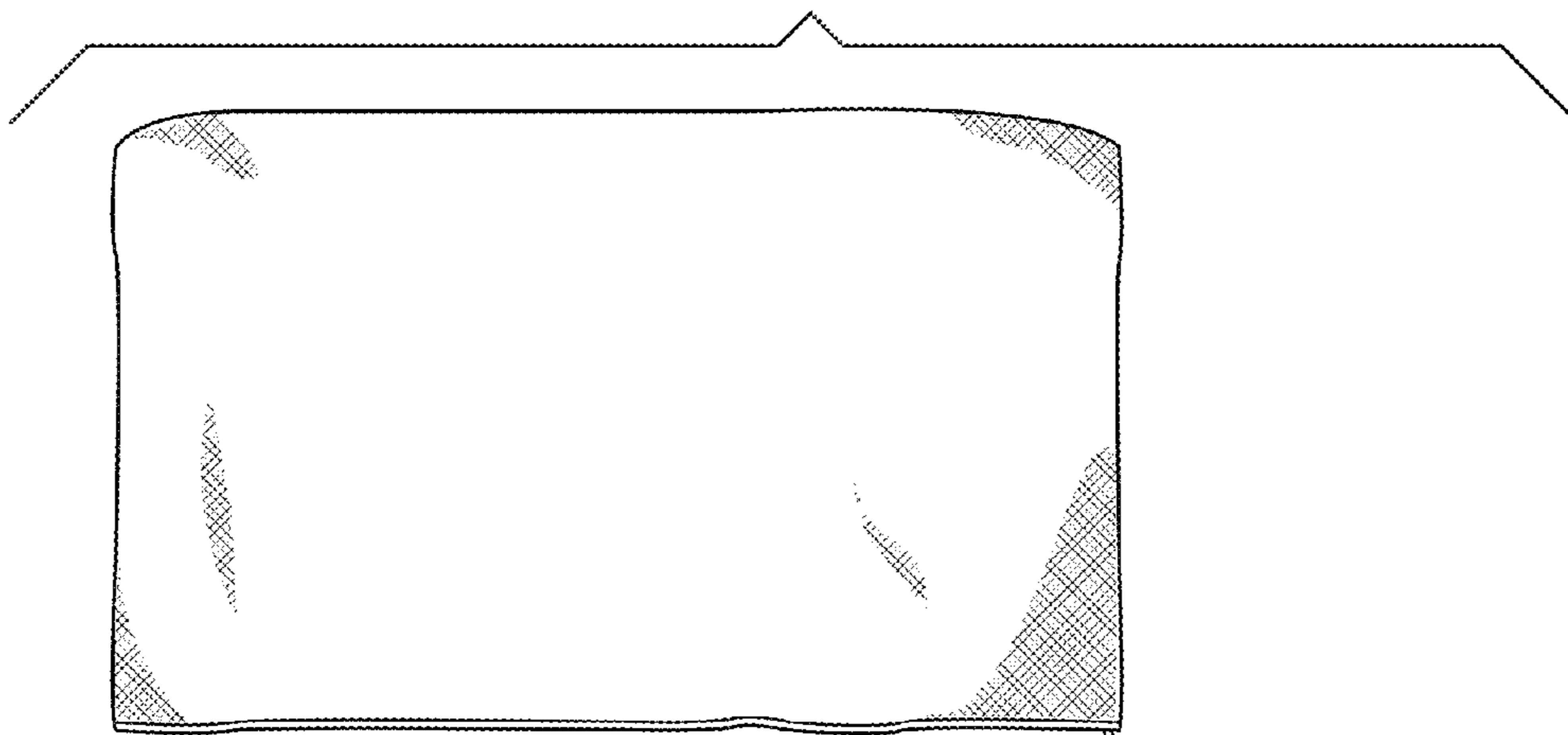
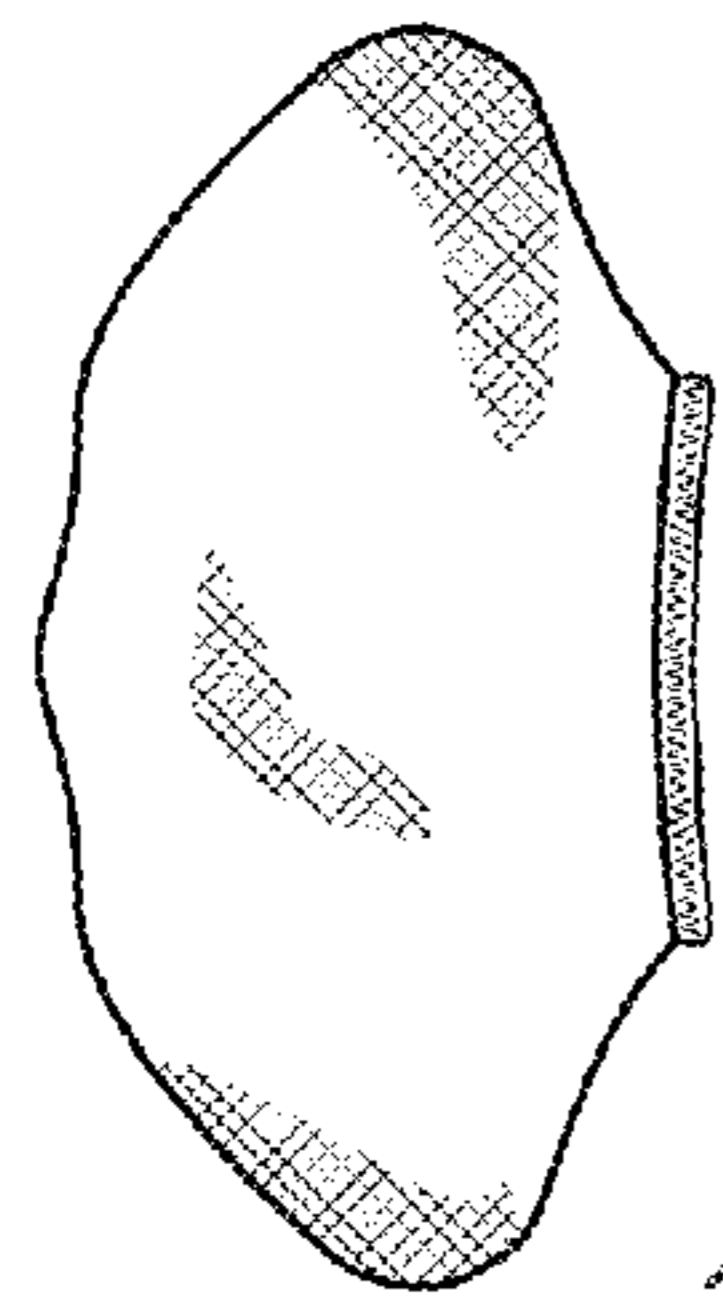

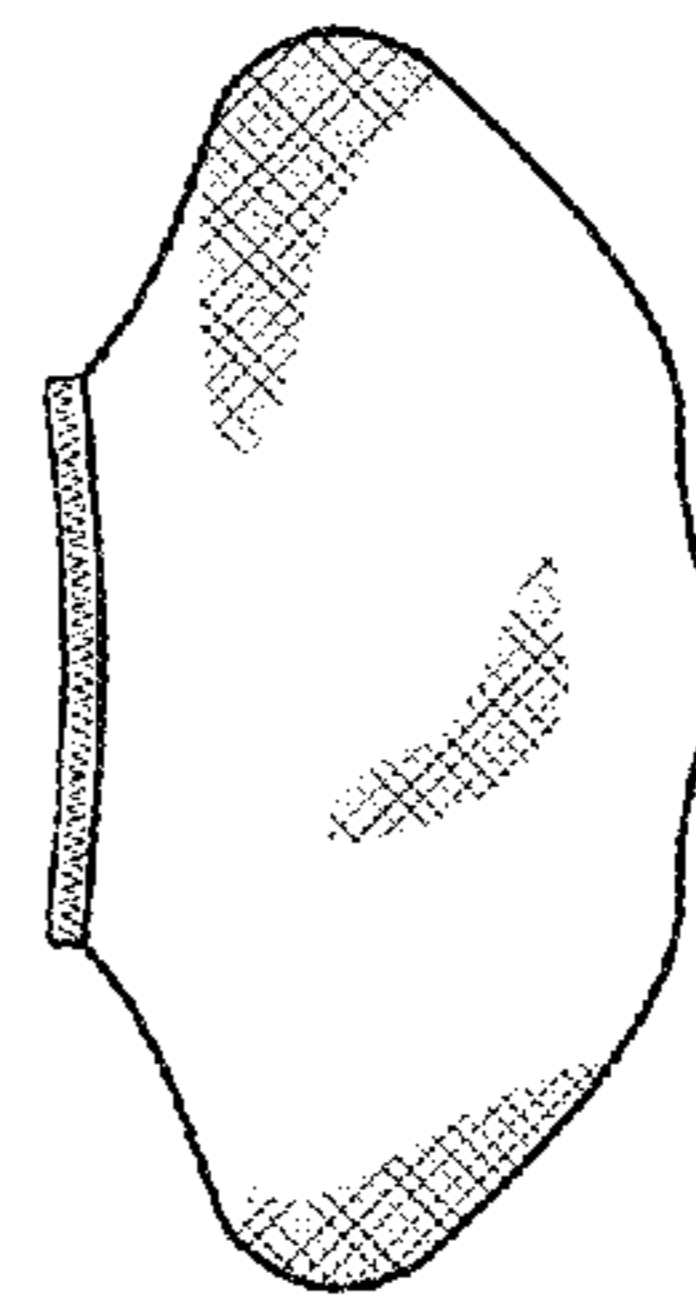
