(57) **CLAIM**

The ornamental design for a paper product with a surface pattern, as shown and described.

DESCRIPTION

The sole FIGURE is a plan view of one side of the paper product with a surface pattern showing our new design. The broken lines shown surrounding the design in the sole FIGURE represent the boundaries of the claimed design for a paper product with a surface pattern and do not form part of the claimed design. The claimed design repeats uniformly throughout the surface of the paper product with a surface pattern.
