FIG. 4 shows a top view thereof.

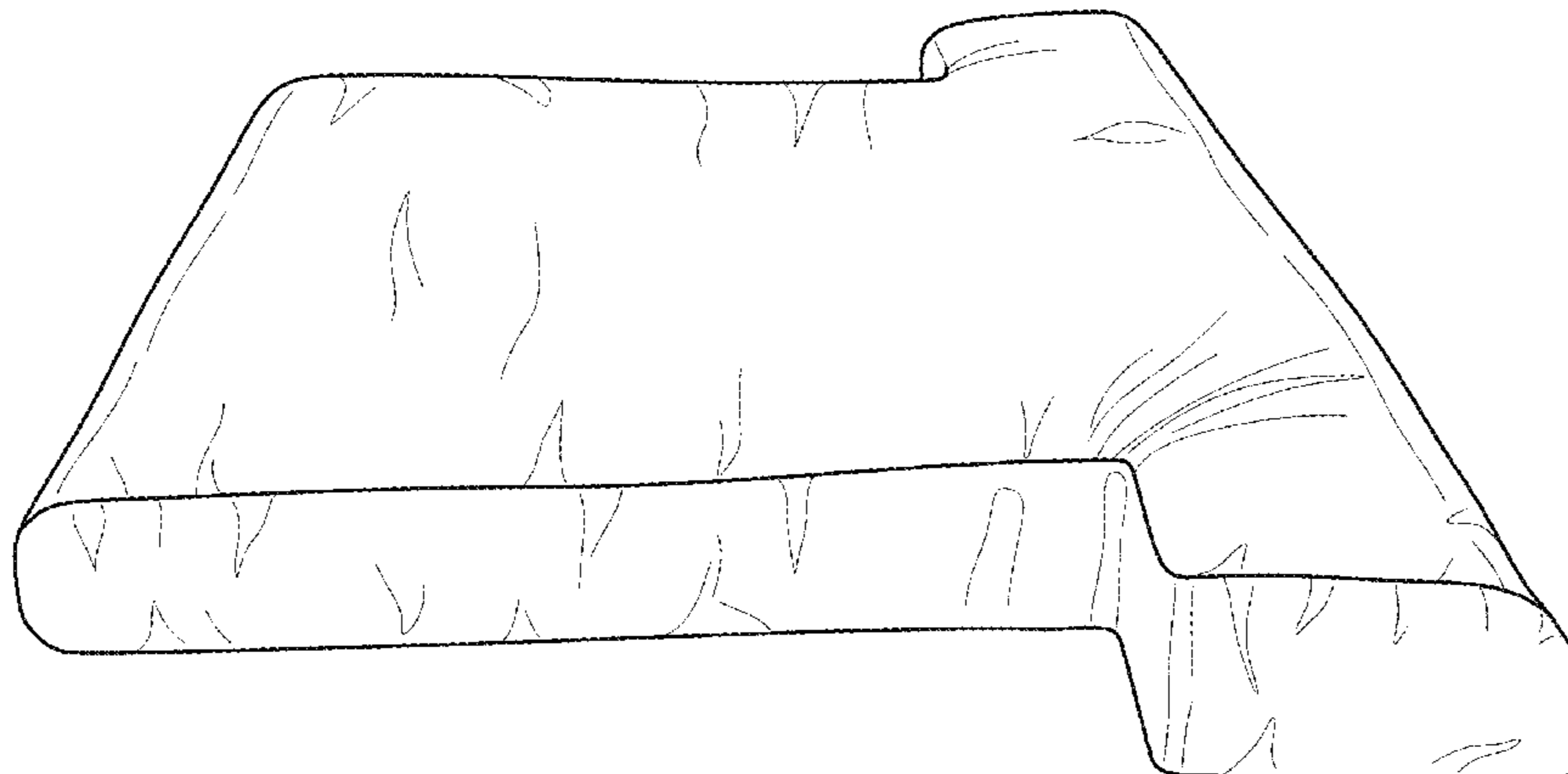
FIG. 5 shows a bottom view thereof.

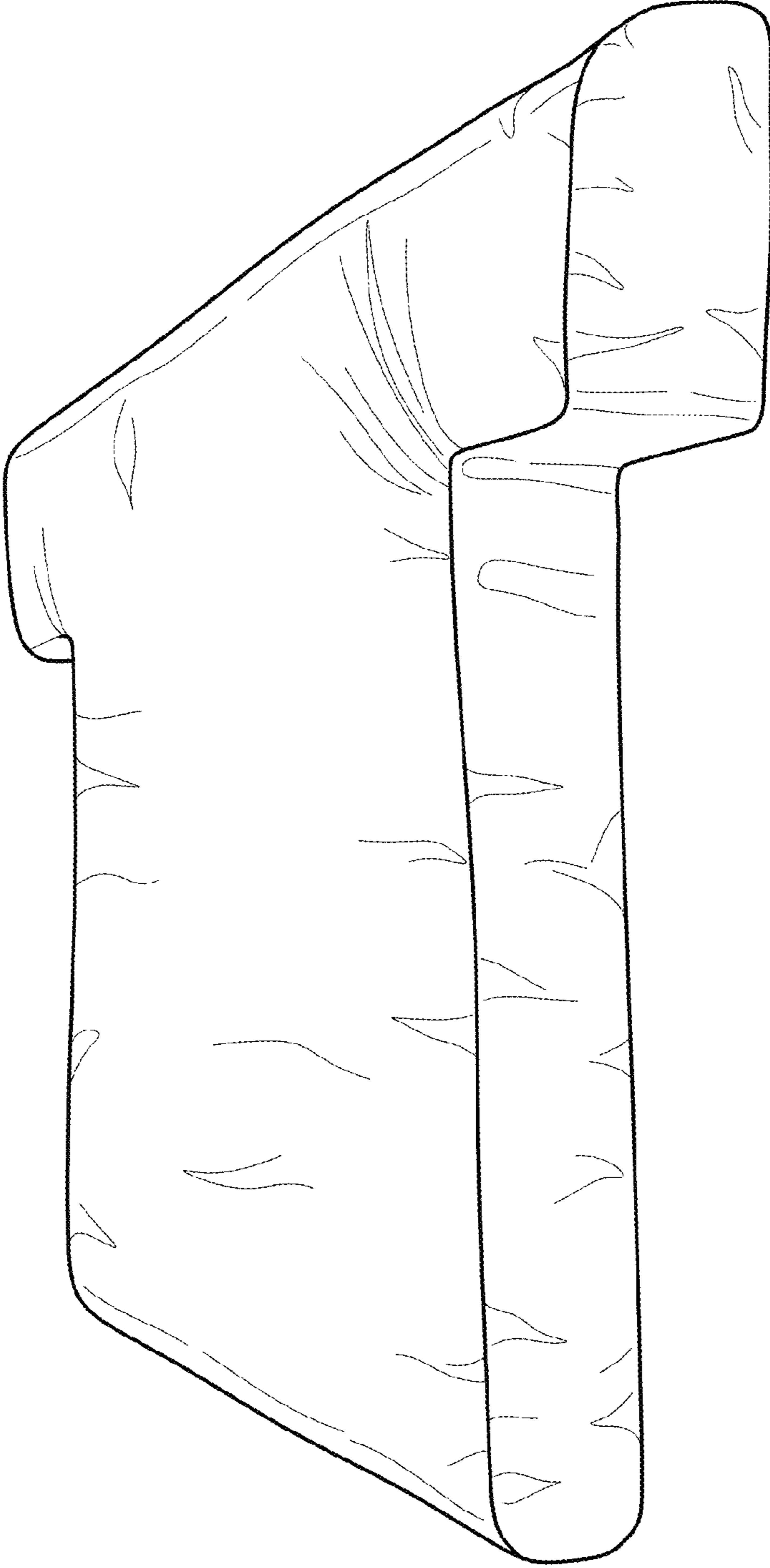

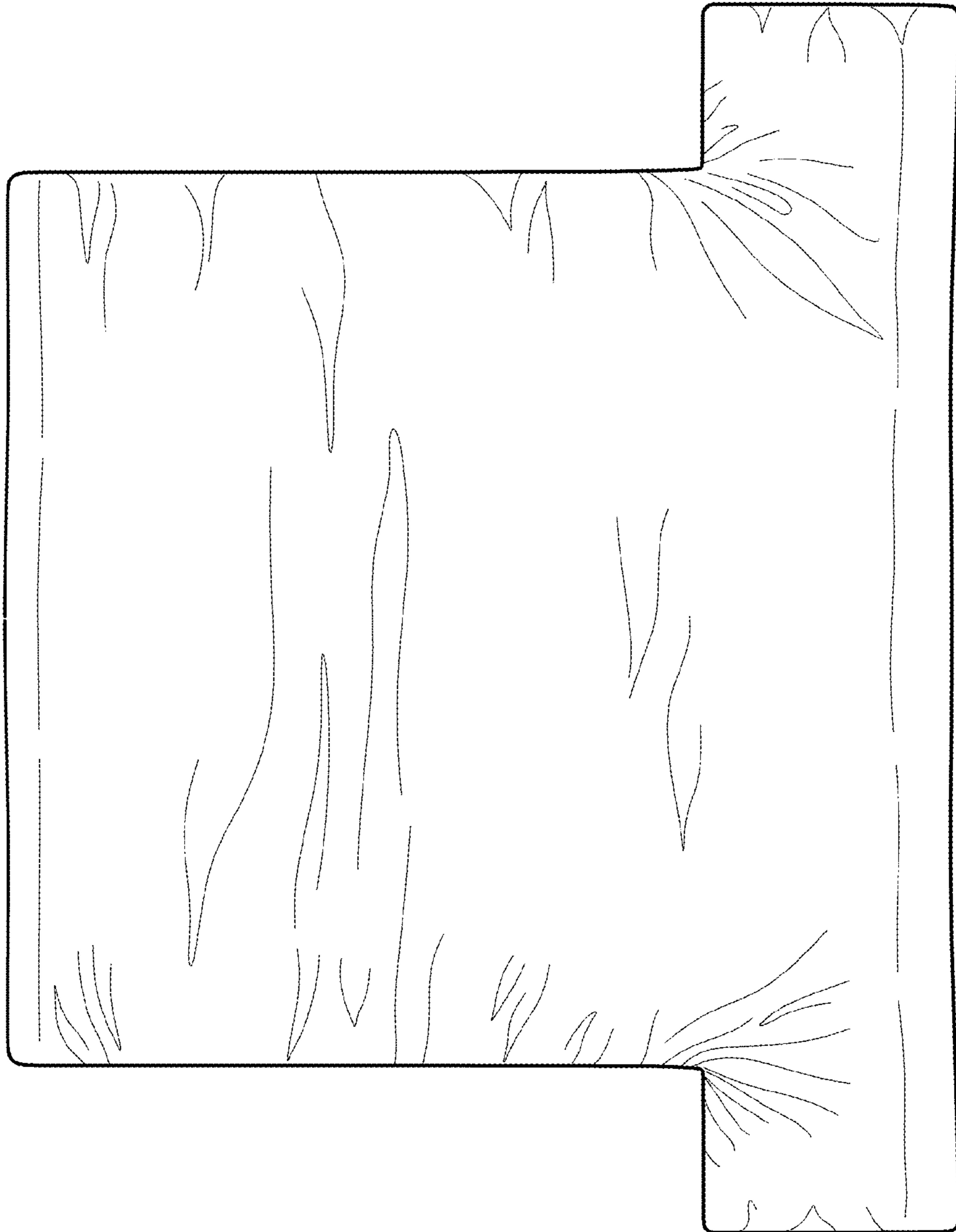

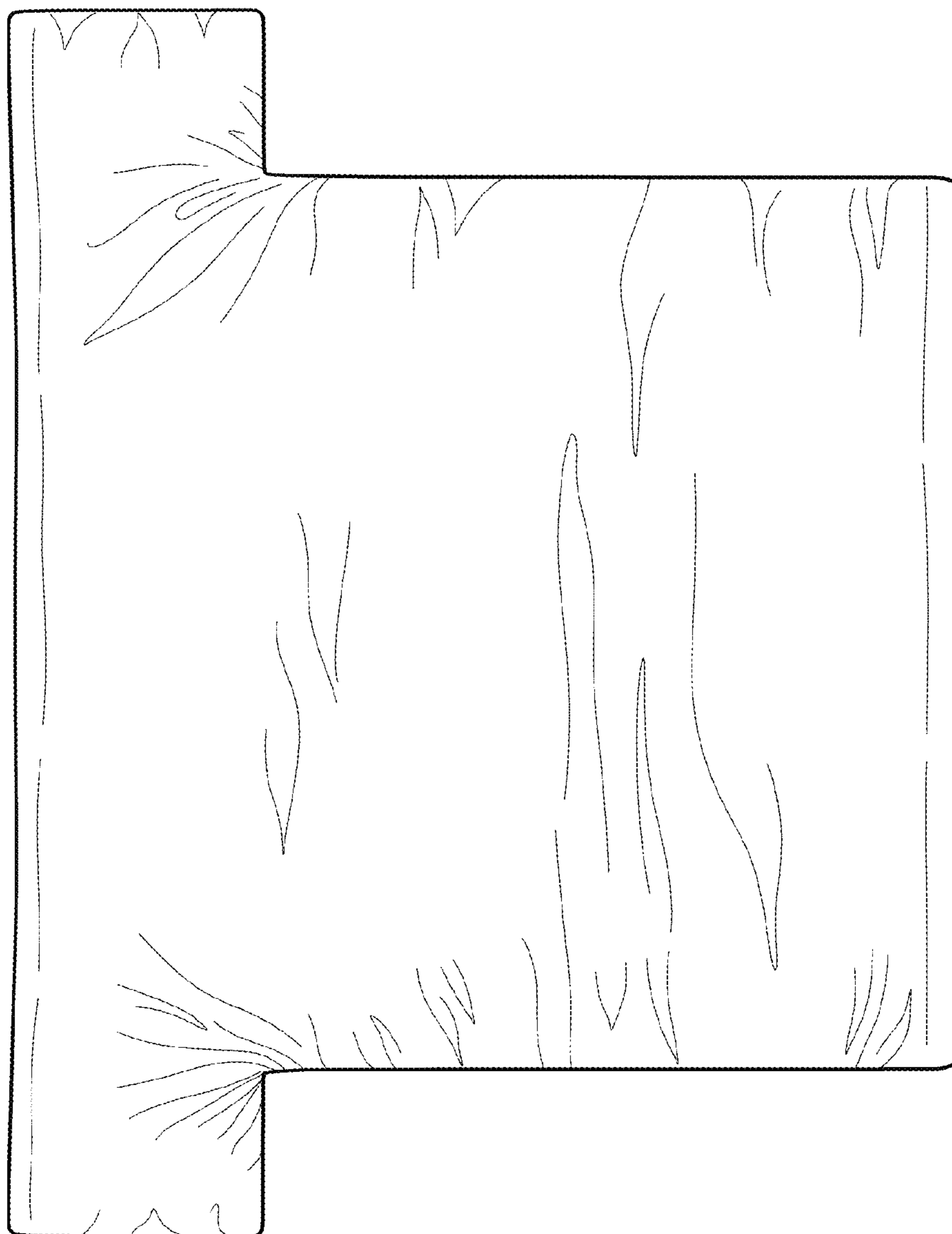

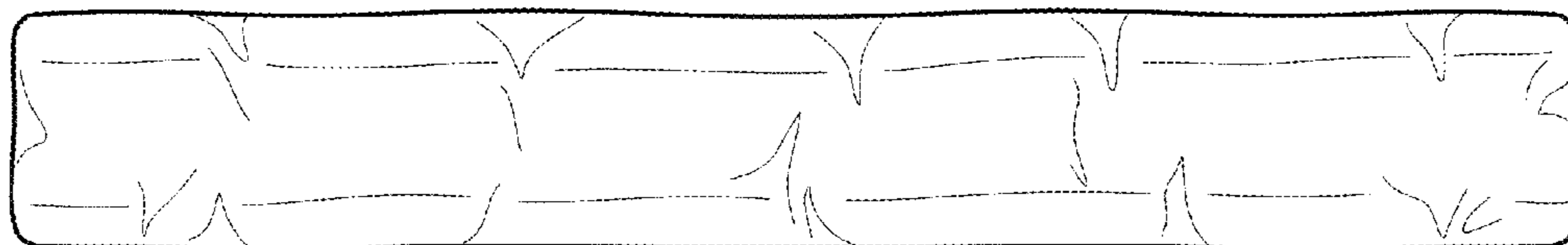

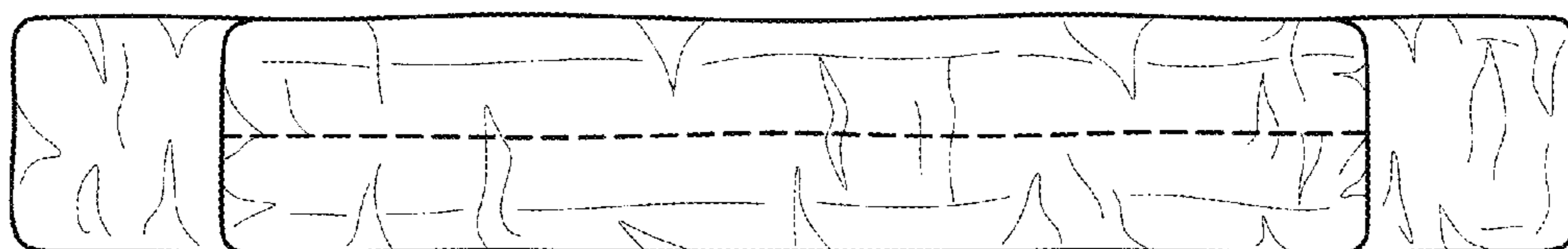

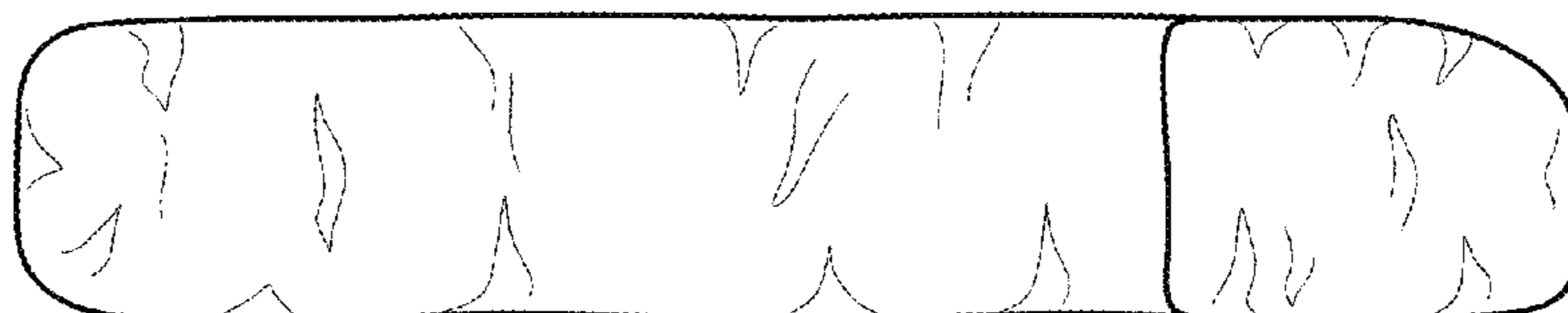

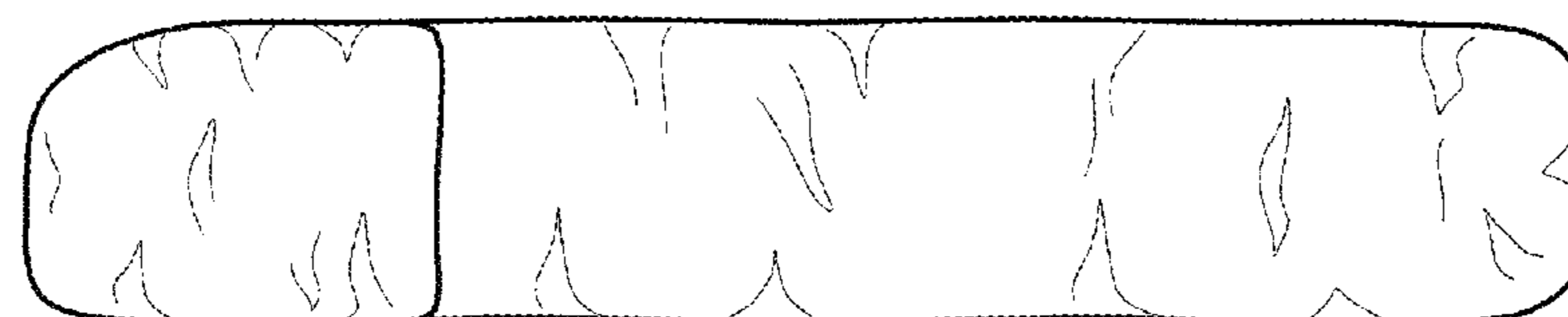
