I claim an ornamental design for a folding table, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view showing my new design.

FIG. 3 is a top view thereof.

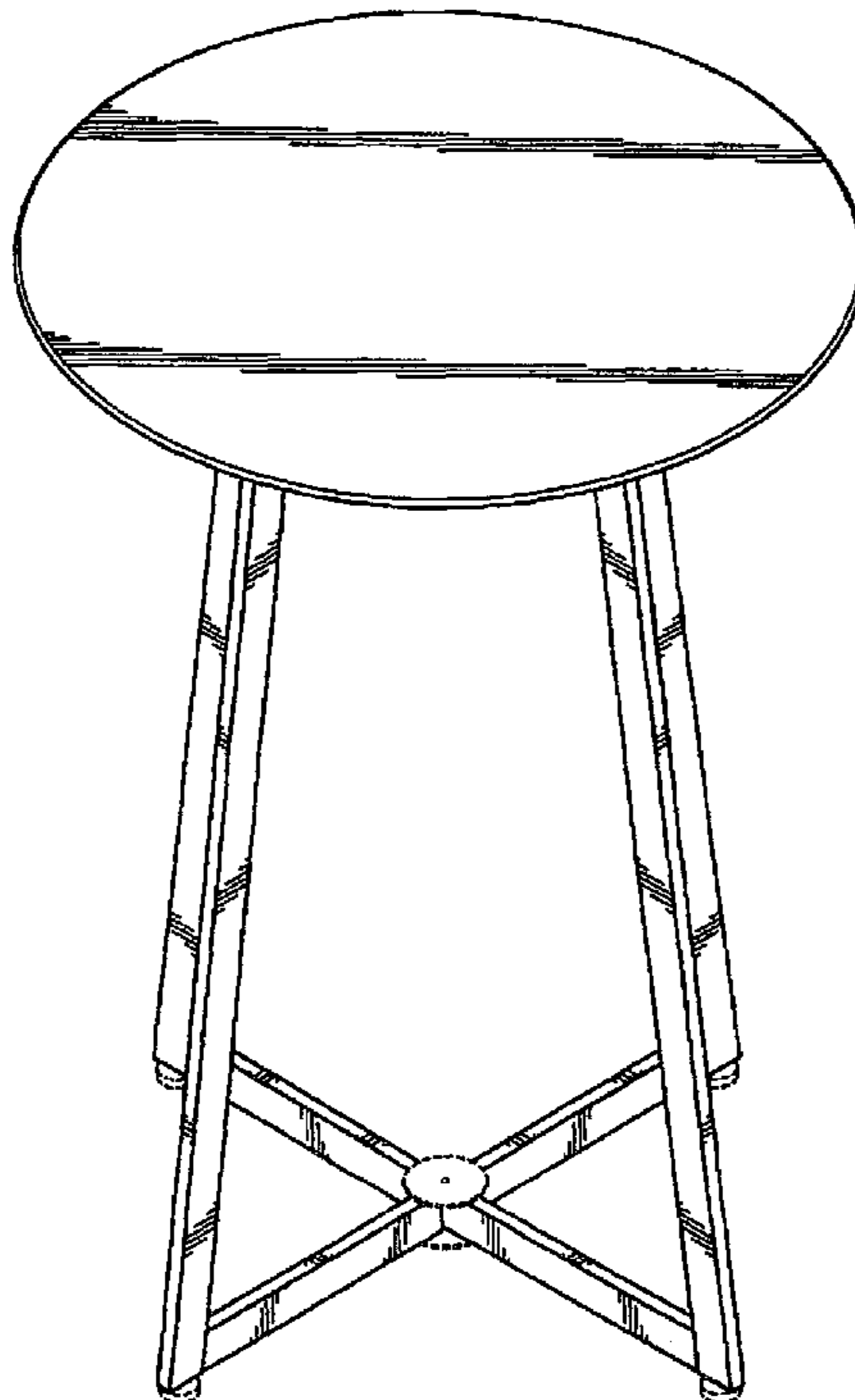
FIG. 4 is a bottom view thereof.

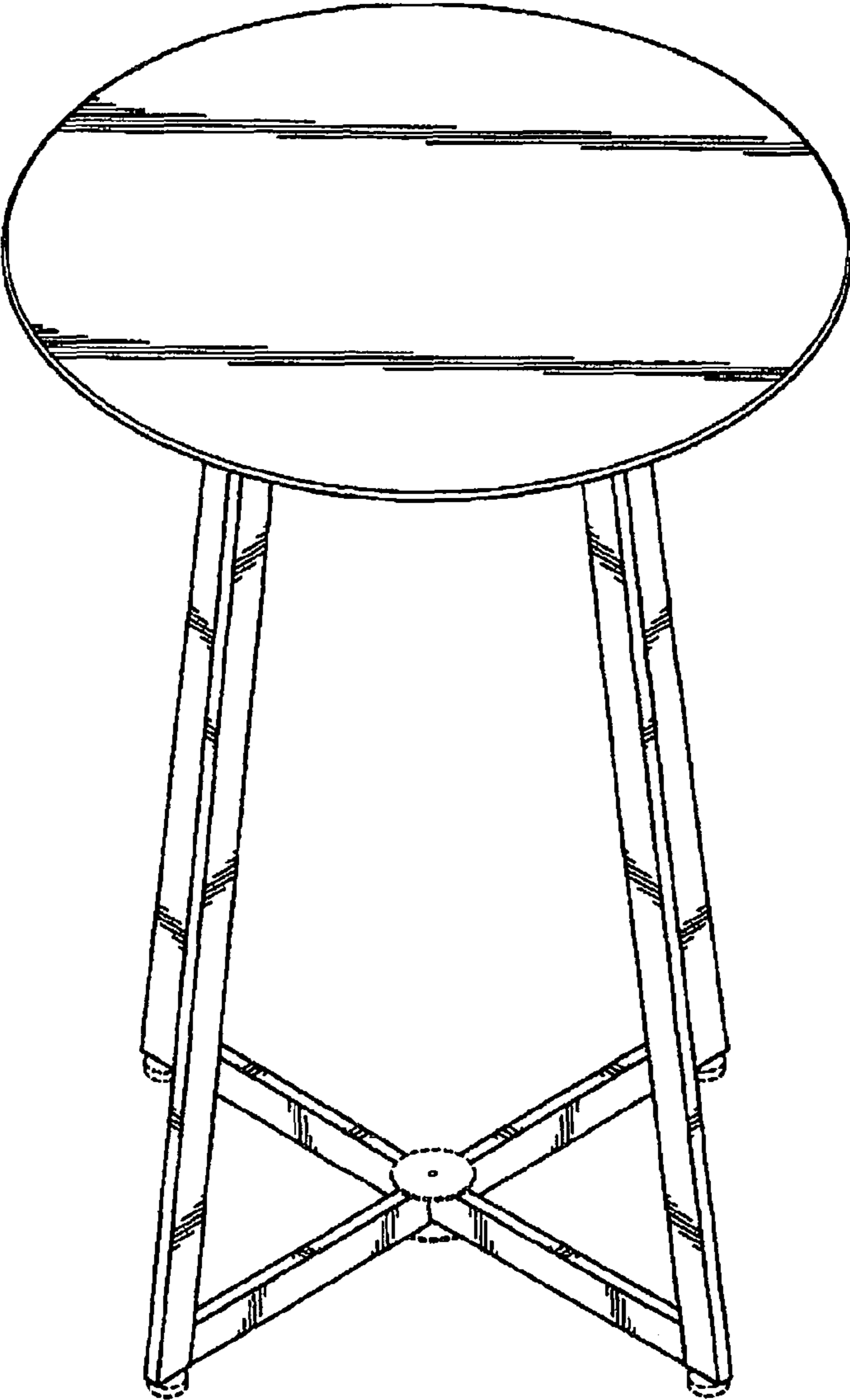

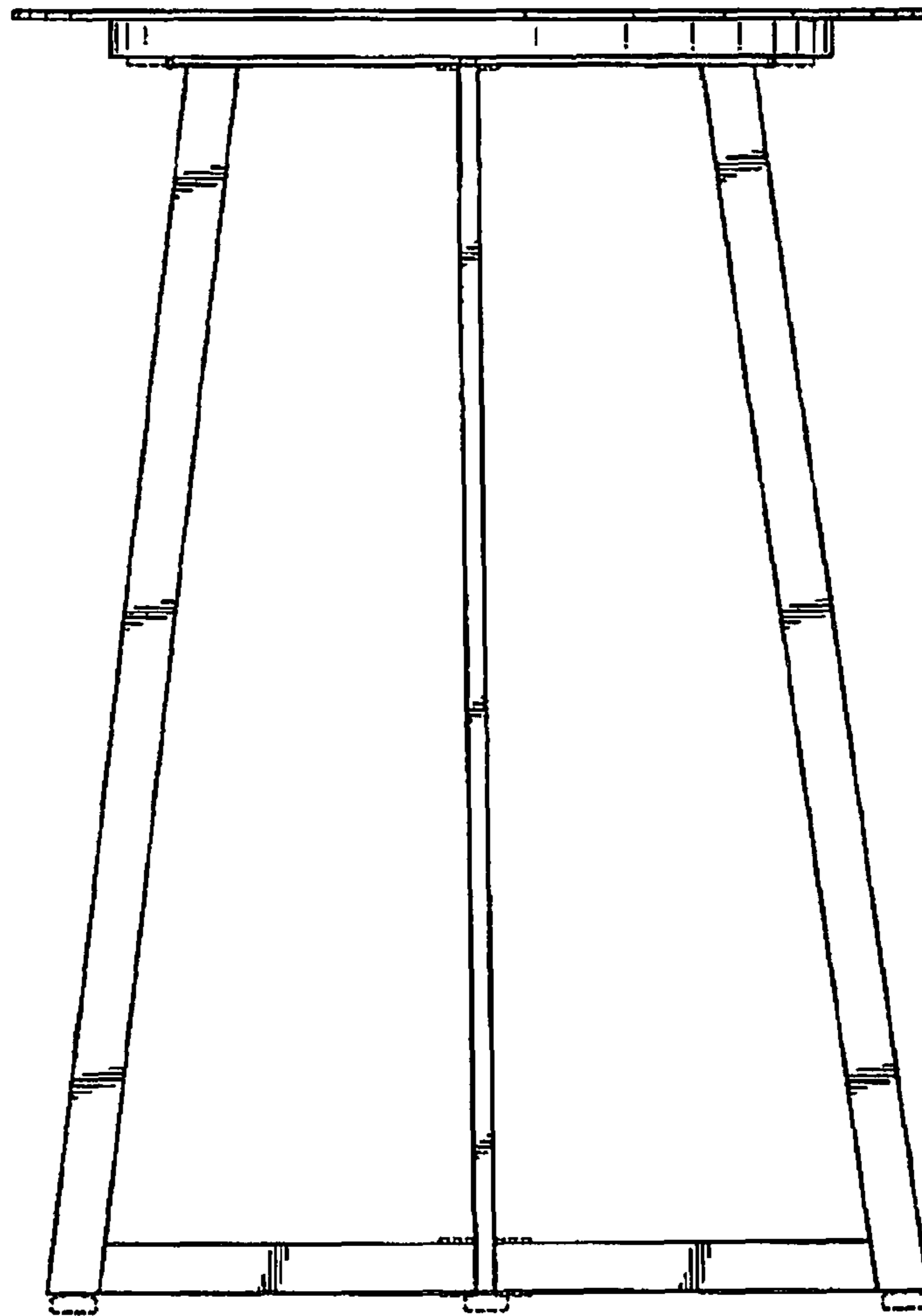

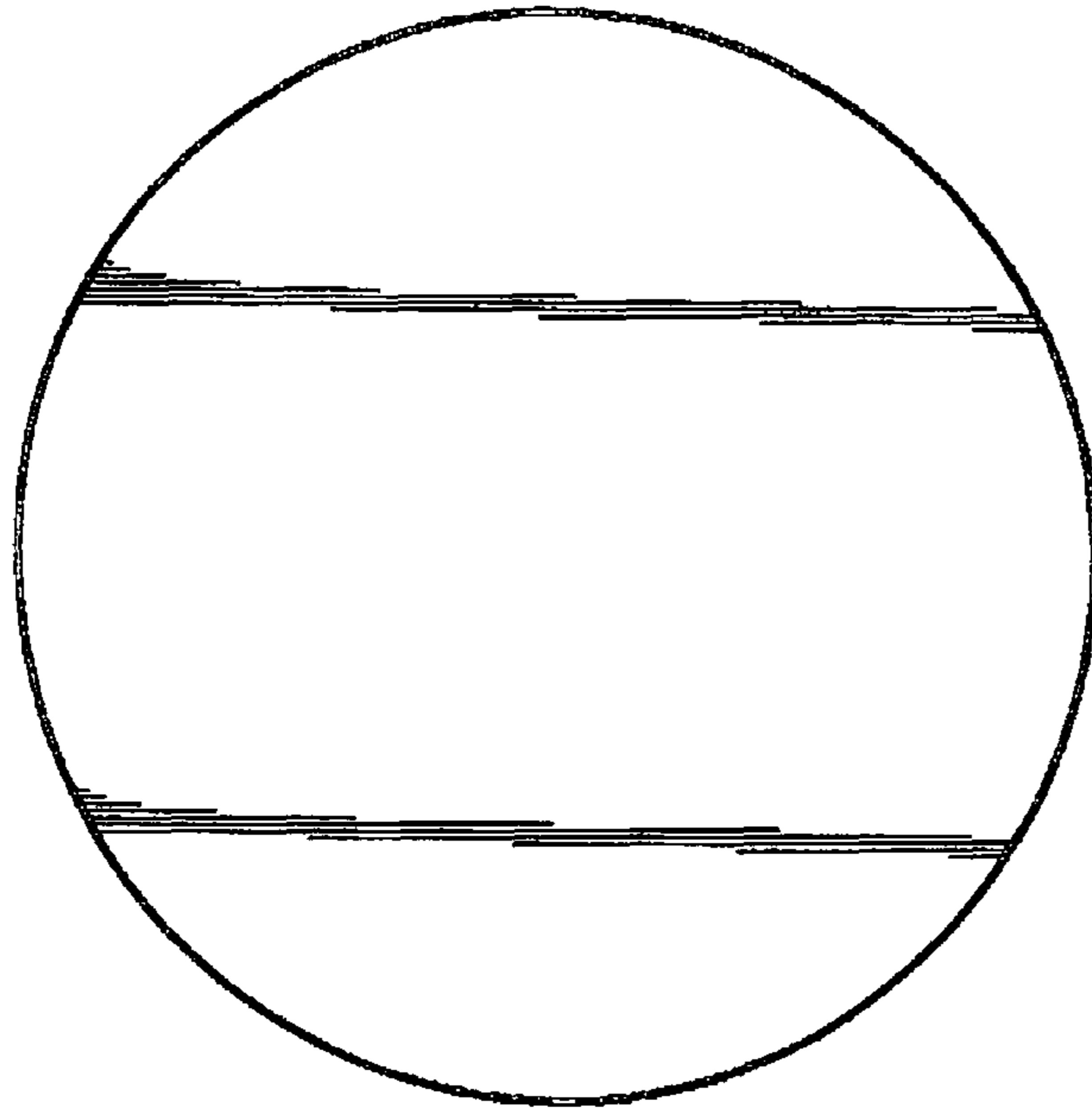

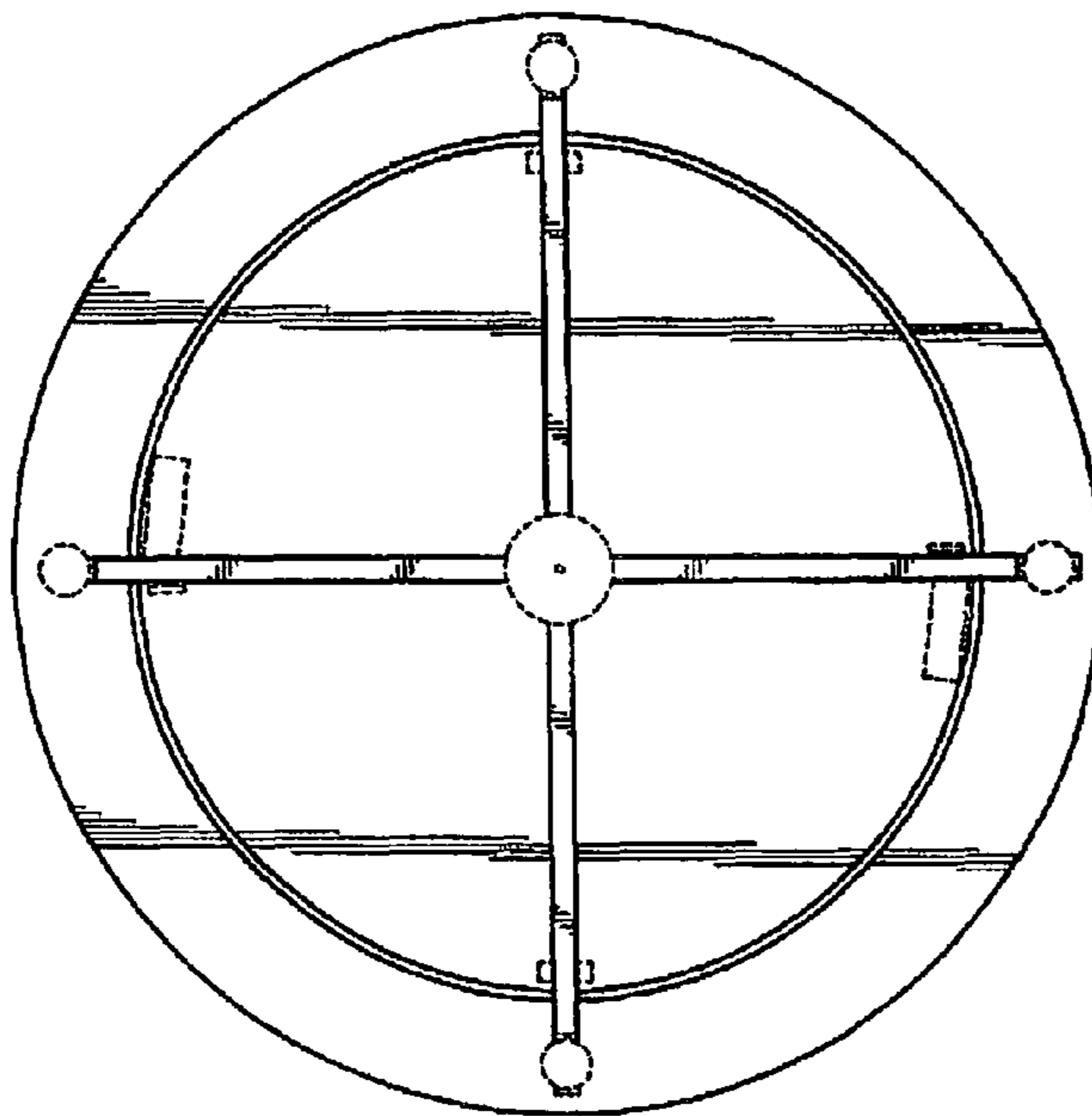

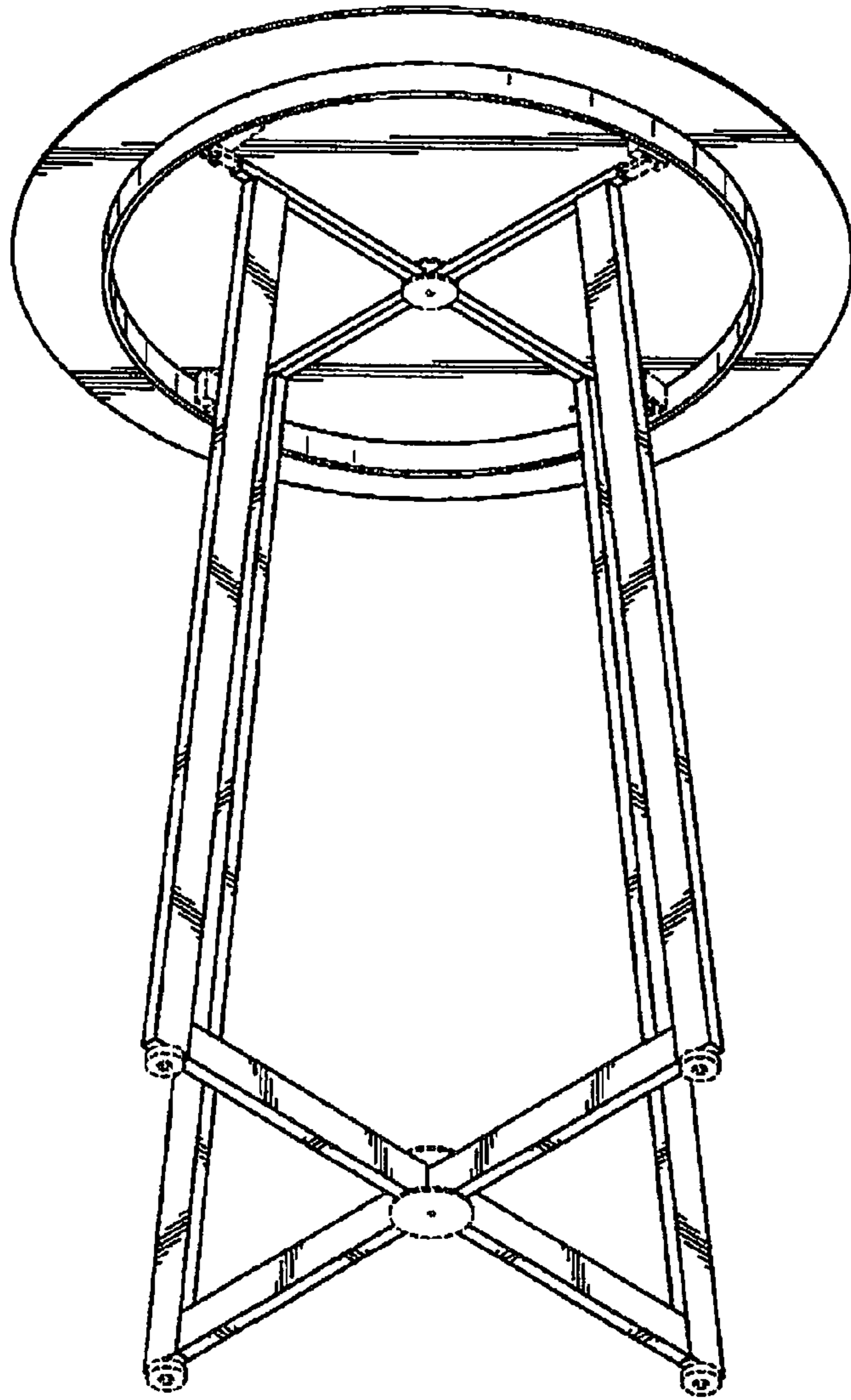

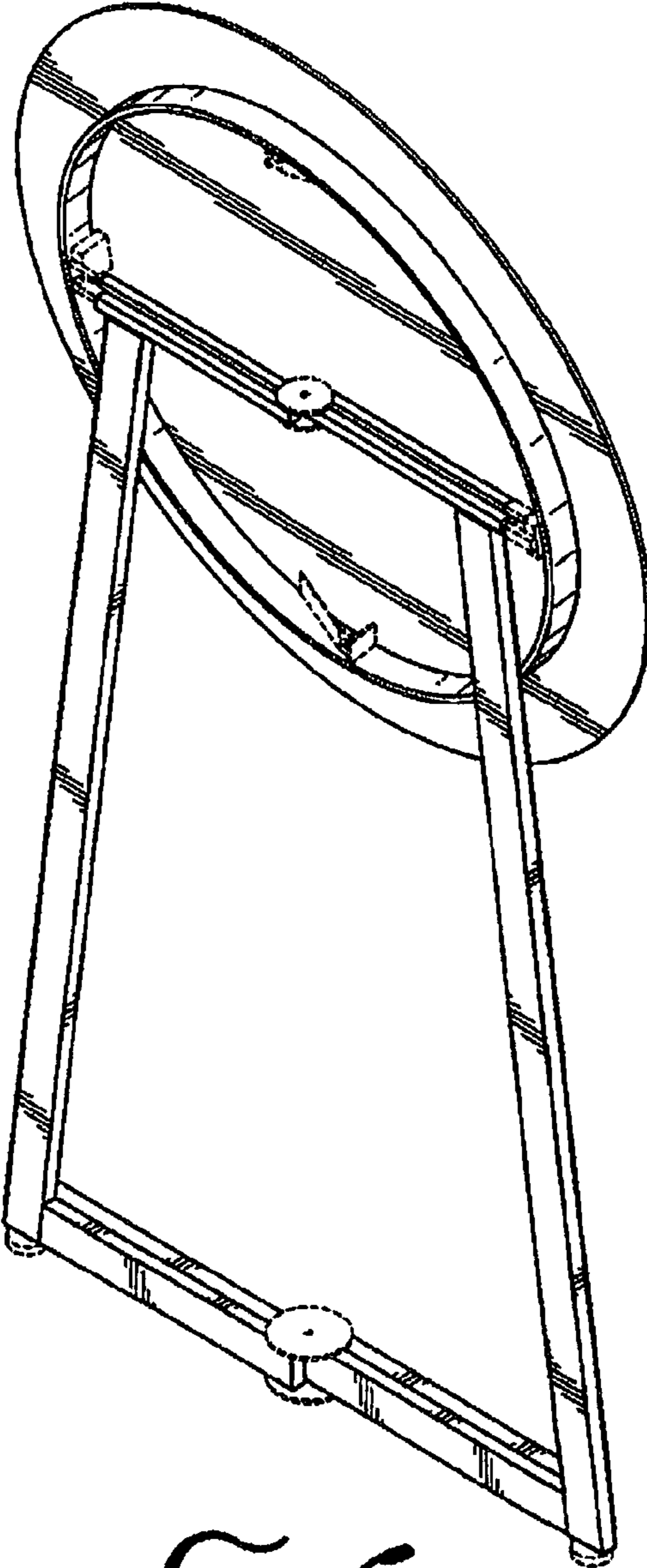
