(57) **CLAIM**

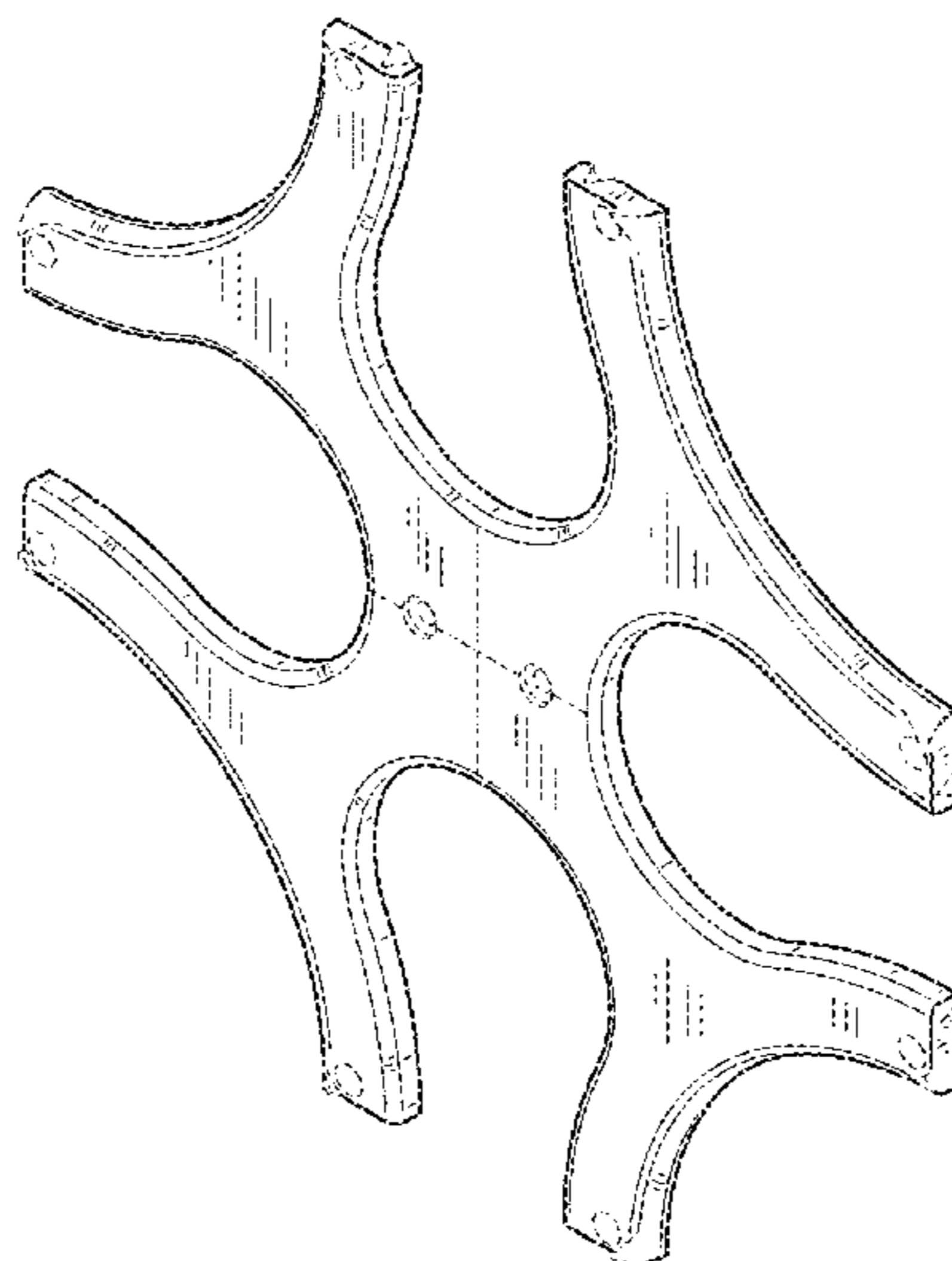
The ornamental design for a mounting bracket, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the mounting bracket; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a right elevation view thereof; FIG. 5 is a left elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view of a plurality of the mounting brackets; FIG. 9 is a front elevation view of the plurality of the mounting brackets; FIG. 10 is a rear elevation view of the plurality of the mounting brackets; FIG. 11 is a right elevation view of the plurality of the mounting brackets; FIG. 12 is a left elevation view of the plurality of the mounting brackets; FIG. 13 is a top plan view of the plurality of the mounting brackets; and, FIG. 14 is a bottom plan view of the plurality of the mounting brackets.

The broken lines depict portions of the mounting bracket that form no part of the claimed design. The plurality of mounting brackets shown in FIGS. 8-14 are included for illustrating environment and form no part of the claimed design.

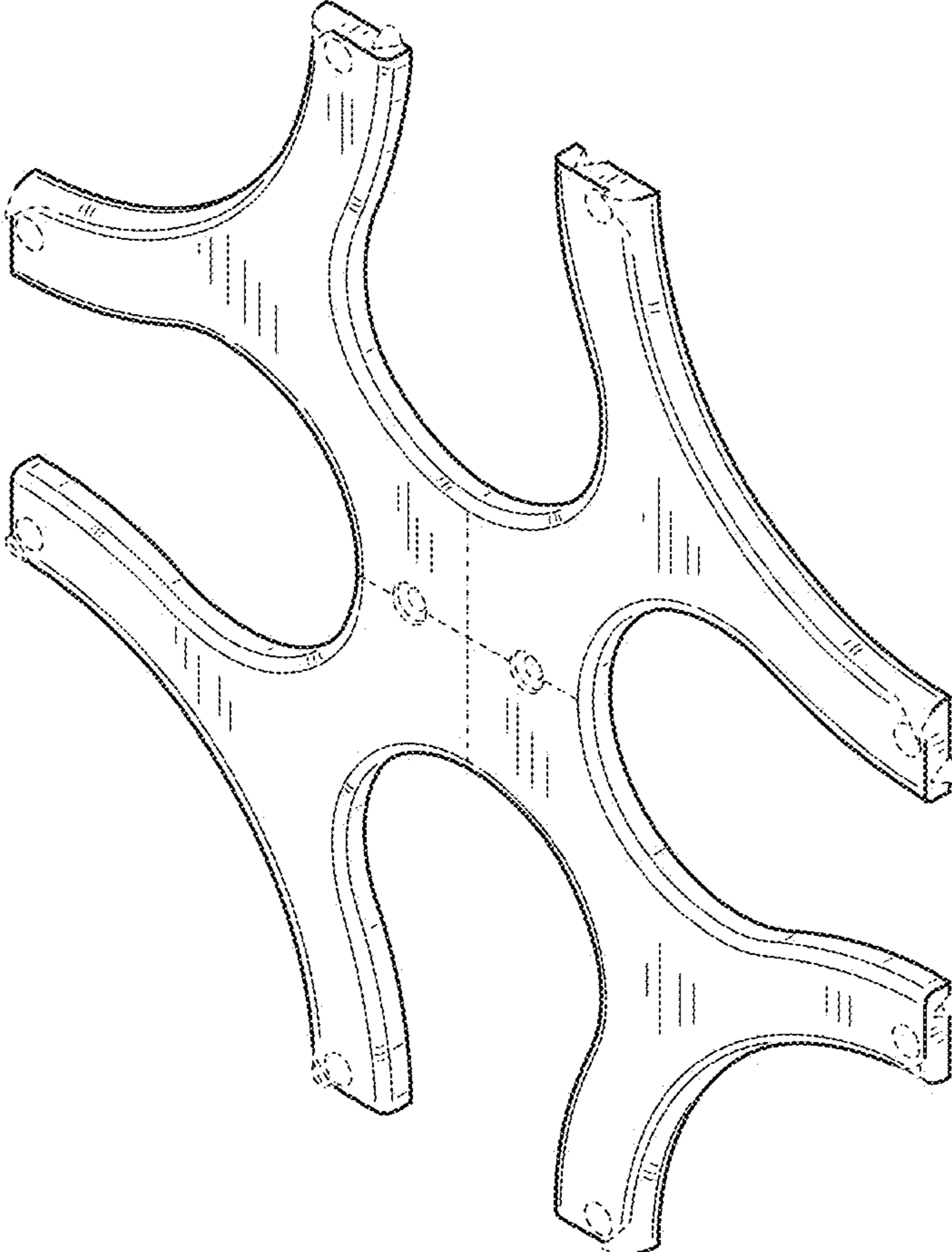

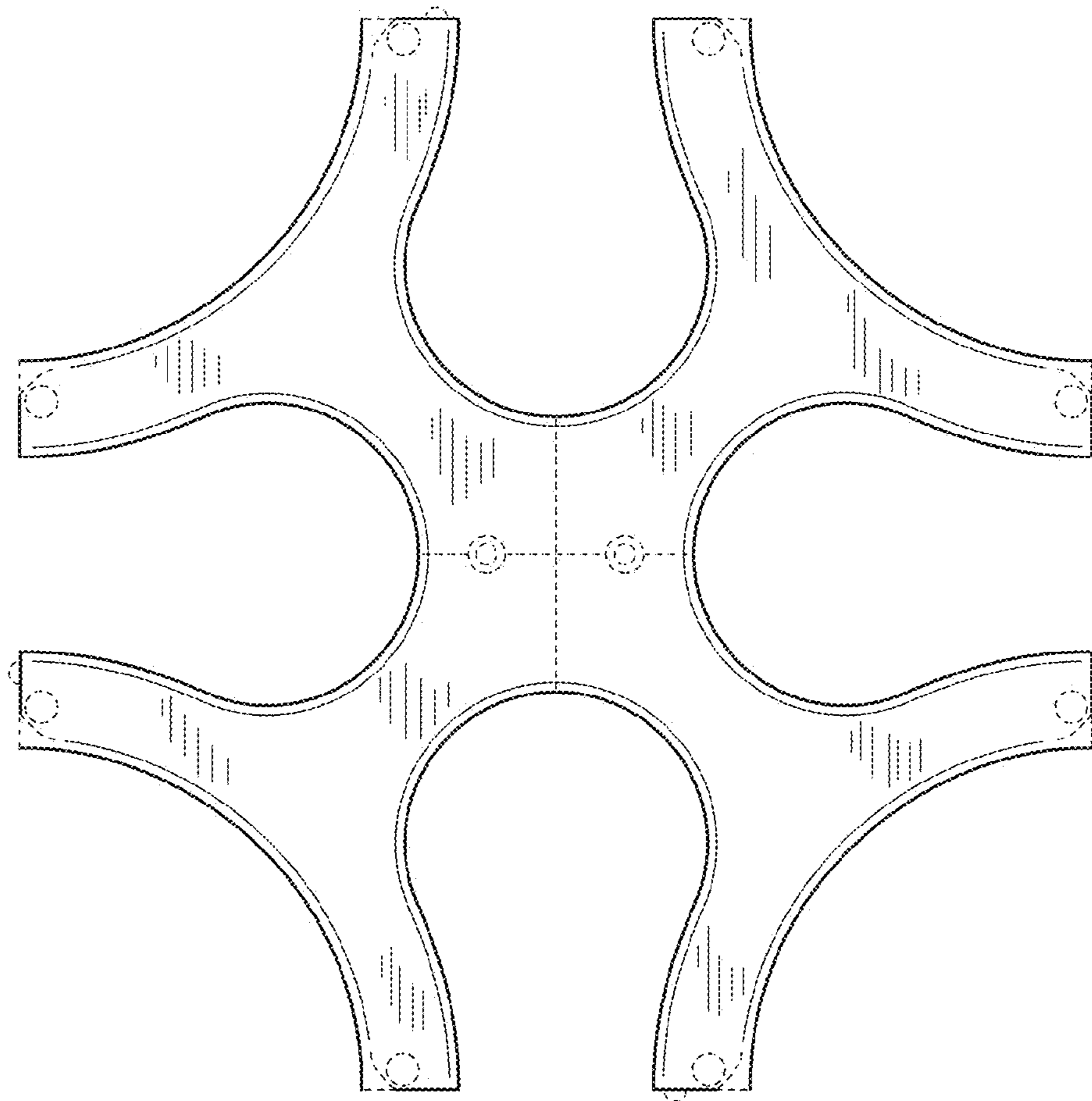

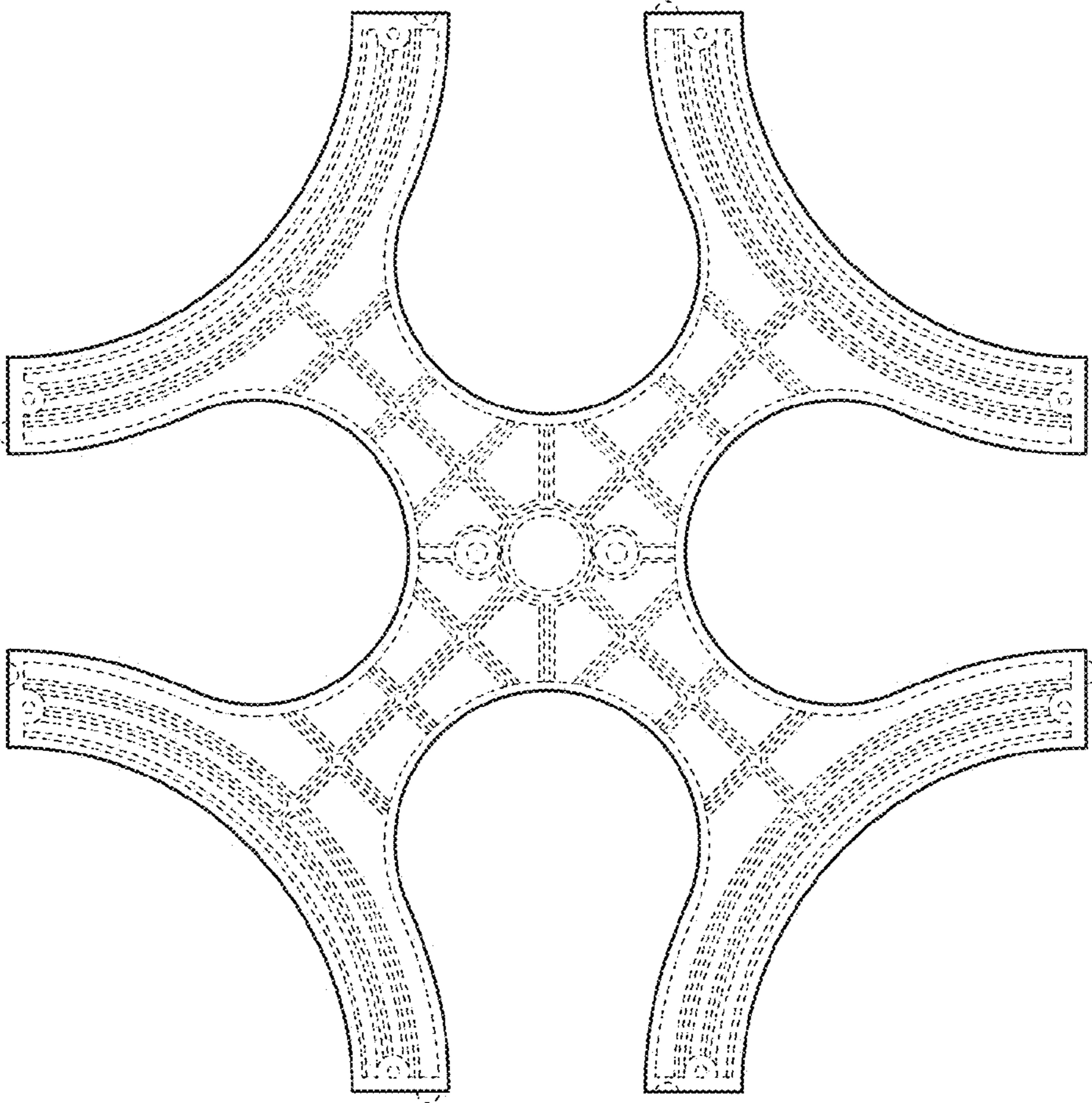

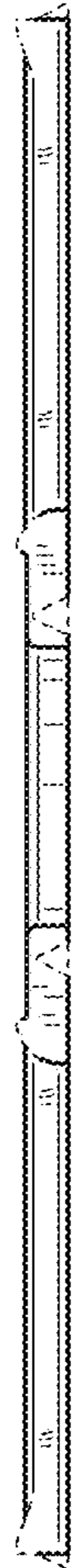

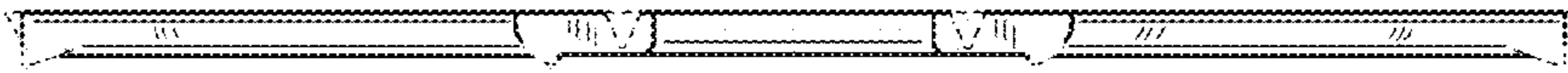

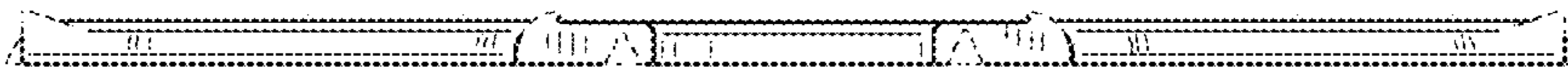

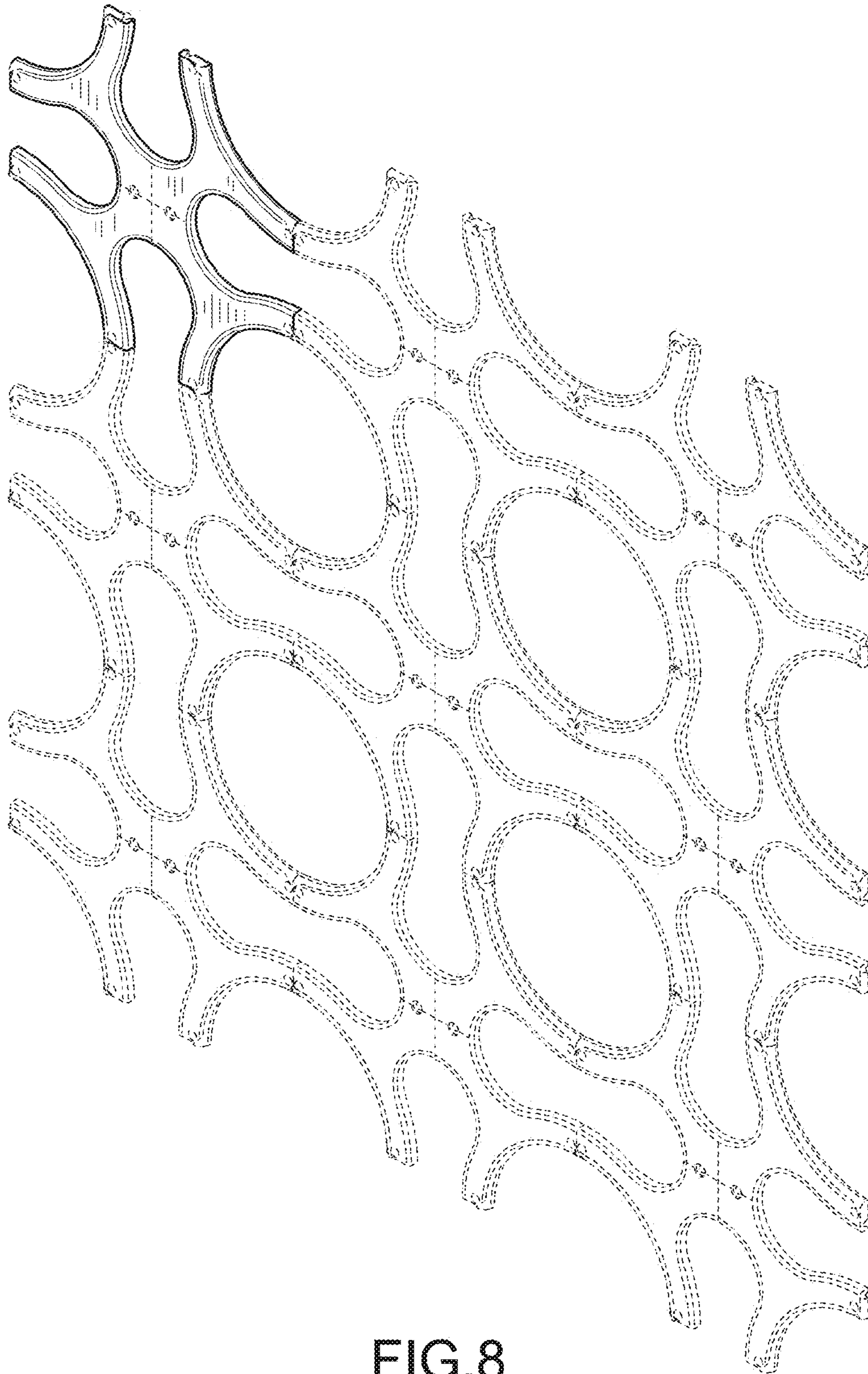

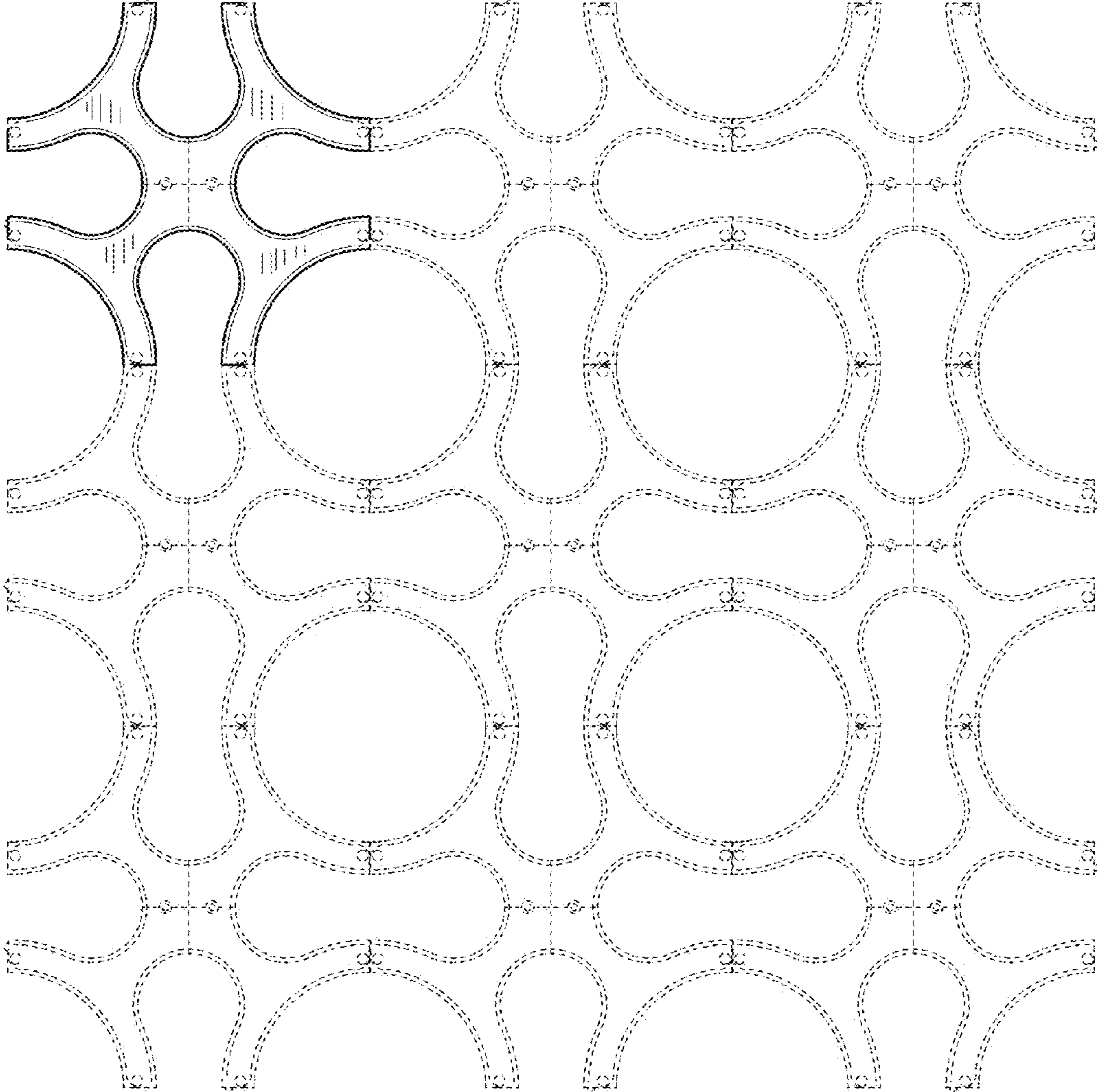

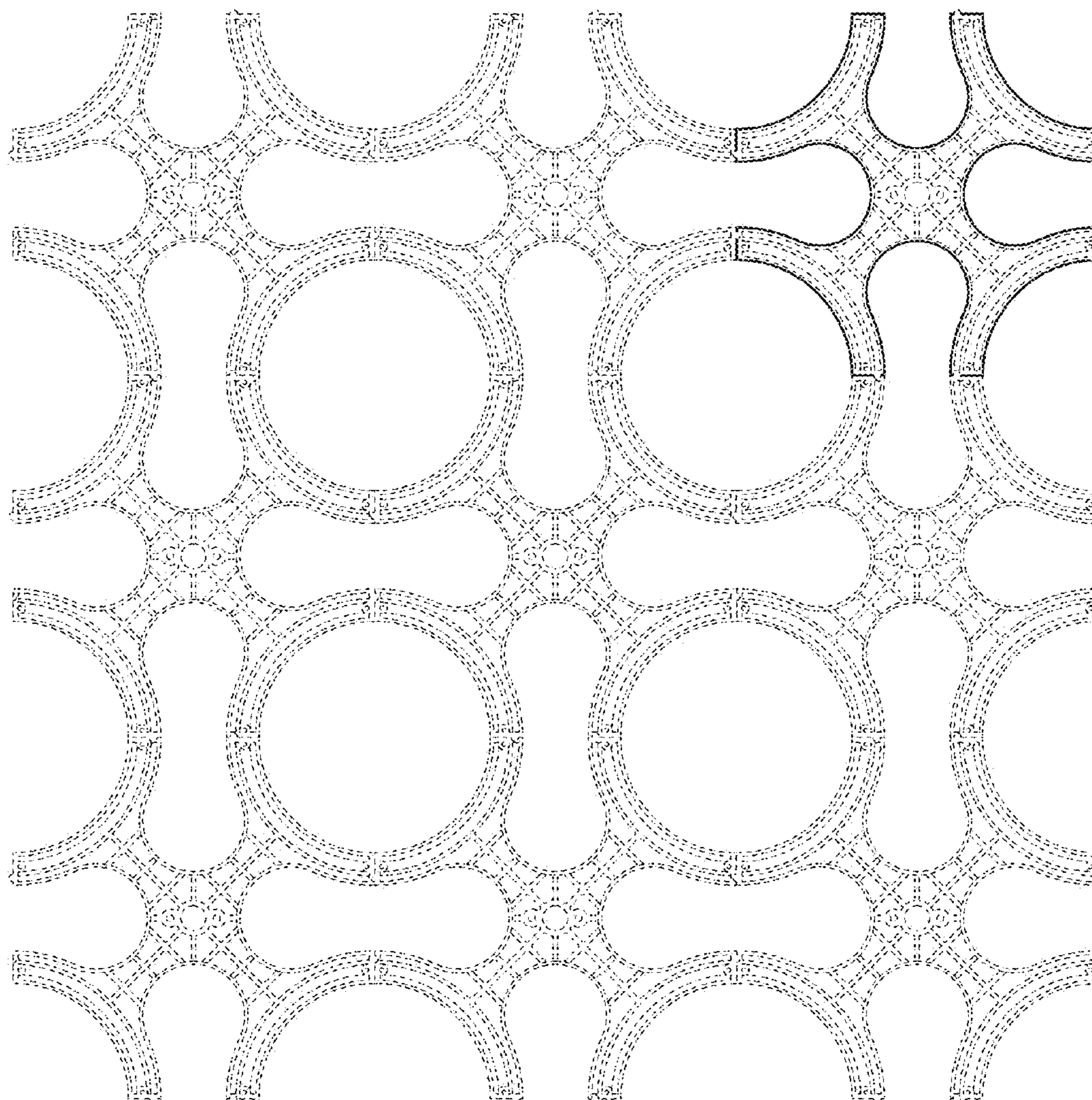

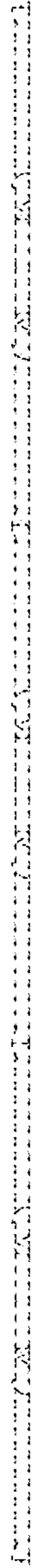

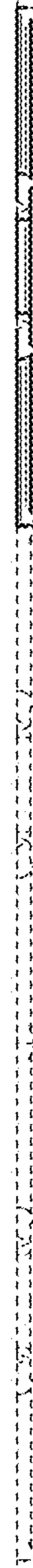

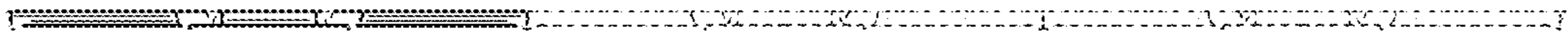

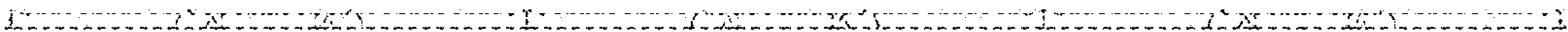
