 FIG. 7 is a bottom view of the package sleeve shown in FIG. 1.

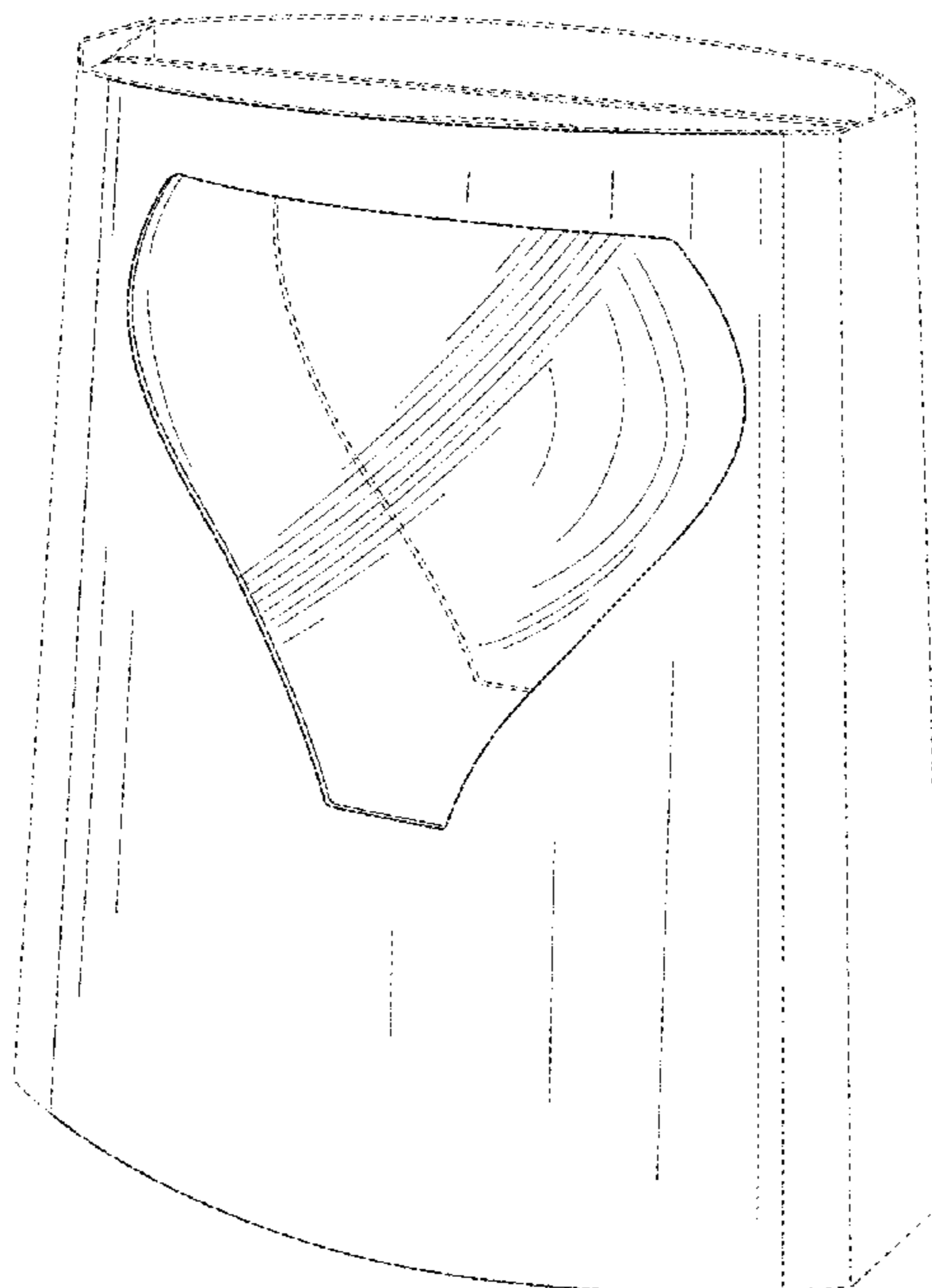

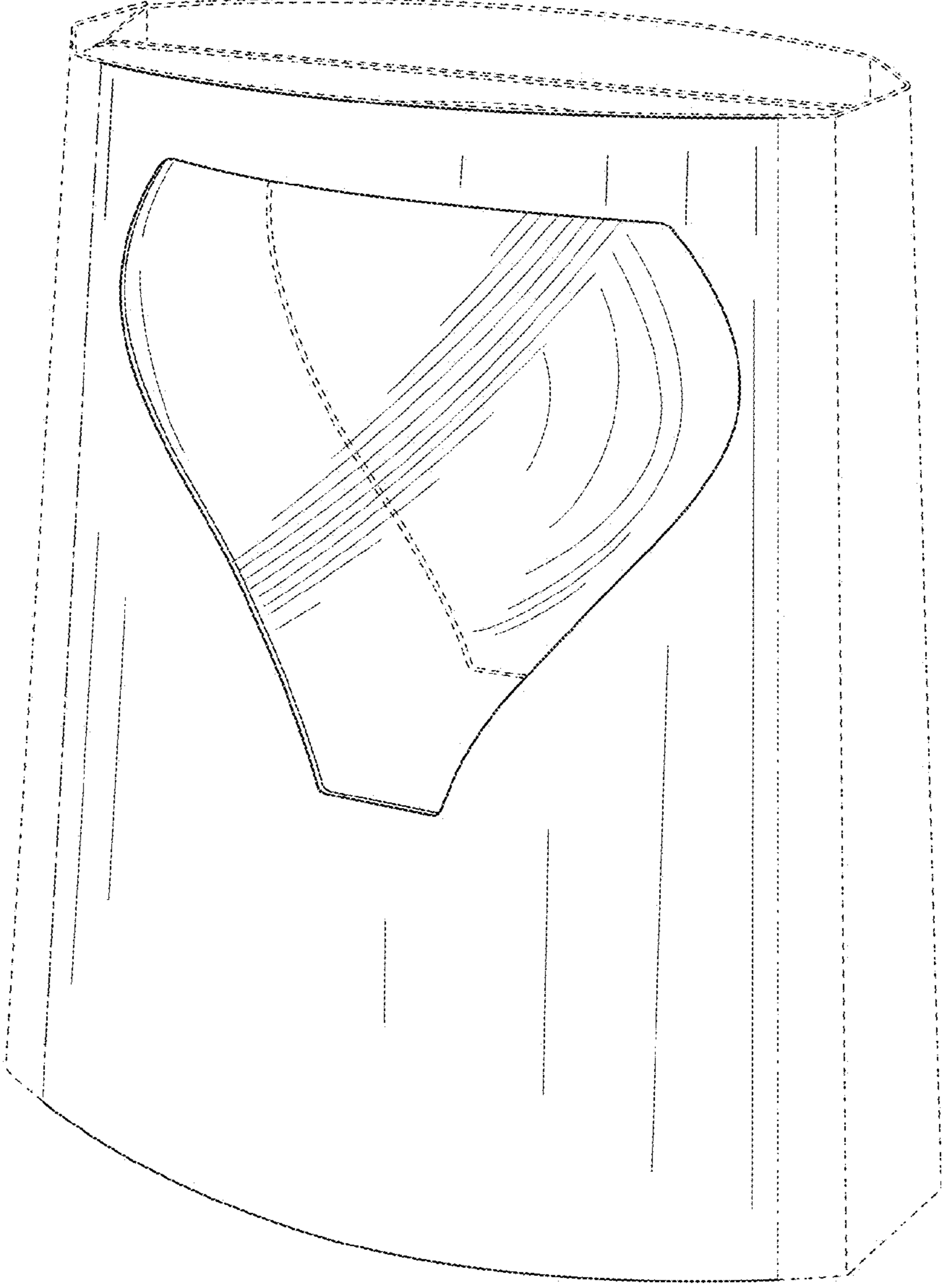

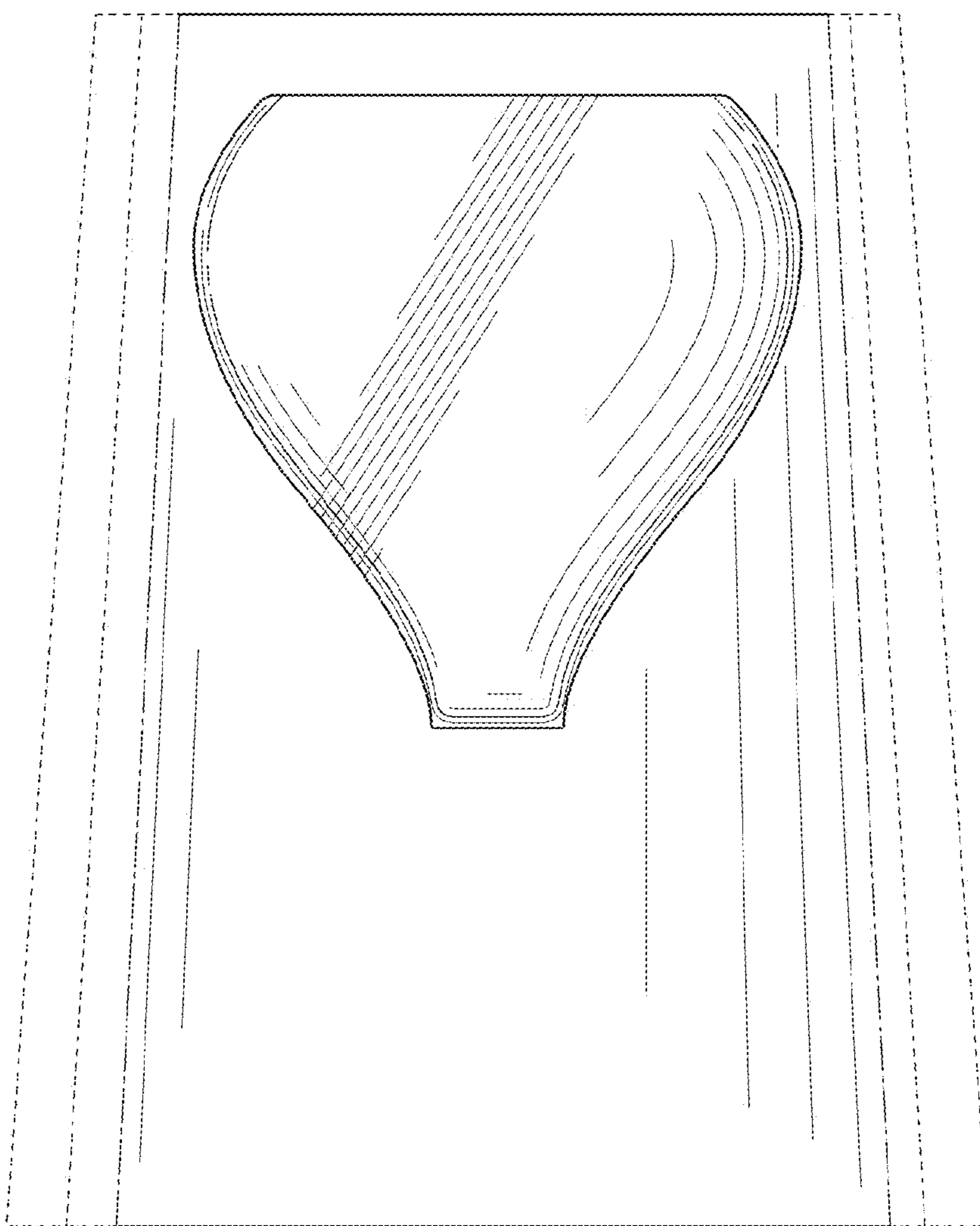

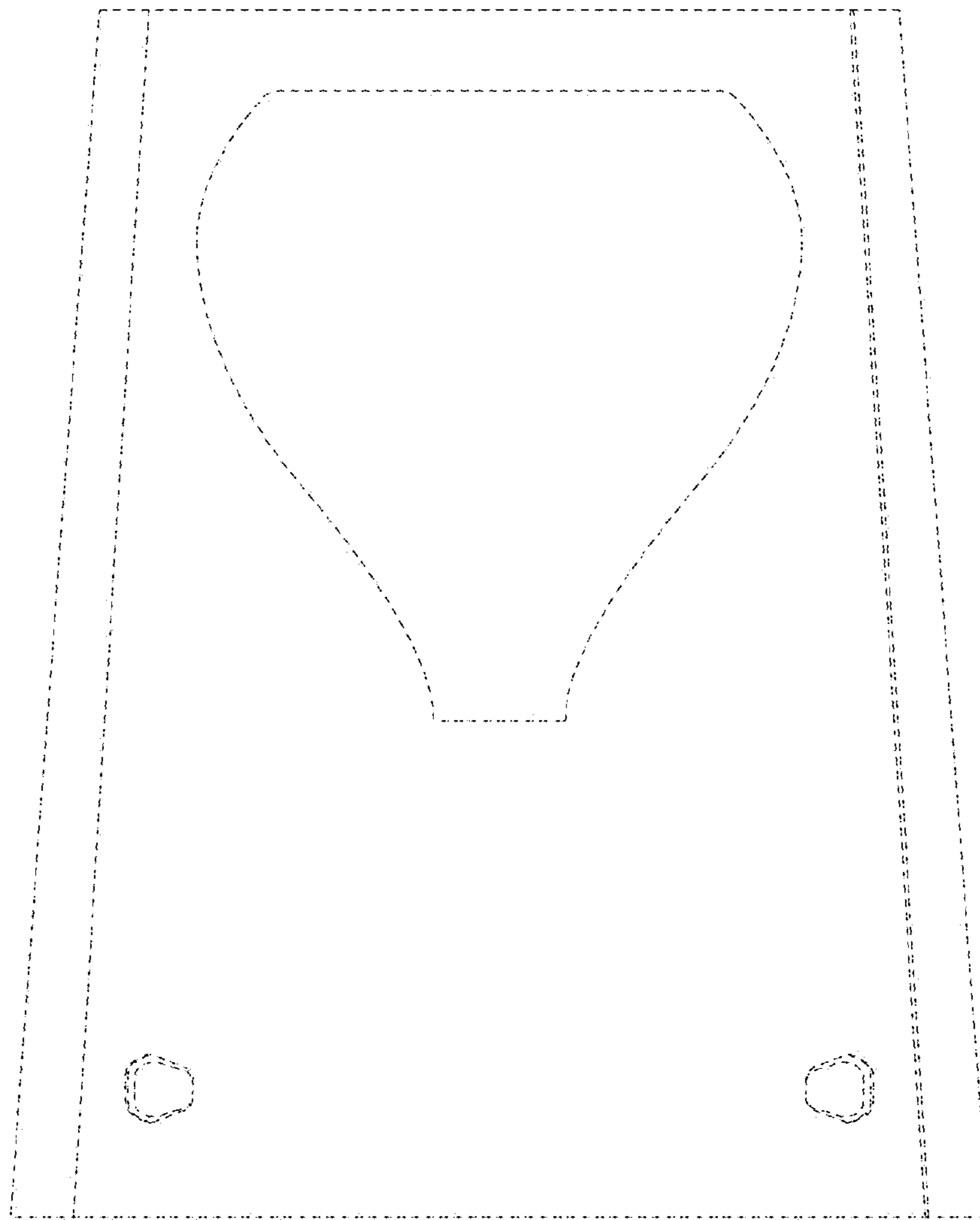

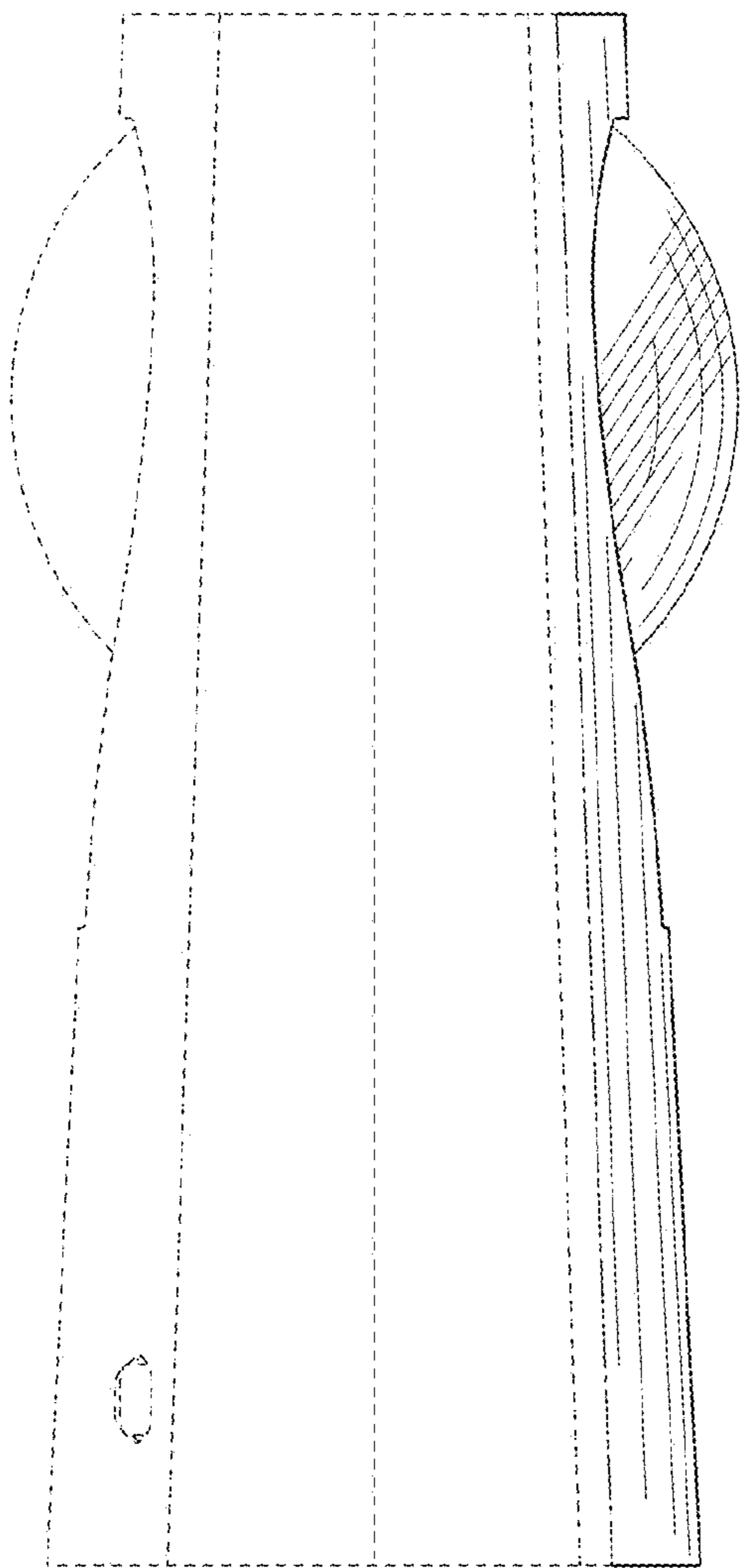

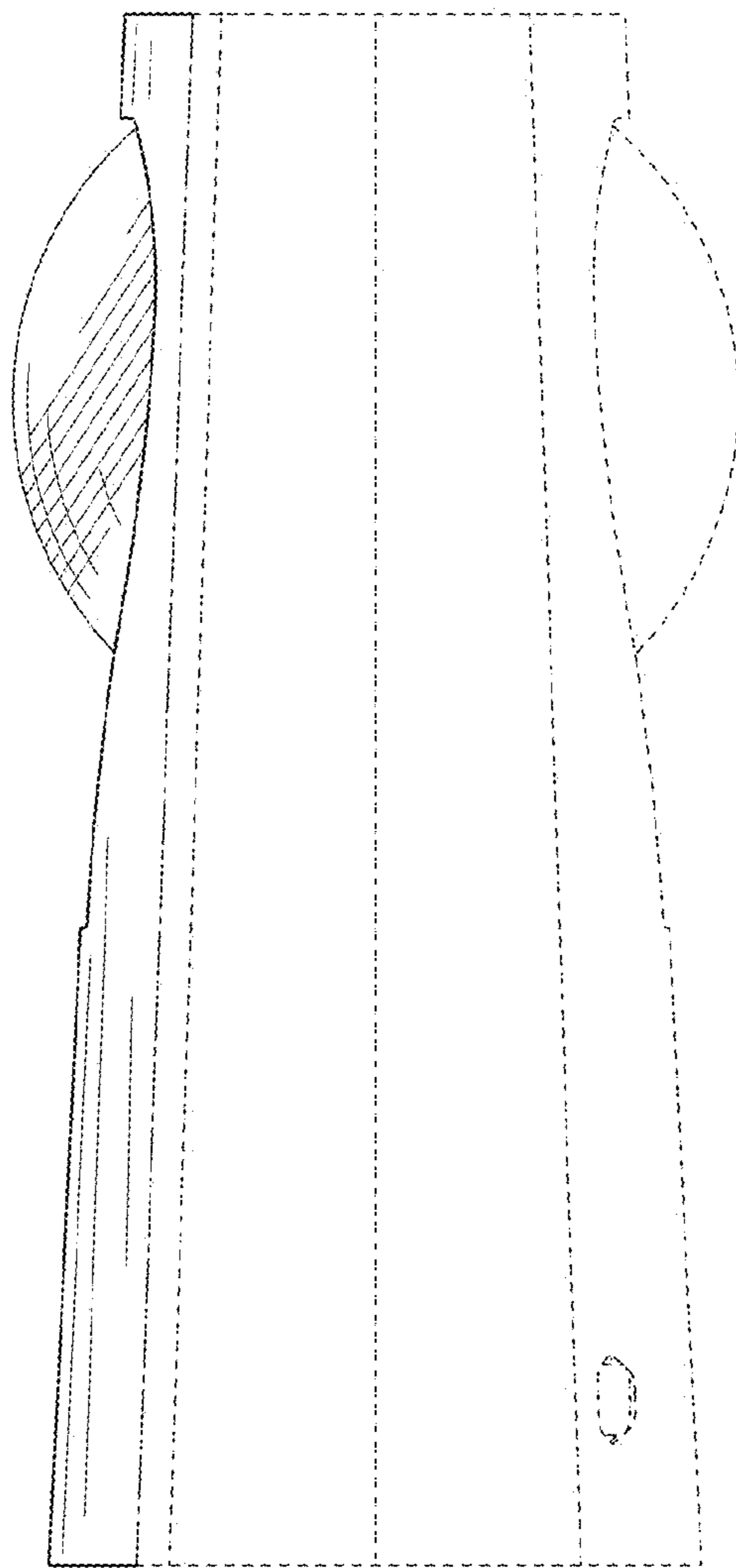

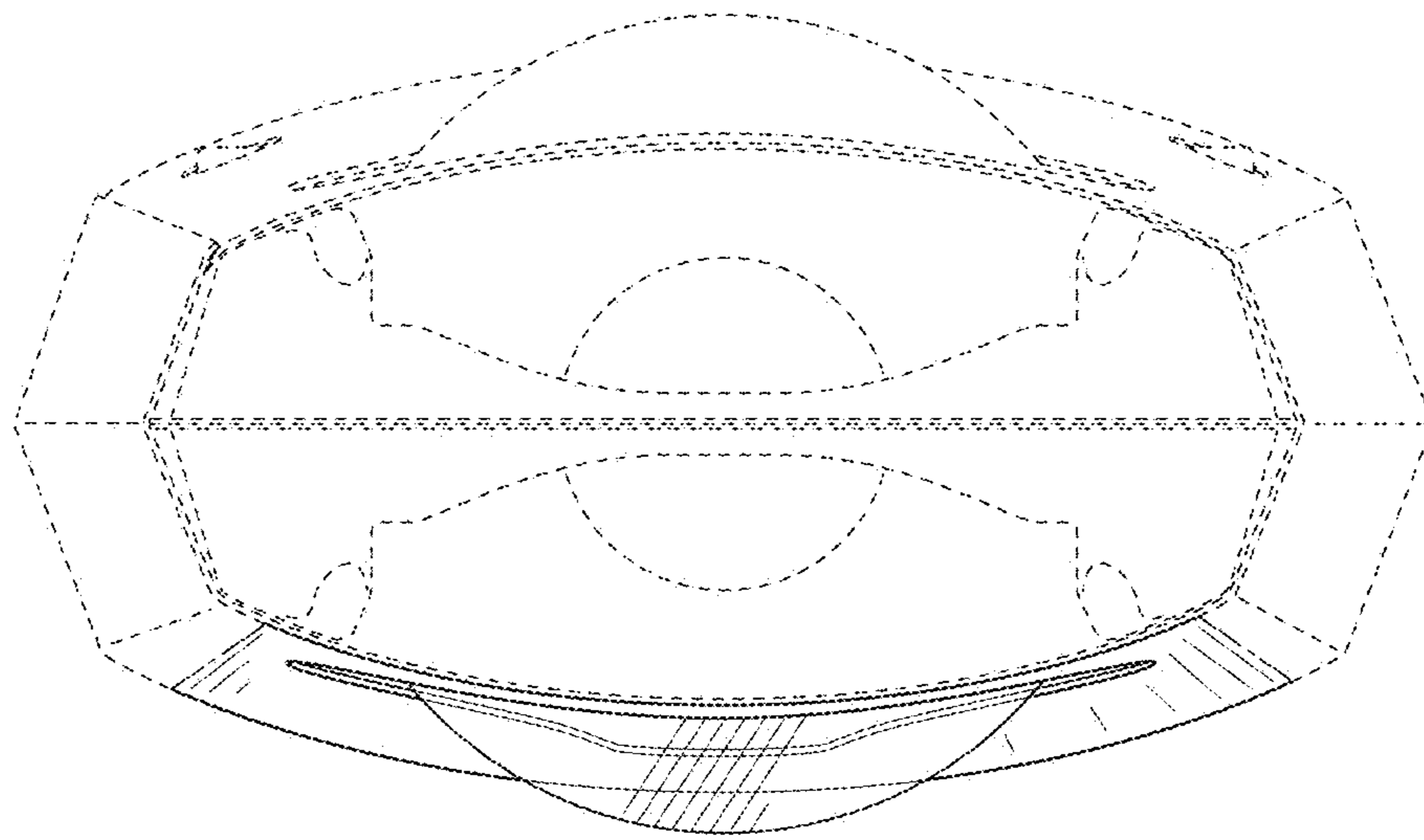

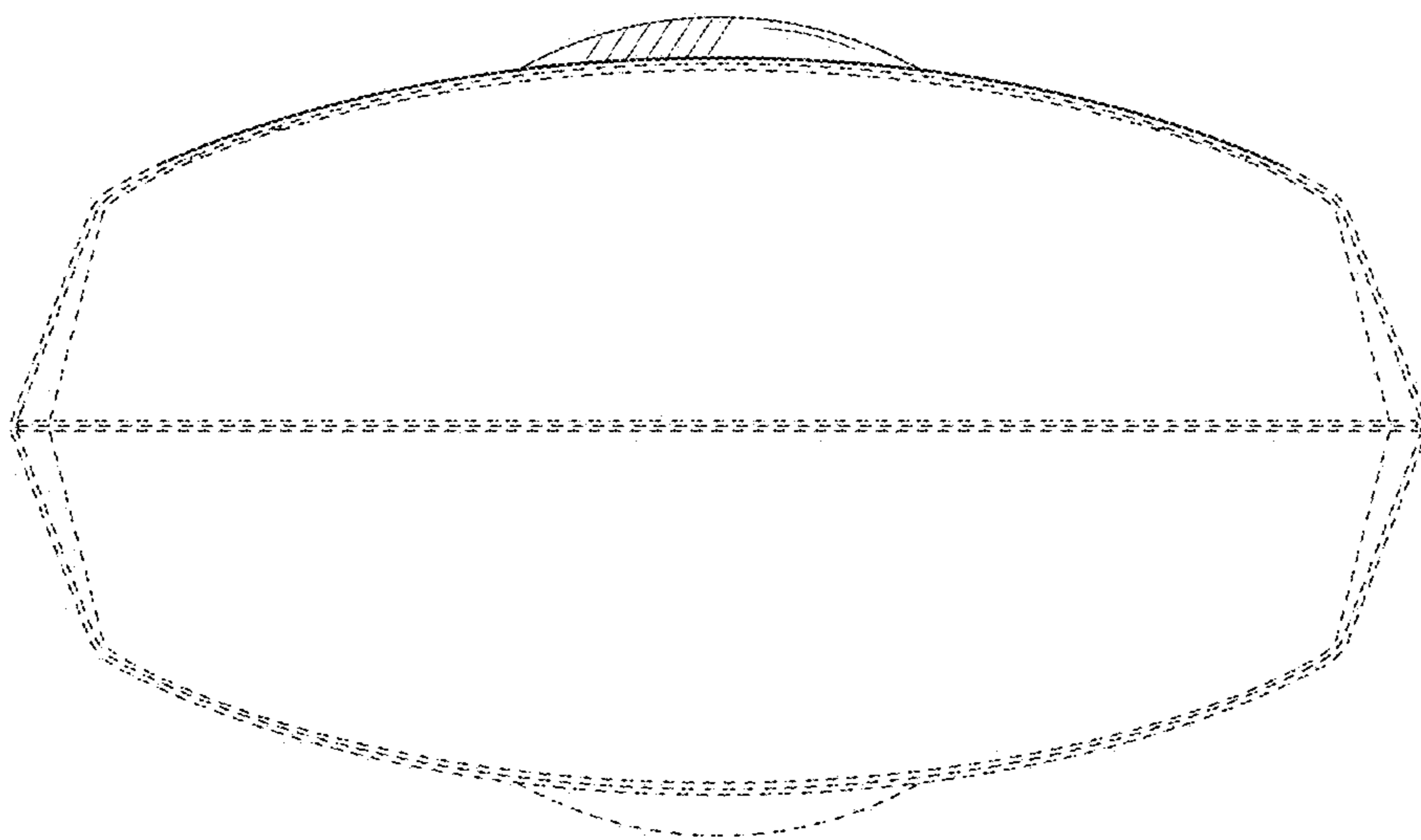
