(57) **CLAIM**

The ornamental design for a reusable apparatus for affixing gift material to a presentation device, as shown and described.

DESCRIPTION

FIG. 1 is a top-down 45 degree tilted perspective view of a reusable apparatus for affixing gift material to a presentation device, showing my new design;

FIG. 2 is a back-side view of a reusable apparatus for affixing gift material to a presentation device, showing my new design;

FIG. 3 is a front-side view of a reusable apparatus for affixing gift material to a presentation device, showing my new design;

FIG. 4 is a bottom-up 45 degree tilted perspective view of a reusable apparatus for affixing gift material to a presentation device, showing my new design;

FIG. 5 is a bottom view of a reusable apparatus for affixing gift material to a presentation device, showing my new design; and,

FIG. 6 is a top-down view of a reusable apparatus for affixing gift material to a presentation device, showing my new design.

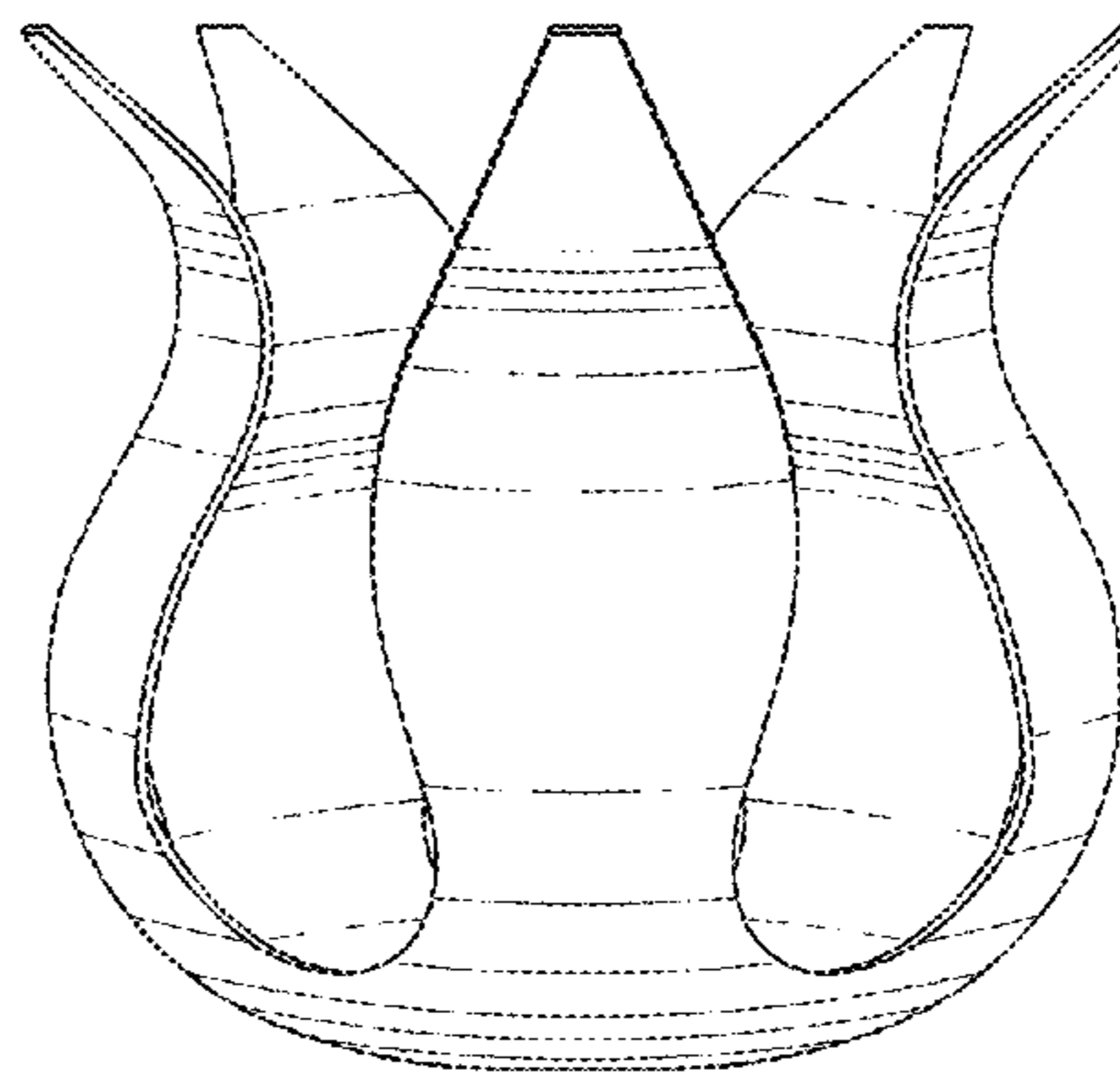
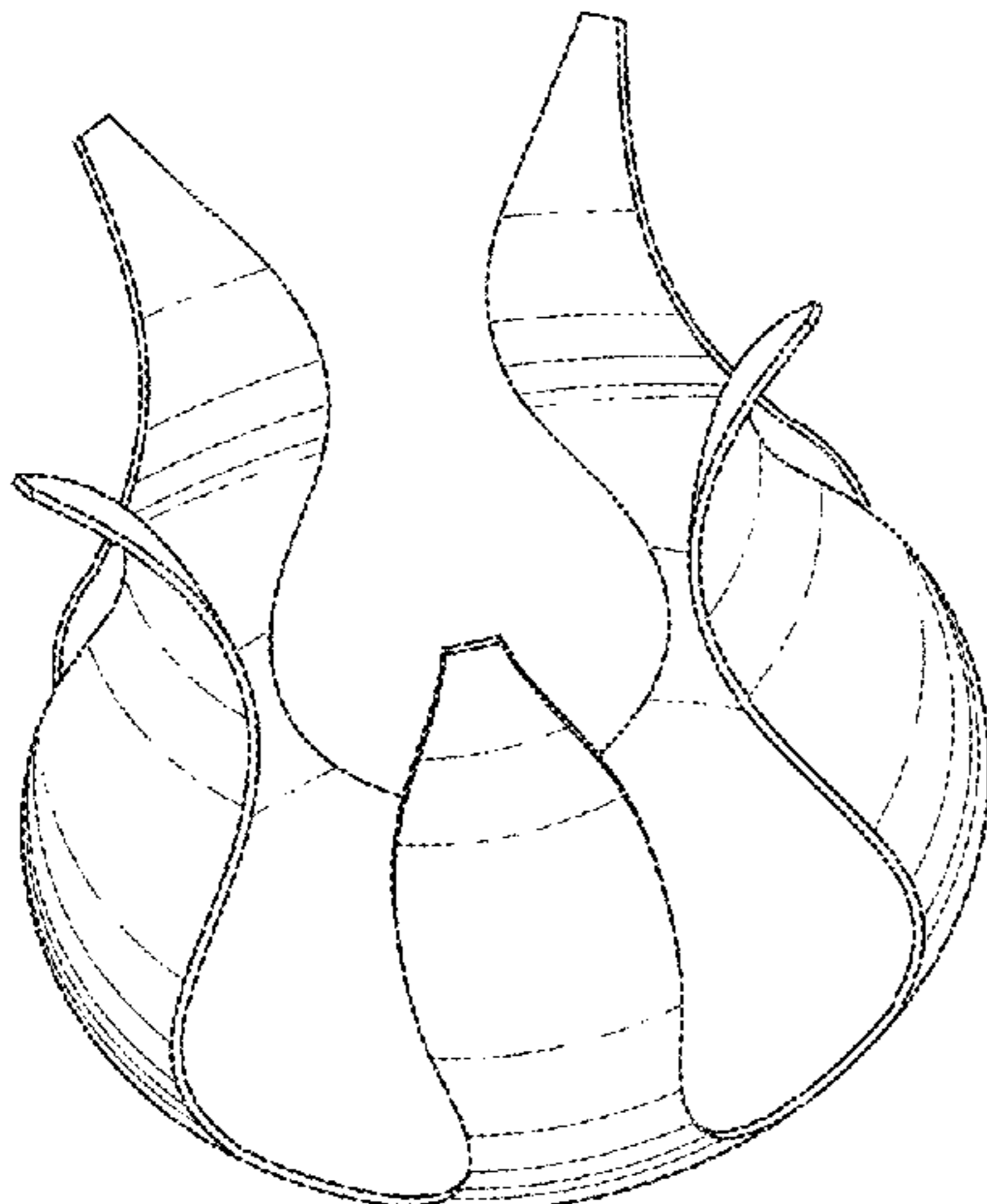

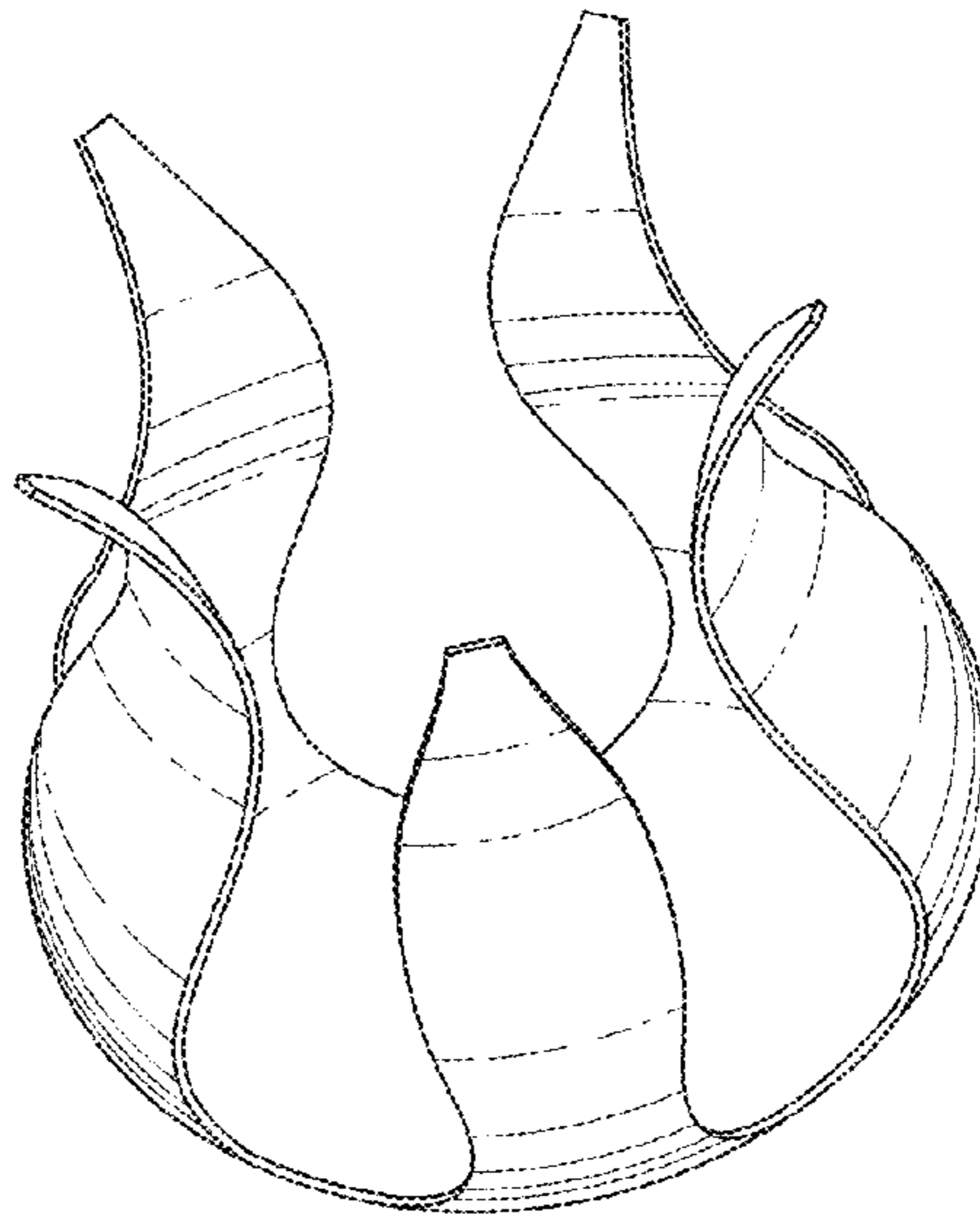

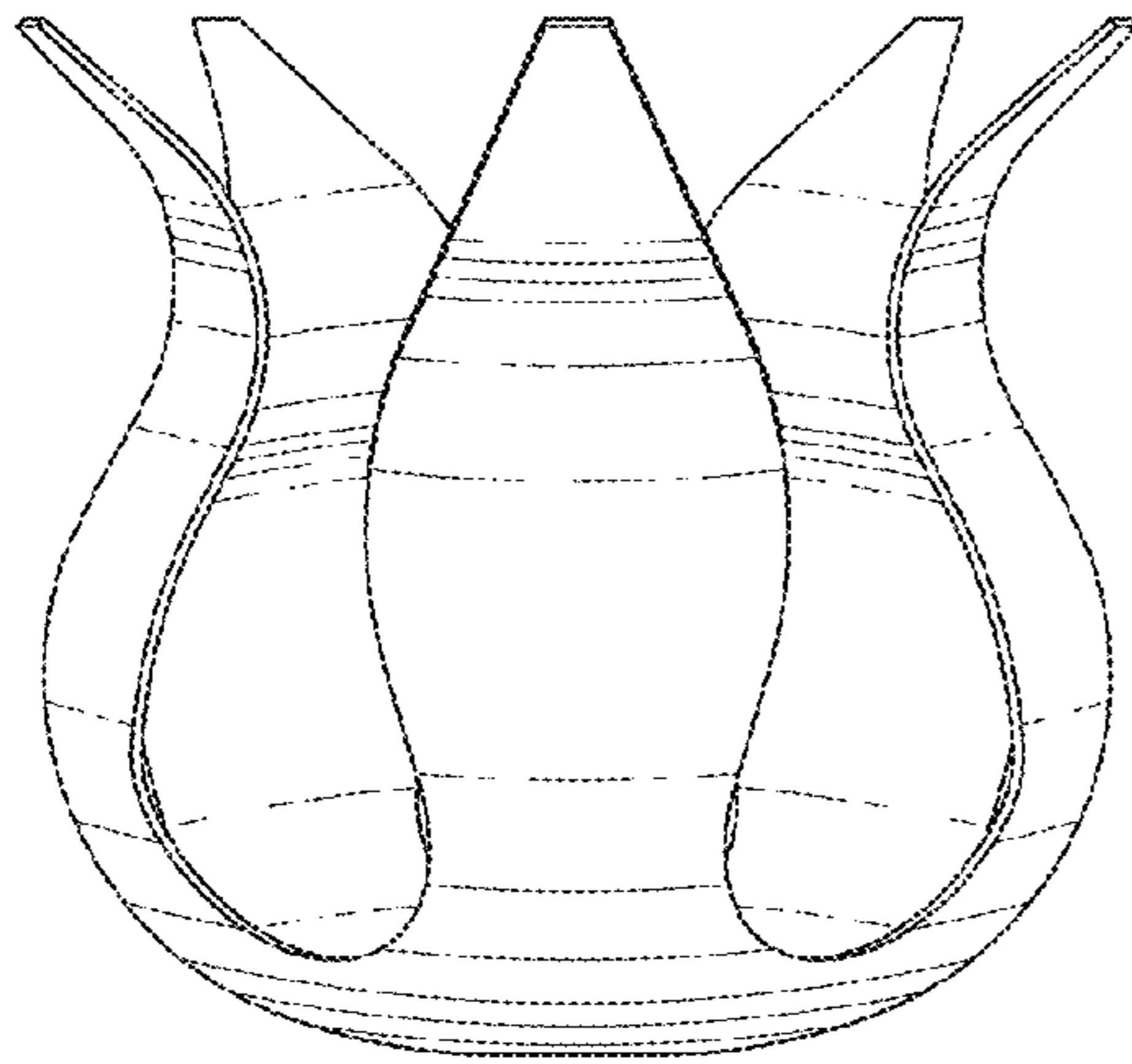
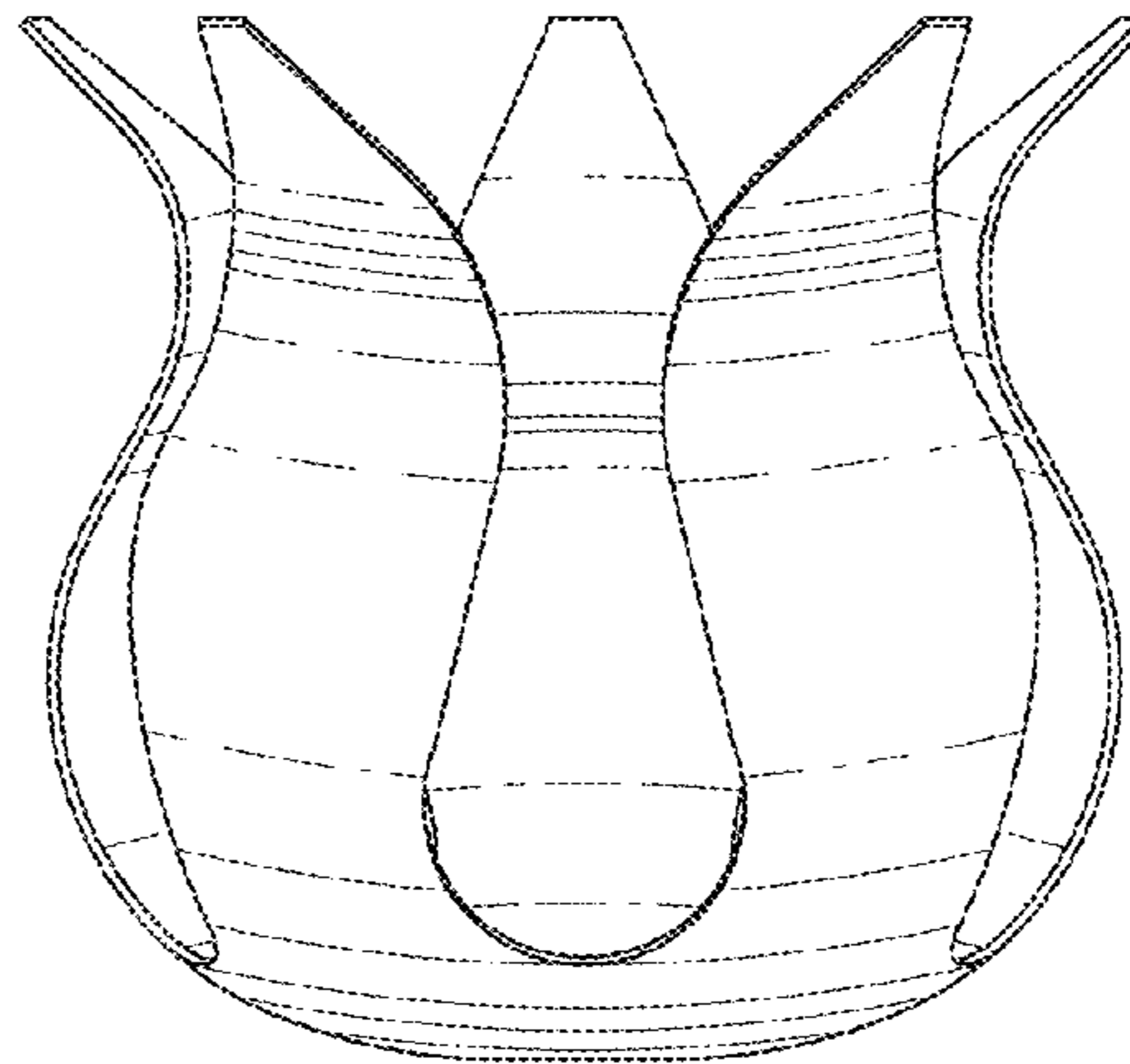

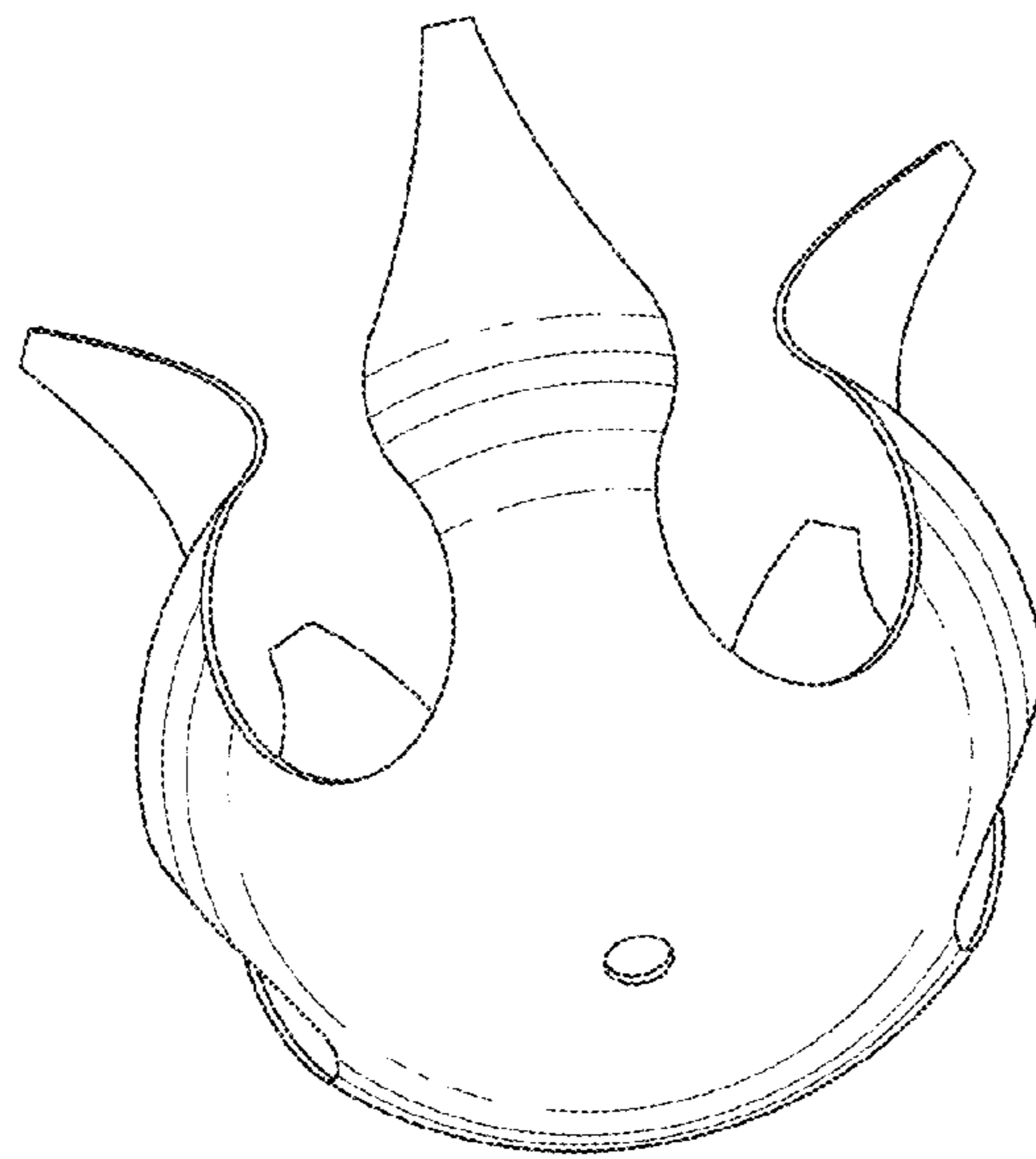

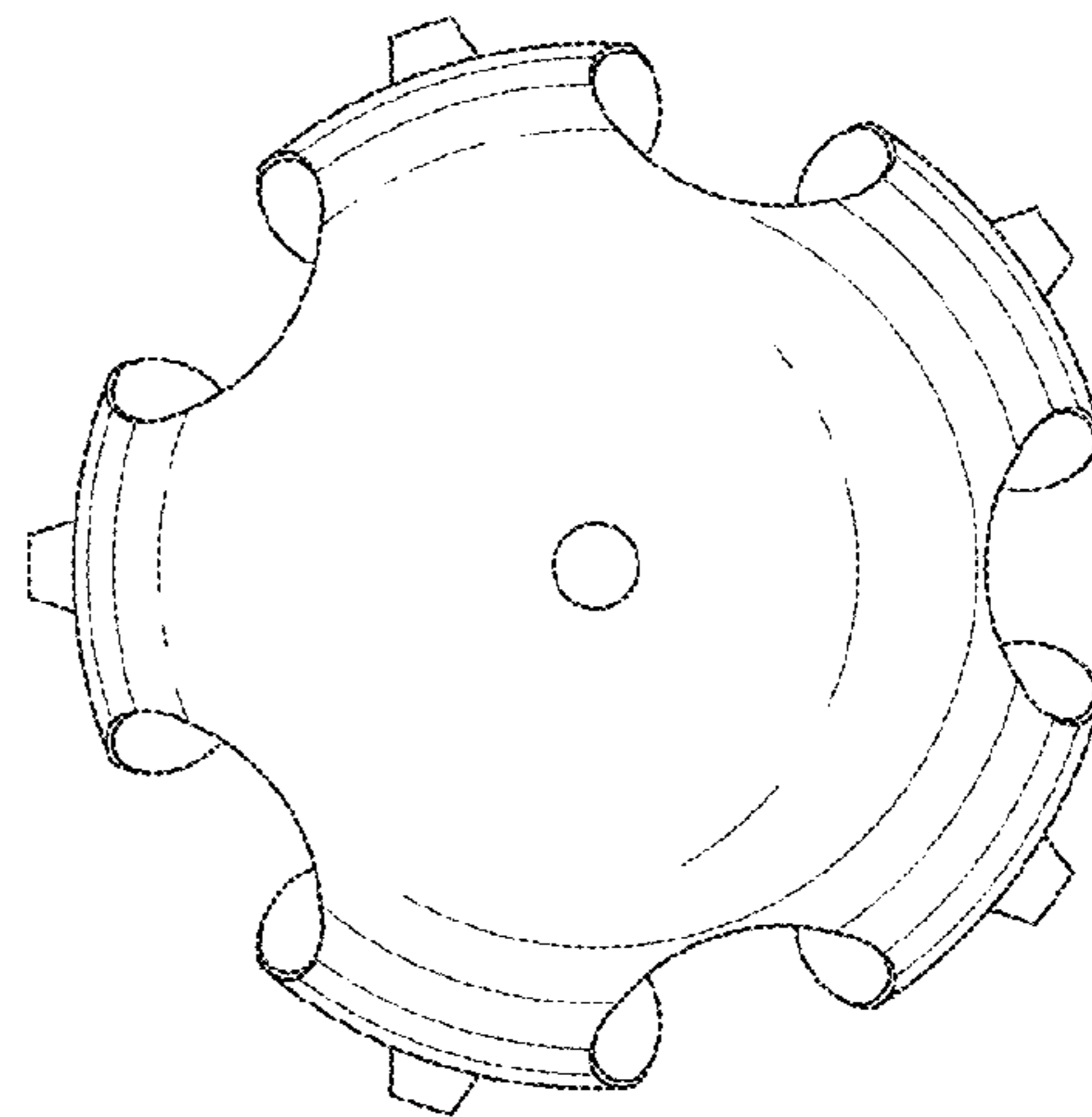

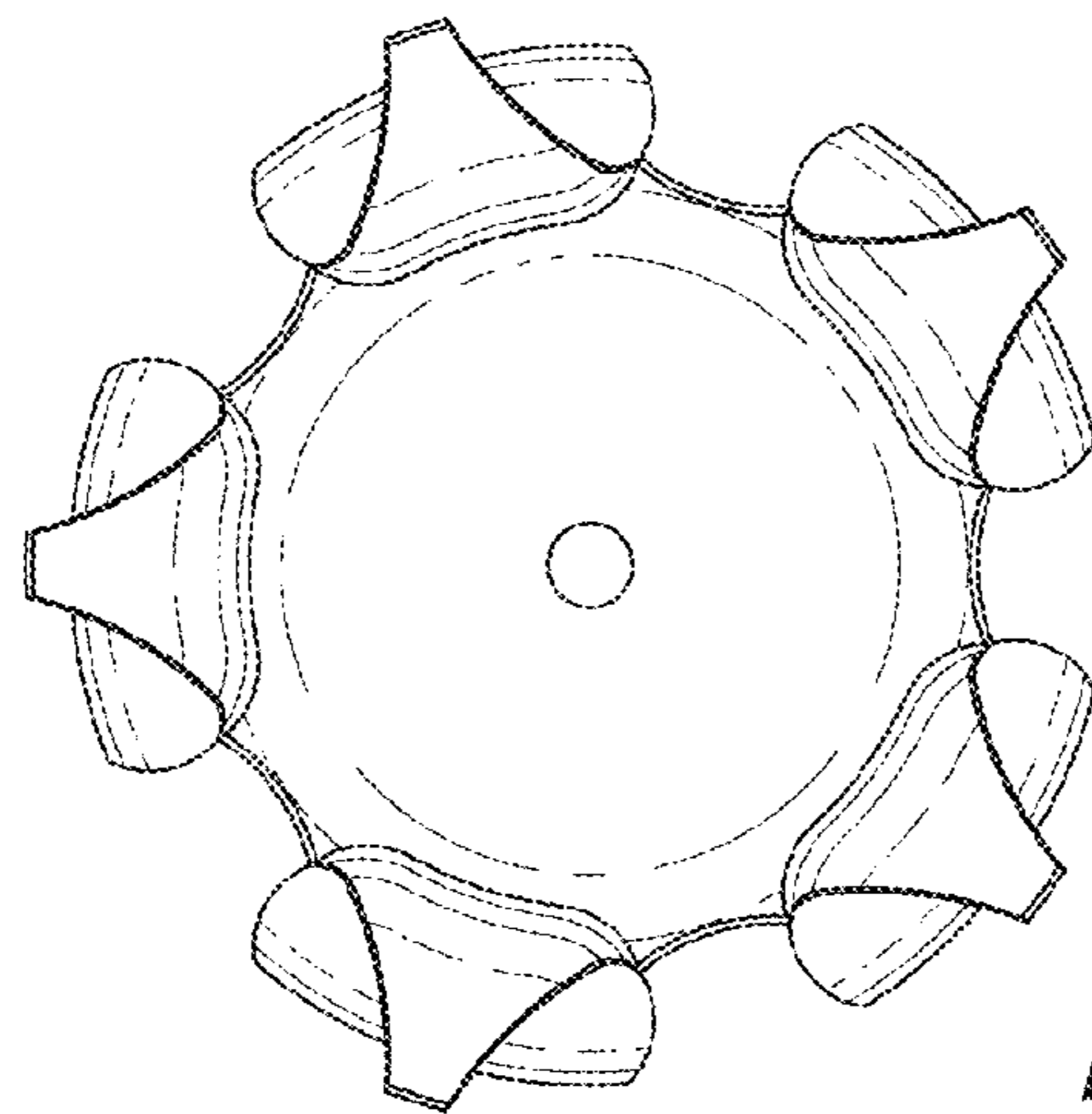
