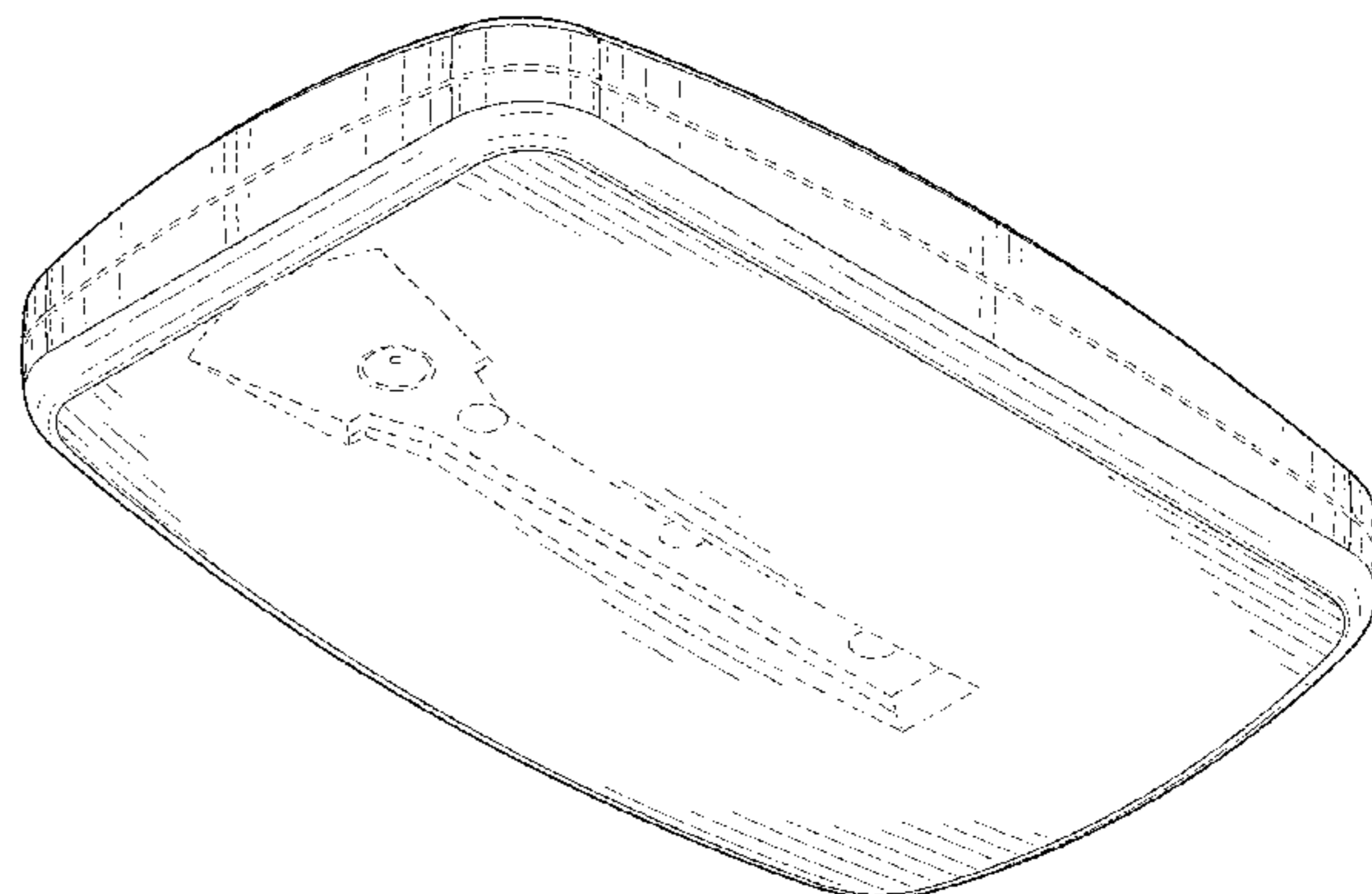
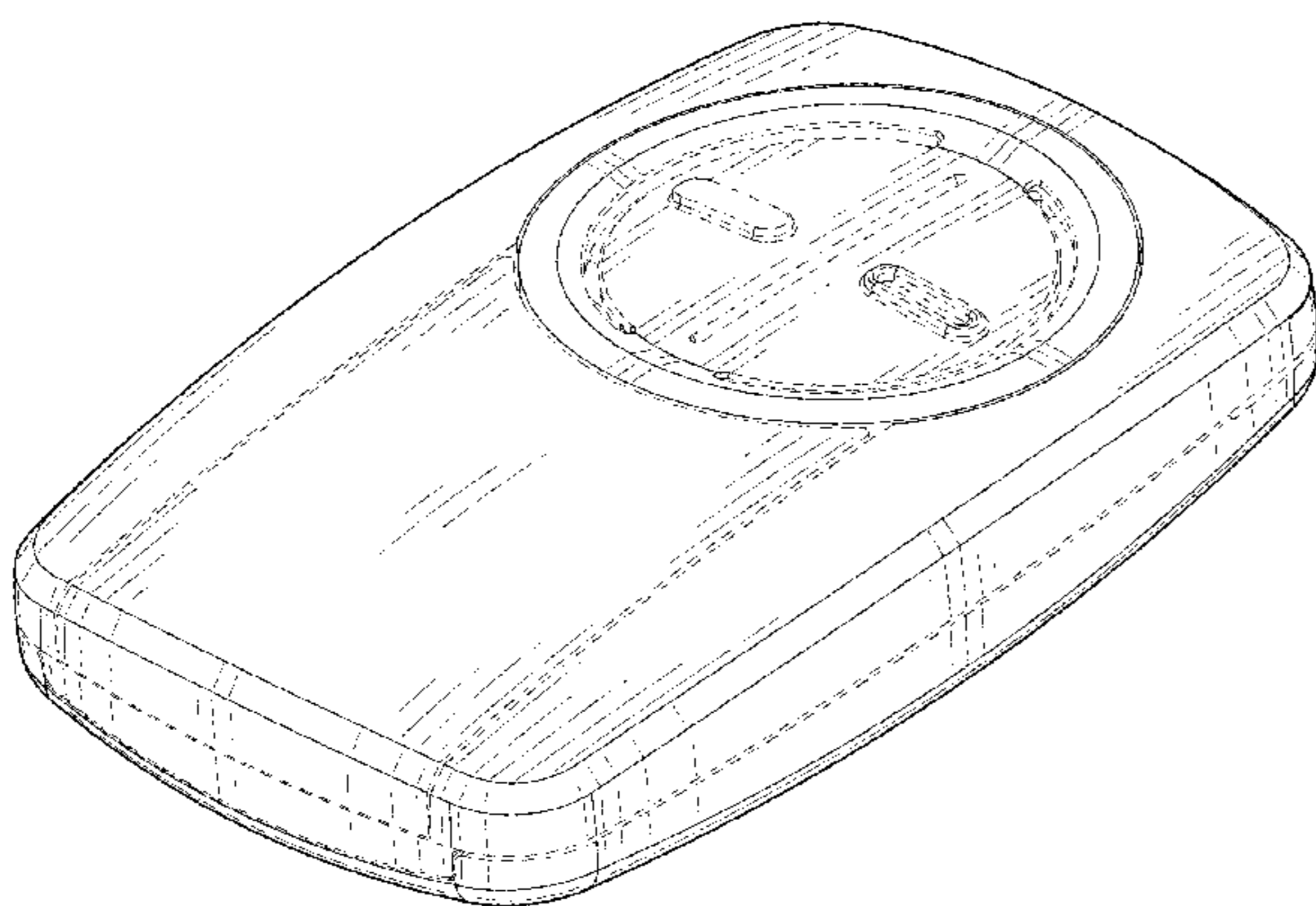
(57) **CLAIM**

We claim the ornamental design for a garage door accessory, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of our new design comprising a garage door accessory;  
FIG. 2 is a bottom perspective view of the garage door accessory of FIG. 1;  
FIG. 3 is a top view of the garage door accessory of FIG. 1;

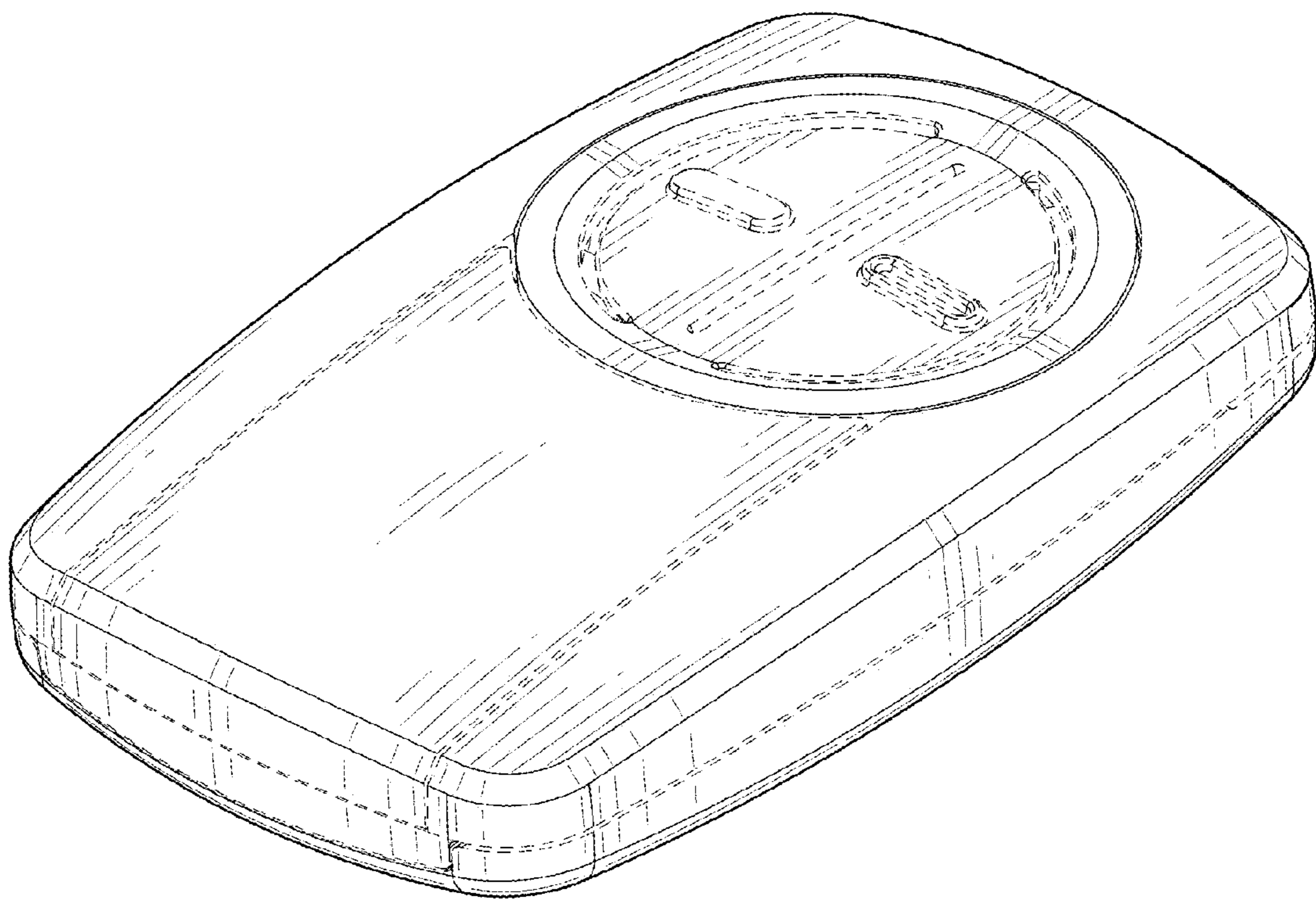

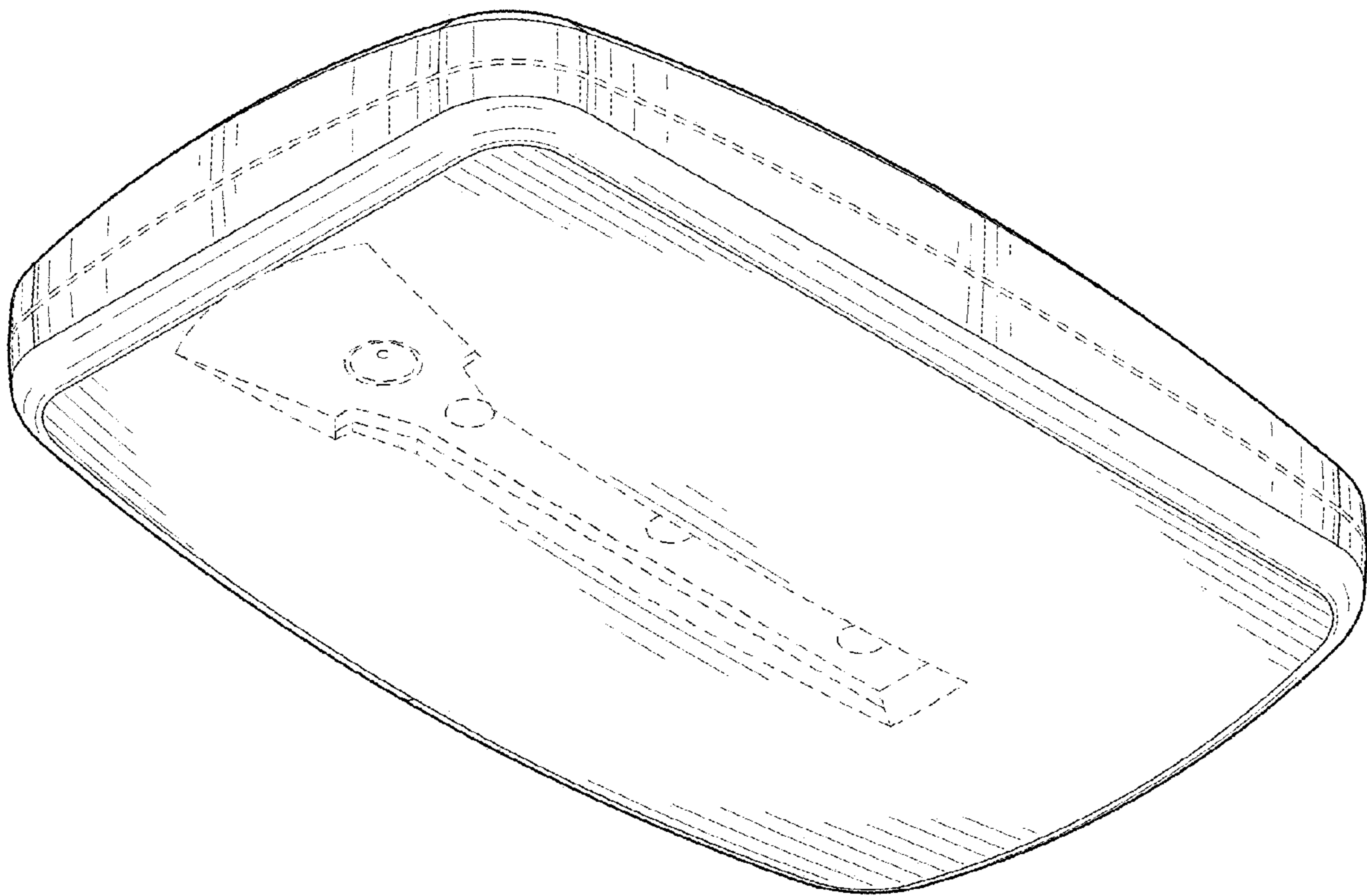

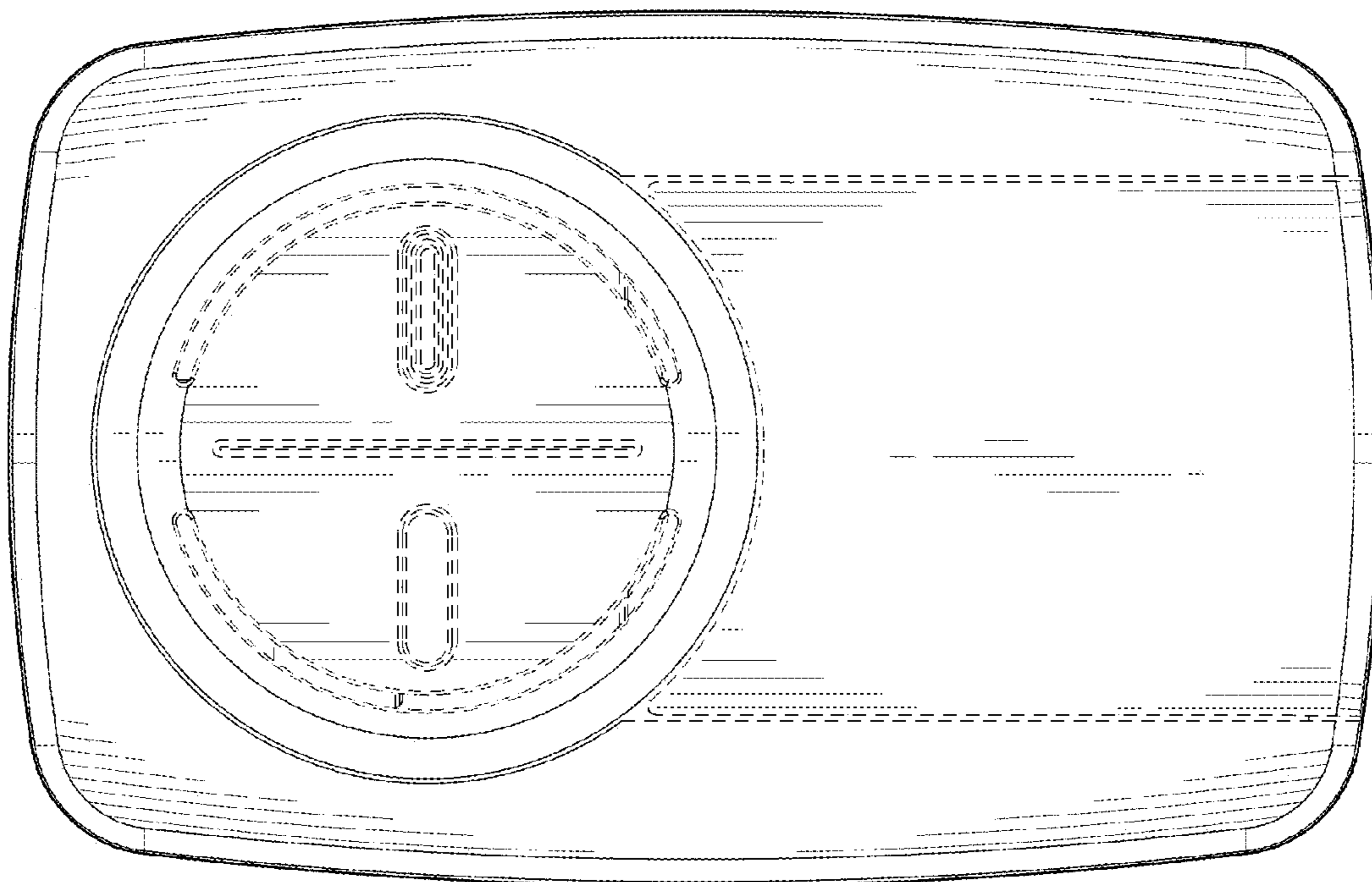

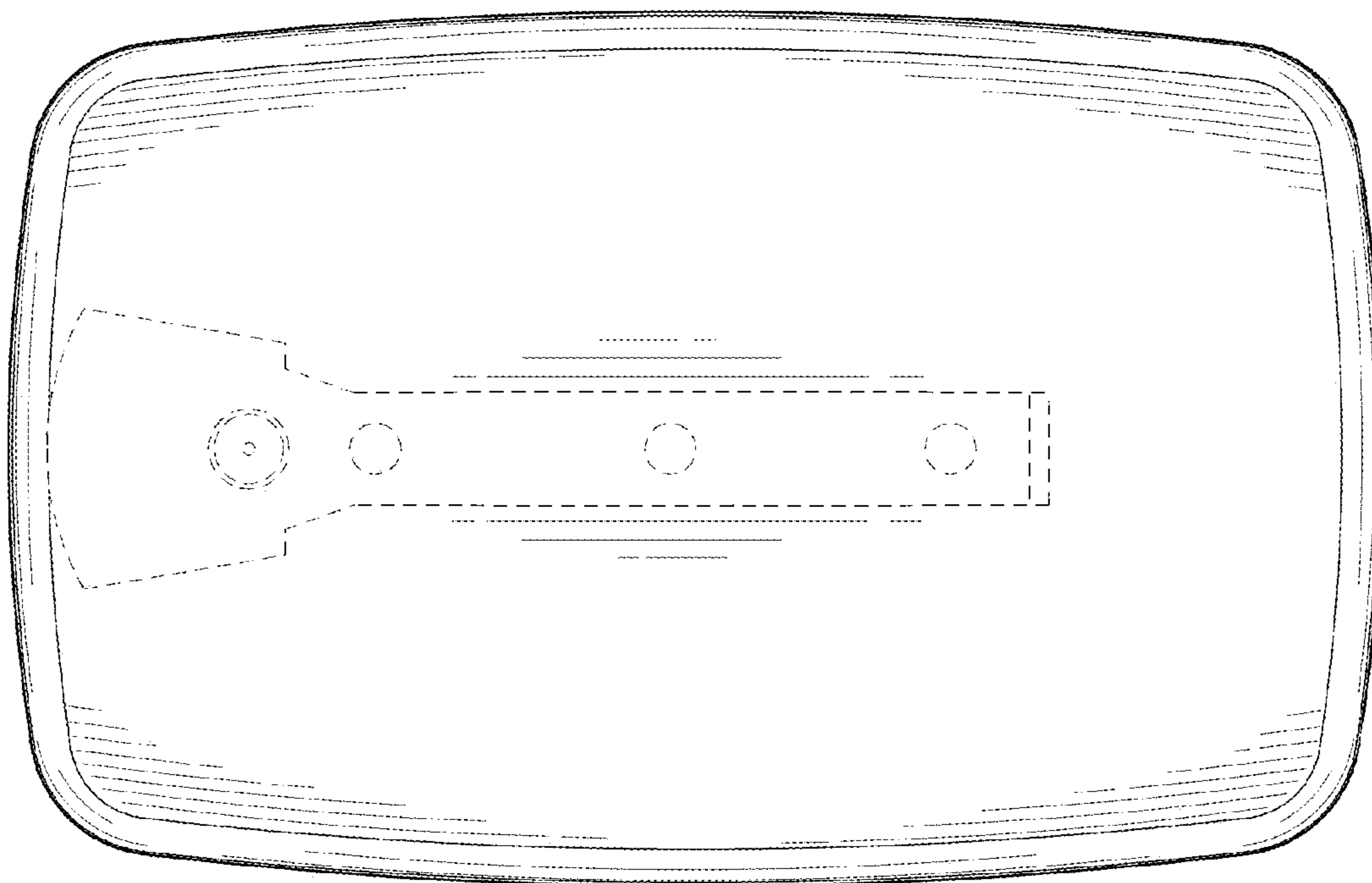

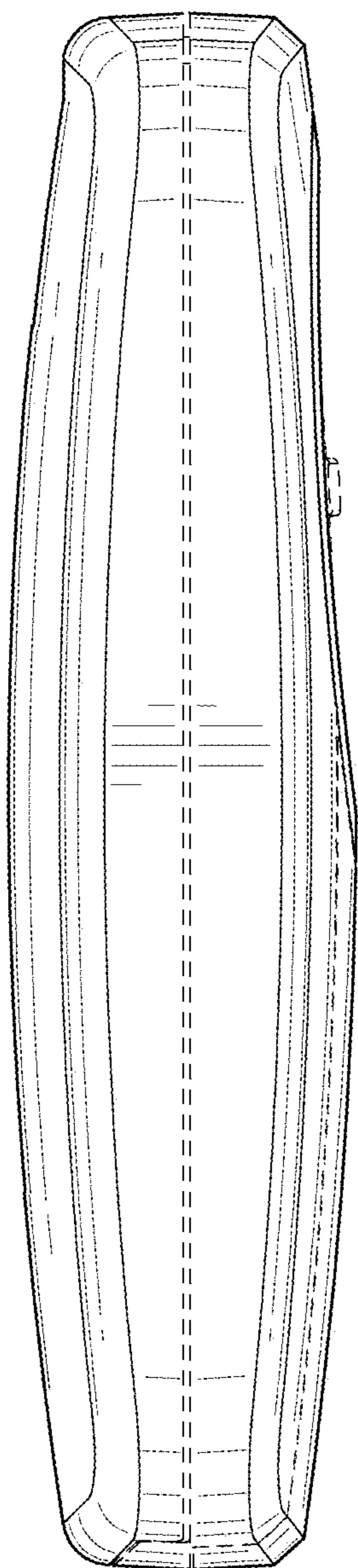

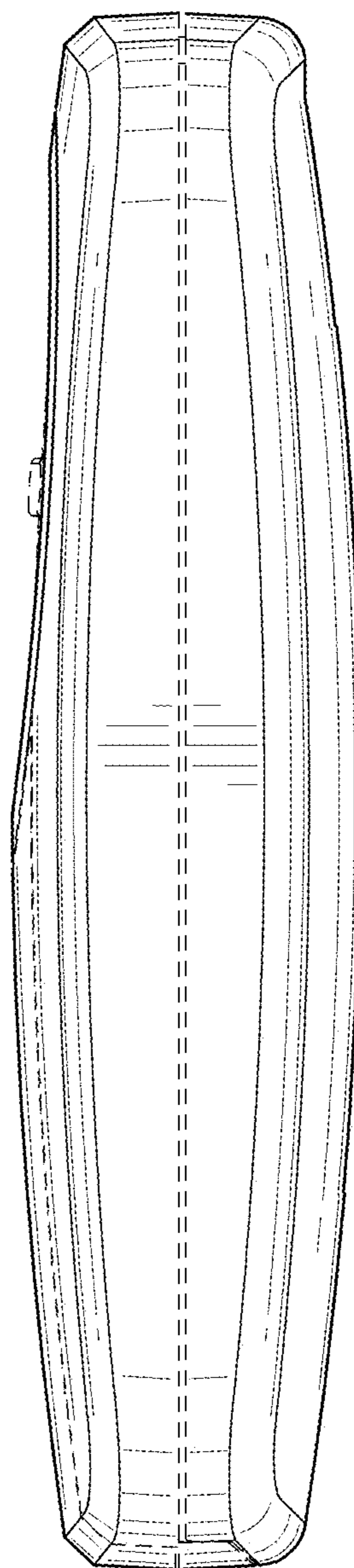

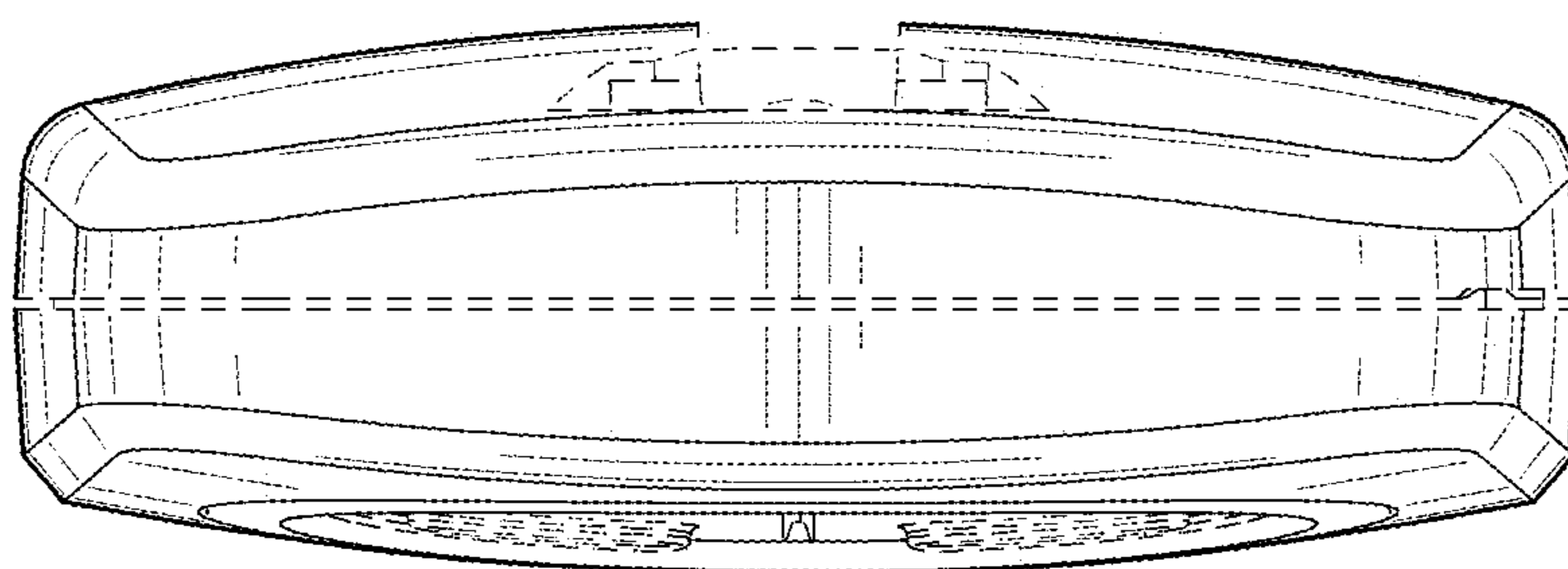

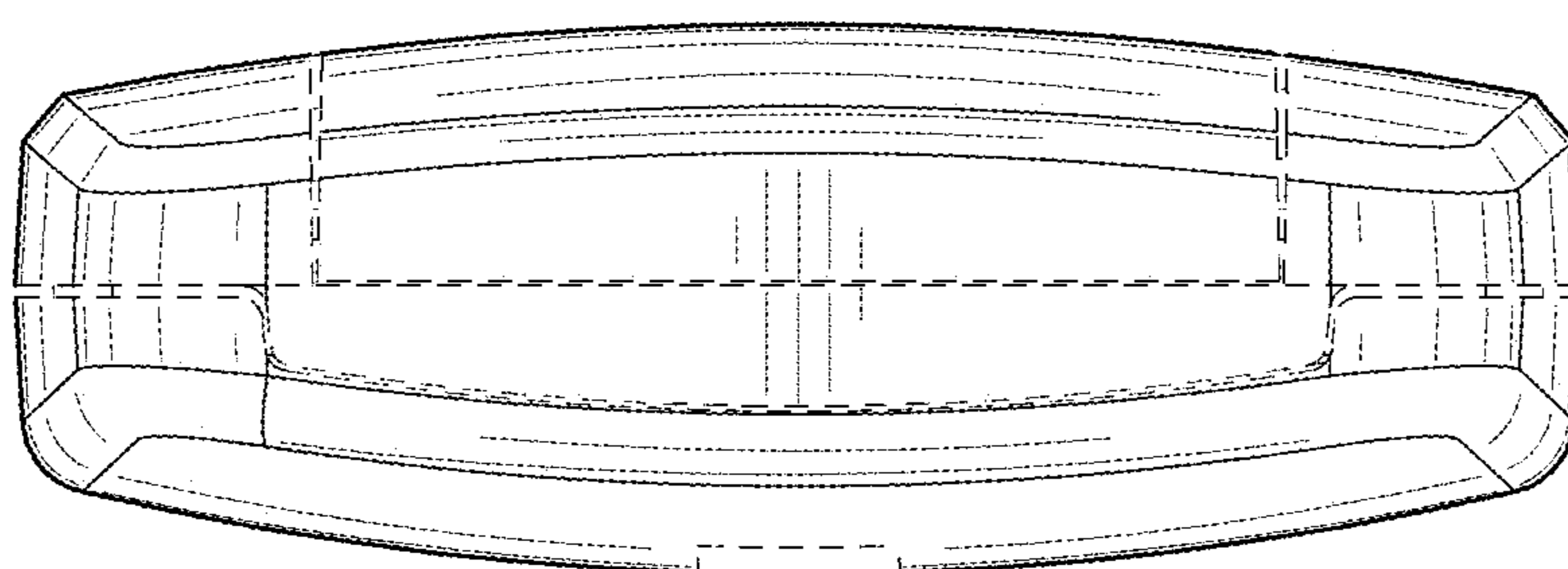
