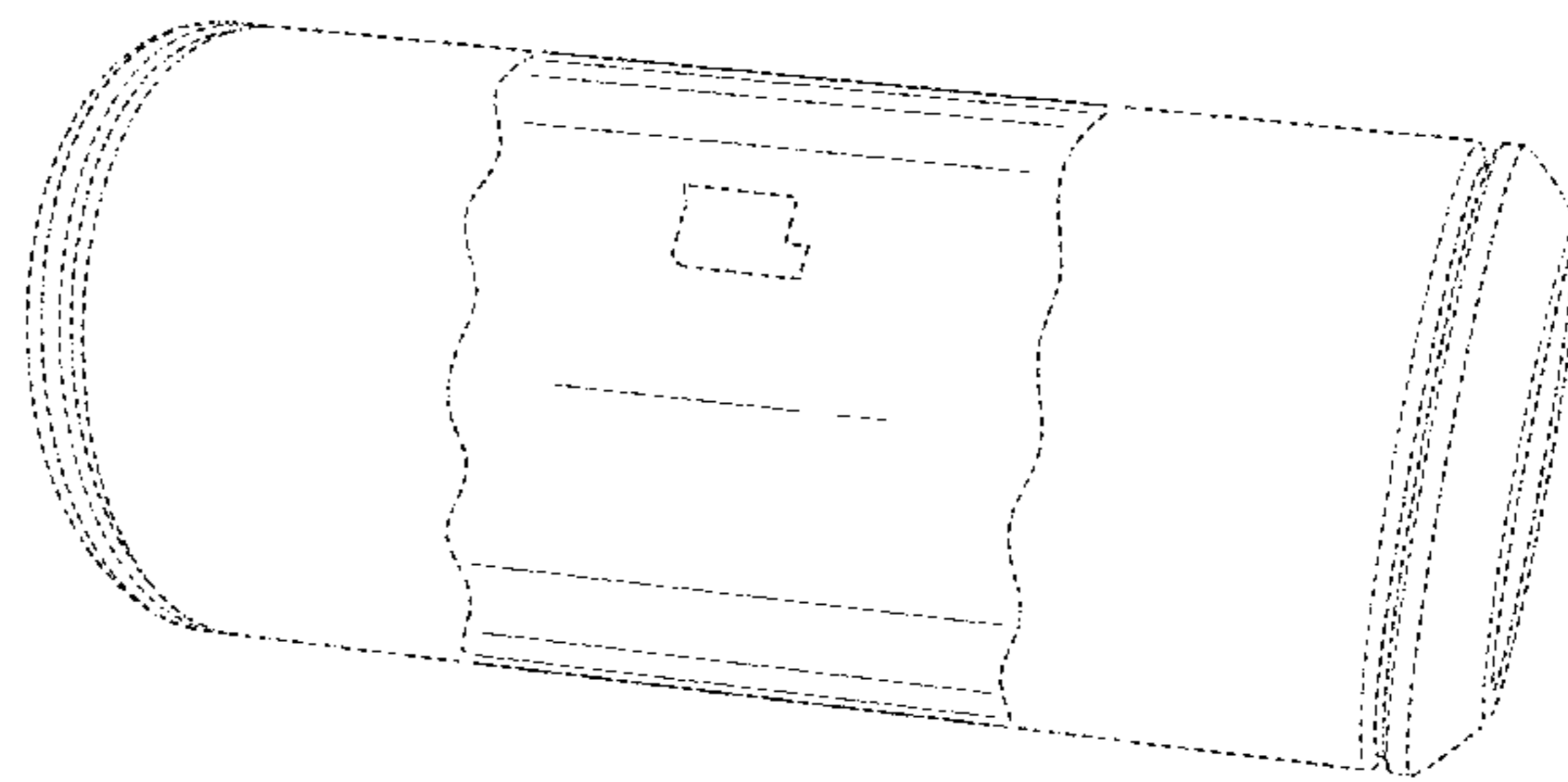
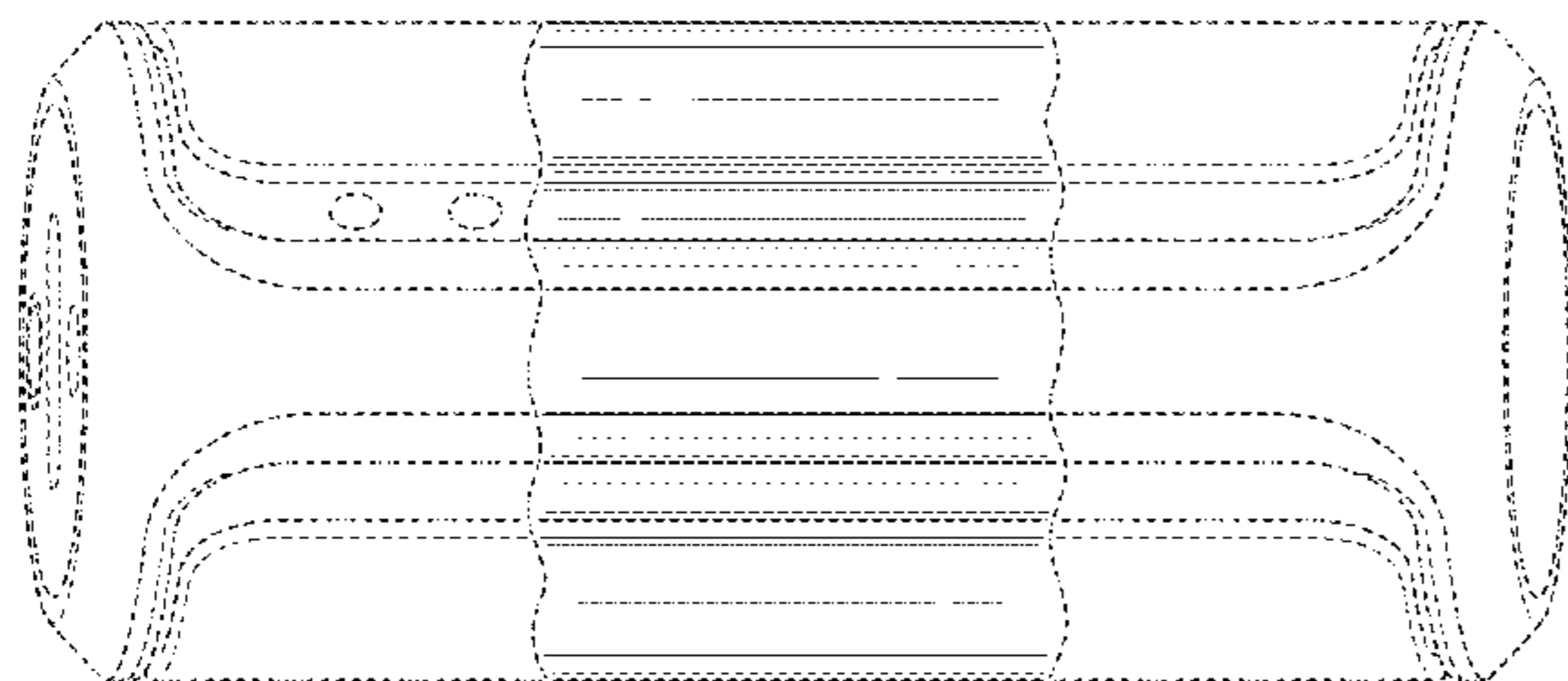
(57) **CLAIM**

The ornamental design for a loudspeaker, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a loudspeaker showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is an end elevational view thereof viewed from the left side of FIG. 1;
FIG. 6 is an end elevational view thereof viewed from the right side of FIG. 1; and,
FIG. 7 is a perspective view thereof shown rotated into an operating position from the position depicted in FIGS. 1-6.
The wavy broken lines seen around the circumference of the loudspeaker body represent the bounds of the claimed design while all other broken lines are included for the purpose of illustrating portions of the loudspeaker; the broken lines form no part of the claimed design.

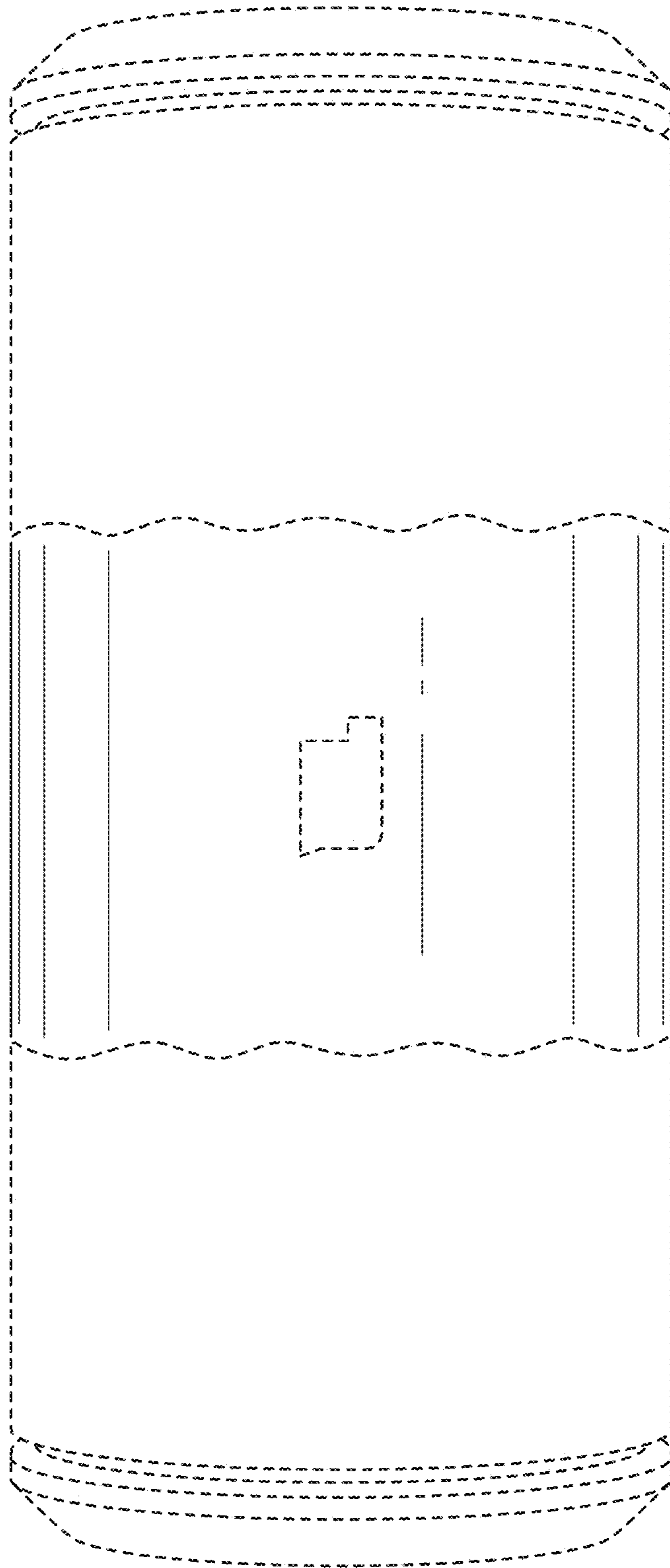

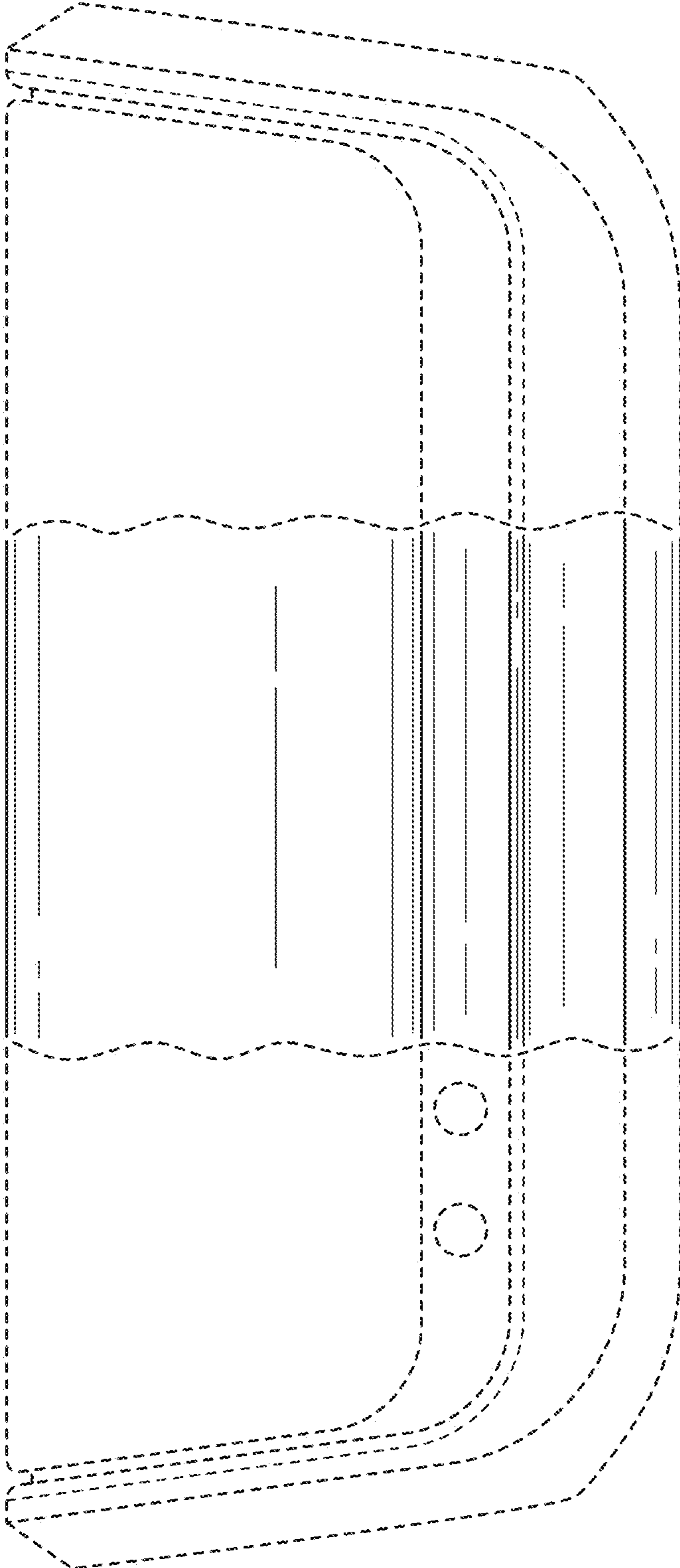

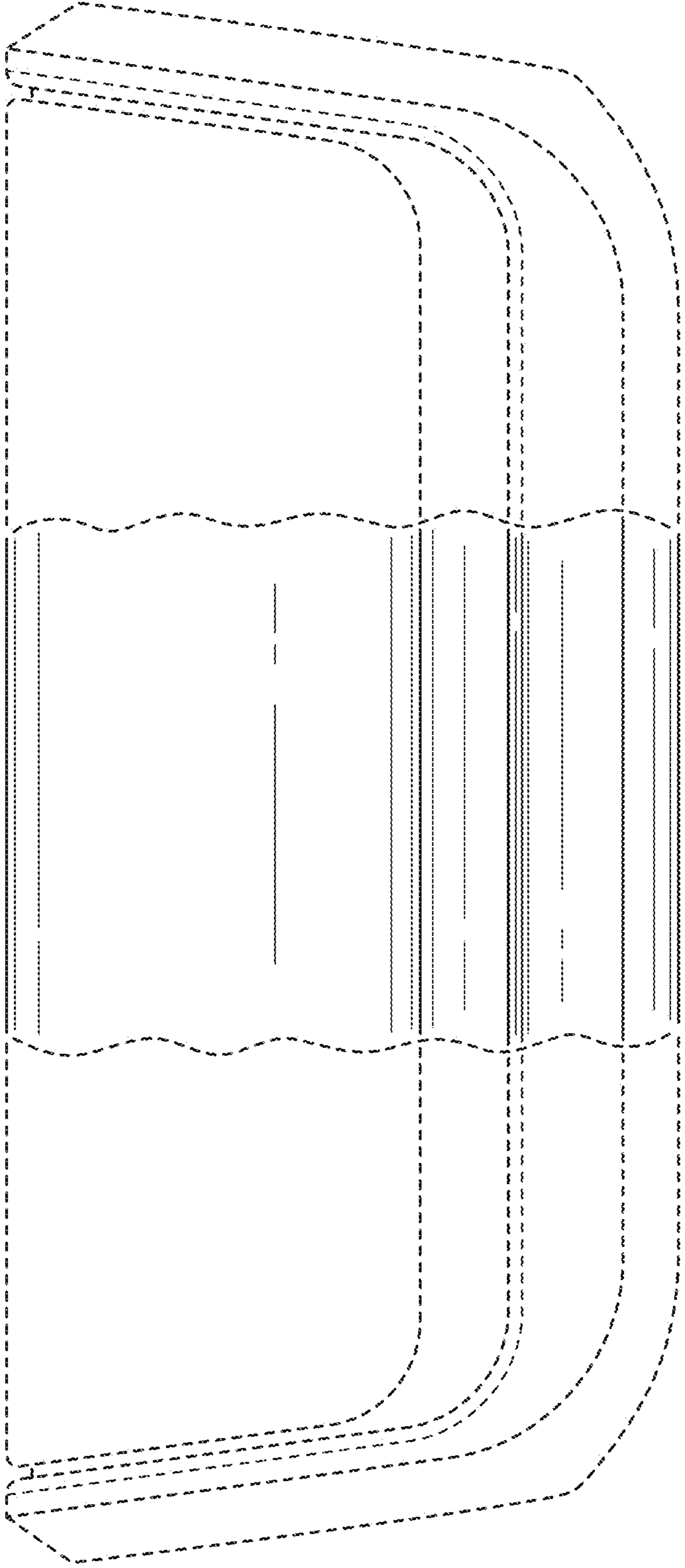

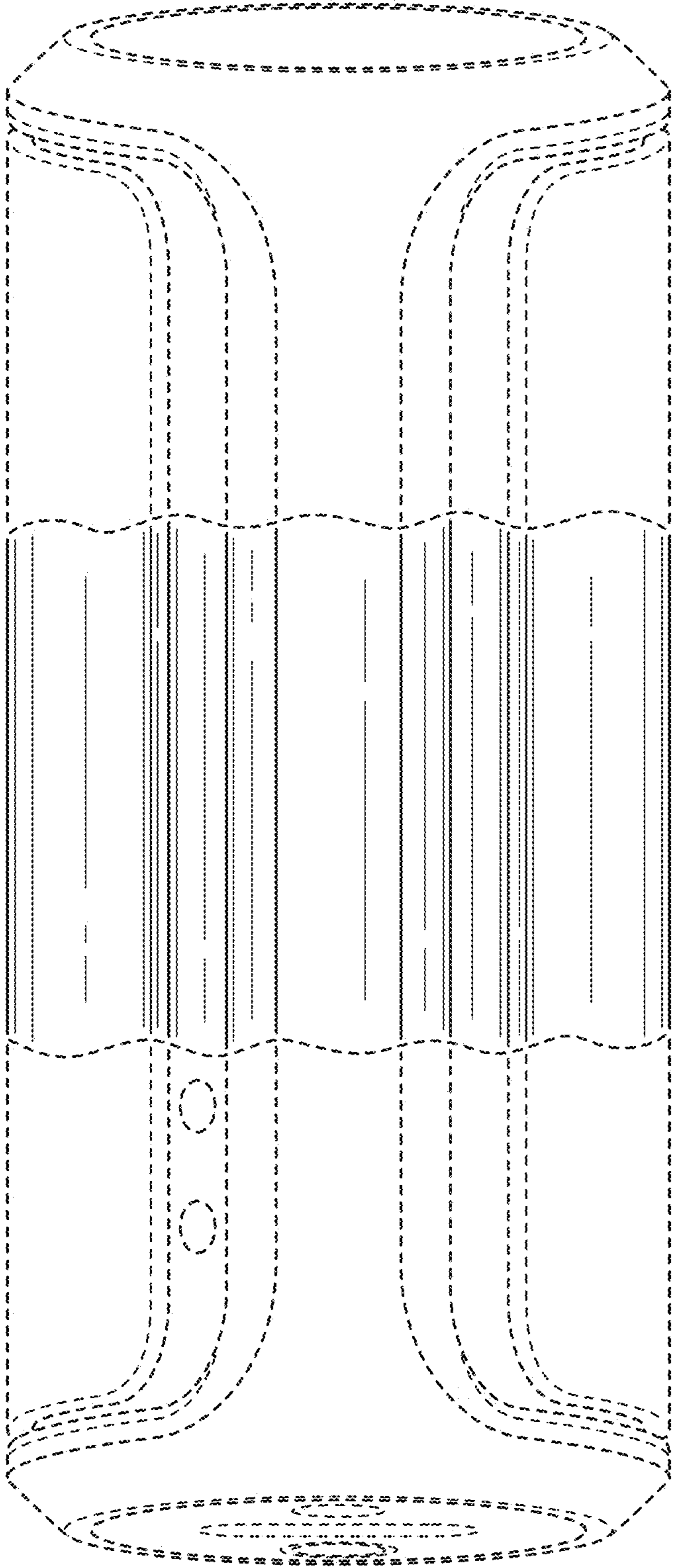

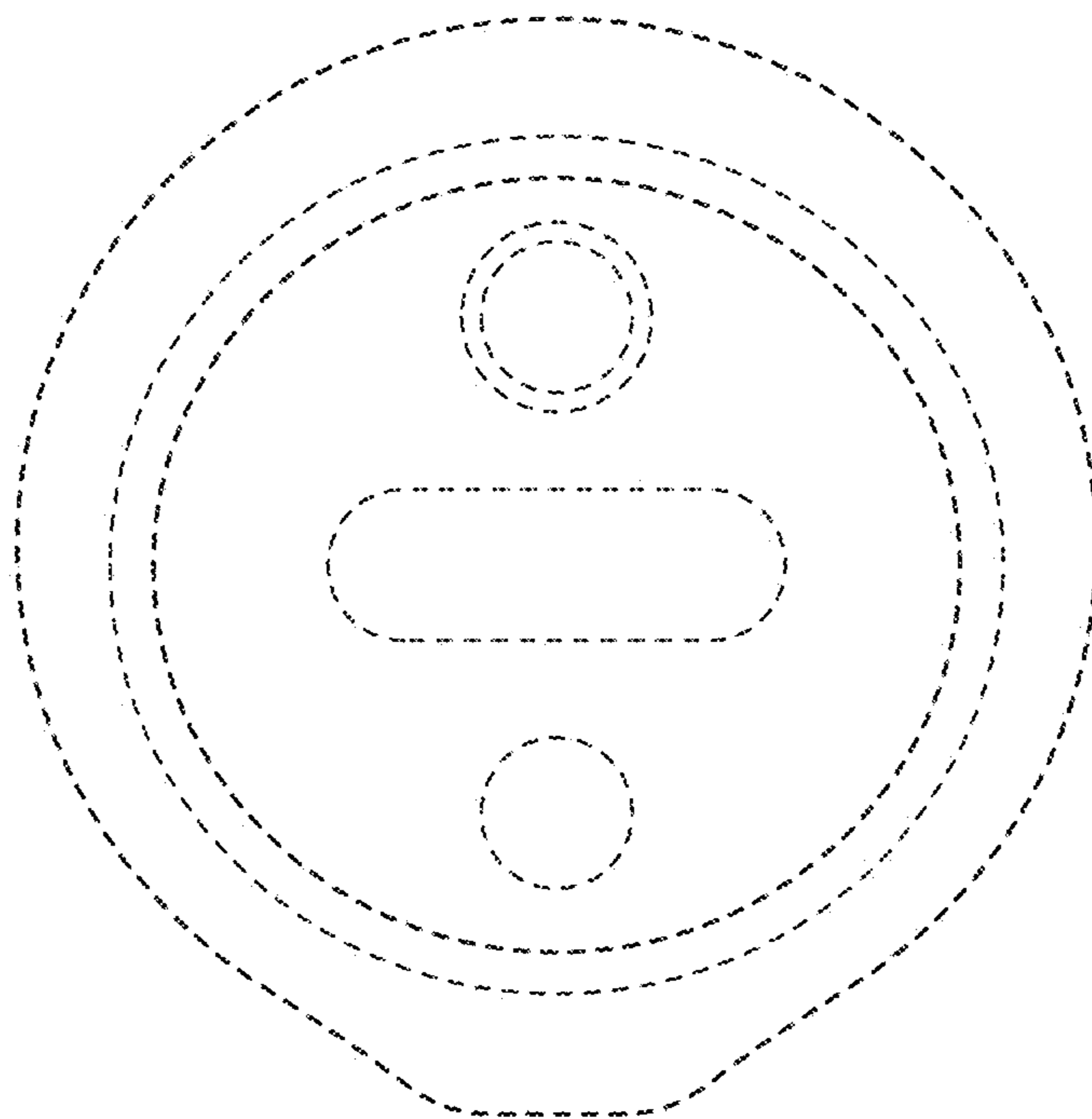

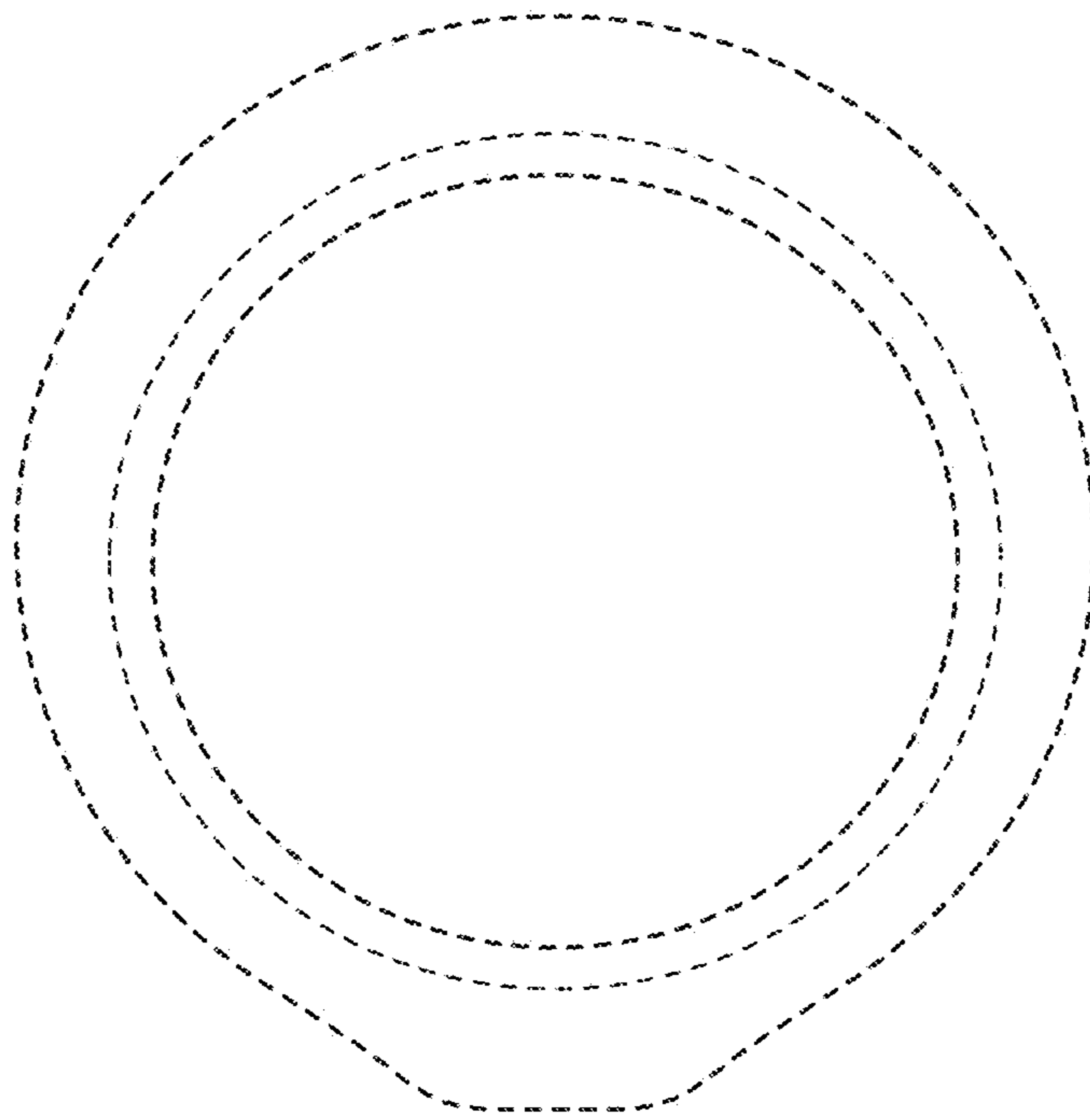

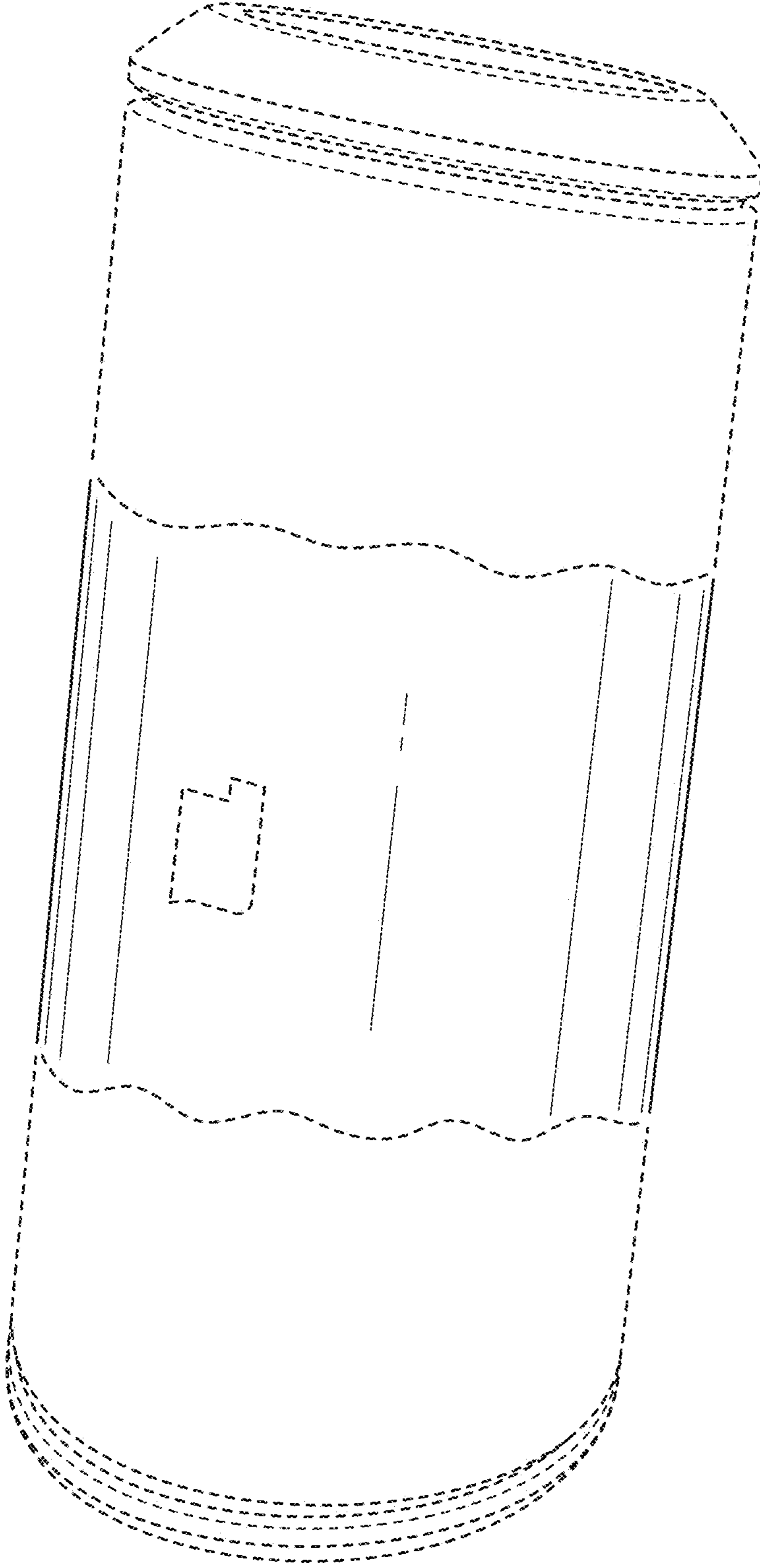
