(57) **CLAIM**

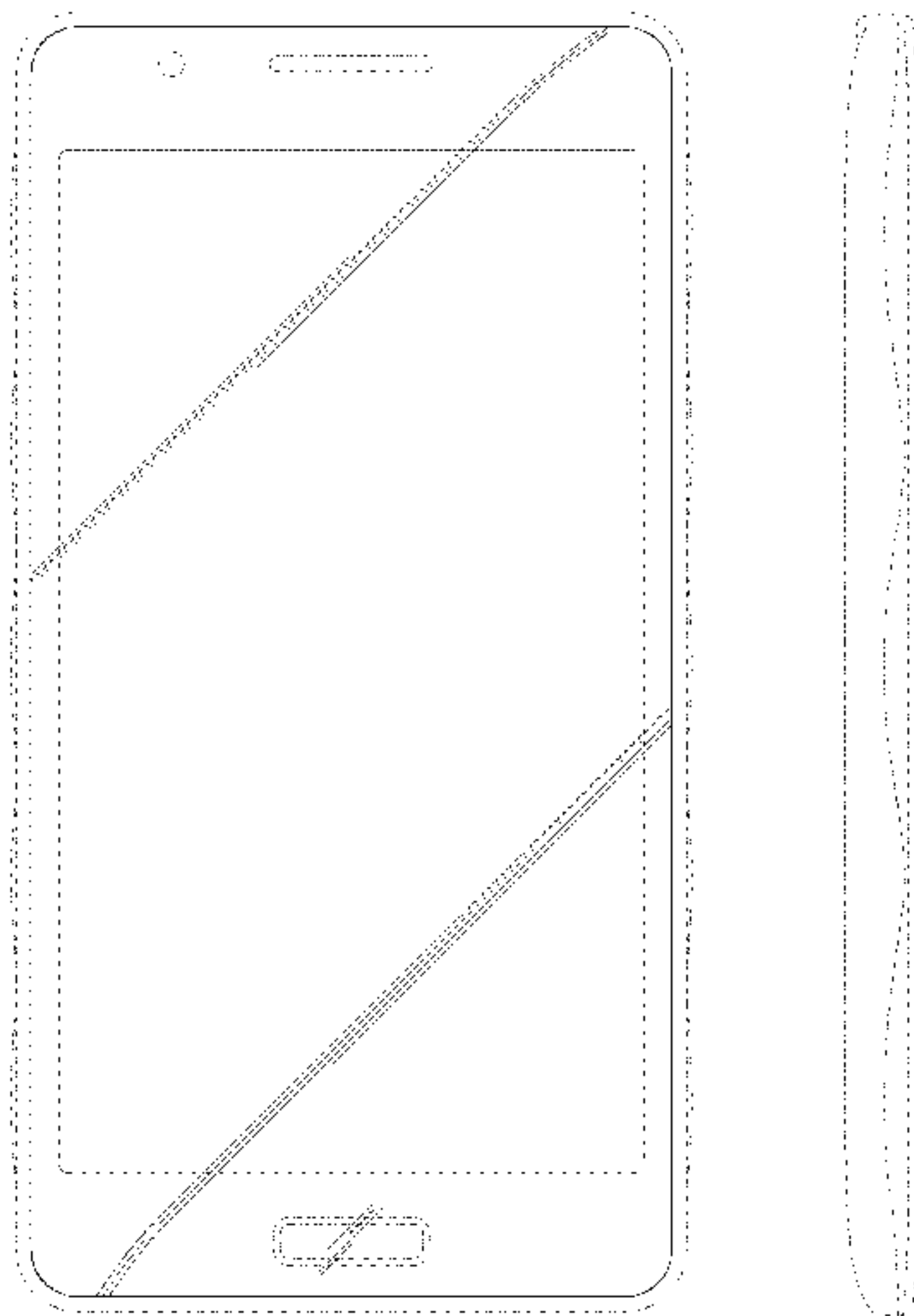
The ornamental design for a portable terminal, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a portable terminal showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left-side view thereof;
FIG. 5 is a right-side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof; and,
FIG. 8 is an enlarged view of the encircled portion A as shown in FIG. 7.

The broken lines shown in the drawings represent portions of the portable terminal that form no part of the claimed design. The dot-dash broken lines in FIGS. 7 and 8 illustrate an enlarged detail and form no part of the claim design. The shade lines in the figures show contour and not surface ornamentation.

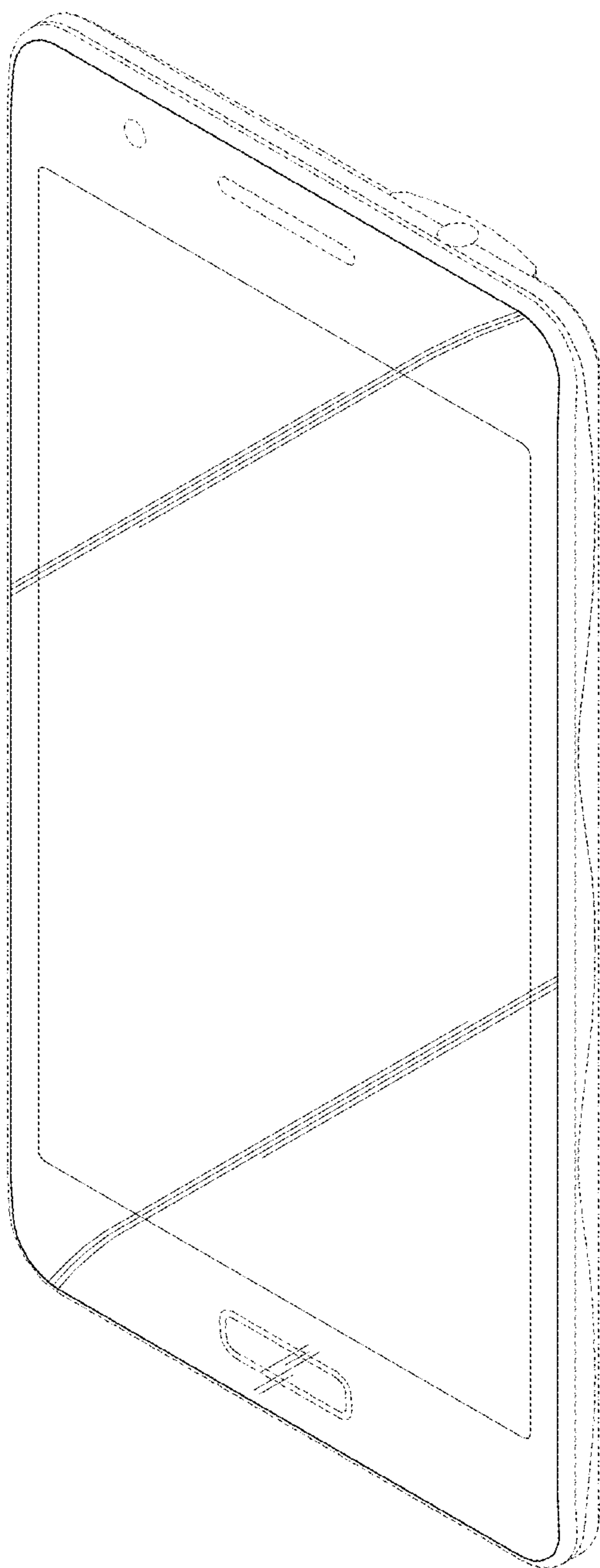

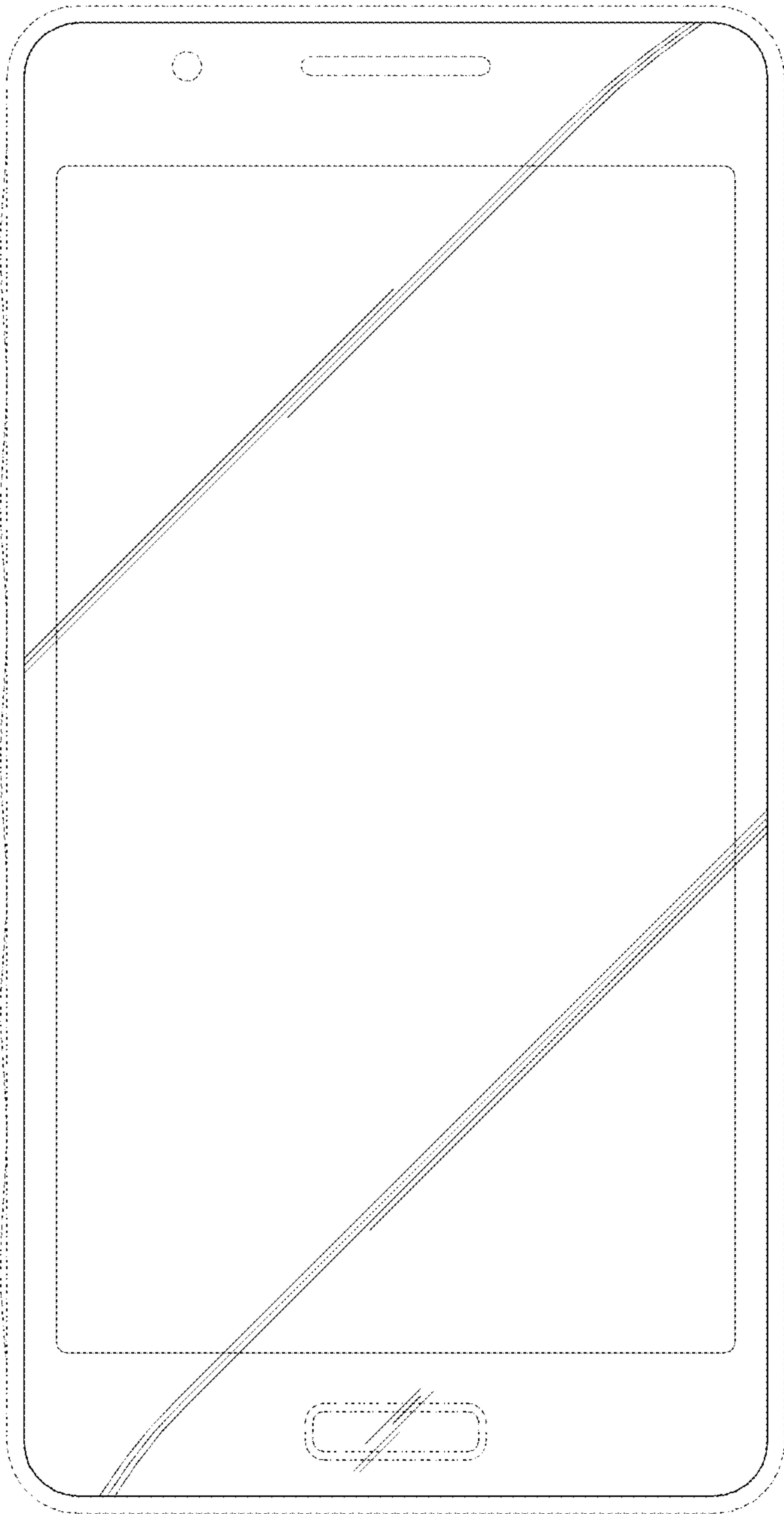

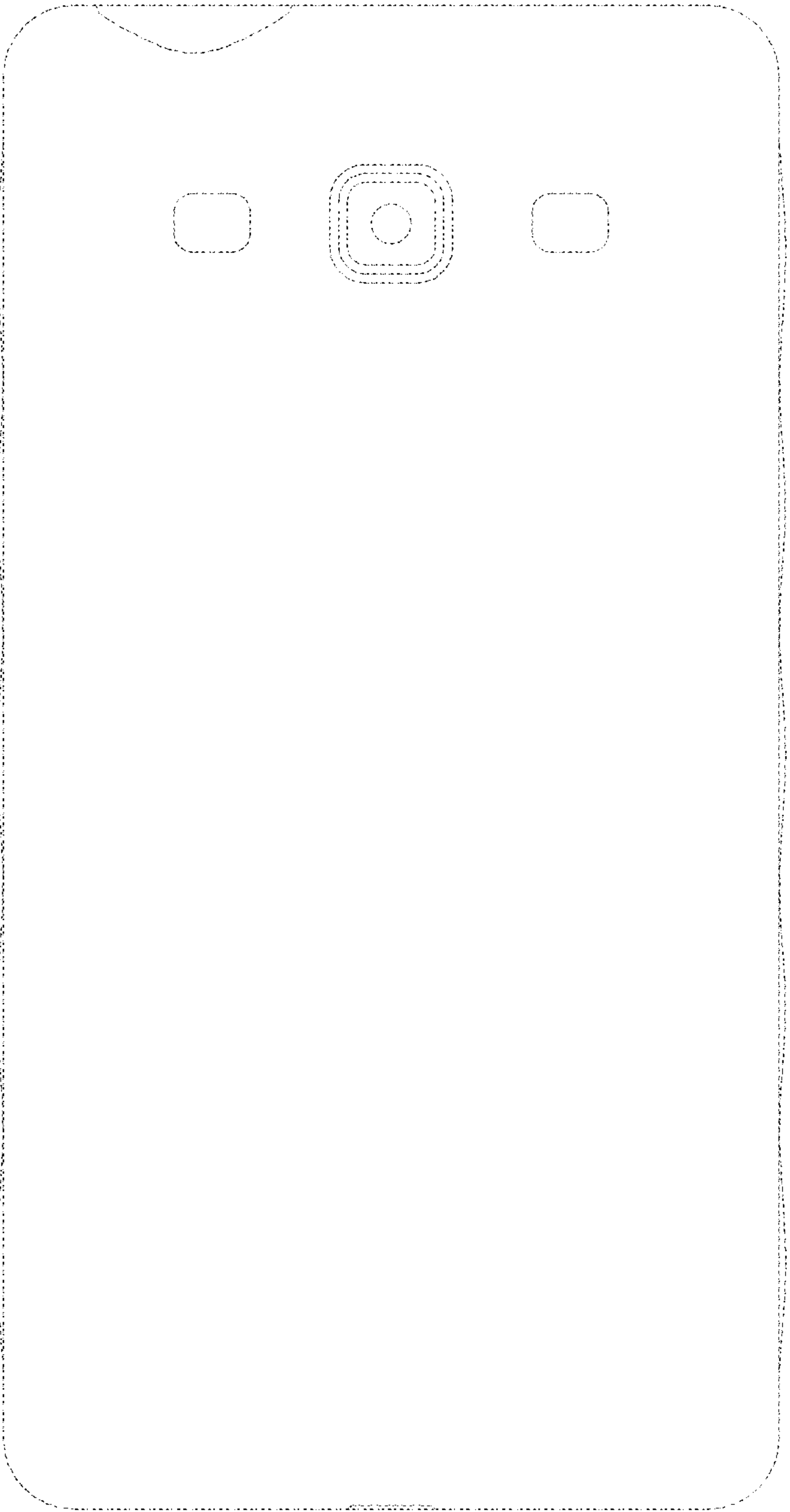

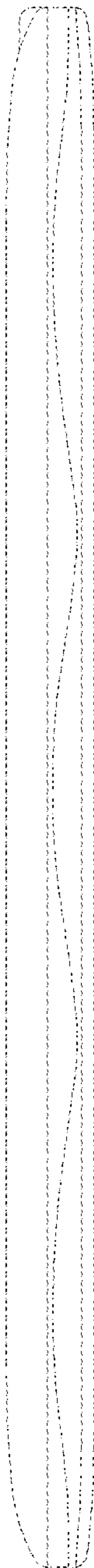

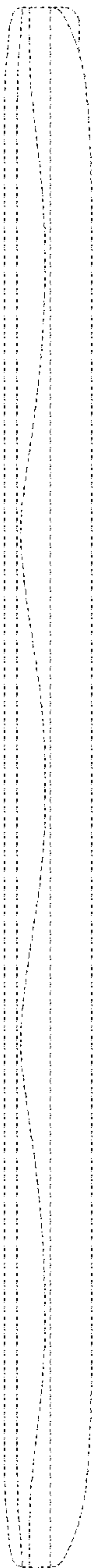

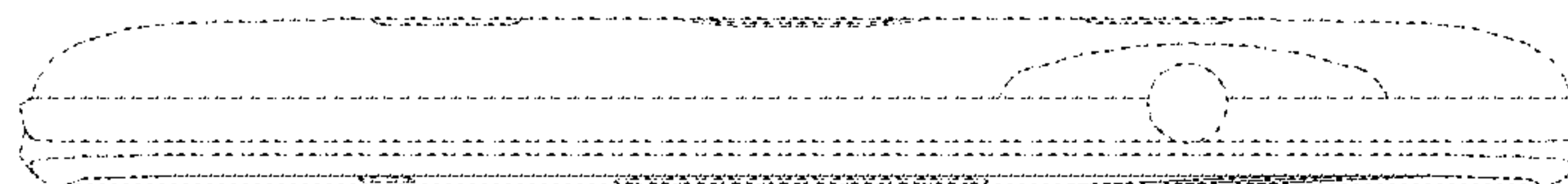

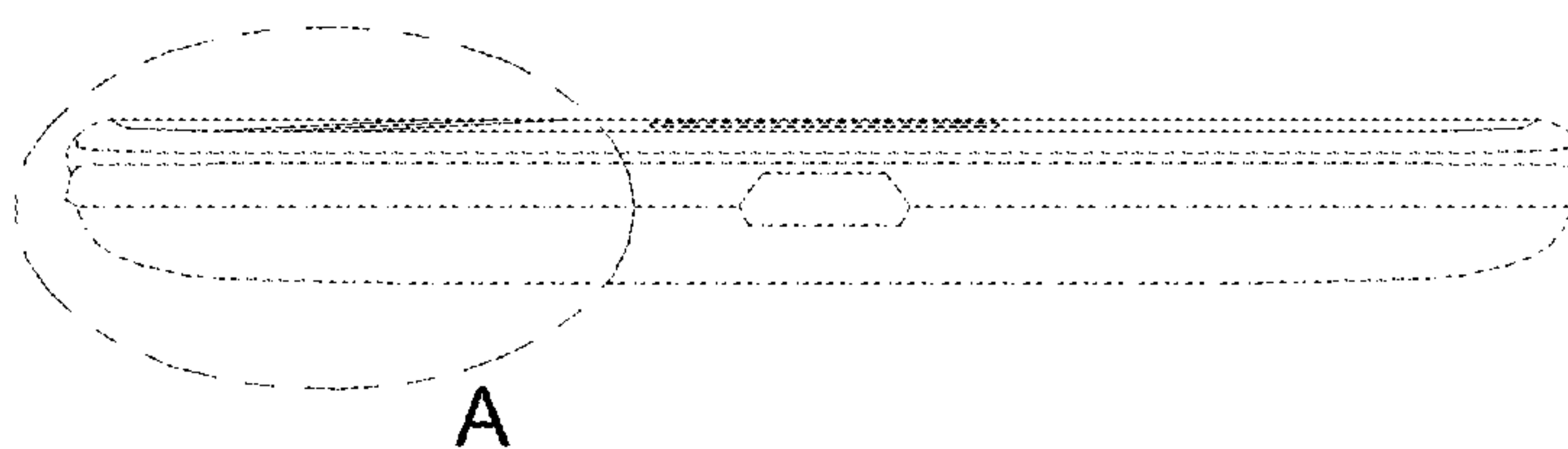
