FIG. 1 is a front view of a display screen with graphical user interface showing our new design;

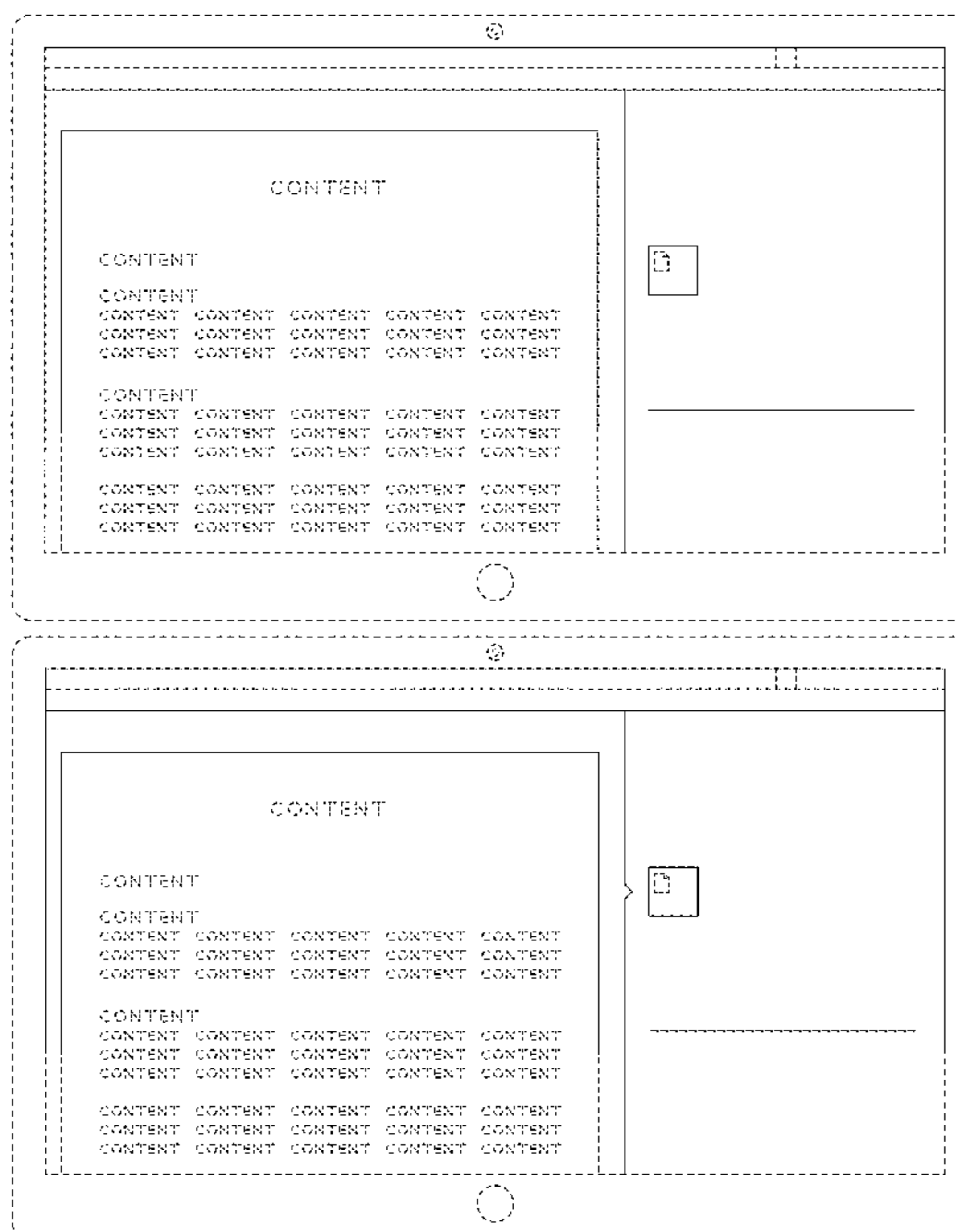
FIG. 2 is a front view of a display screen with graphical user interface showing an alternative embodiment of our new design;

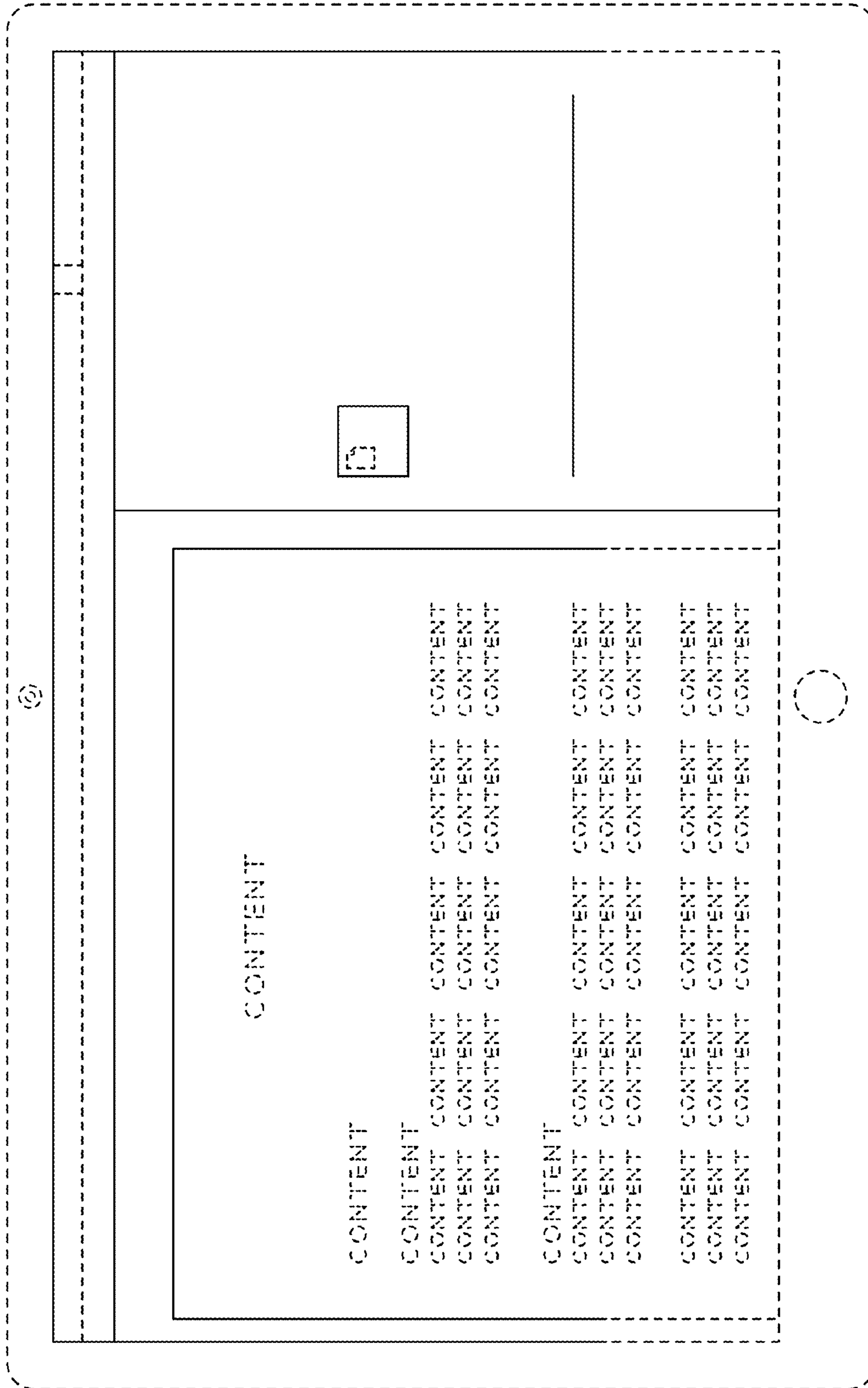

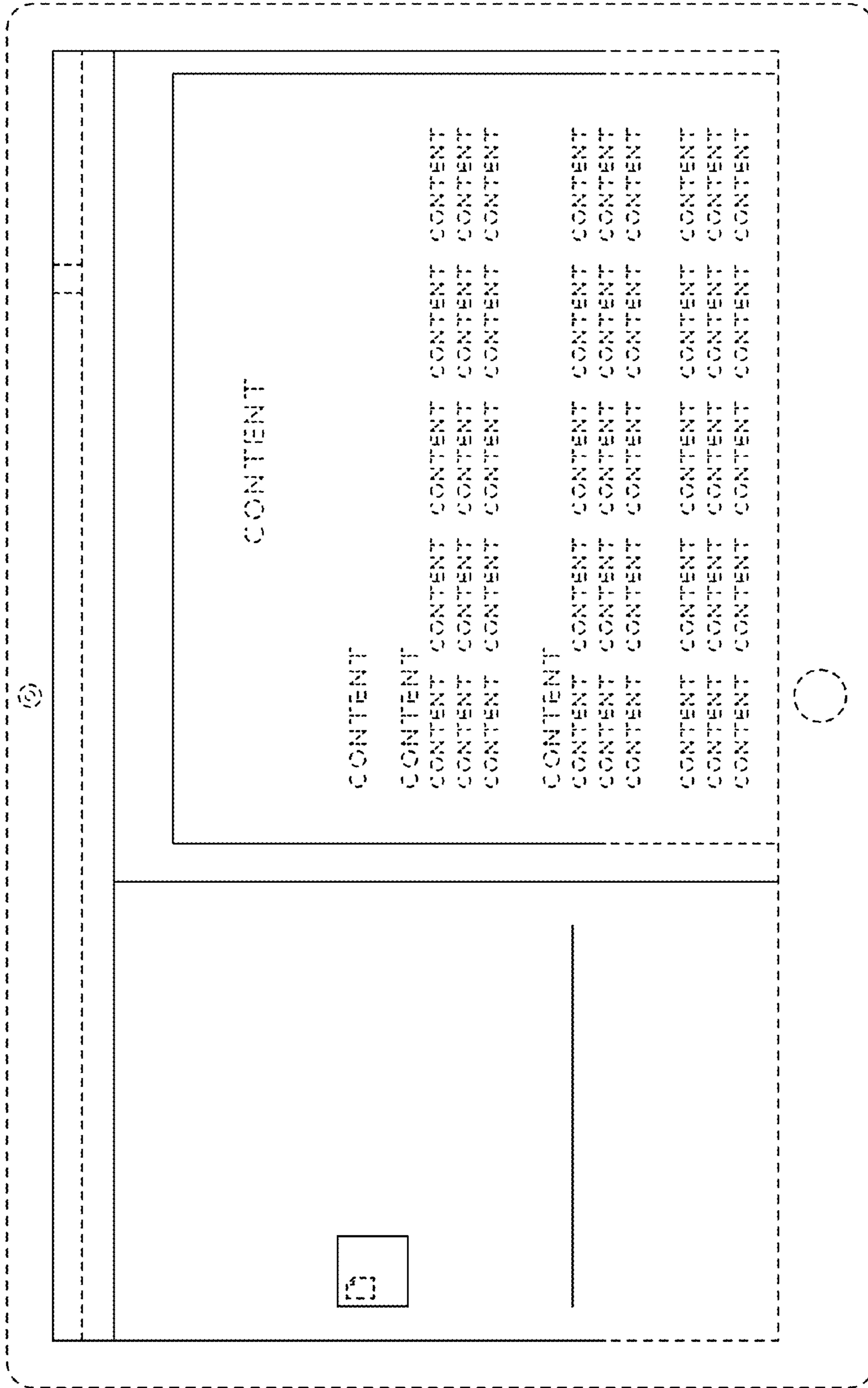

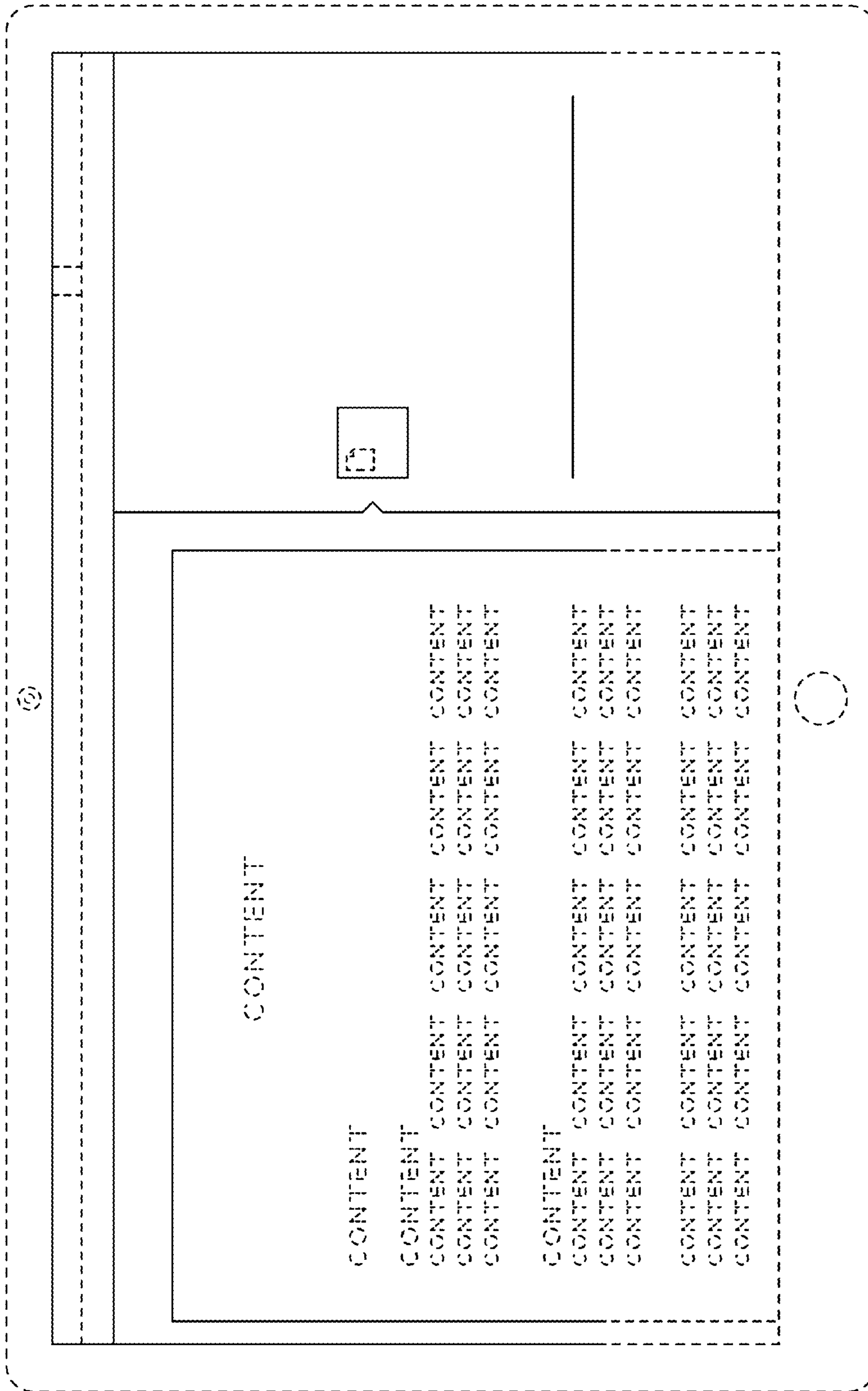

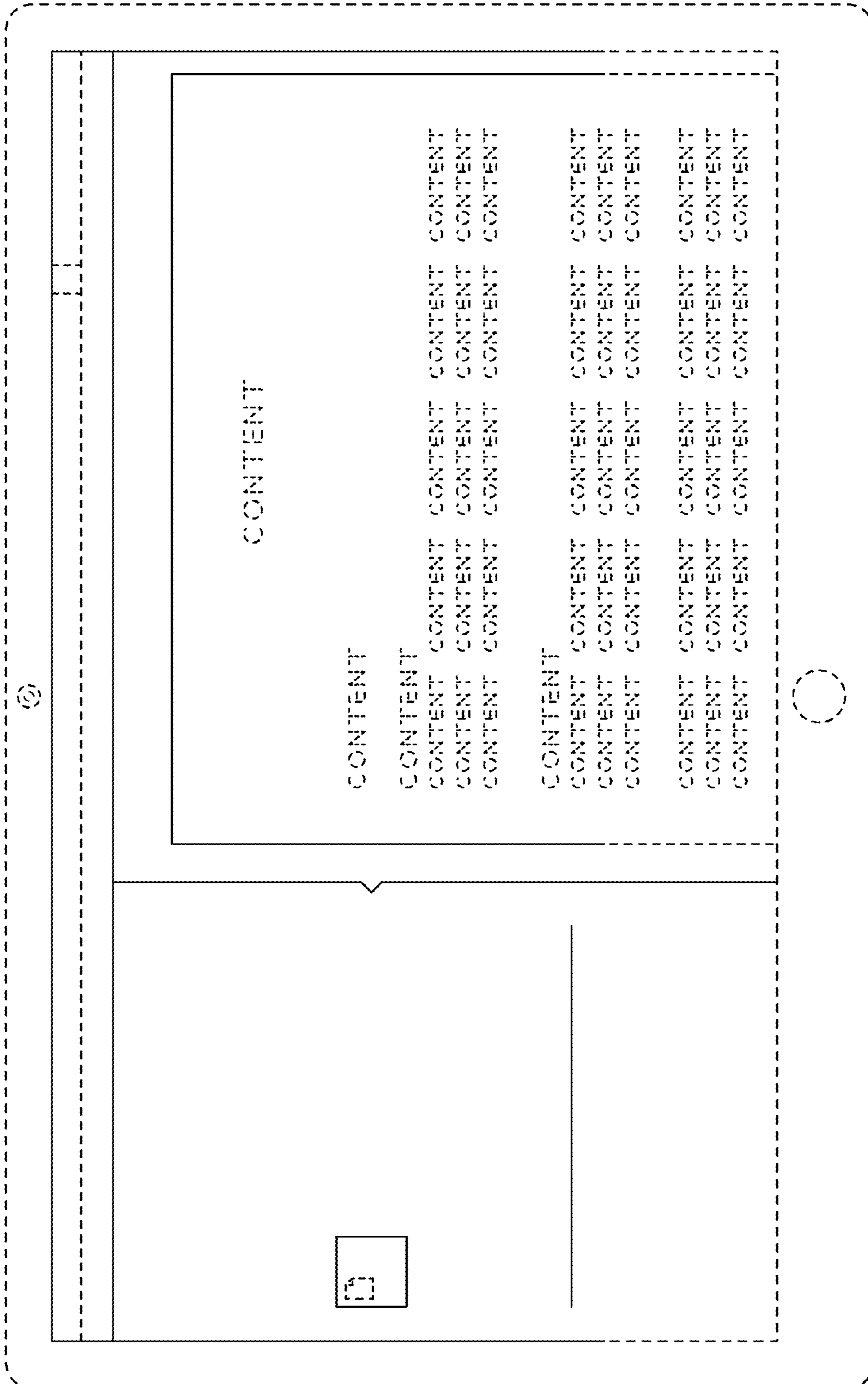
