**DESCRIPTION**

FIG. 1 is a top plan view of the weather stripping, with the central flaps in a closed position;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a bottom view thereof;  
FIG. 5 is a right side view thereof with the central flaps disposed in an open position, the left side view being a mirror image;  
FIG. 6 is a right side view thereof with the central flaps disposed in a closed position, the left side view being a mirror image;  
FIG. 7 is a top plan view of a second embodiment of the weather stripping, with the central flaps in a closed position;  
FIG. 8 is a front view thereof;  
FIG. 9 is a rear view thereof;  
FIG. 10 is a bottom view thereof;  
FIG. 11 is a right side view thereof, with the central flaps disposed in an open position, the left side view being a mirror image; and,  
FIG. 12 is a right side view thereof, with the central flaps disposed in a closed position, the left side view being a mirror image.

The weather stripping of the present design is depicted in a ‘broken-away’ manner. The appearance of any portion of the article between the break lines forms no part of the claimed design.

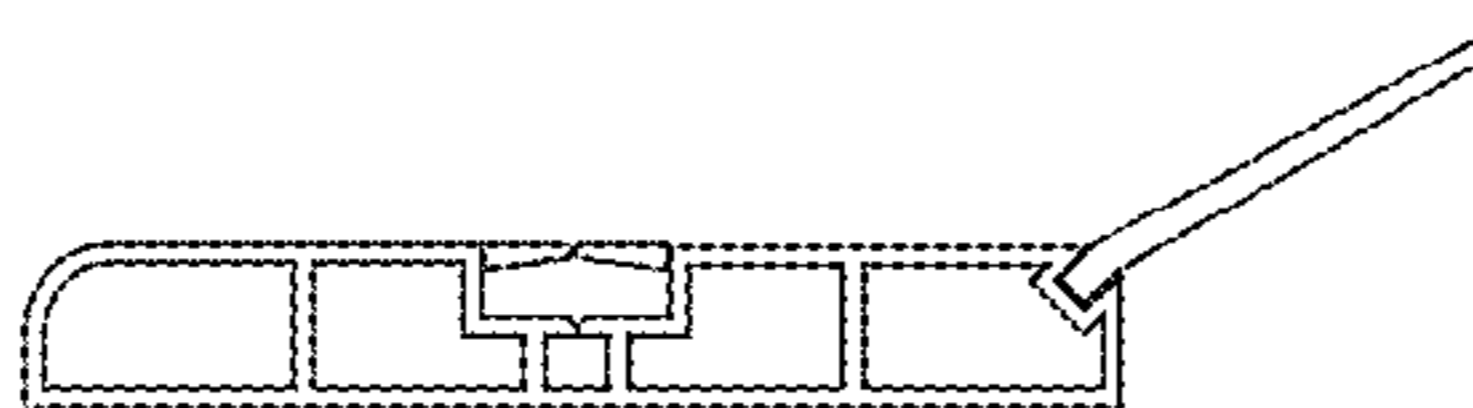
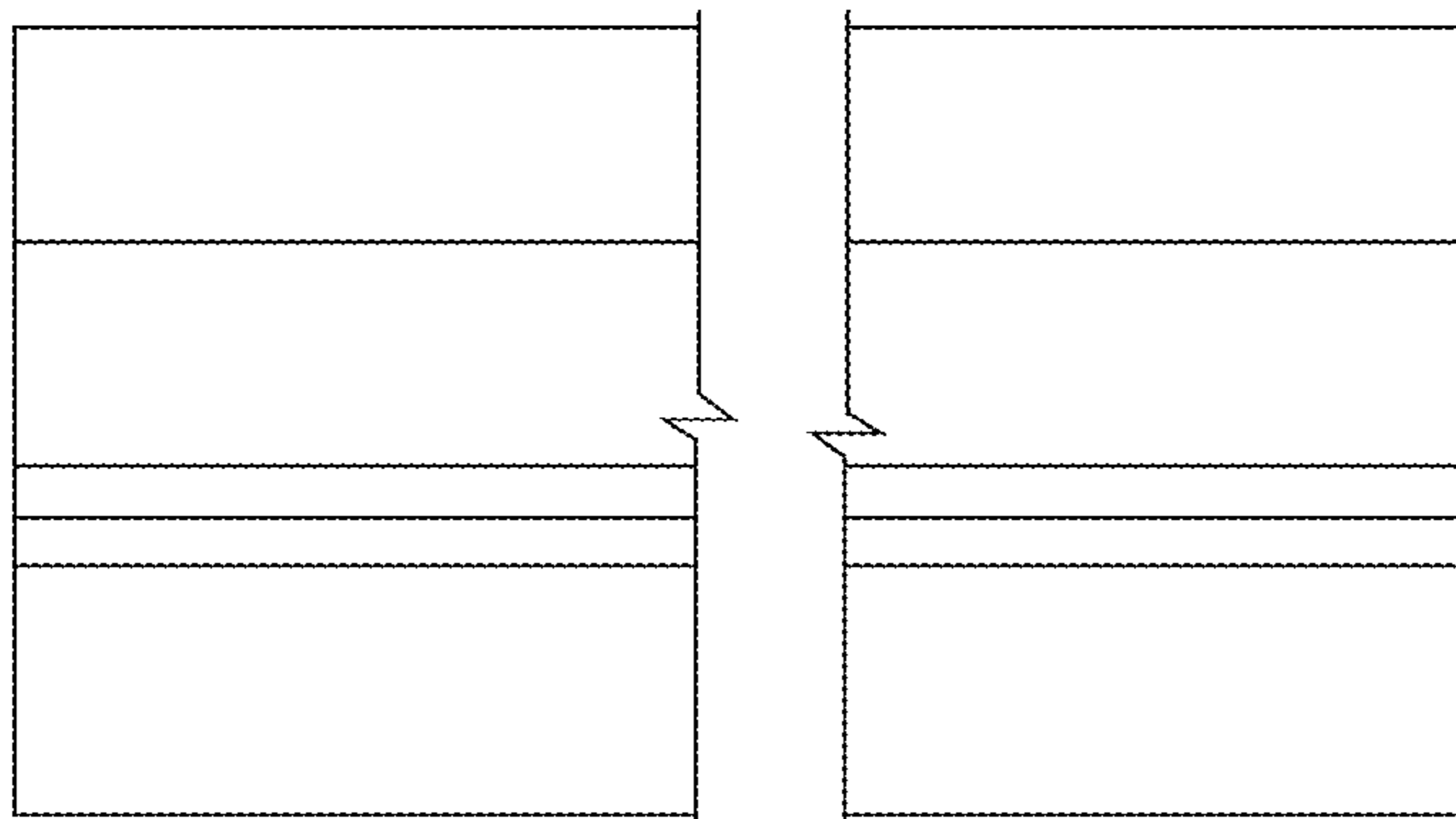

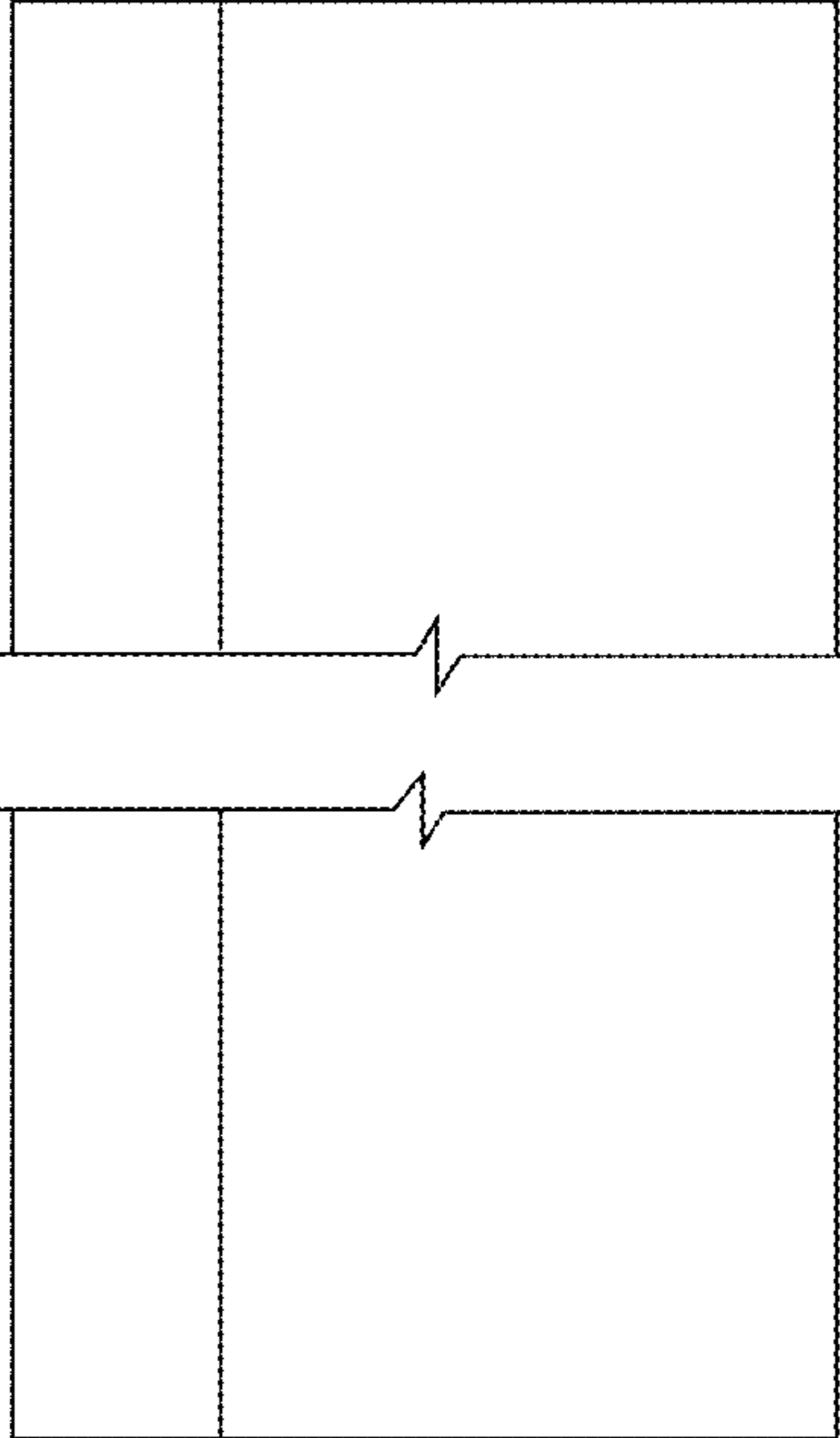

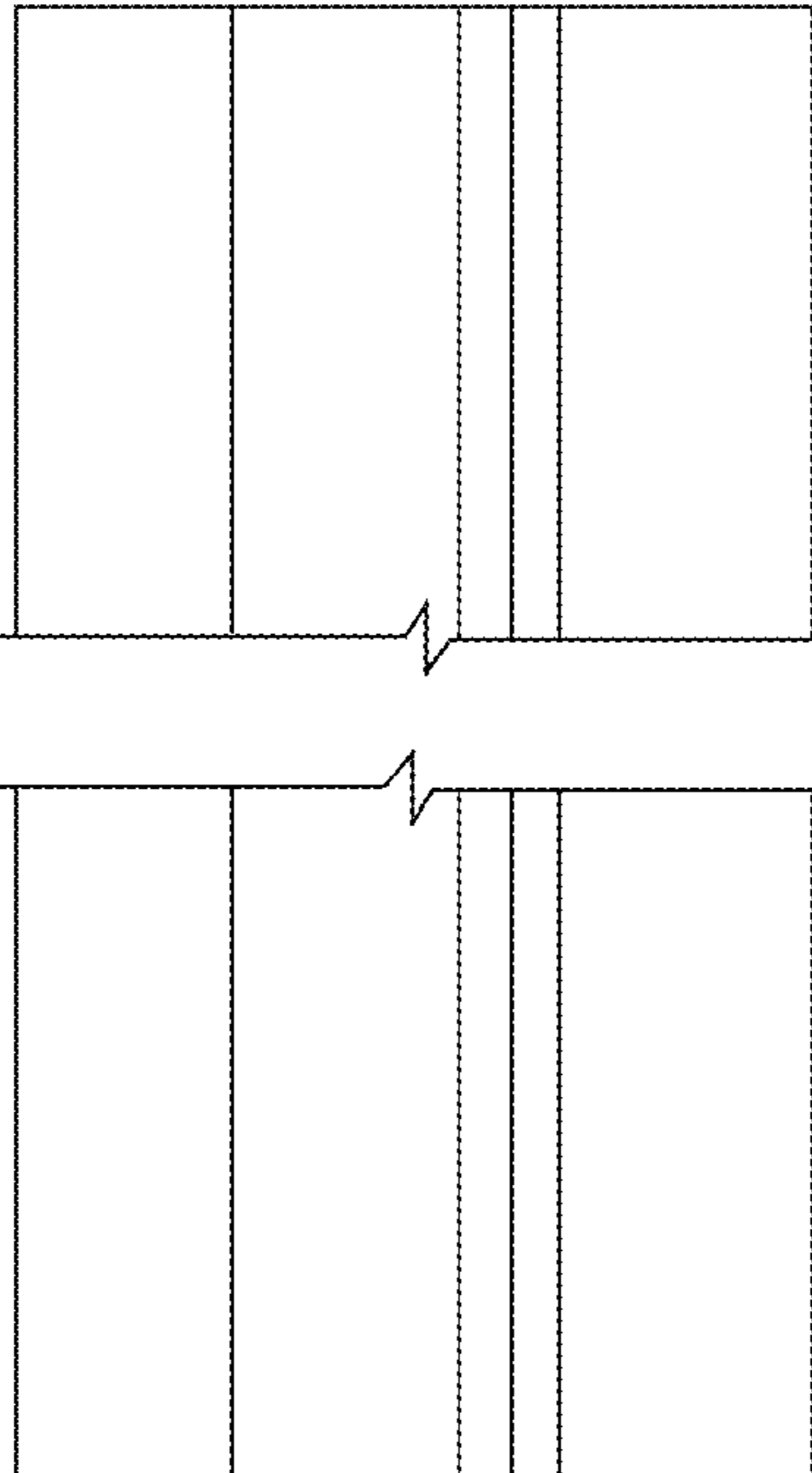

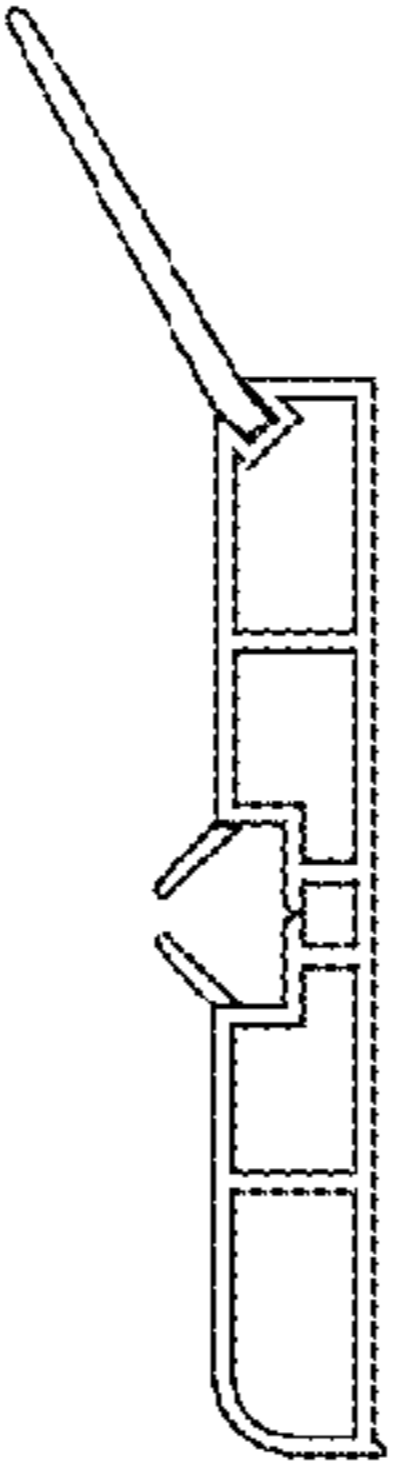

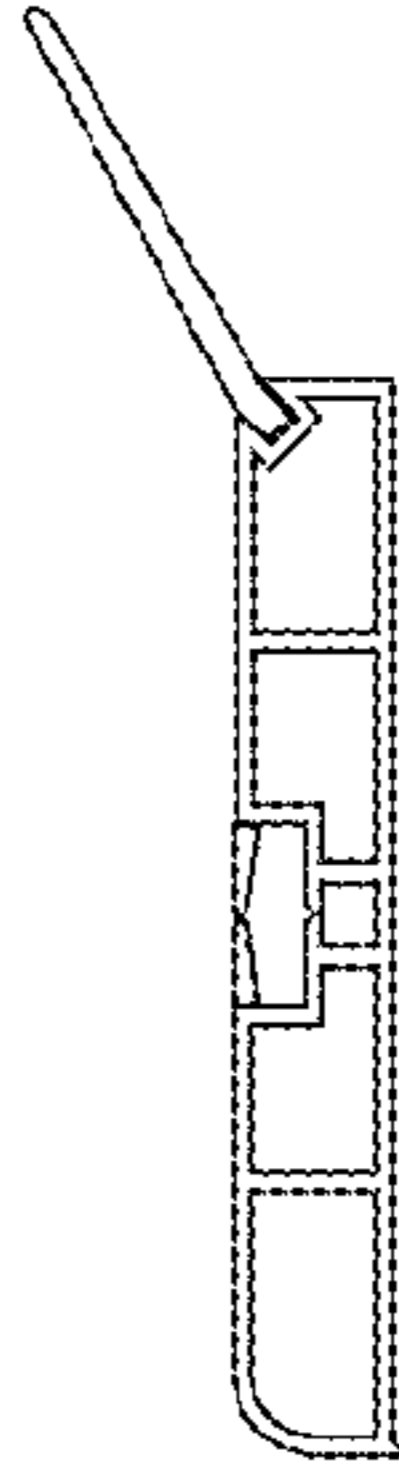

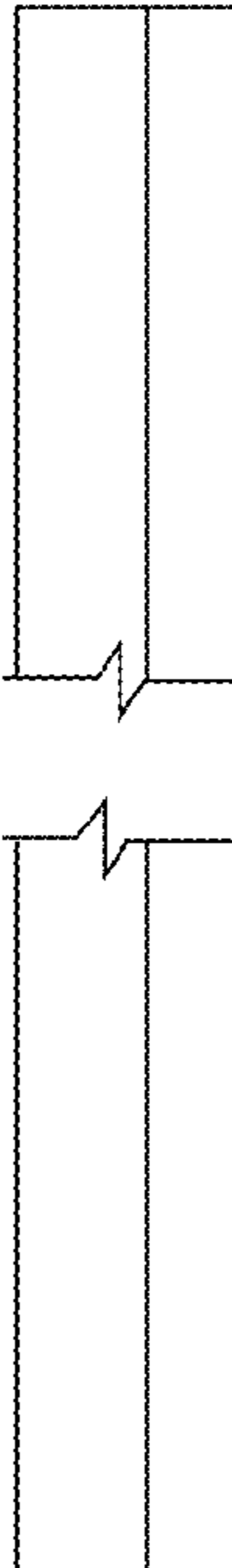

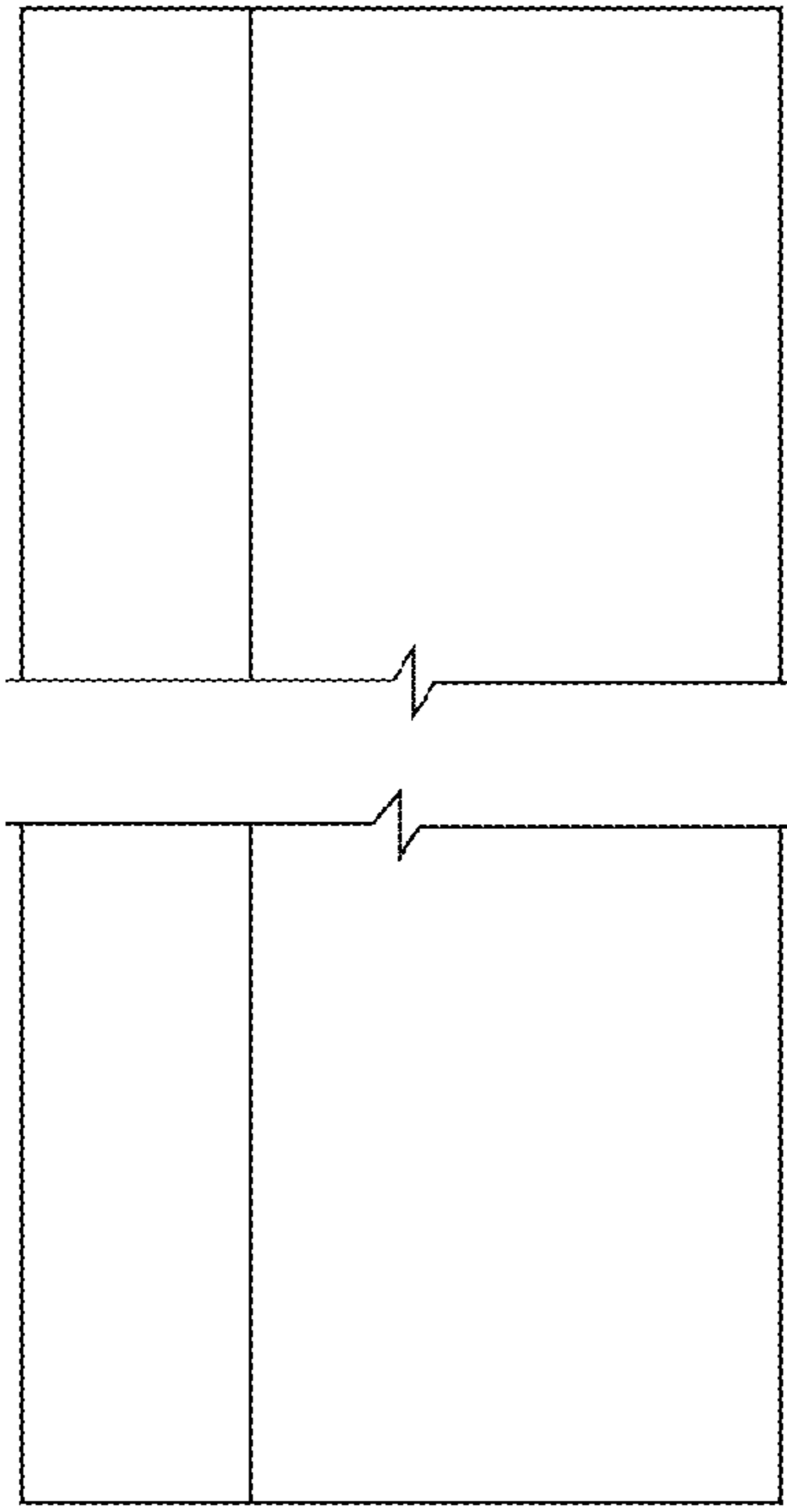

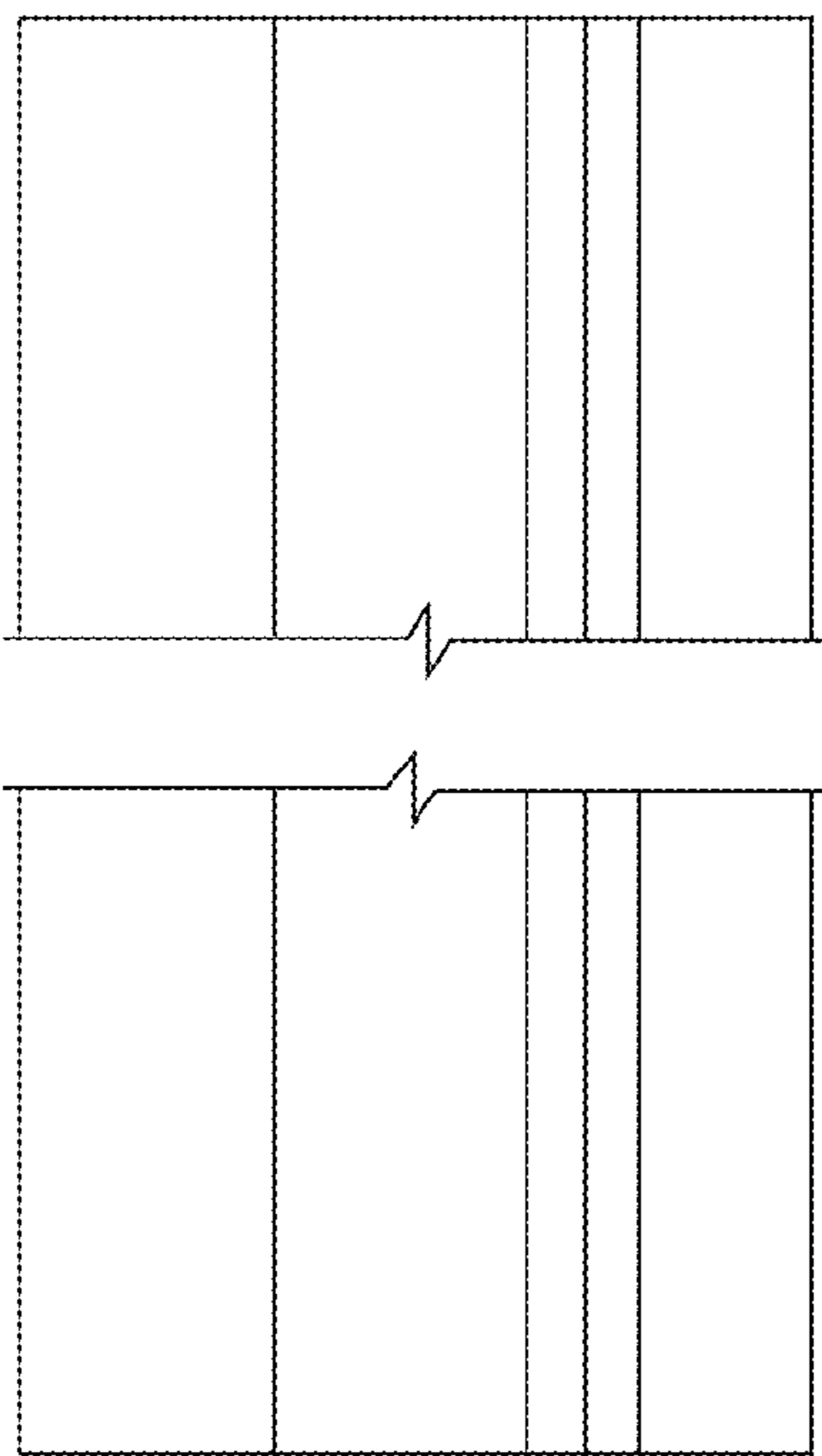

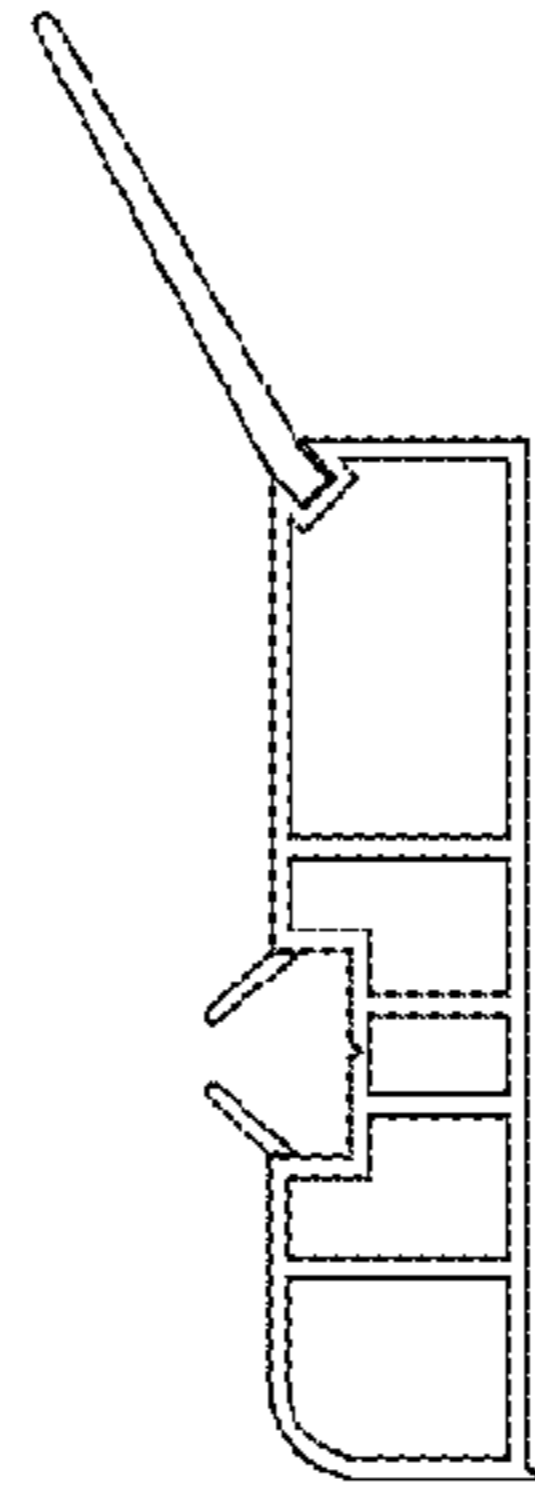

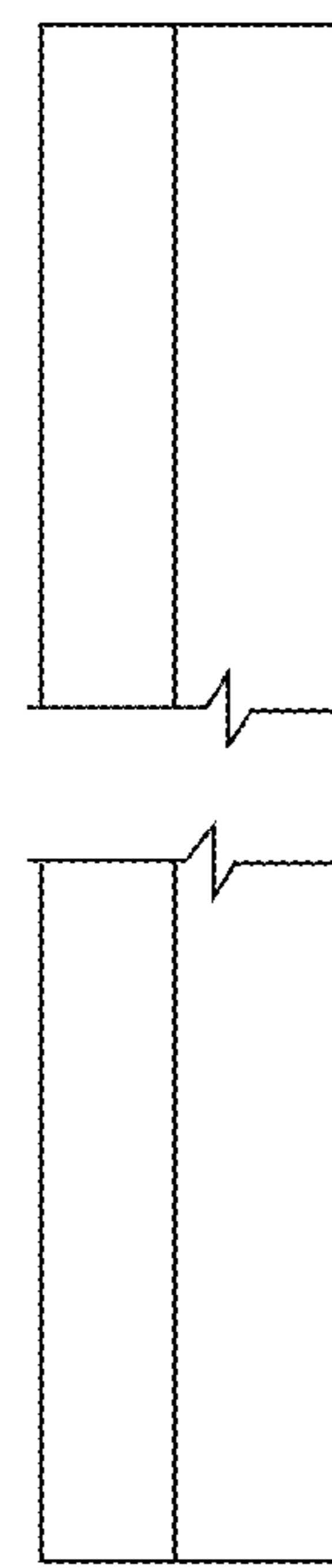

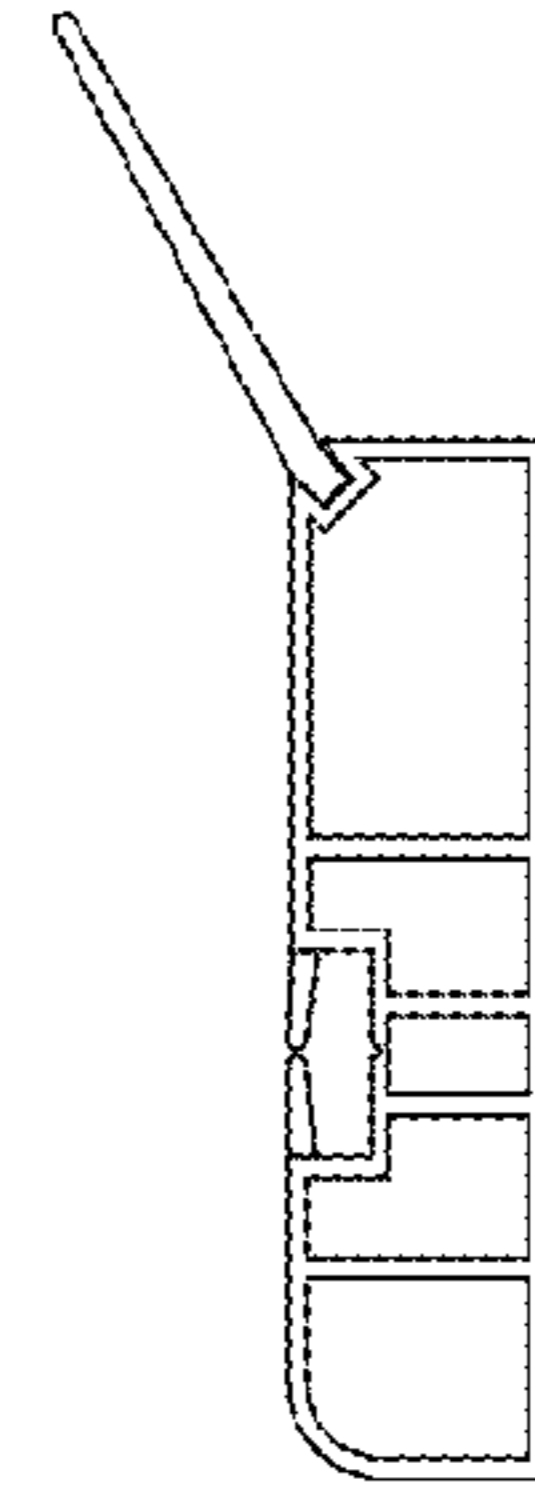

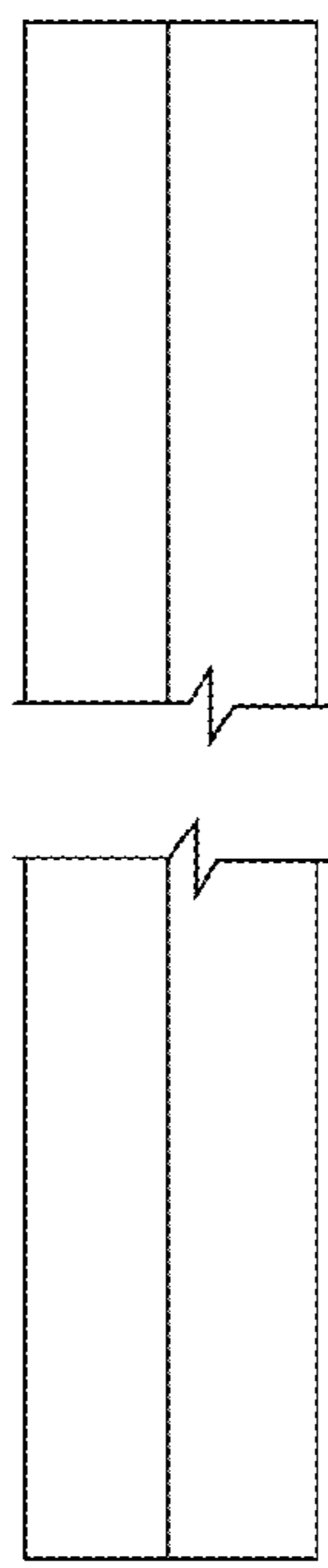
