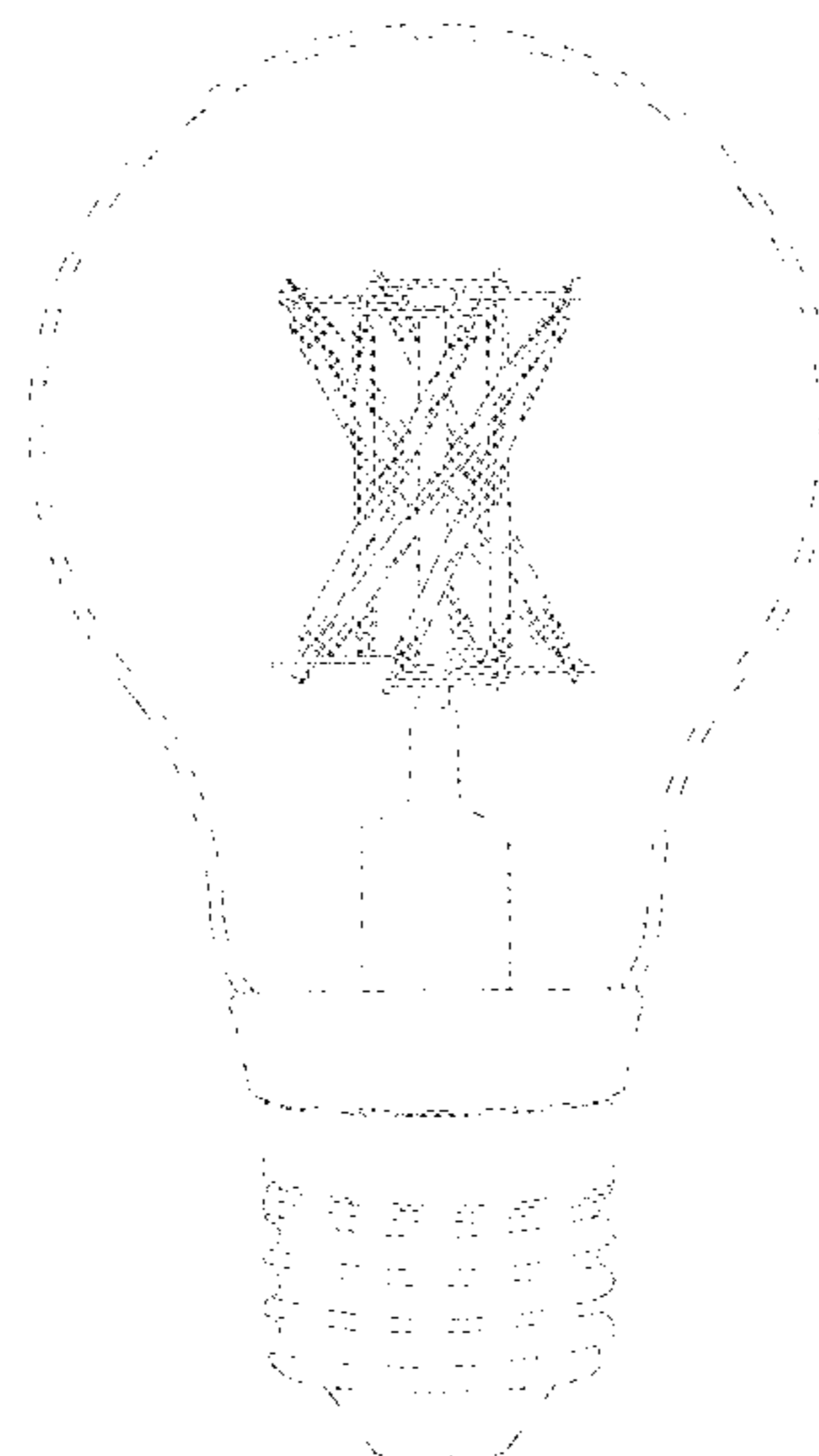
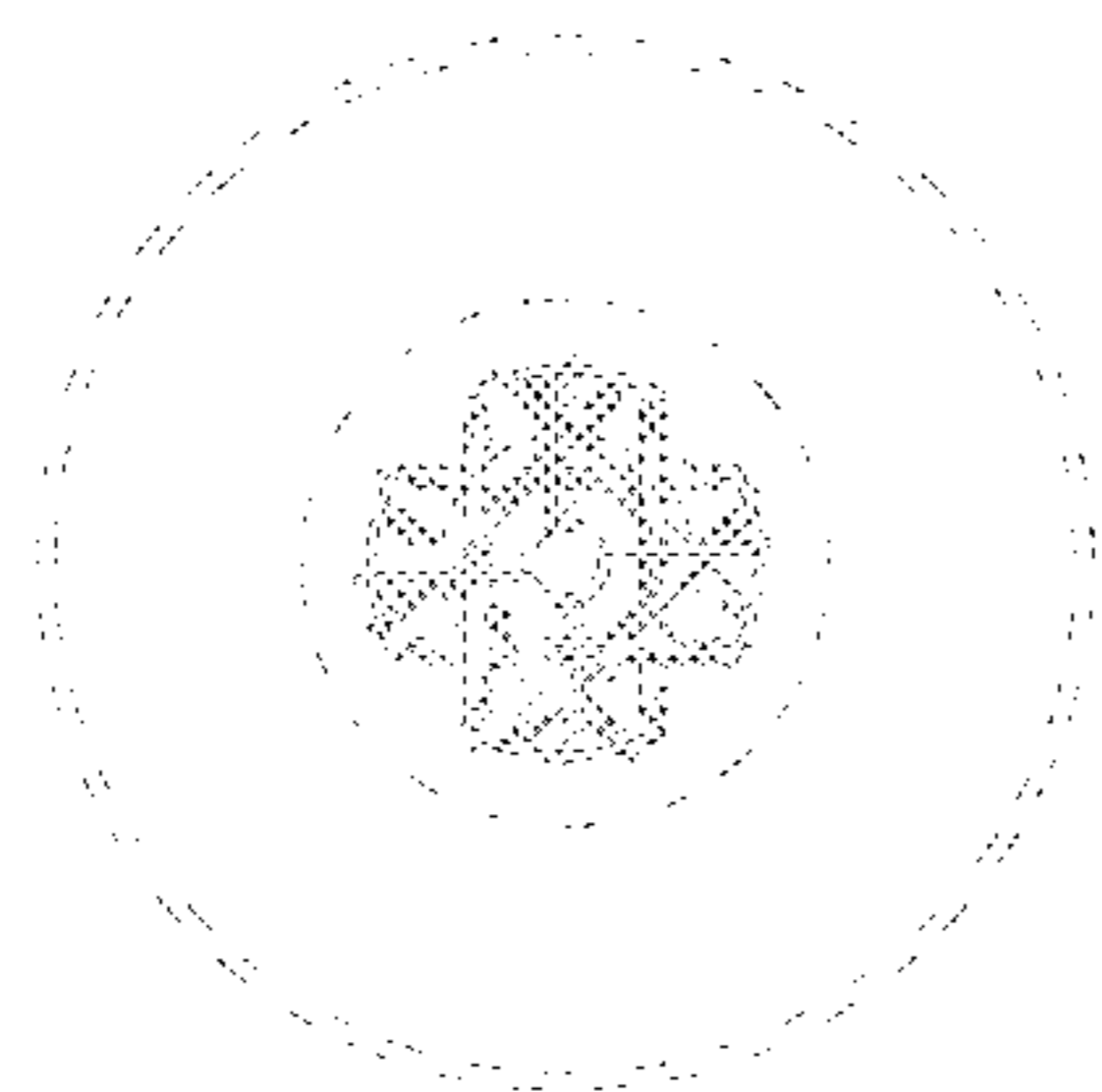
(57) **CLAIM**

The ornamental design for a LED bulb, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the LED bulb, the rear view being identical to the front view;

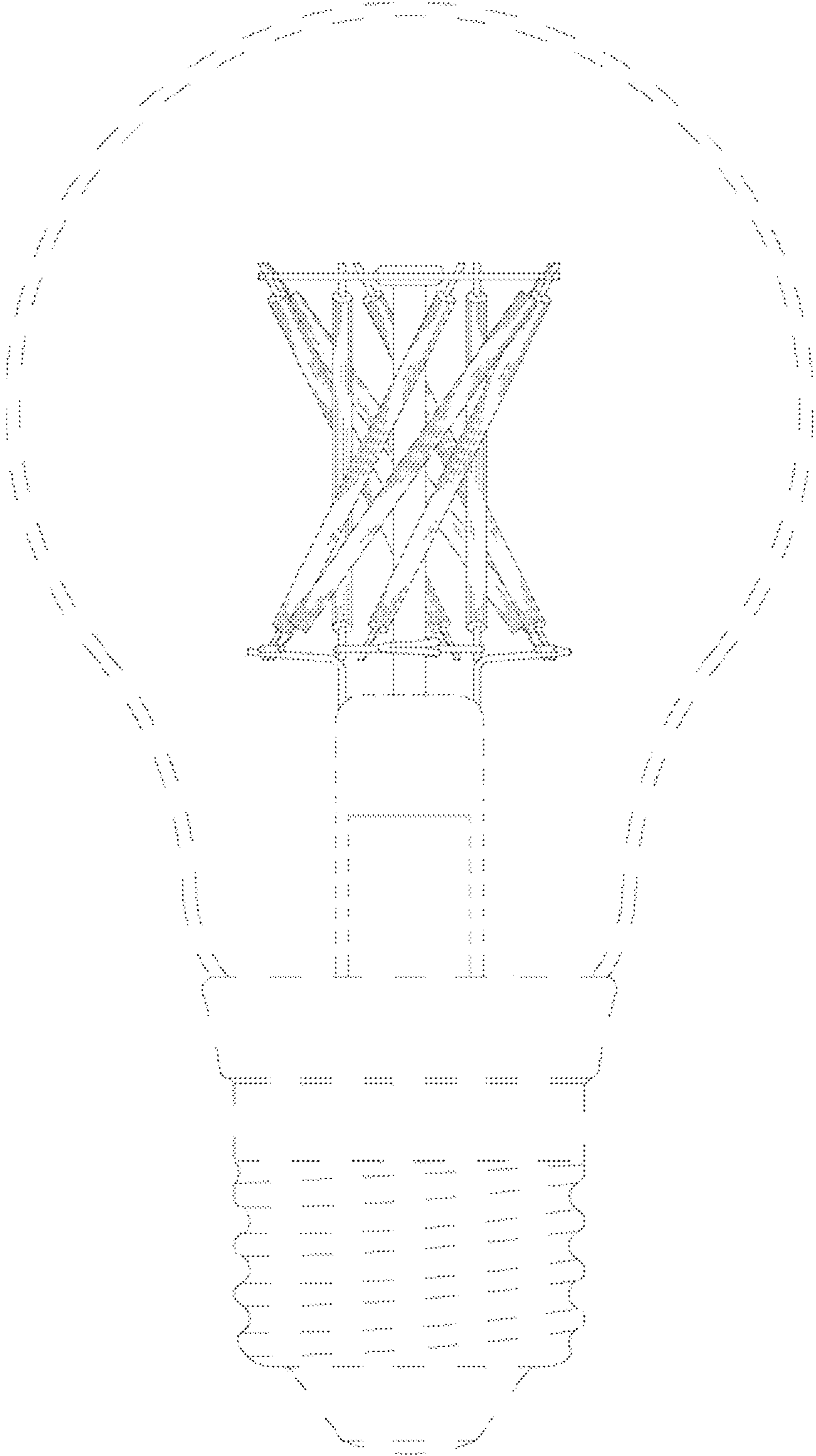

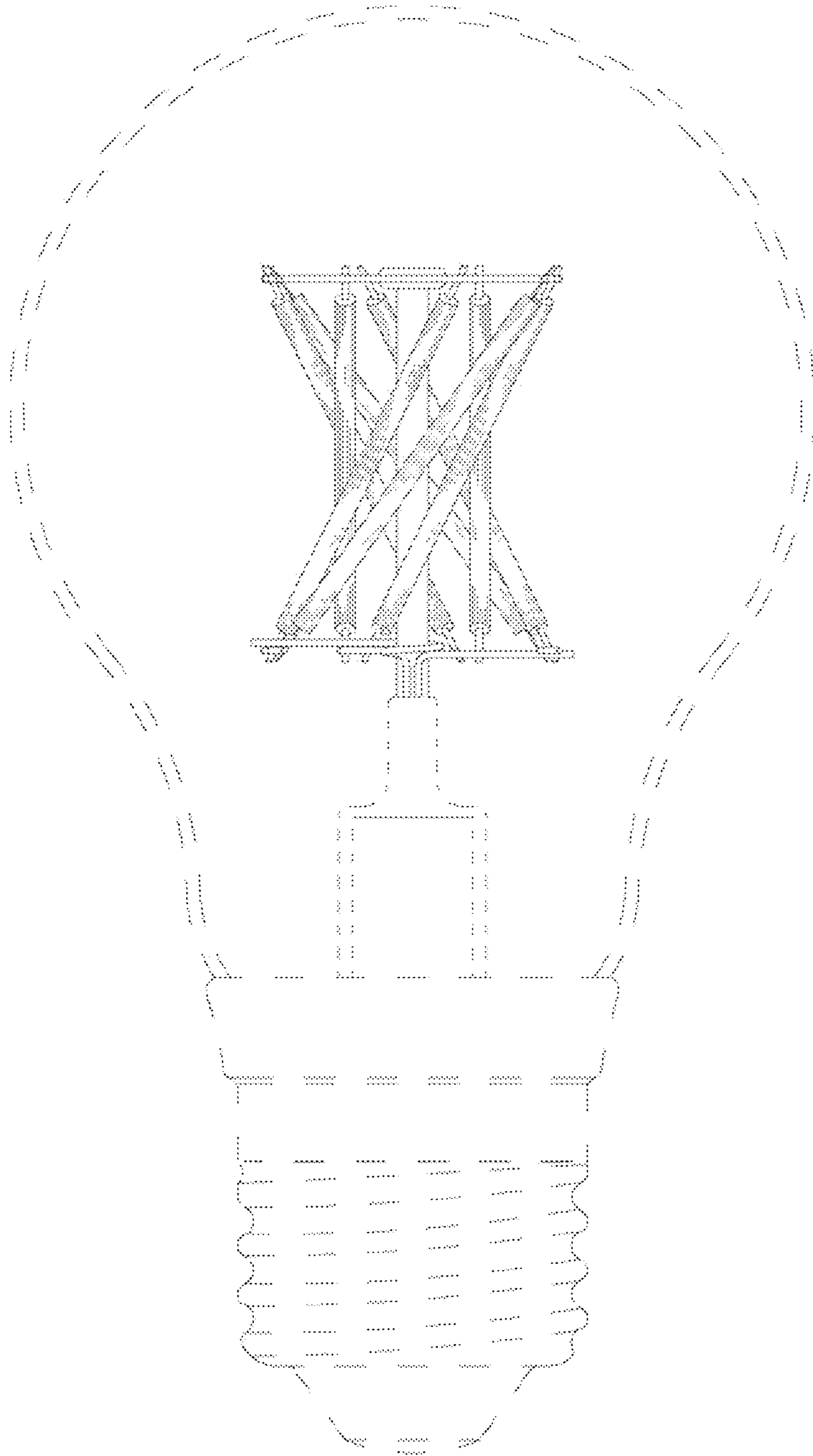

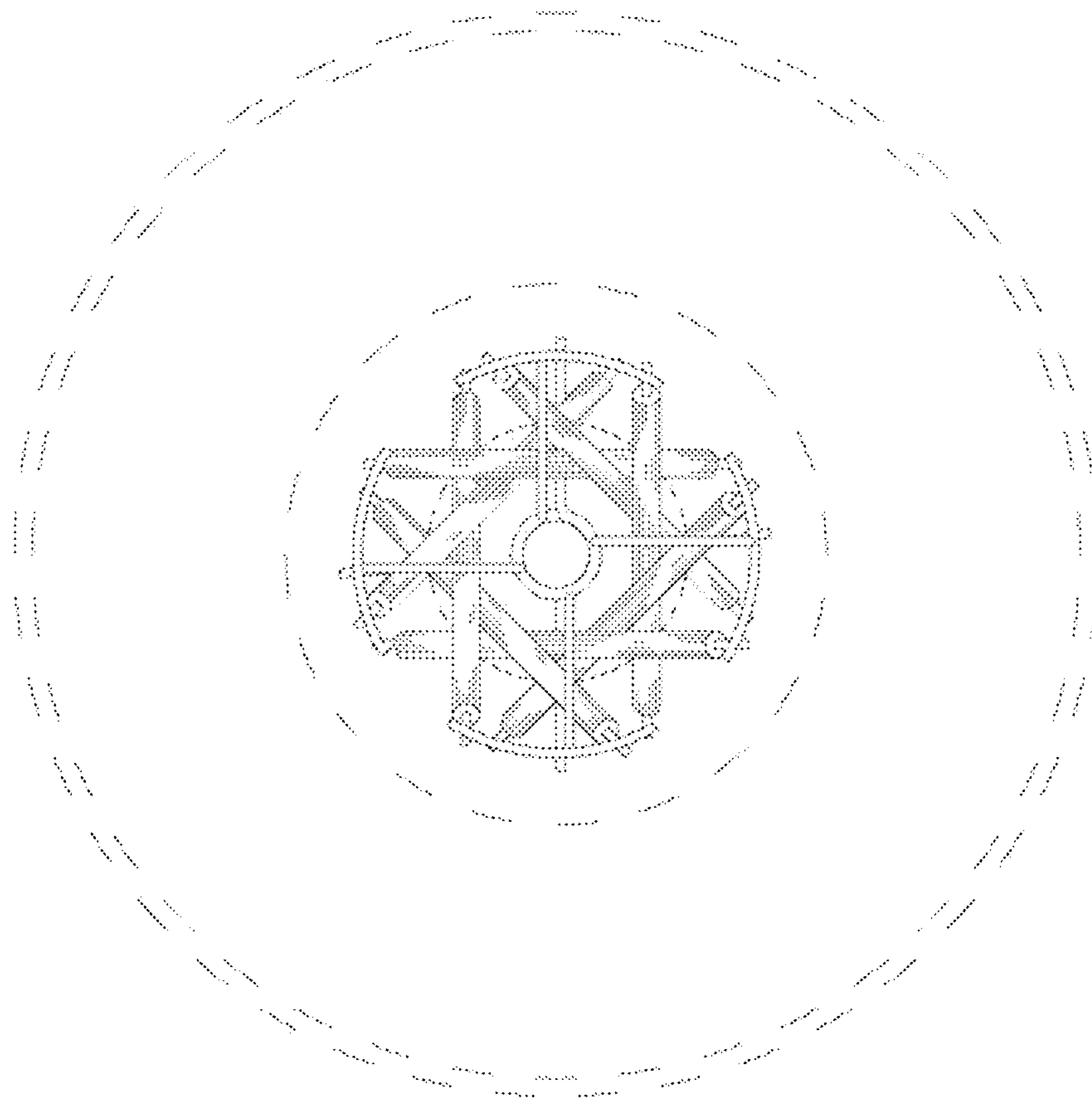

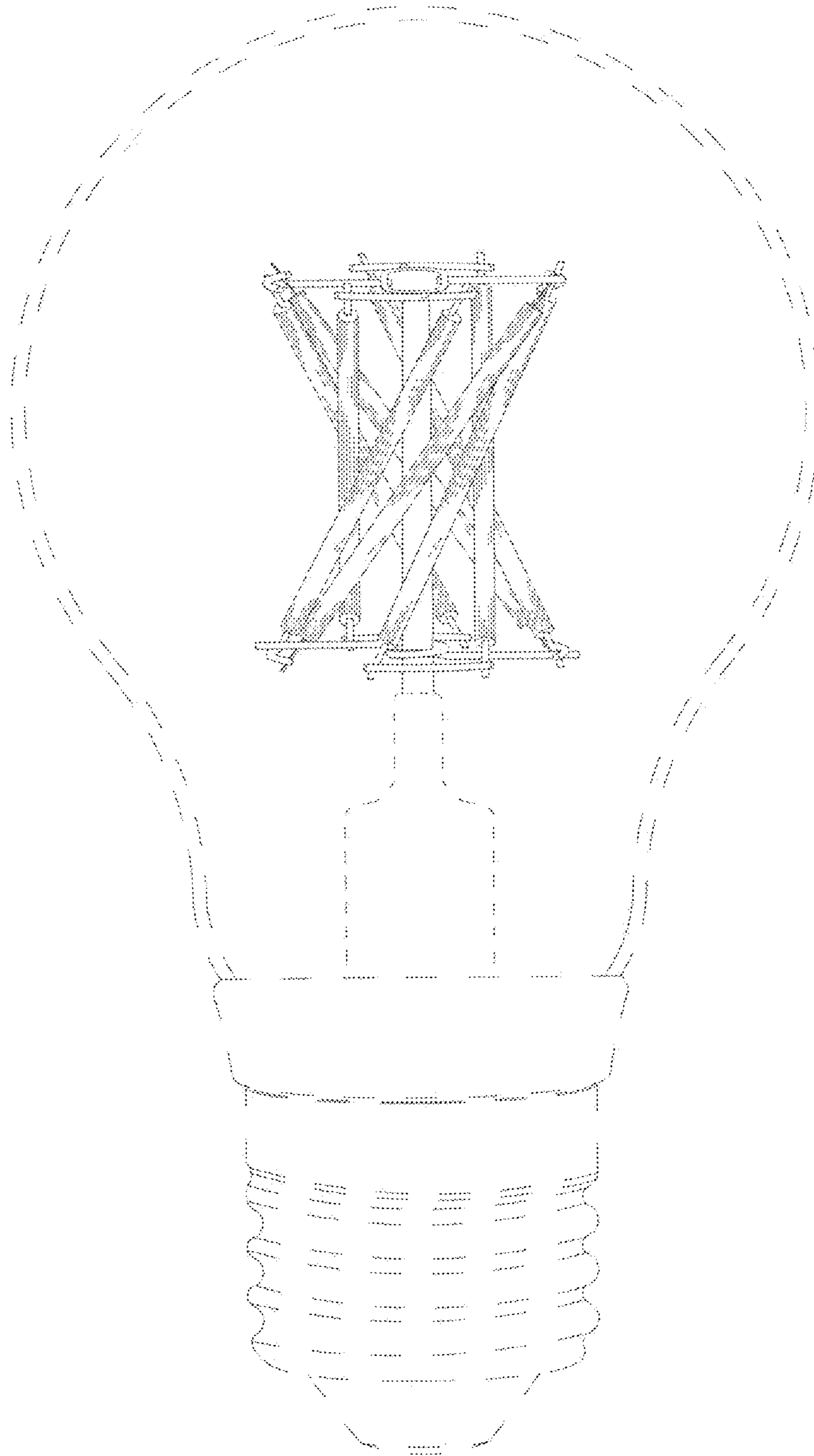
