We claim the ornamental design for a shaped food product, as shown and described.

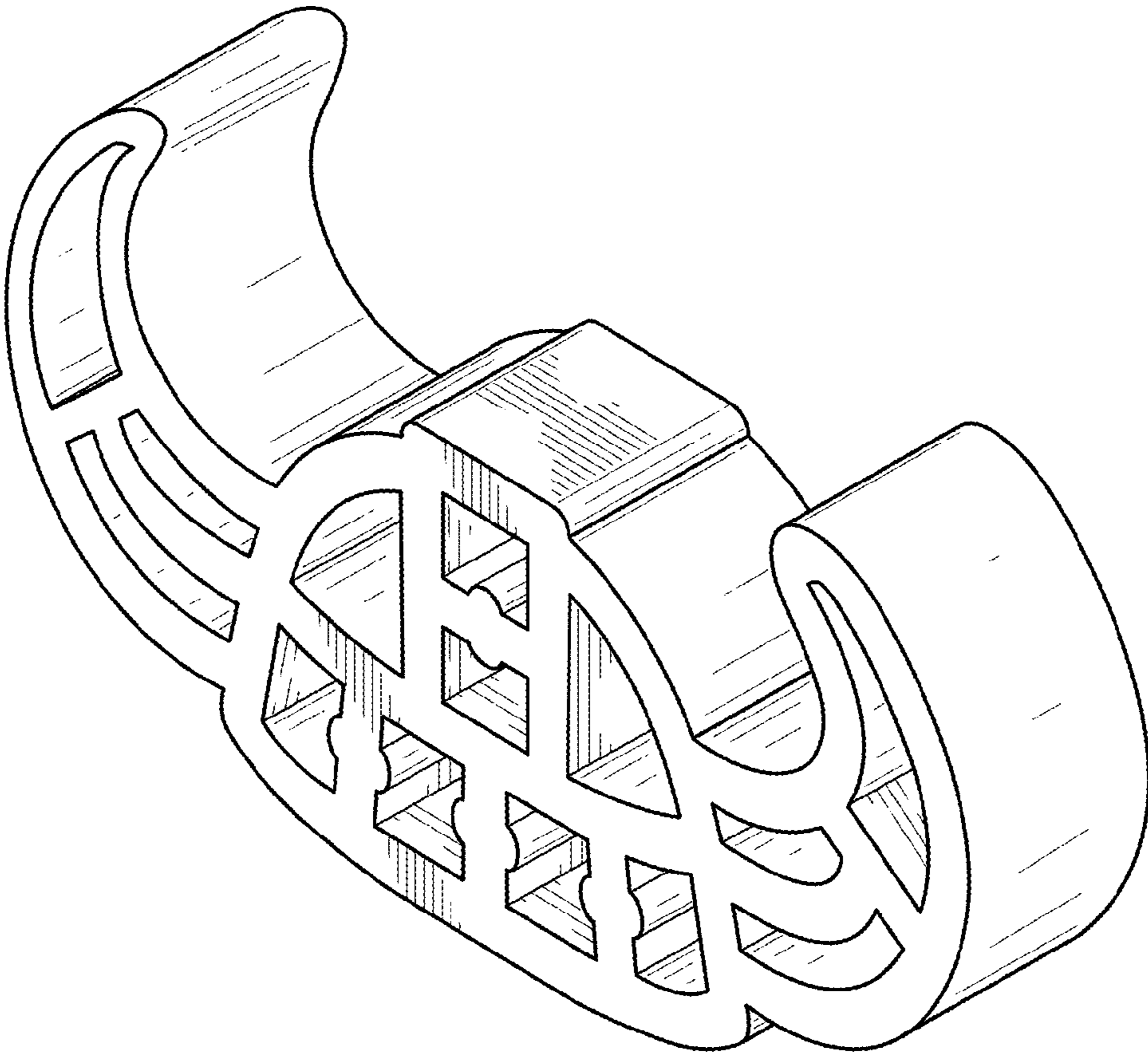

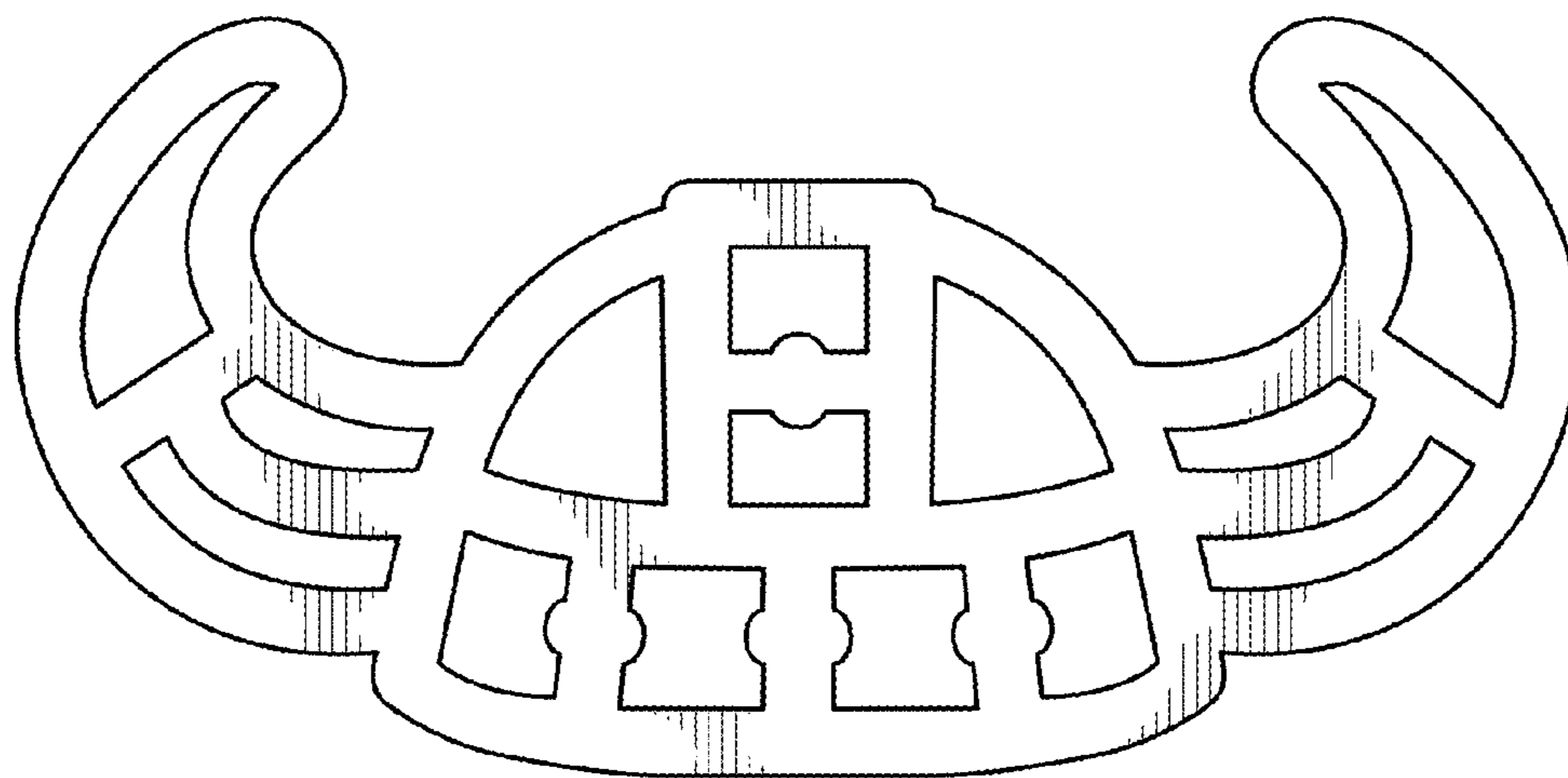

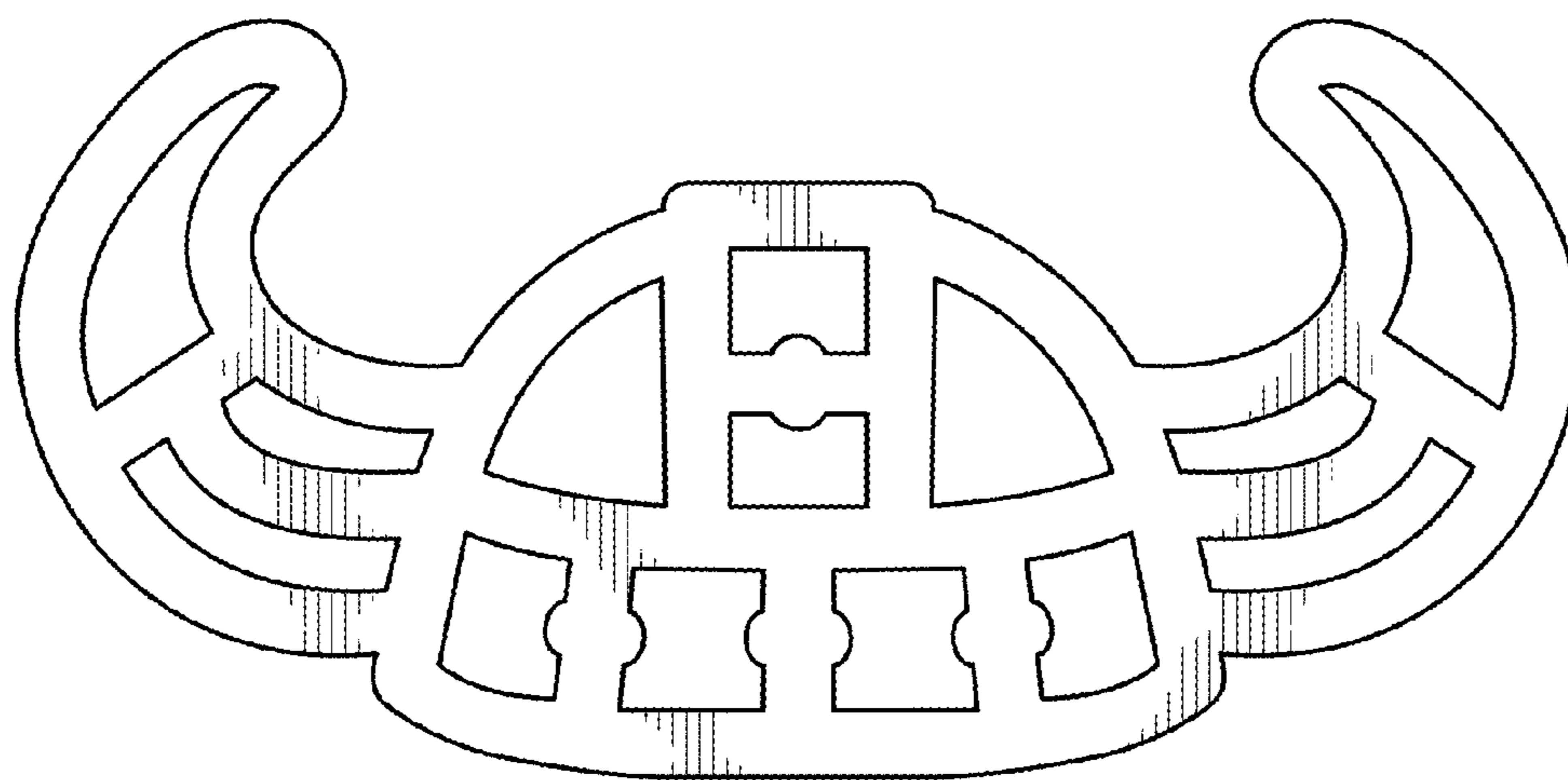
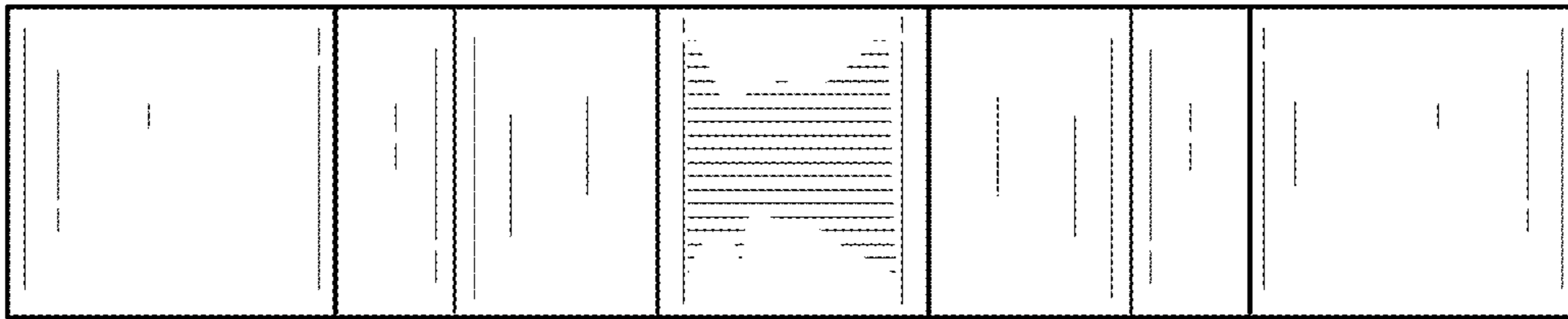
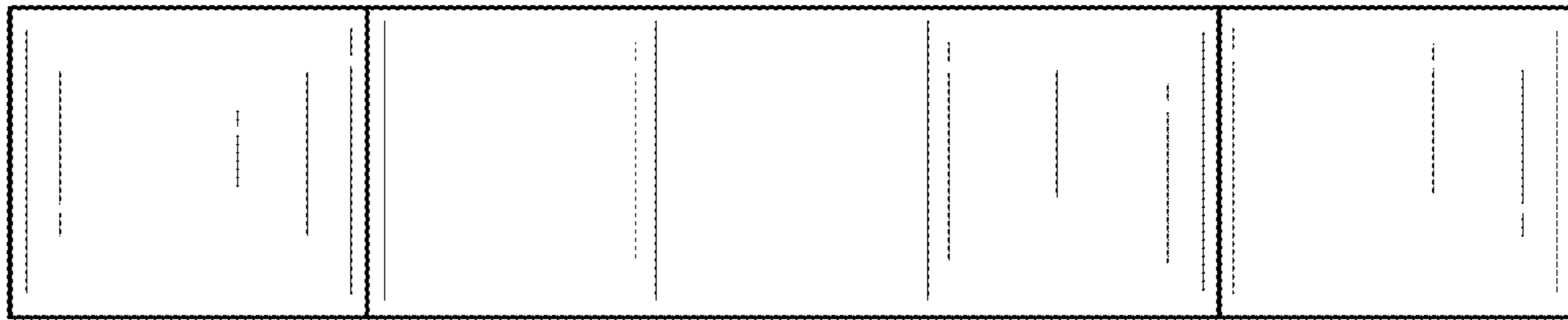


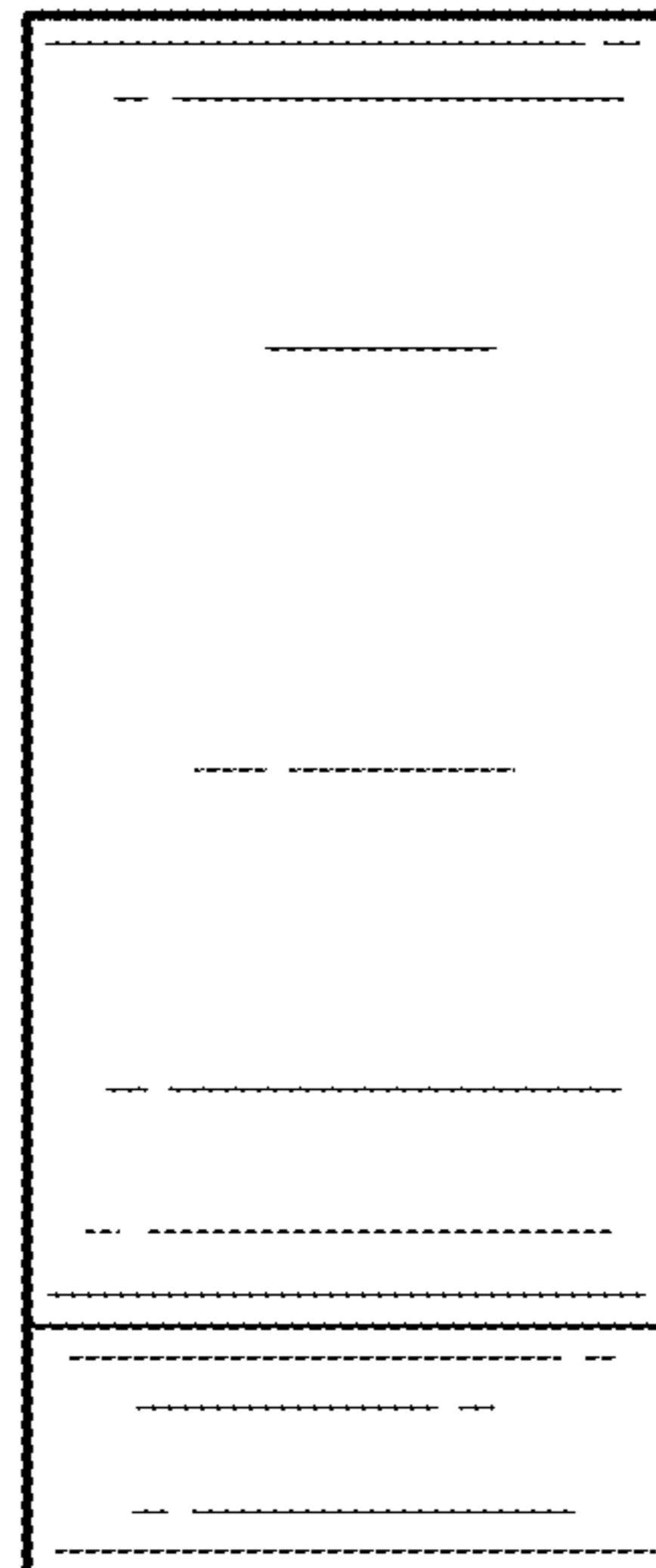

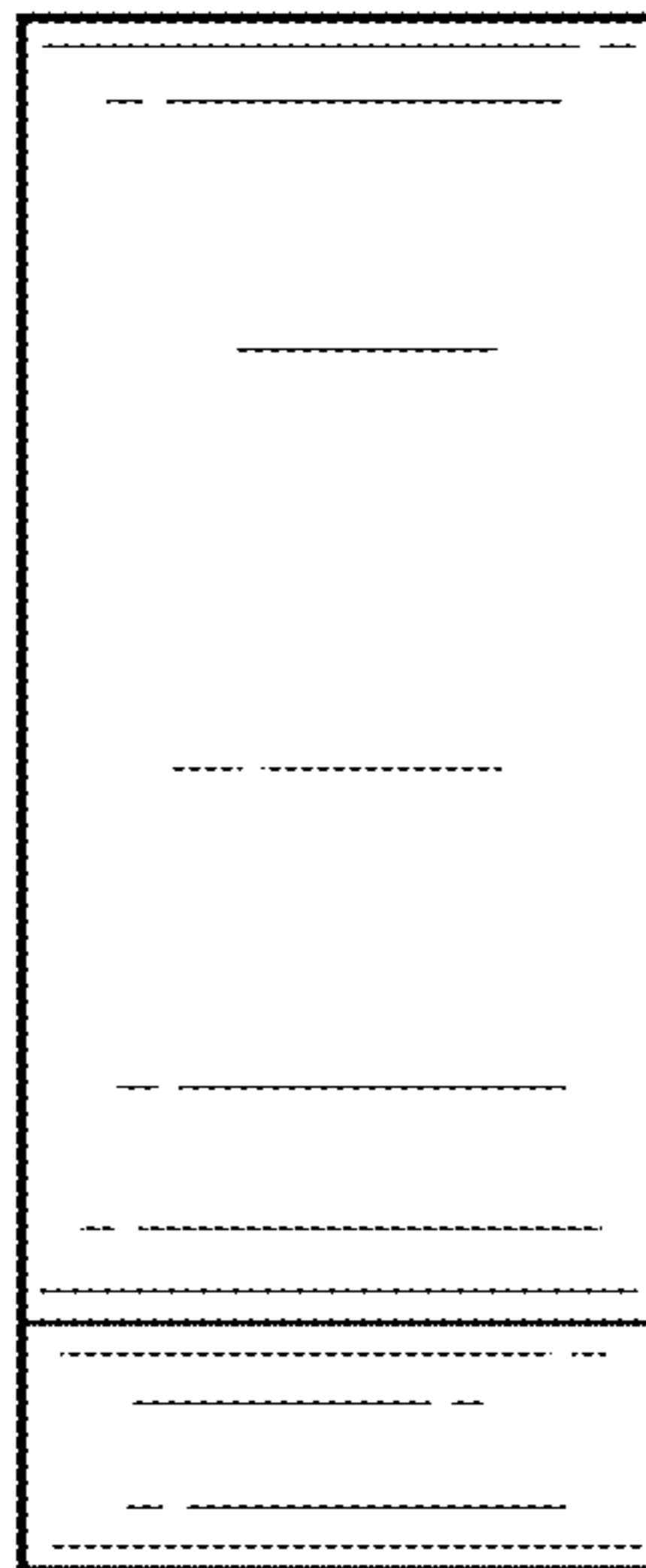

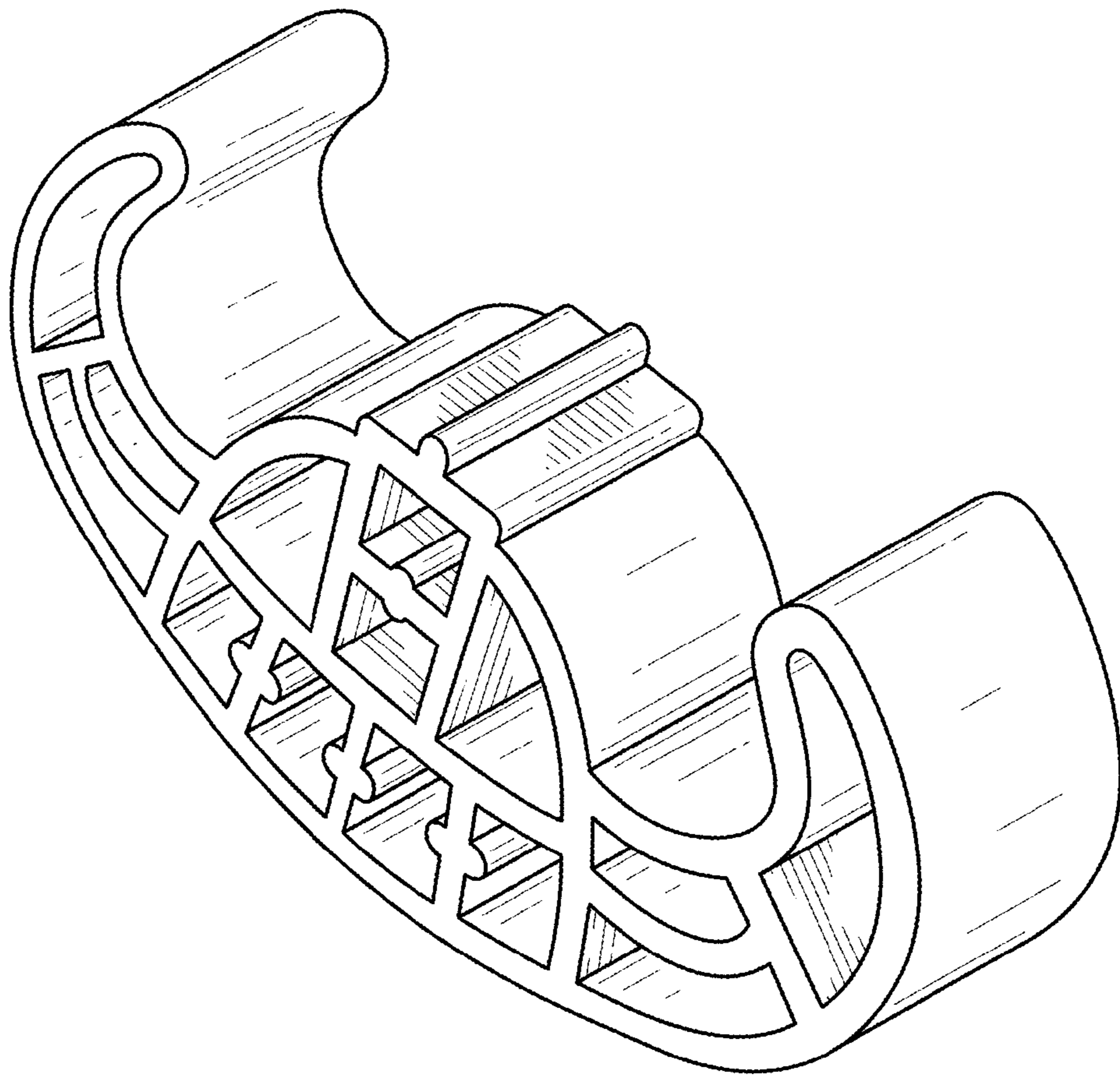

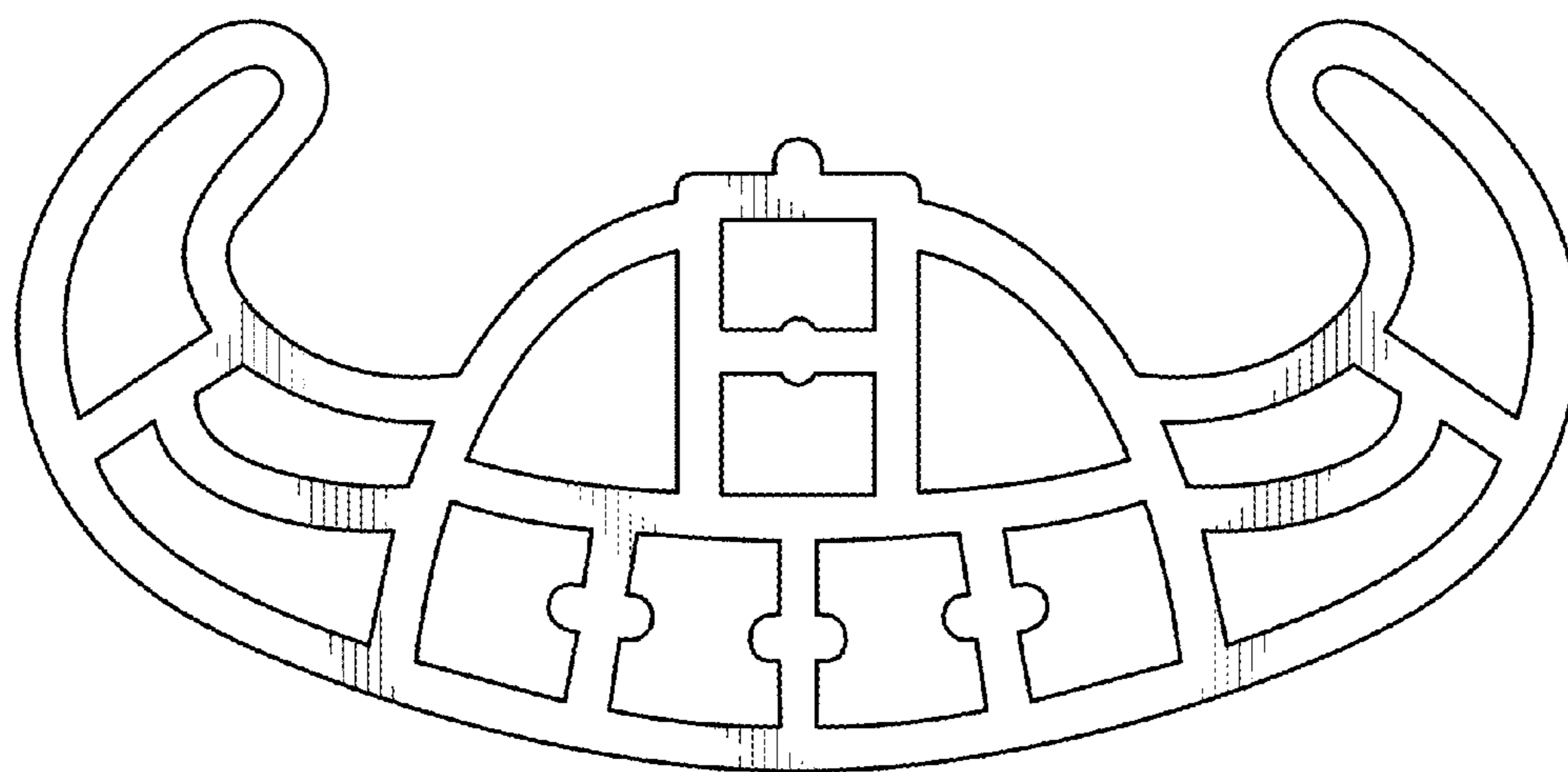

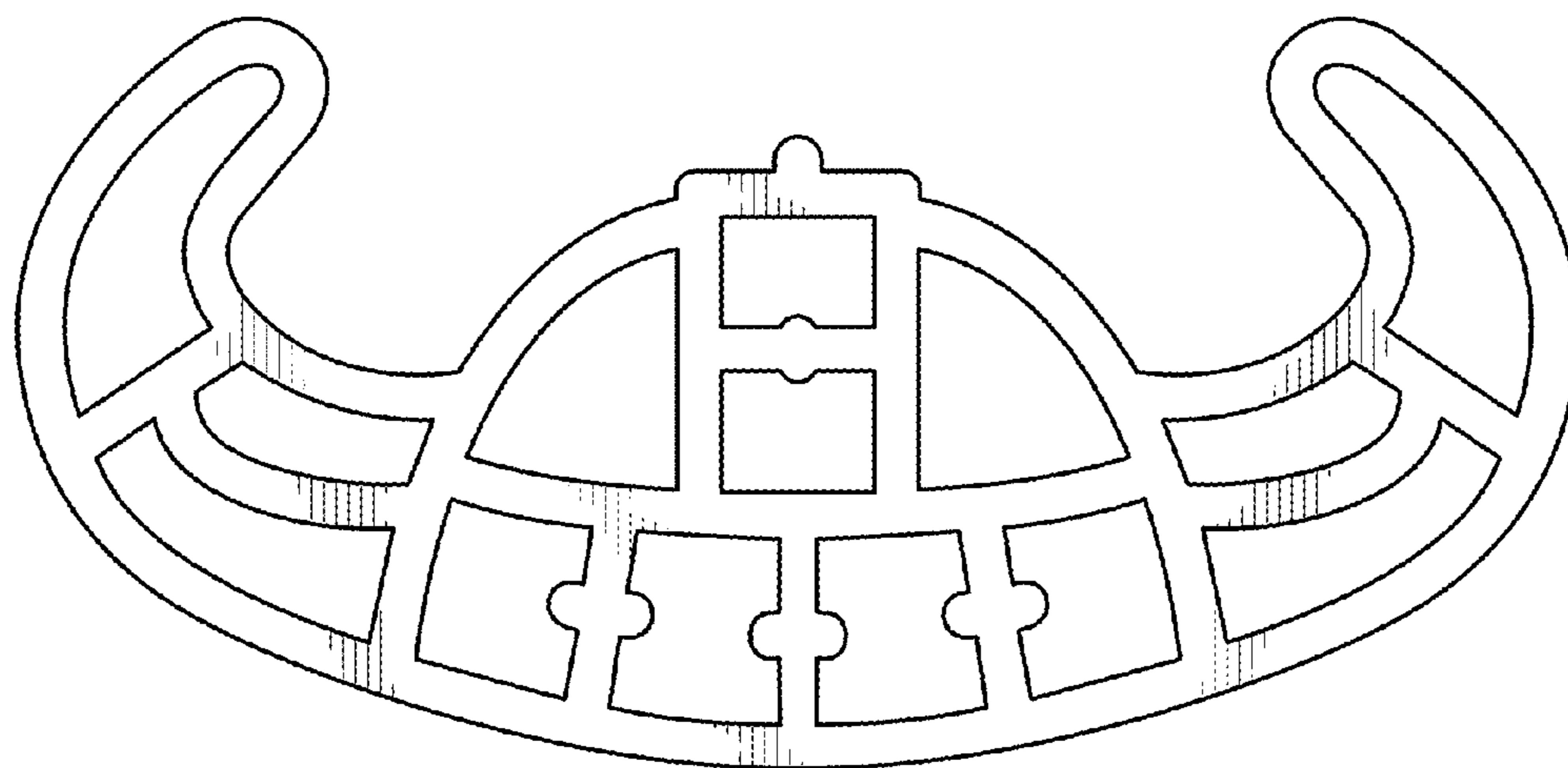
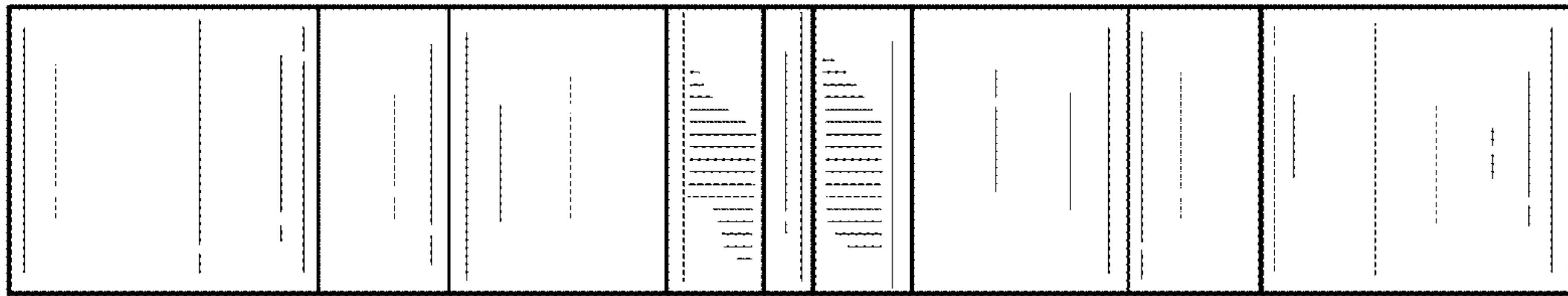


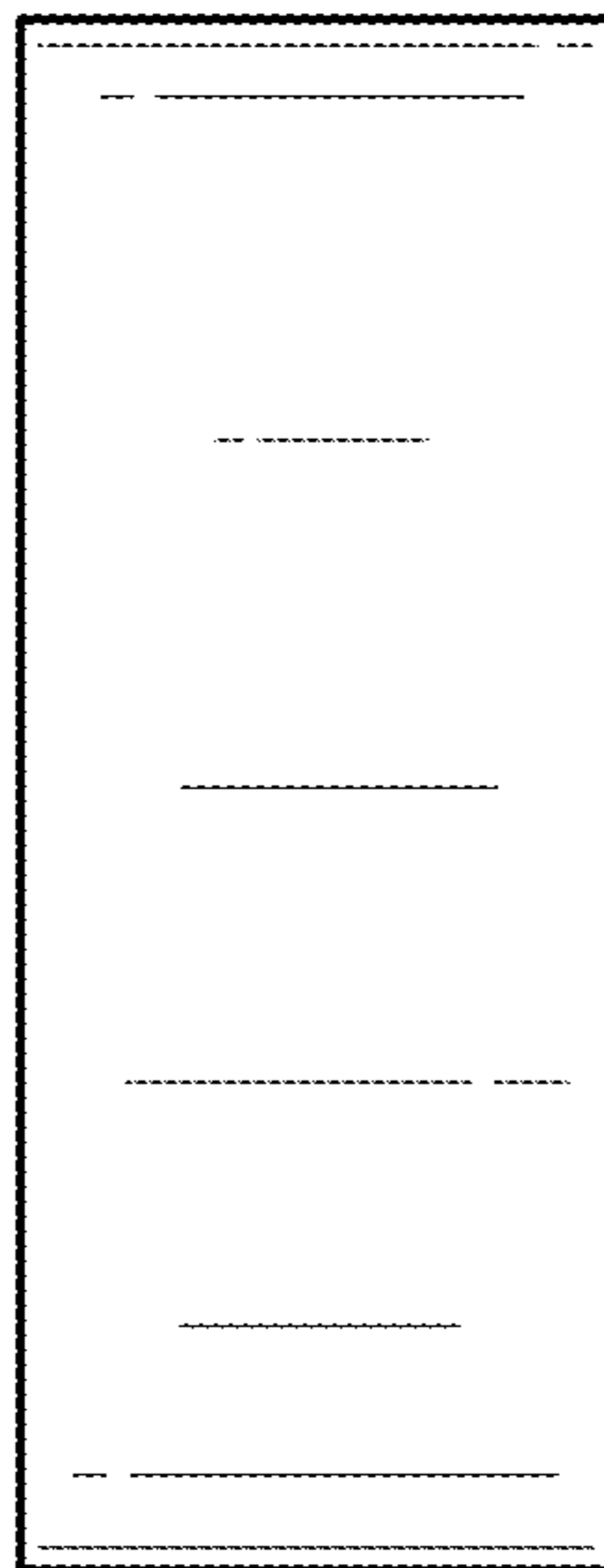

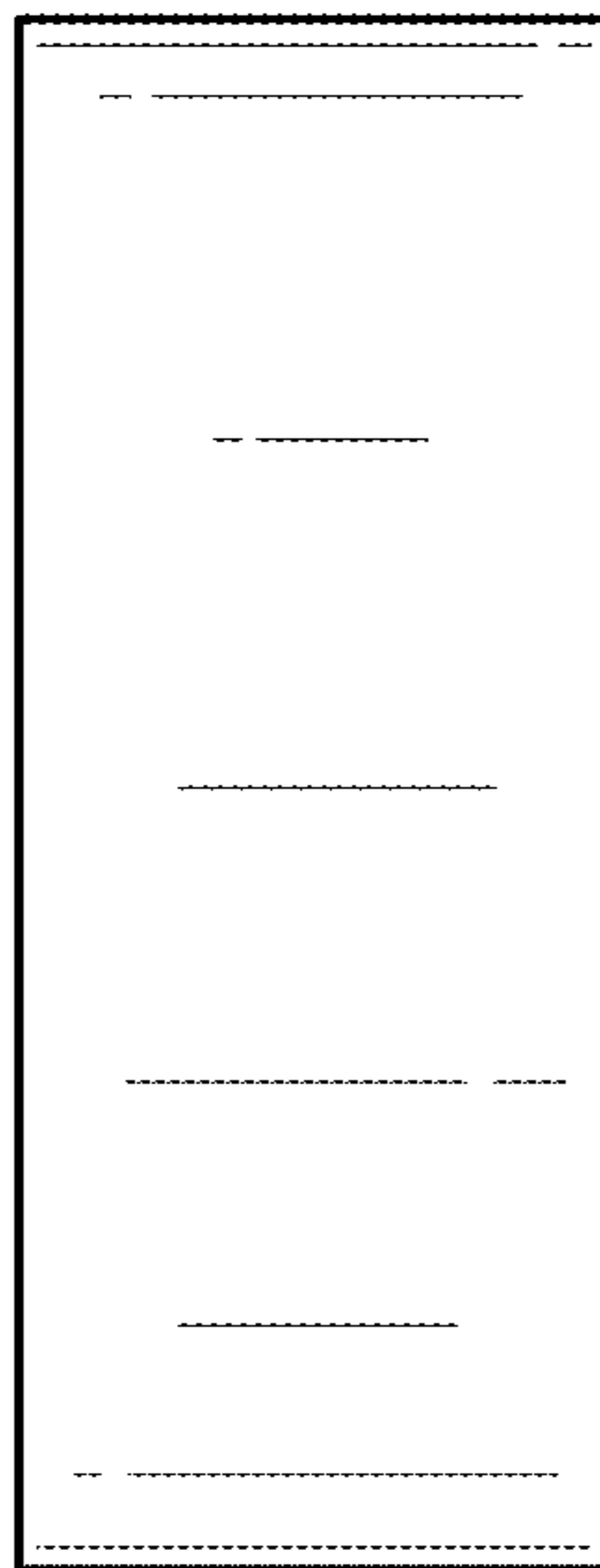
