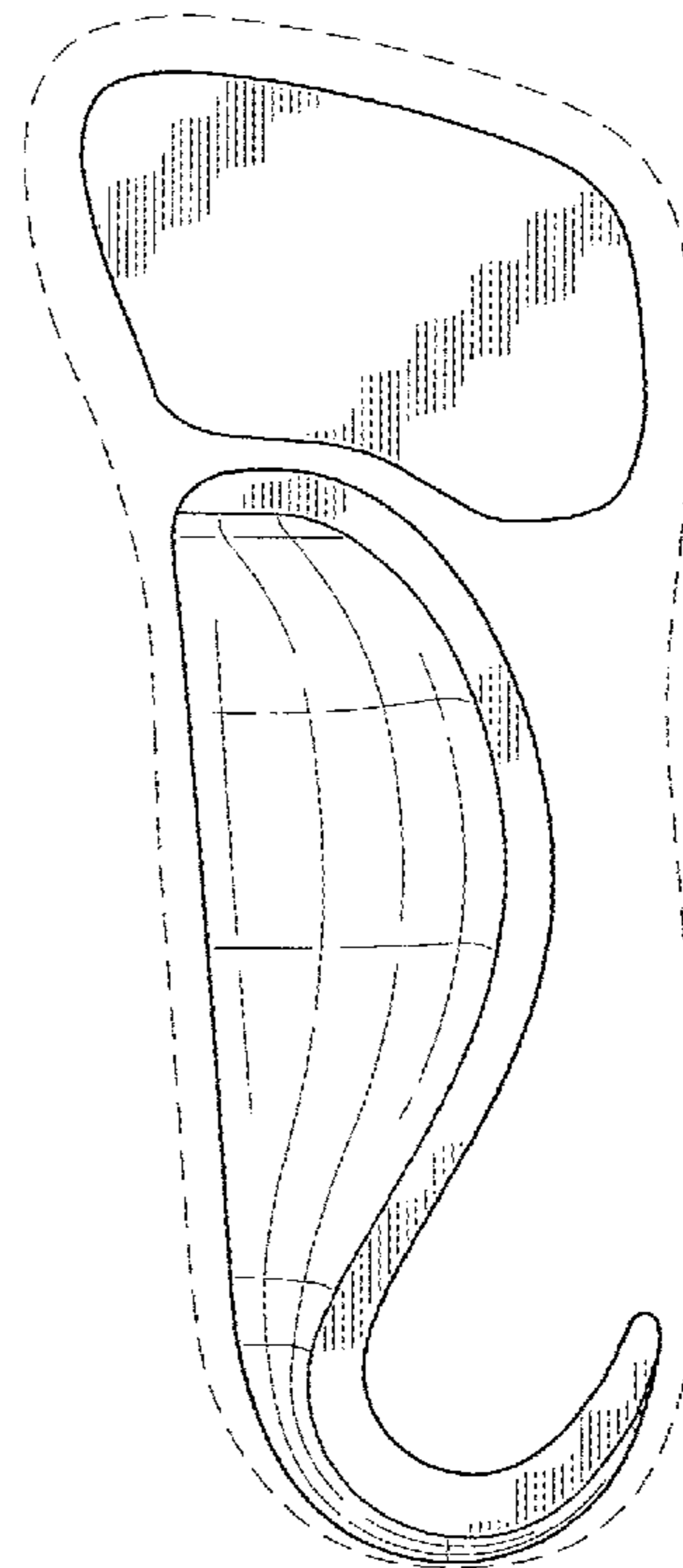
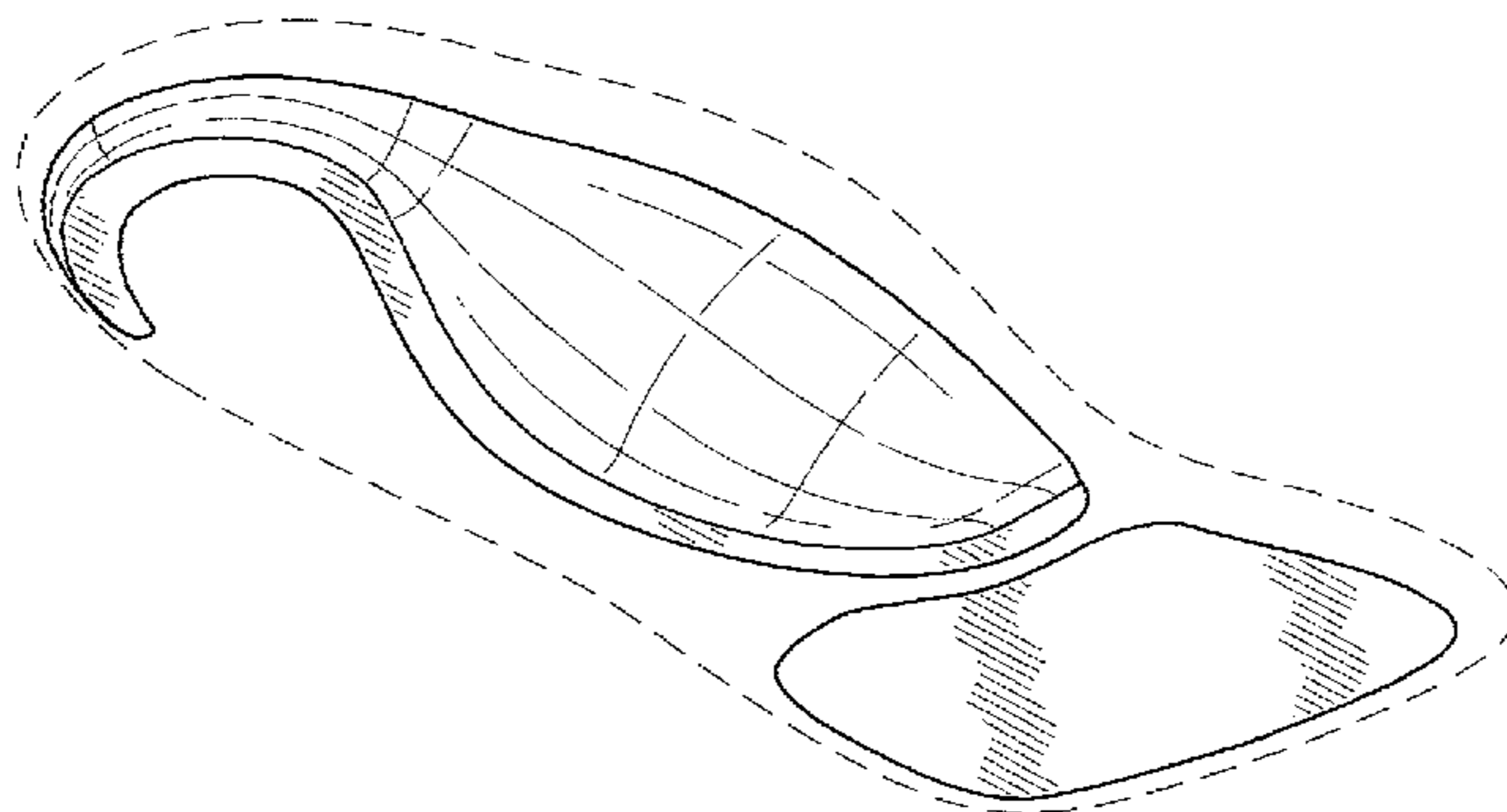
(57) **CLAIM**

The ornamental design for an insole, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, right side perspective view of an insole for the left shoe showing our new design; FIG. 2 is a bottom, front, right side perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a left side elevational view thereof; FIG. 7 is a front elevational view thereof; and, FIG. 8 is a rear elevational view thereof. The broken lines are not part of the claimed design. The right shoe insole is a mirror image of the views of the left shoe insole.

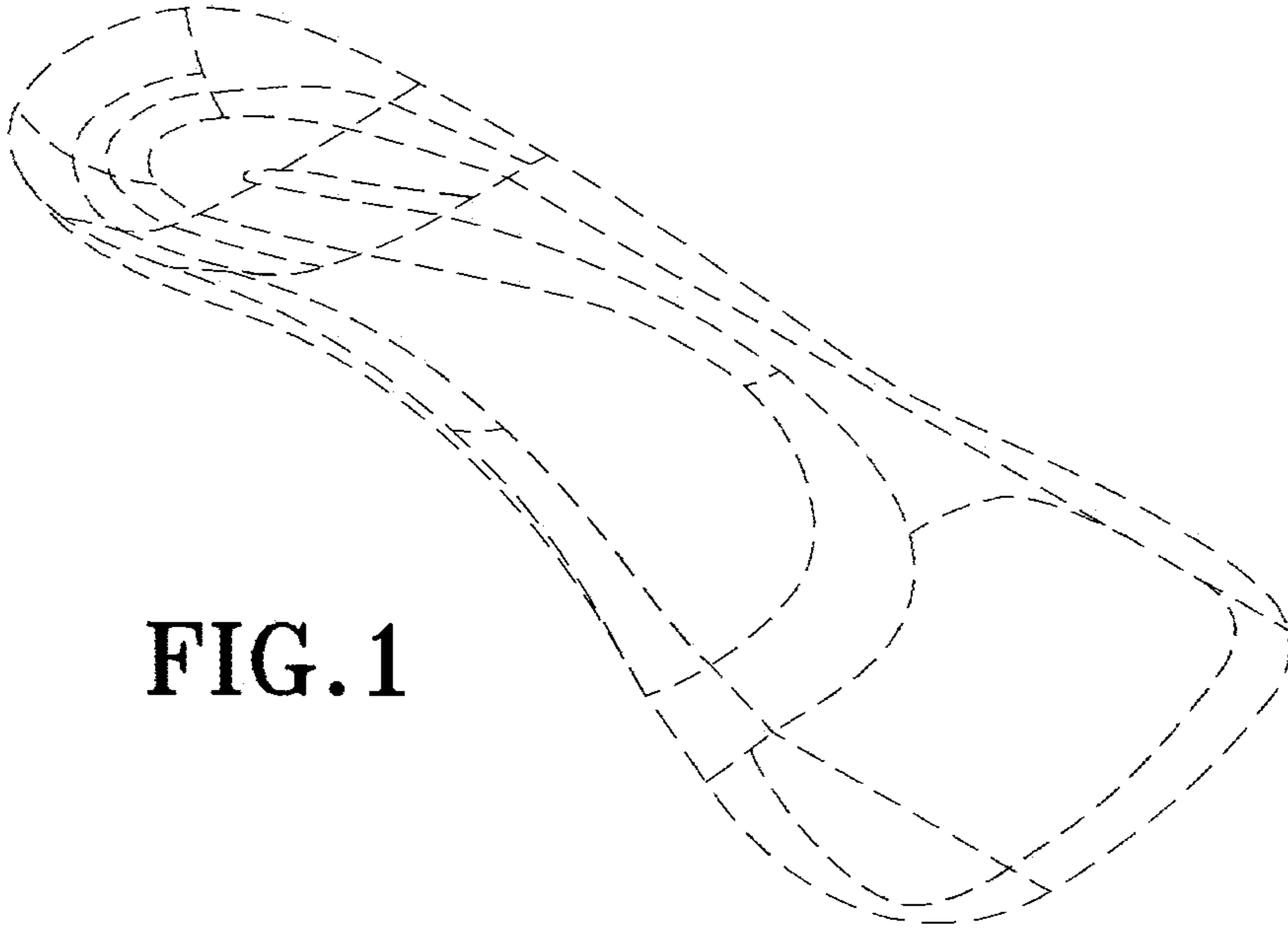

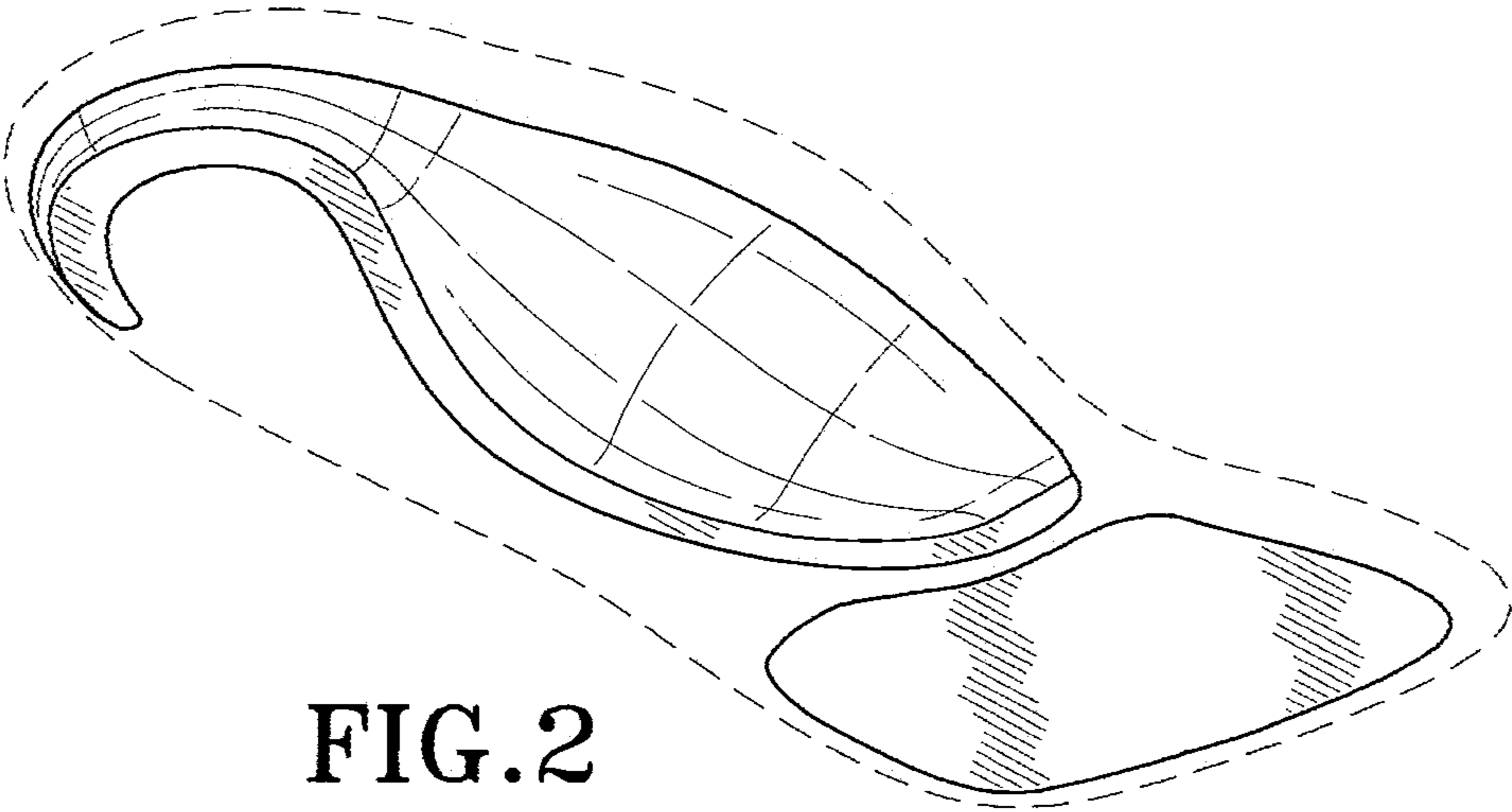

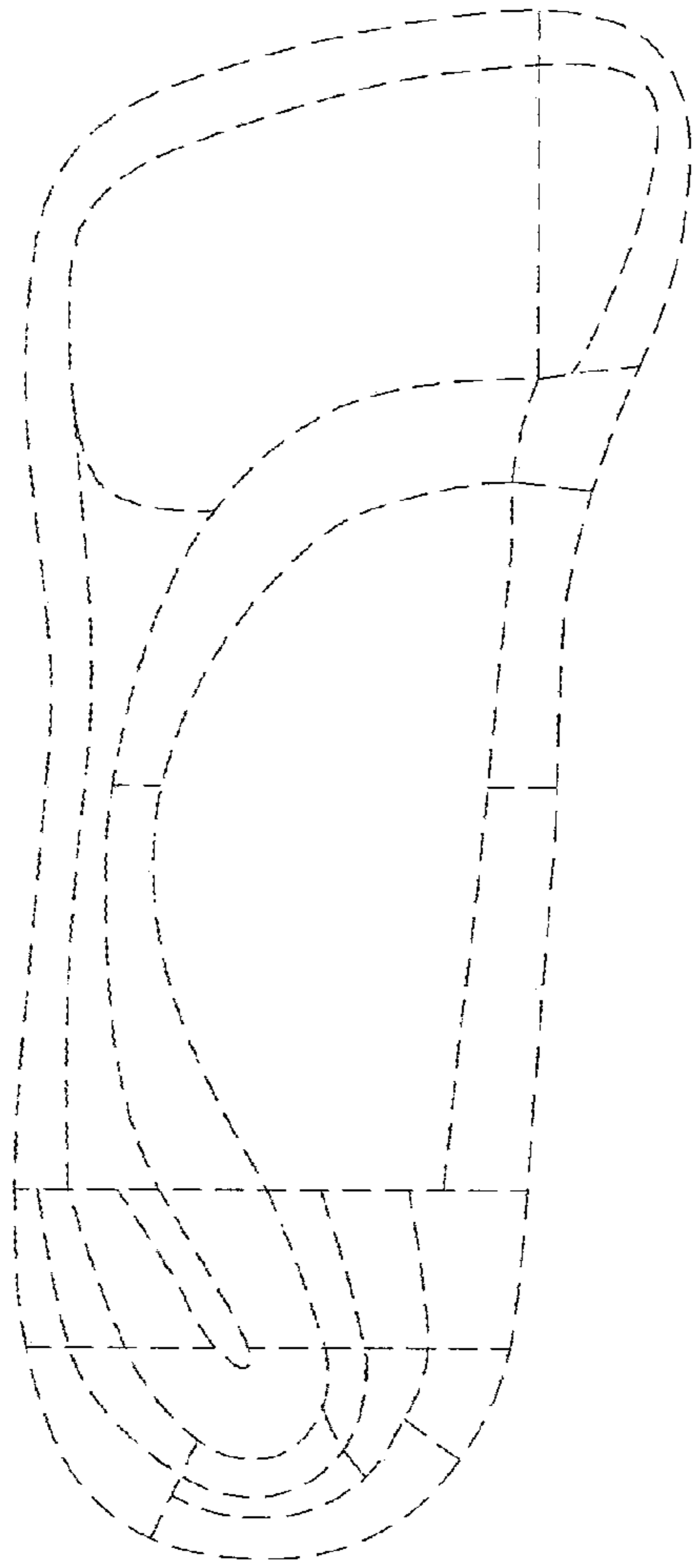

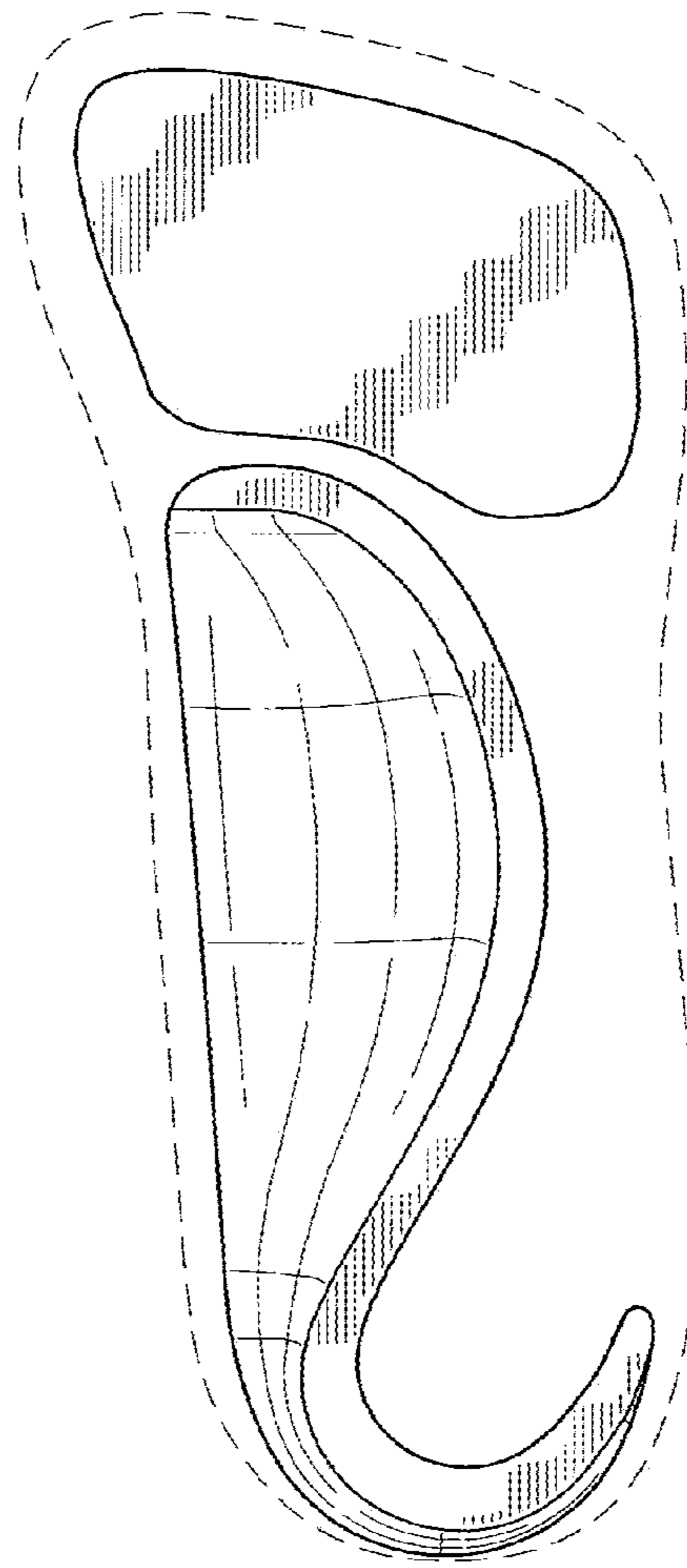

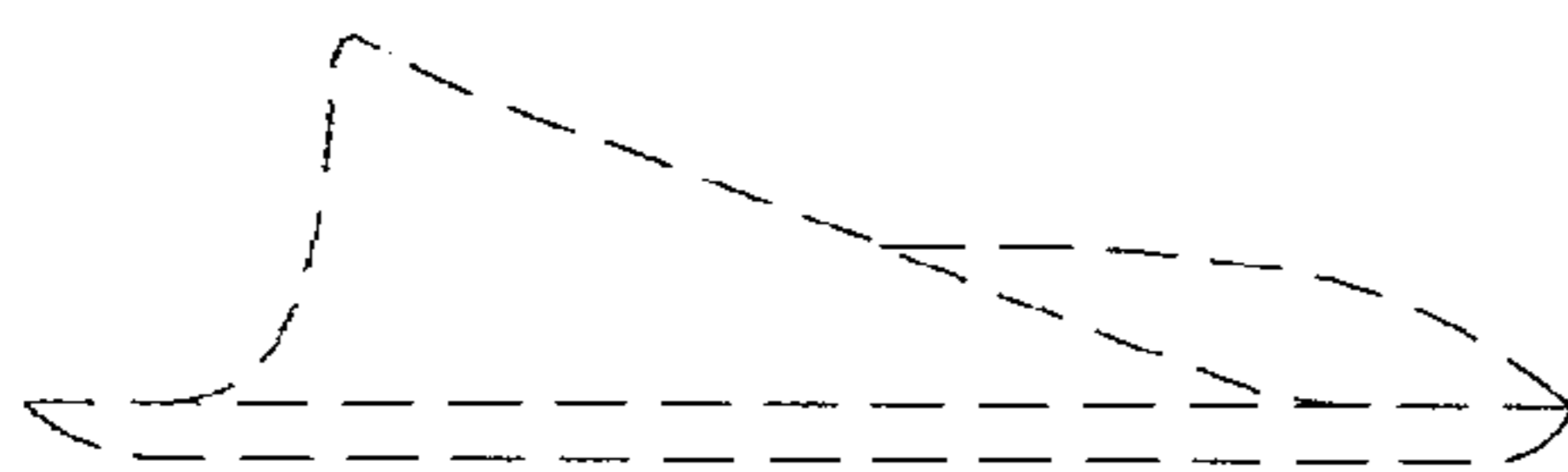

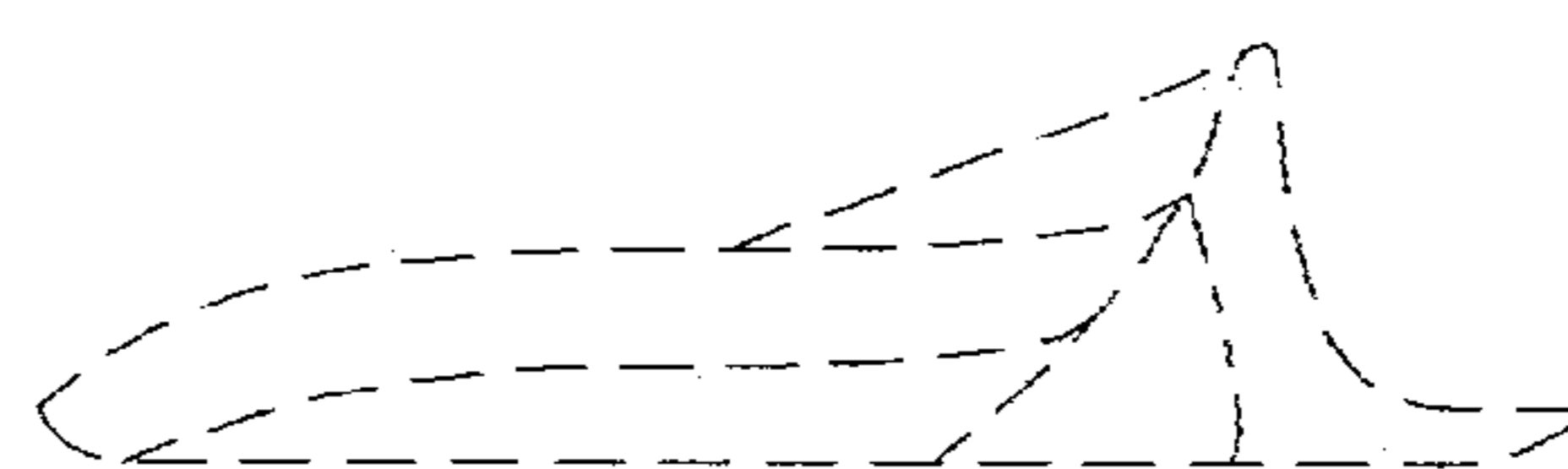
