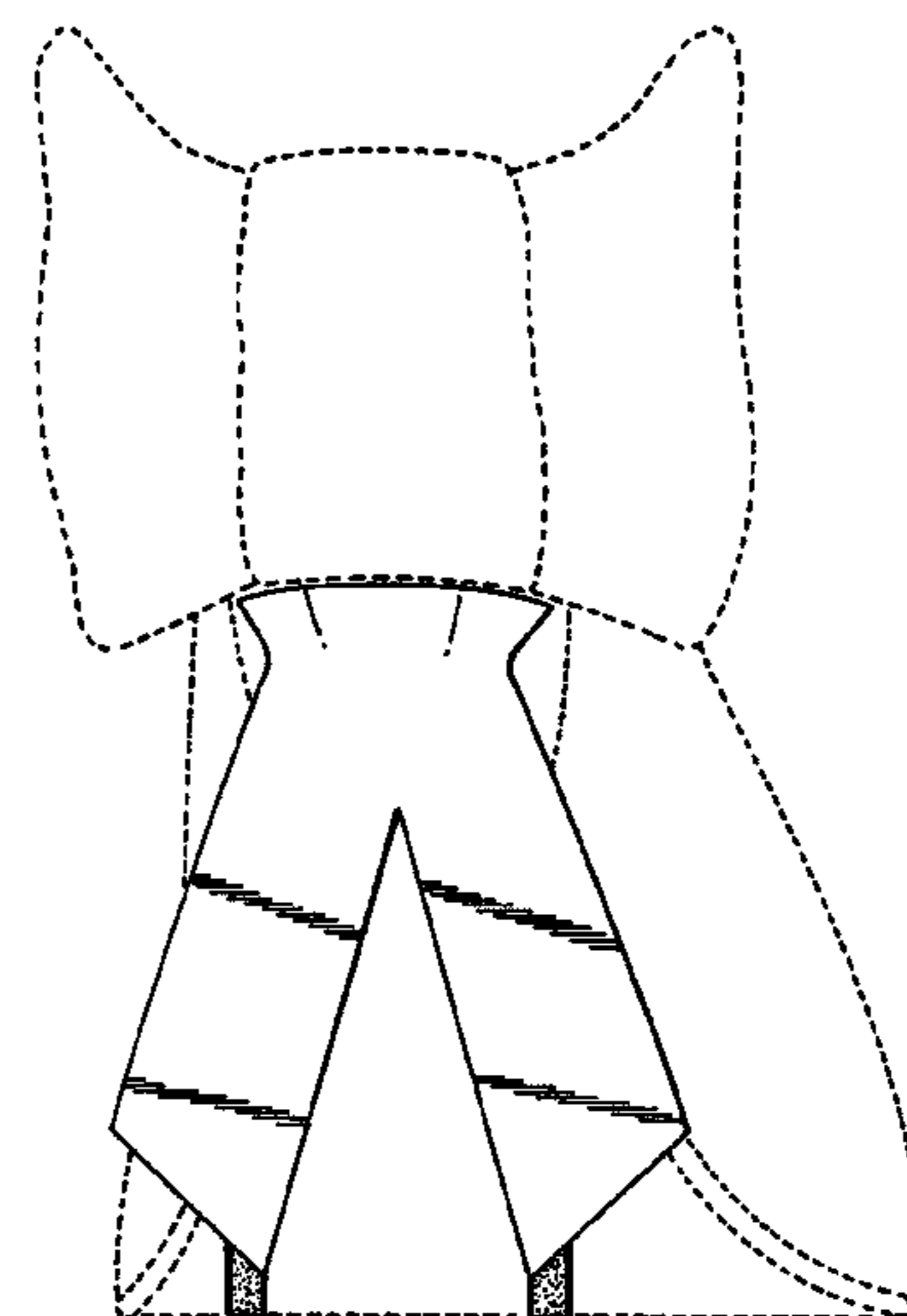
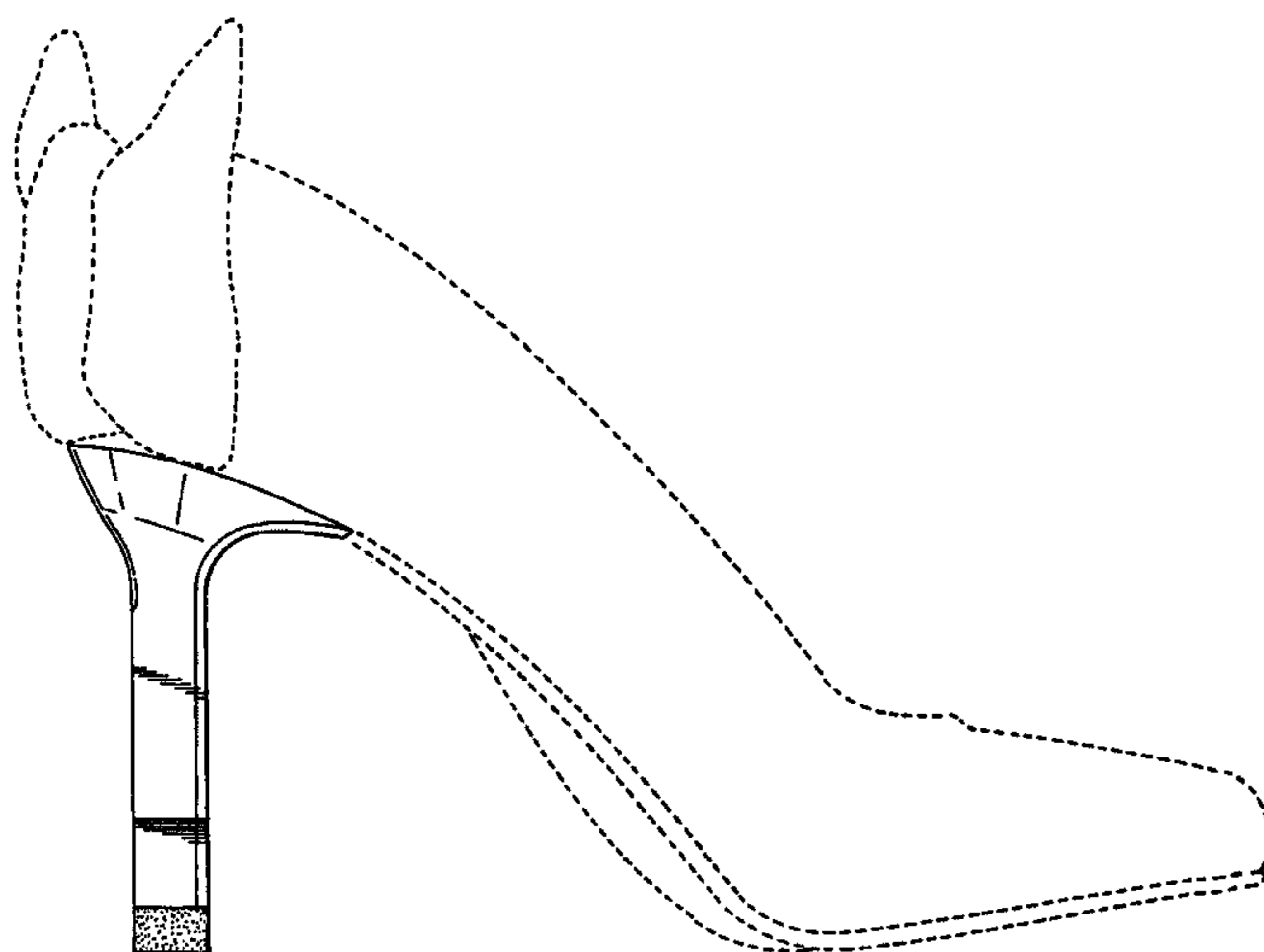
(57) **CLAIM**

The ornamental design for a shoe heel, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of a shoe heel showing my new design; and,

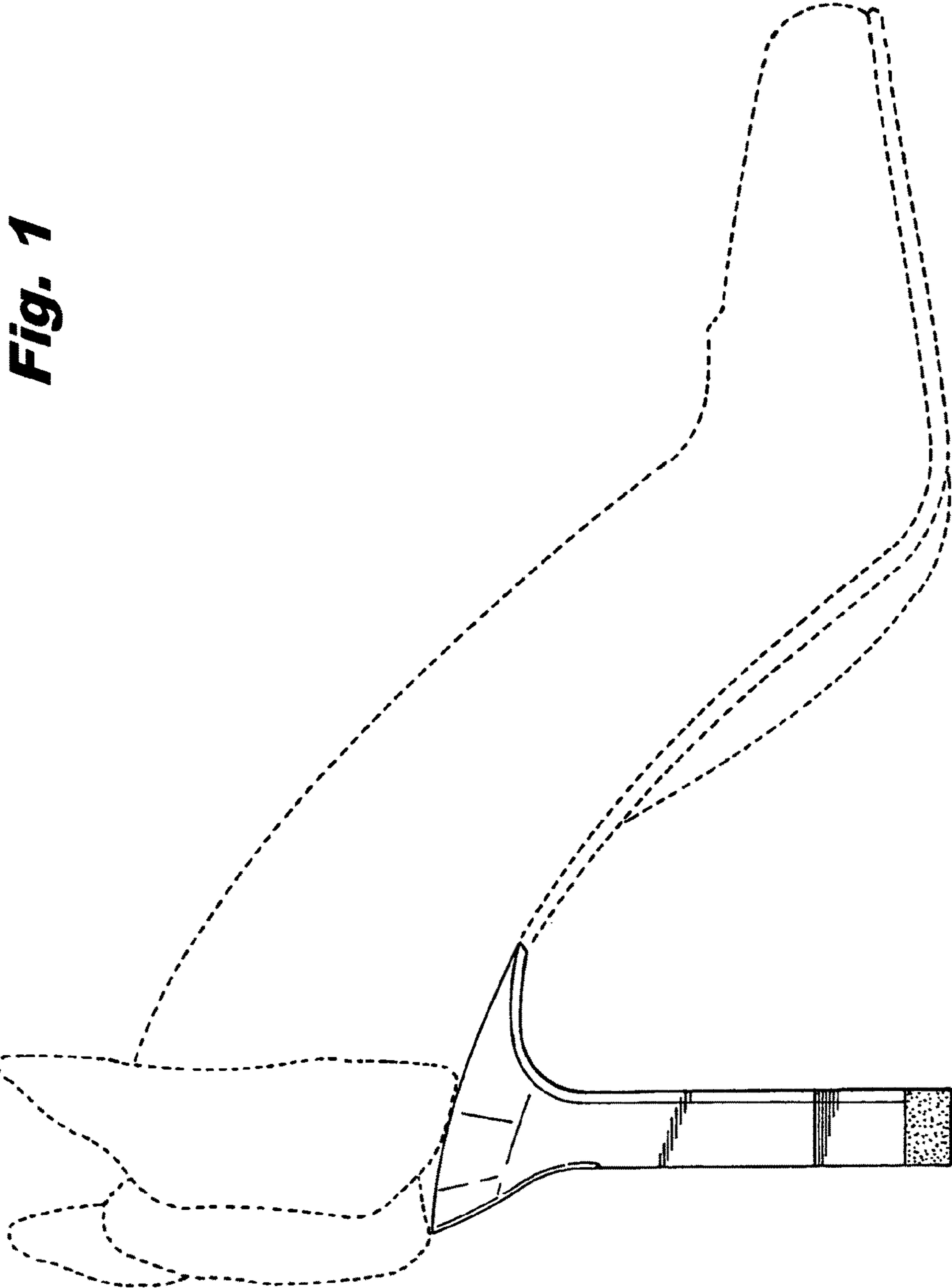

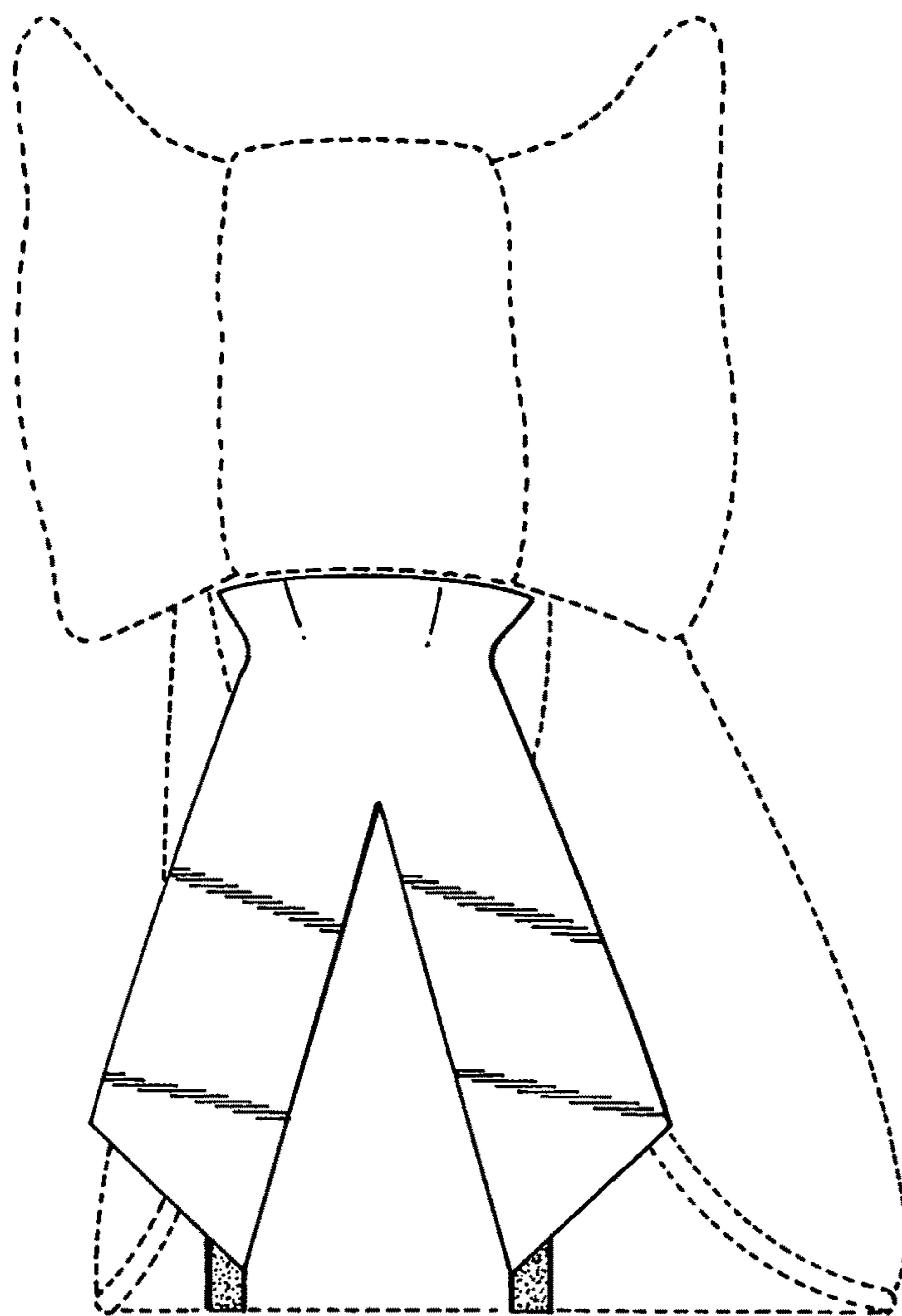
