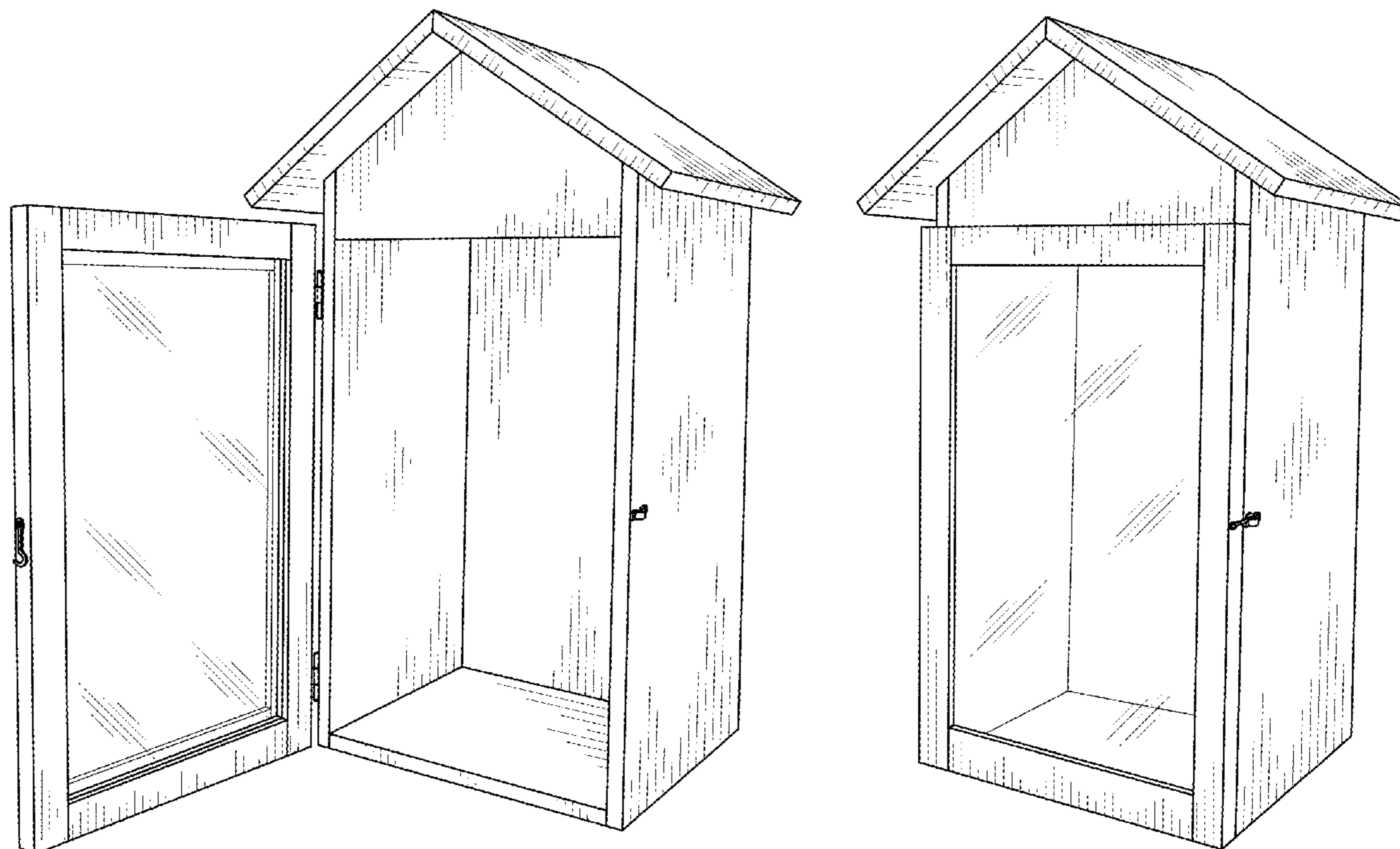
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a display case, showing my new design in an open configuration;
 FIG. 2 is a perspective view thereof, illustrated in a closed configuration;
 FIG. 3 is a front elevational view of FIG. 2;
 FIG. 4 is a rear elevational view of FIG. 2;
 FIG. 5 is a left-side elevational view of FIG. 2;

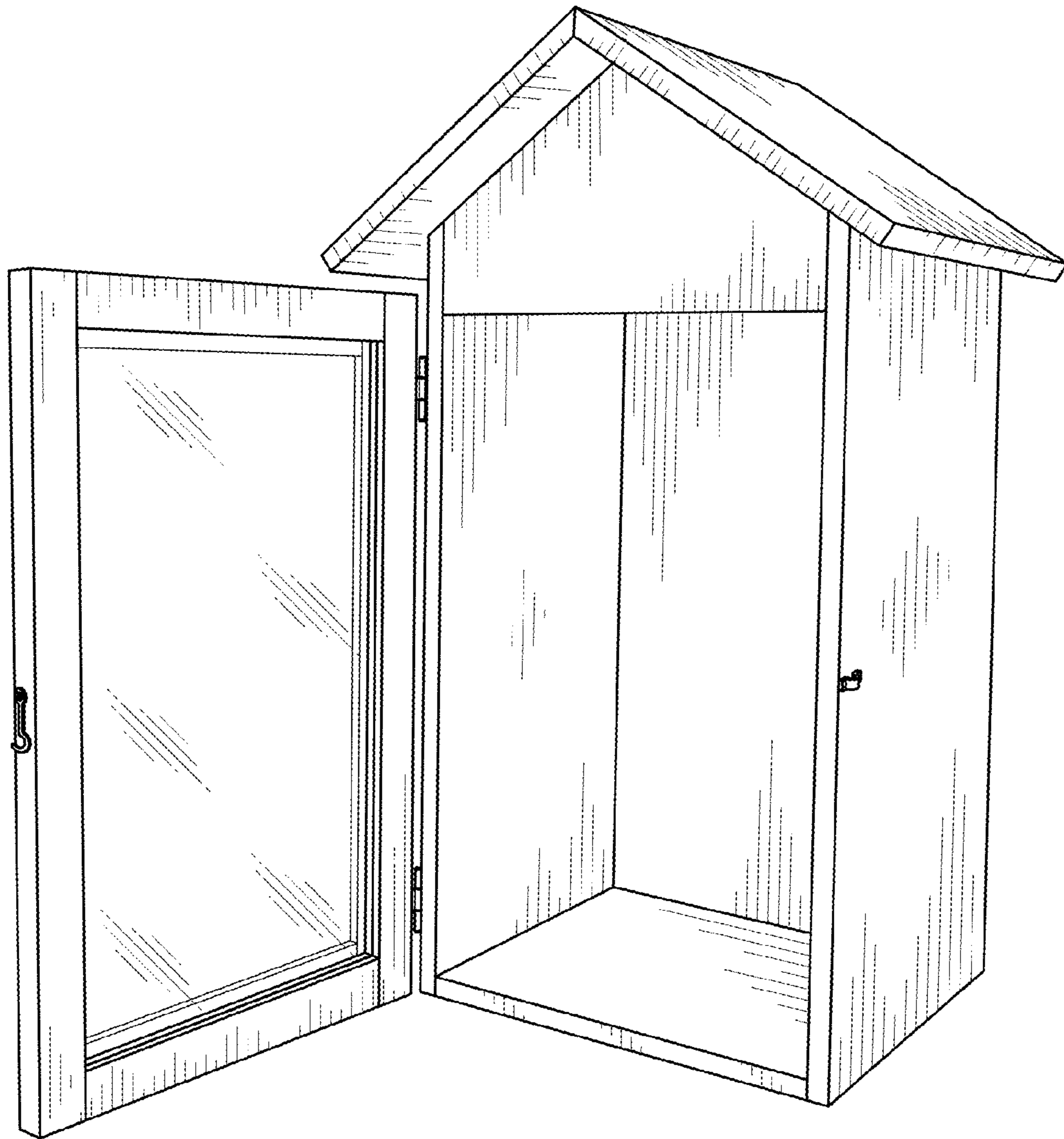

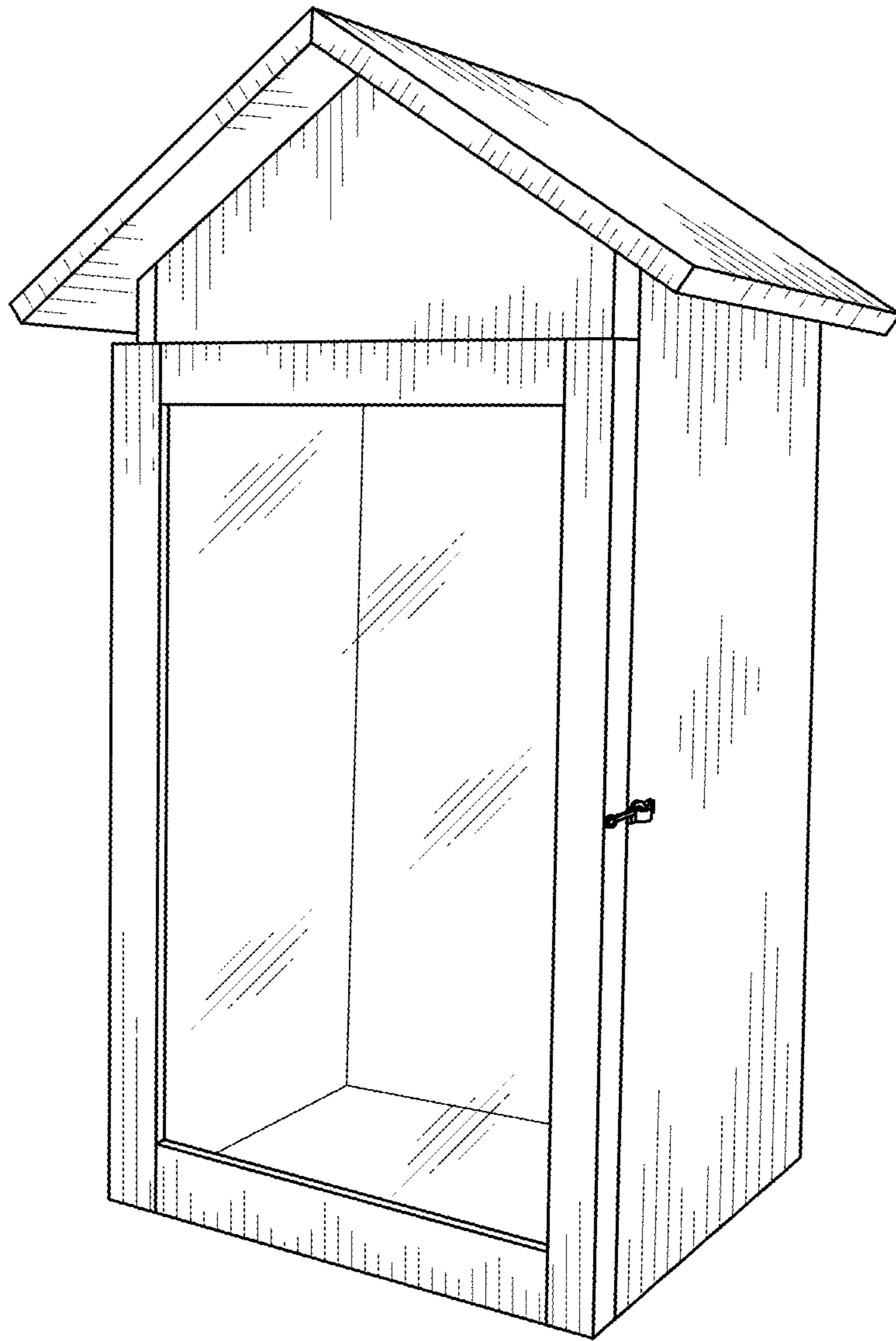

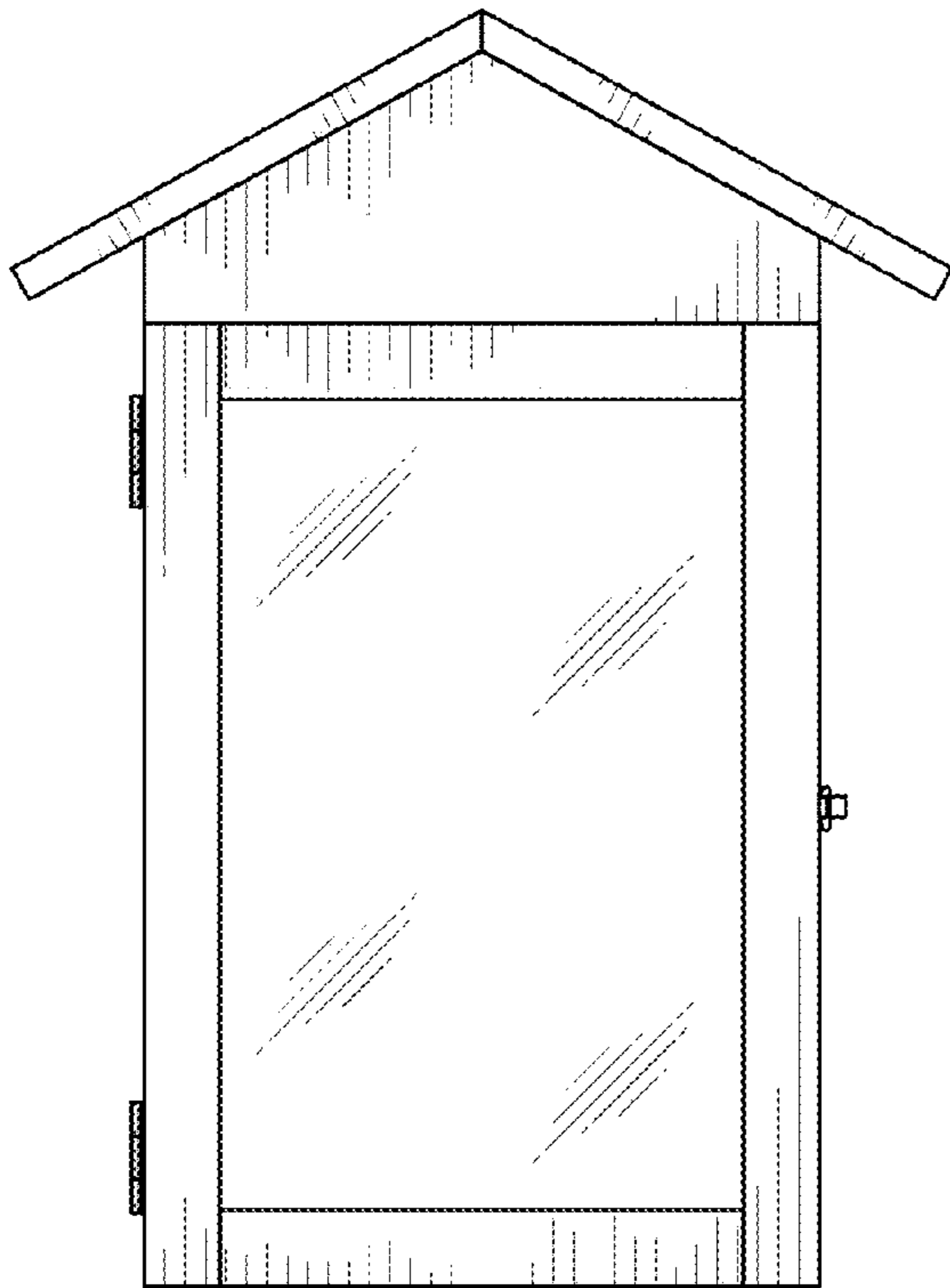

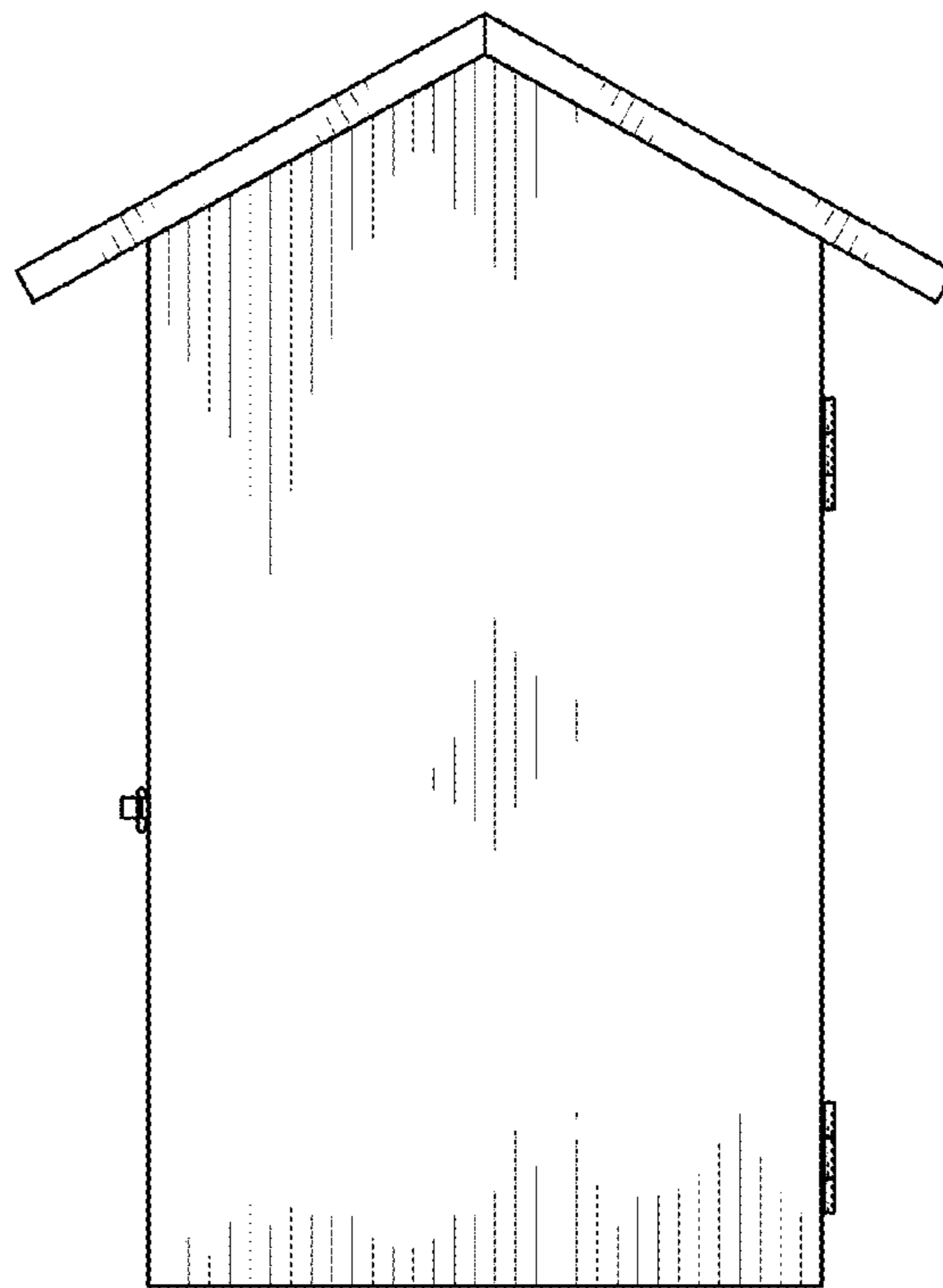

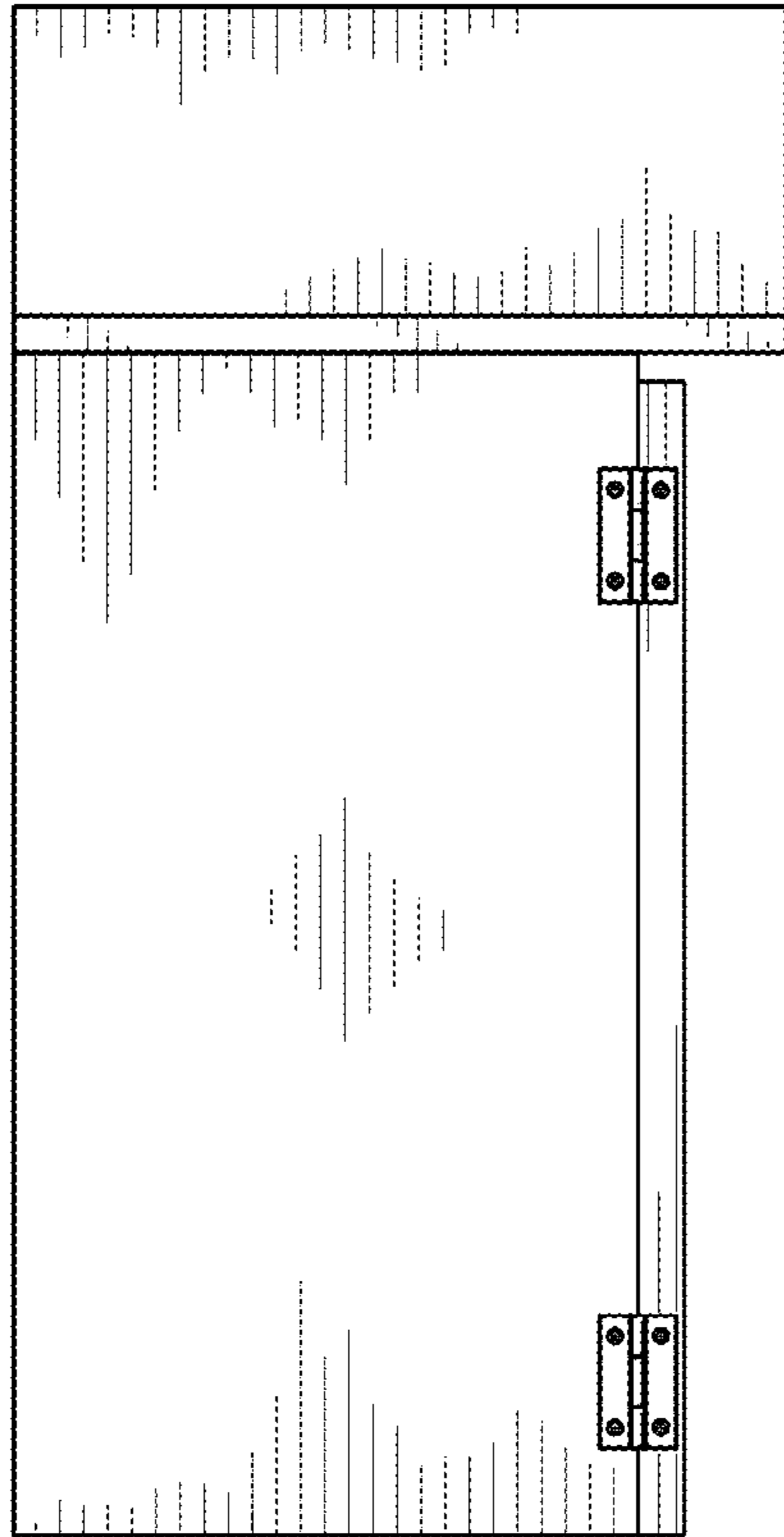

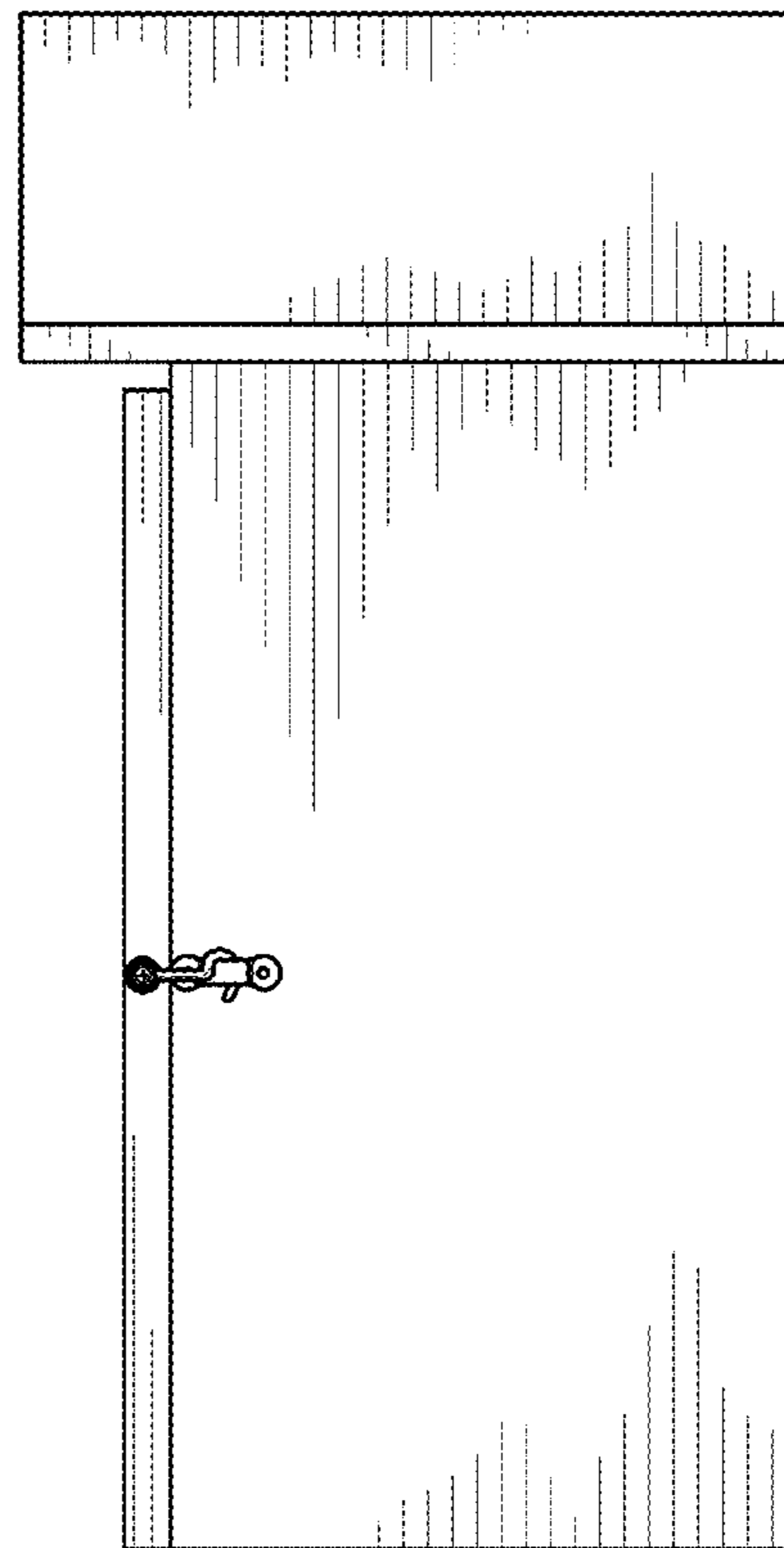

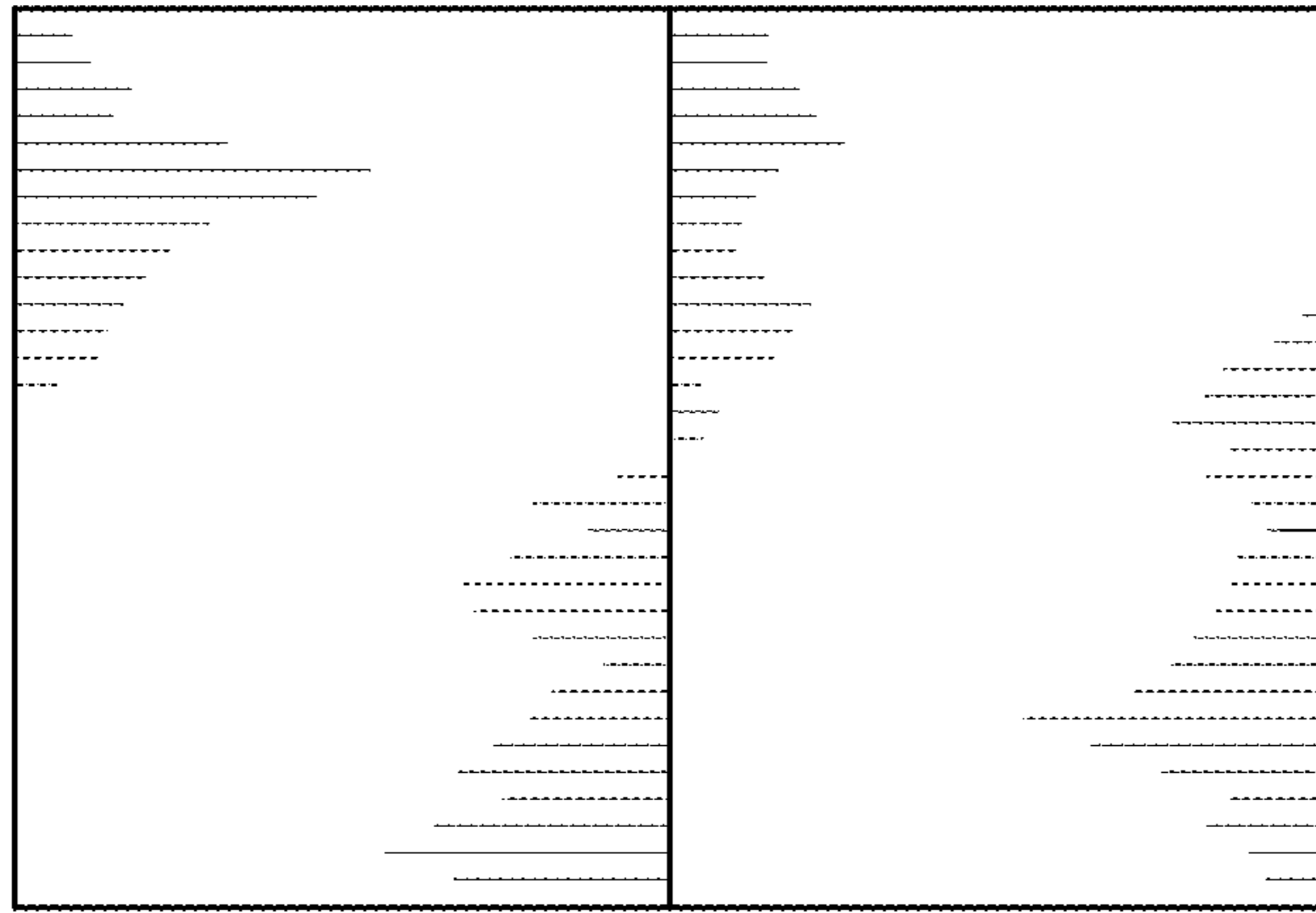

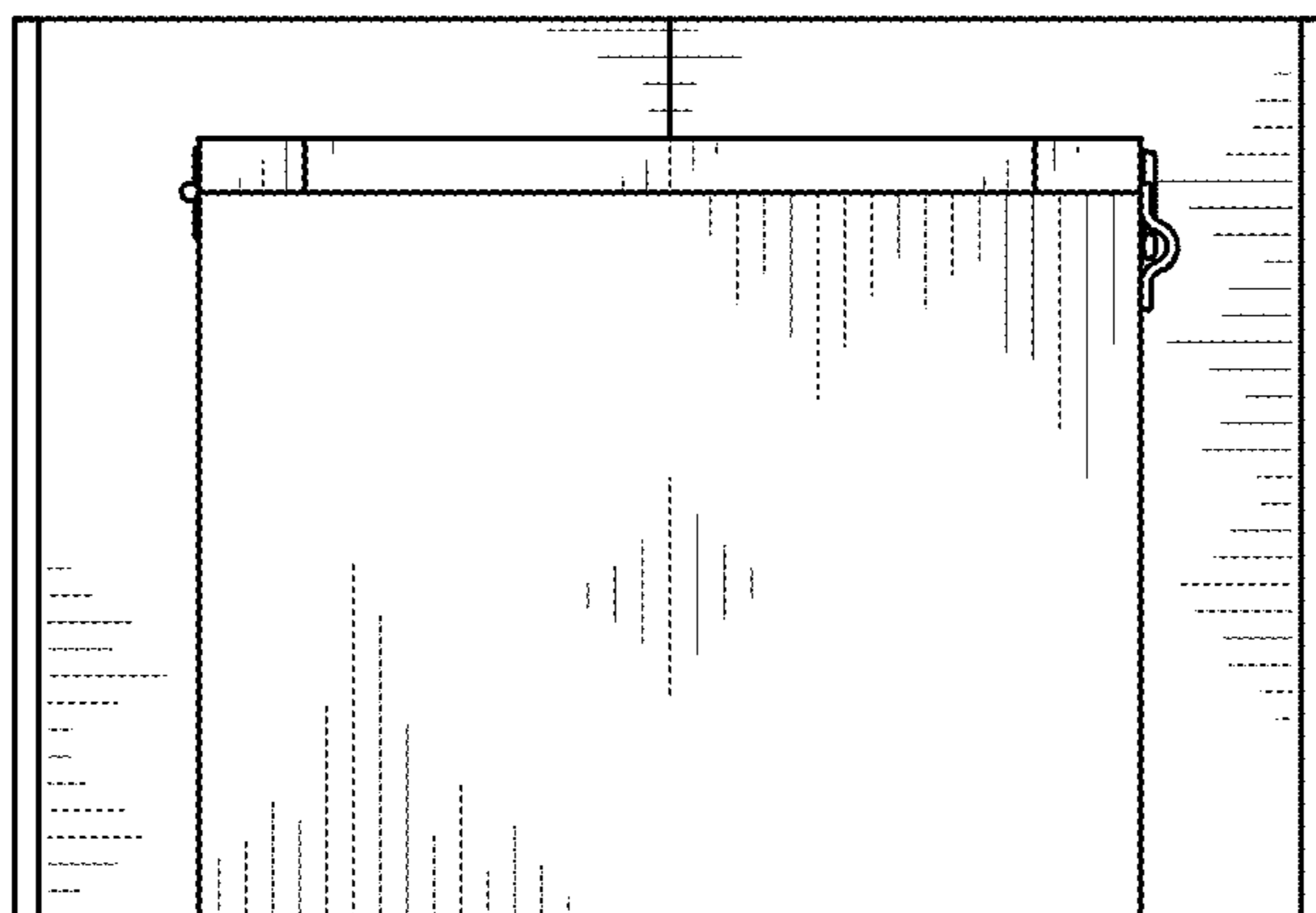
