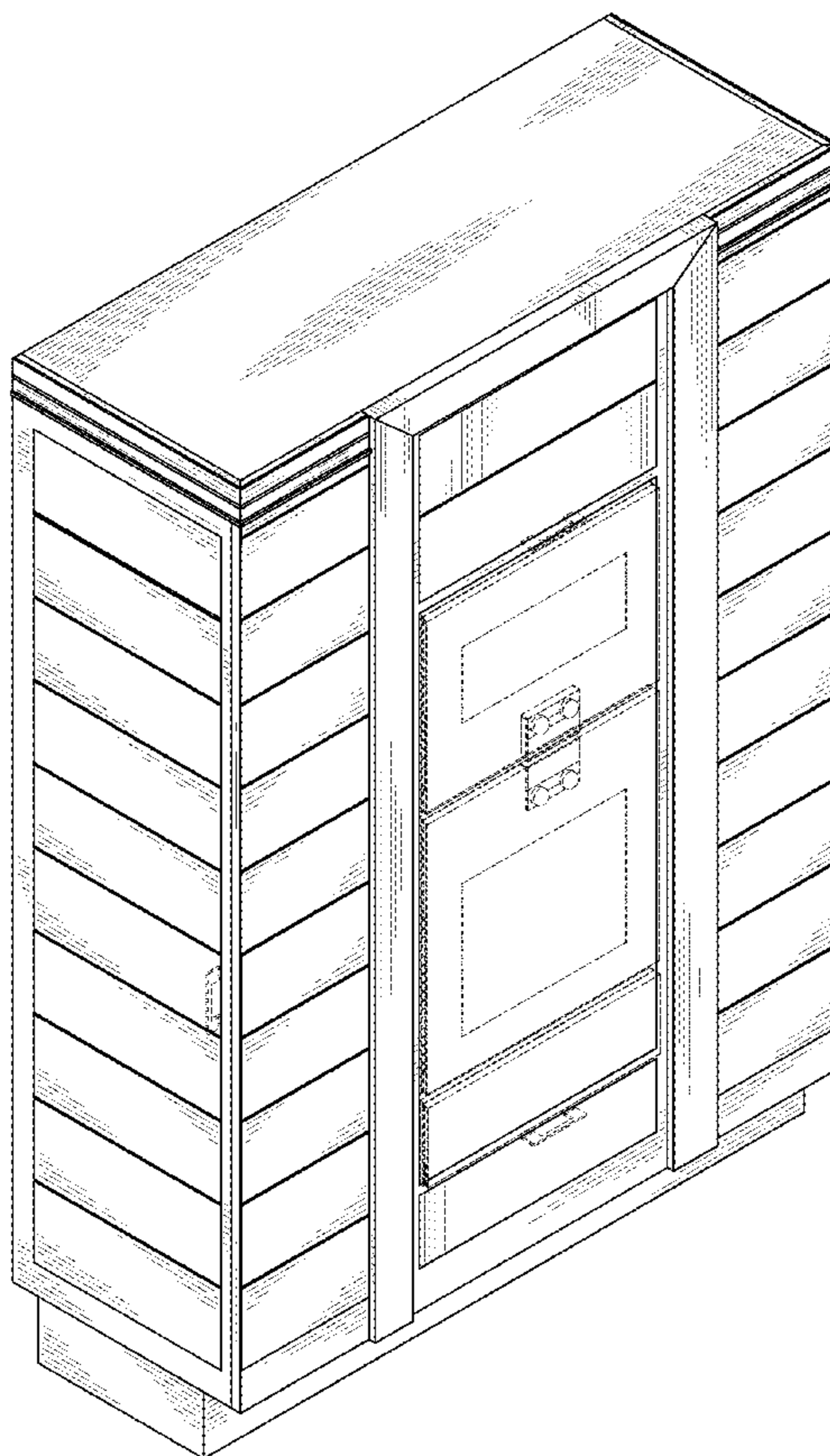
(57) **CLAIM**

What is claimed is the ornamental design for the cupboard, as shown and described herein.

**DESCRIPTION**

FIG. 1 depicts a perspective view of the cupboard;

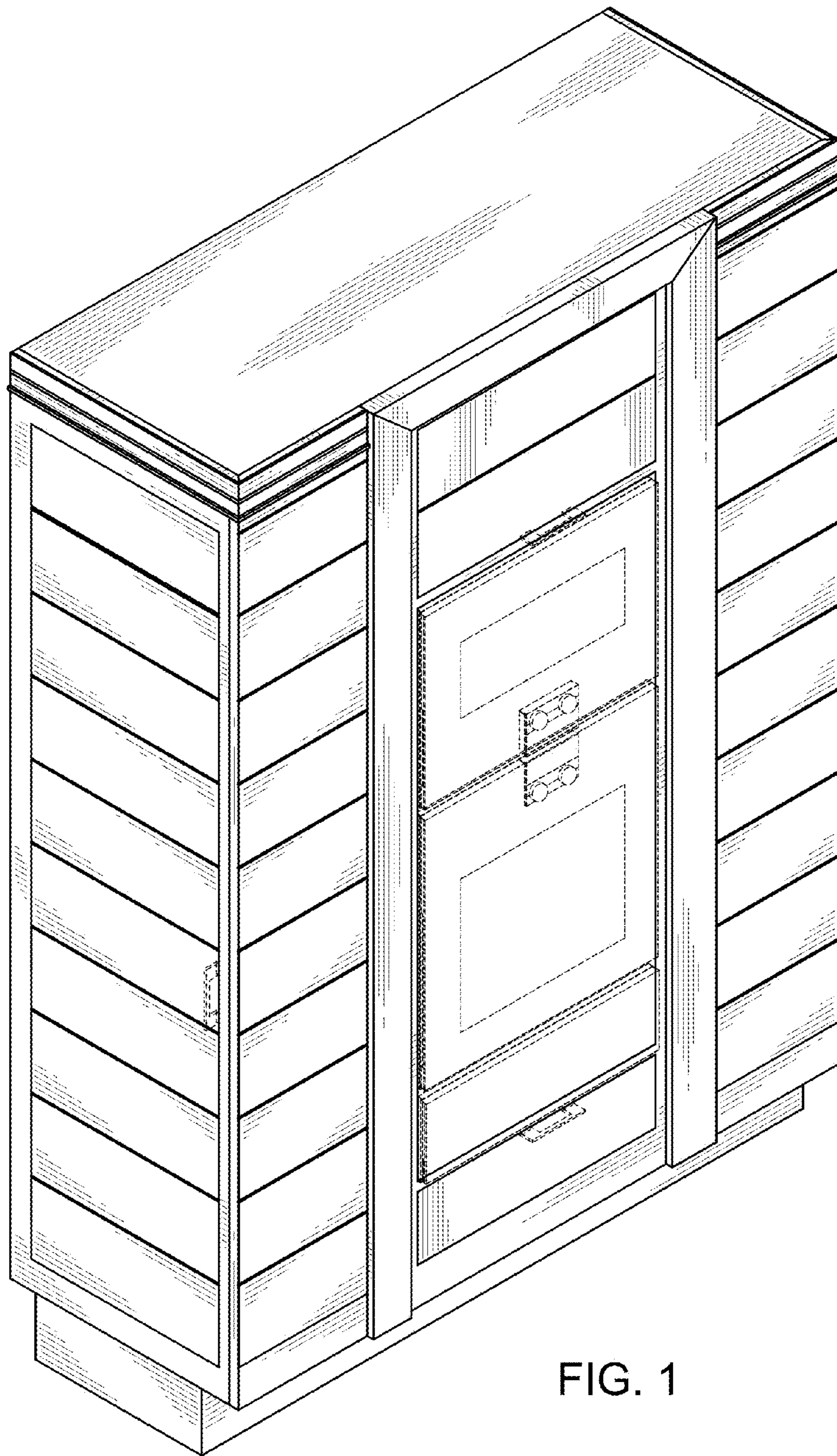

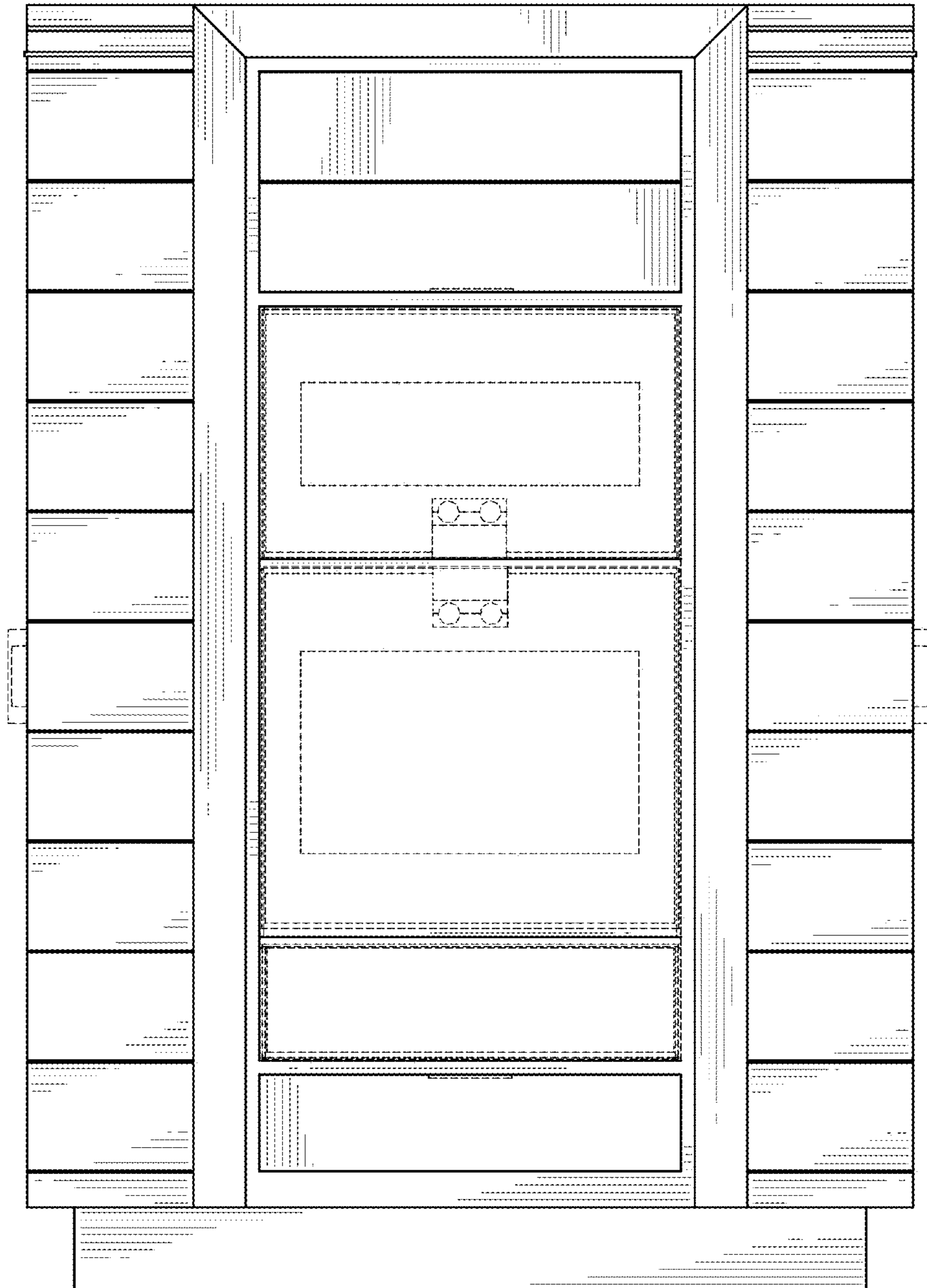

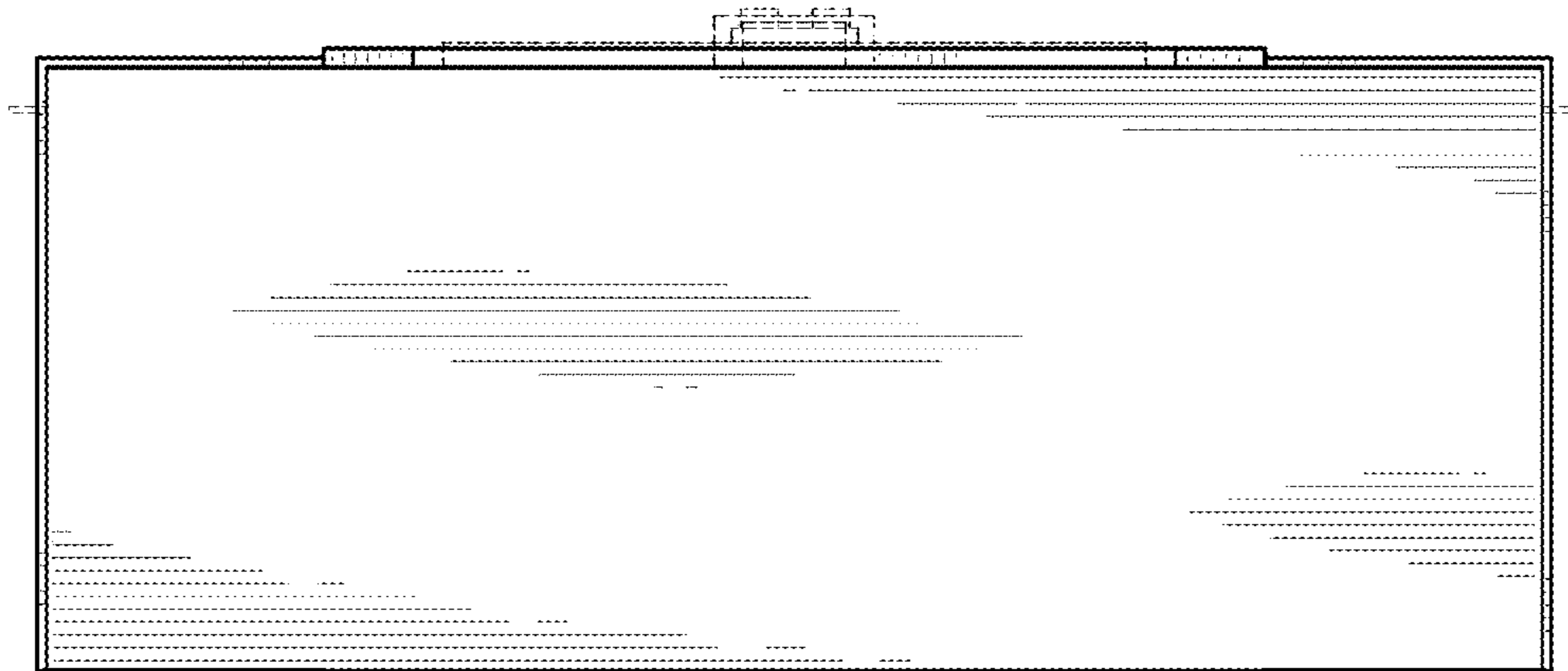

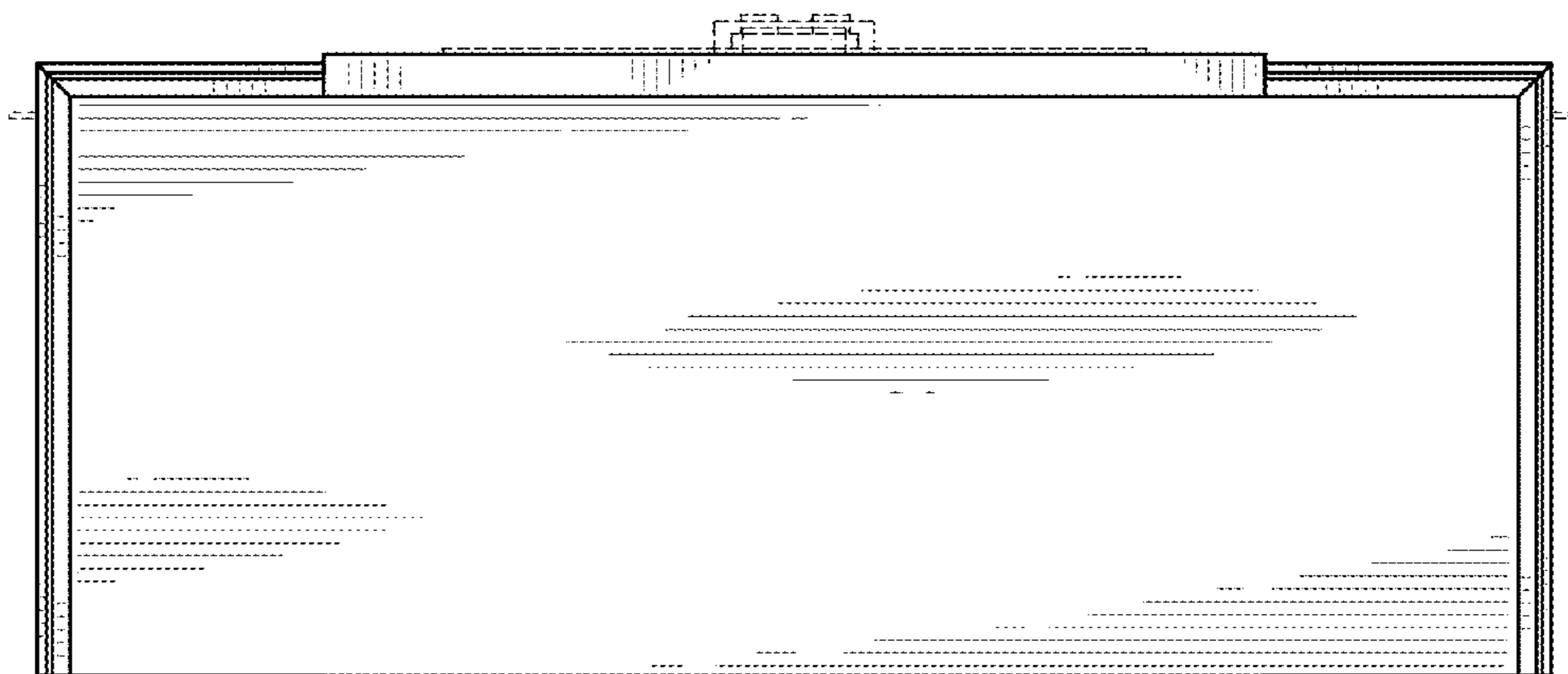

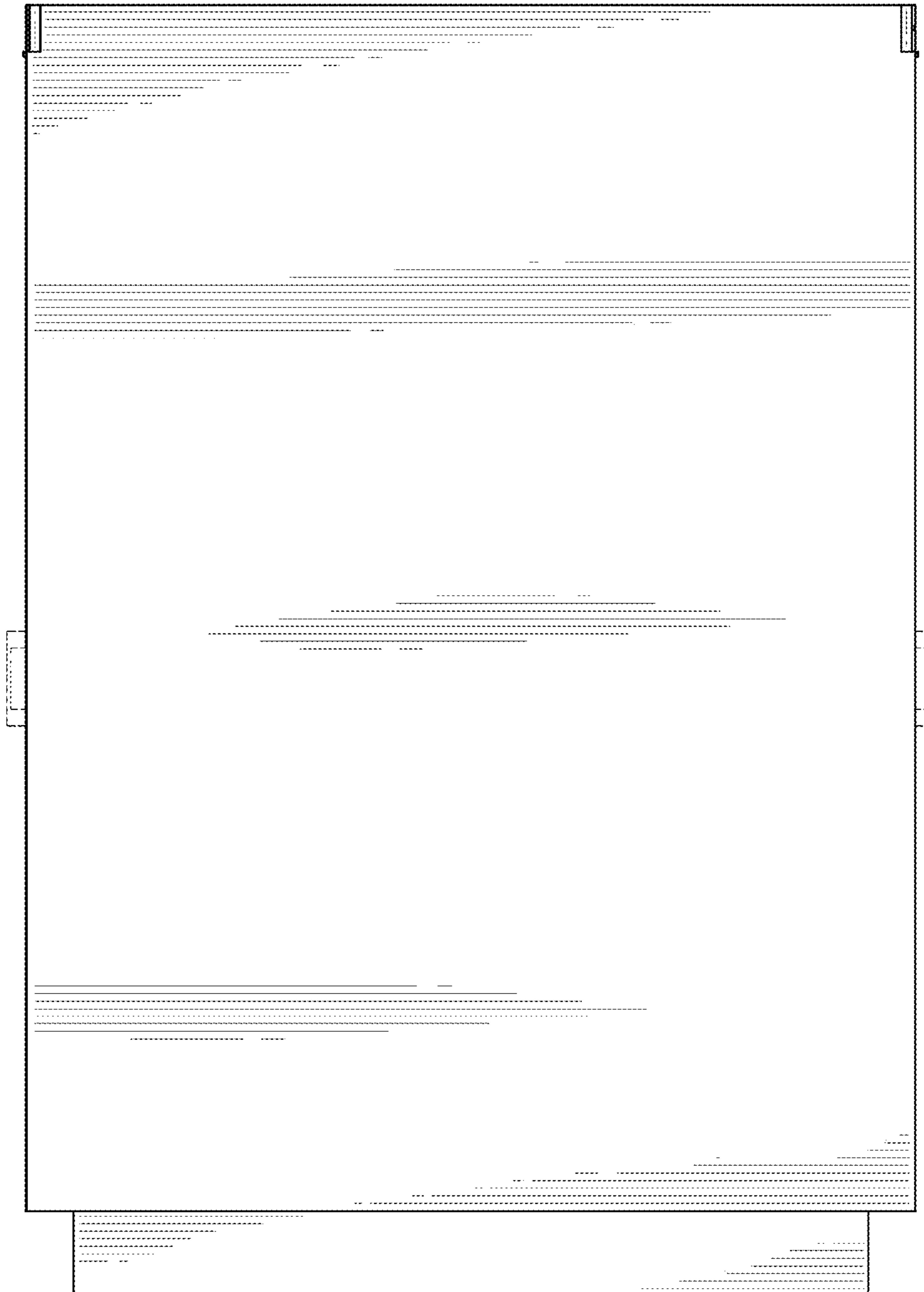

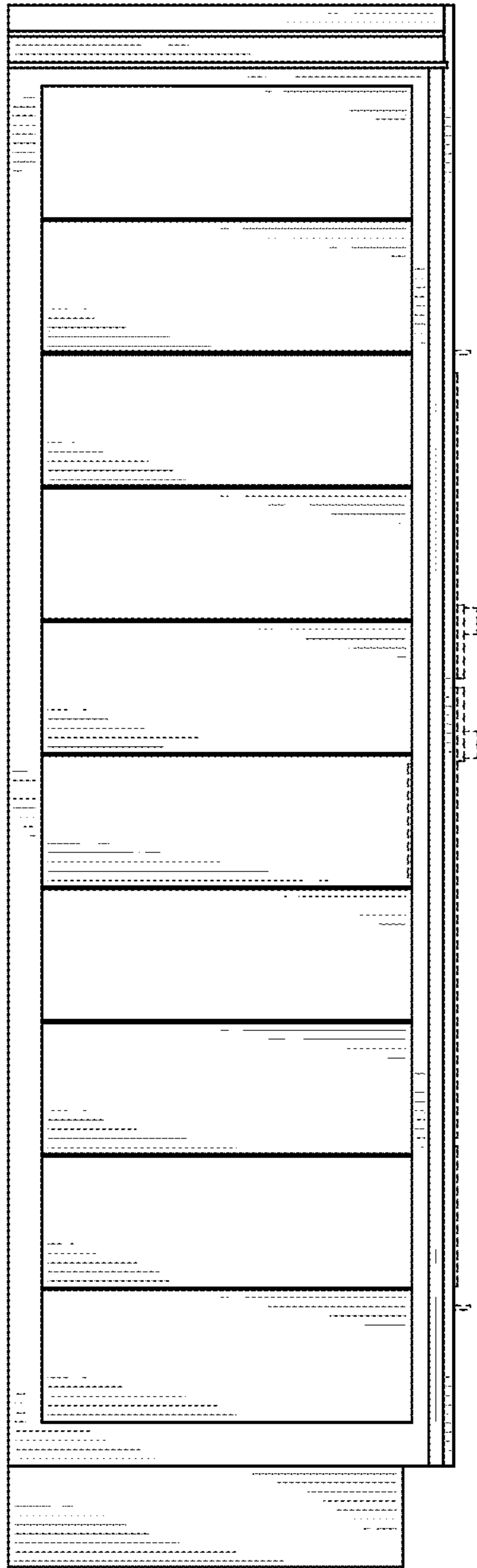

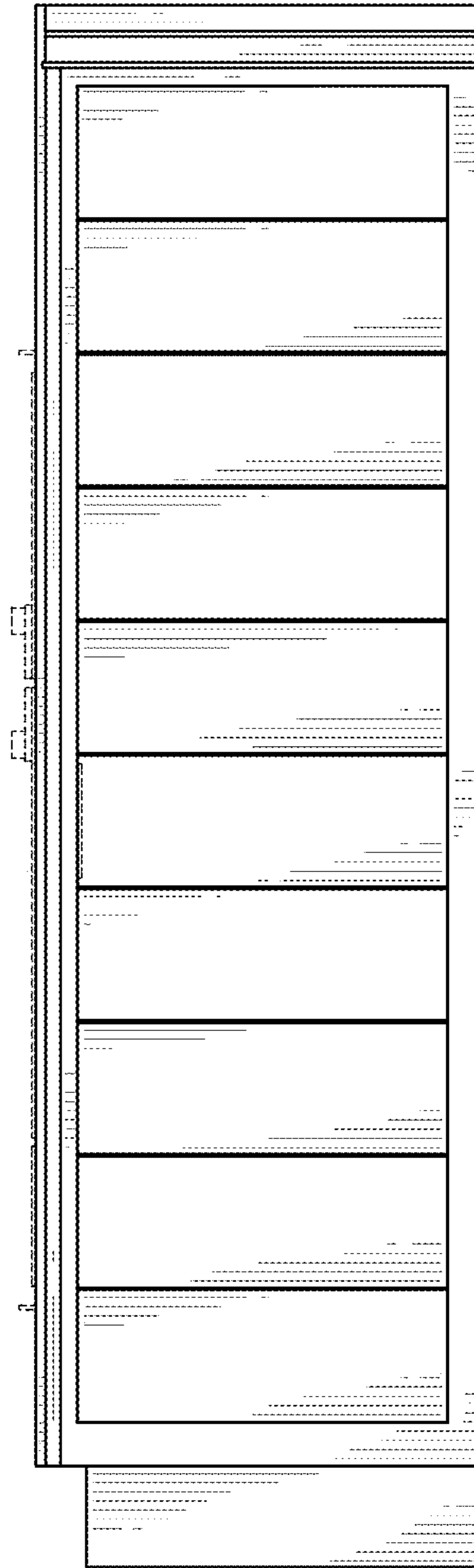
