**DESCRIPTION**

FIG. 1 is a left front perspective view showing my new design;

FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a front elevation view thereof; and,  
FIG. 7 is a rear elevation view thereof.  
Broken lines showing a stool base for the seat are included for  
the purpose of illustrating an environmental structure of the  
seating surface and form no part of the claimed design.

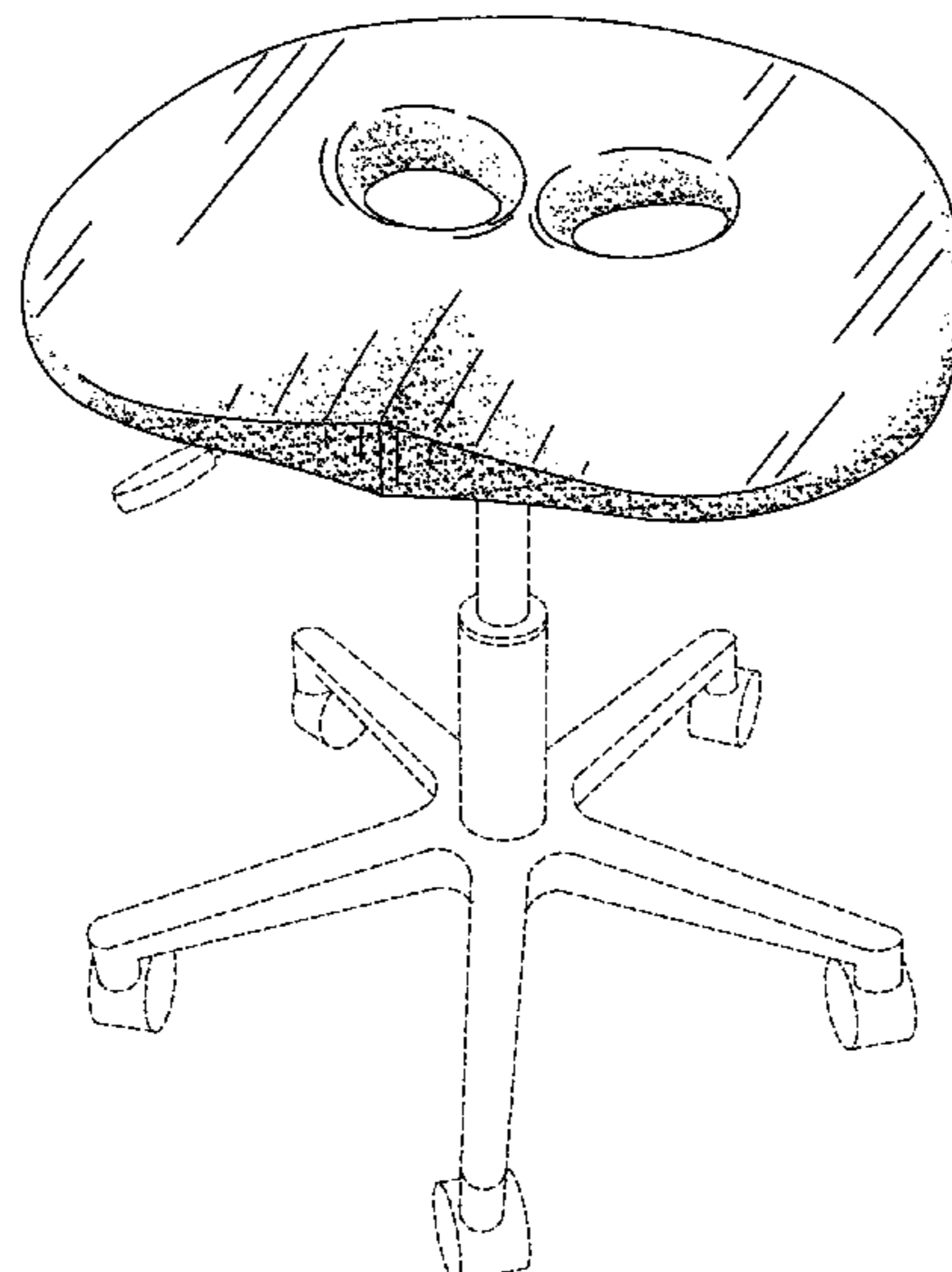

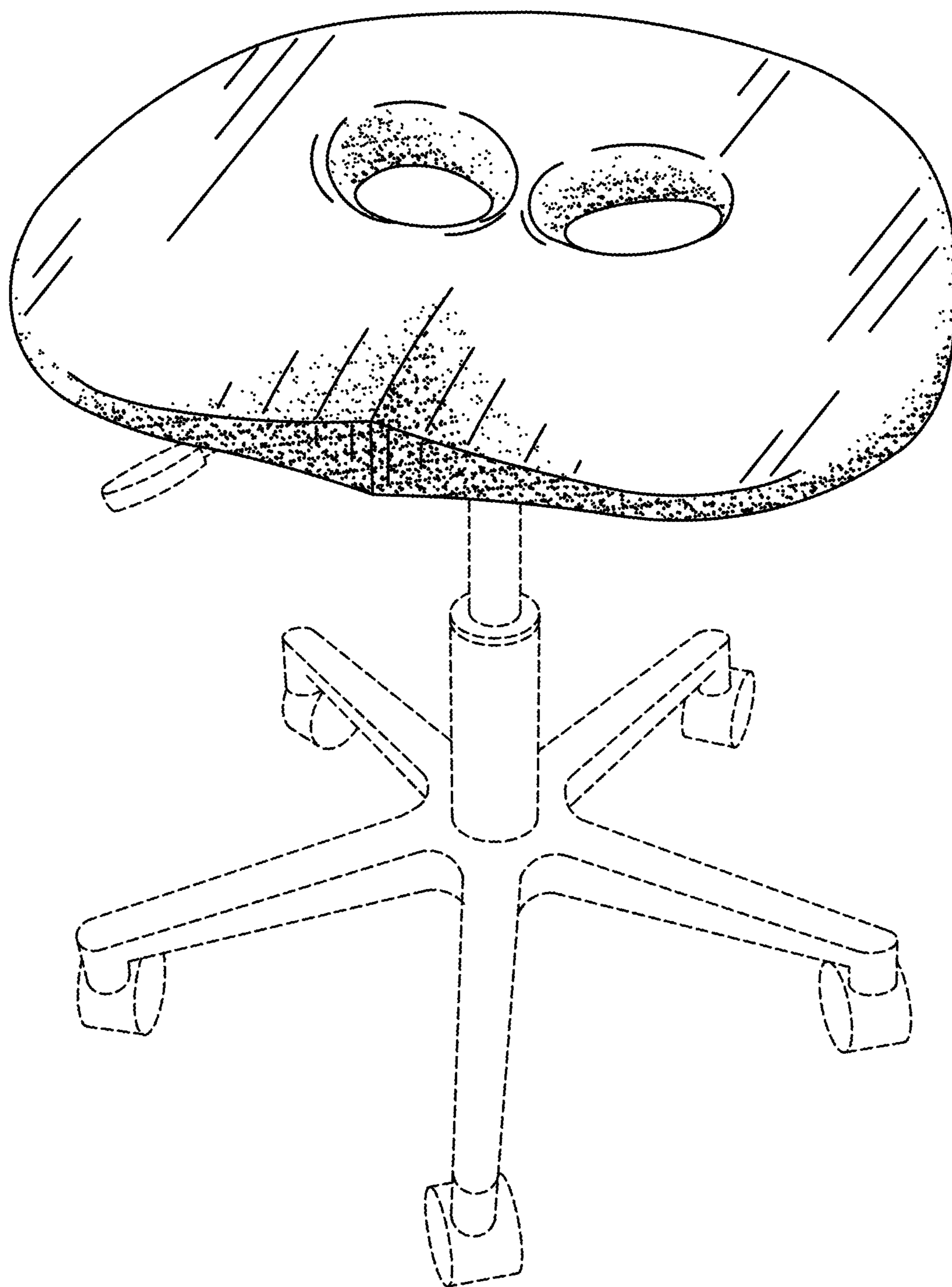

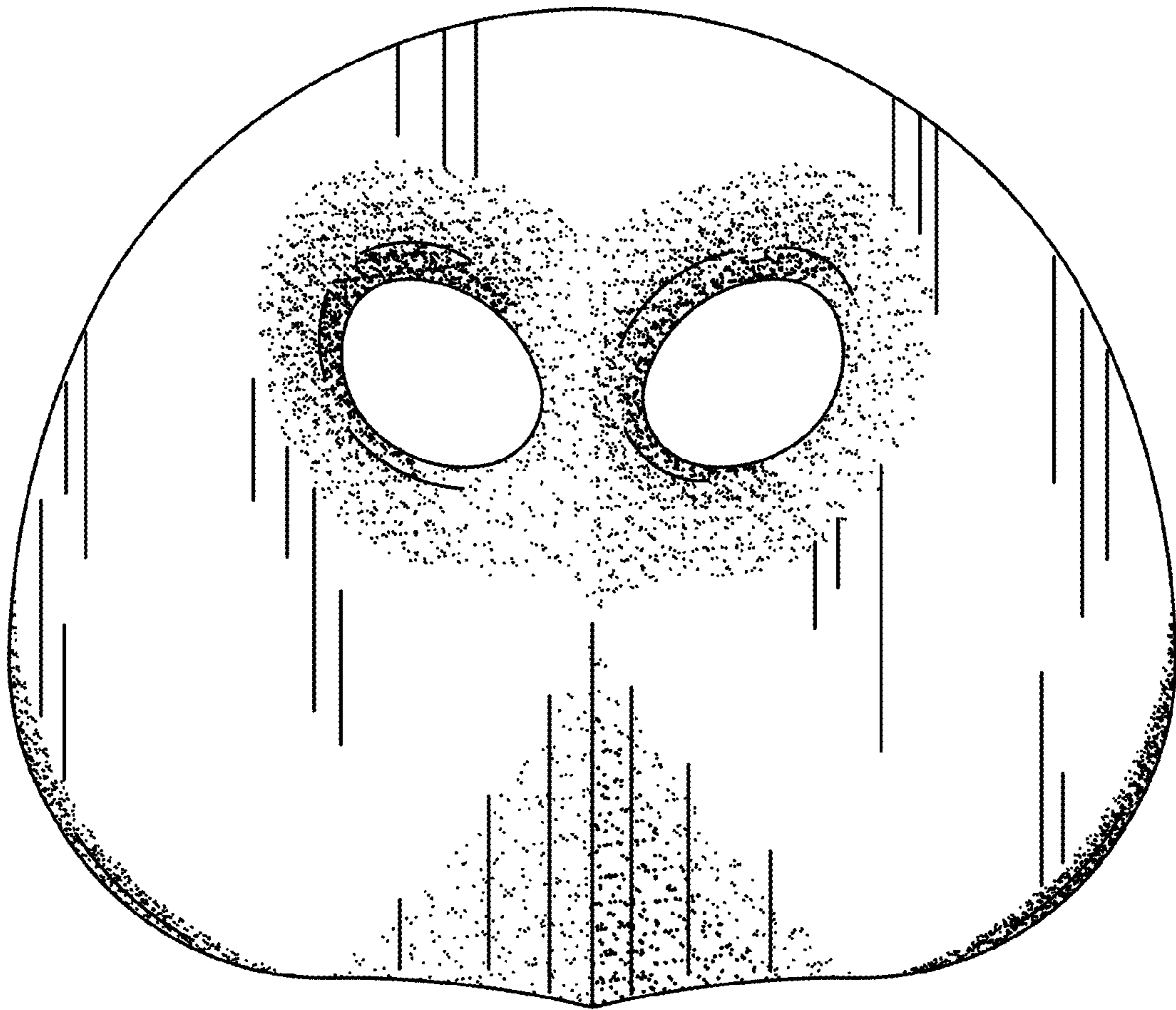

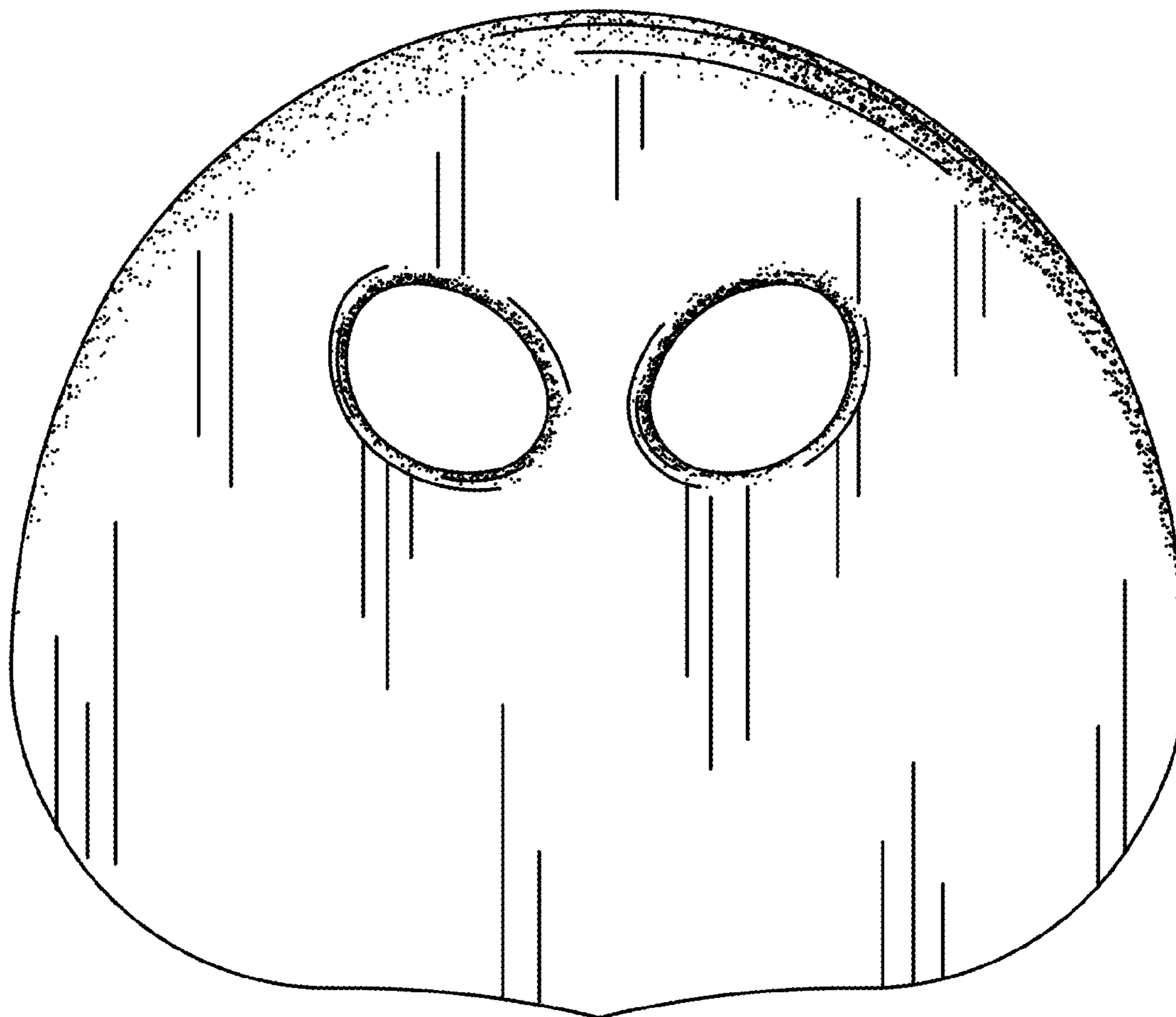

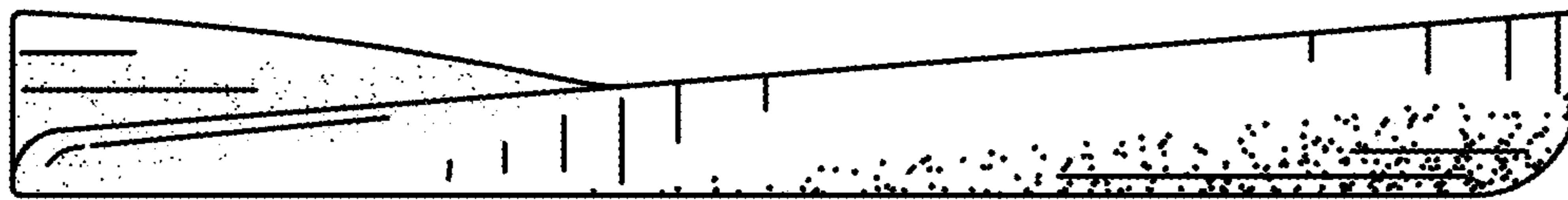

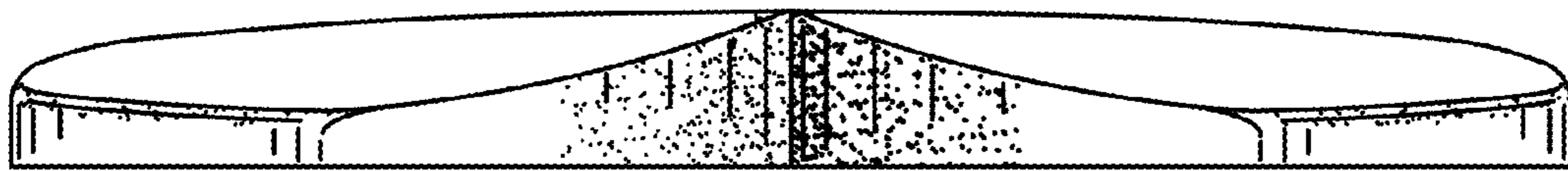
