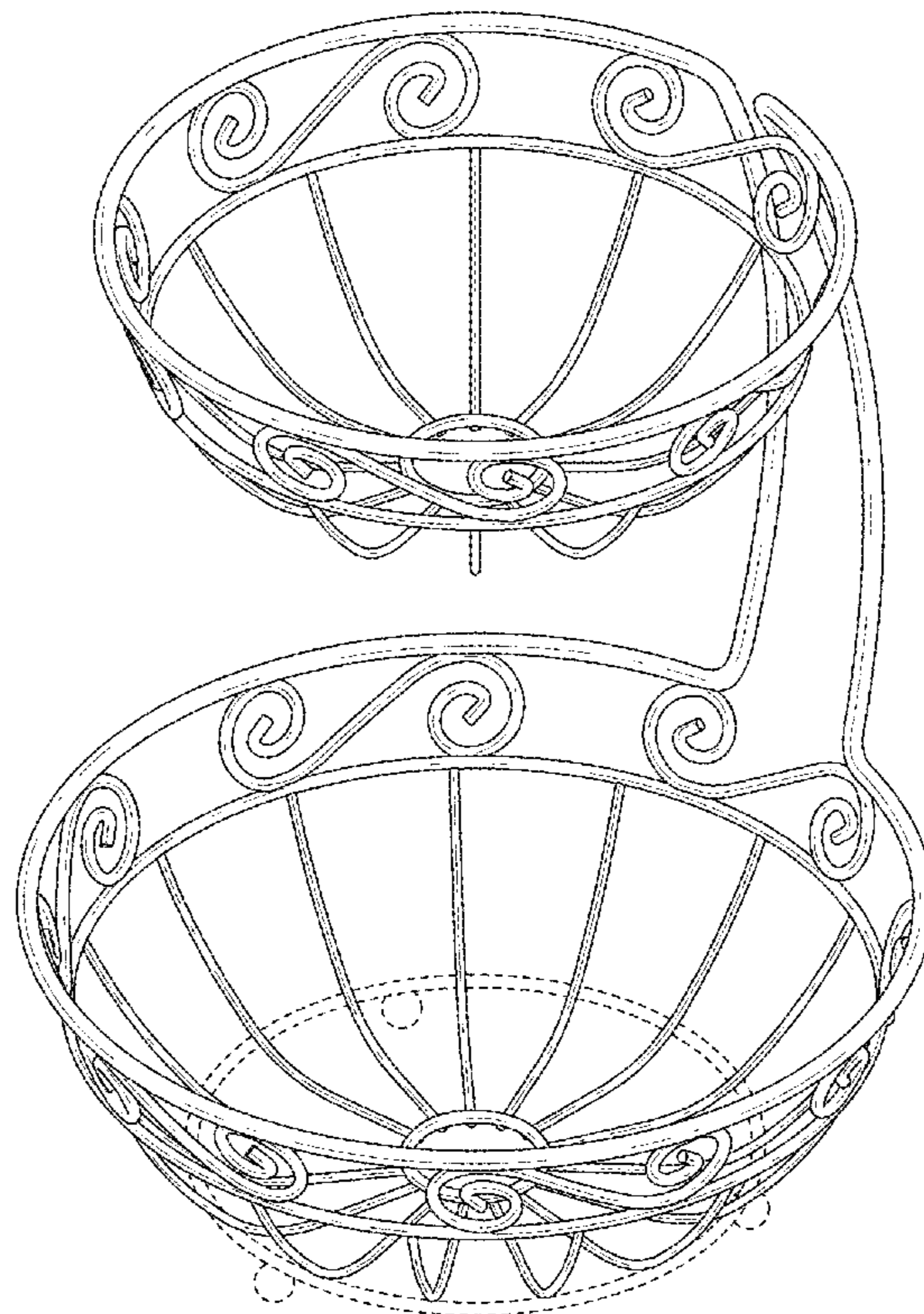
(57) **CLAIM**

What is claimed is the ornamental design for a two tier server,
as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a two tier server showing a new
design;
FIG. 2 is a front view of the two tier server of FIG. 1;
FIG. 3 is a side view of the two tier server of FIG. 1;
FIG. 4 is a rear view of the two tier server of FIG. 1;
FIG. 5 is a top view of the two tier server of FIG. 1; and,
FIG. 6 is a bottom view of the two tier server of FIG. 1.

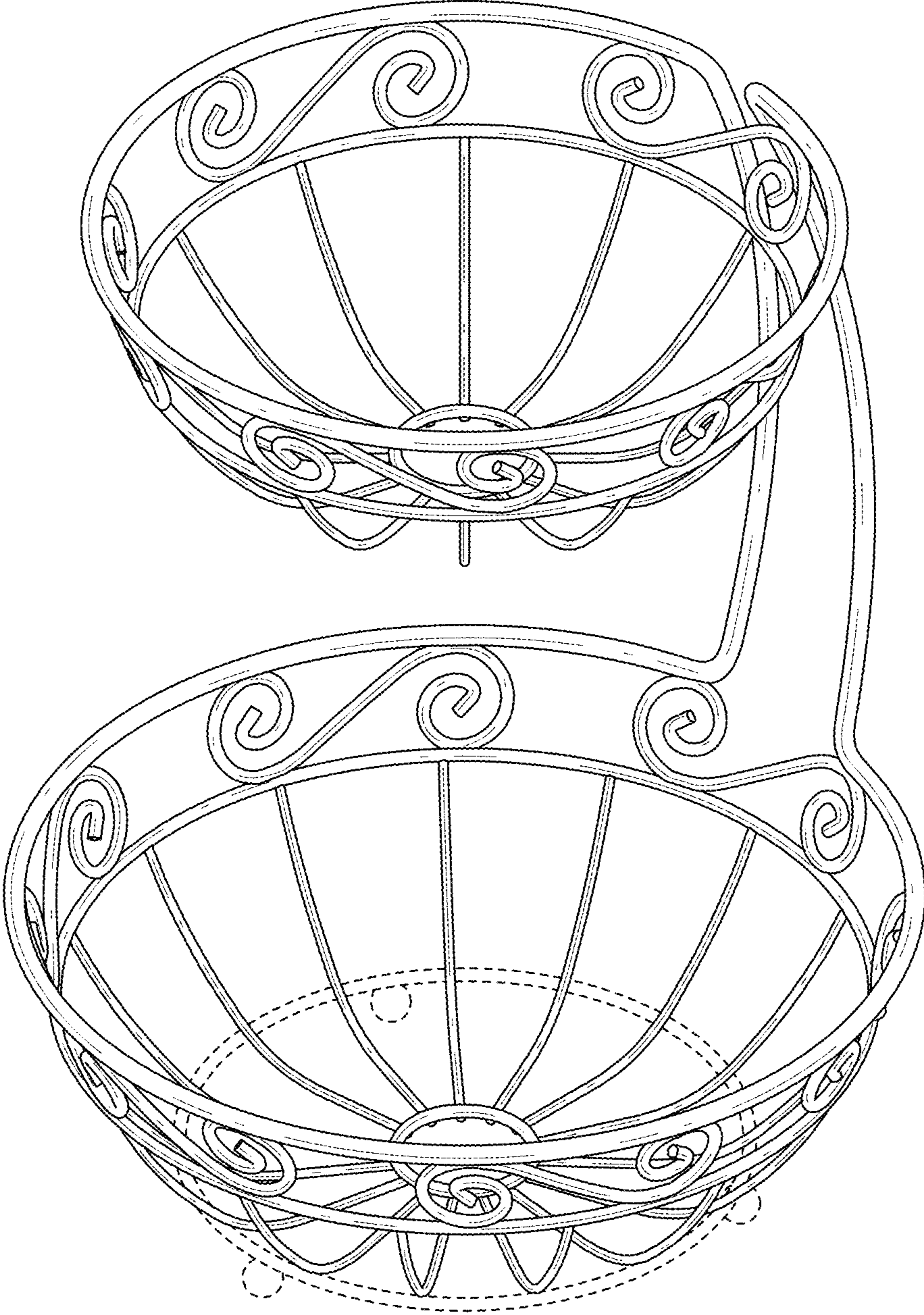

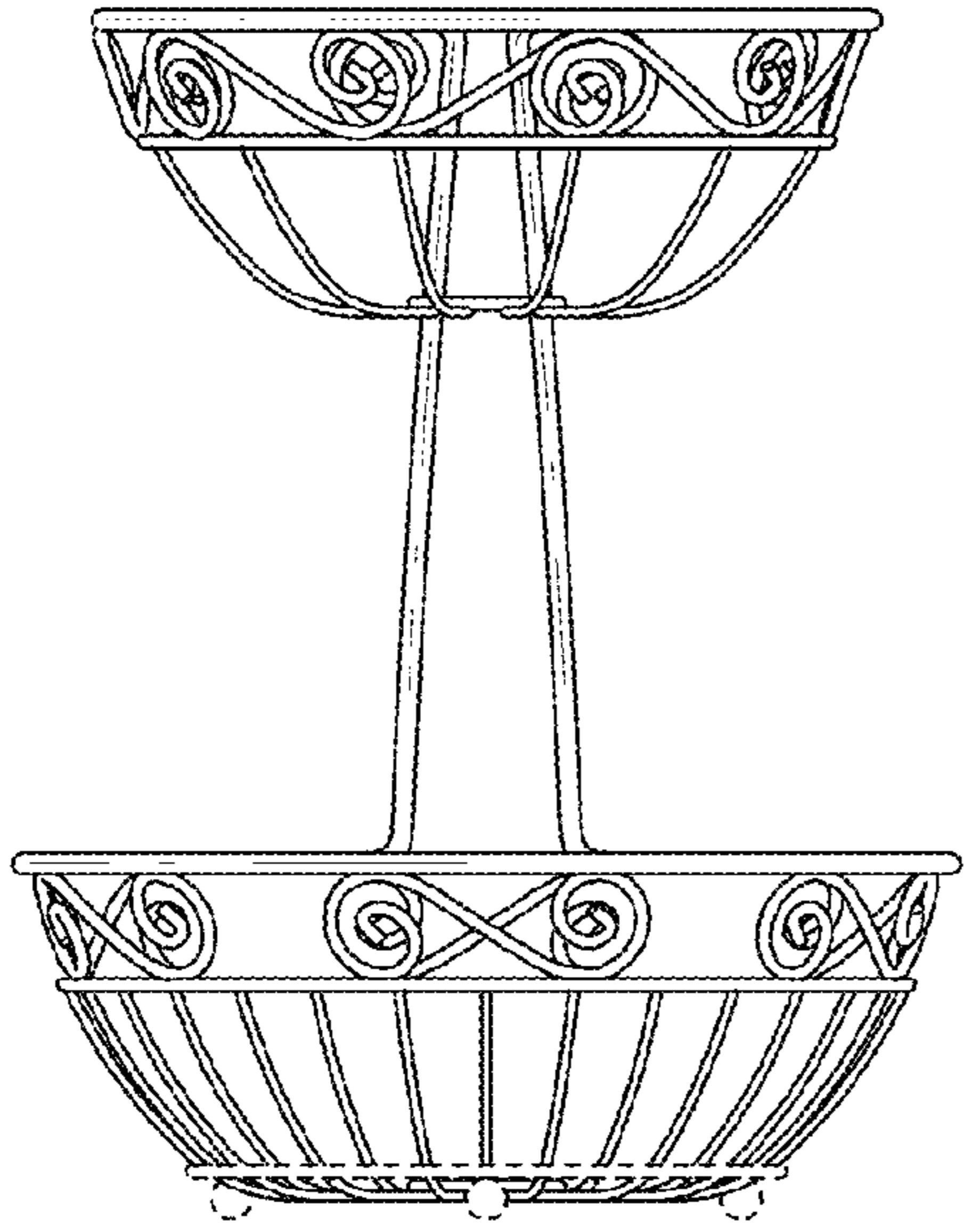

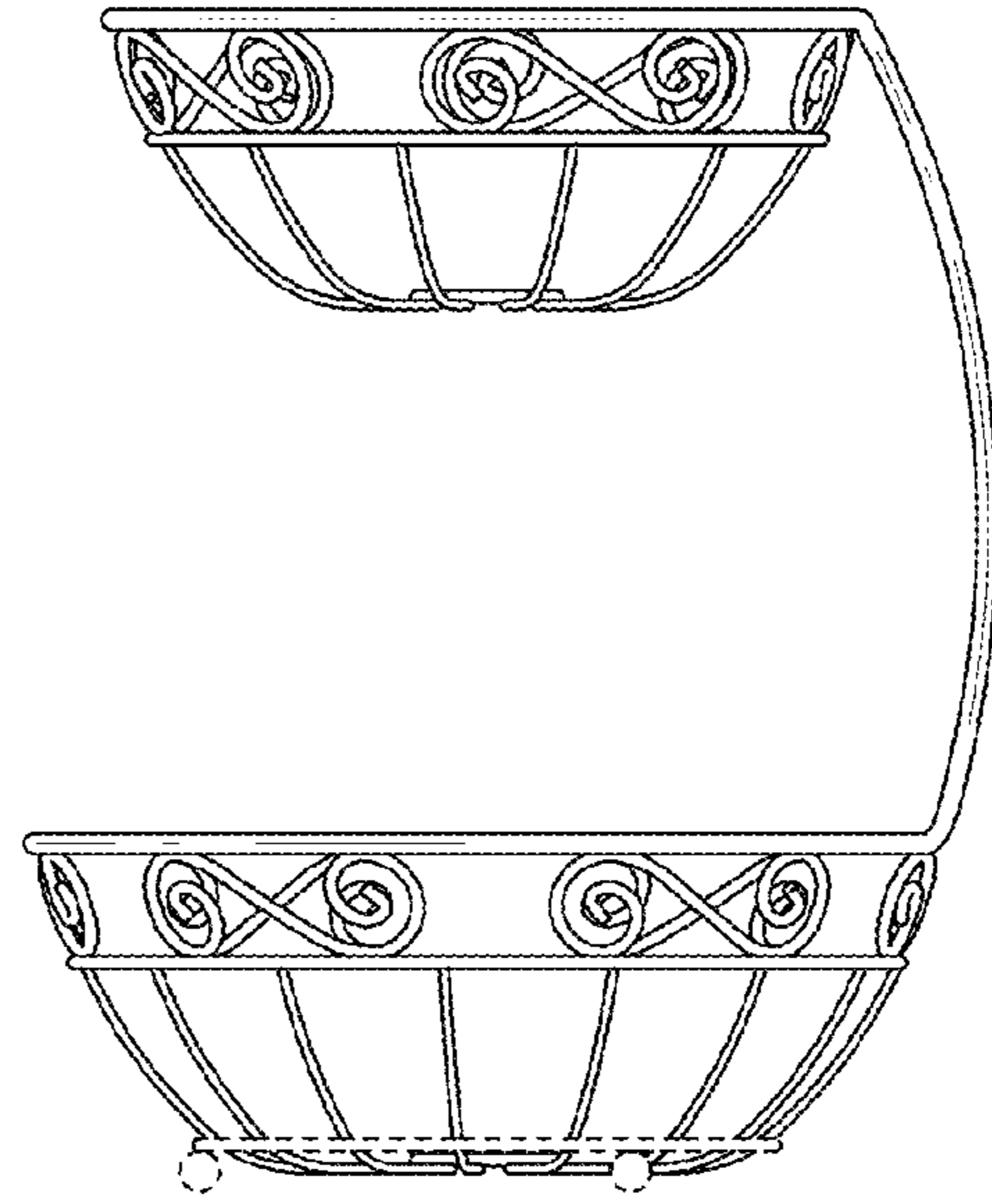

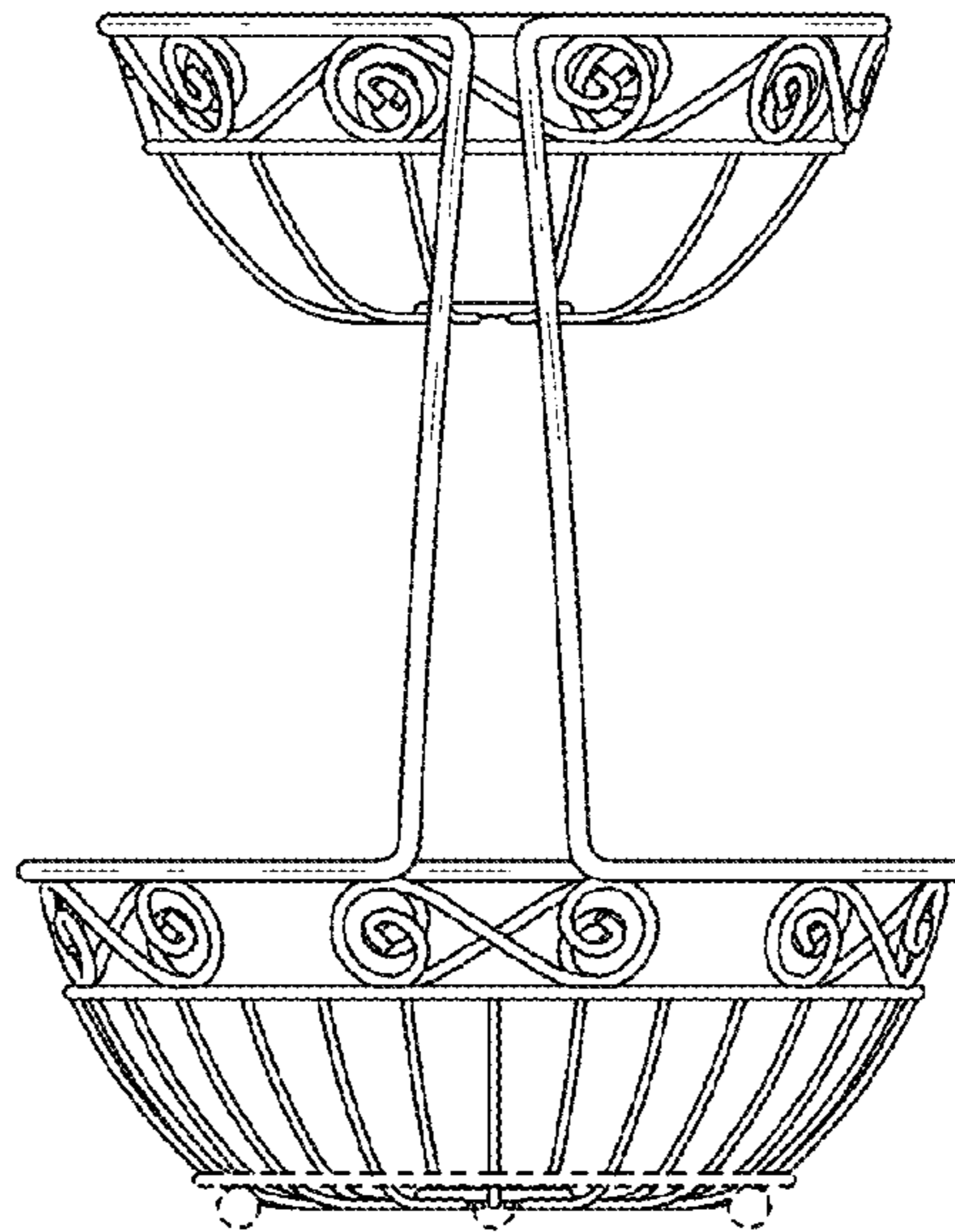

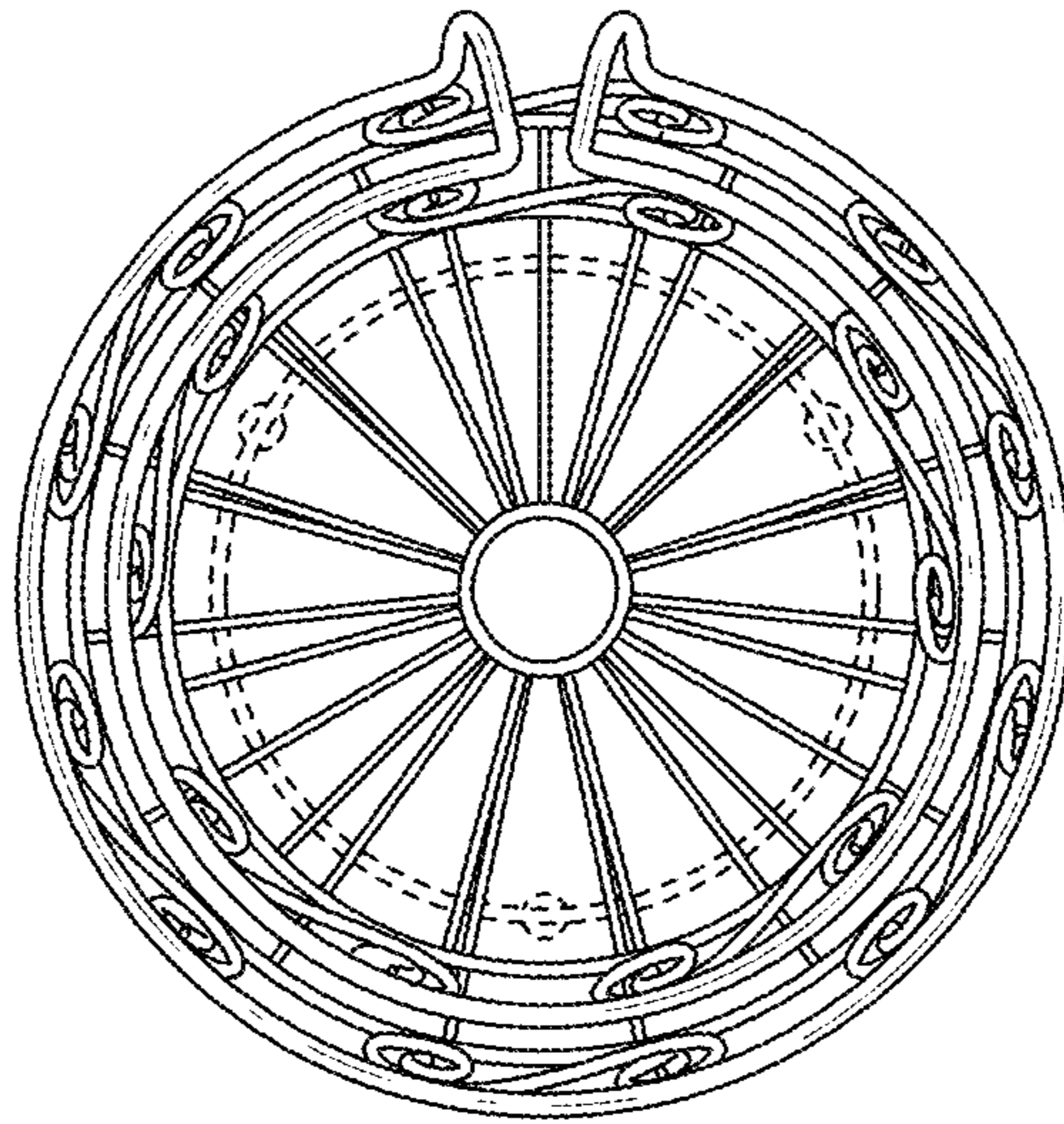

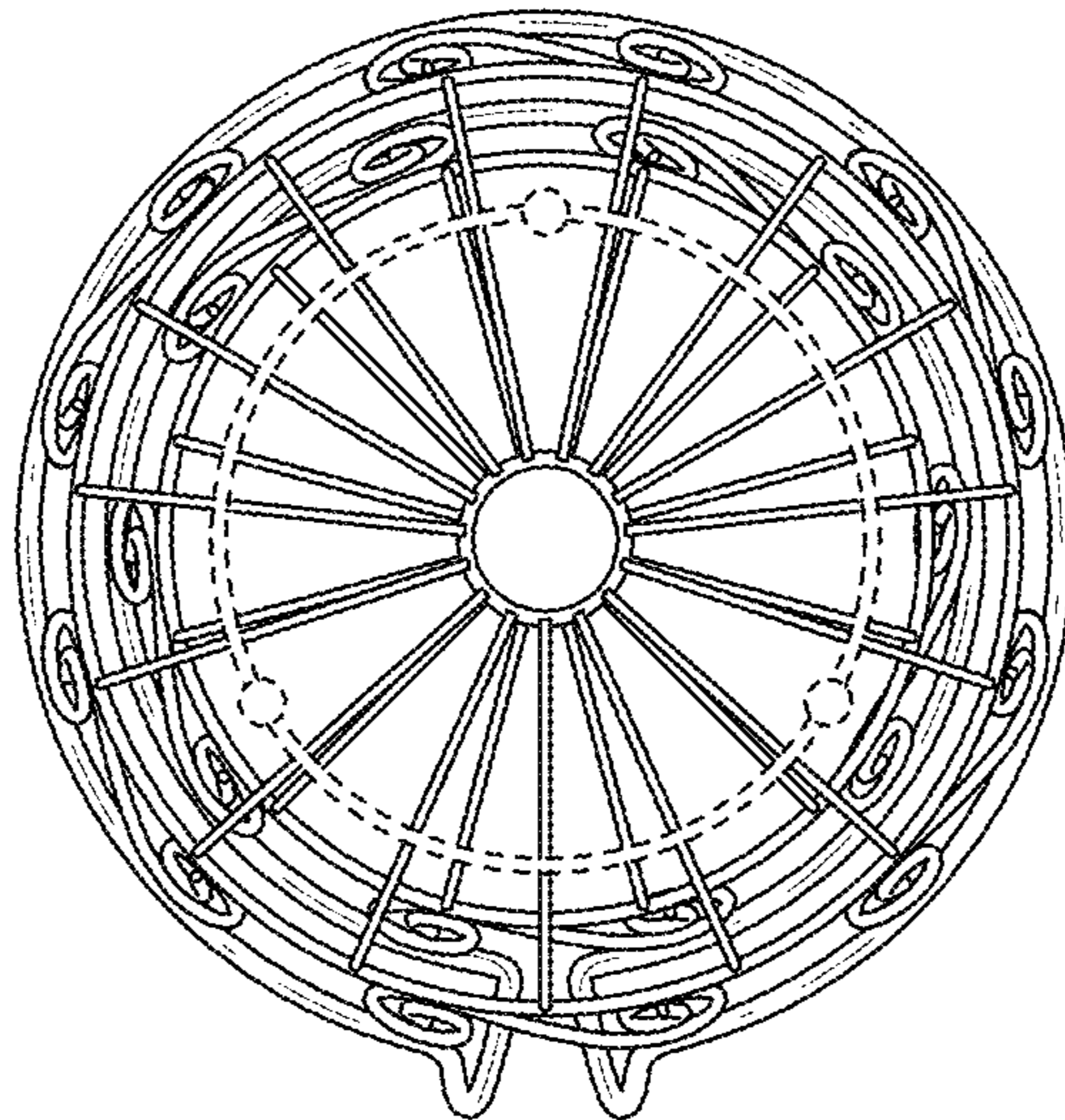
