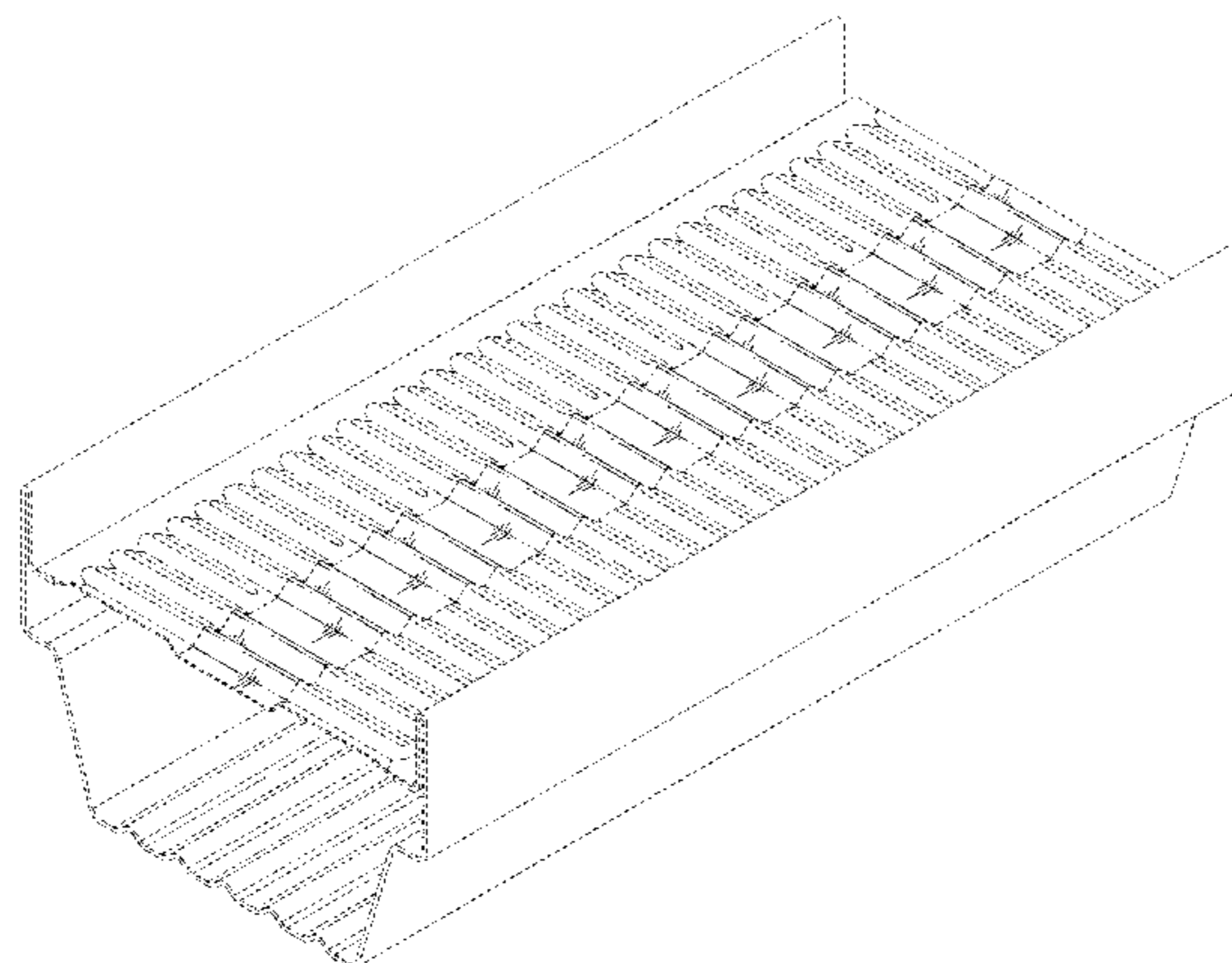
(57) **CLAIM**

We claim the ornamental design for a spacer for a multi-pane glazing unit, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a section of a spacer for a multi-pane glazing unit according to another embodiment of our design.
FIG. 2 is a top plan view thereof.
FIG. 3 is a cross-sectional view thereof, taken along lines 3-3 in FIG. 2.
FIG. 4 is a cross-sectional view thereof, taken along lines 4-4 in FIG. 2.
FIG. 5 is a bottom plan view thereof;
FIG. 6 is a left-side elevational view thereof
FIG. 7 is a right-side elevational view thereof; and,
FIG. 8 is a cross-sectional view thereof, taken along lines 3-3 in FIG. 2, and wherein said spacer is shown in its environment during use, incorporated into a multi-pane glazing unit. Where included, broken lines showing environment or structure are for illustrative purposes only and form no part of the claimed design.

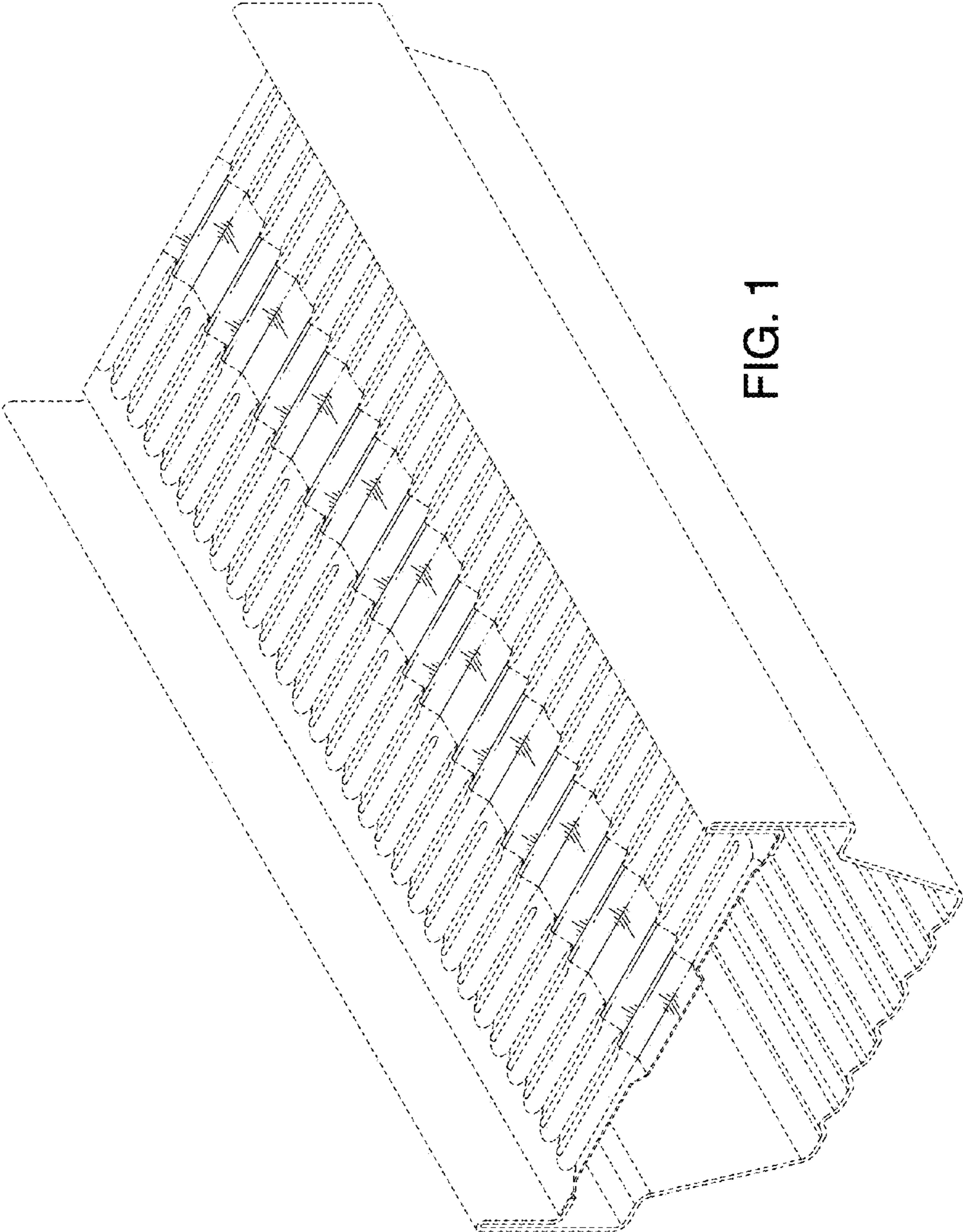

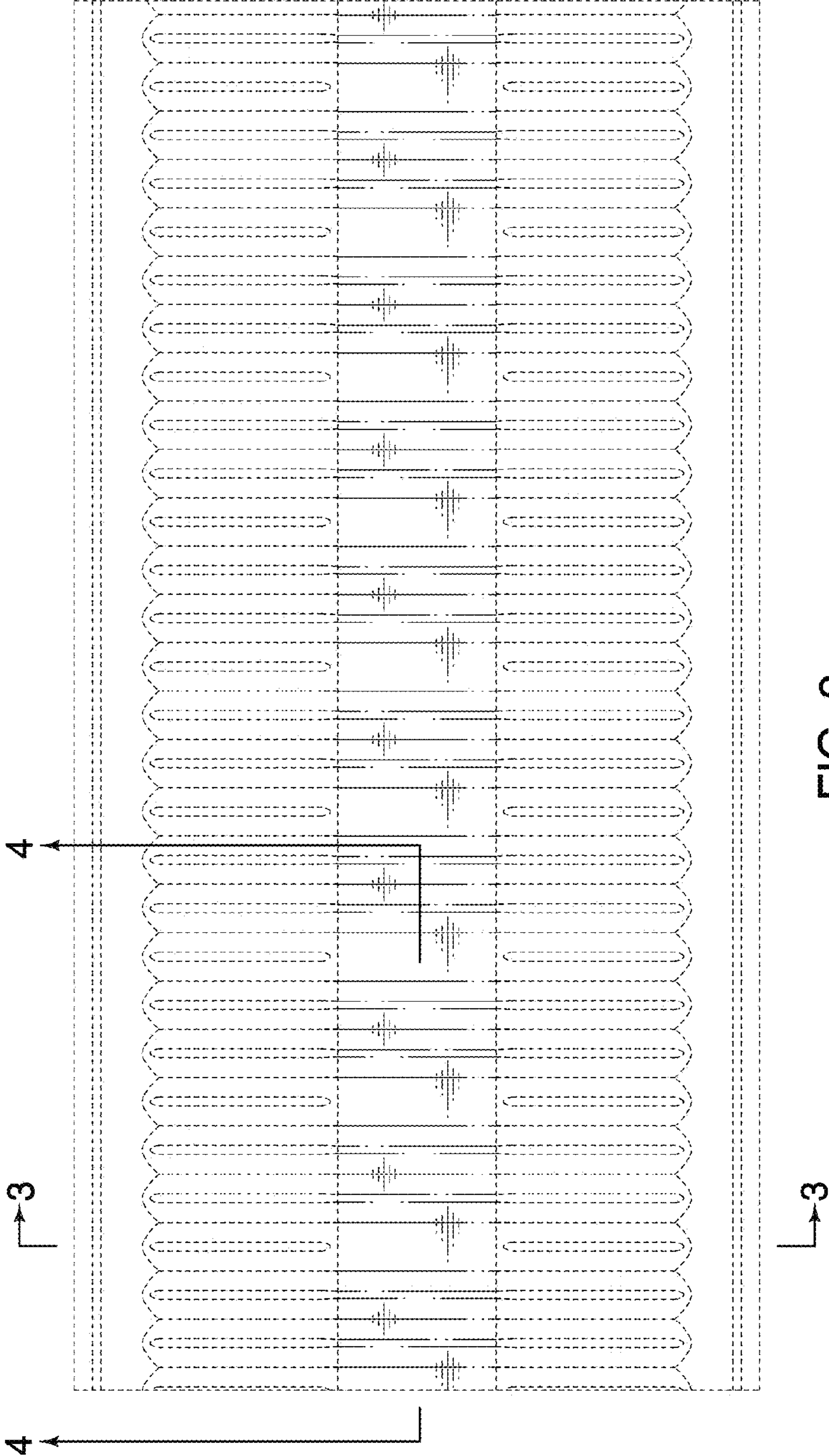

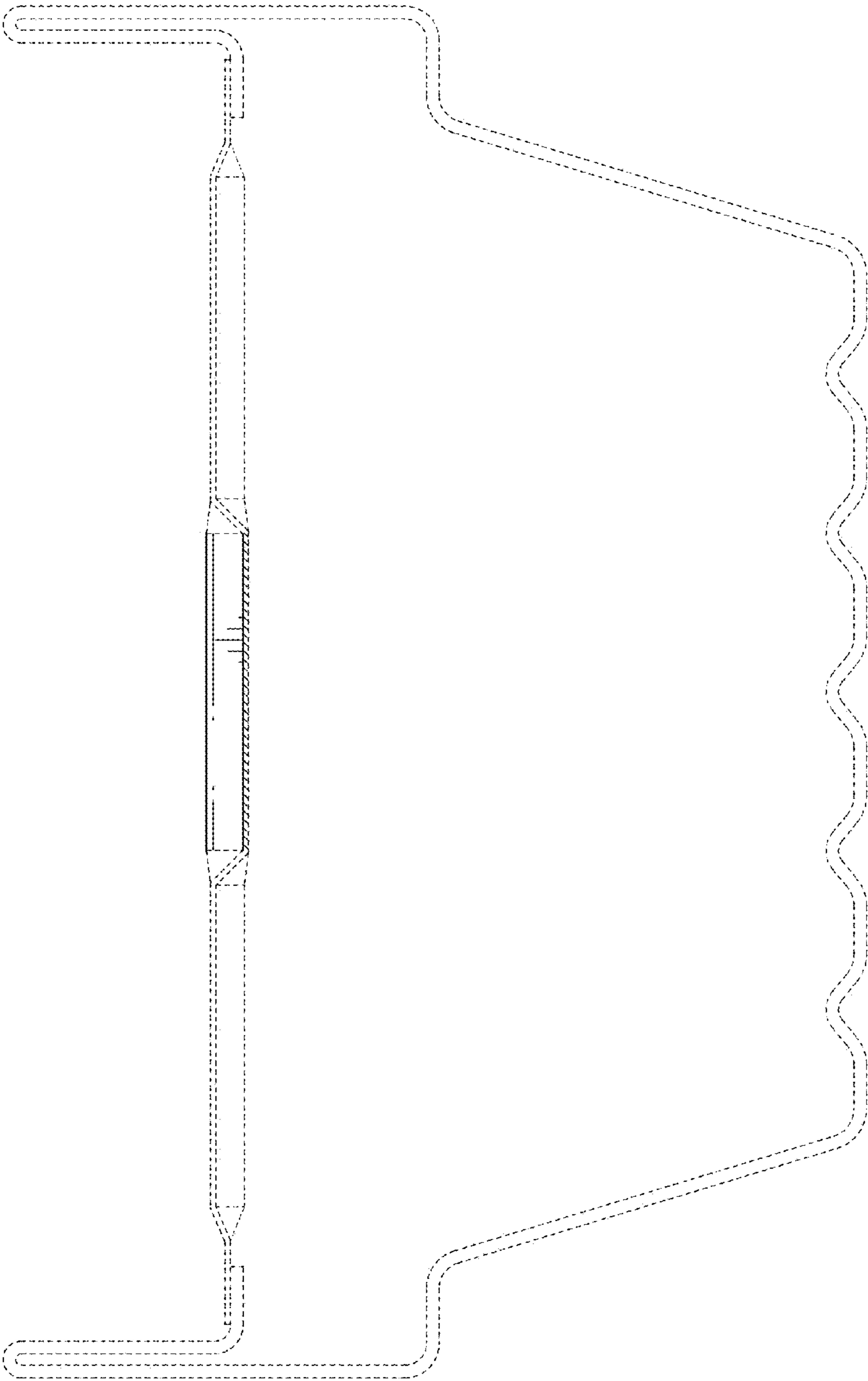

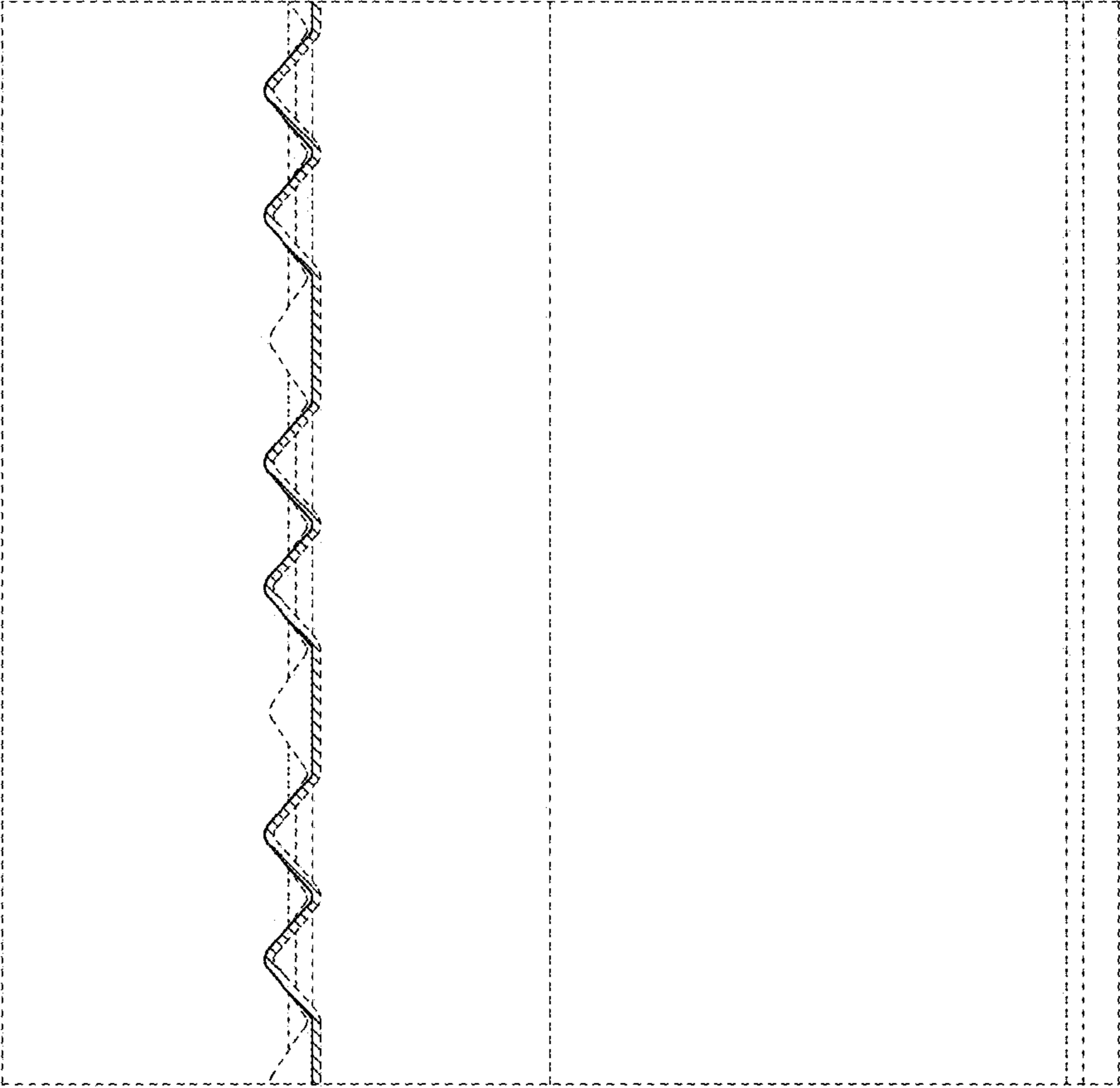

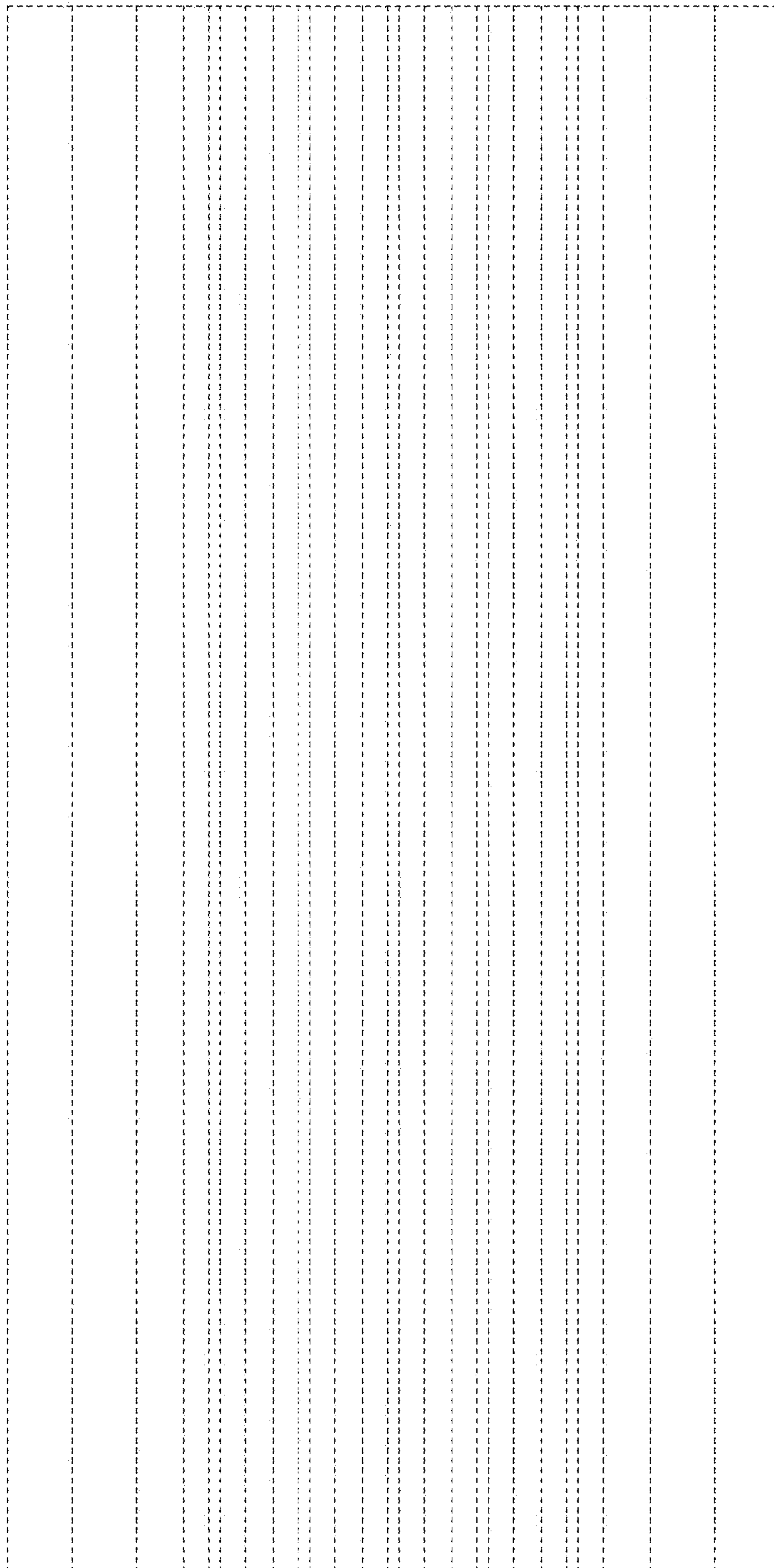

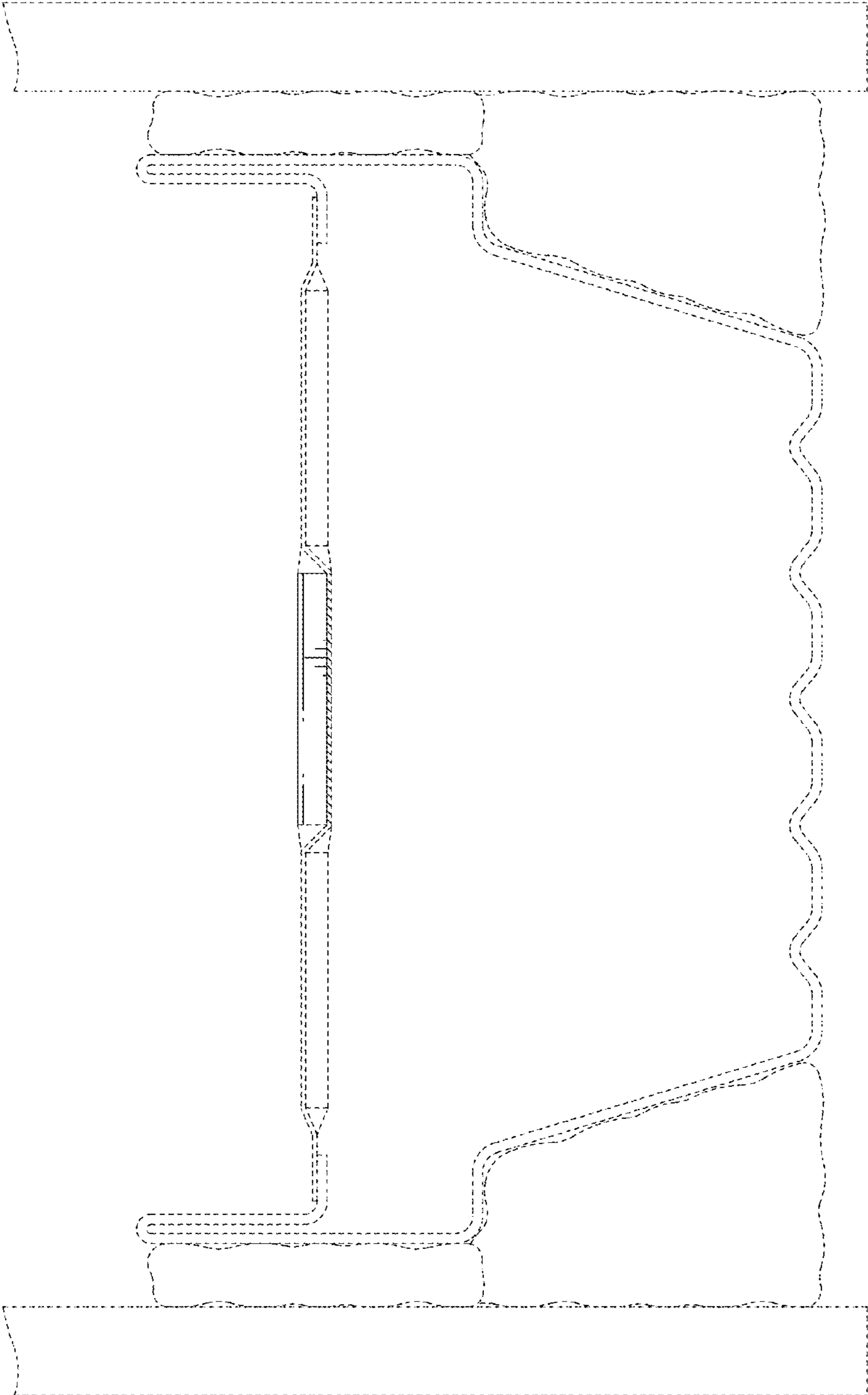
