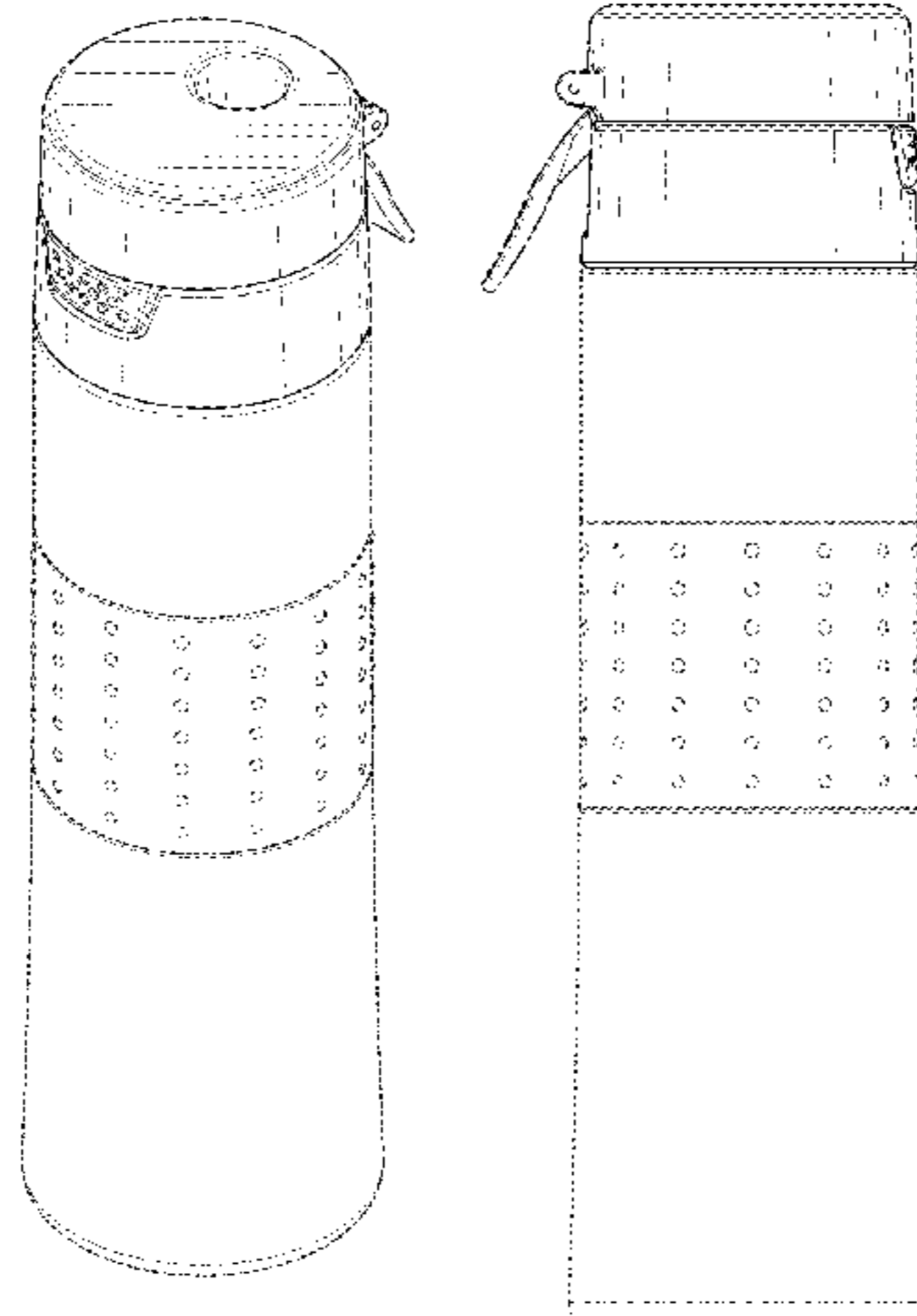
The ornamental design for a cap with sprayer and spout cover, as shown and described.

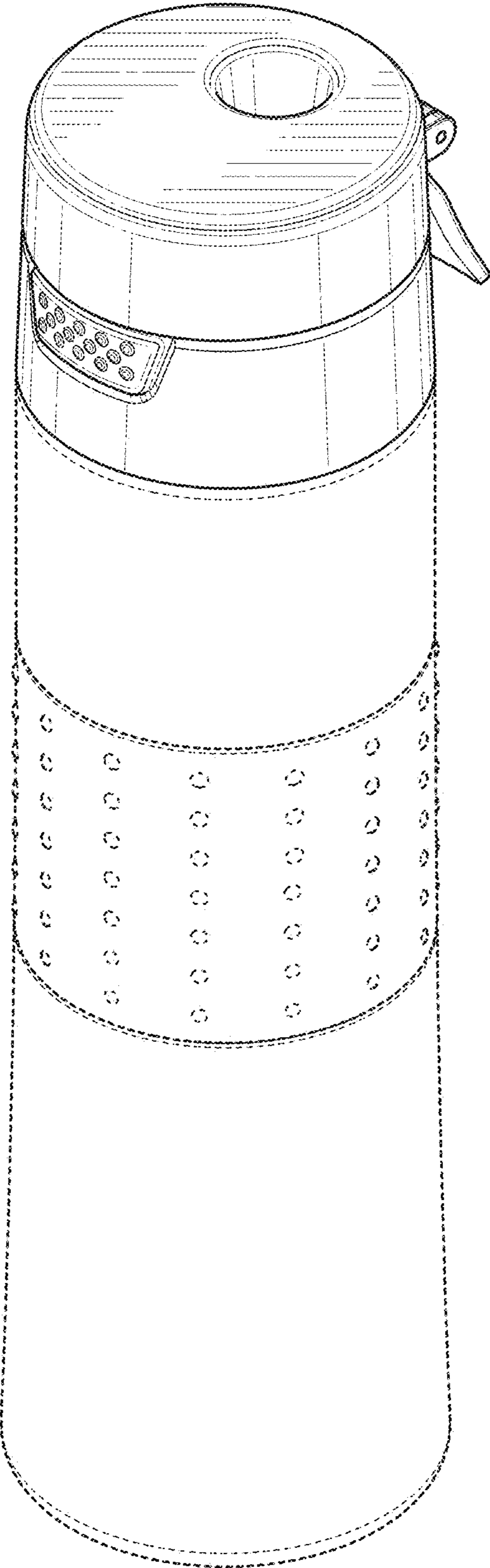

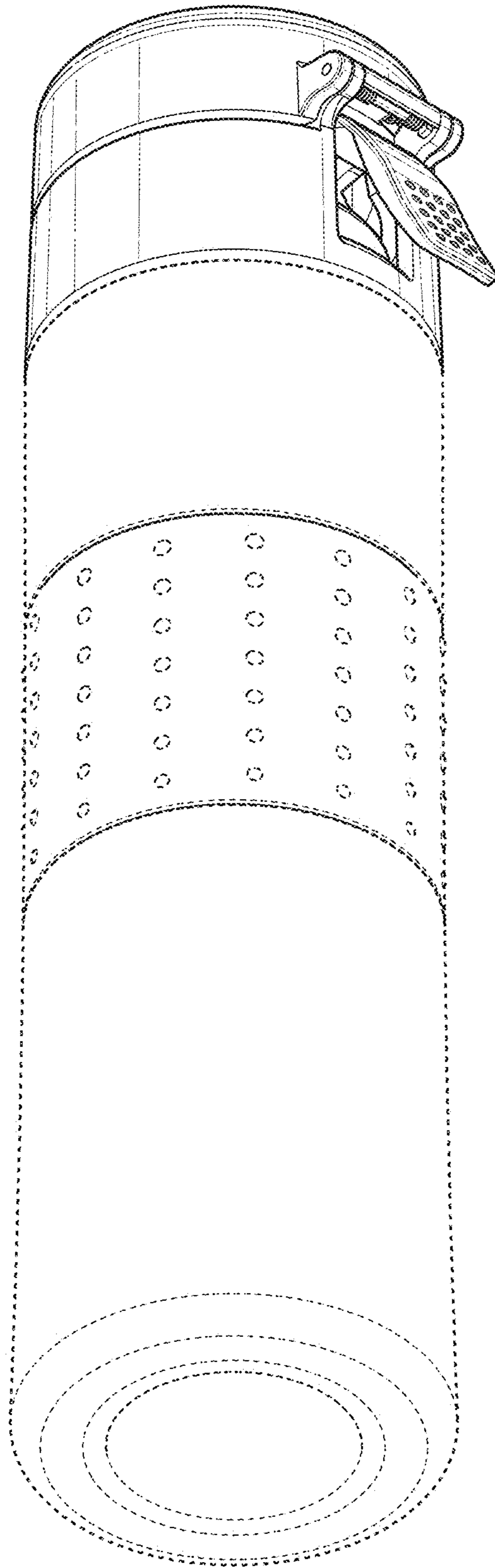

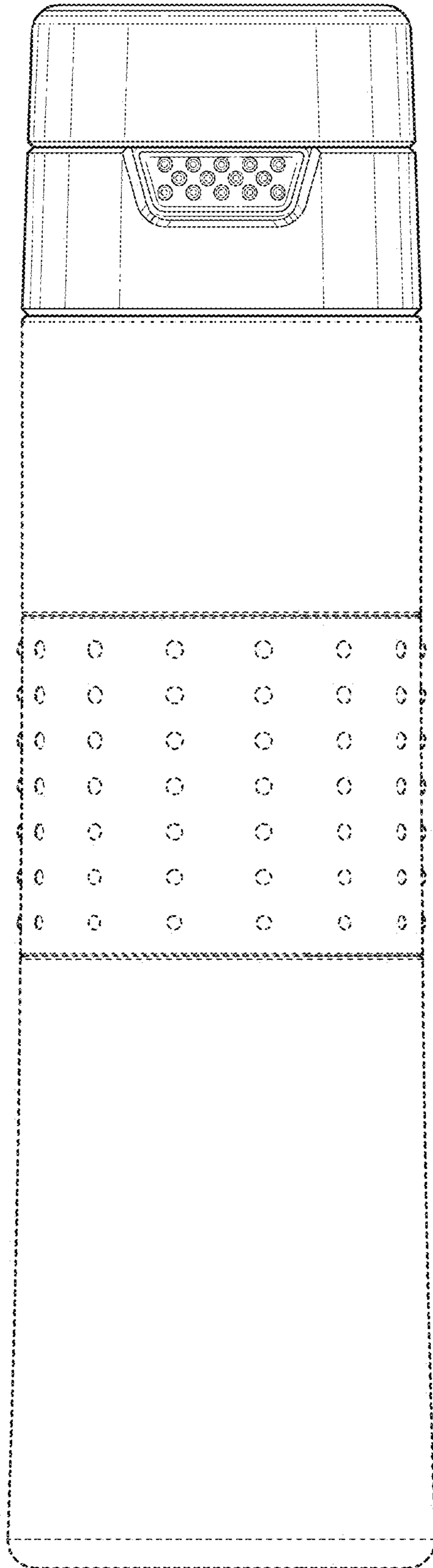

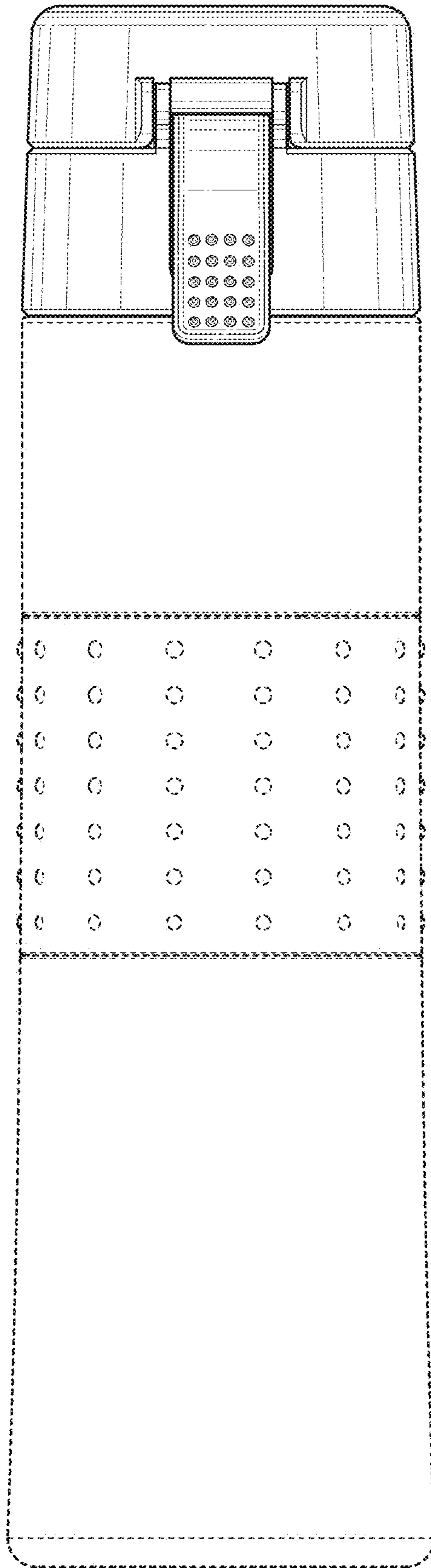

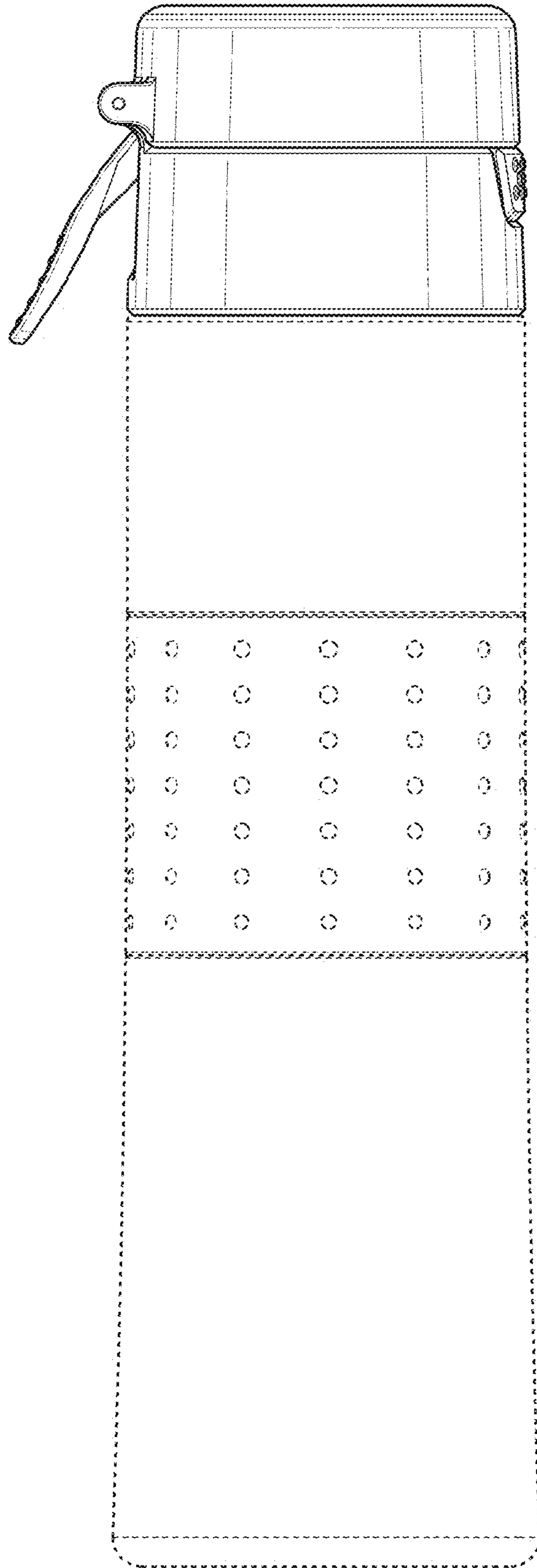

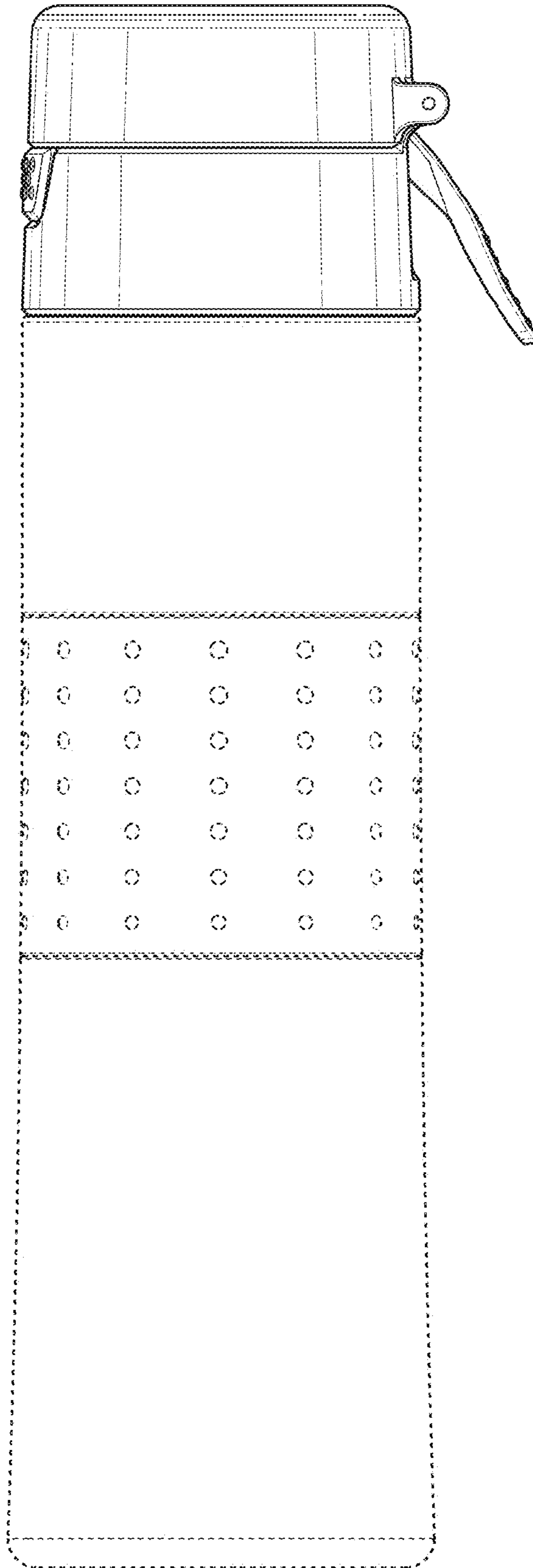

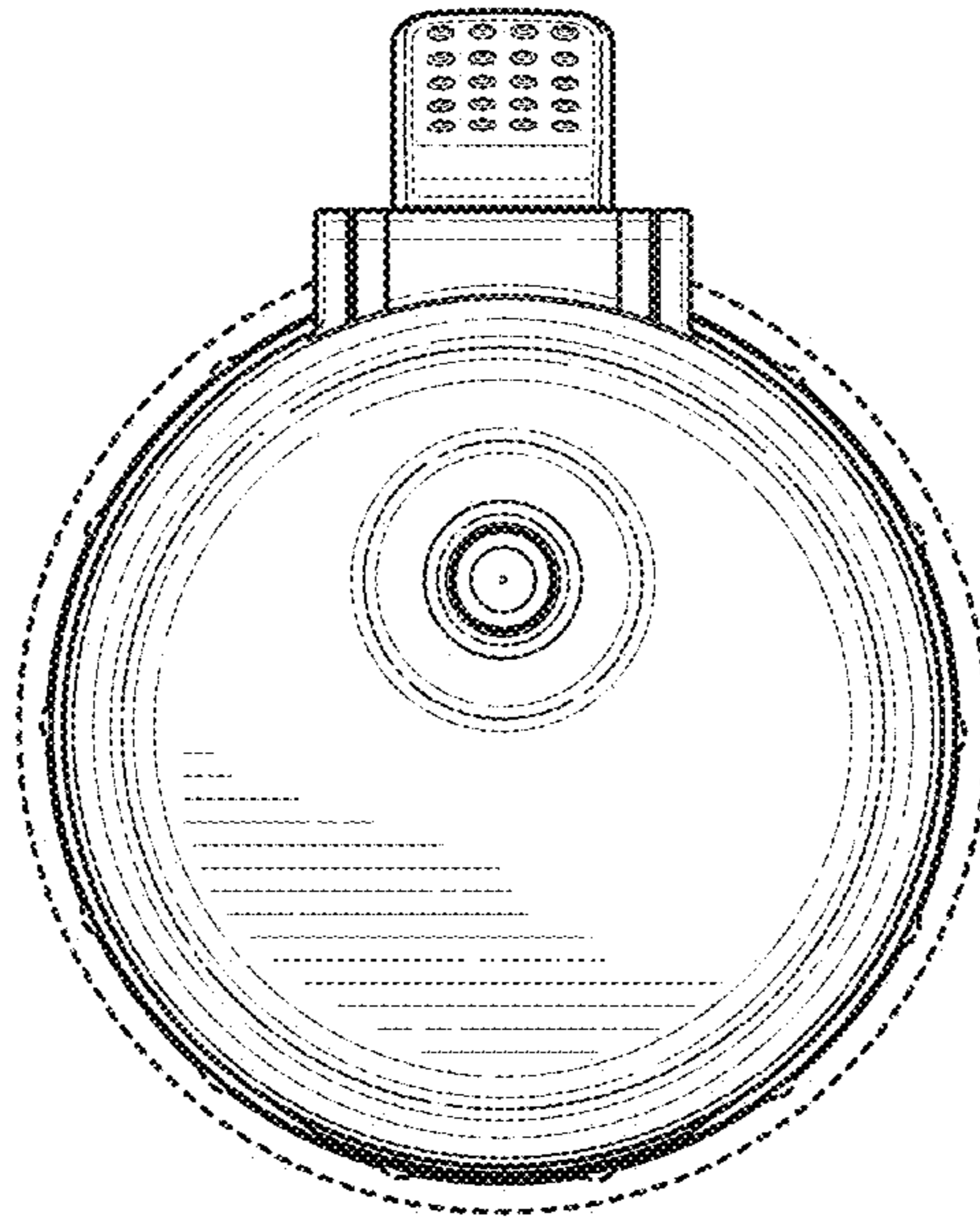

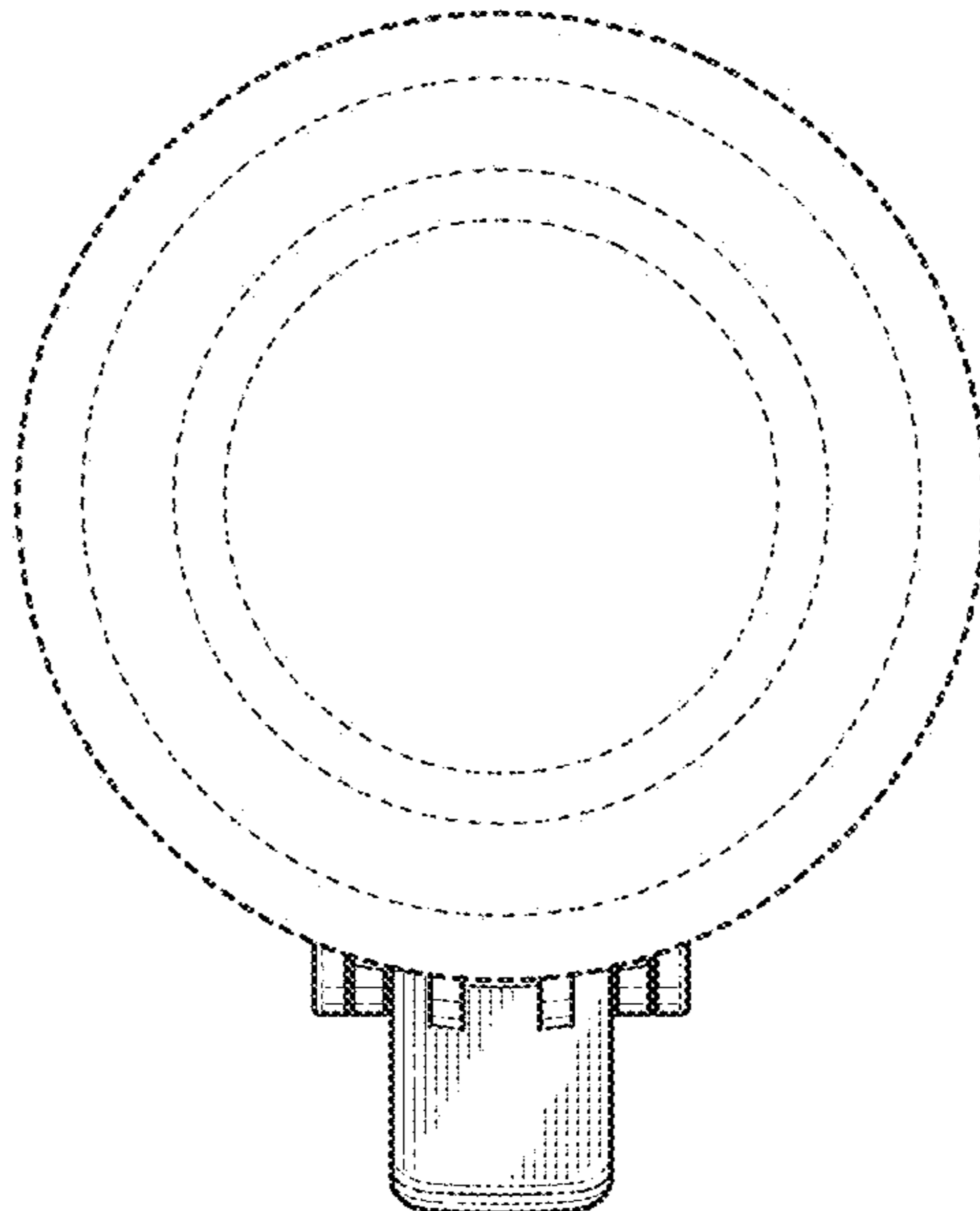
