FIG. 1 is a front, top and right side perspective view of a bottle with cap and transparent lower portion showing the new design.

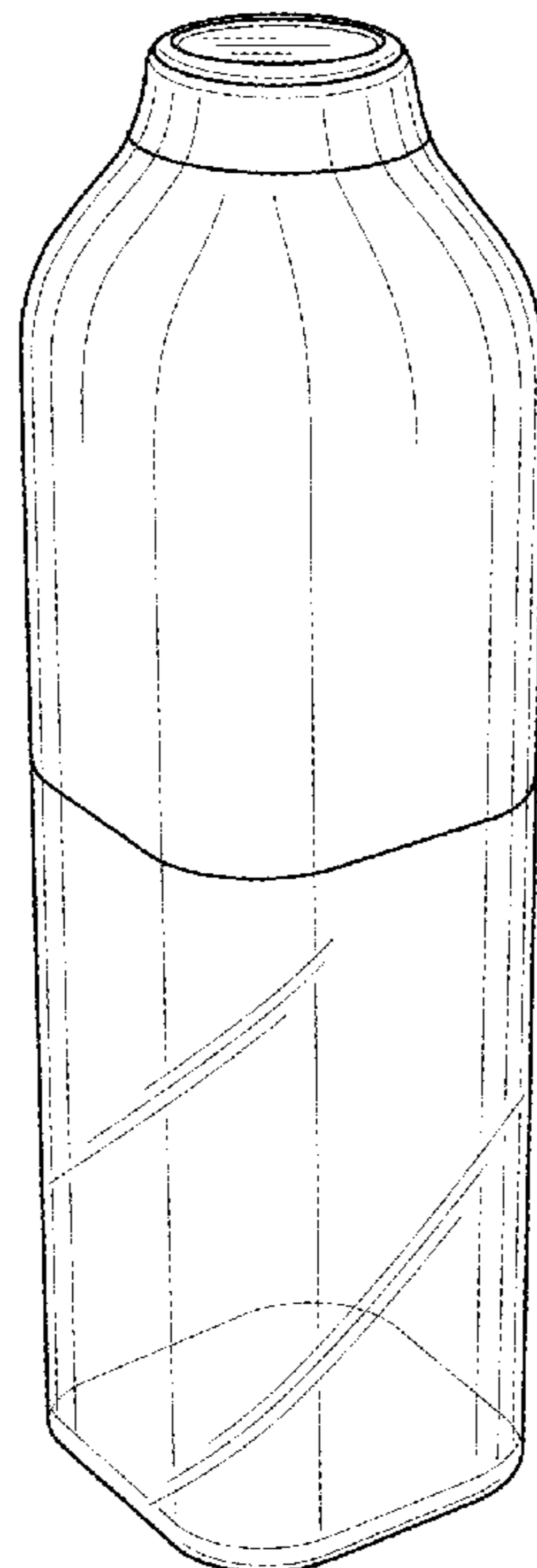
FIG. 2 is a front view thereof, the back, right side and left views being a mirror image thereof; and,

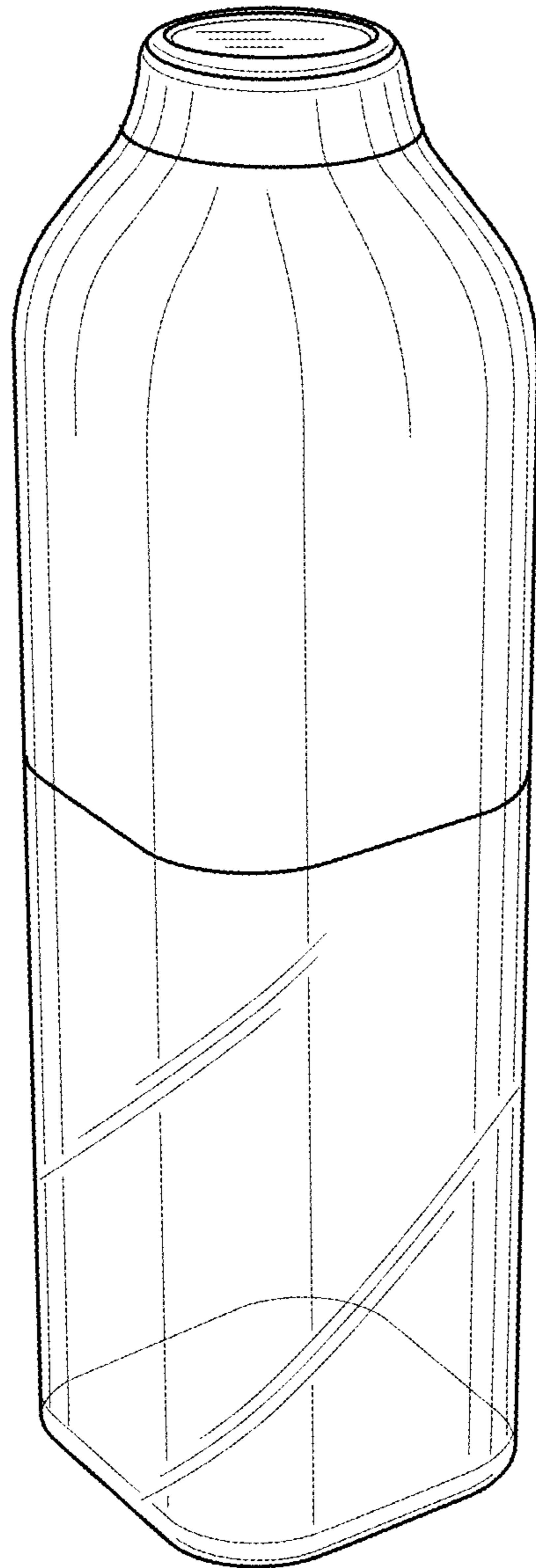

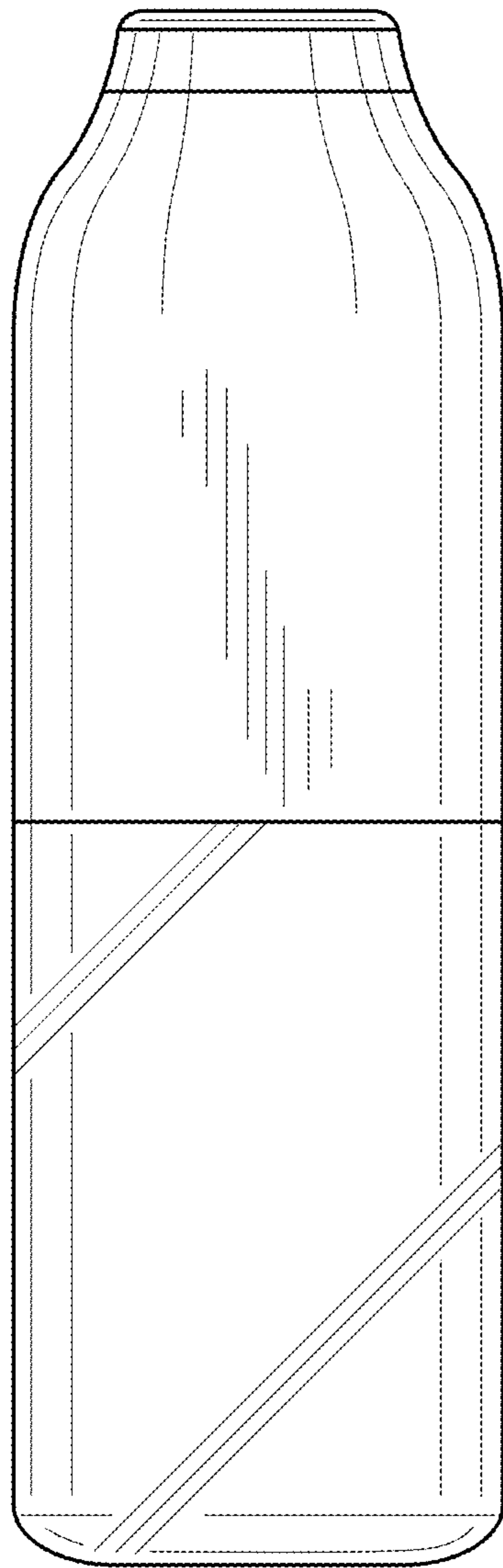

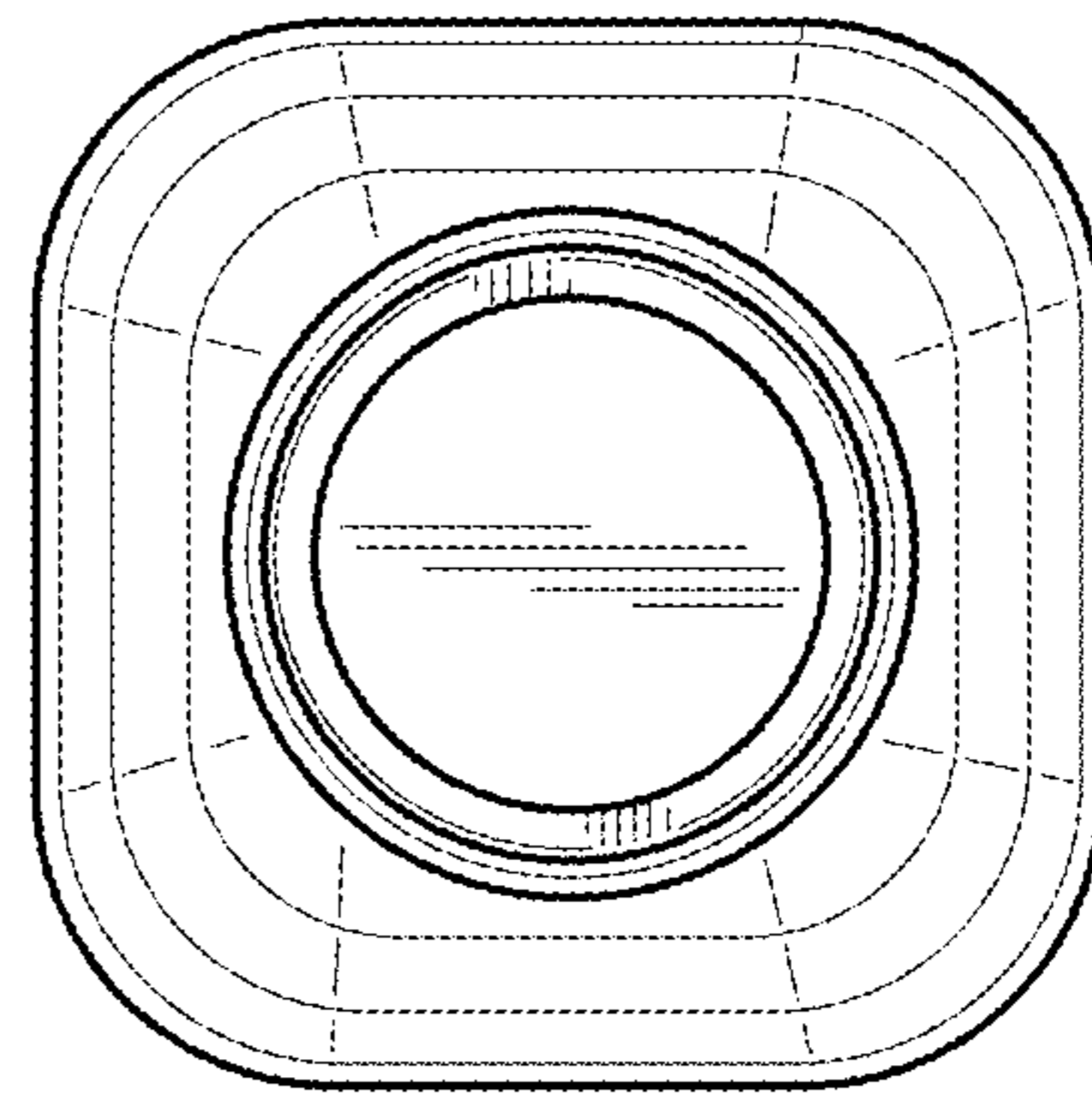
