DESCRIPTION

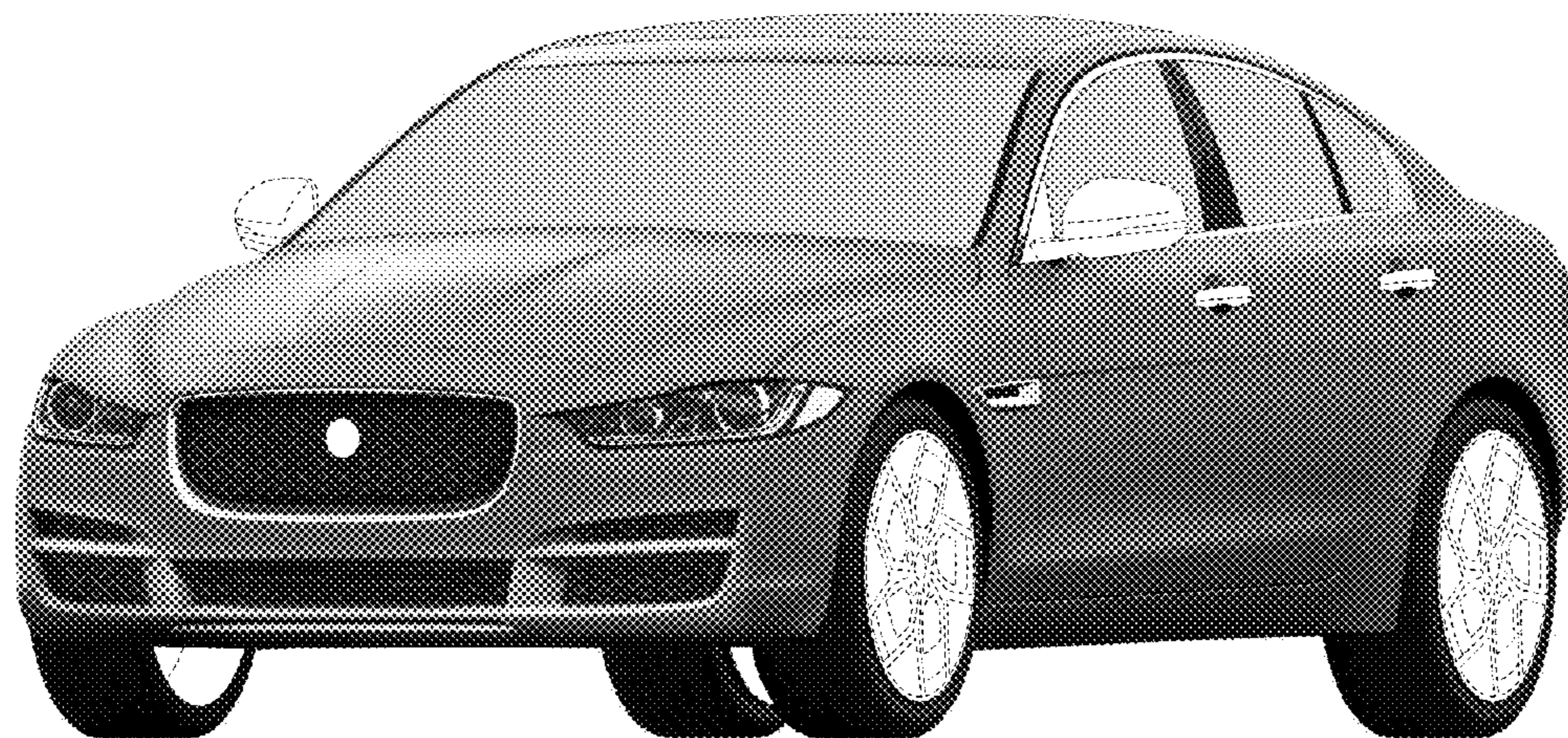

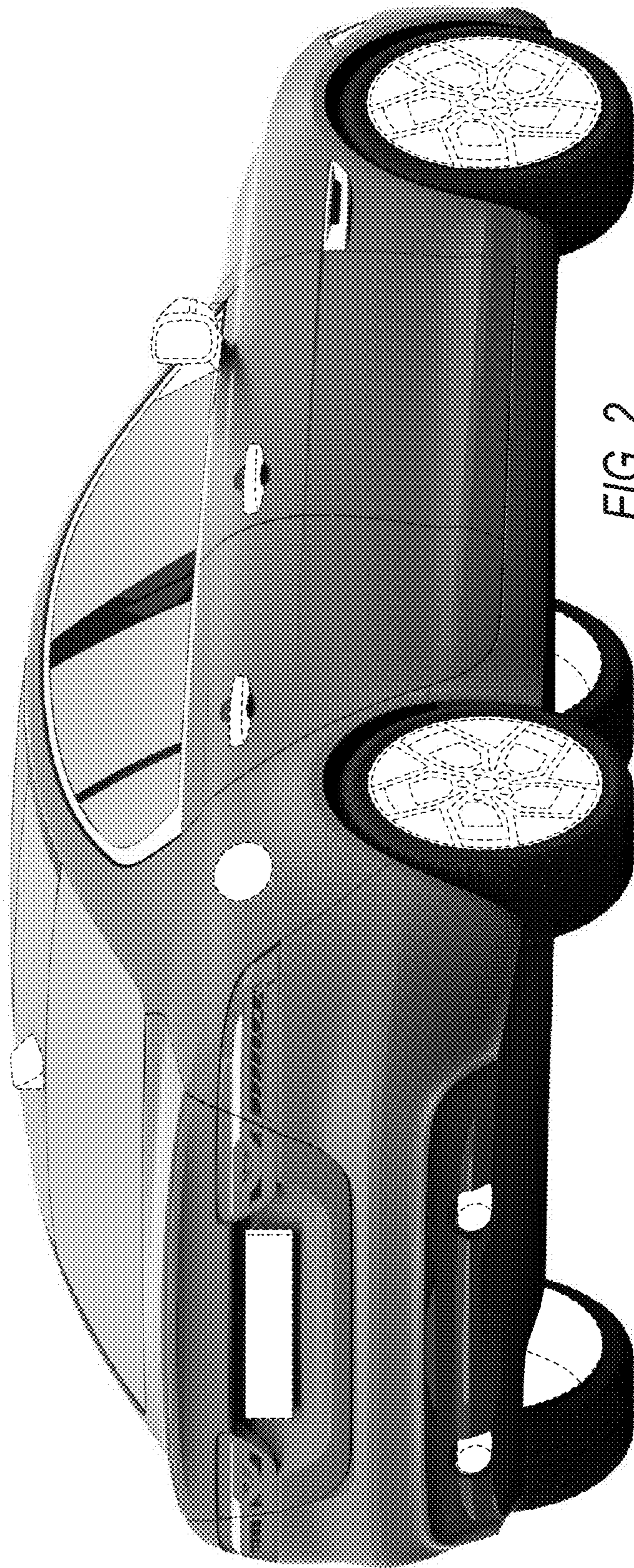

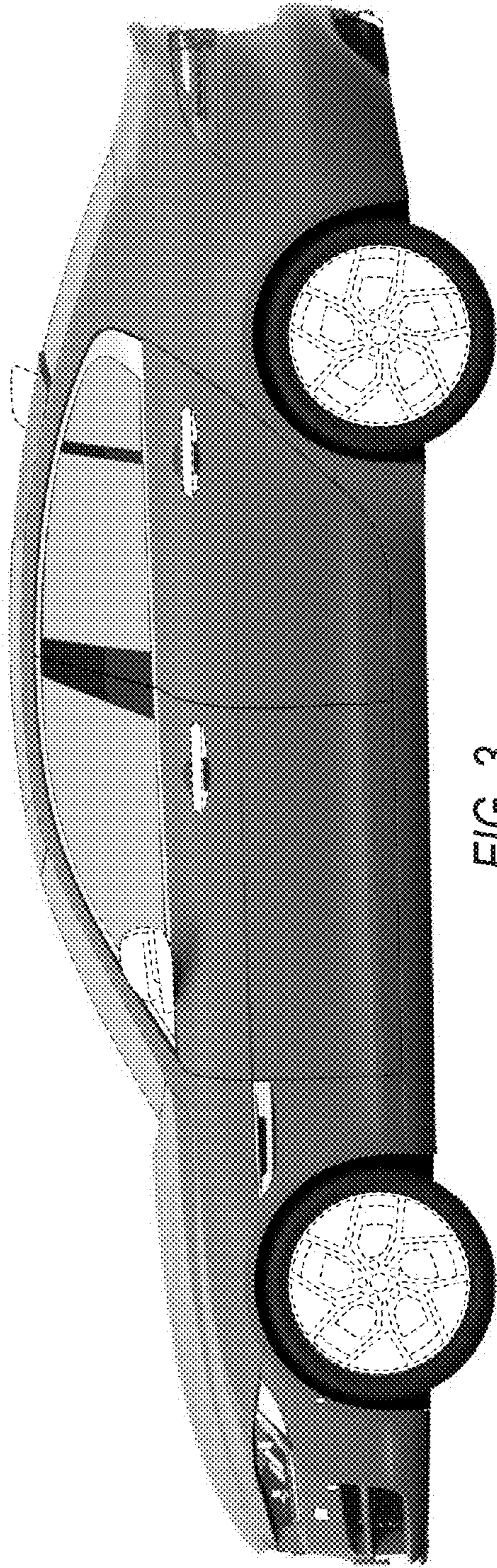

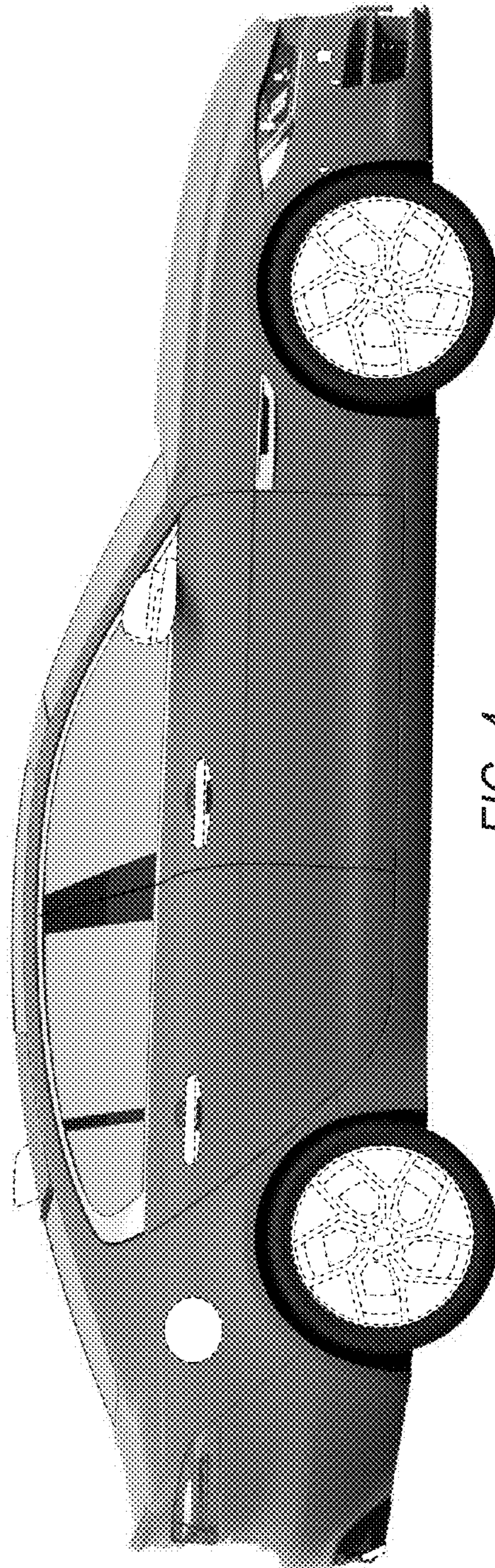

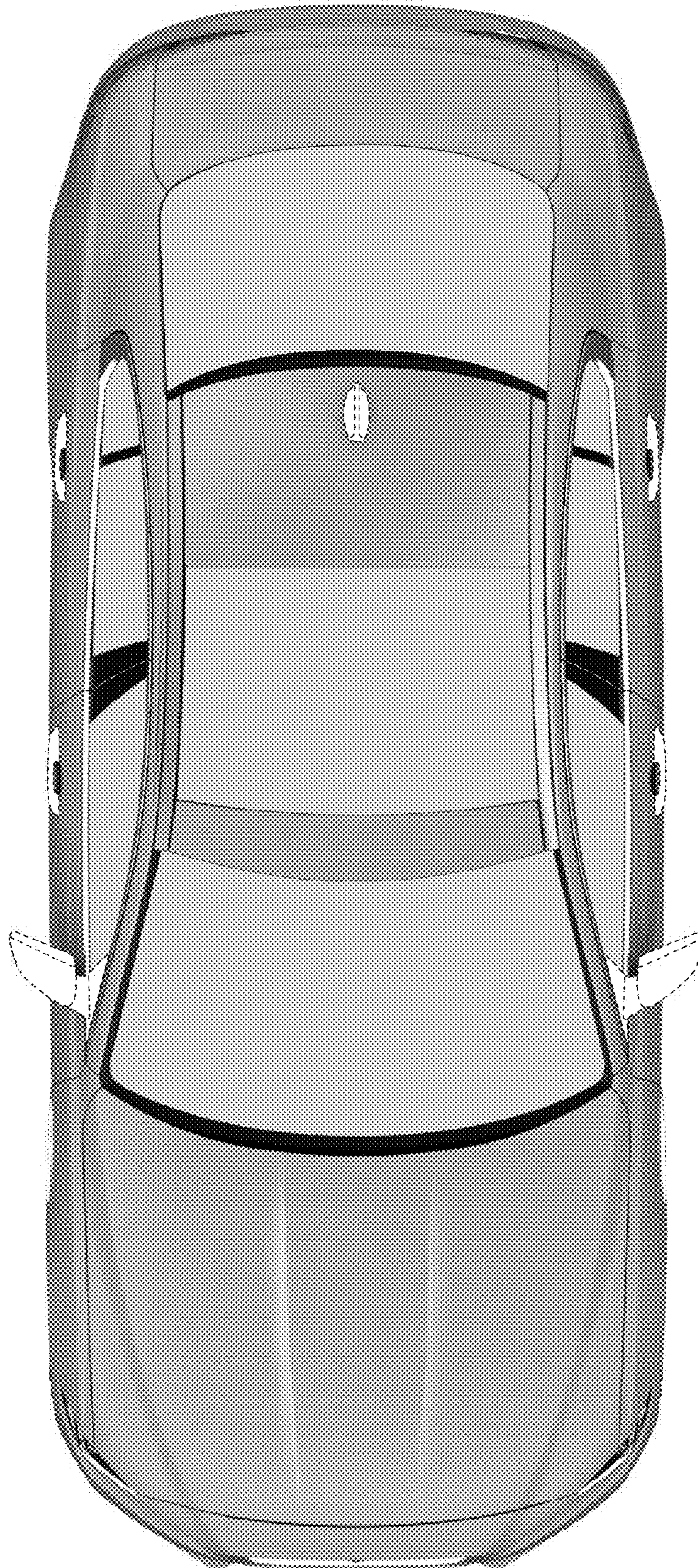

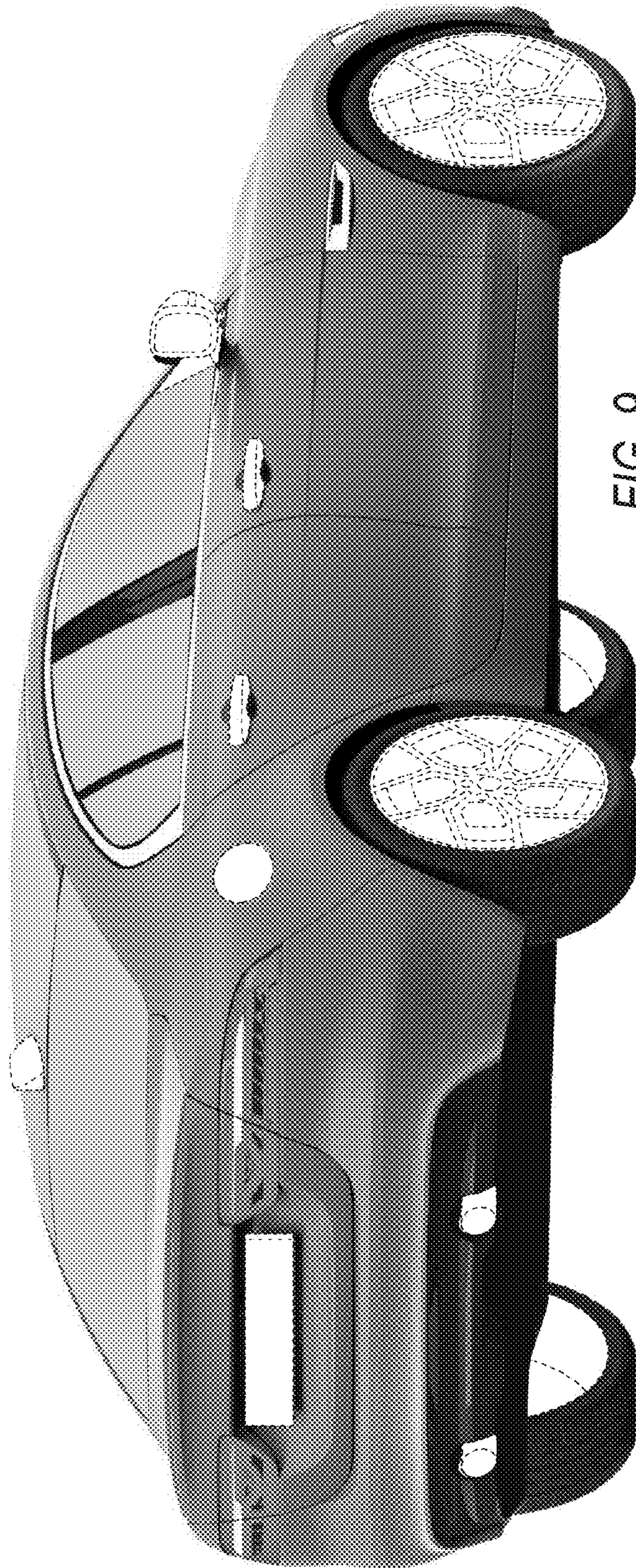

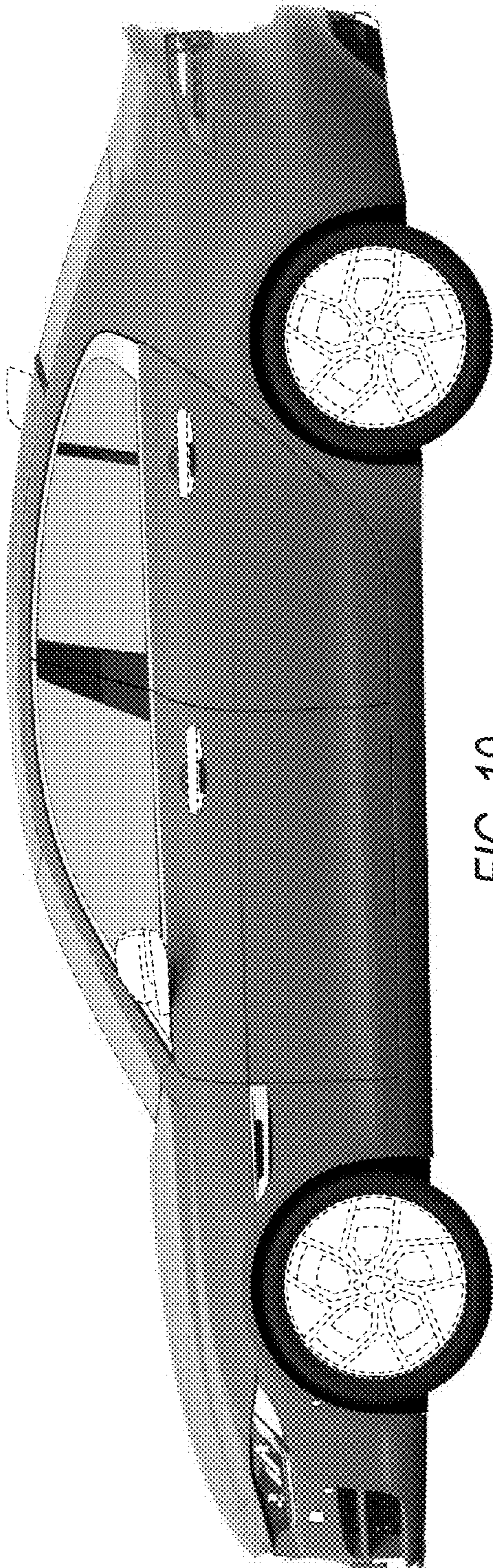

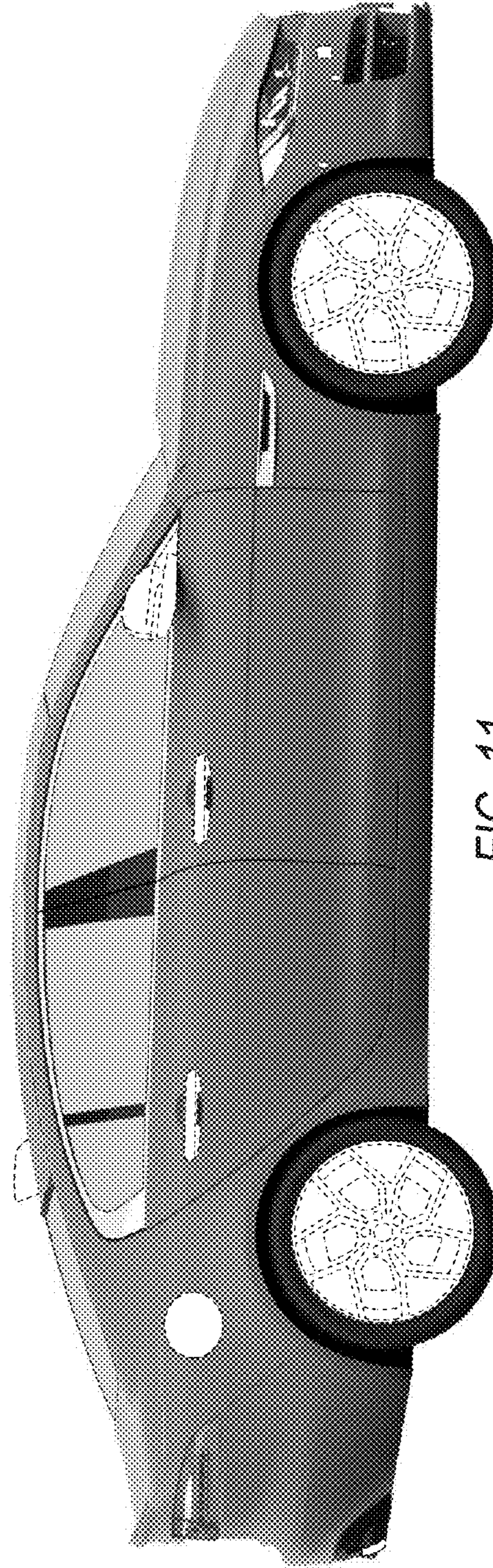

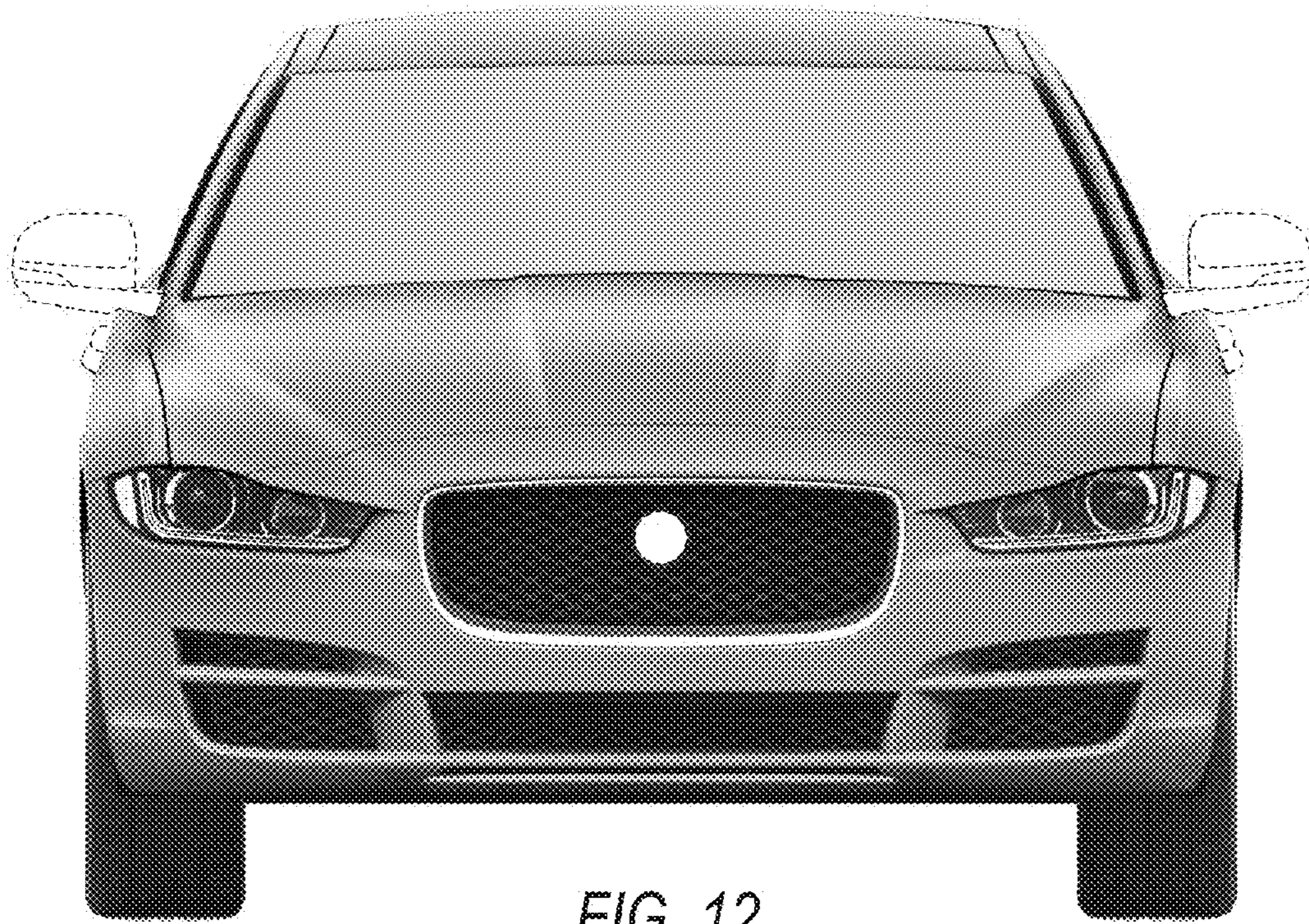

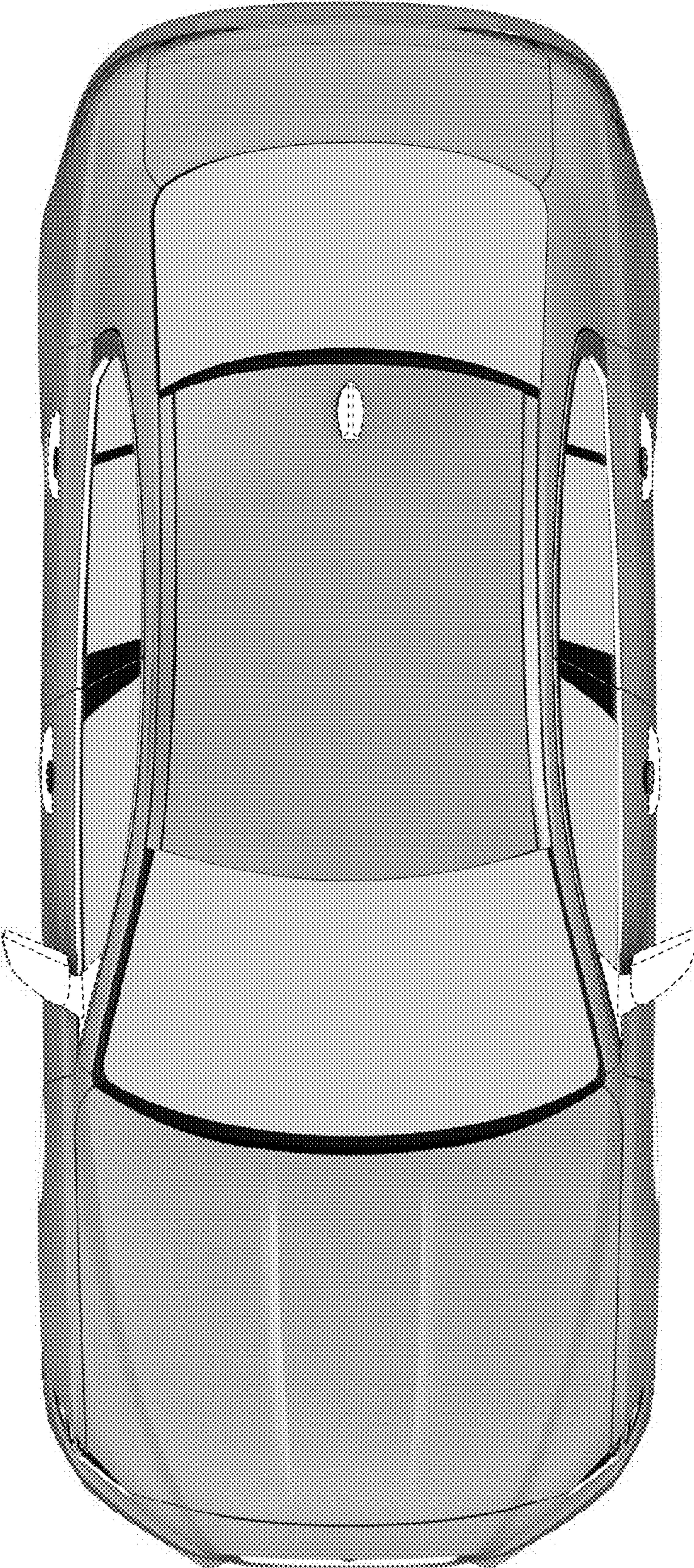
