(57) **CLAIM**

The ornamental design for a mattress for a patient repositioning system, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a mattress for a patient repositioning system according to the present invention.

FIG. 2 is a front view of the mattress shown in FIG. 1.

FIG. 3 is a right side view thereof; the left side view being a mirror image thereof.

FIG. 4 is a rear view thereof.

FIG. 5 is a top view thereof.

FIG. 6 is a bottom view thereof.

FIG. 7 is another perspective view of the mattress shown in FIGS. 1-6, but shown in an alternate position (head end portion folded).

FIG. 8 is a front view of the mattress shown in FIG. 7, in the alternative position.

FIG. 9 is a right side view thereof; the left side view being a mirror image thereof.

FIG. 10 is a rear view thereof.

FIG. 11 is a top view thereof.

FIG. 12 is a bottom view thereof.

FIG. 13 is a perspective view of a second alternative embodiment of a mattress for a patient repositioning system according to the present invention.

FIG. 14 is a front view of the mattress shown in FIG. 13.

FIG. 15 is a right side view thereof; the left side view being a mirror image thereof.

FIG. 16 is a rear view thereof.

FIG. 17 is a top view thereof.

FIG. 18 is a bottom view thereof.

FIG. 19 is another perspective view of the mattress shown in FIGS. 13-18, but shown in an alternate position (head end portion folded).

FIG. 20 is a front view of the mattress shown in FIG. 19, in the alternate position.

FIG. 21 is a right side view thereof; the left side view being a mirror image thereof.

FIG. 22 is a rear view thereof.

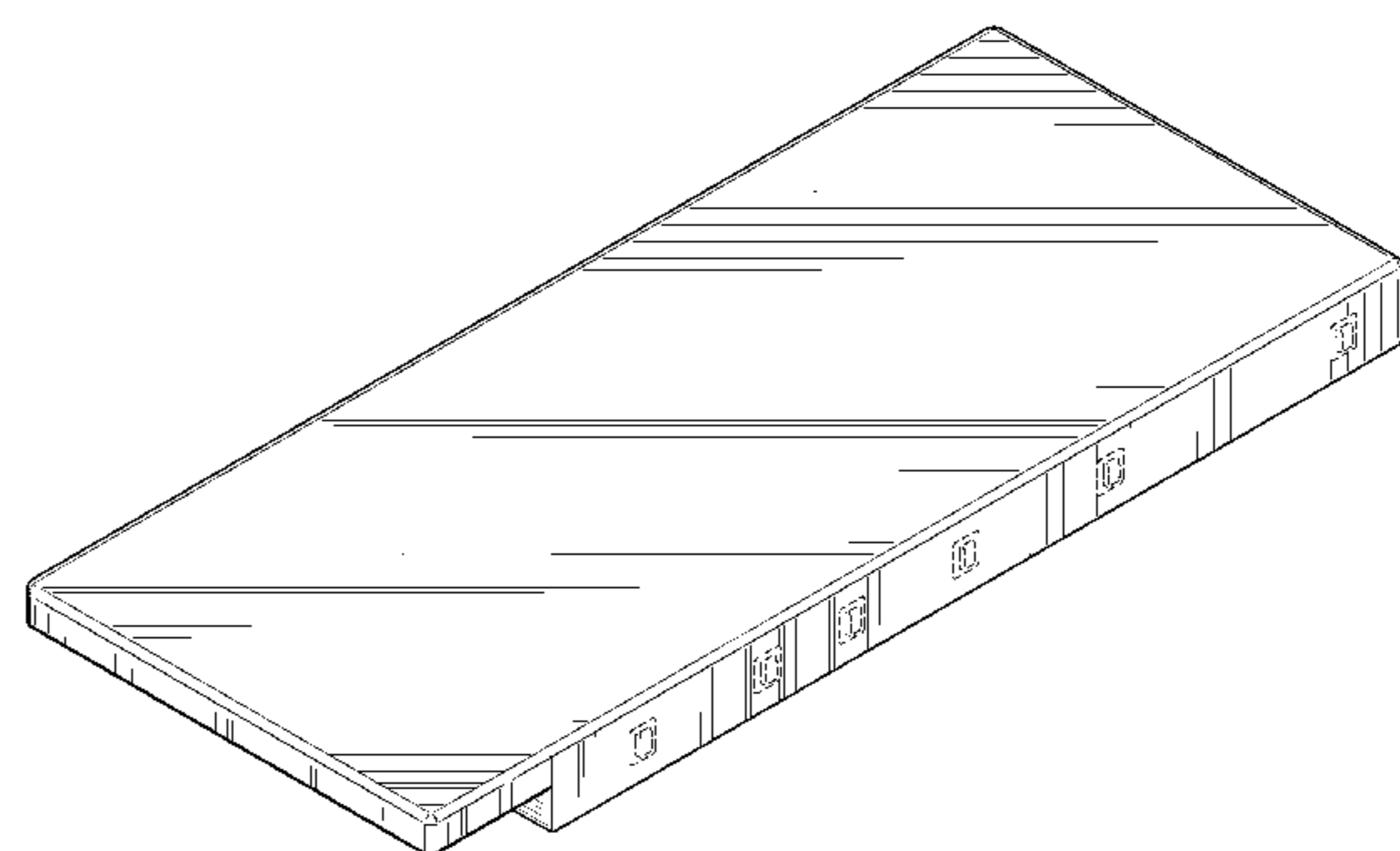
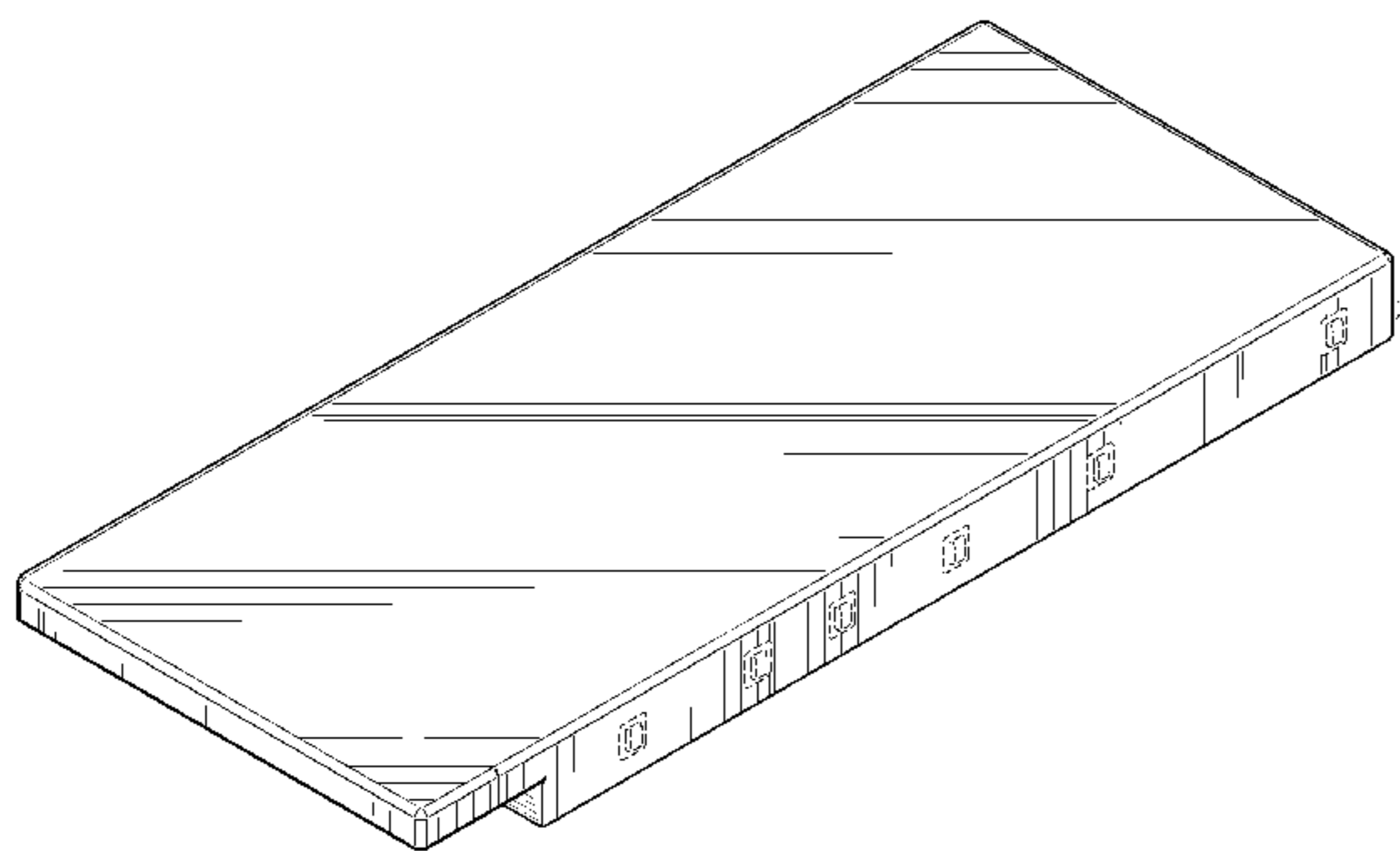
FIG. 23 is a top view thereof; and,

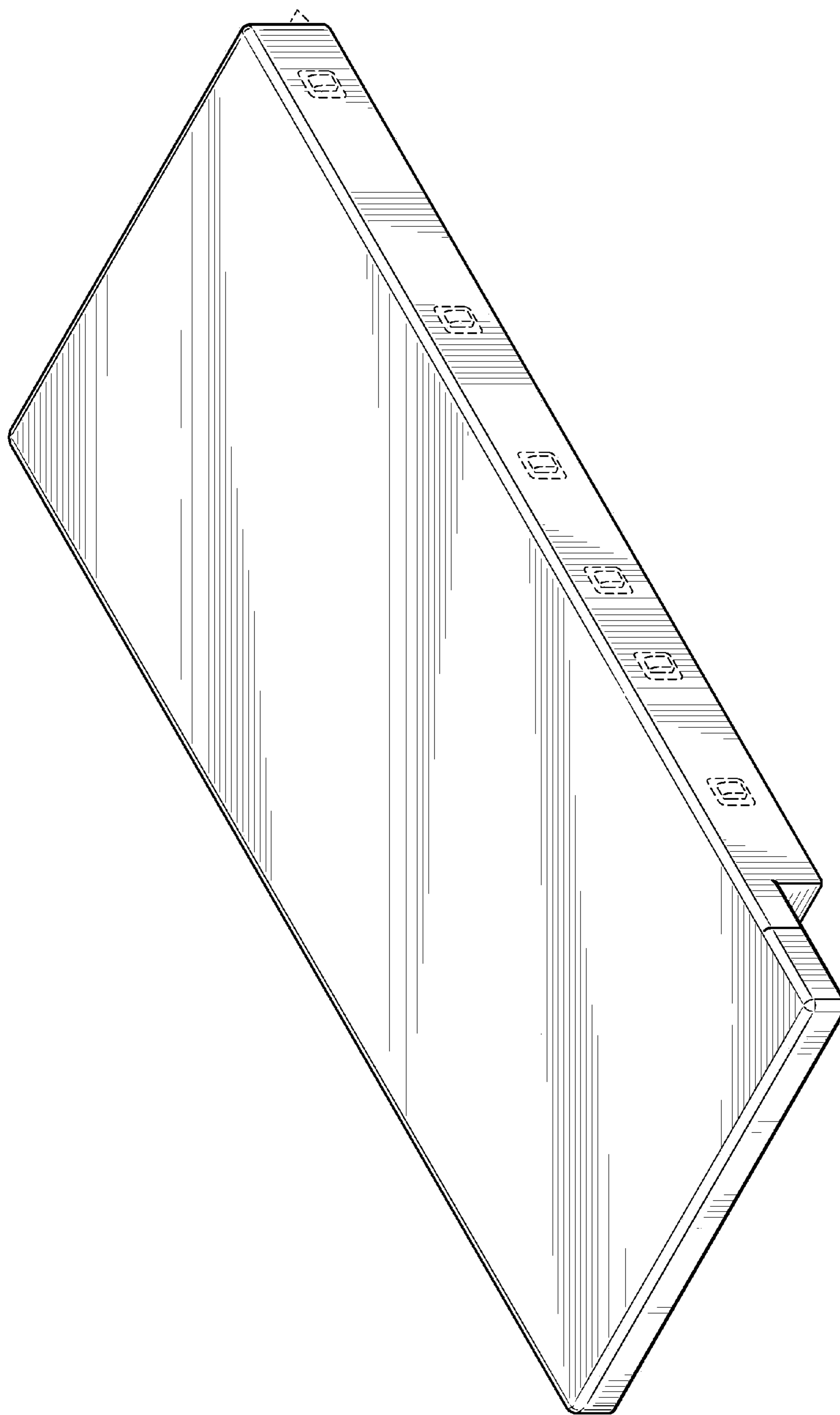

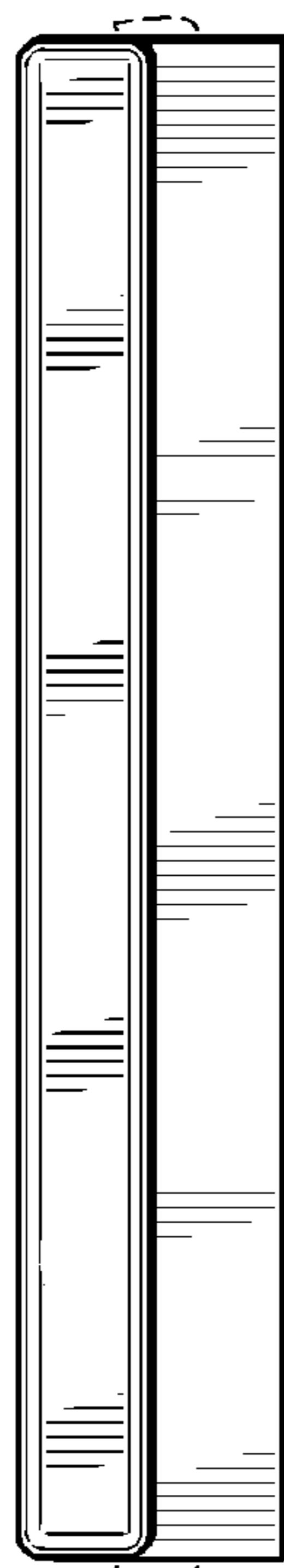

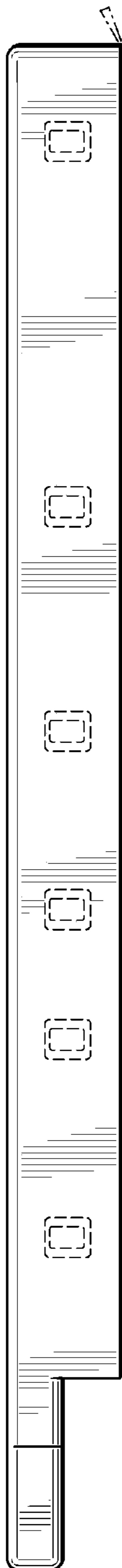

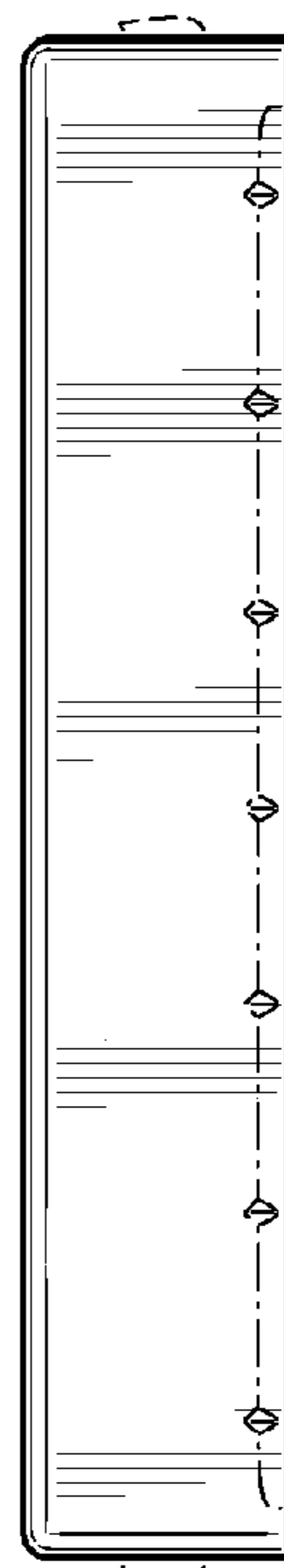

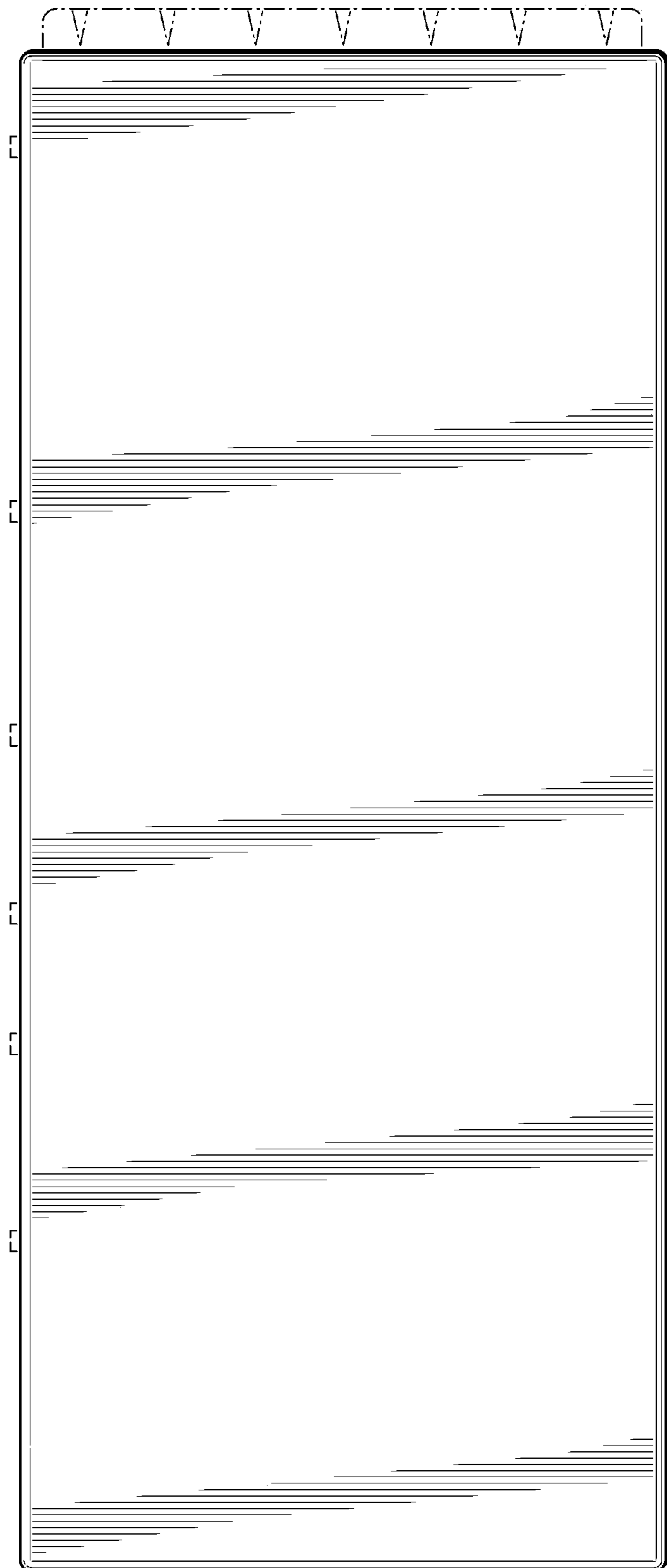

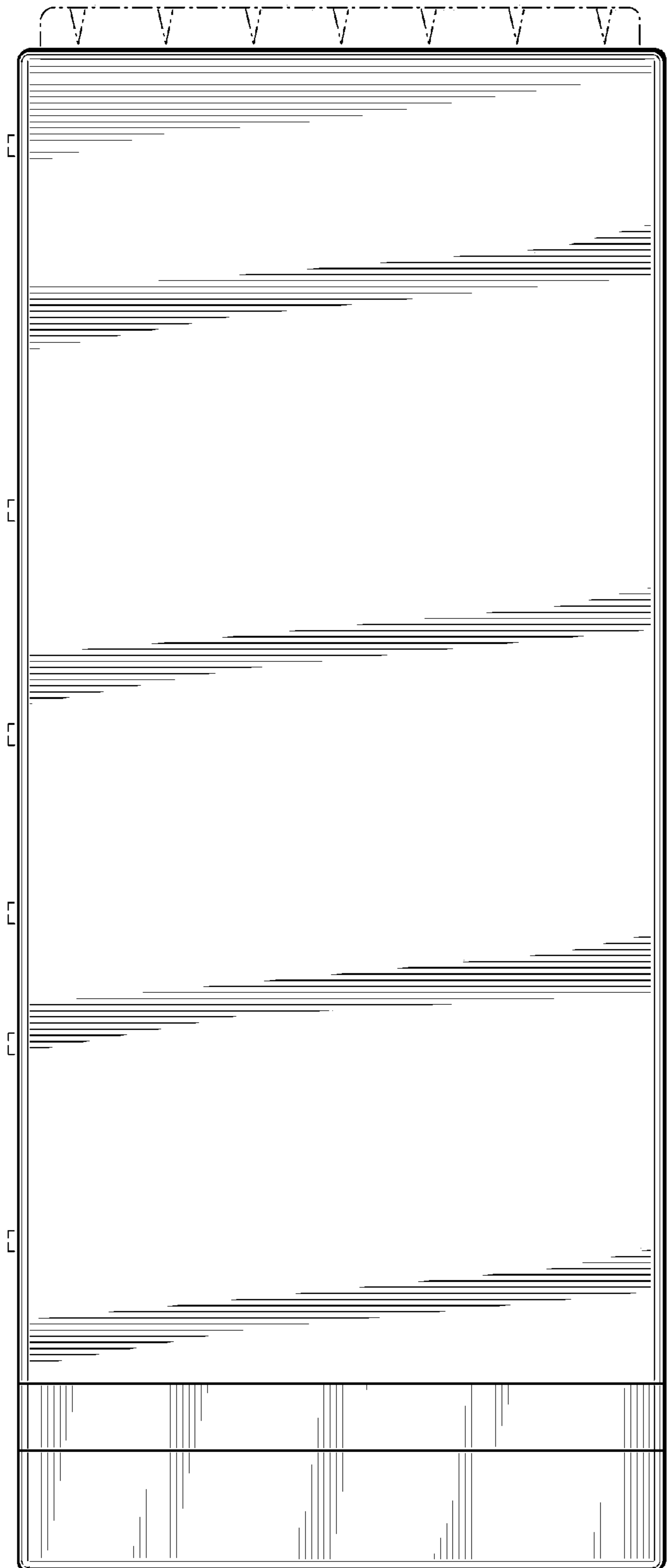

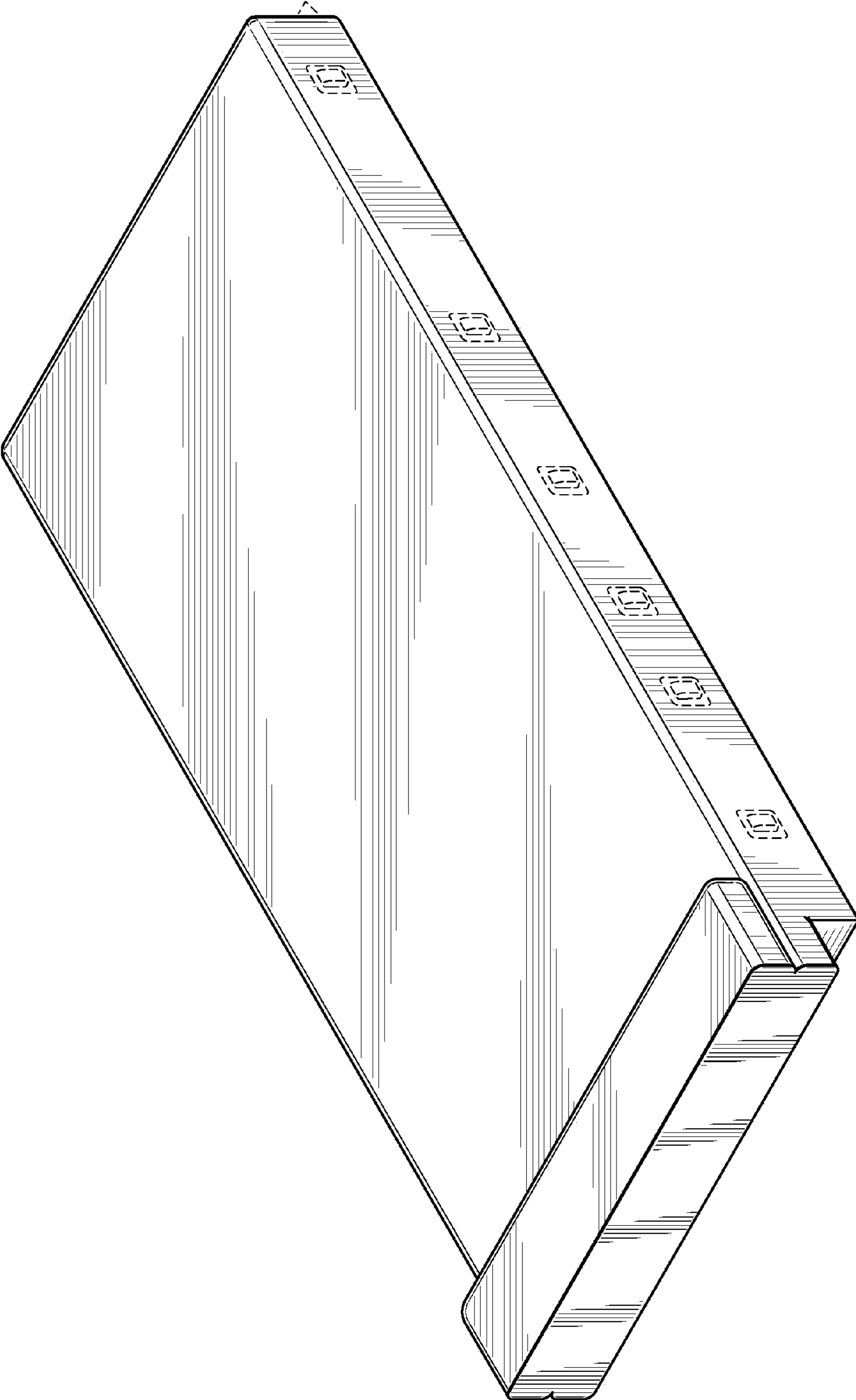

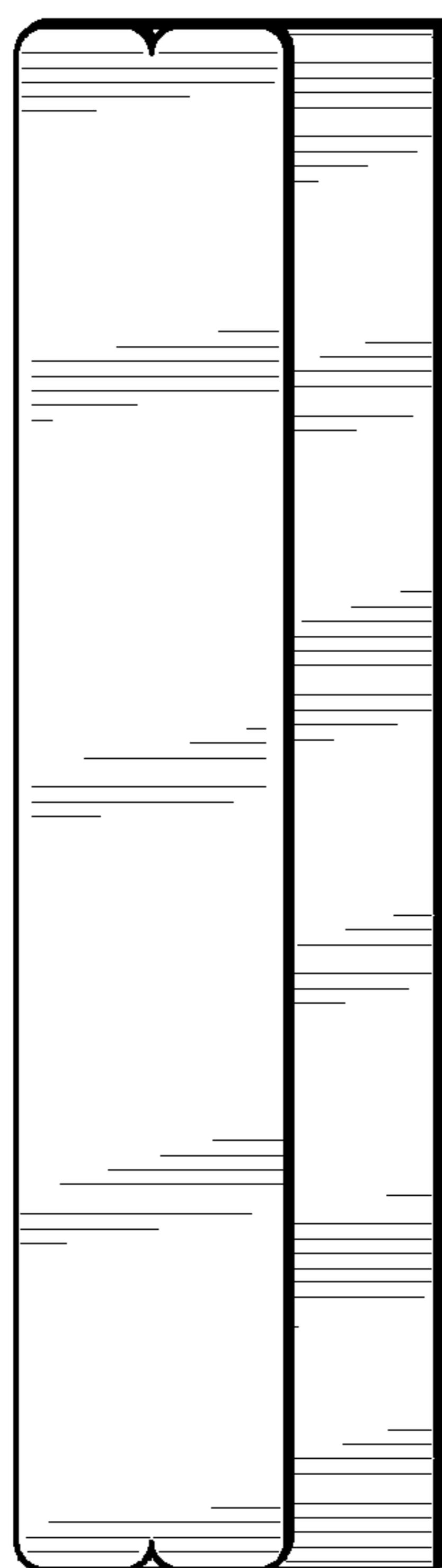

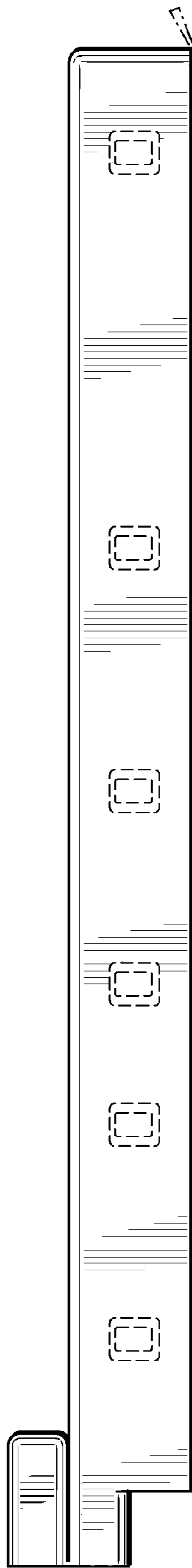

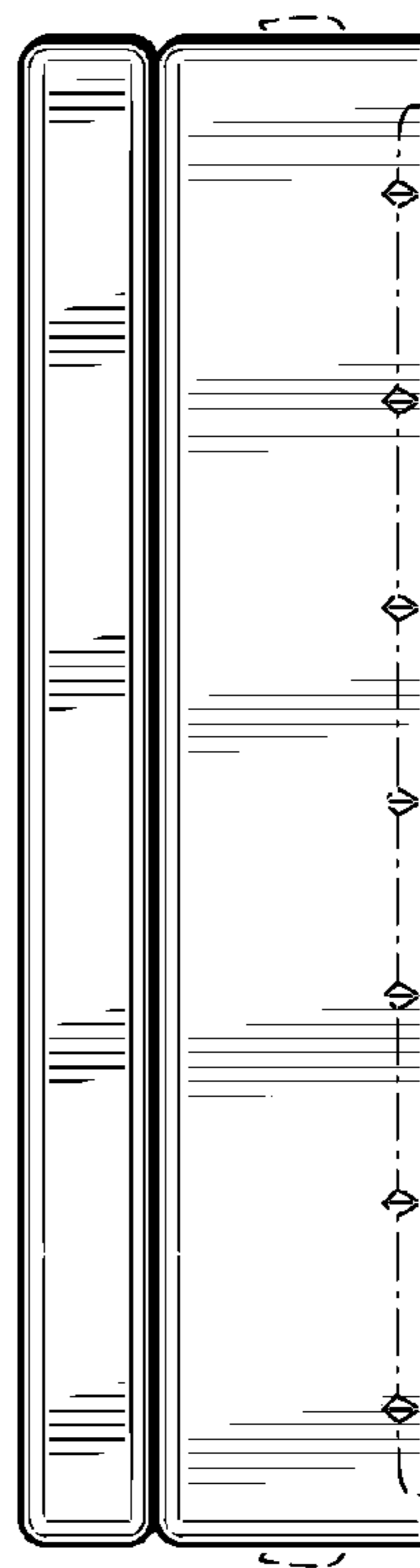

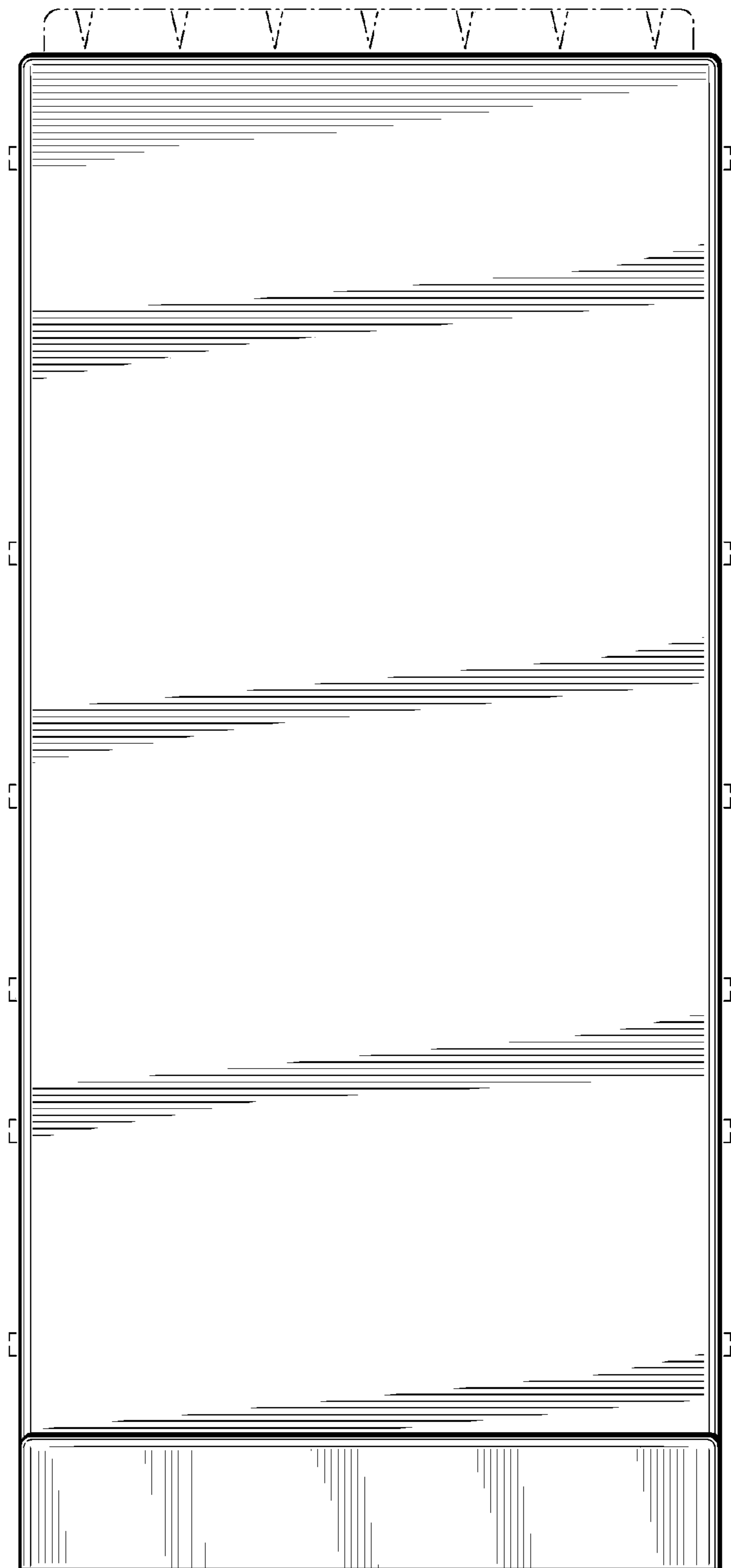

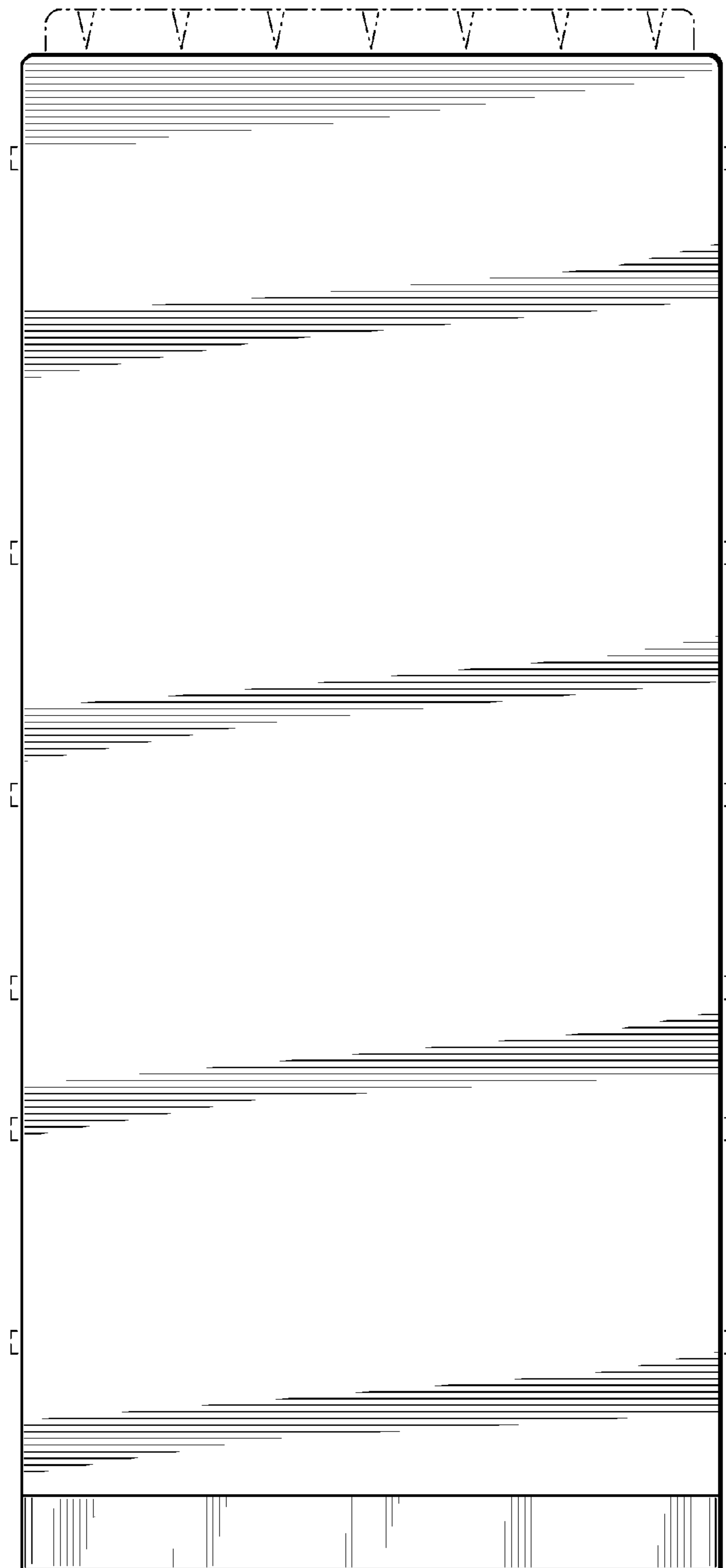

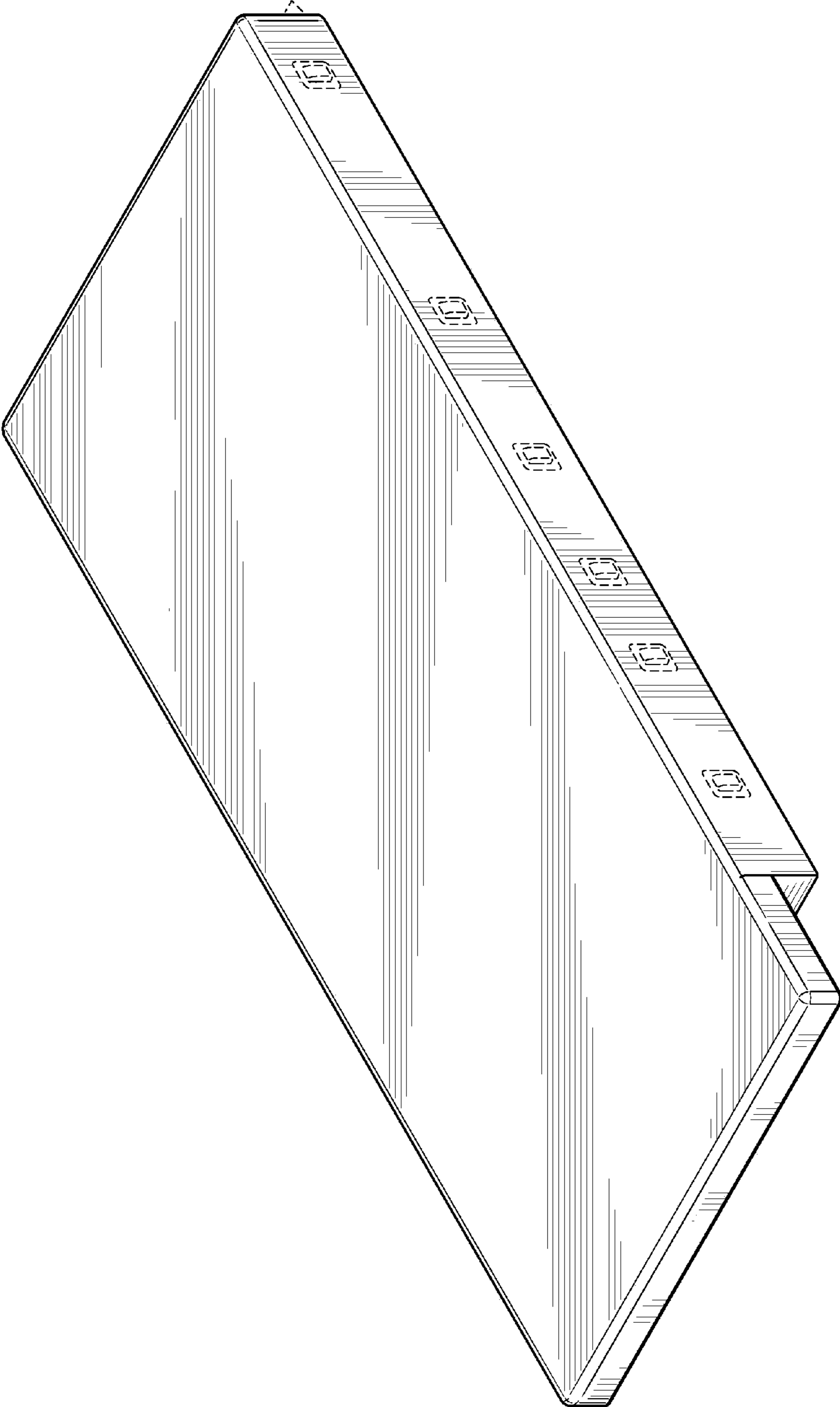

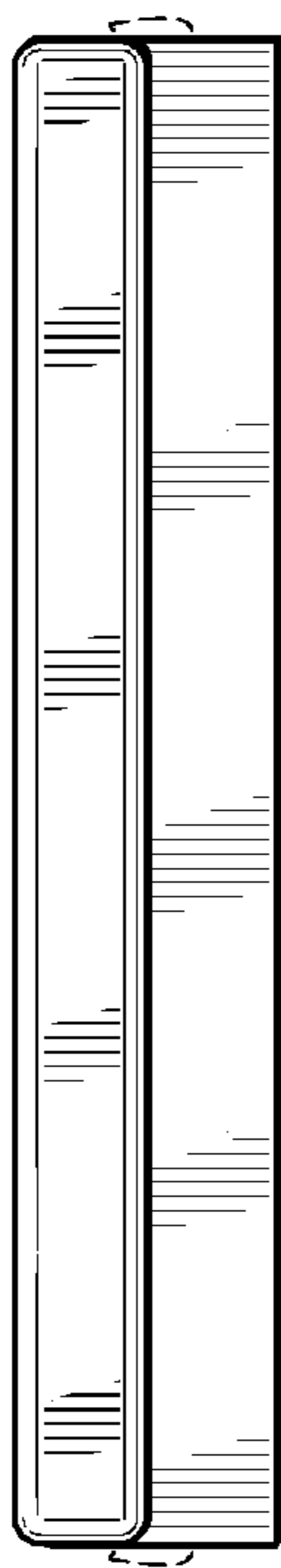

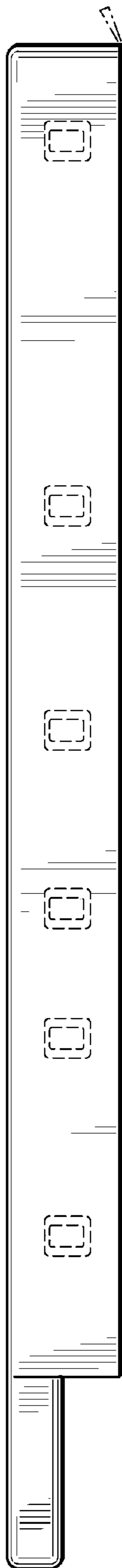

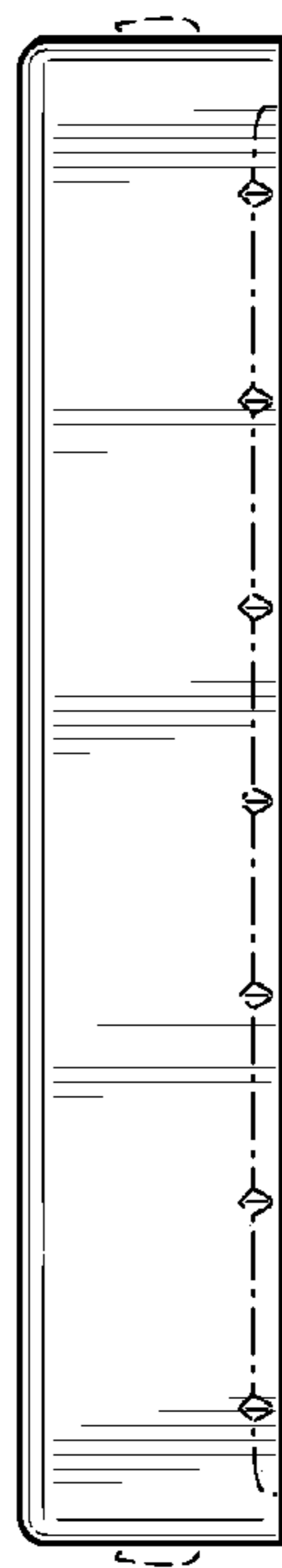

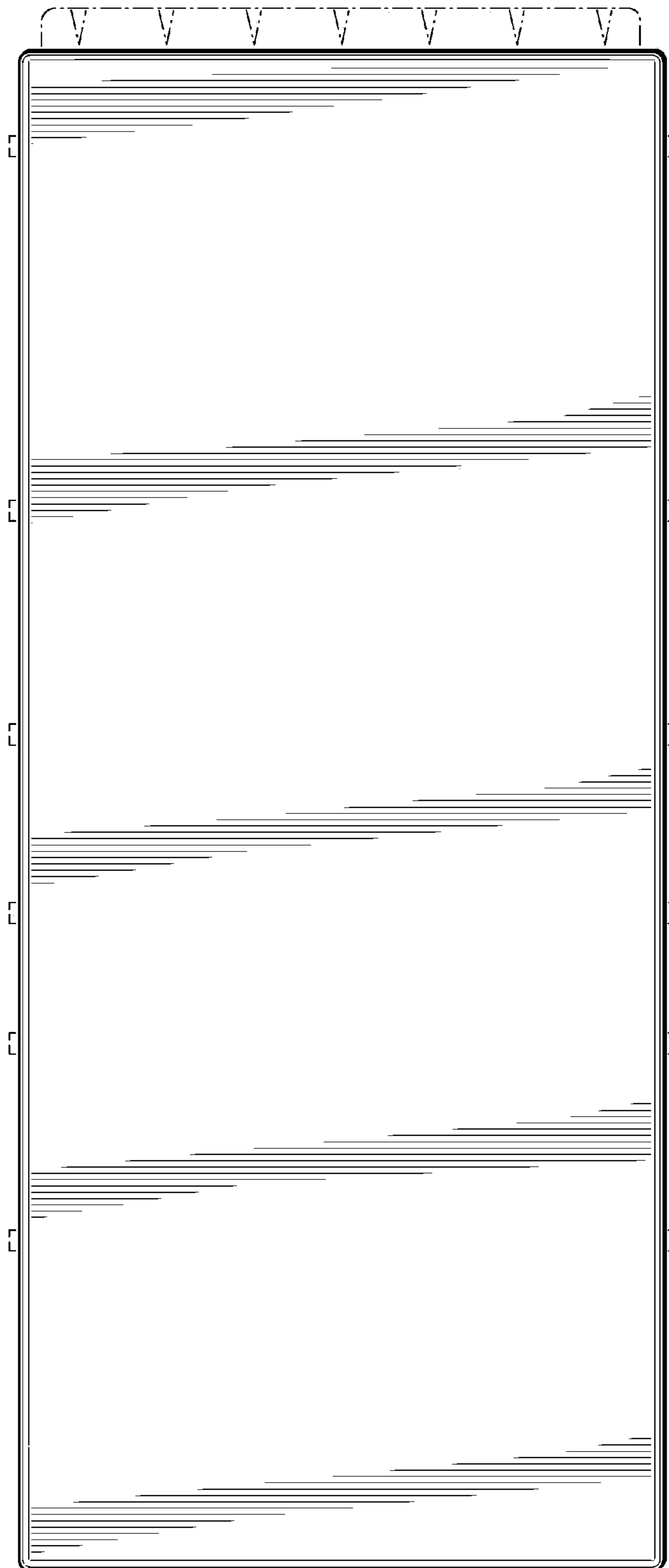

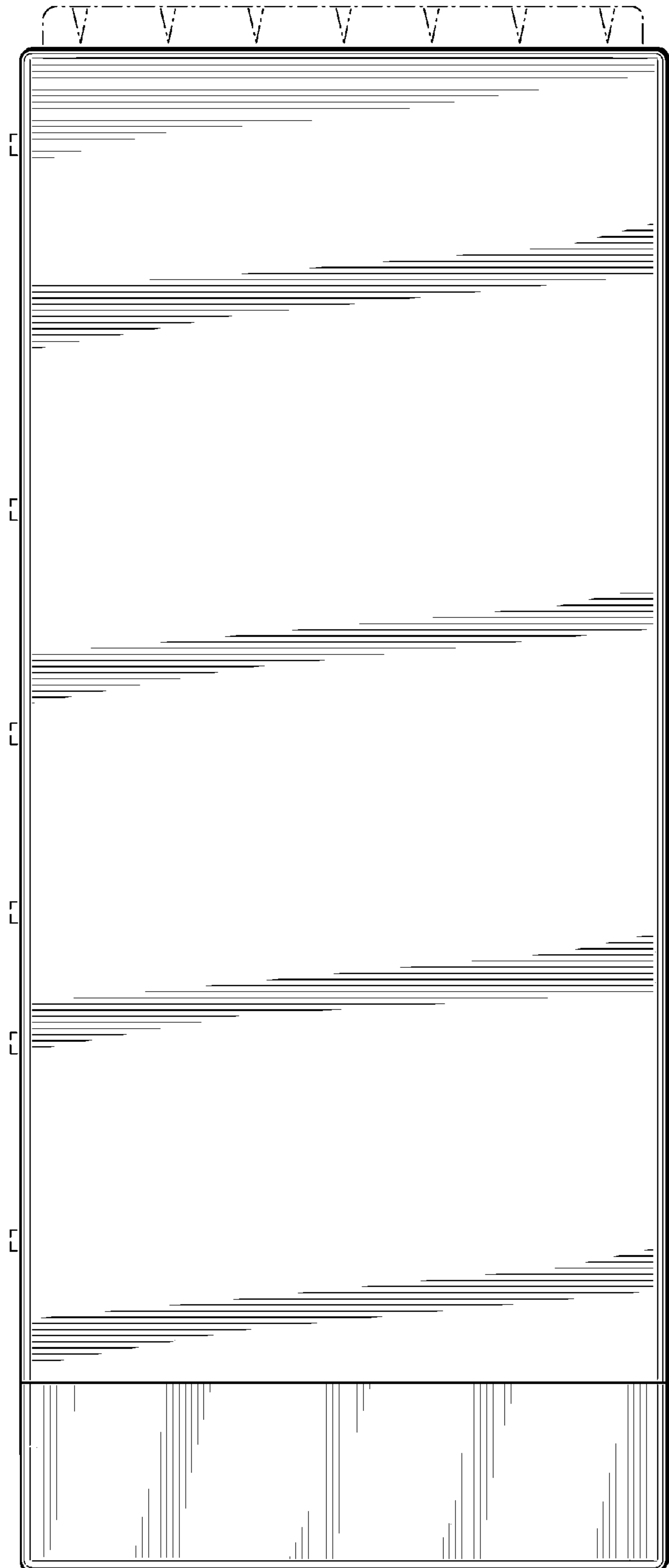

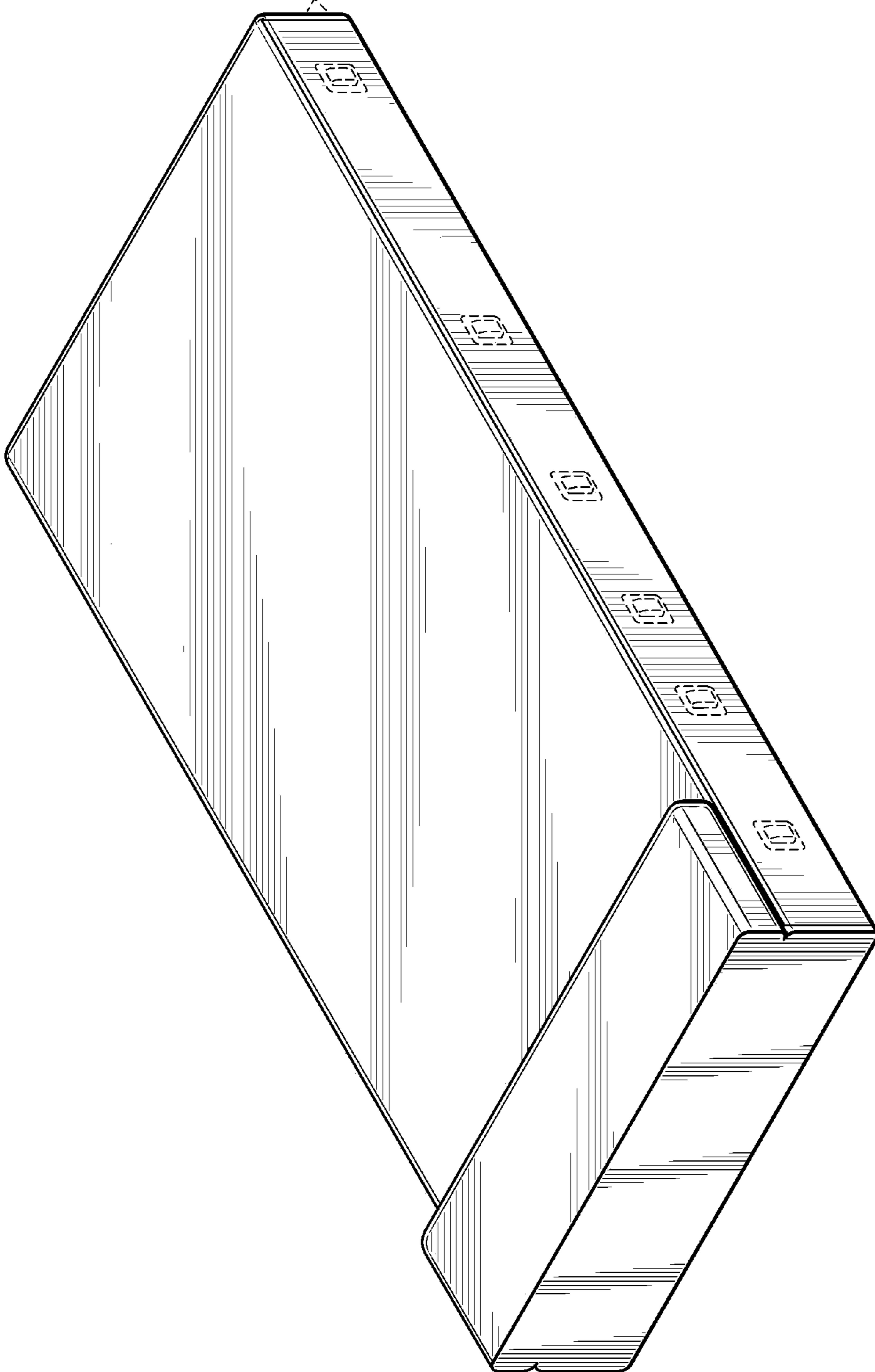

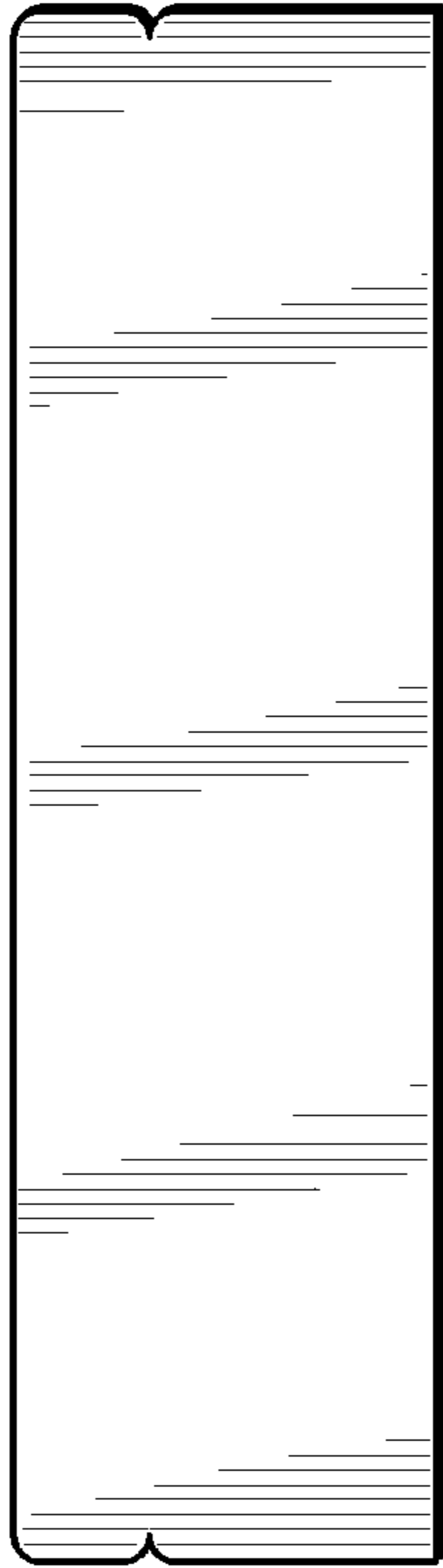

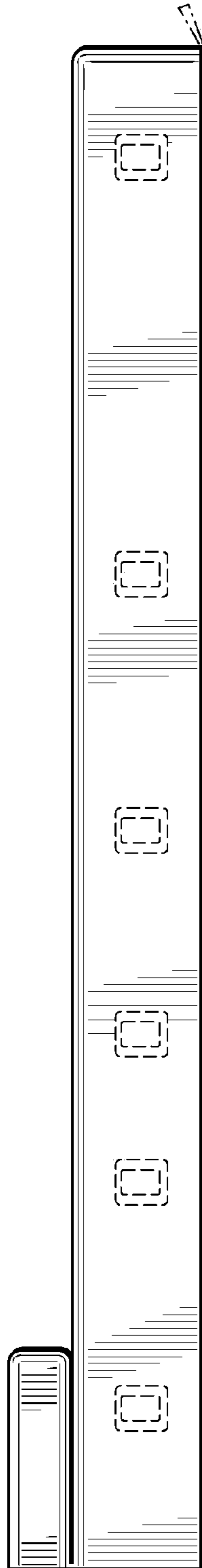

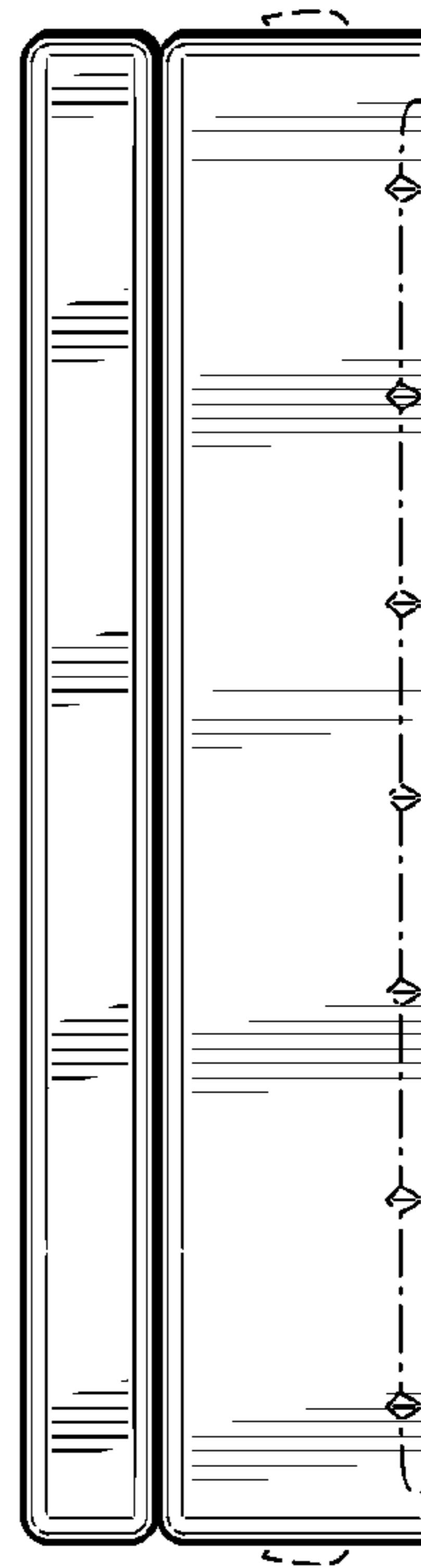

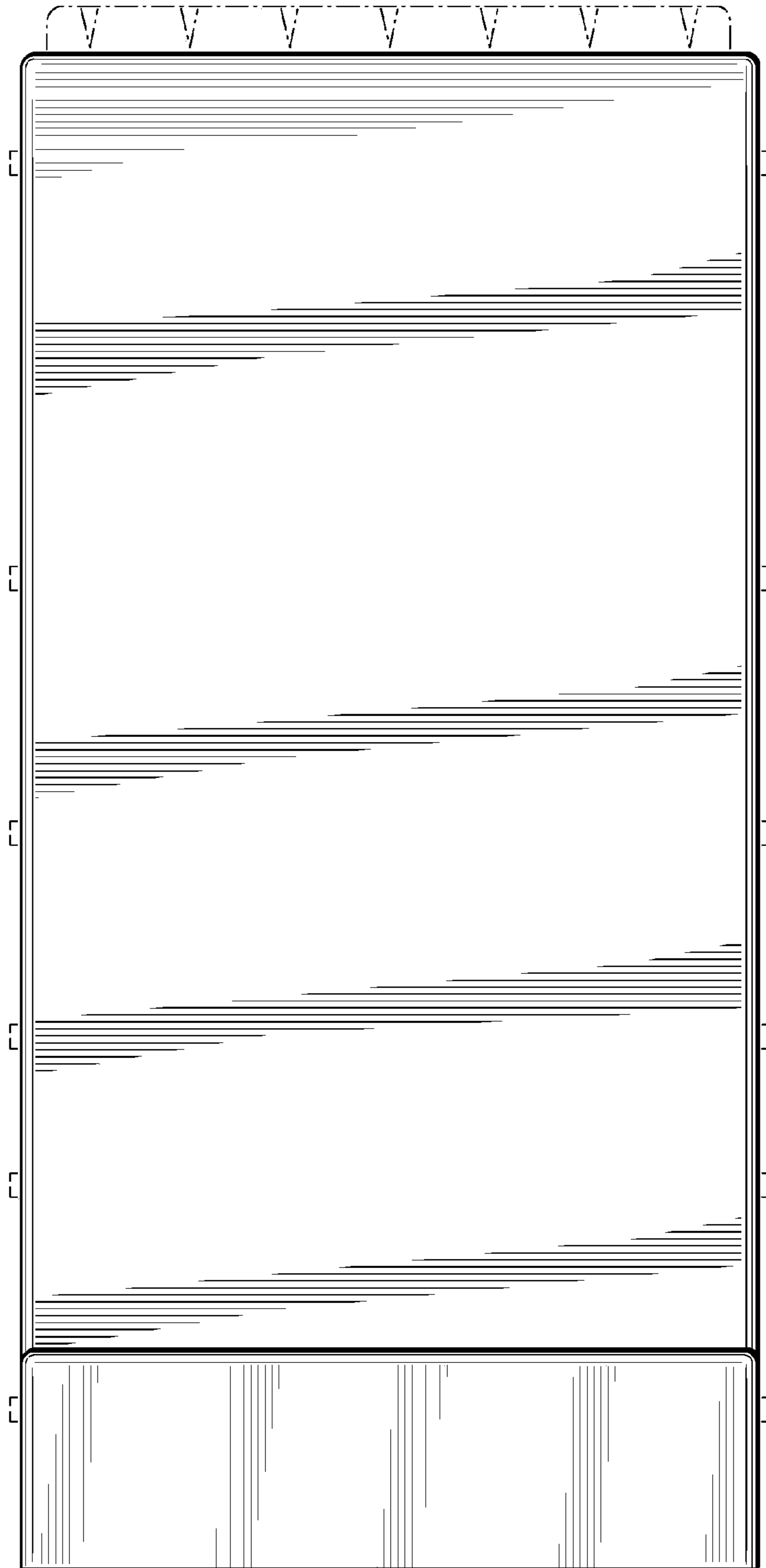

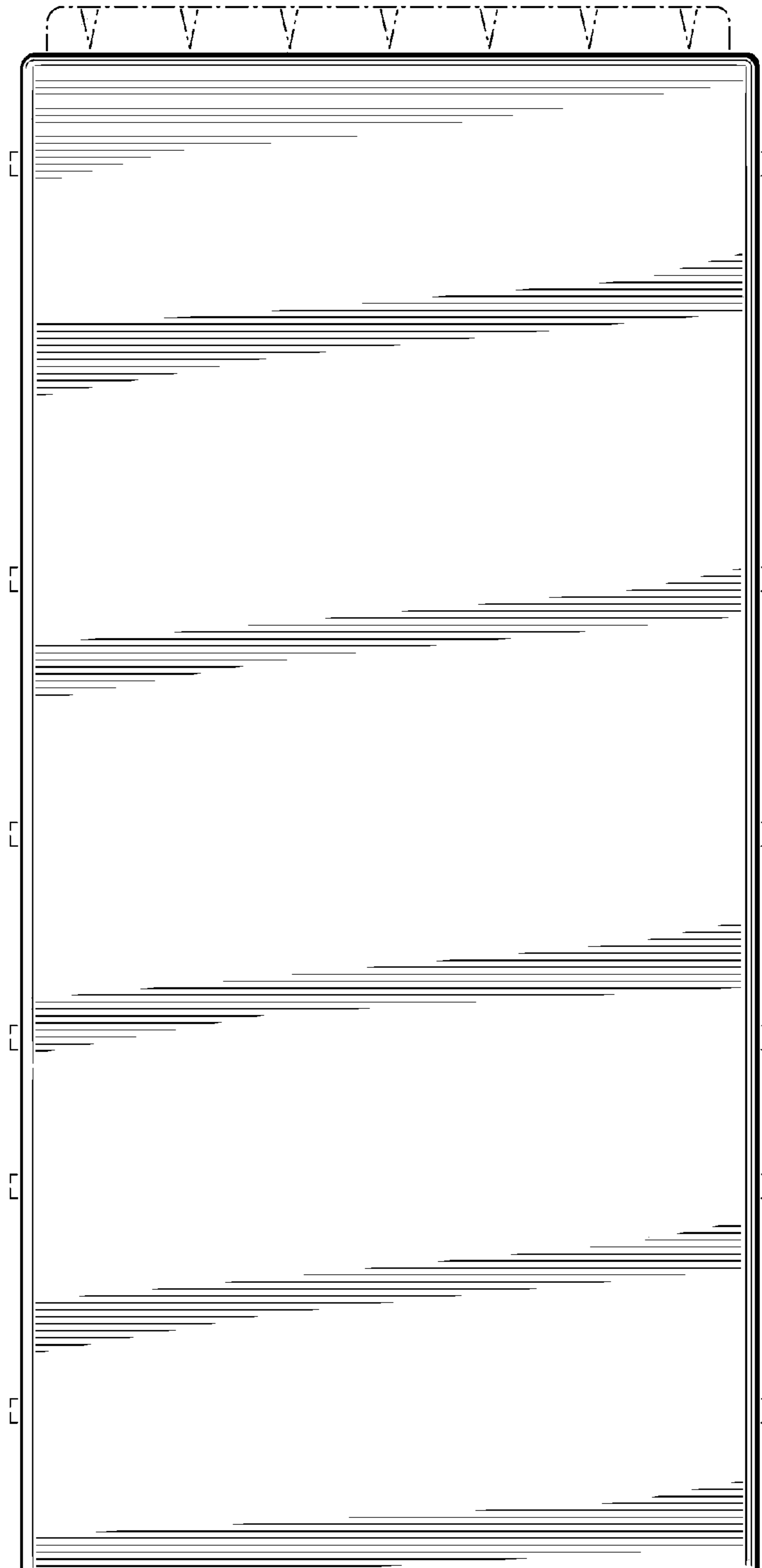
