DESCRIPTION

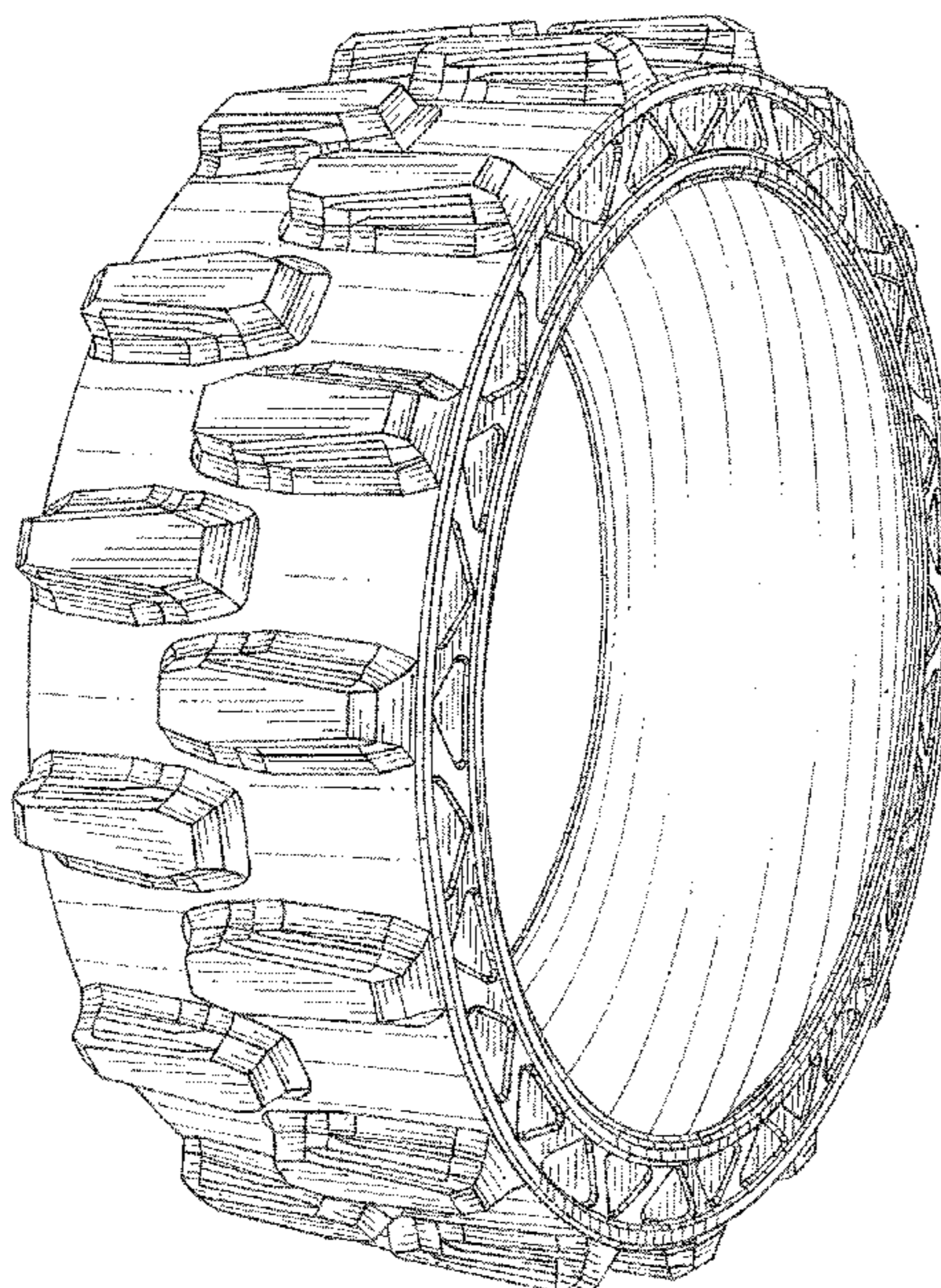
FIG. 1 is a perspective view of a tire according to our new design.

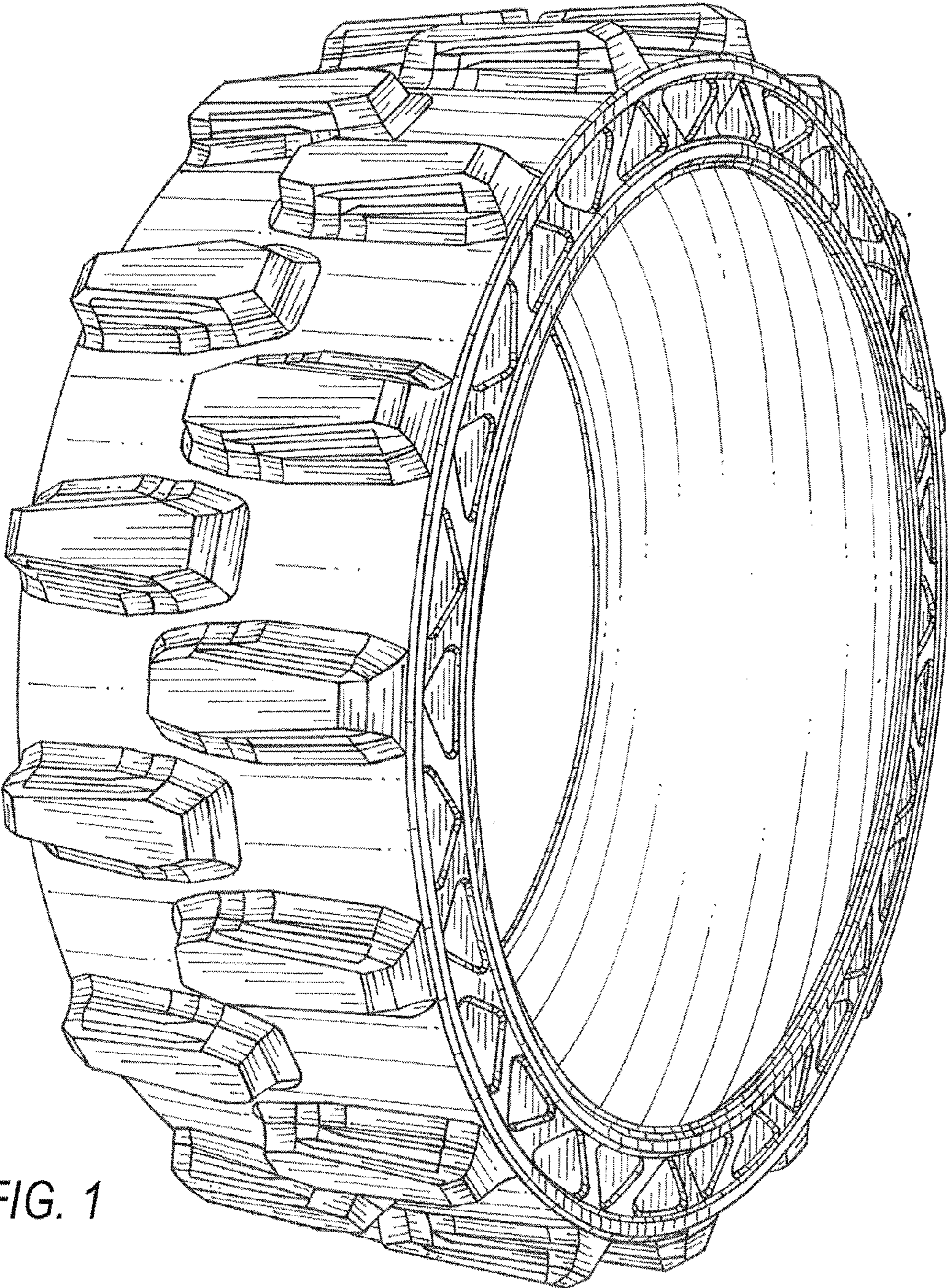

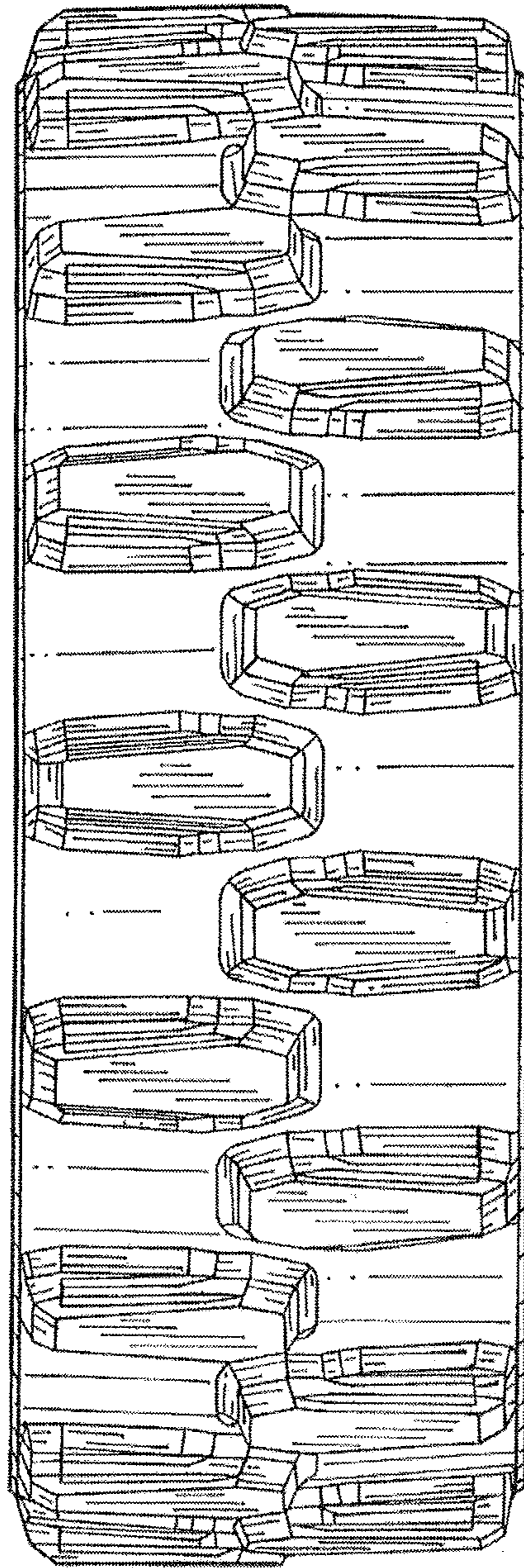

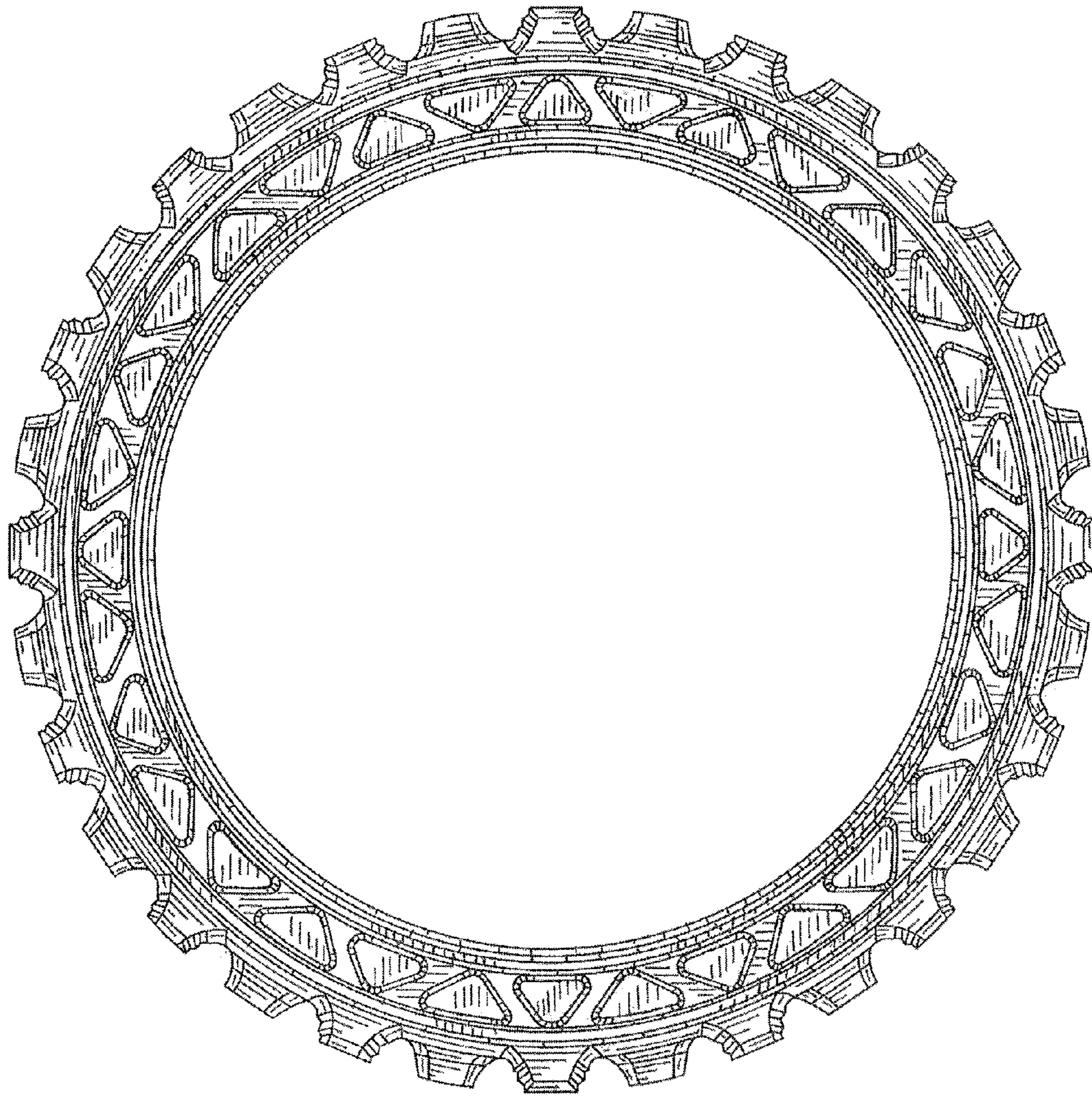
