DESCRIPTION

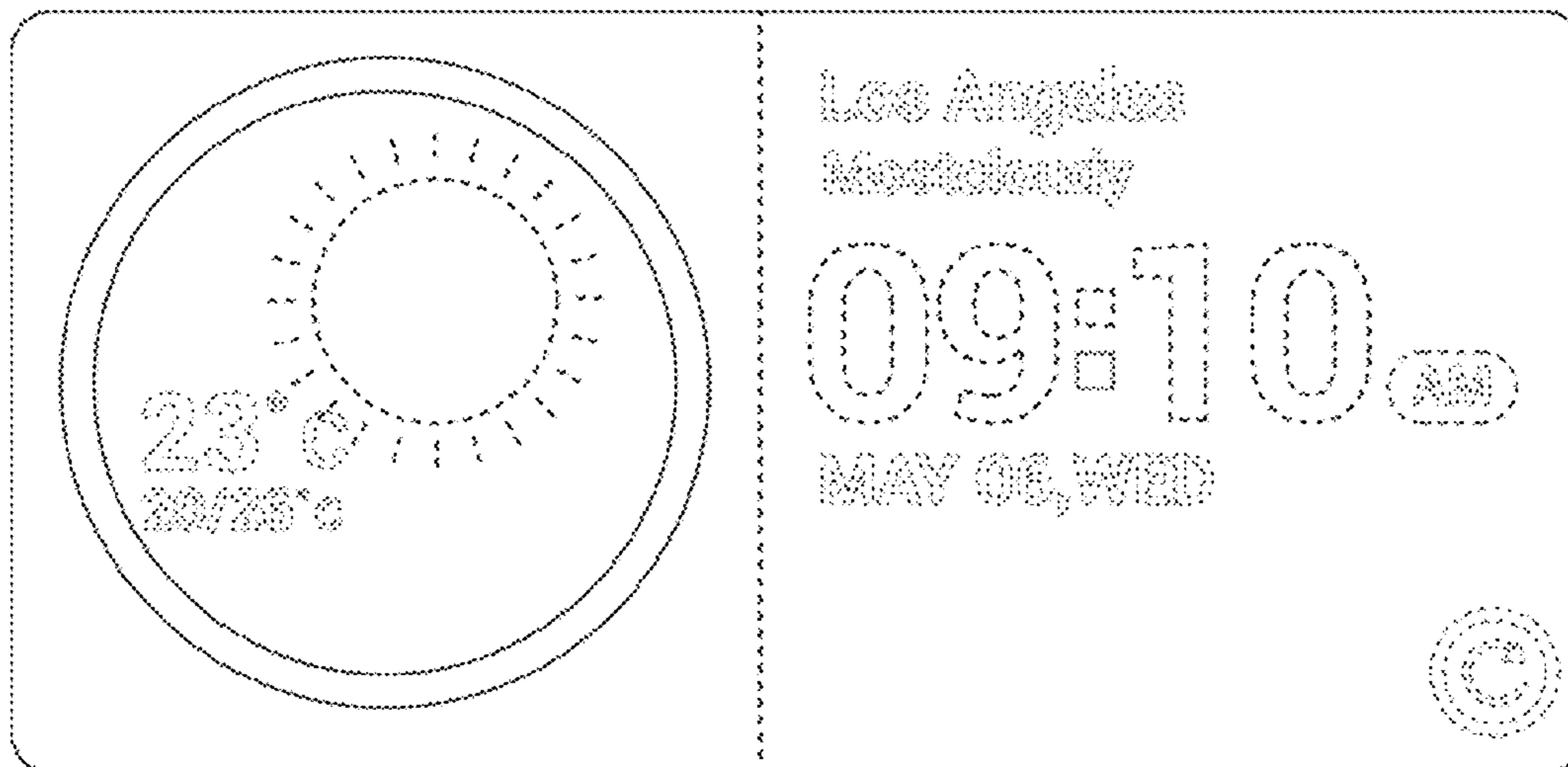
FIG. 1 is a front view of portion of a display screen that can include an icon for display.

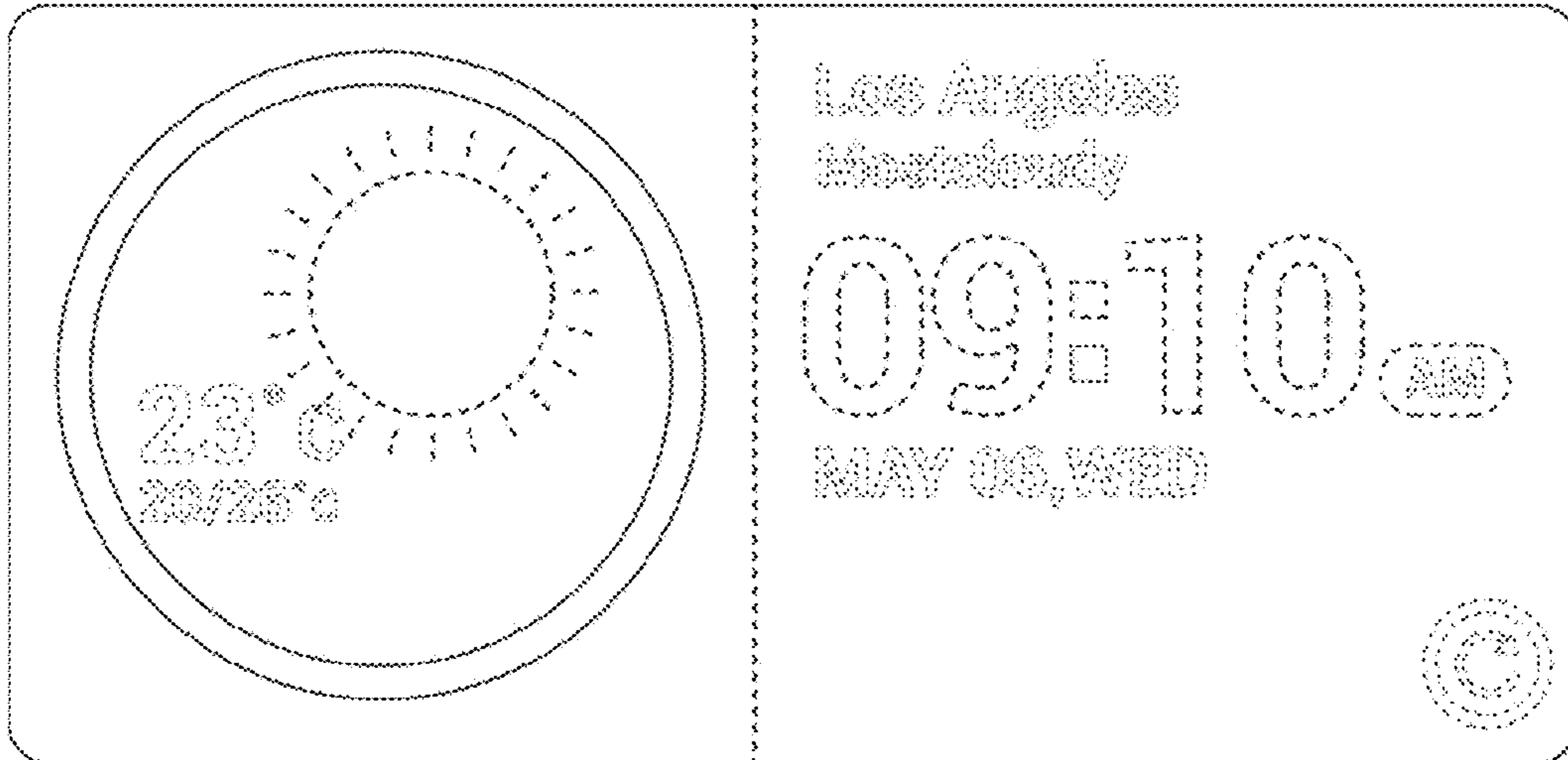

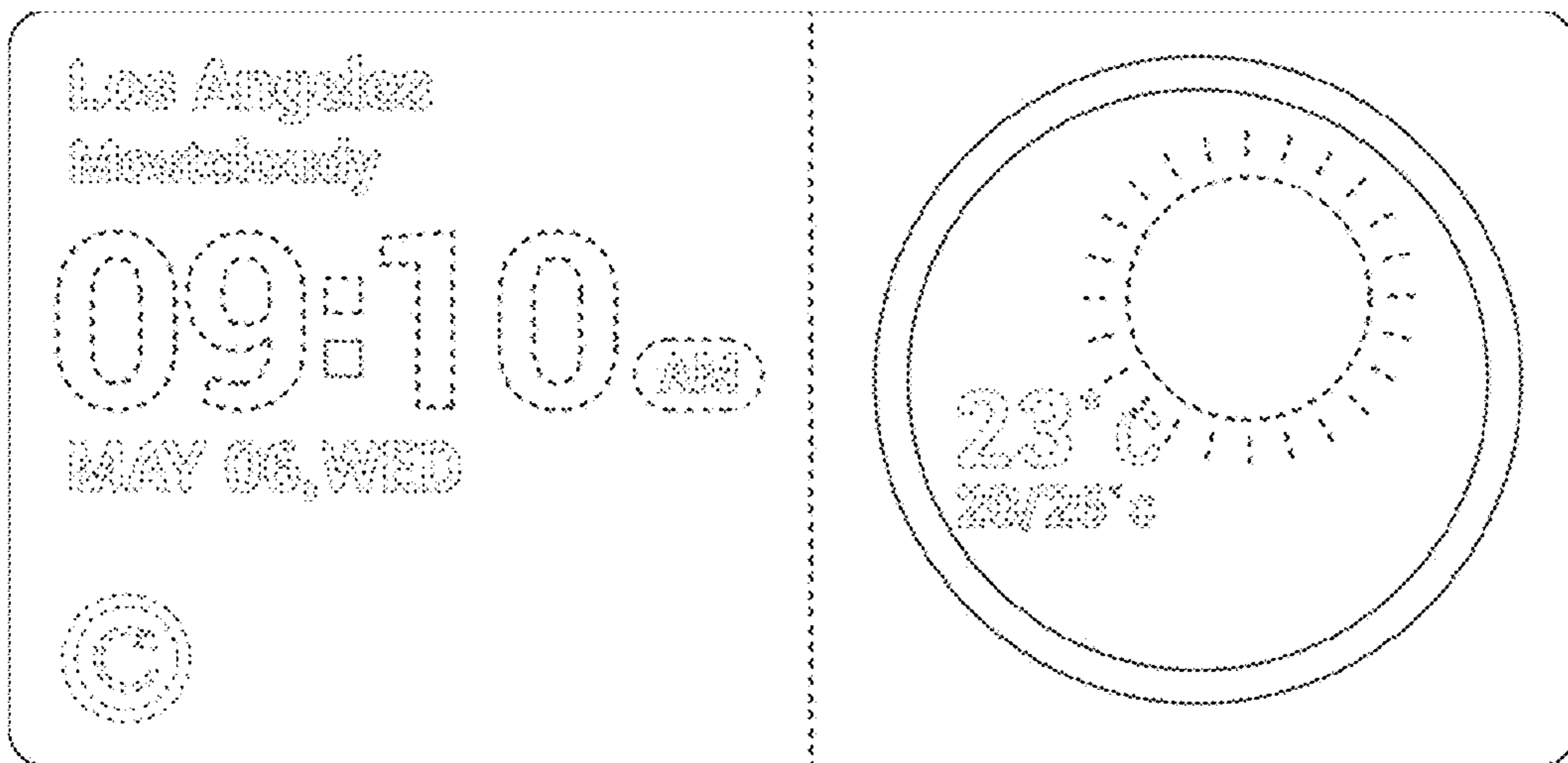

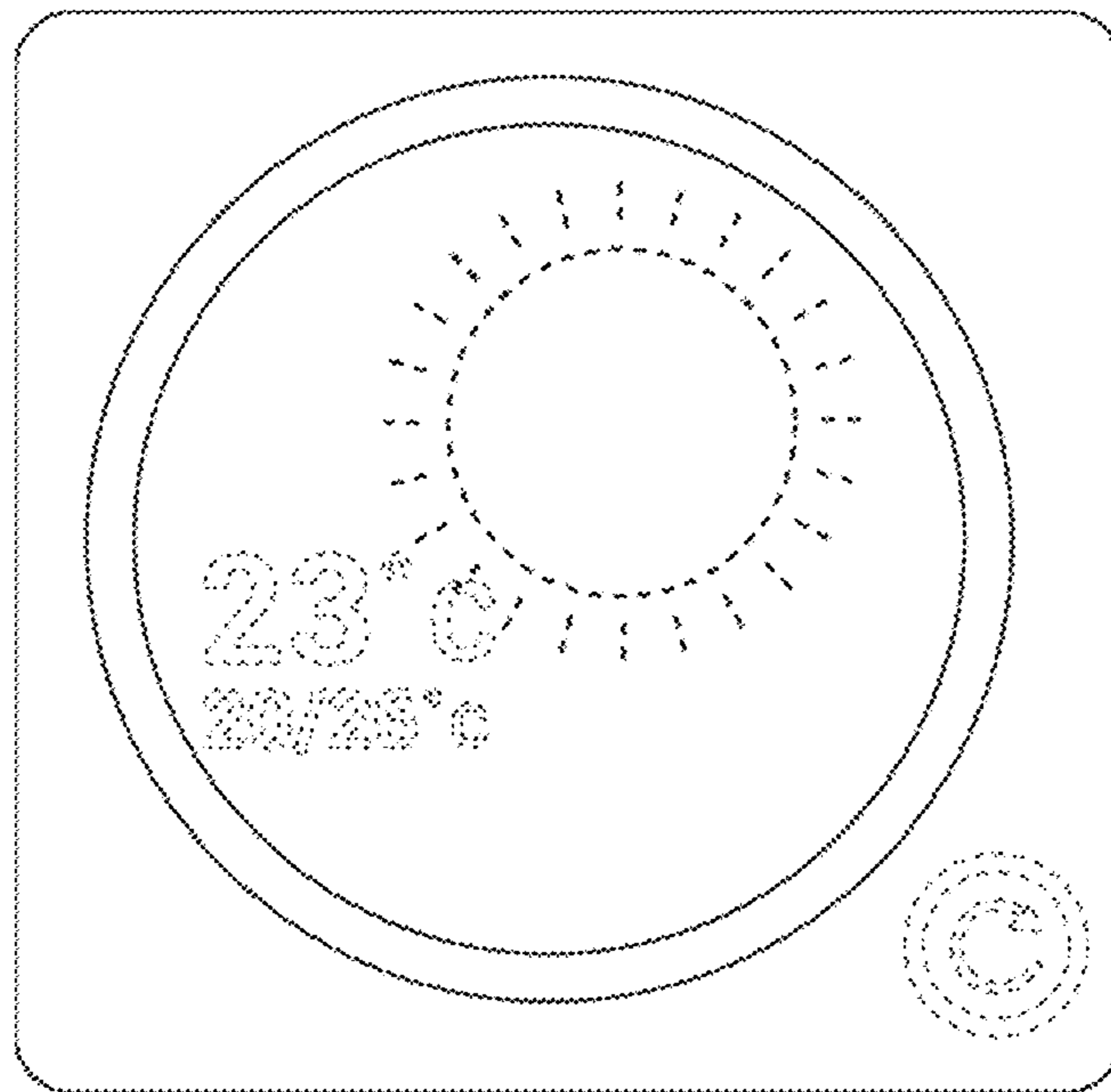
