(57) **CLAIM**

We claim the ornamental design for a washing machine with full-touch LCD having graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a washing machine with full-touch LCD having graphical user interface showing our new design; and,

FIG. 2 is an enlarged view thereof, but shown without broken lines for ease of illustration.

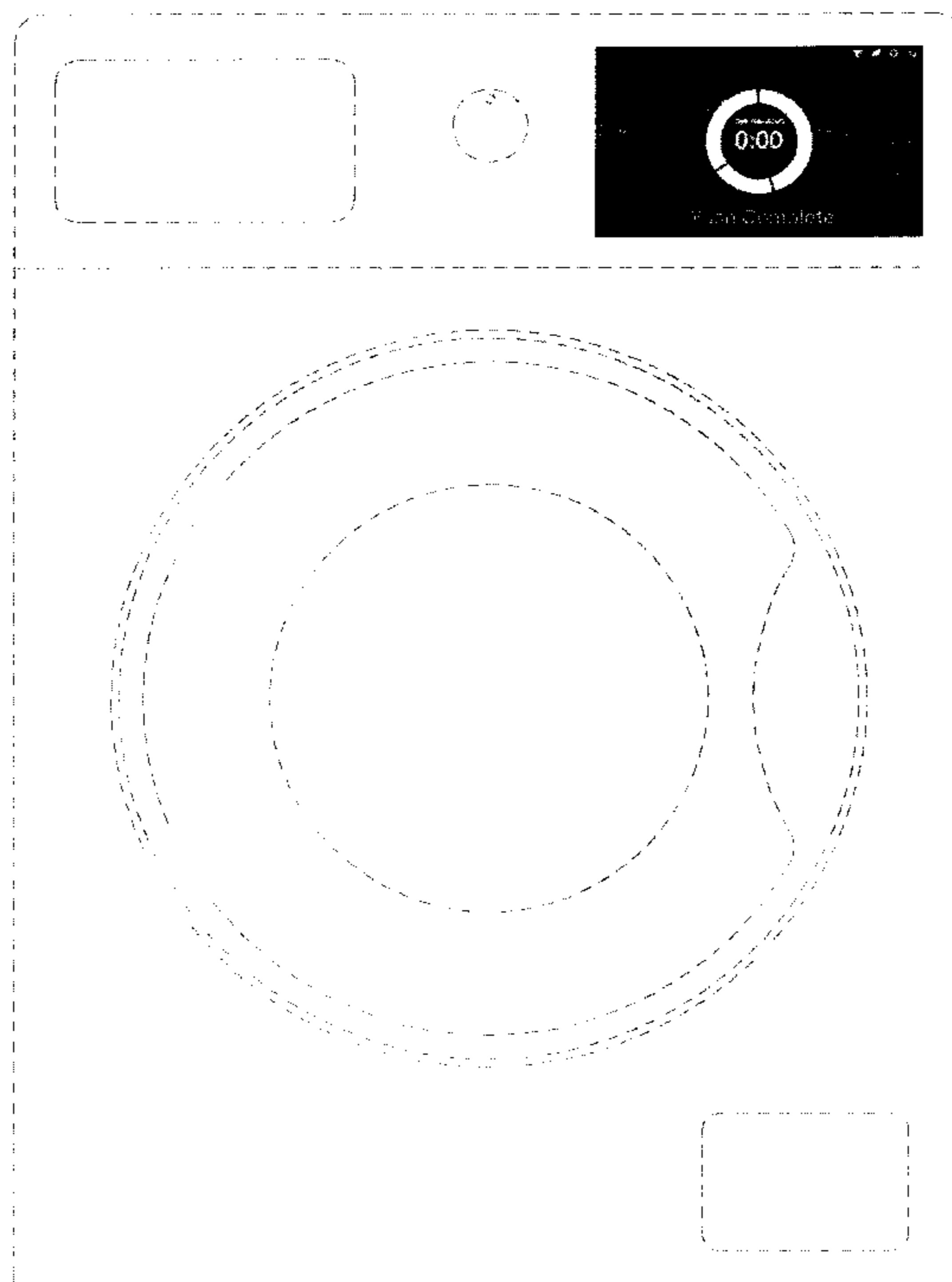

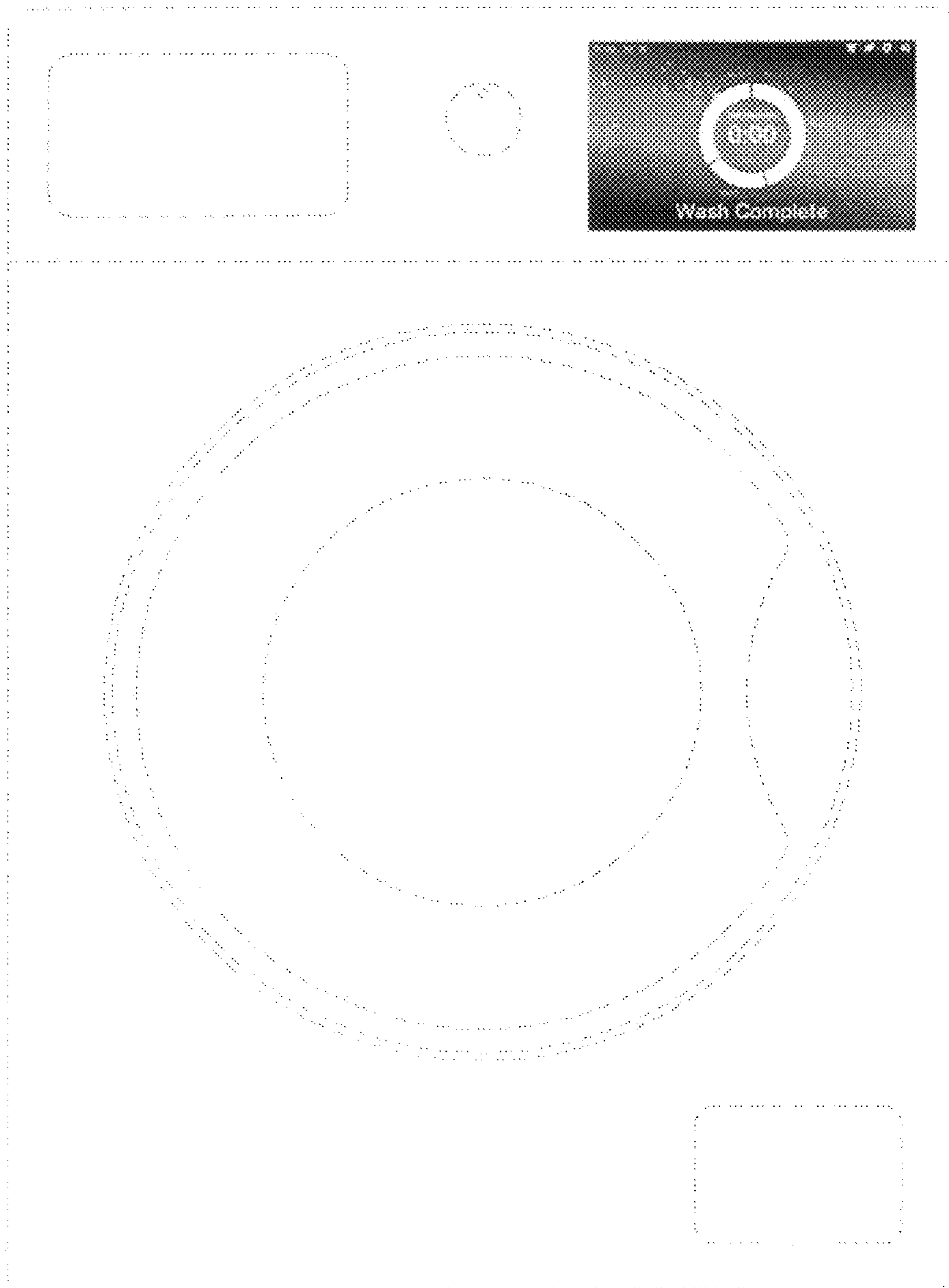
