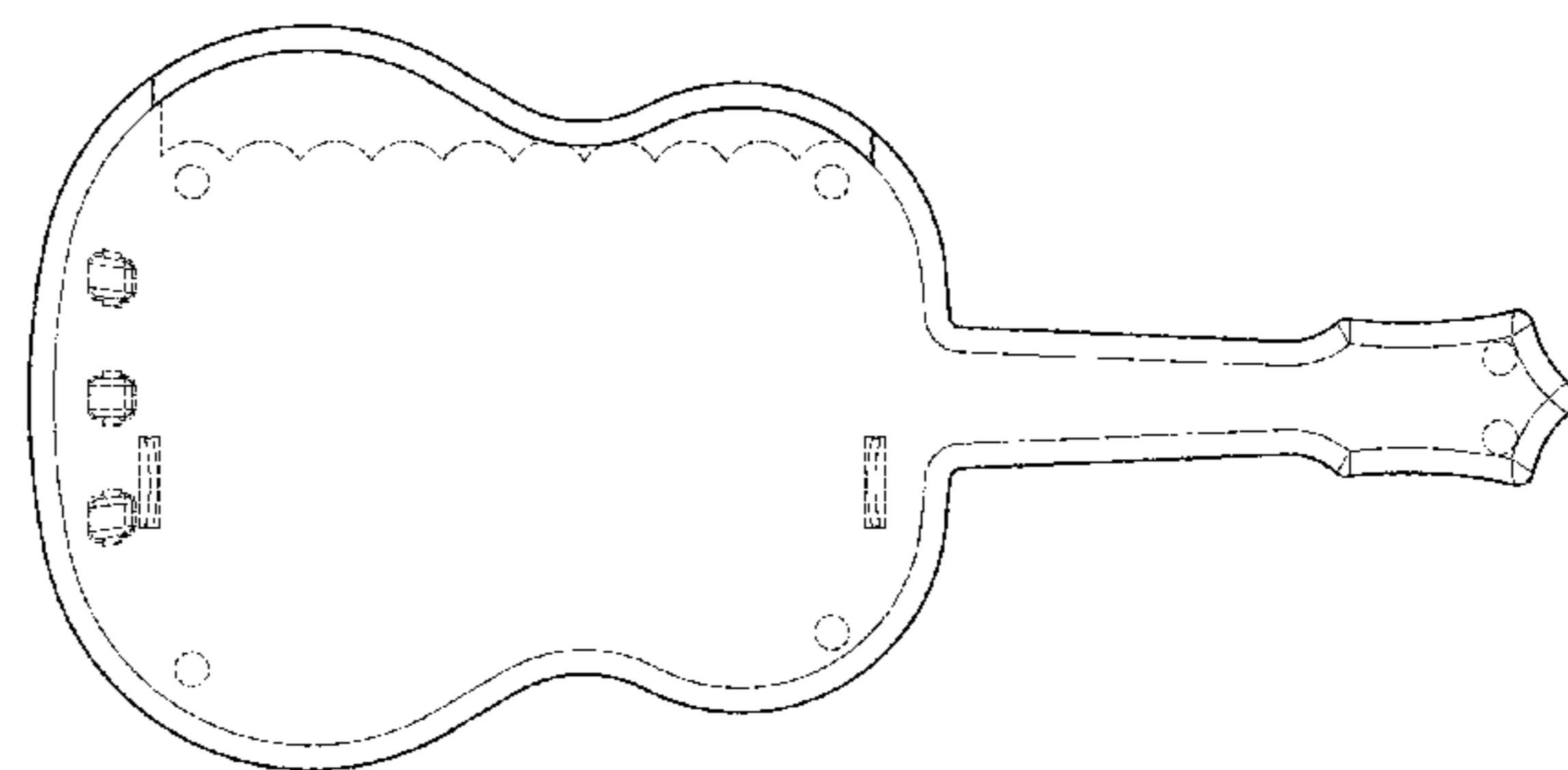
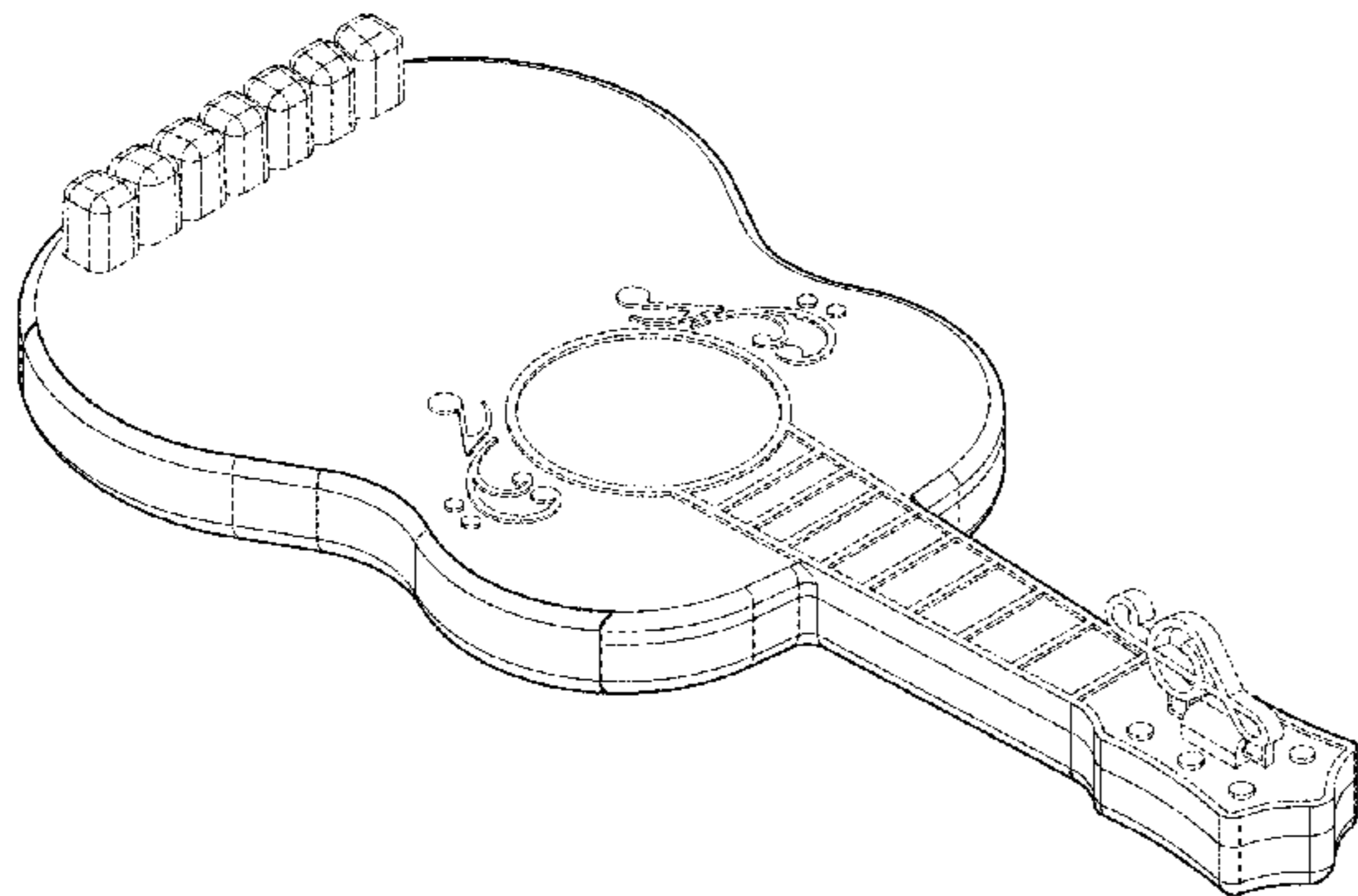
The ornamental design for a friendship bracelet maker, as shown and described.

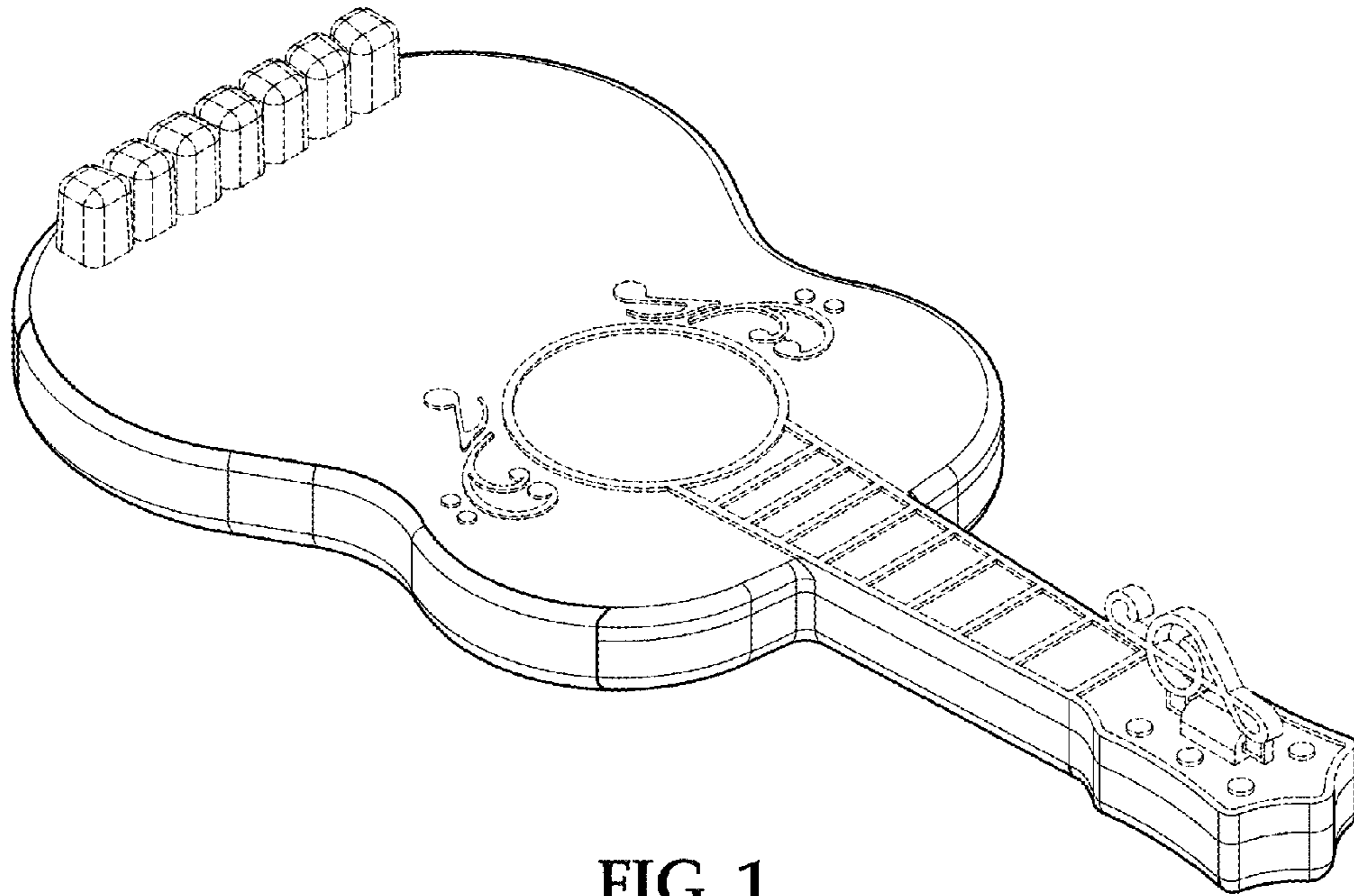

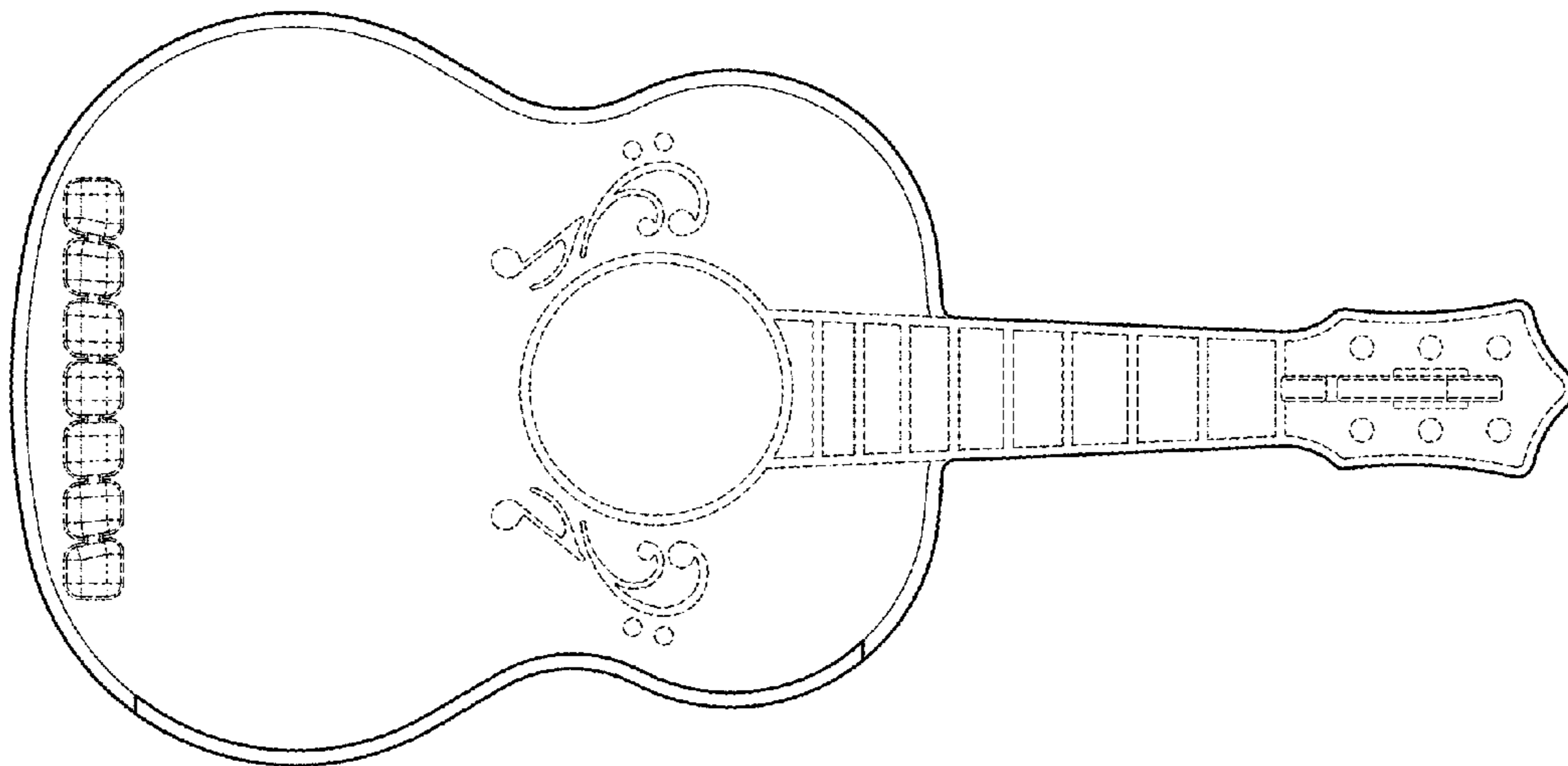

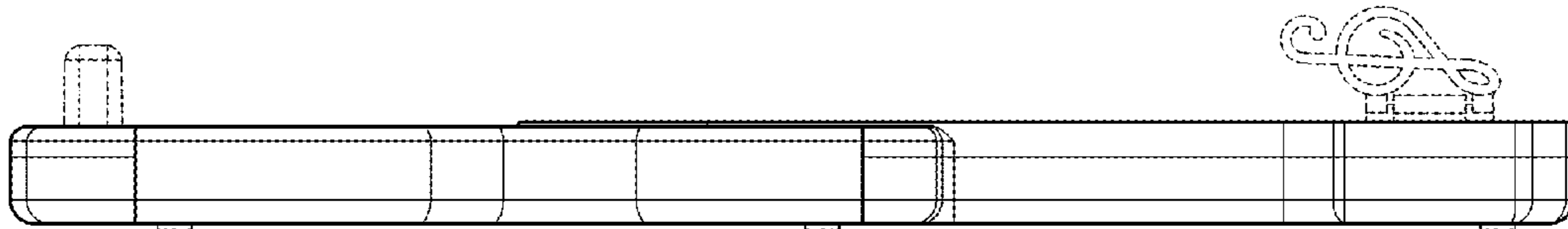

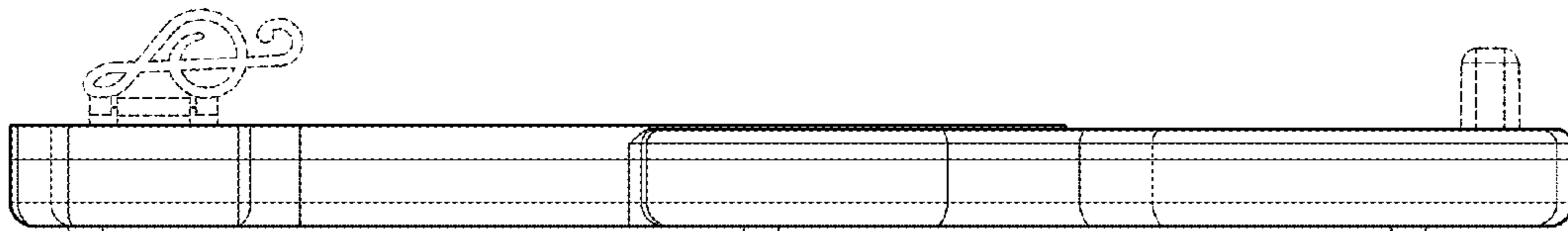

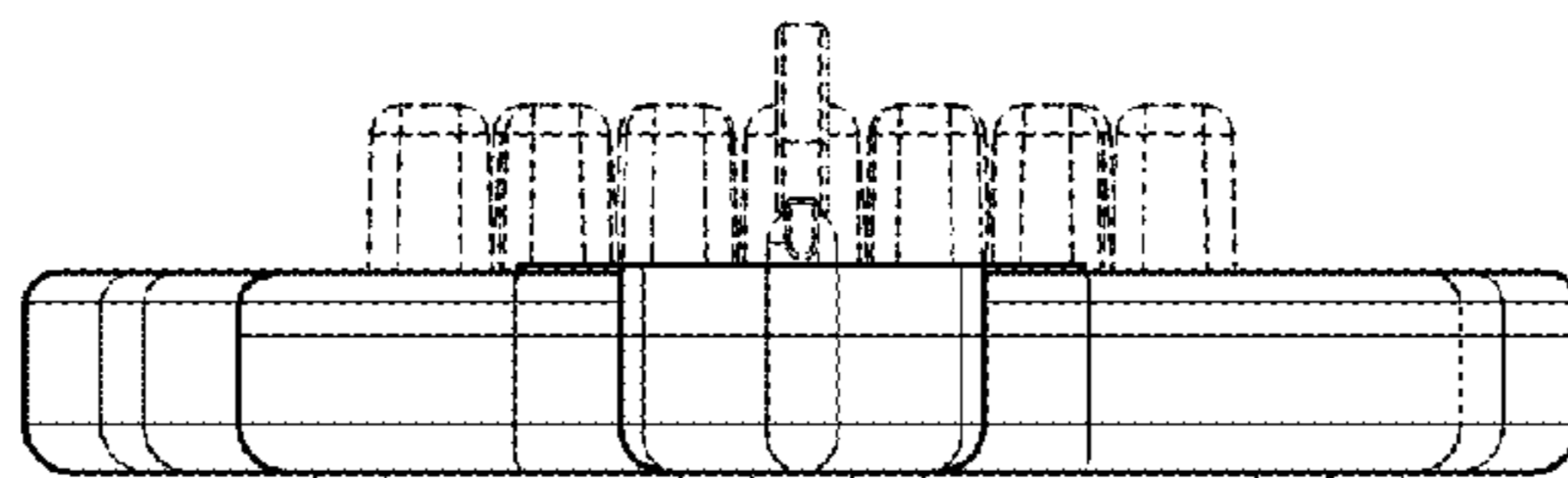

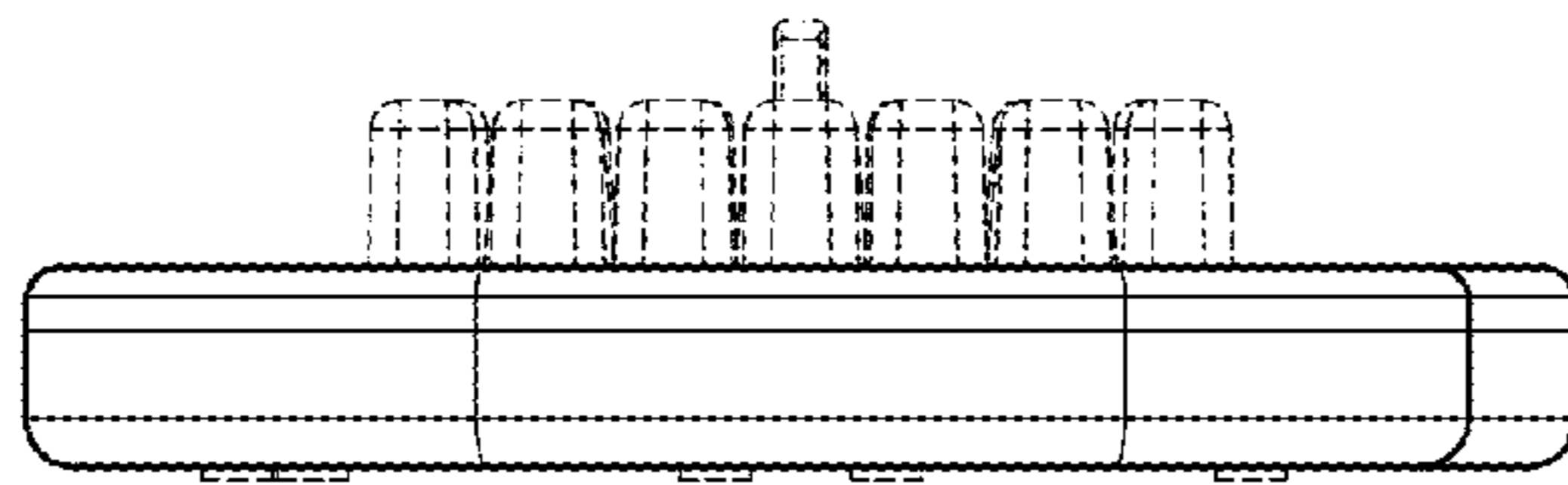

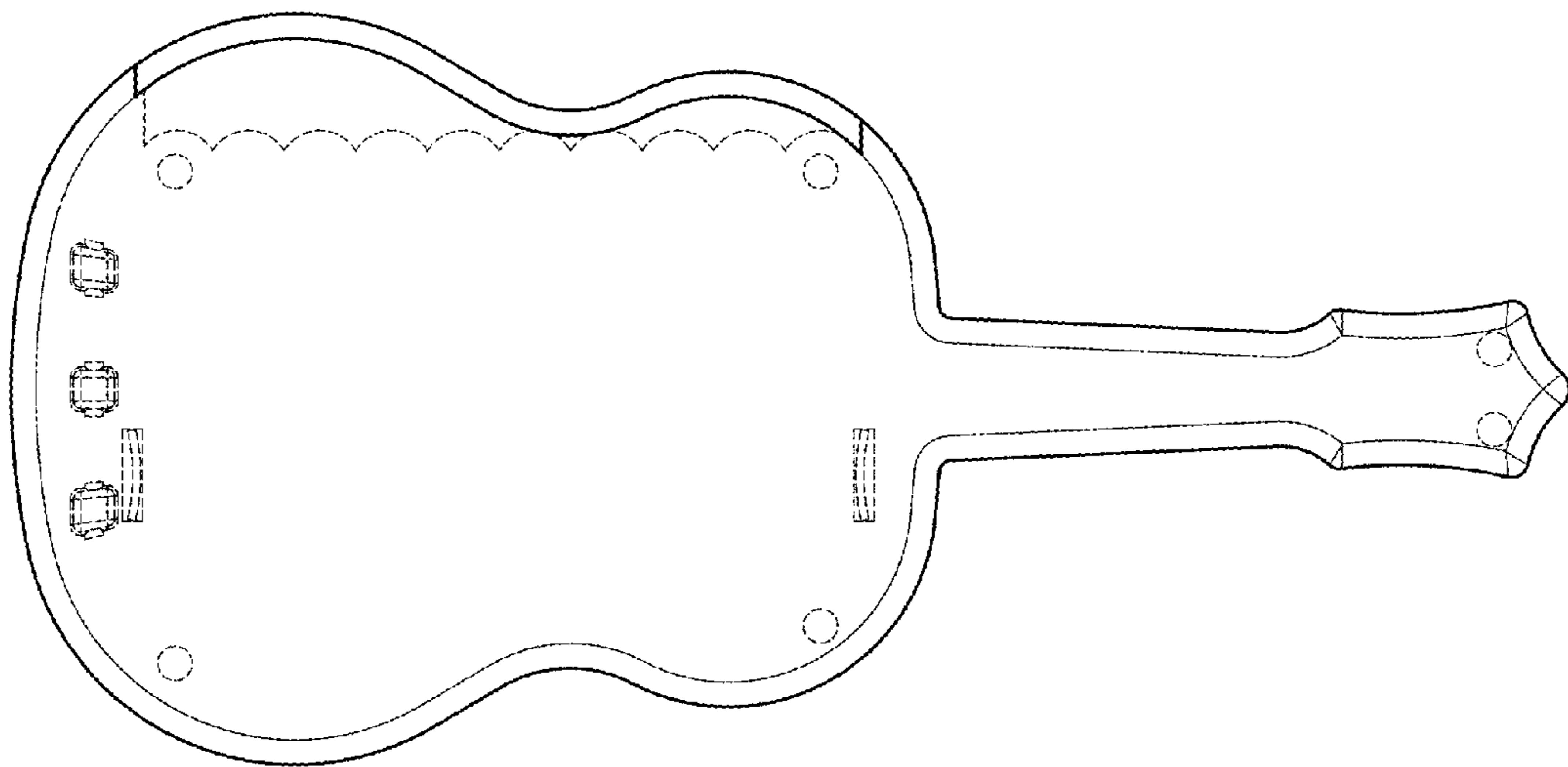
