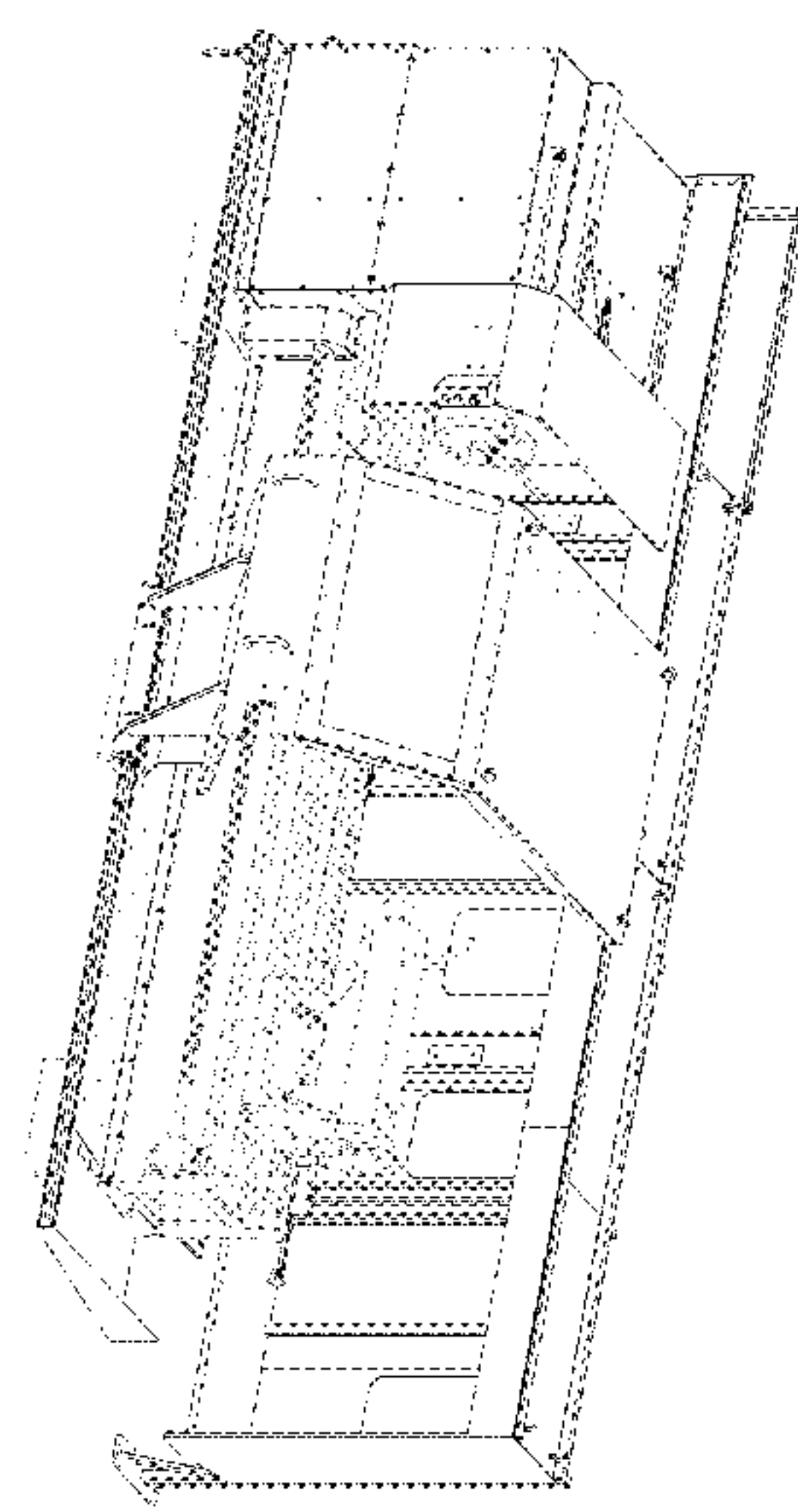

(57) **CLAIM**
The ornamental design for a cover for a lathe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a lathe assembly showing the position of a cover for a lathe in the lathe assembly;
FIG. 2 is a front elevational view of a cover for a lathe showing my new design;
FIG. 3 is a top plan view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a perspective left view thereof; and,
FIG. 8 is a perspective right view thereof.

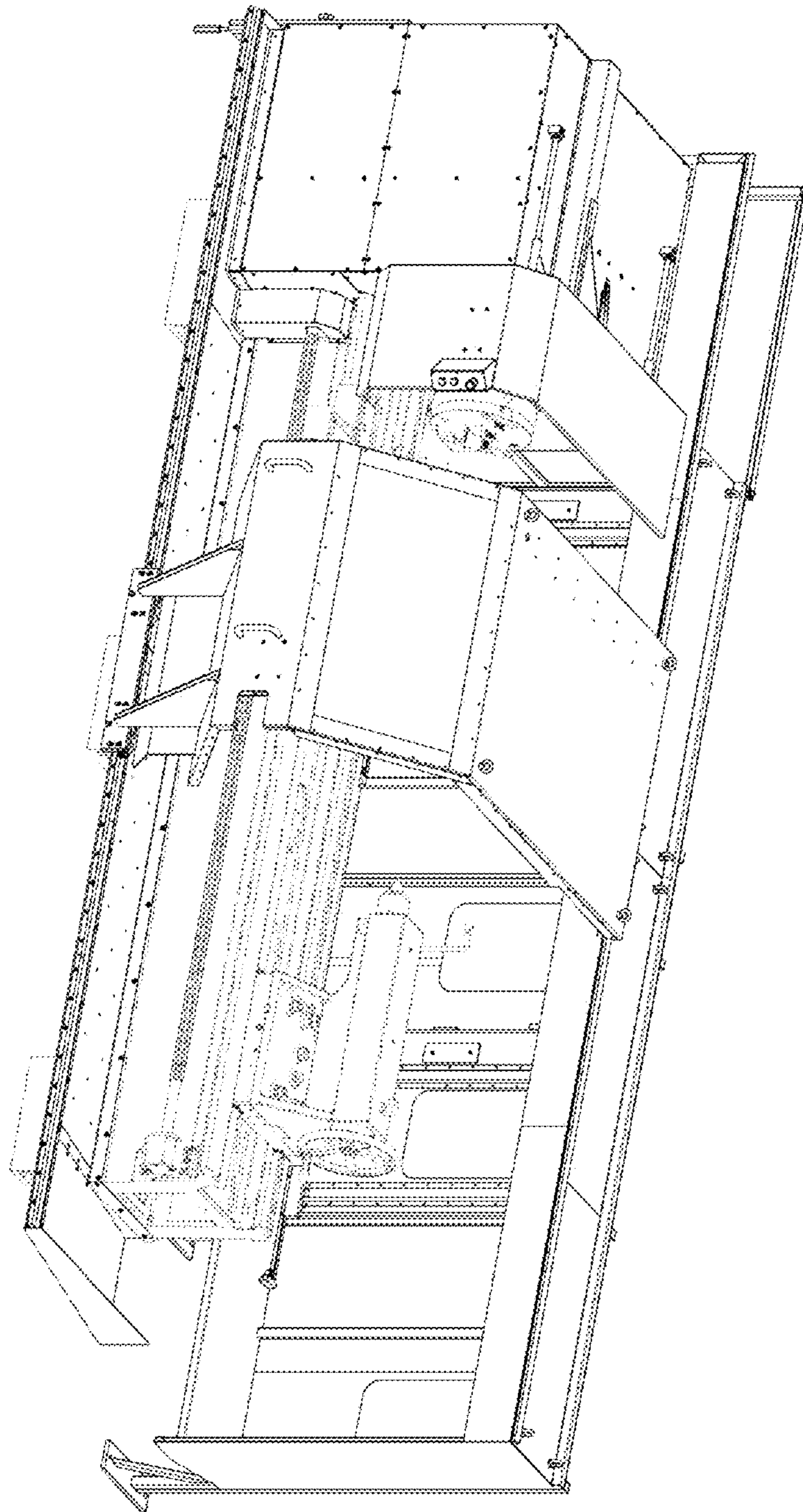

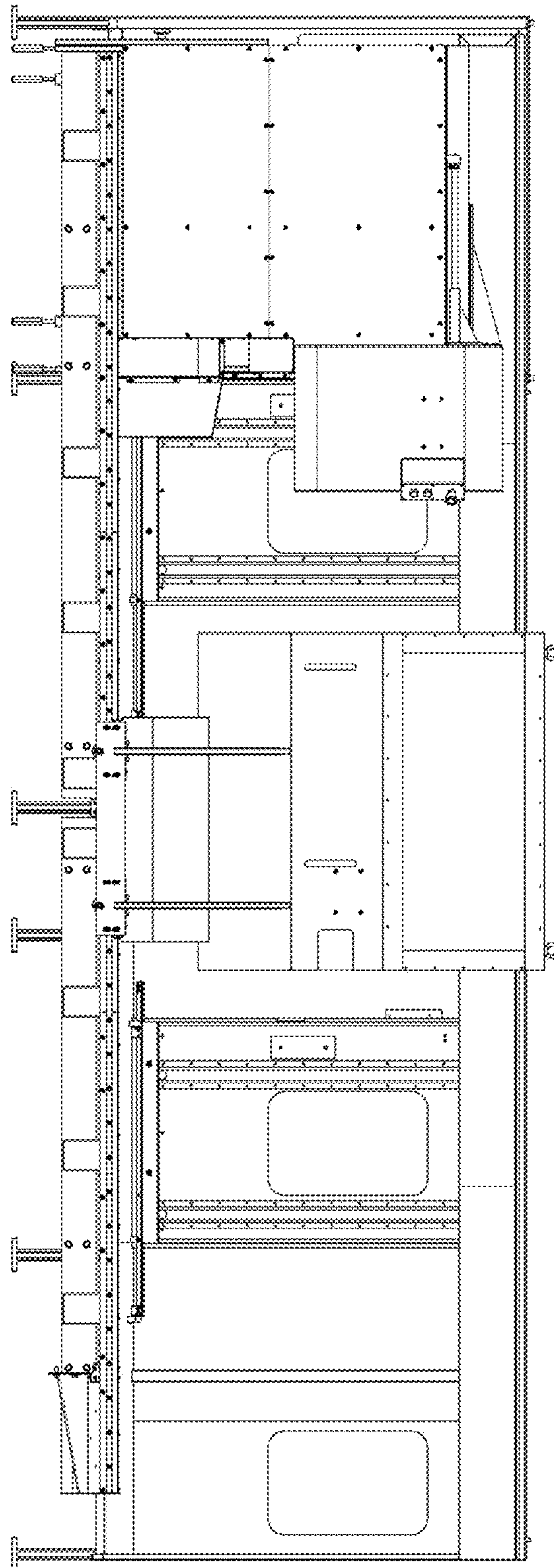

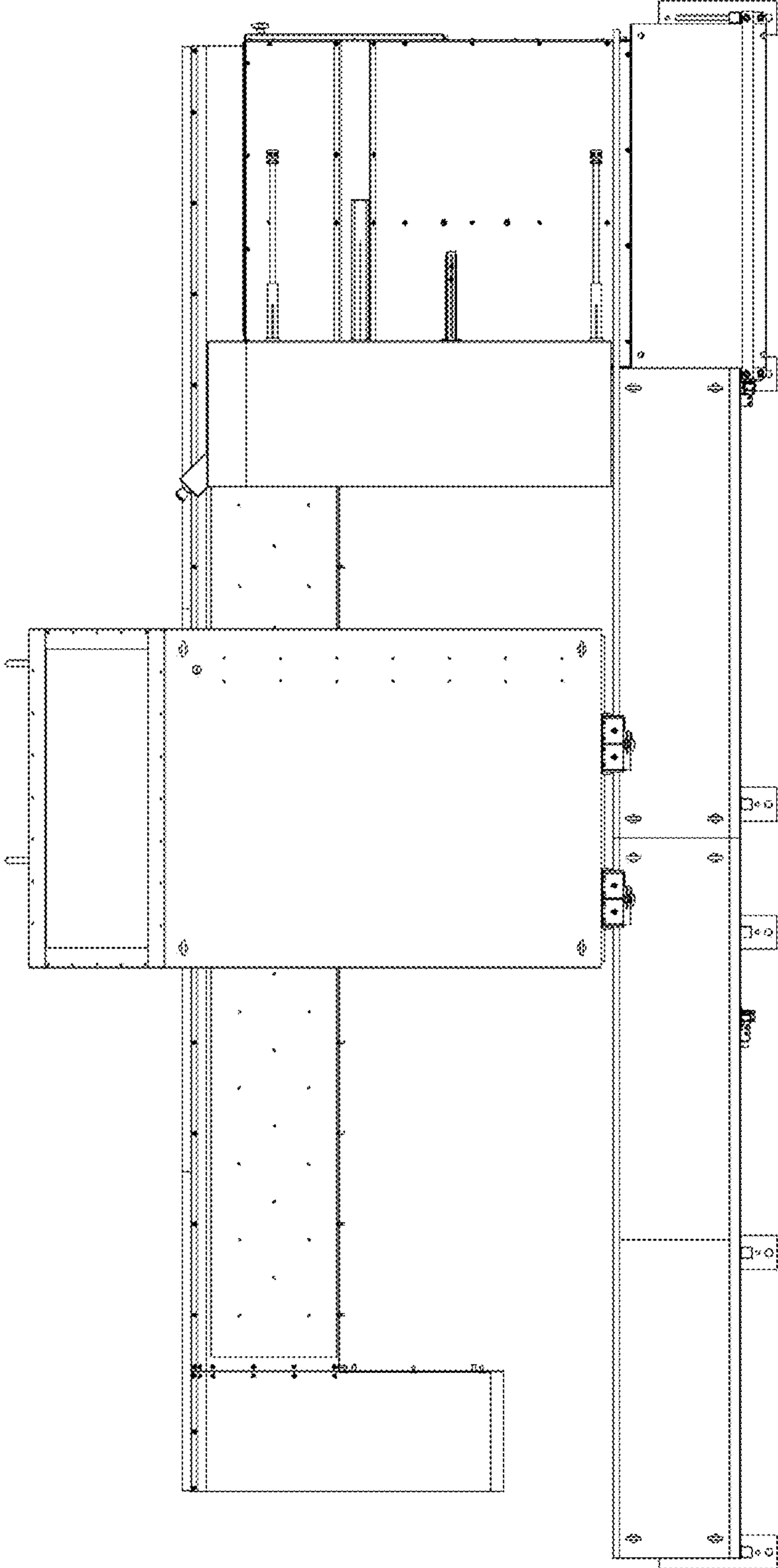

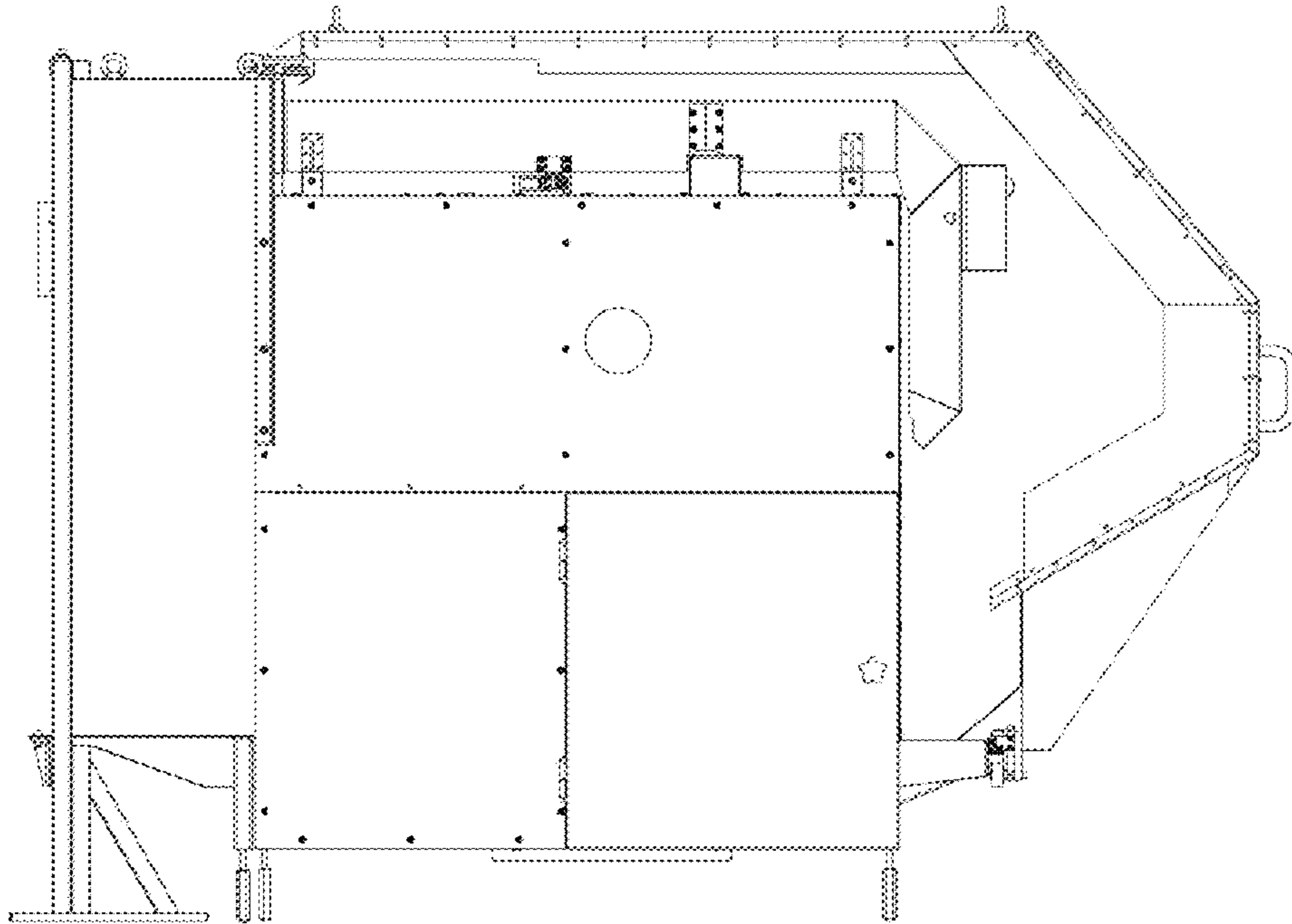

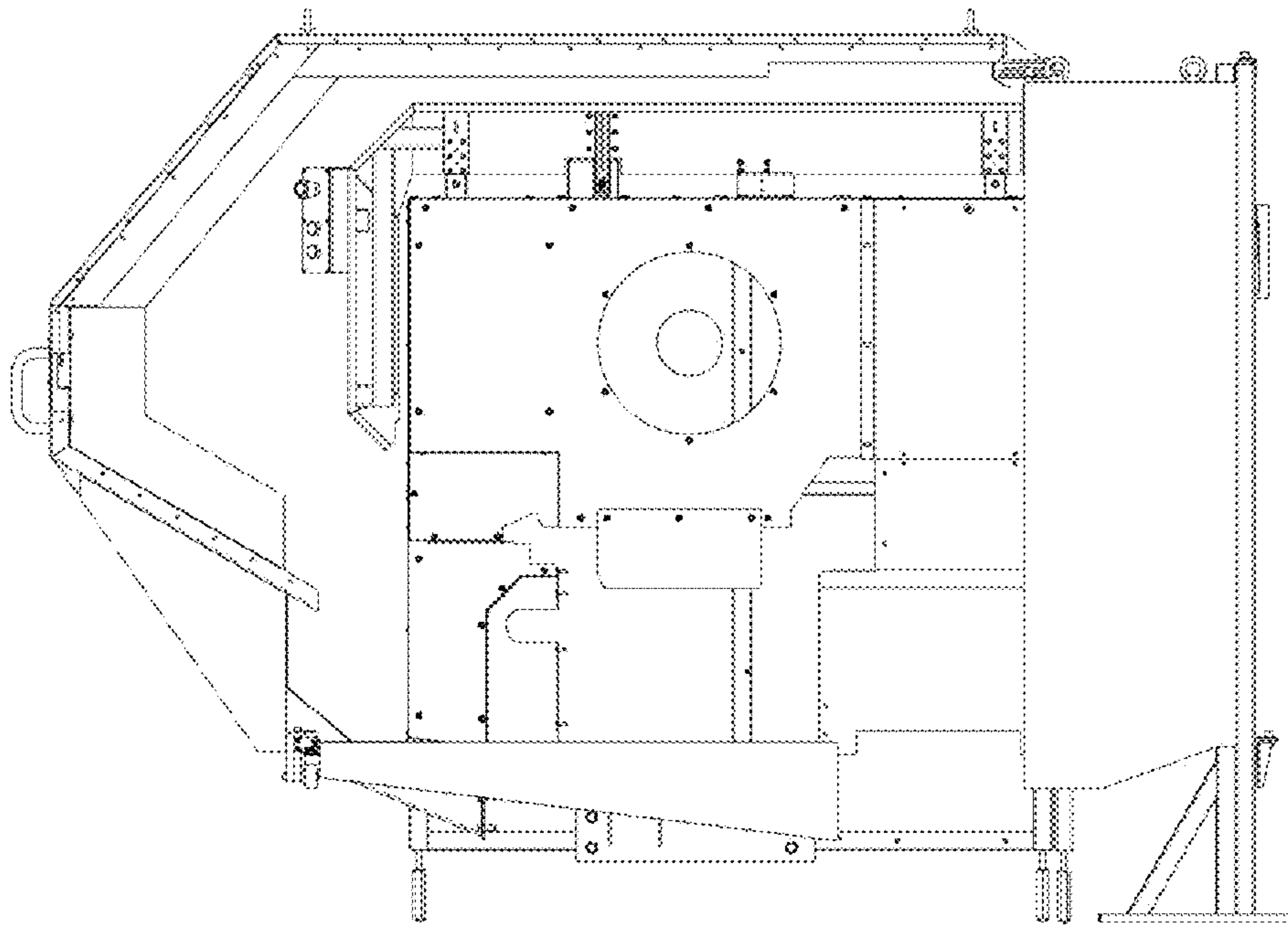

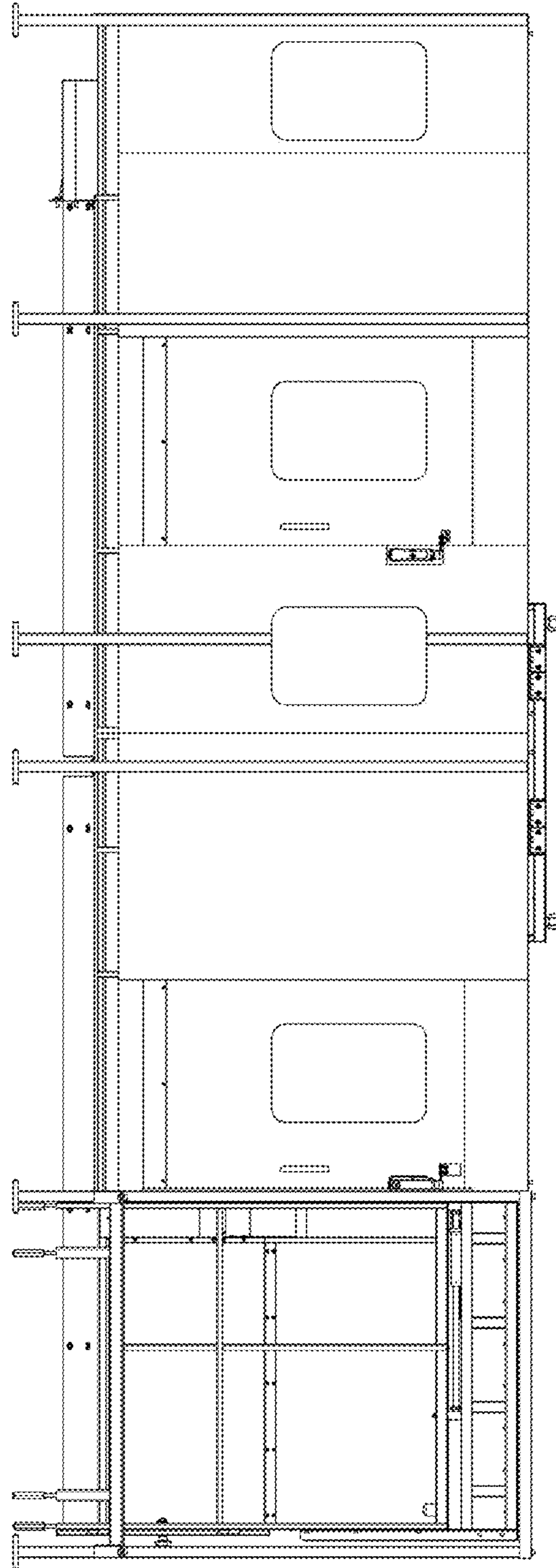

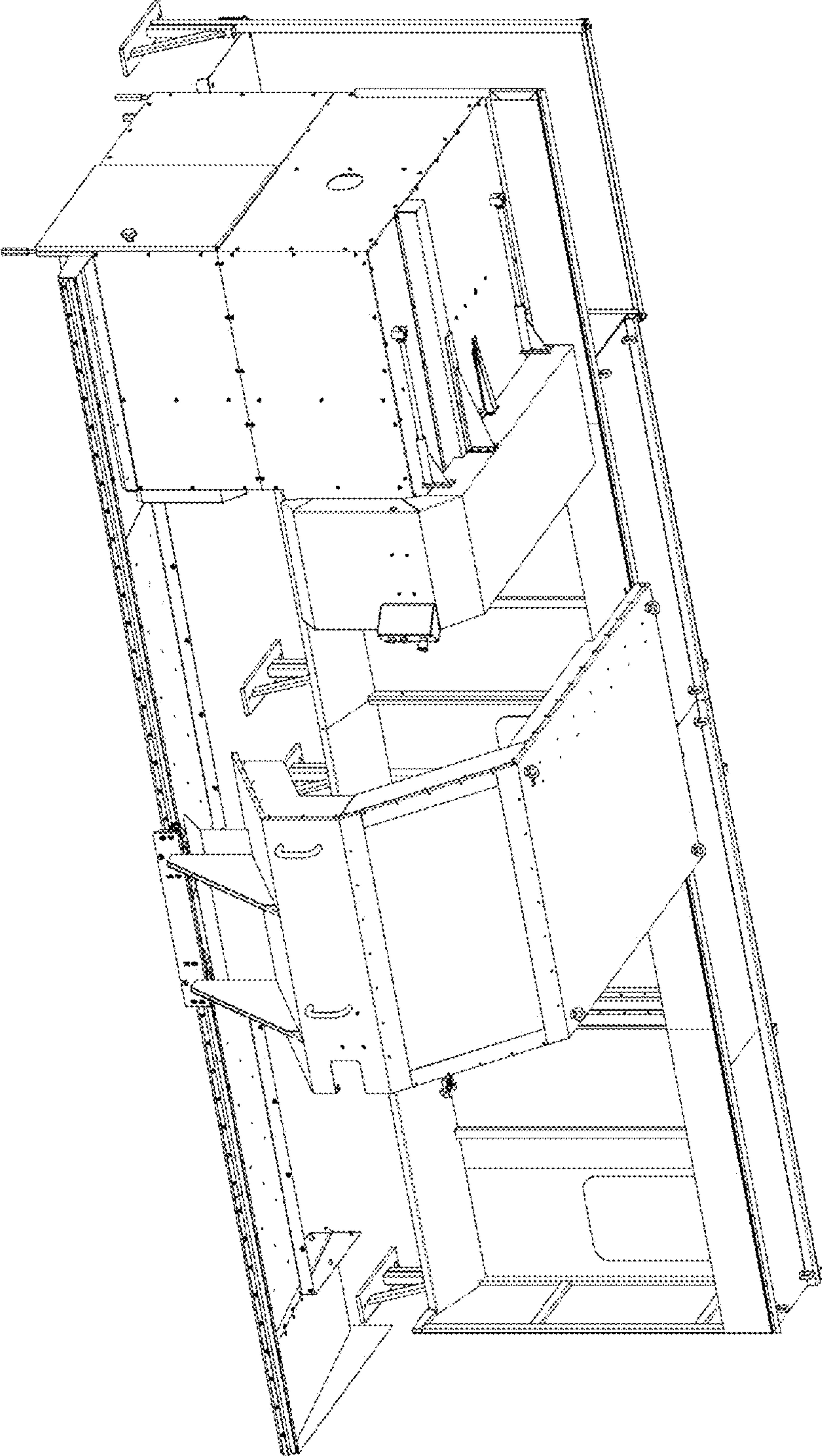

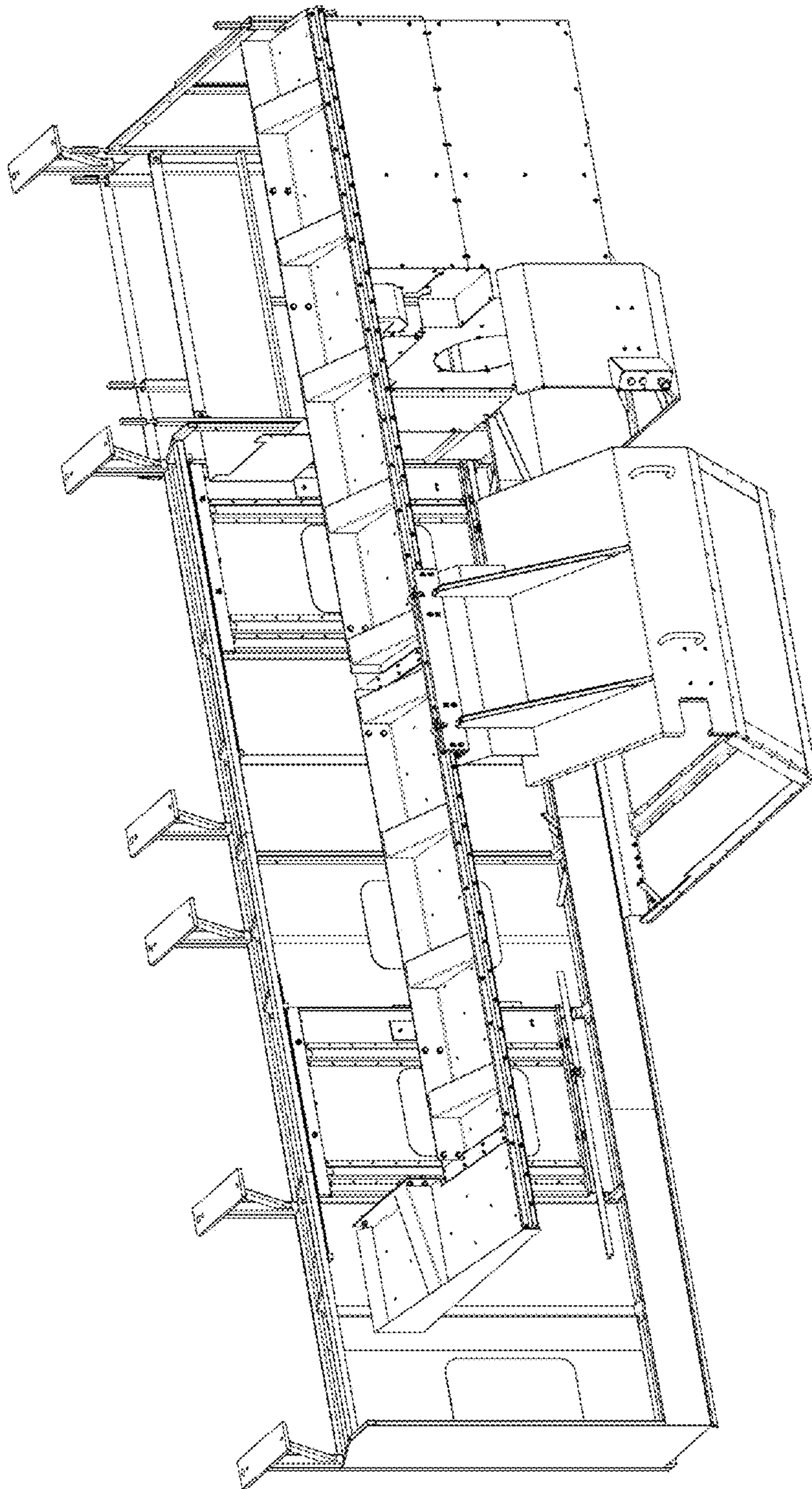
