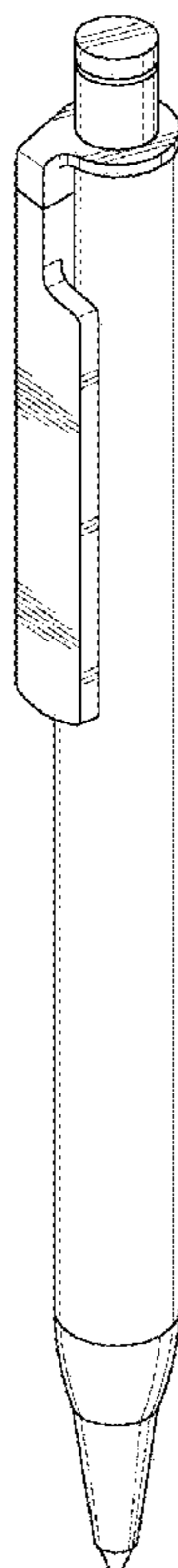
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a bottom, front, right perspective view of a ballpoint pen in accordance with my design;

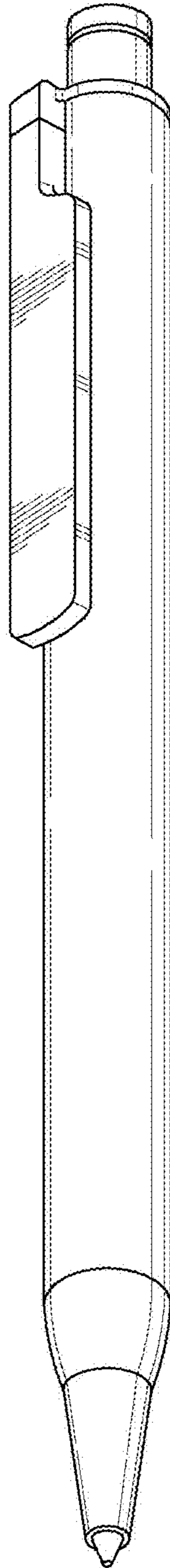

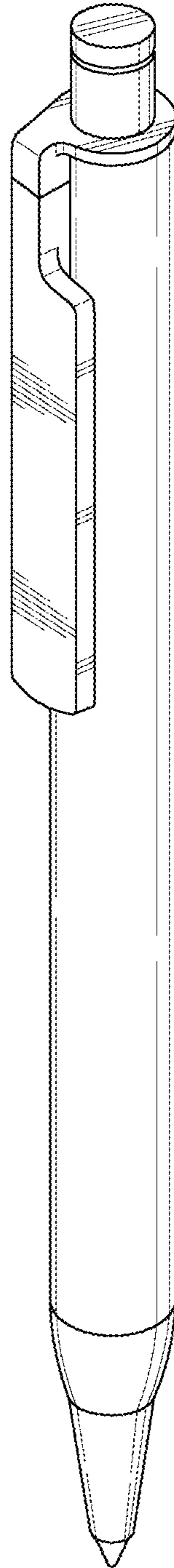

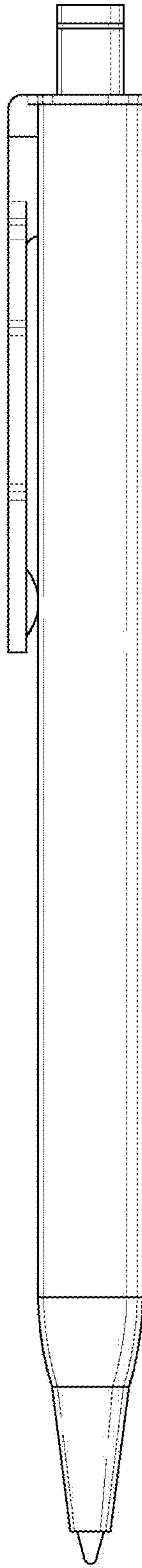

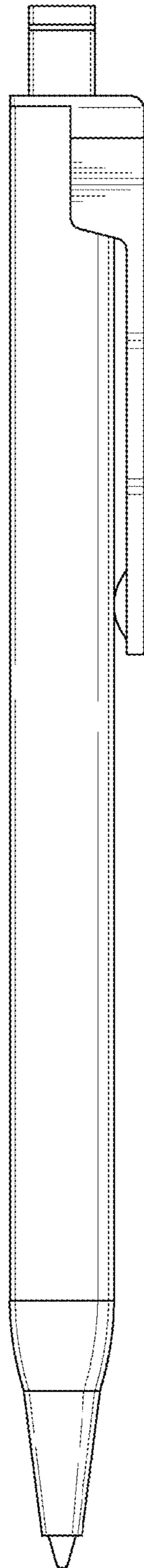

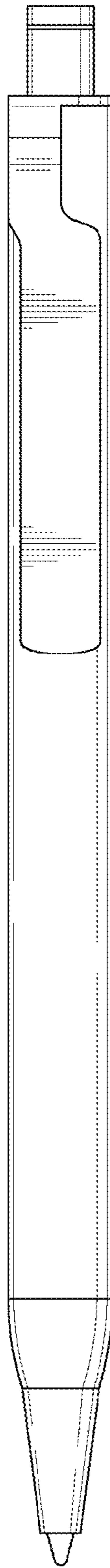

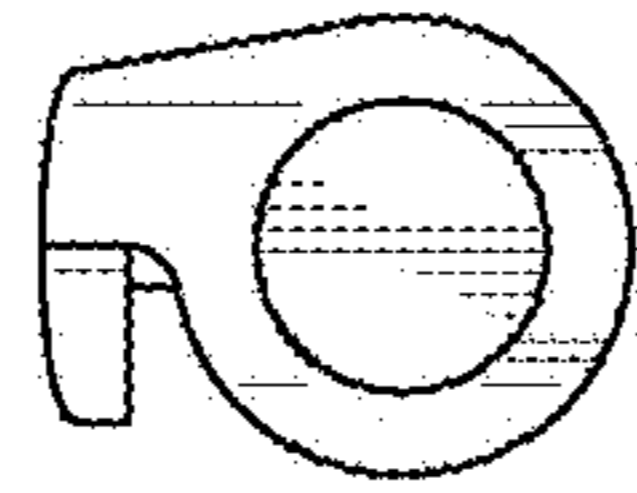

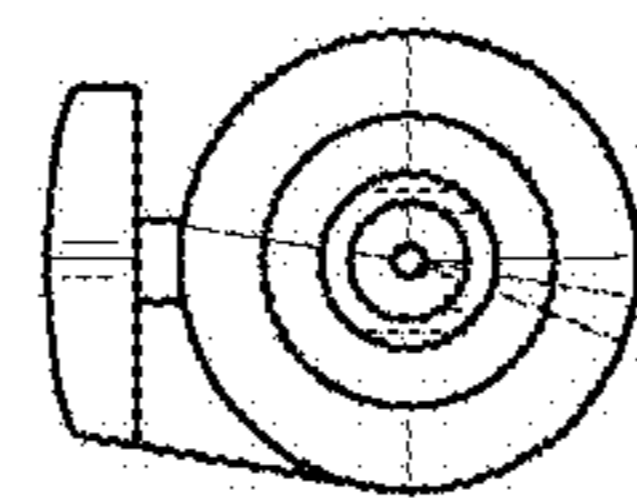
