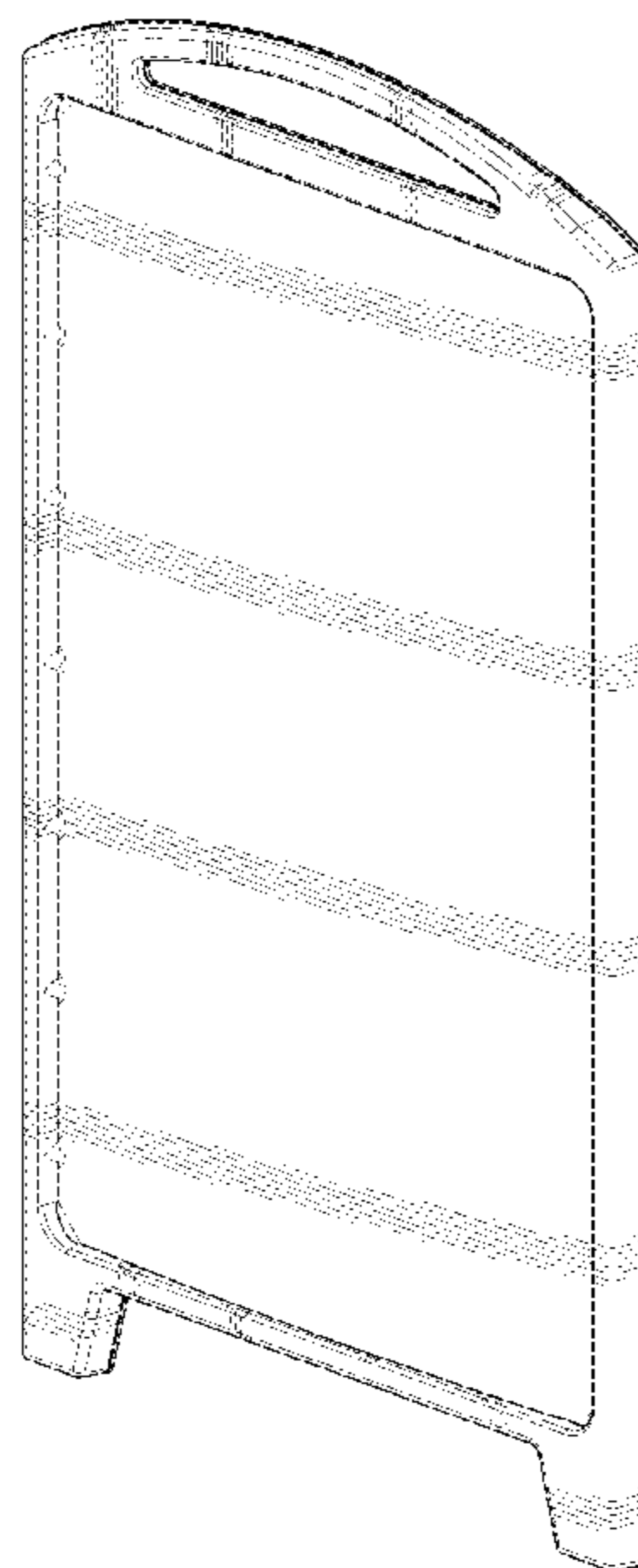
FIG. 1 is a front perspective view of a portable sign board;

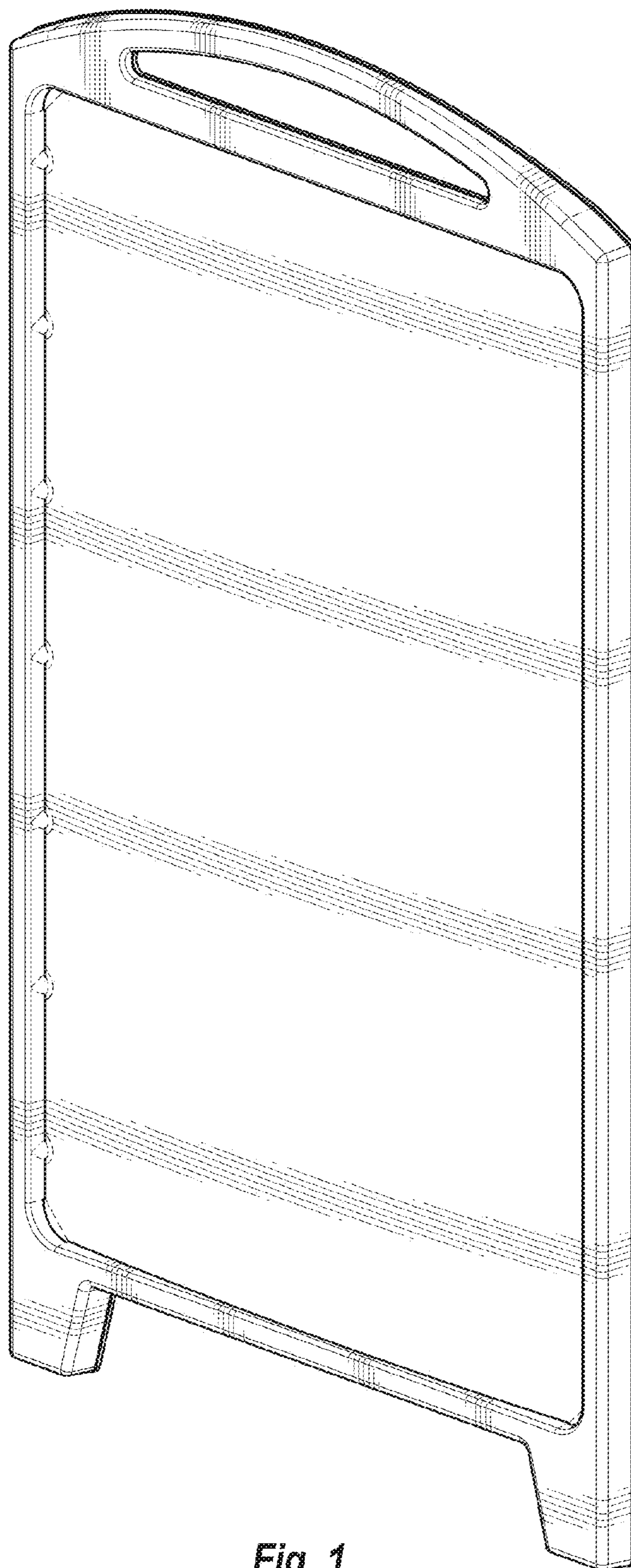

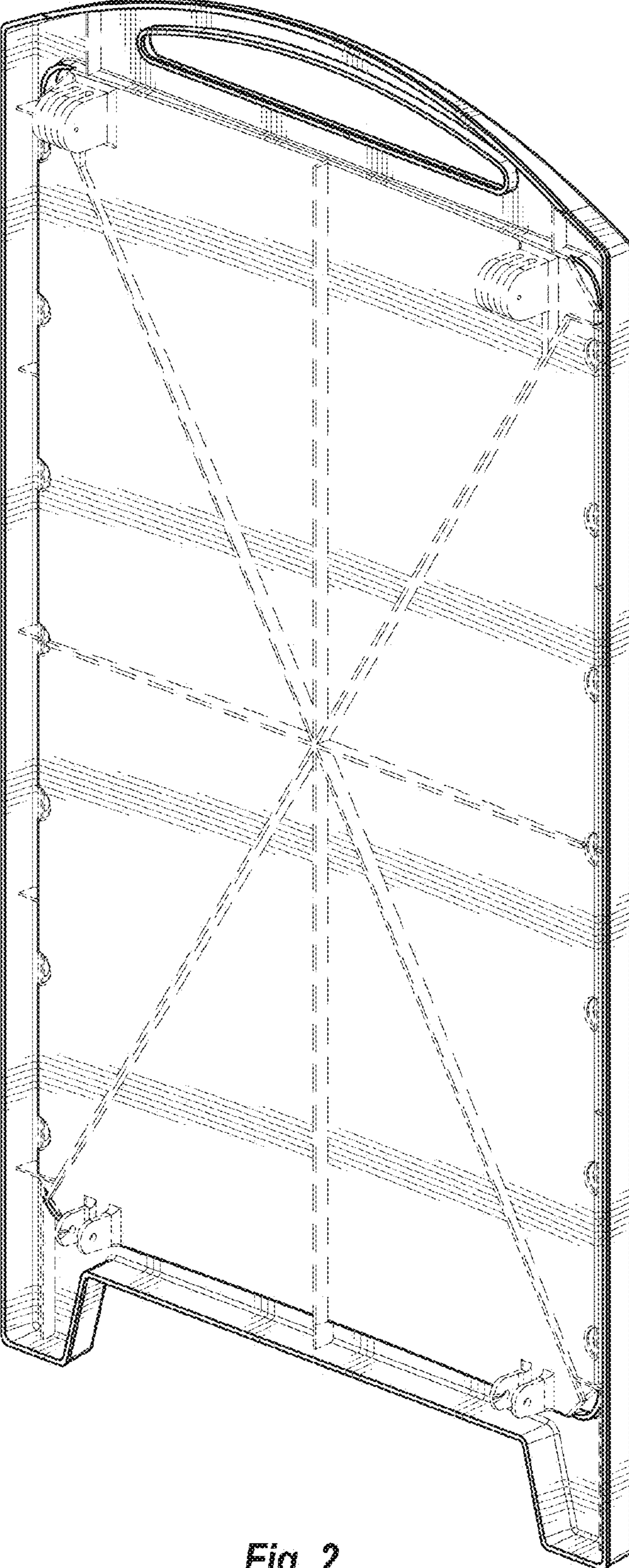

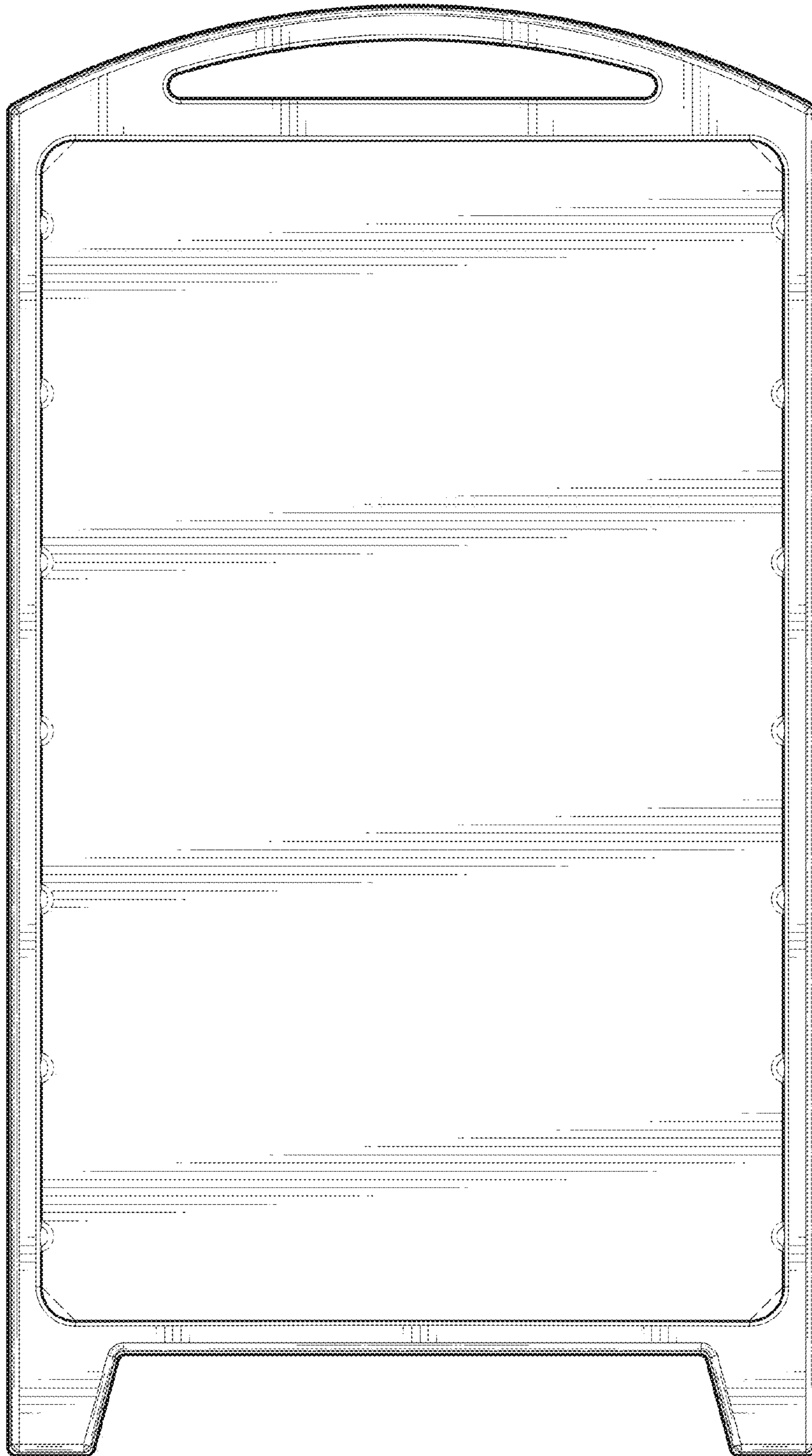

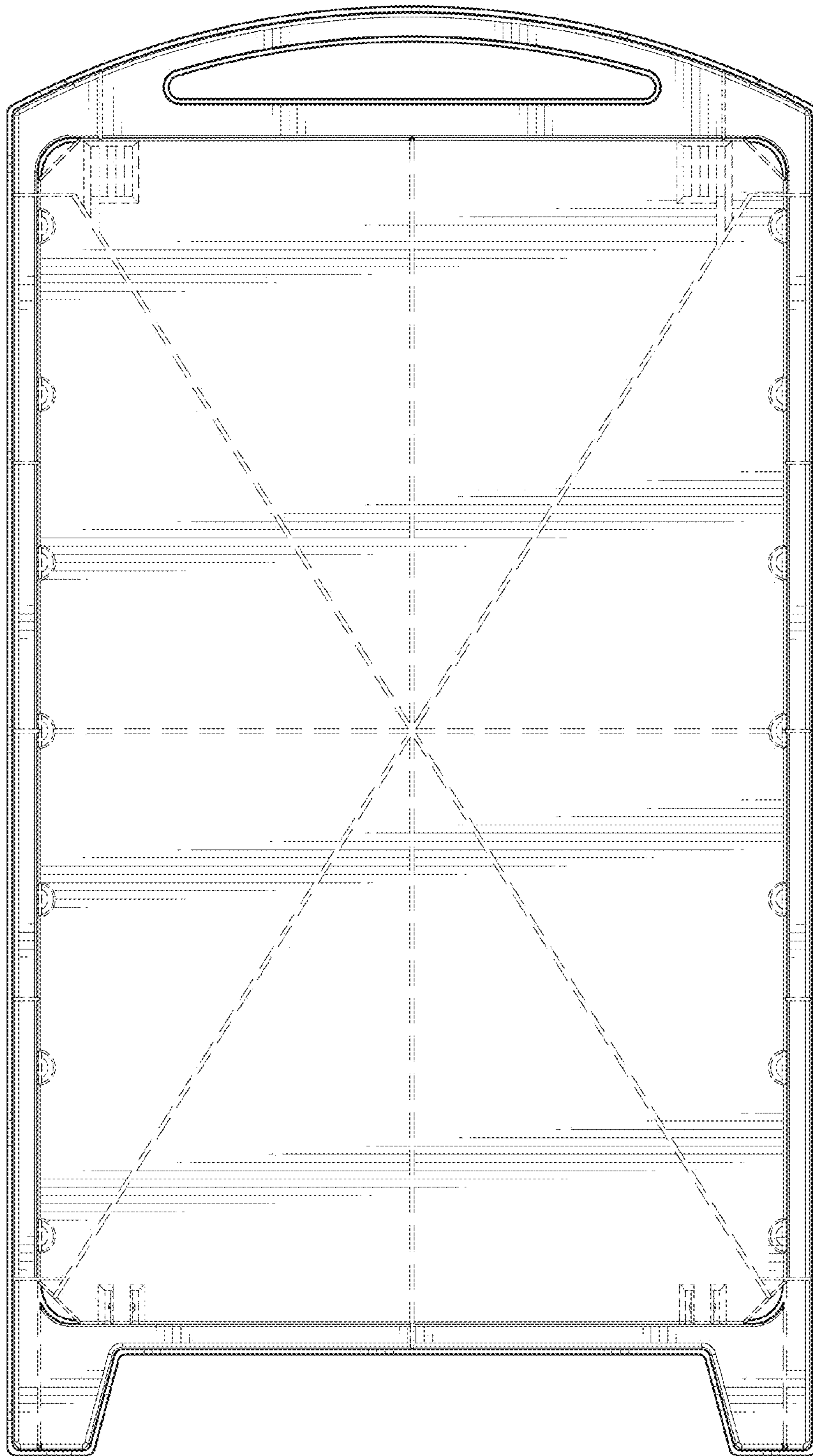

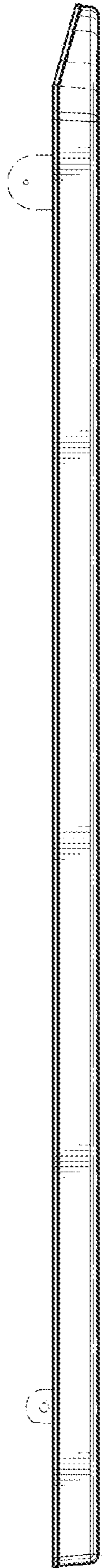

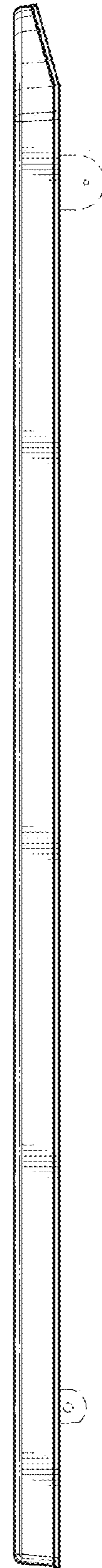

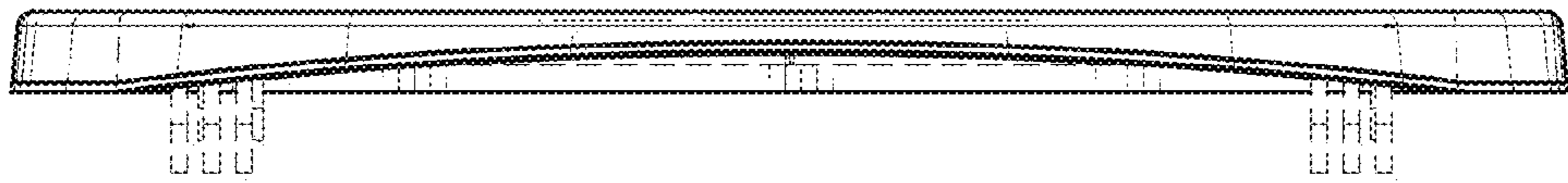

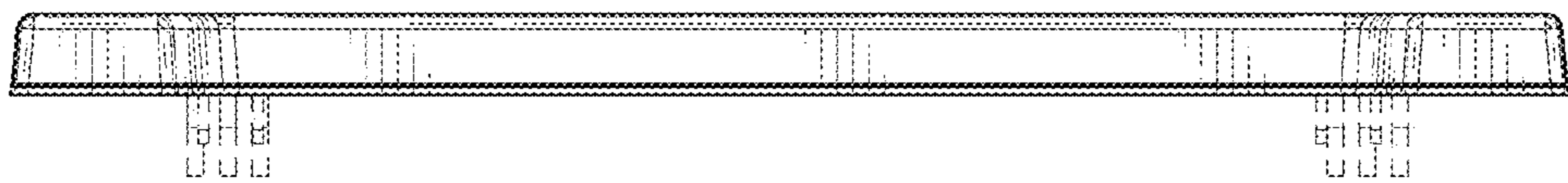
