**DESCRIPTION**

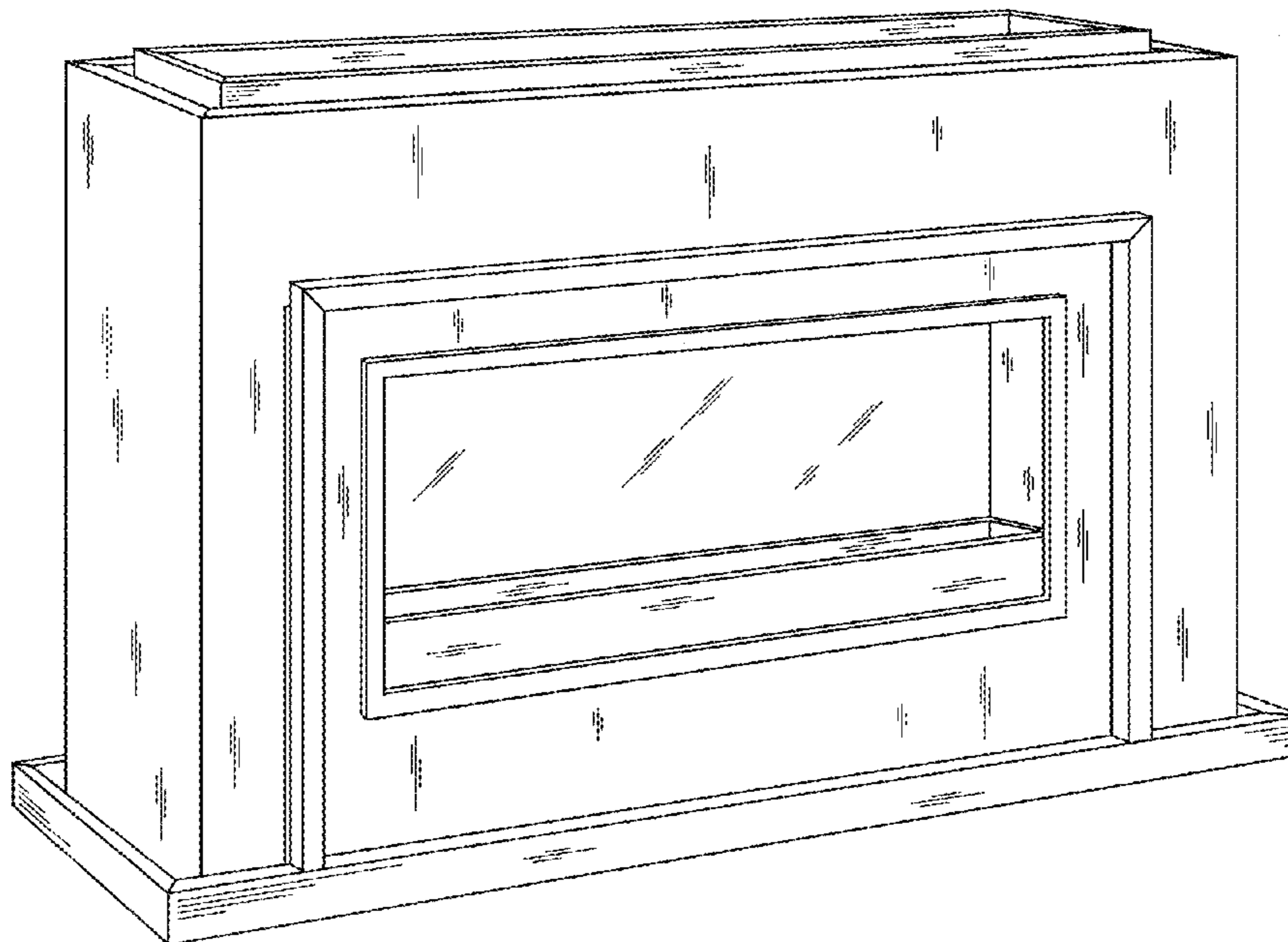

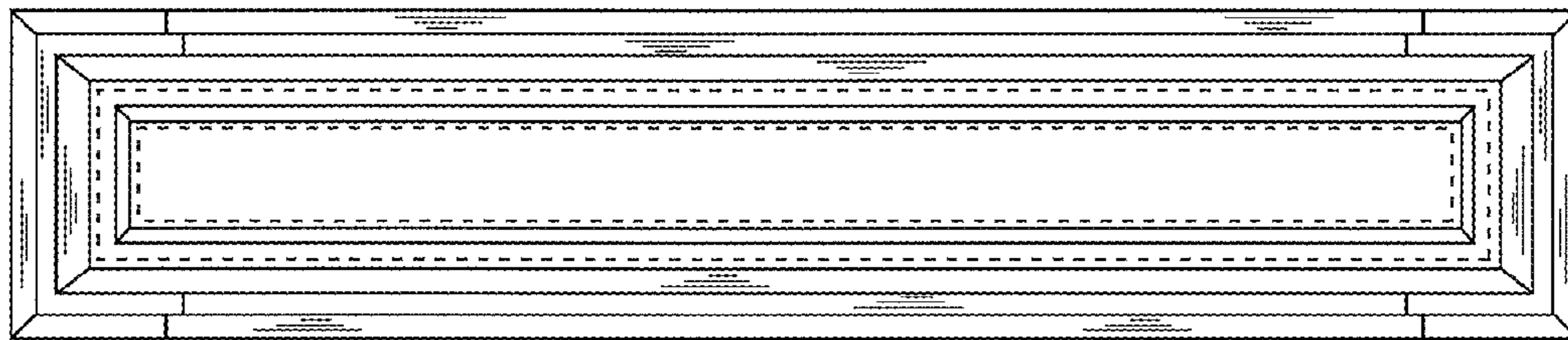

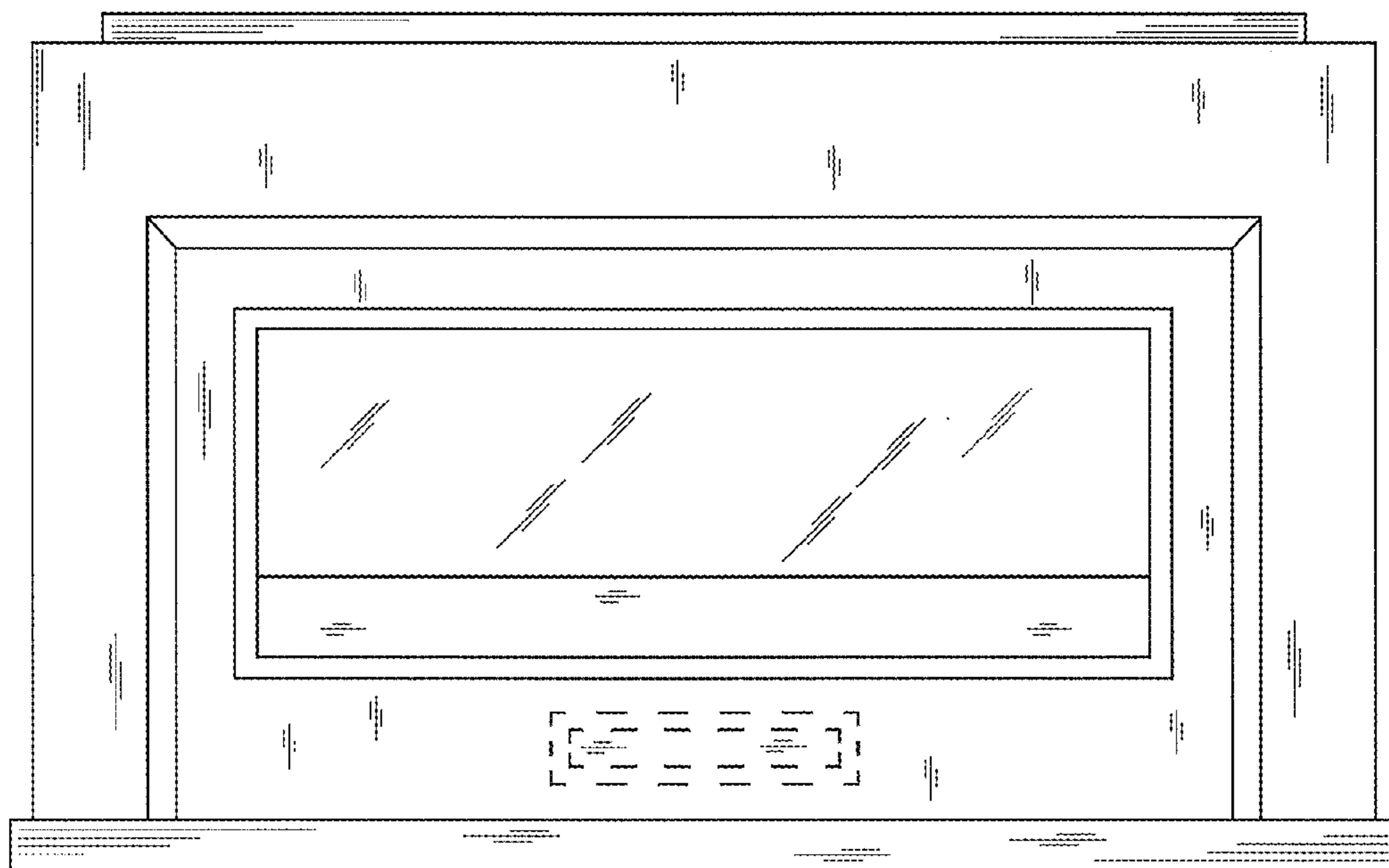

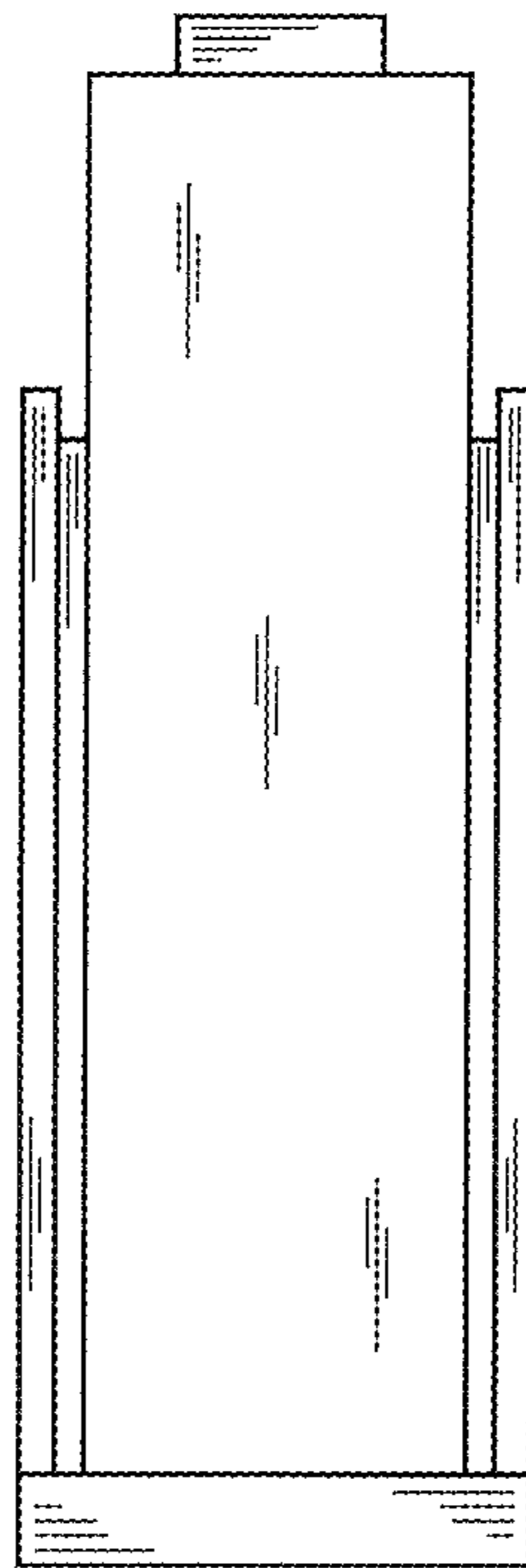

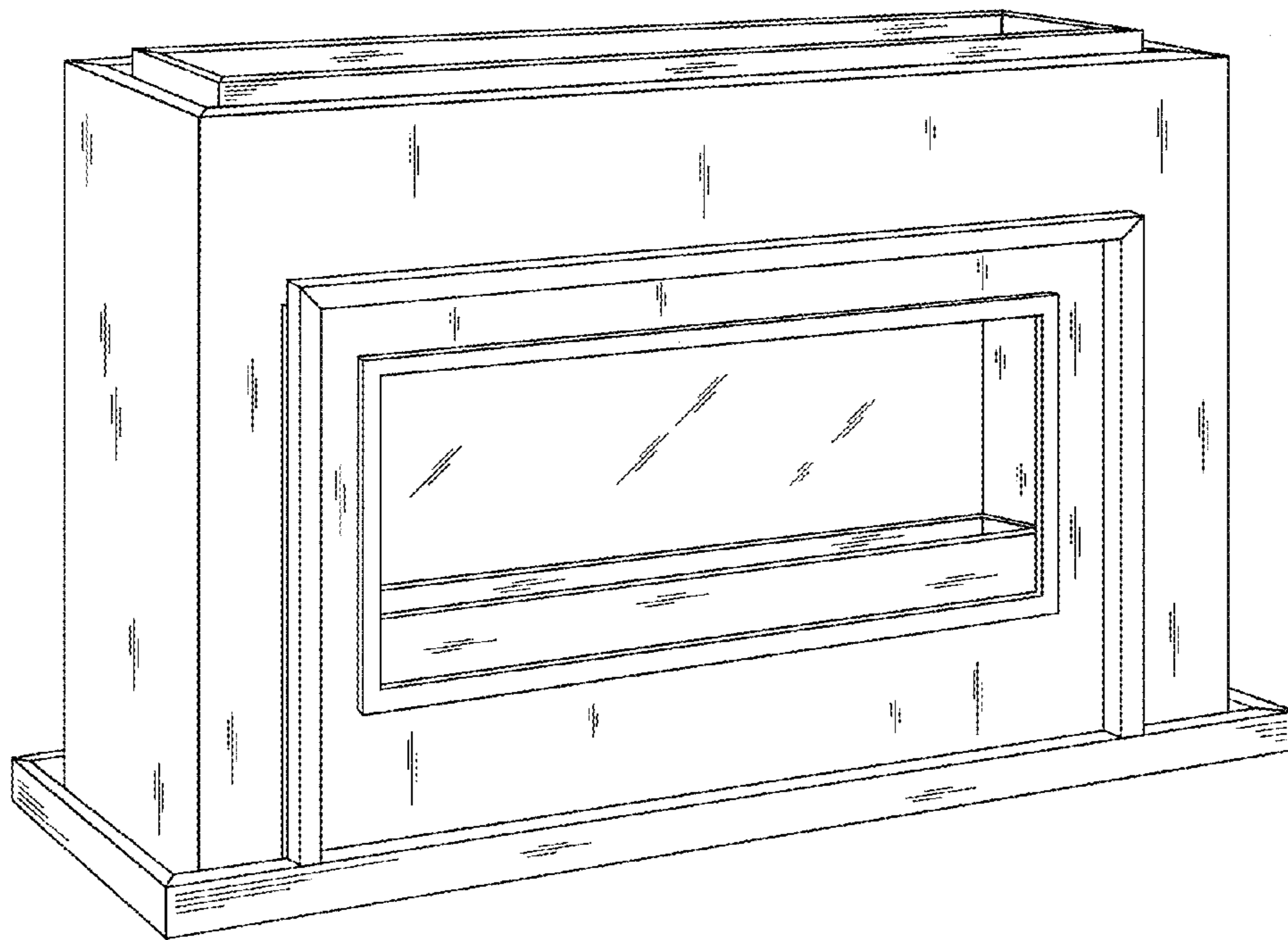
