DESCRIPTION
FIG. 1 is a left side elevational view of an e-cigarette according to our new design, with a right side elevational view being a mirror image thereof;

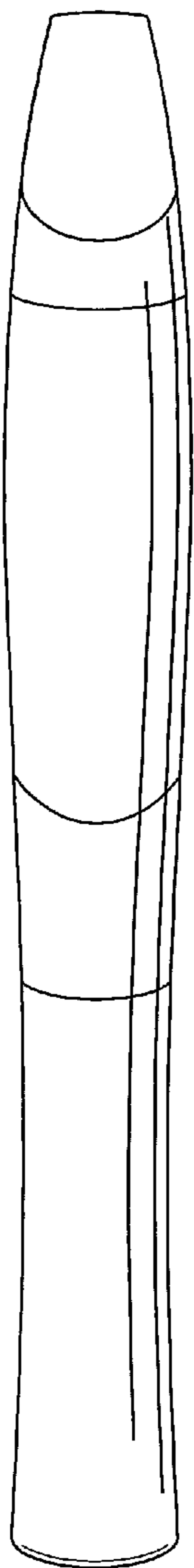

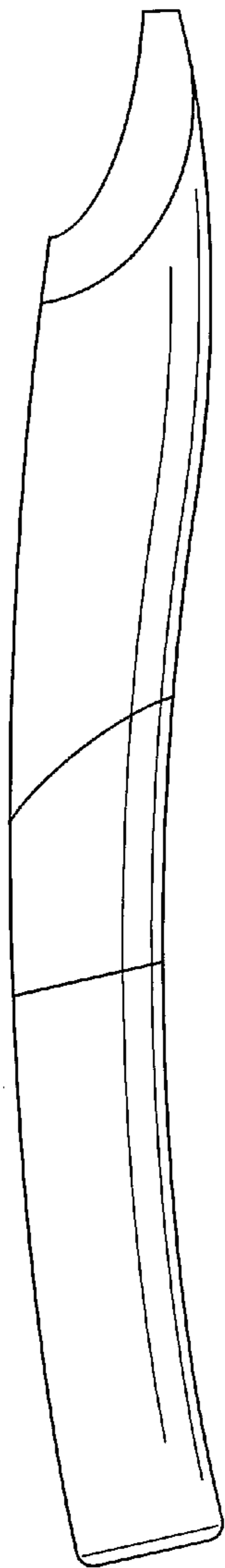

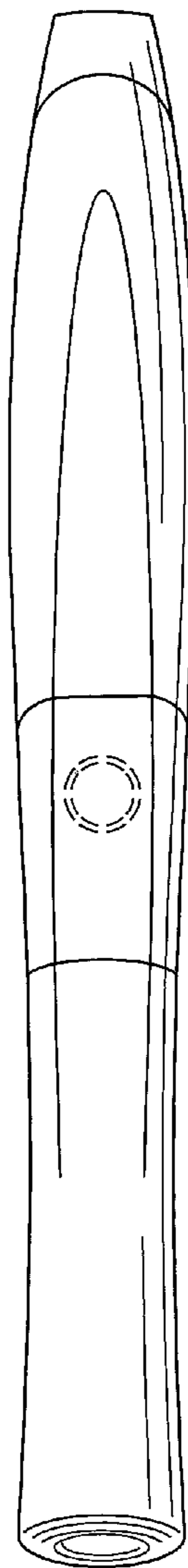

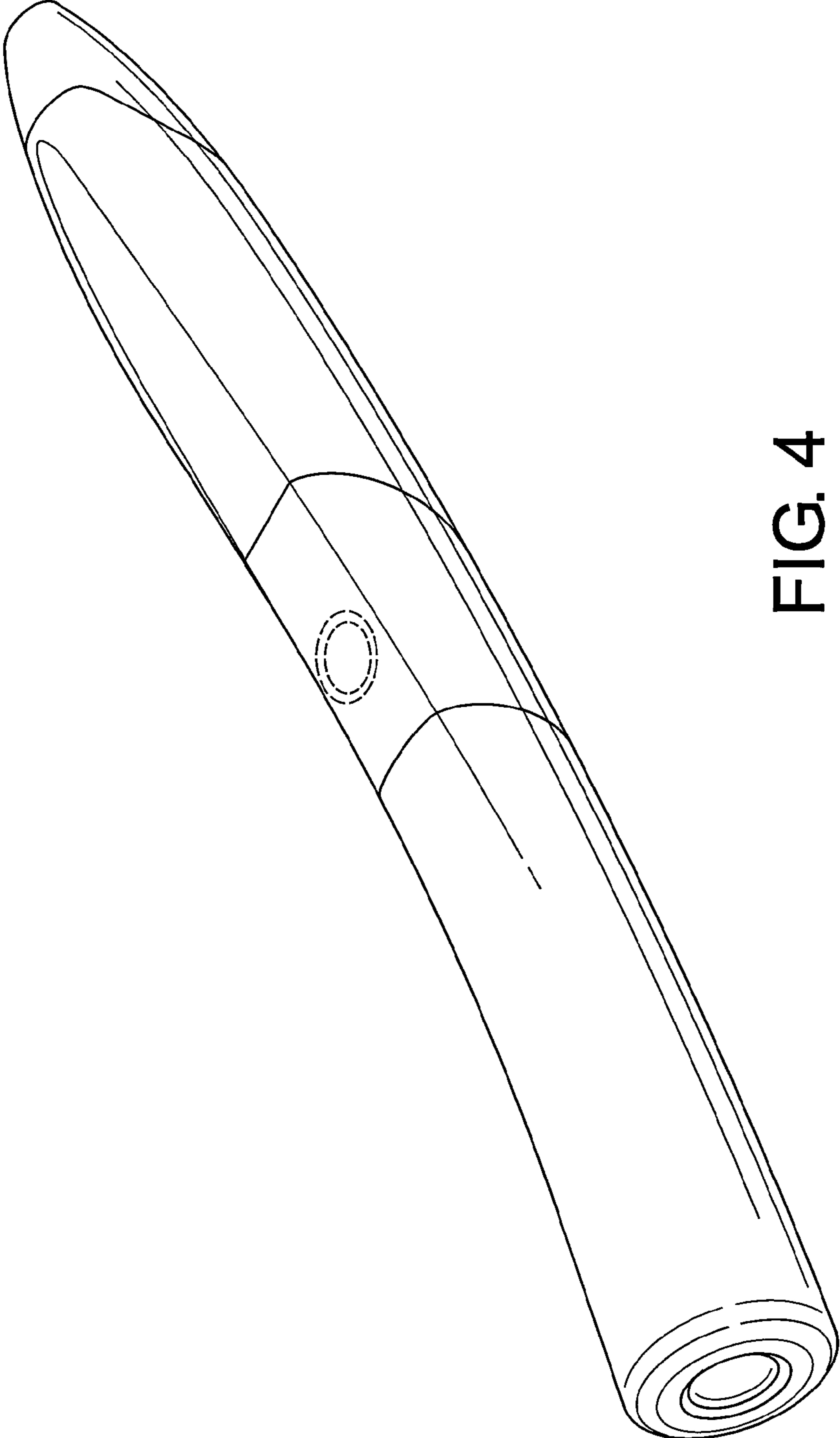
