(57) **CLAIM**

I claim the ornamental design for a prosthetic phallus retention undergarment, as shown and described.

**DESCRIPTION**

FIG. 1 is a view in front elevation of a prosthetic phallus retention undergarment showing my design;

FIG. 2 is a view in rear elevation of the prosthetic phallus retention undergarment of FIG. 1;

FIG. 3 is a bottom plan view of the prosthetic phallus retention undergarment of FIG. 1;

FIG. 4 is a top plan view of the prosthetic phallus retention undergarment of FIG. 1;

FIG. 5 is a view in left side elevation of the prosthetic phallus retention undergarment of FIG. 1;

FIG. 6 is a view in right side elevation of the prosthetic phallus retention undergarment of FIG. 1;

FIG. 7 is a view in front elevation of the prosthetic phallus retention undergarment of FIG. 1 in an inside-out configuration;

FIG. 8 is a view in rear elevation of the prosthetic phallus retention undergarment of FIG. 1 in an inside-out configuration;

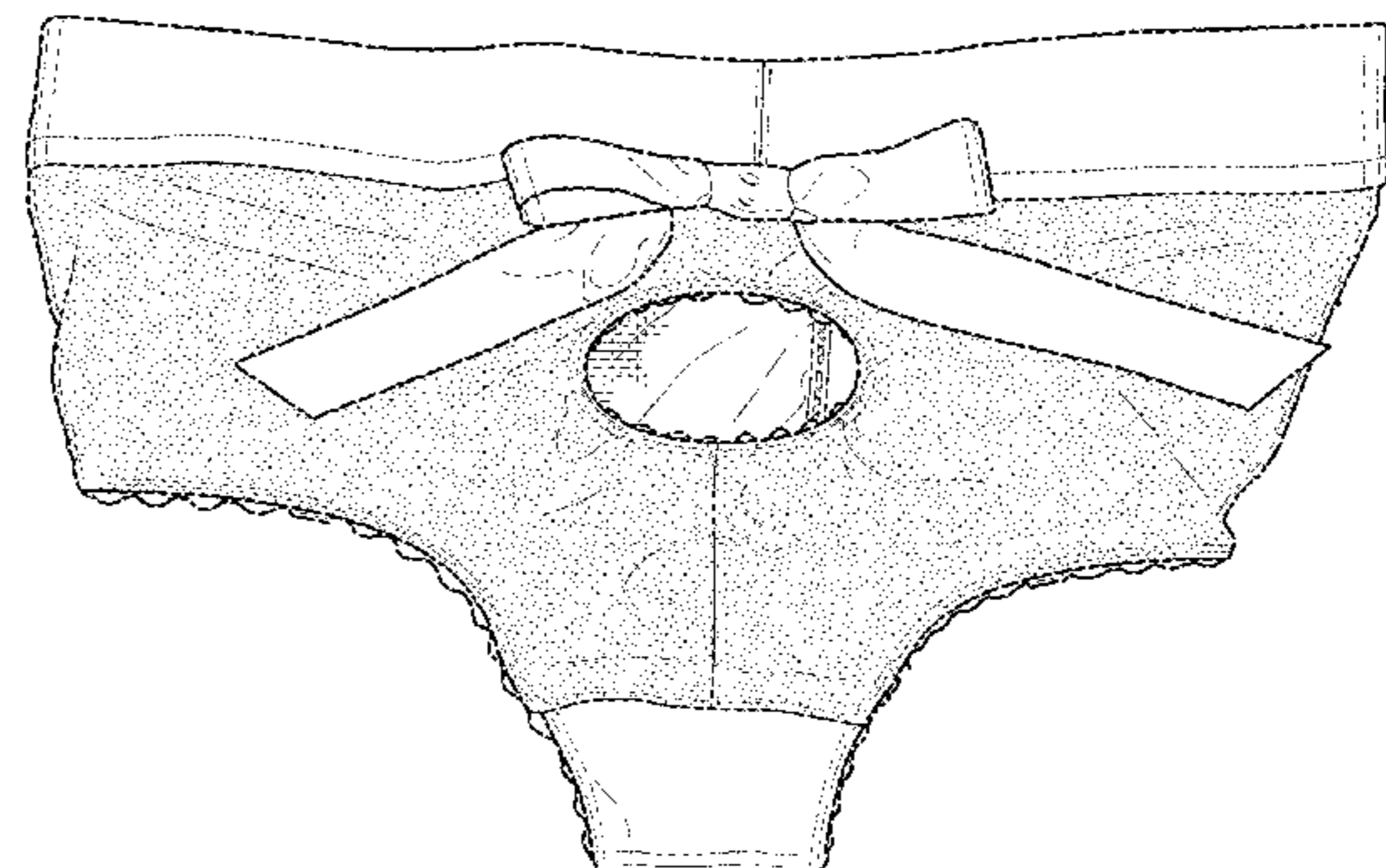
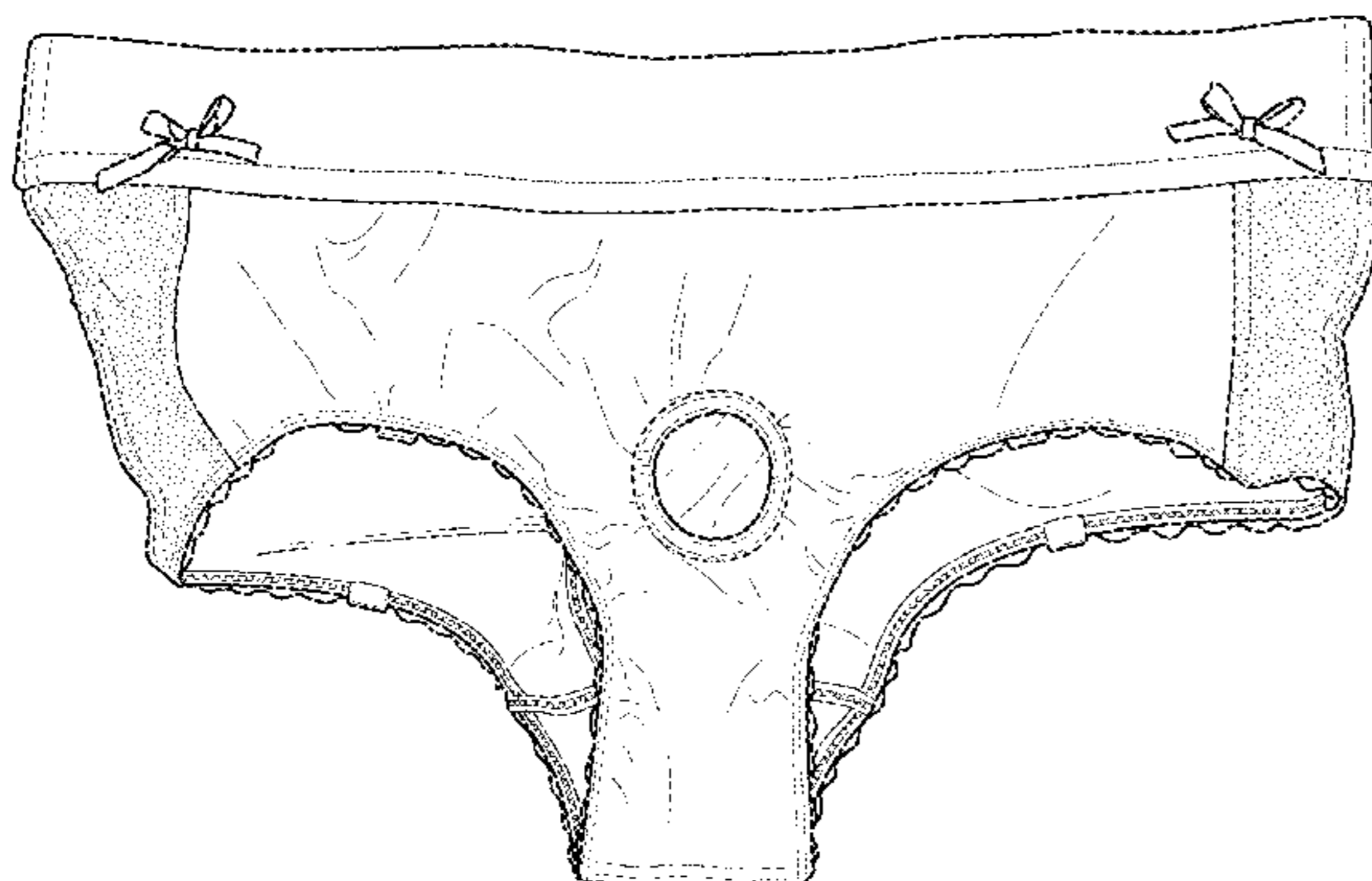
FIG. 9 is a view in front elevation of the prosthetic phallus retention undergarment of FIG. 1 in an inside-out configuration with the rear flaps opened; and,

FIG. 10 is an enlarged fragmentary view of FIG. 1 showing the phallus retention aperture portion of the prosthetic phallus retention undergarment in an inside-out configuration with the top ends of the rear flaps cut away to permit pivoting of the rear flaps to an opened position.

The outer most horizontal top and bottom broken lines shown in FIG. 10 represent the boundaries of the partial view and form no part of the claim. All remaining broken lines represent features of the prosthetic phallus retention undergarment that form no part of claimed design.

The mesh pattern is shown only on portions of the panels for ease of viewing and illustration. The mesh pattern covers the entire panel on which the portion or portions of the mesh pattern is shown. The stippling represents a contrasting material from the non-stippled material.

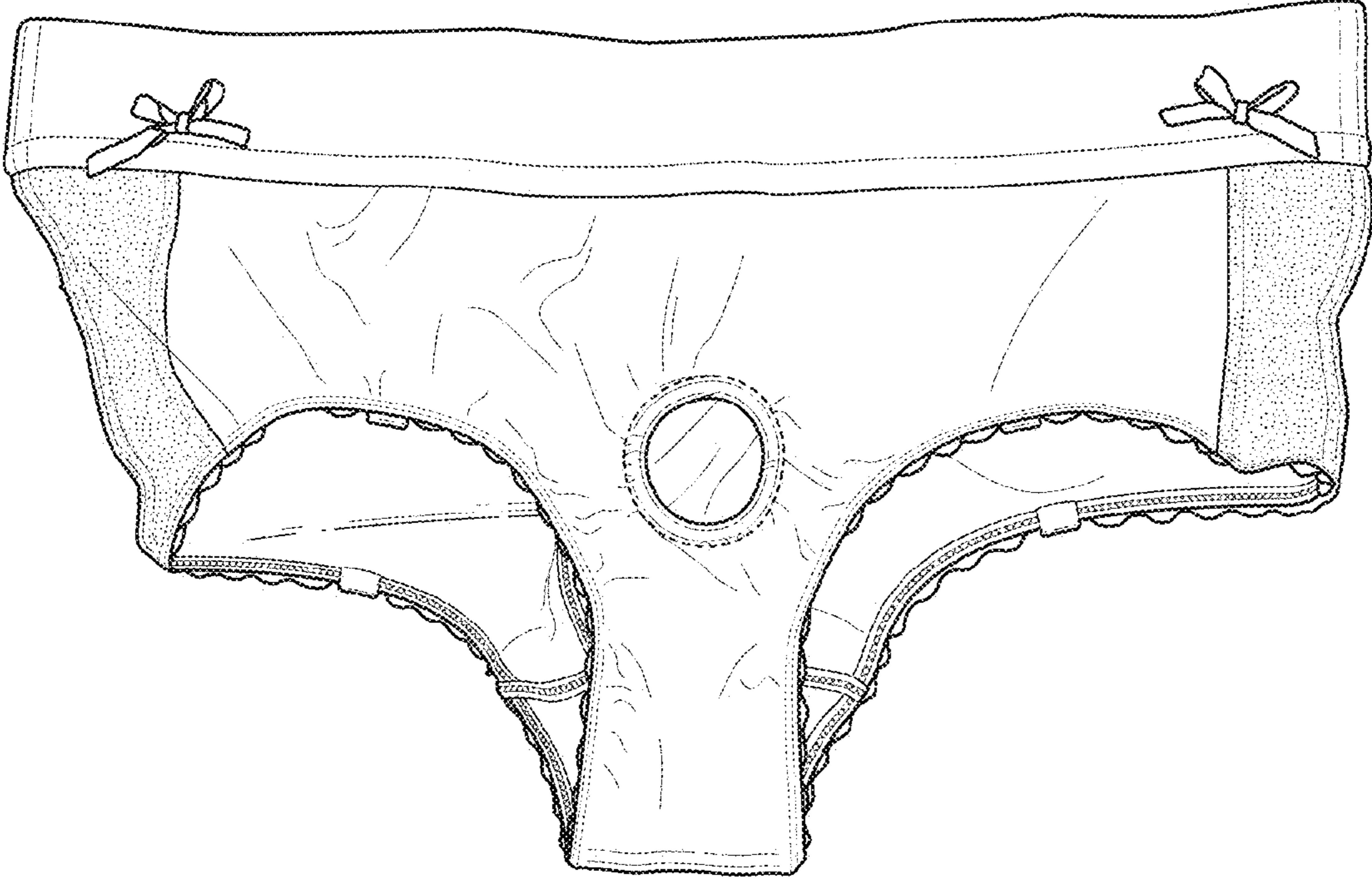

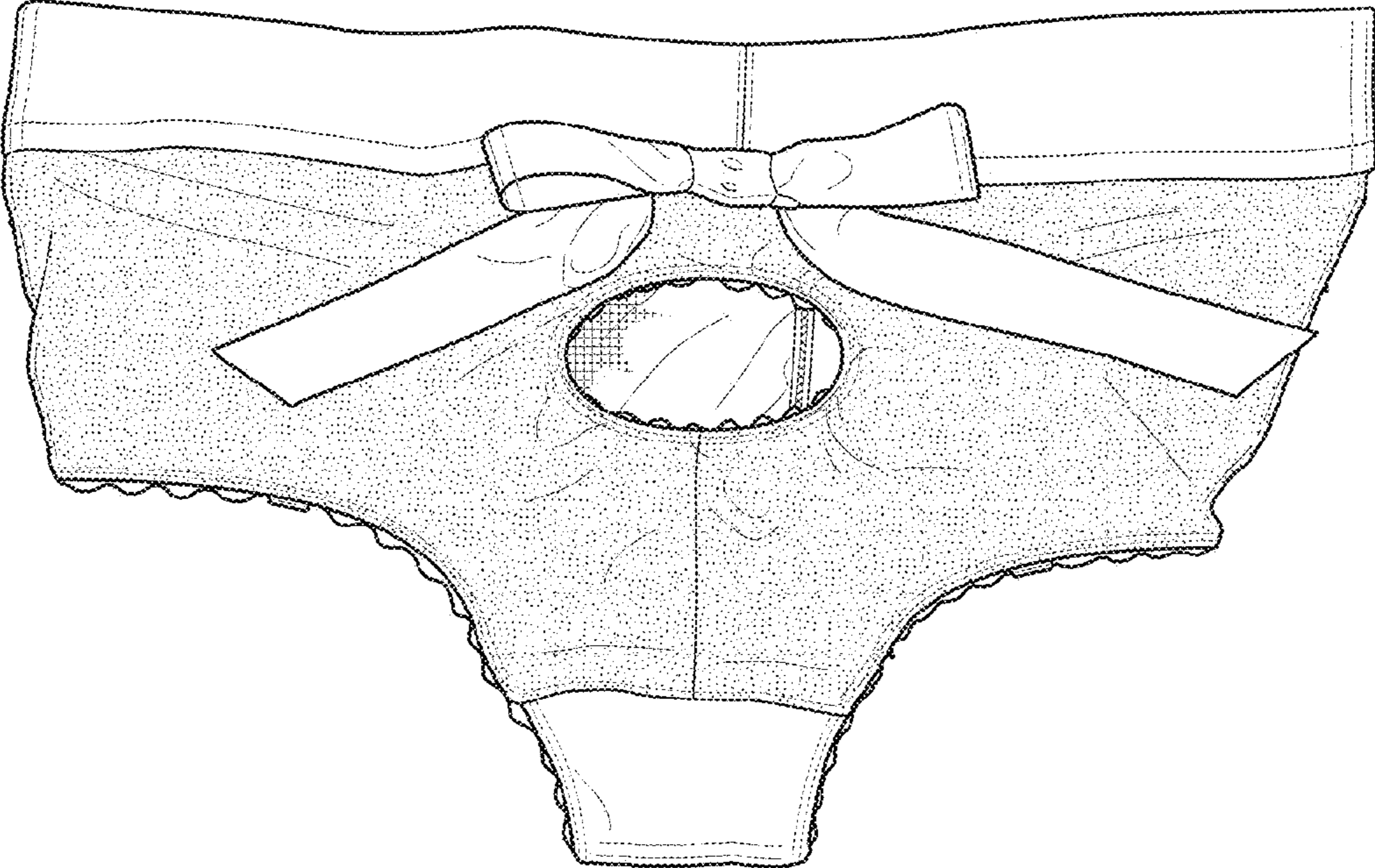

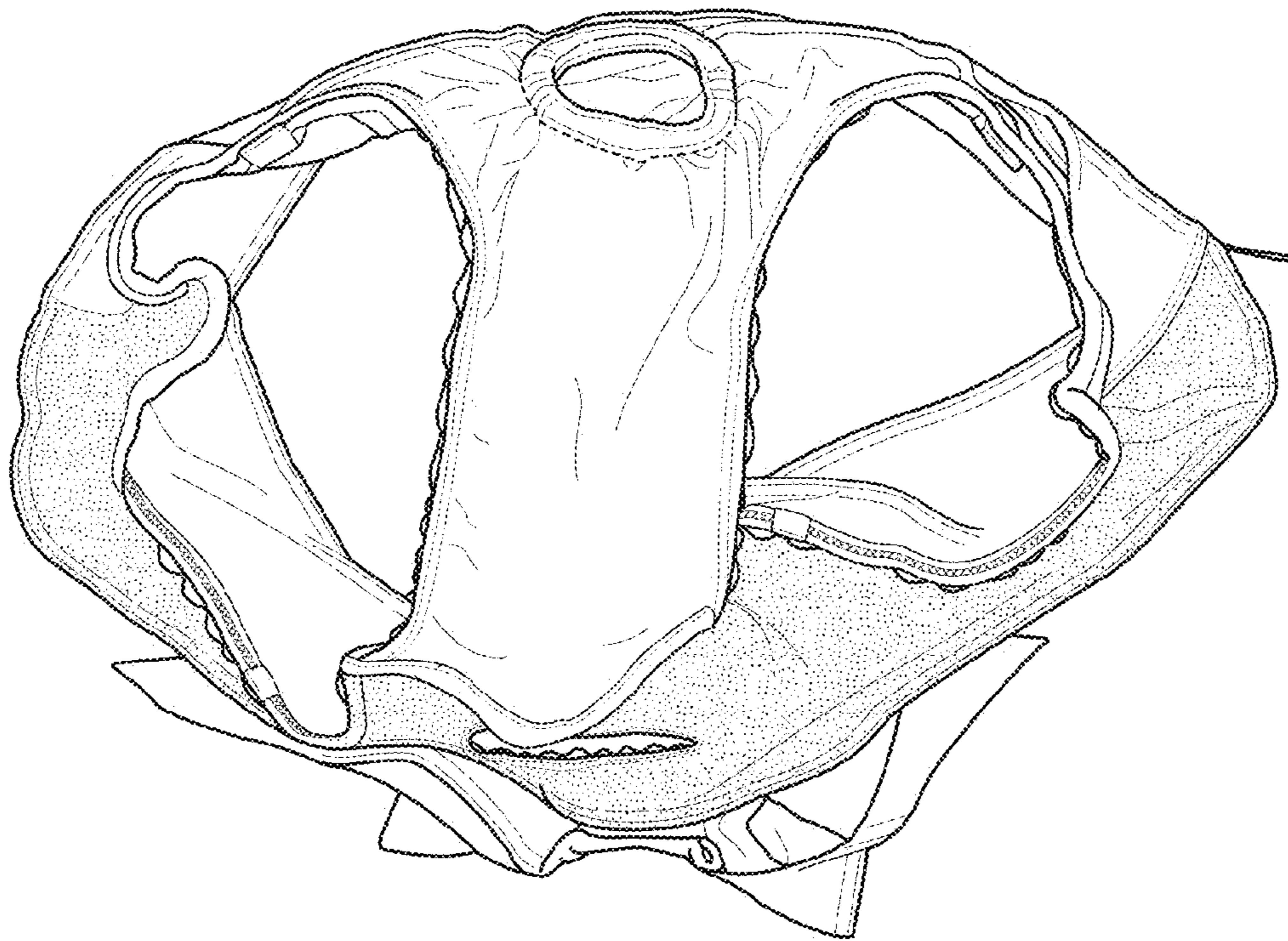

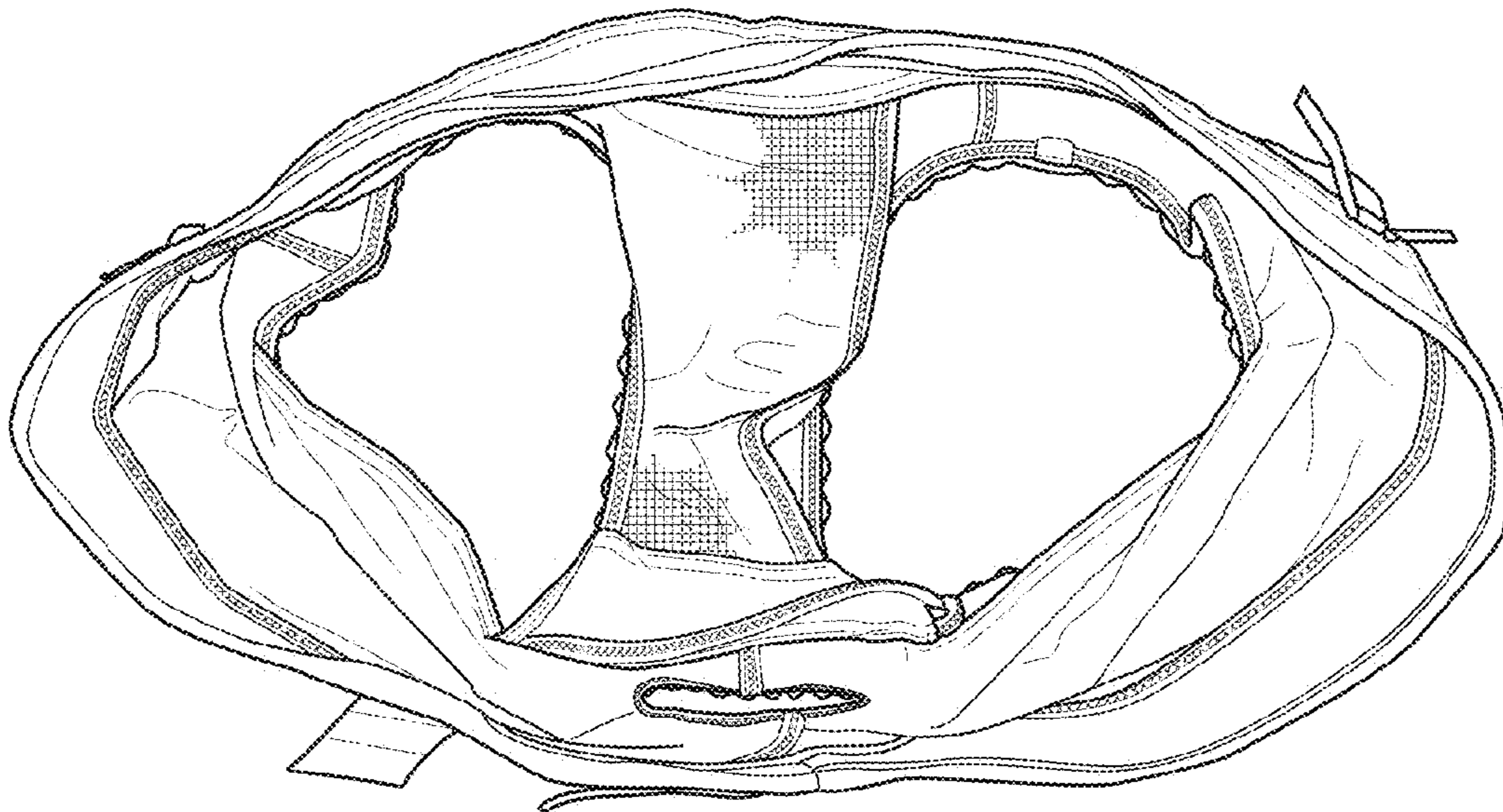

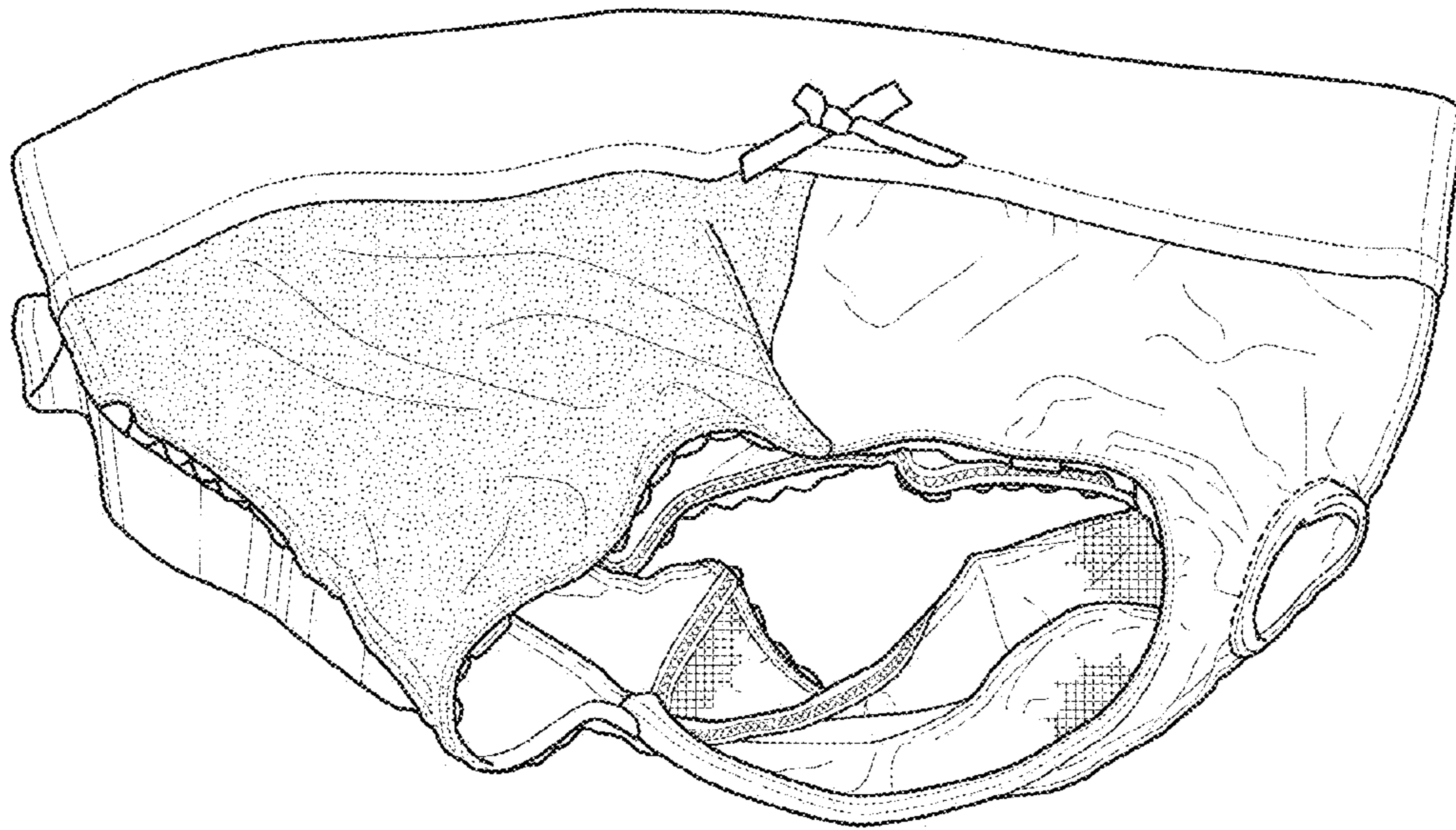

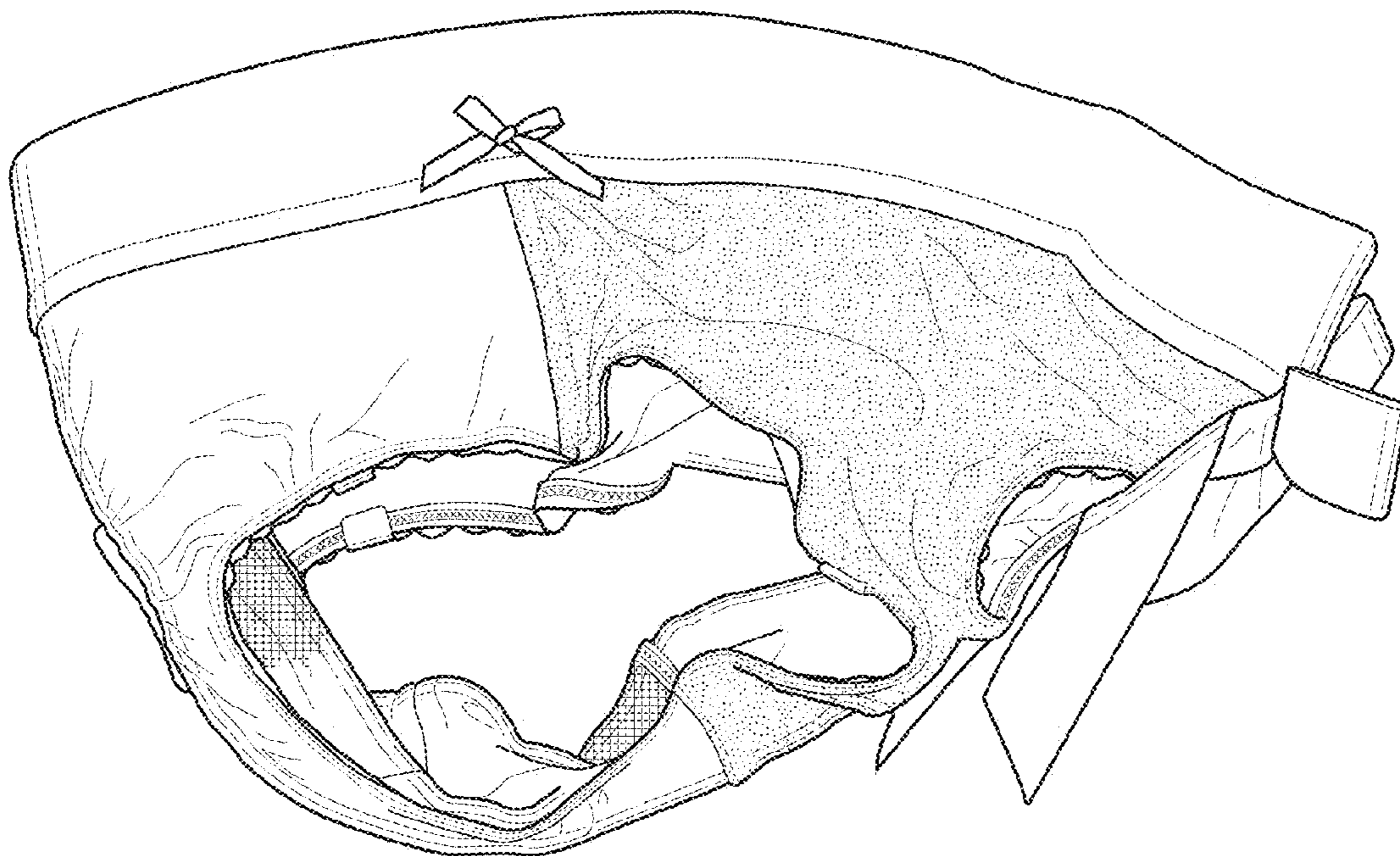

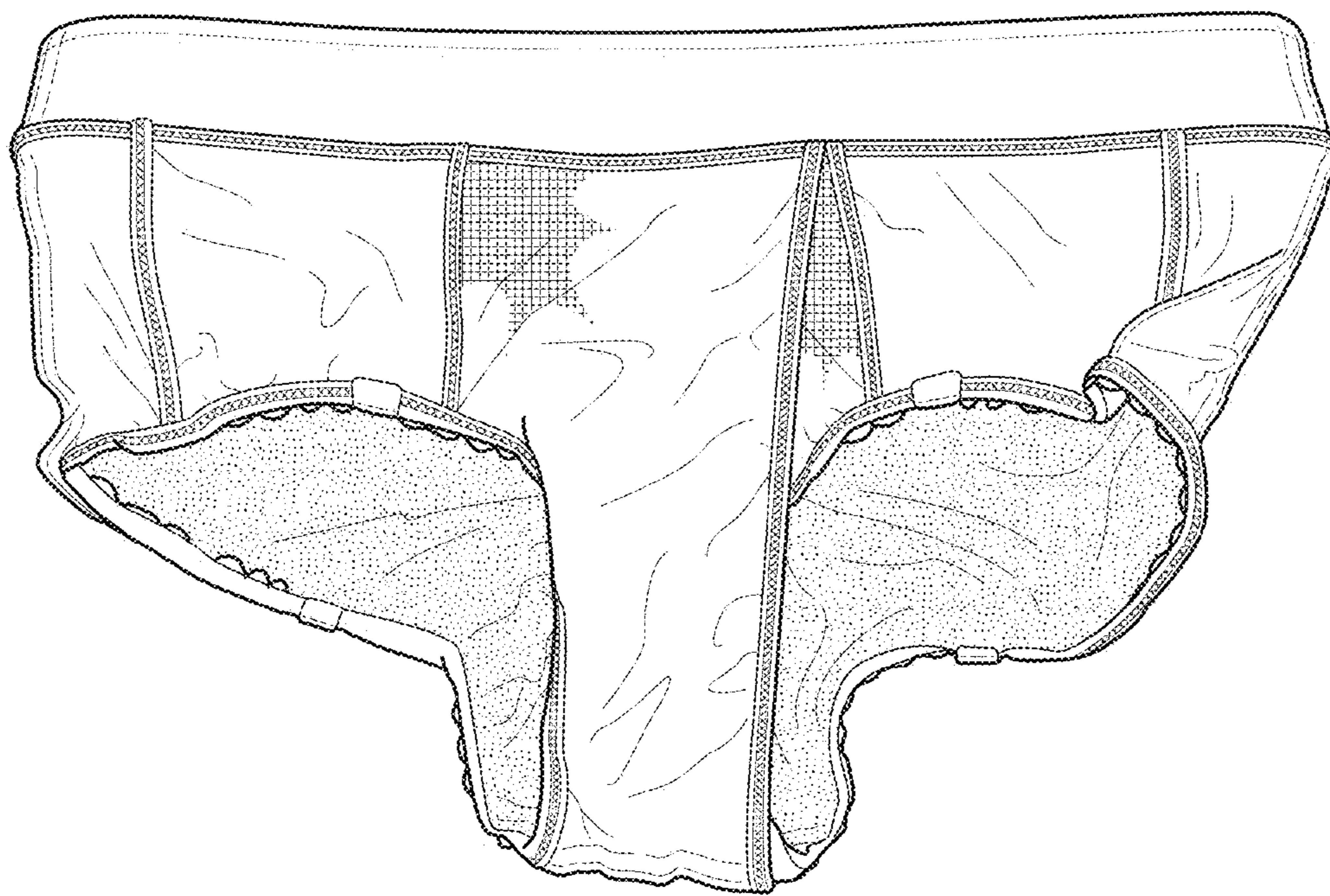

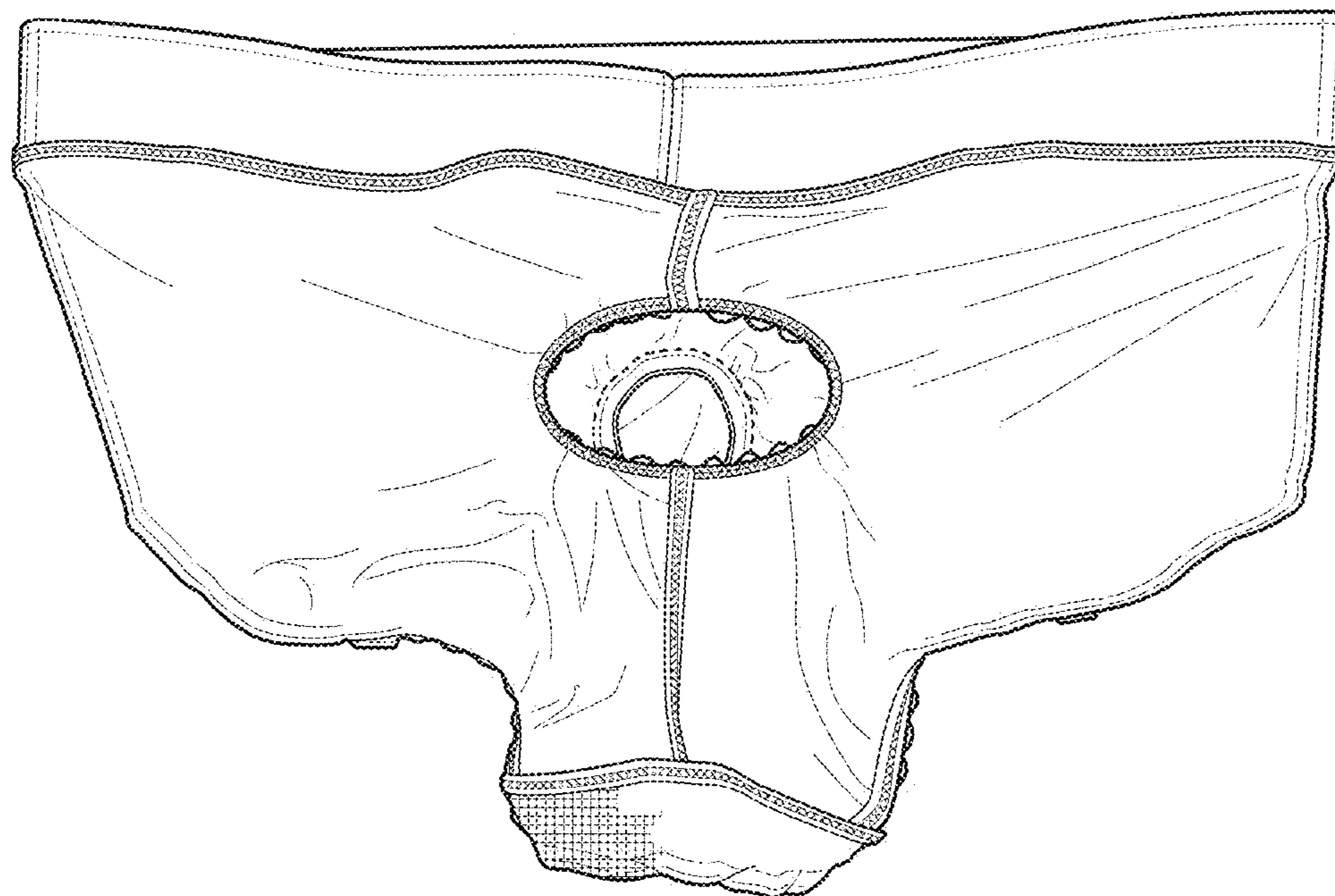

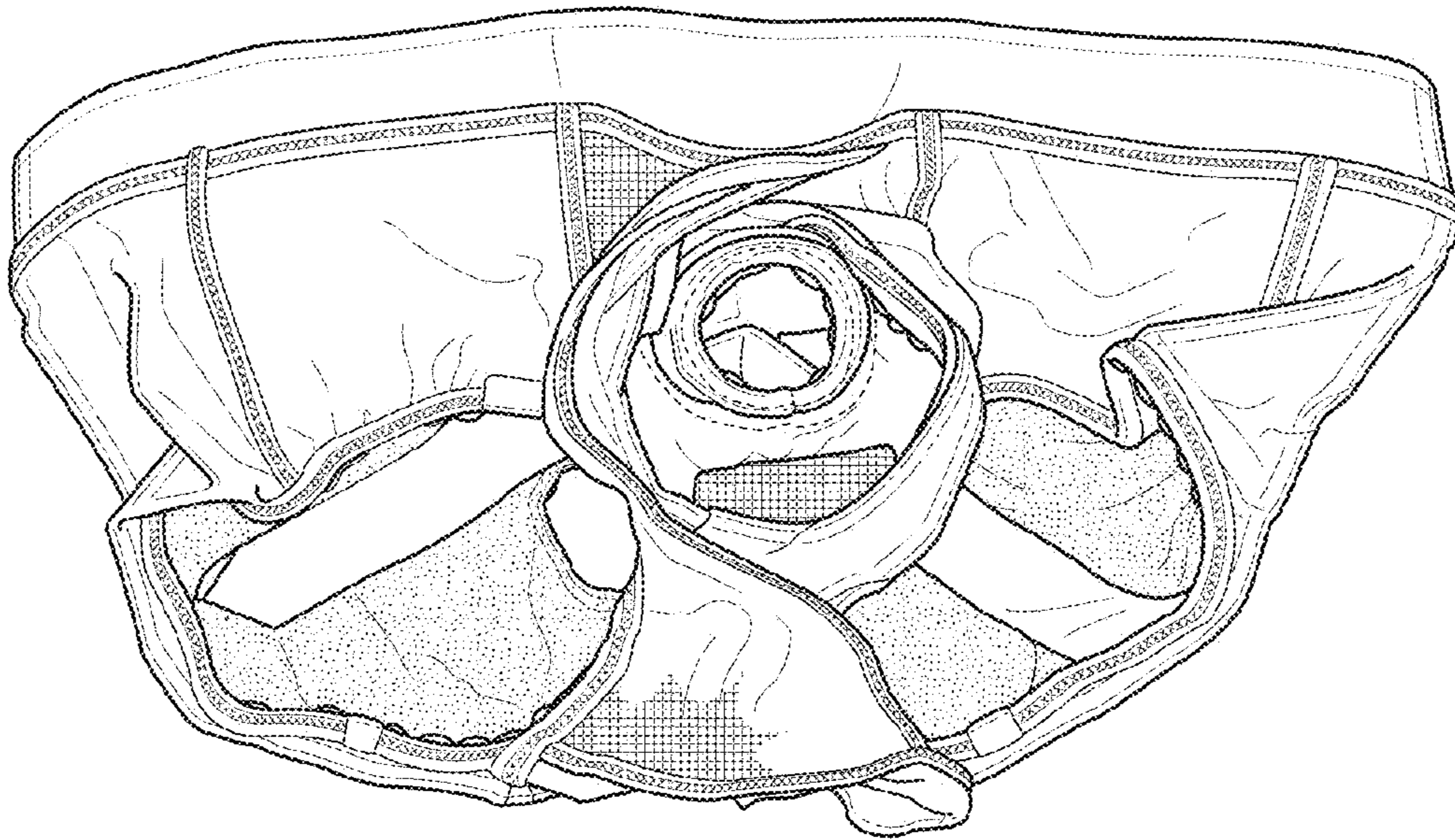

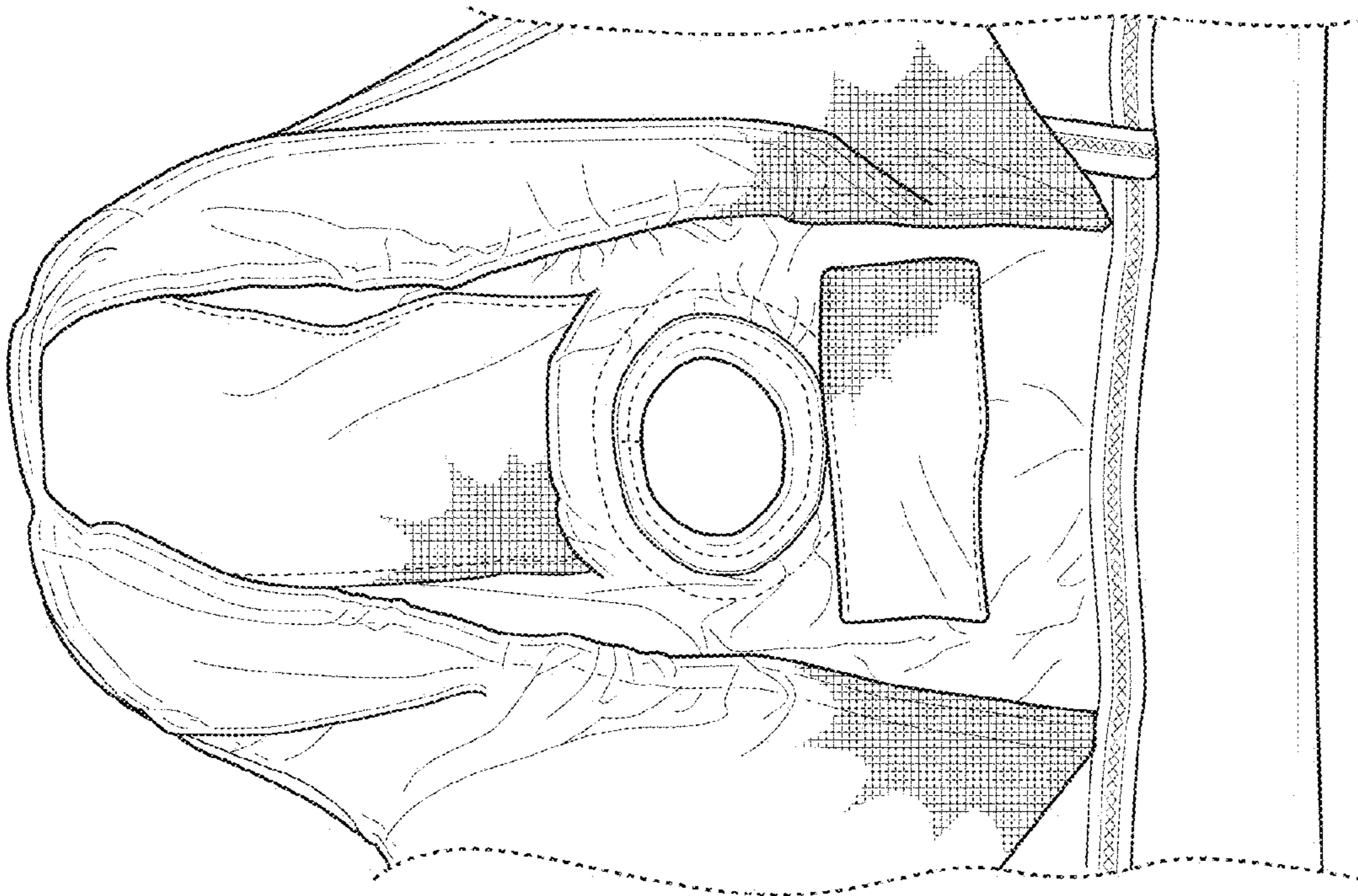
