The ornamental design for a backpack, as shown and described.

**DESCRIPTION**

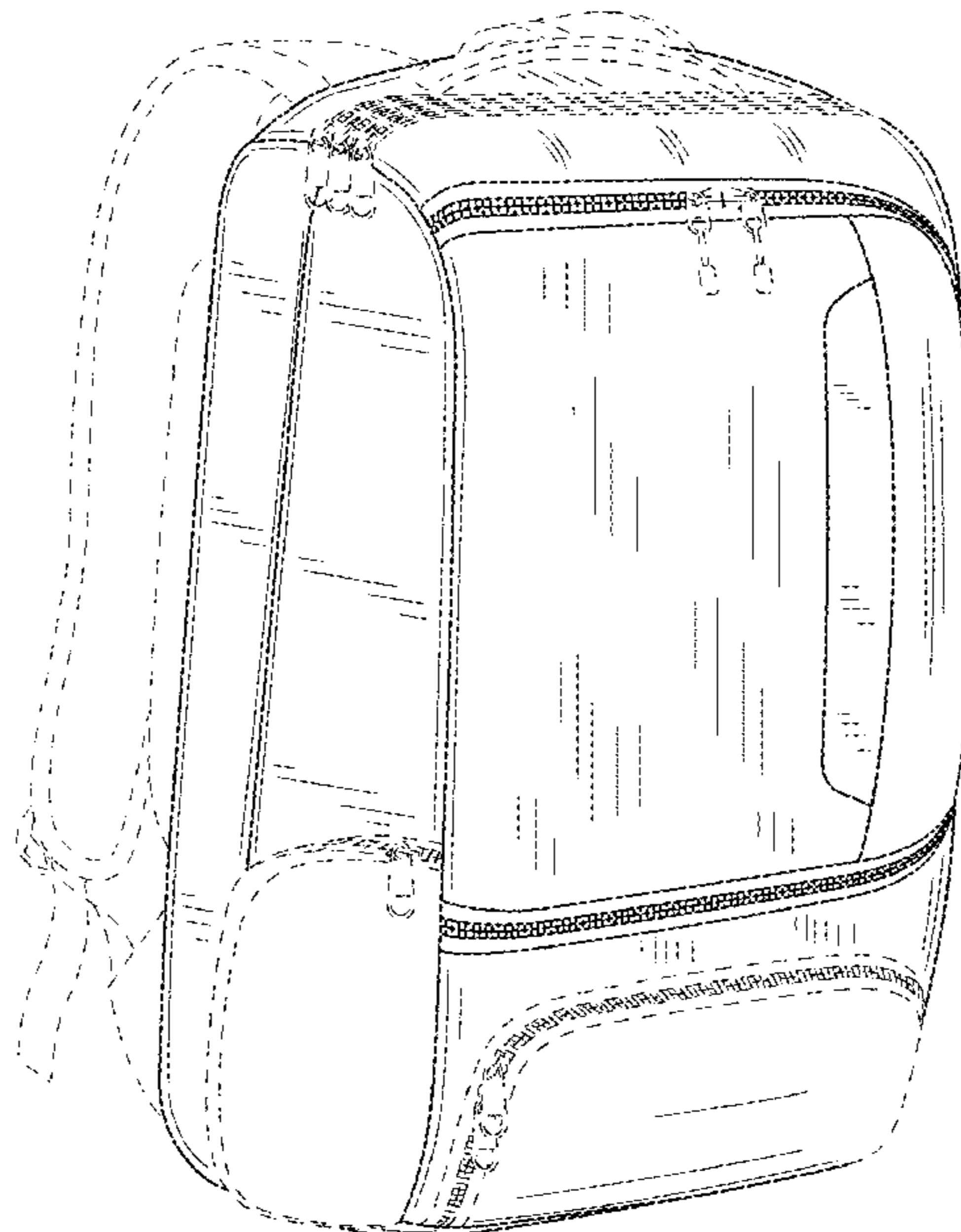

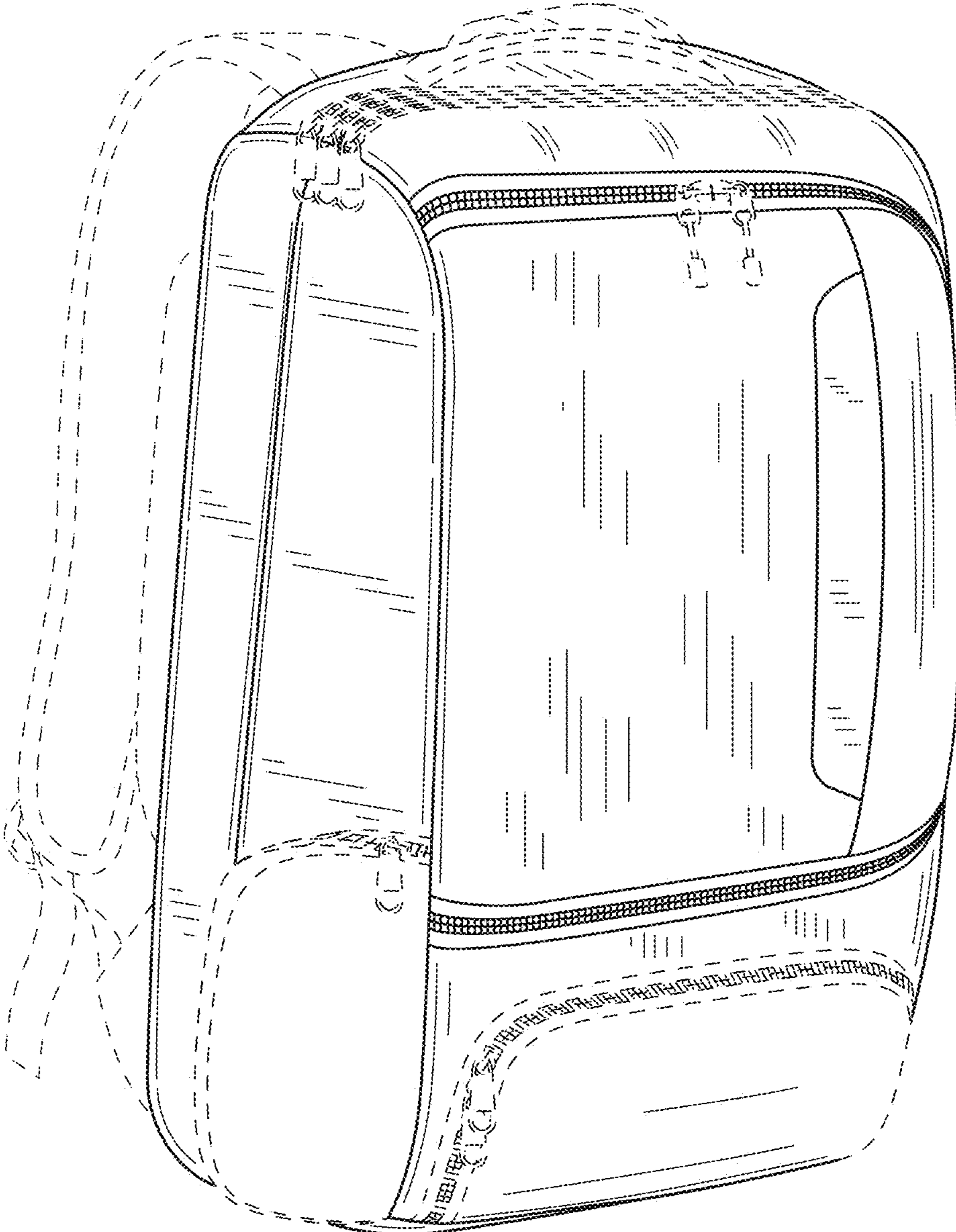

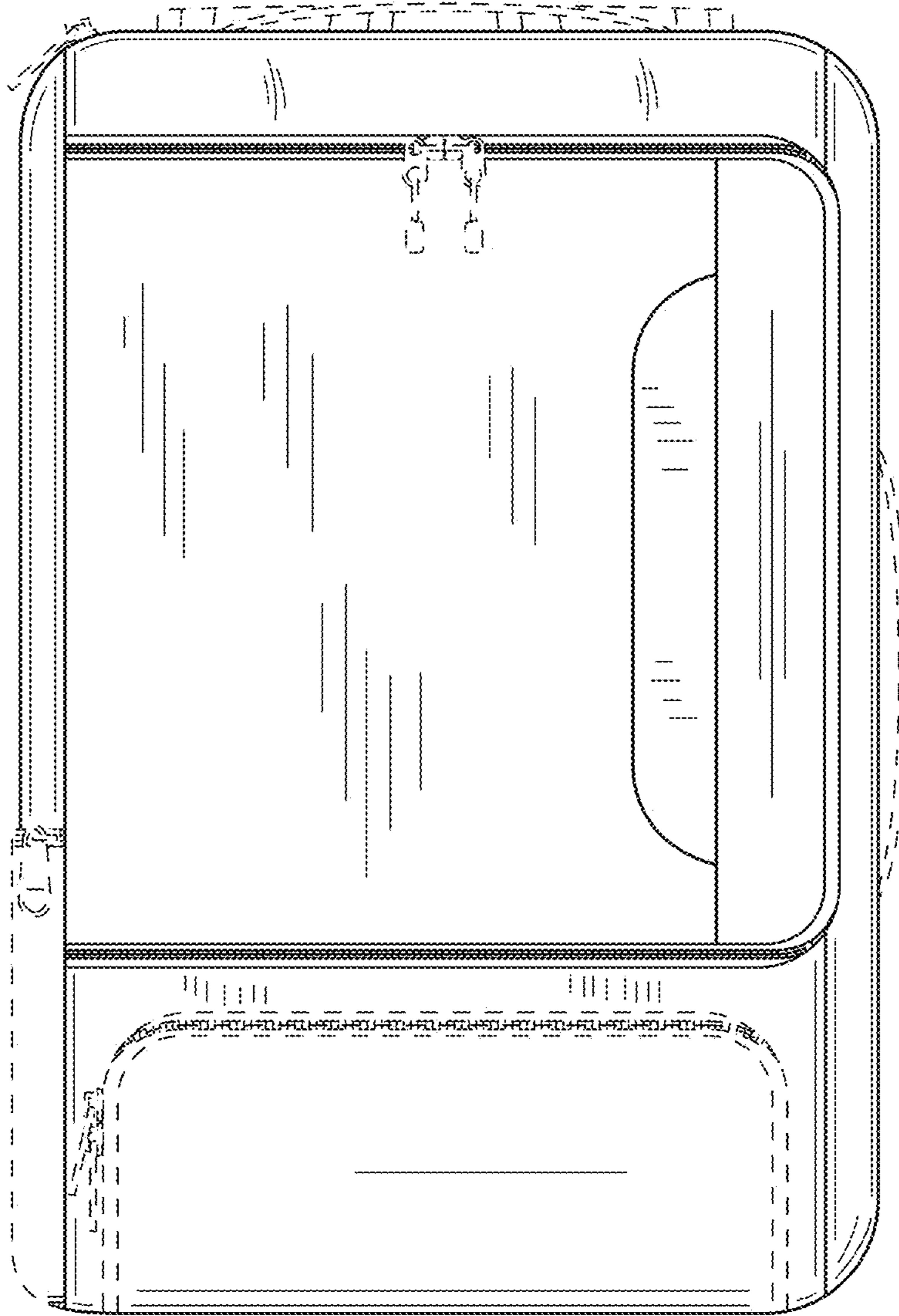

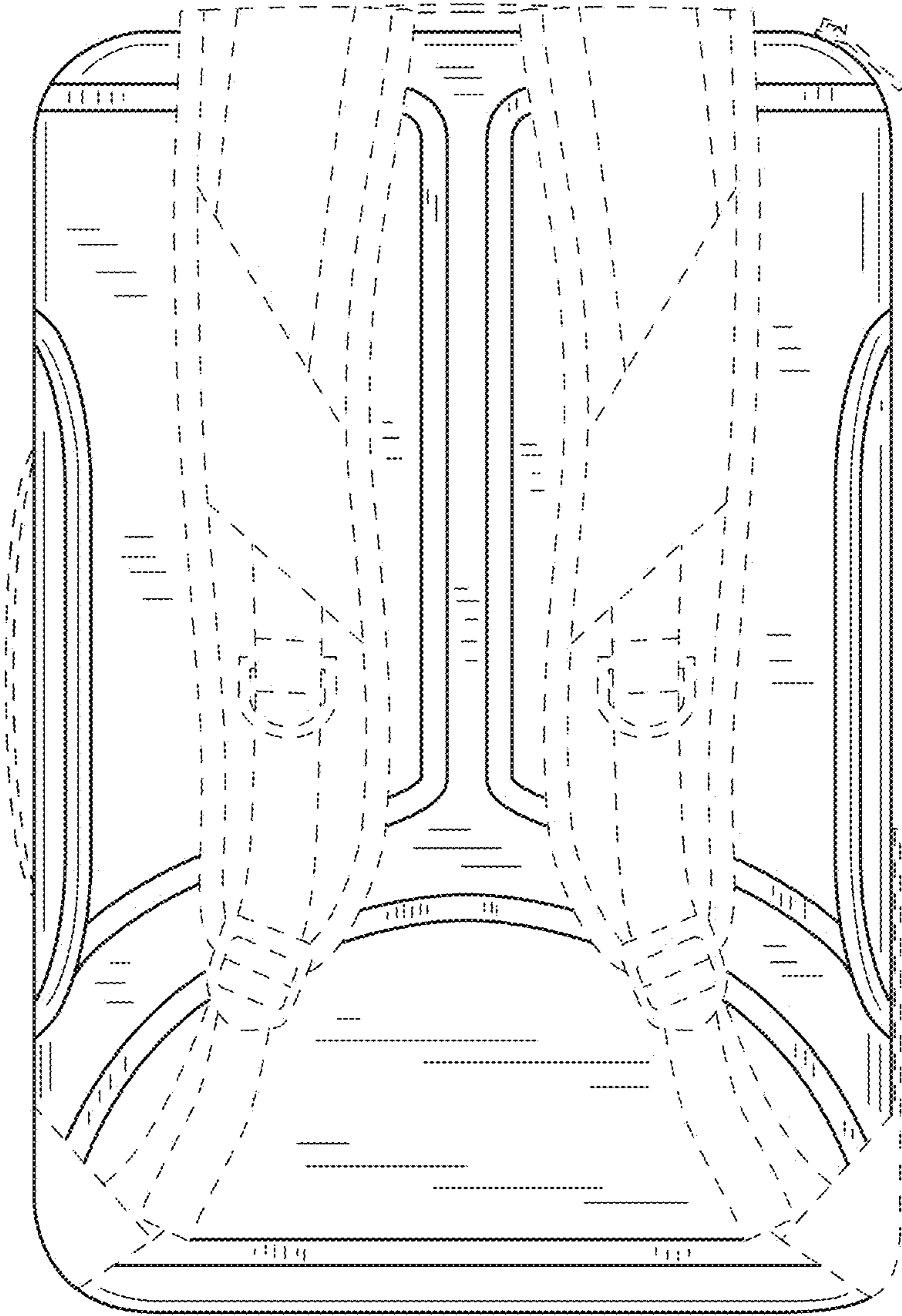

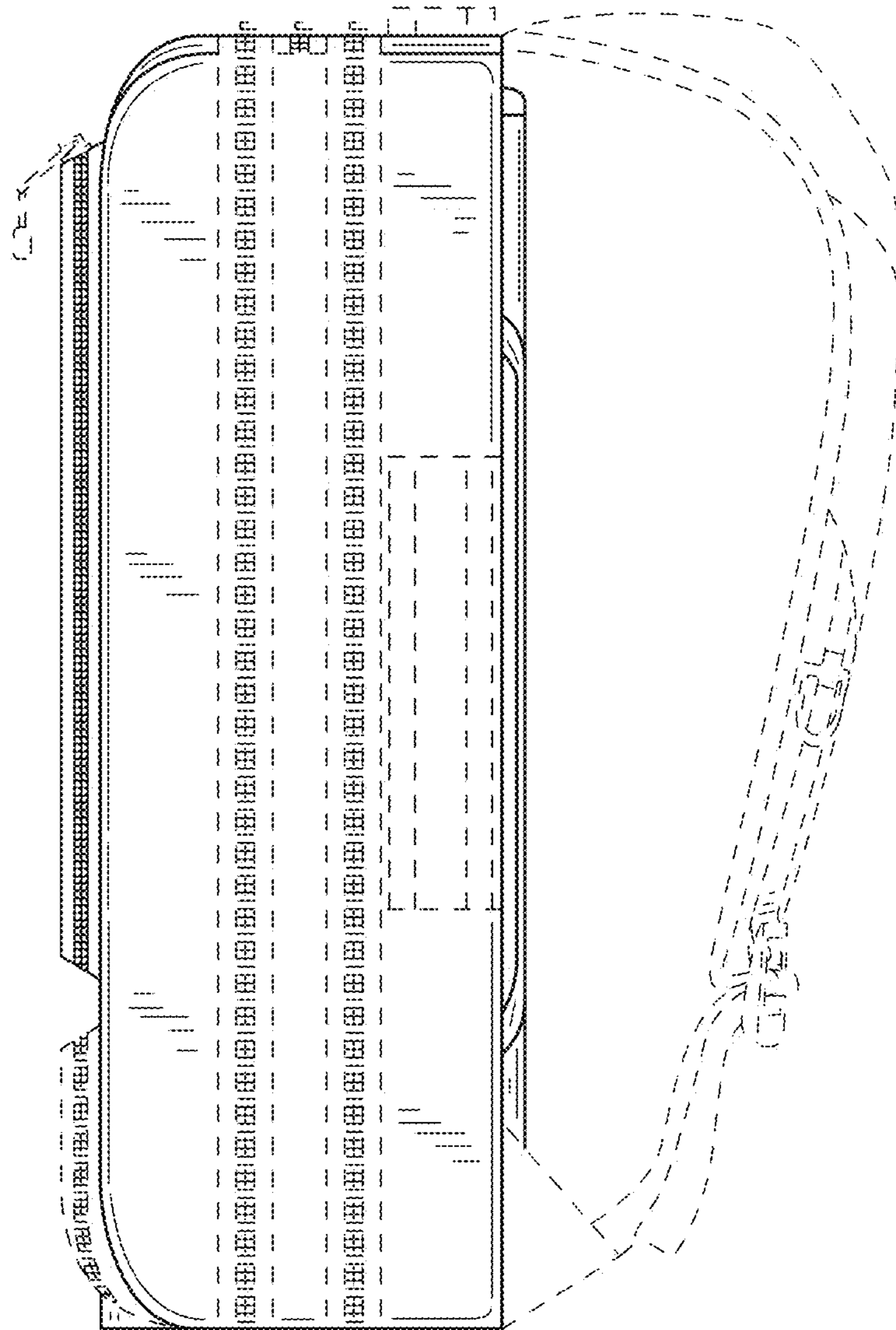

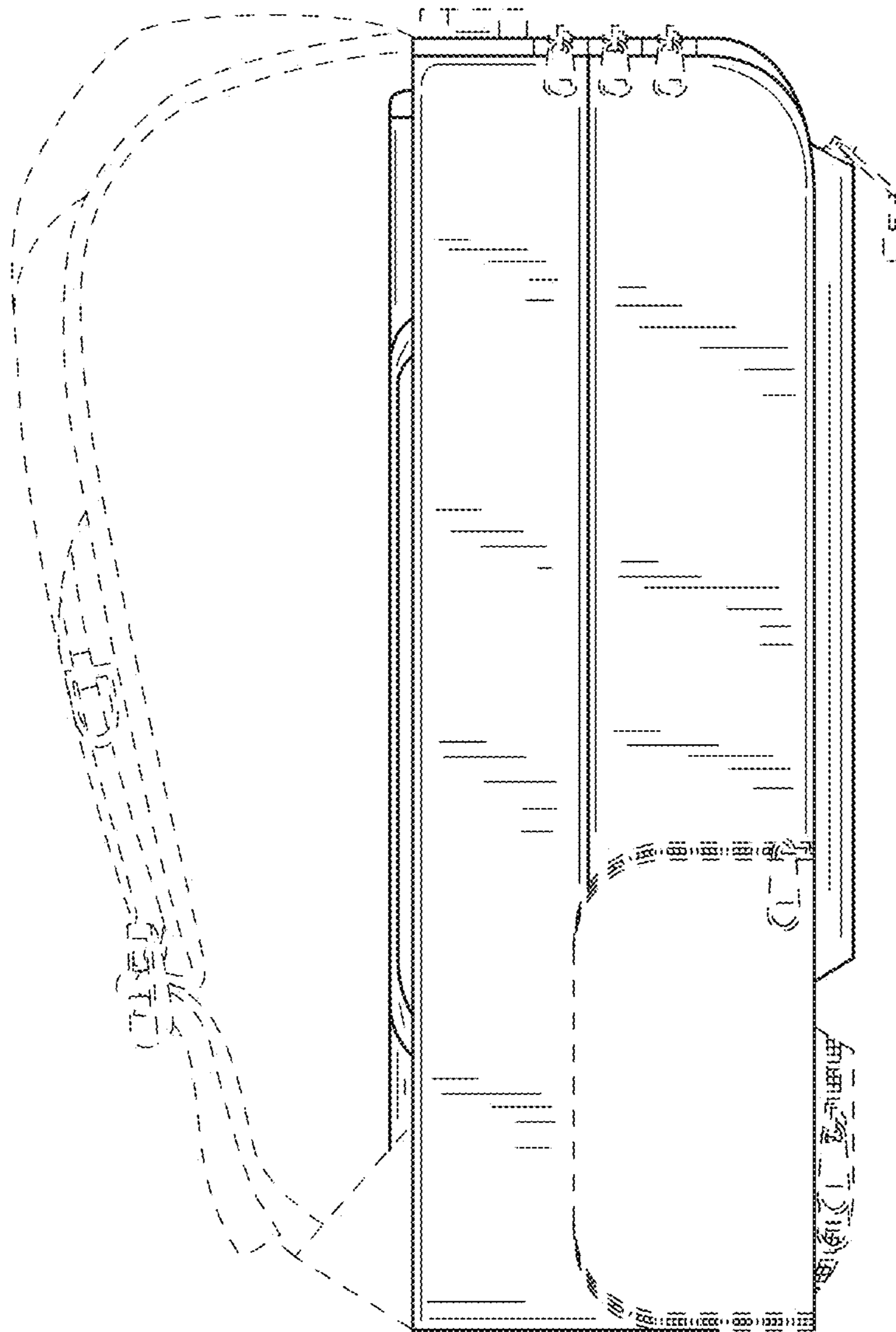

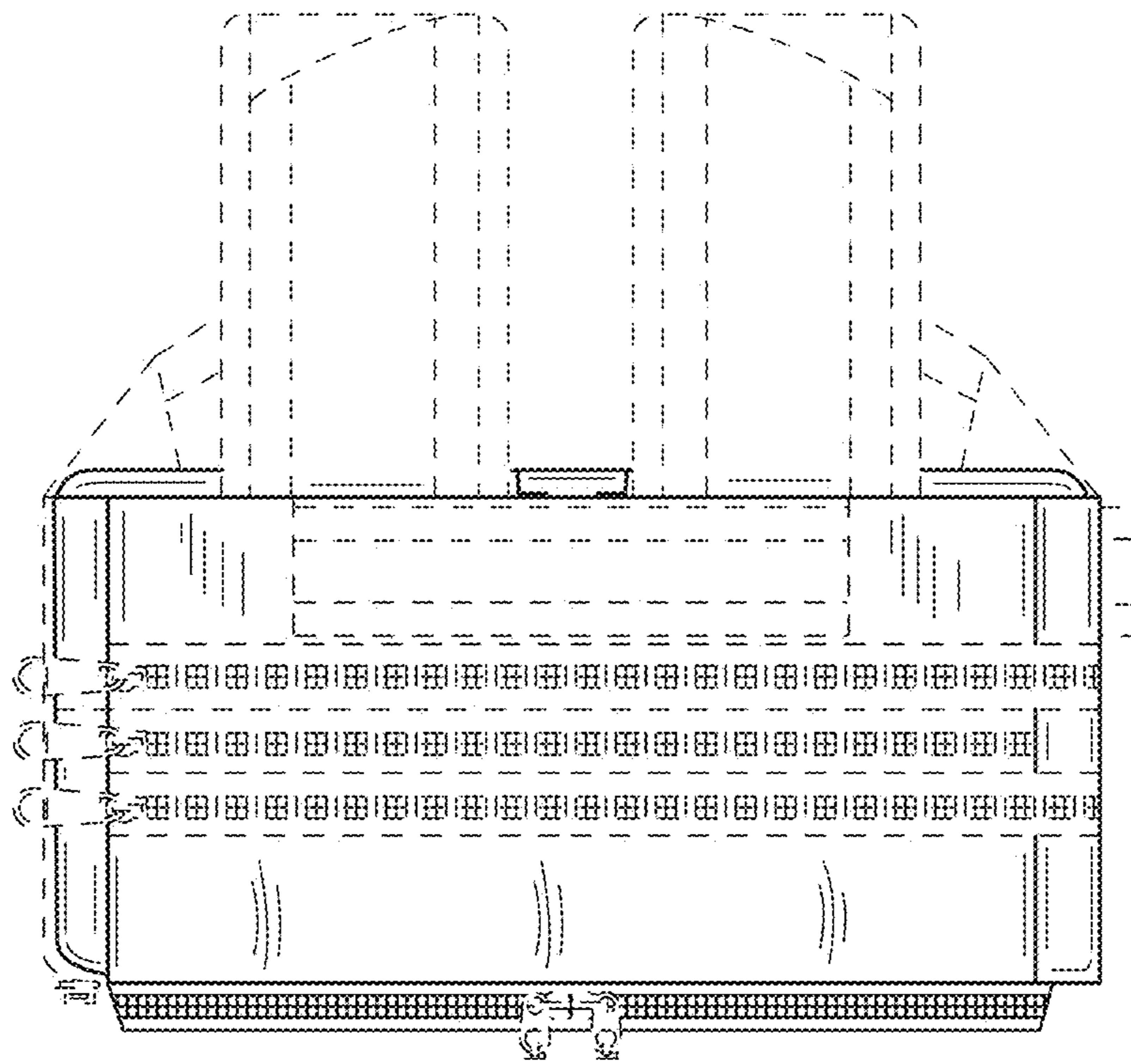

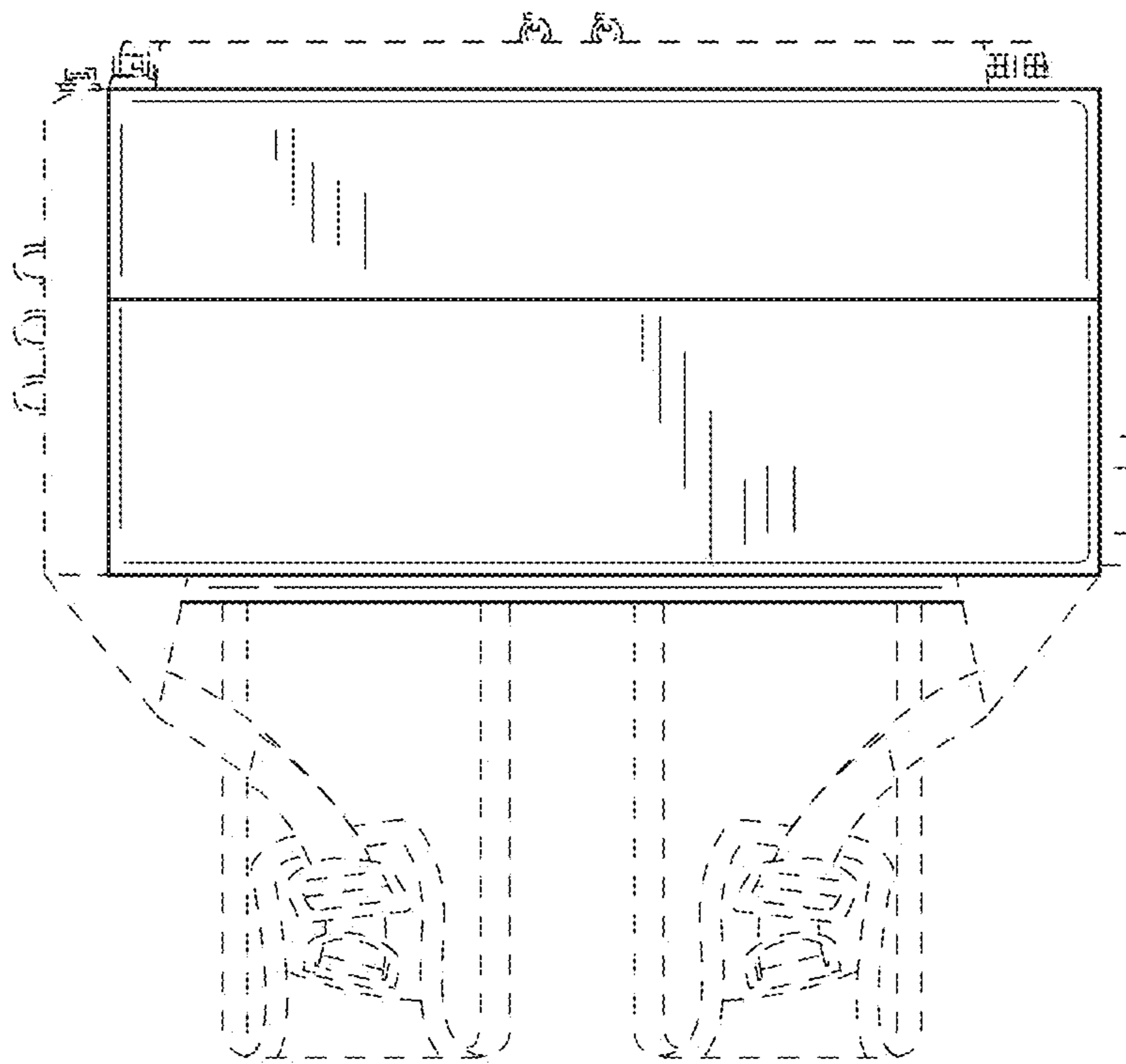

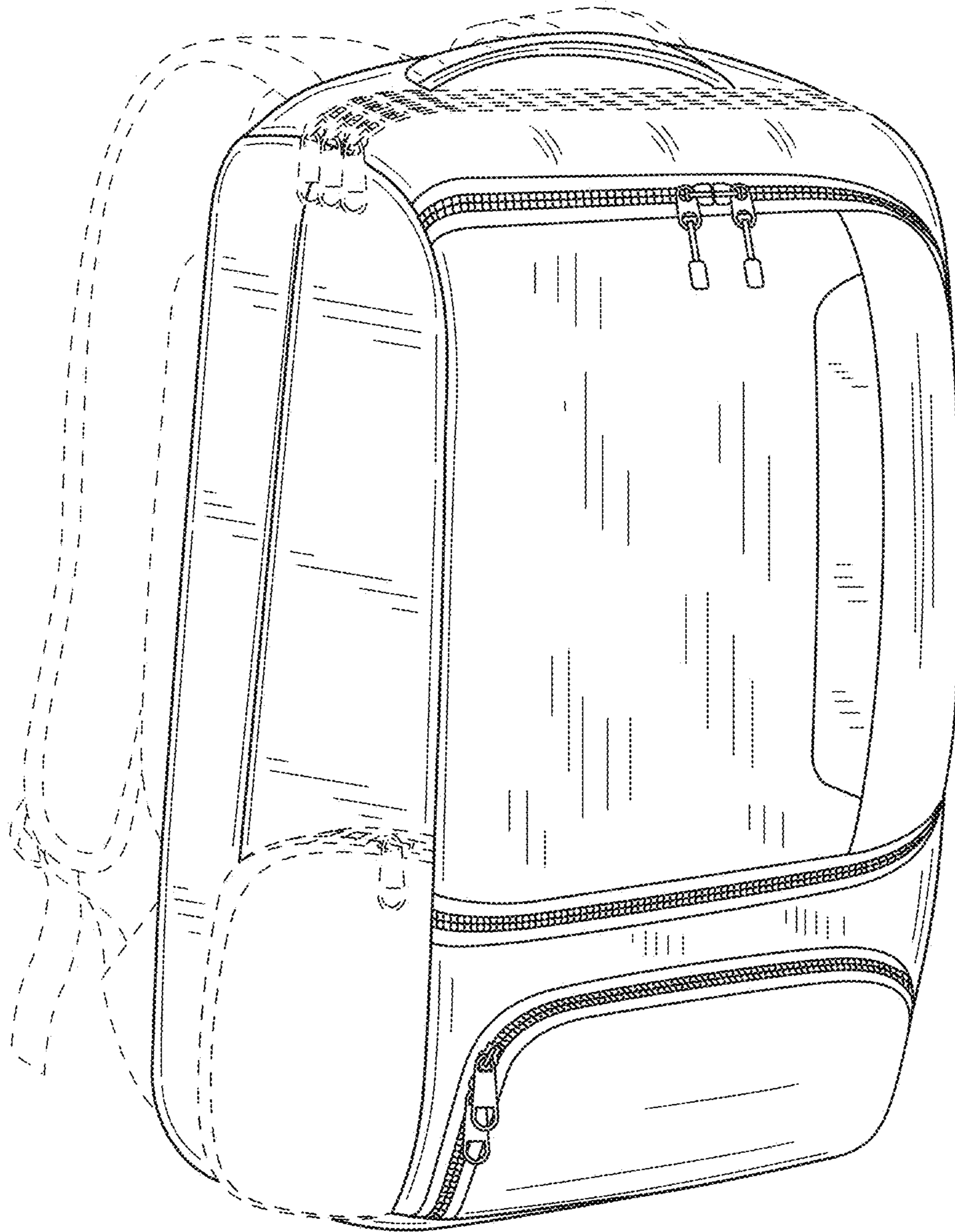

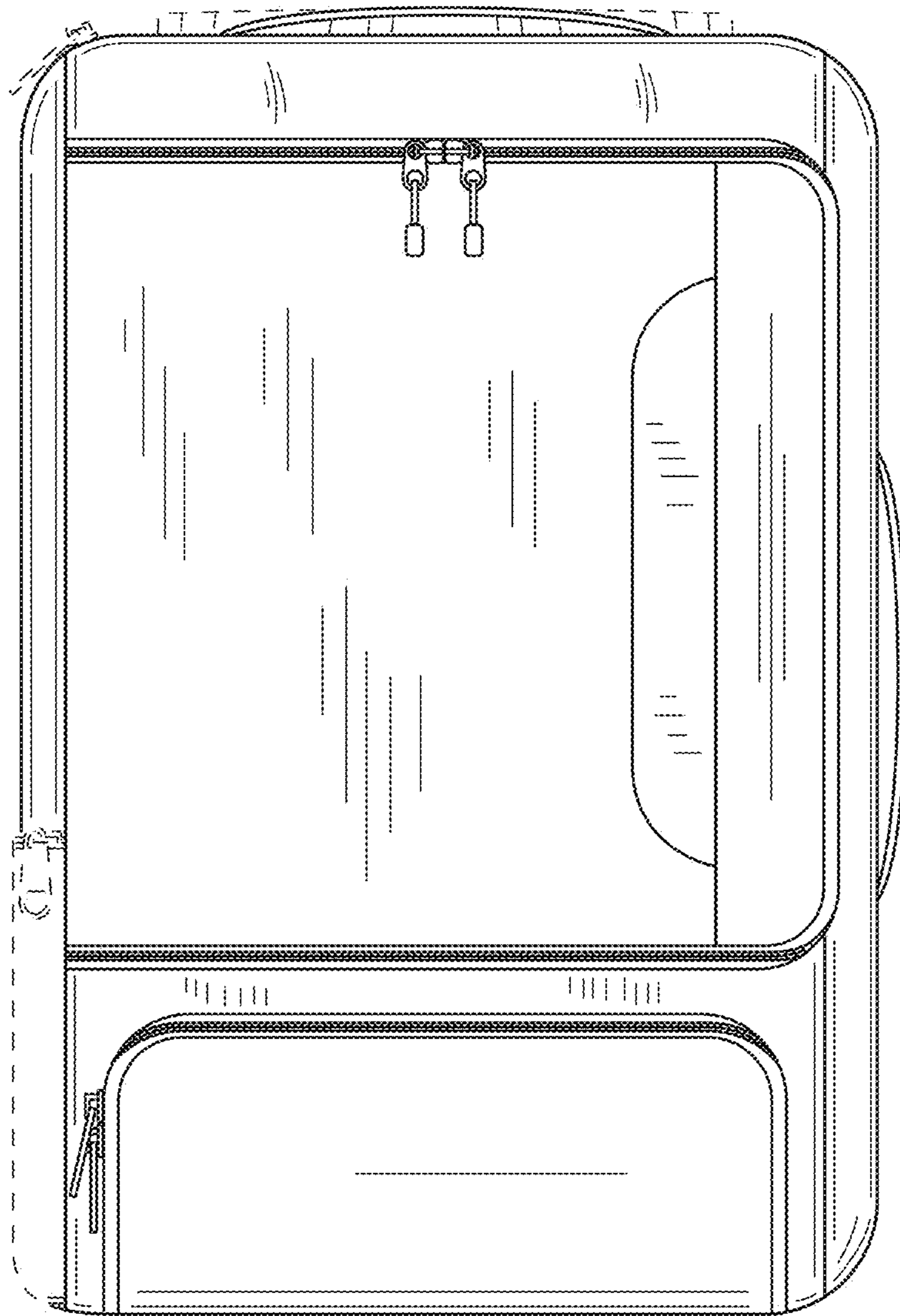

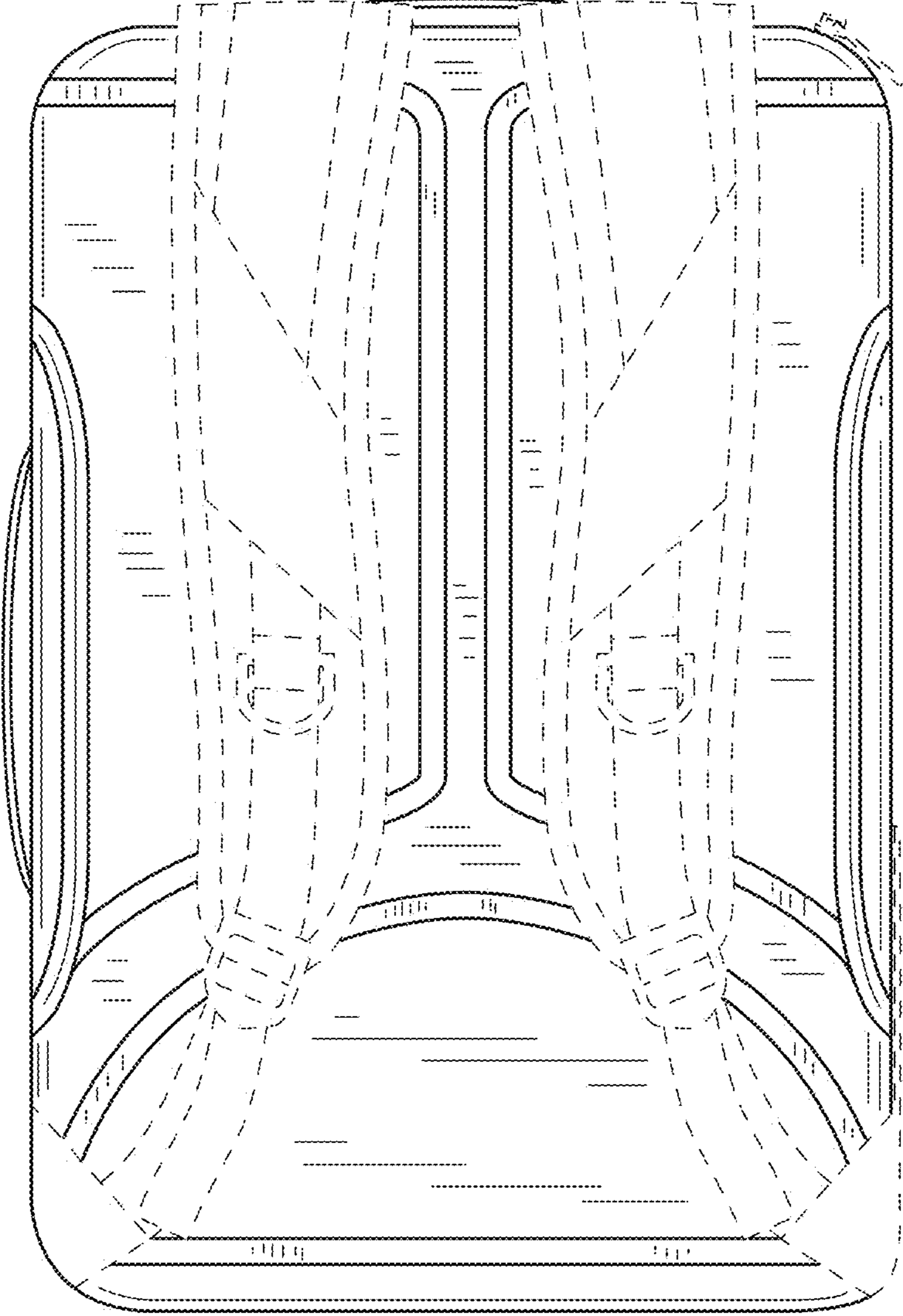

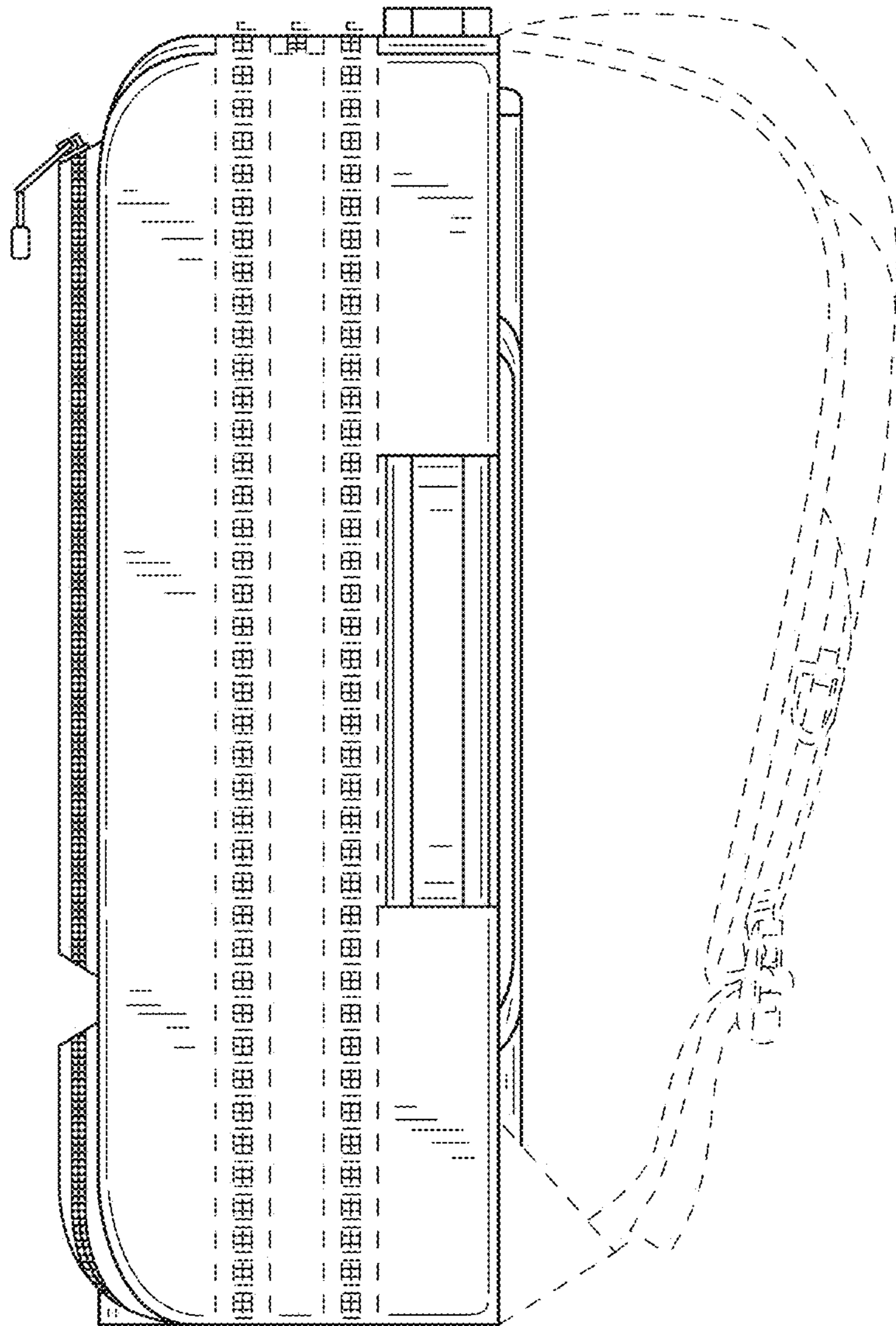

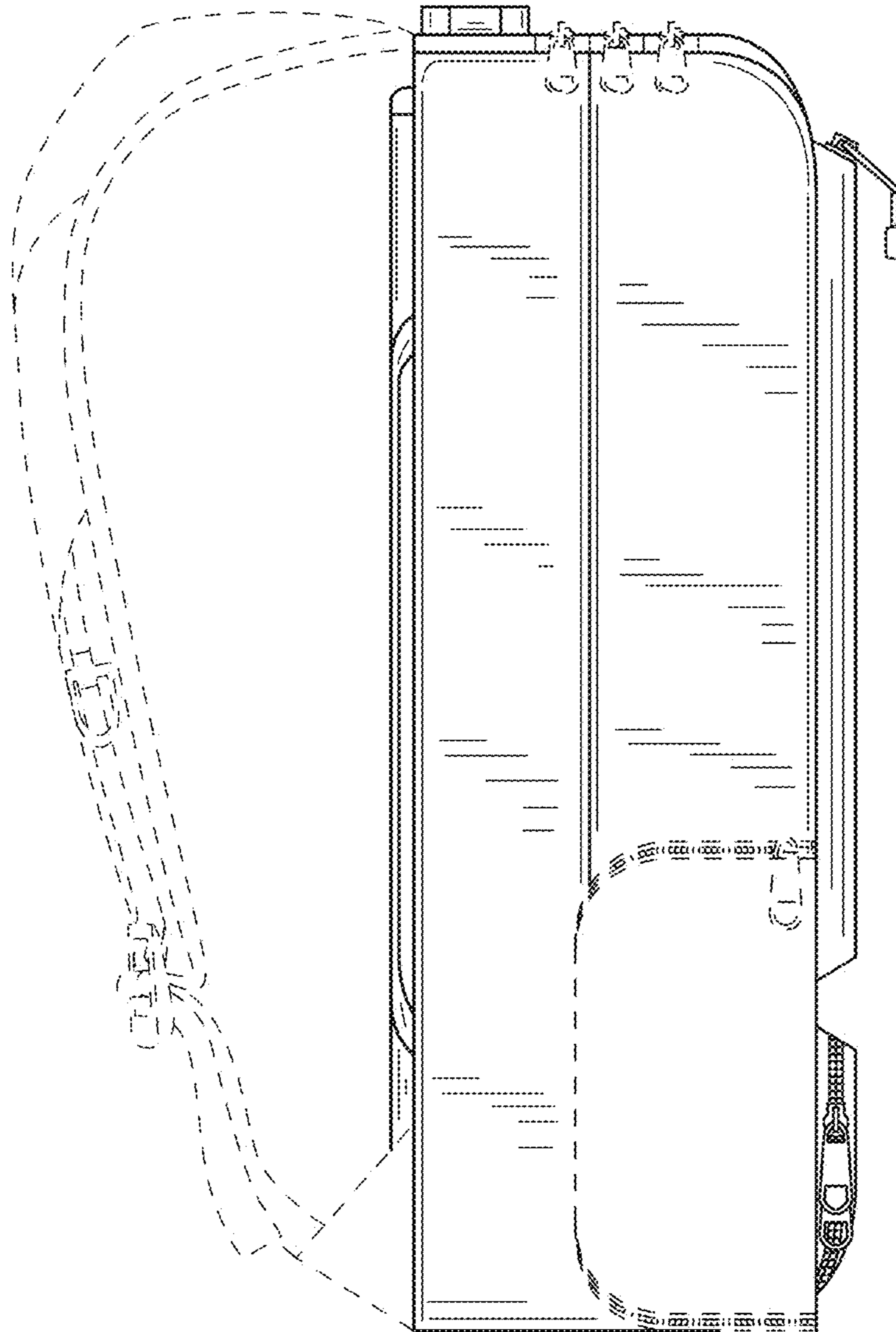

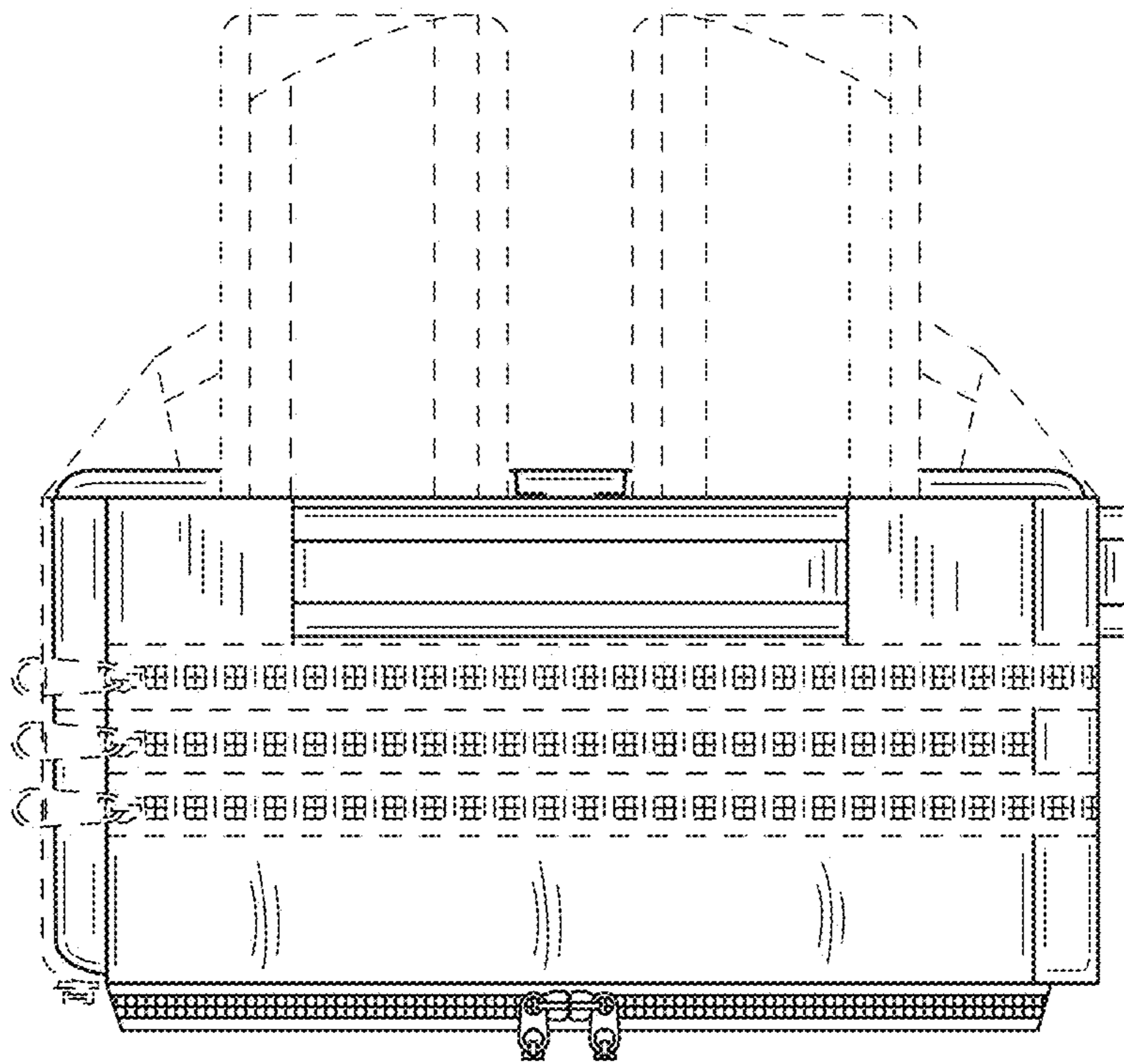

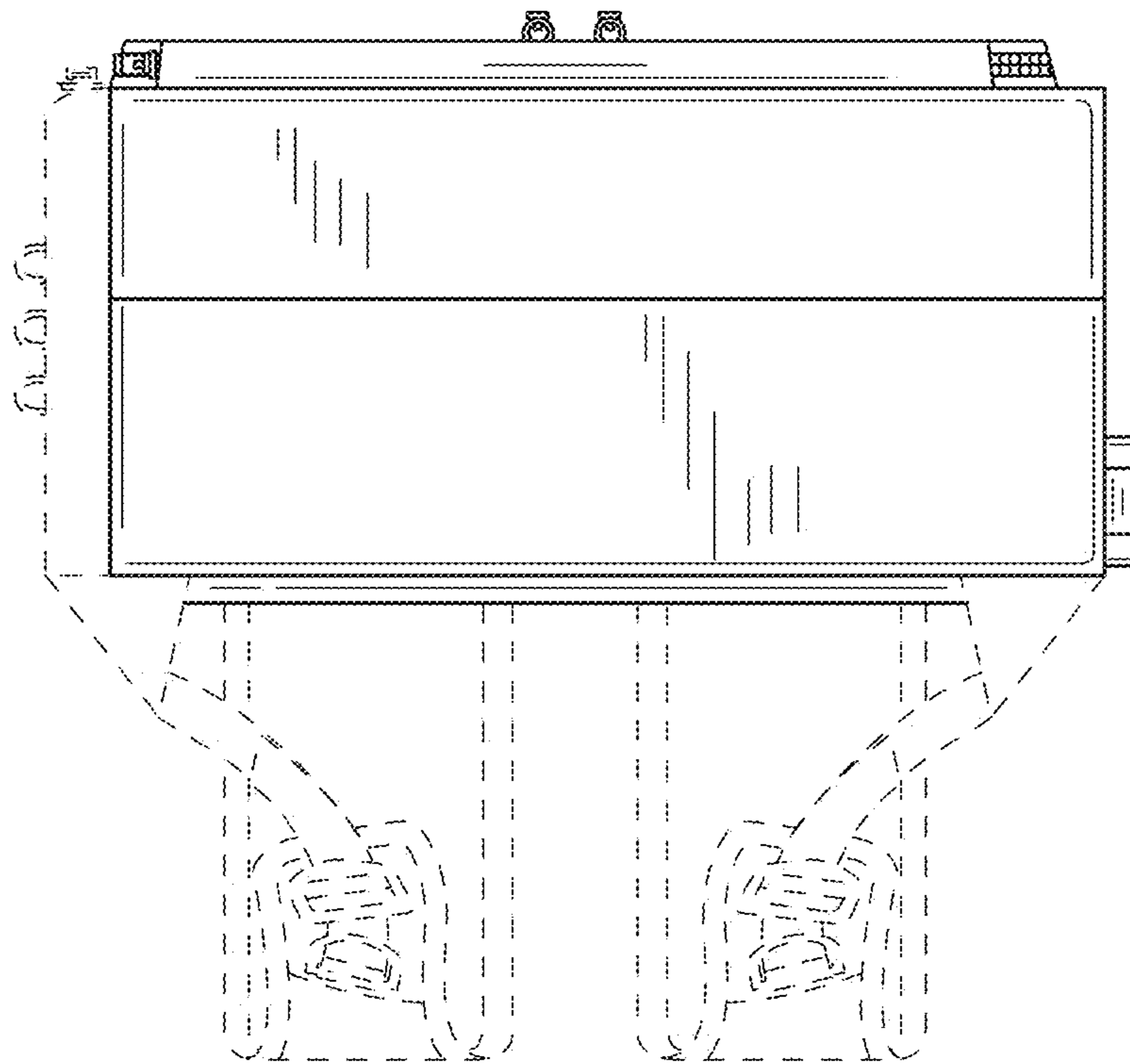
