(57) **CLAIM**

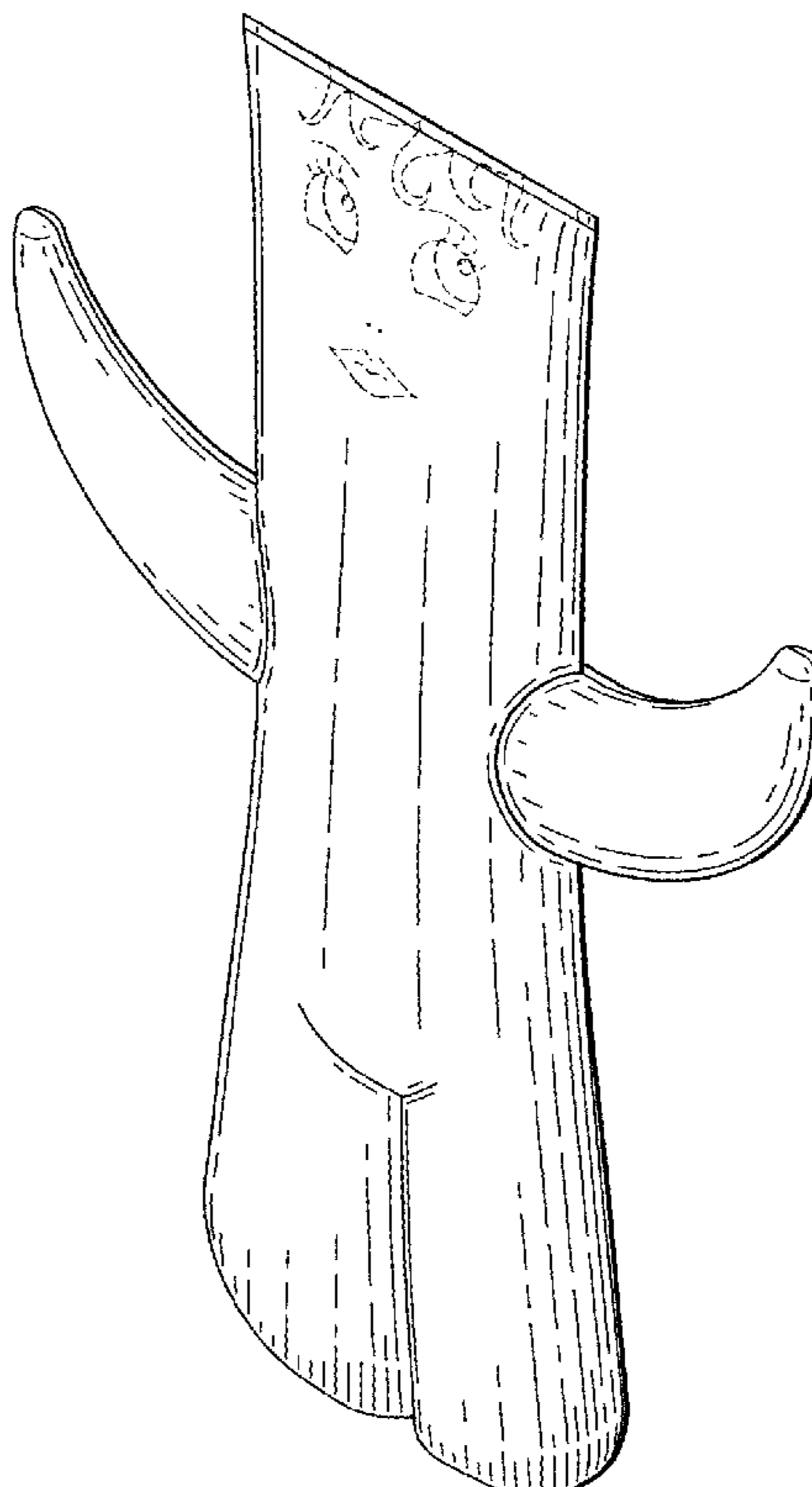
The ornamental design for a breast support pillow, as shown and described.

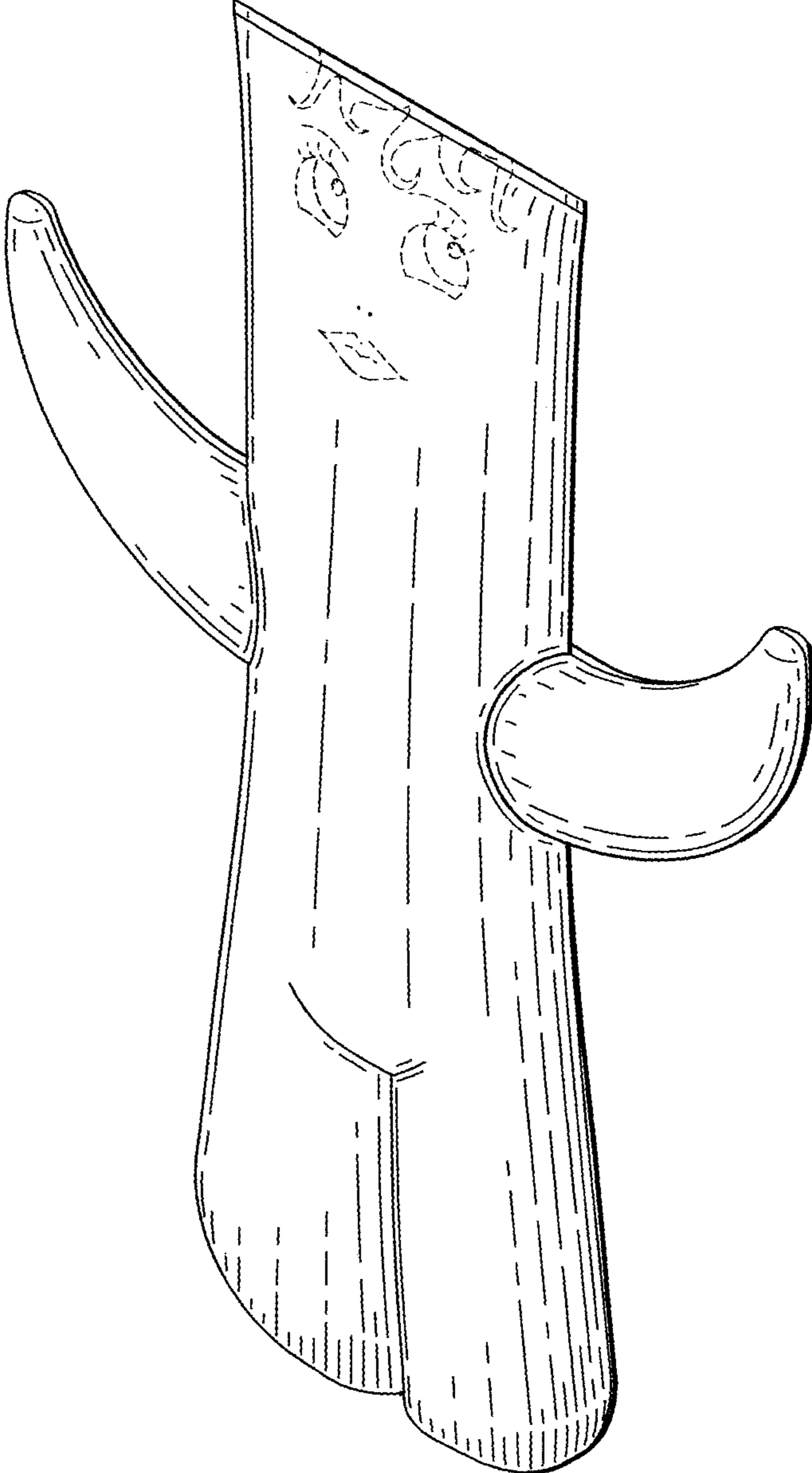

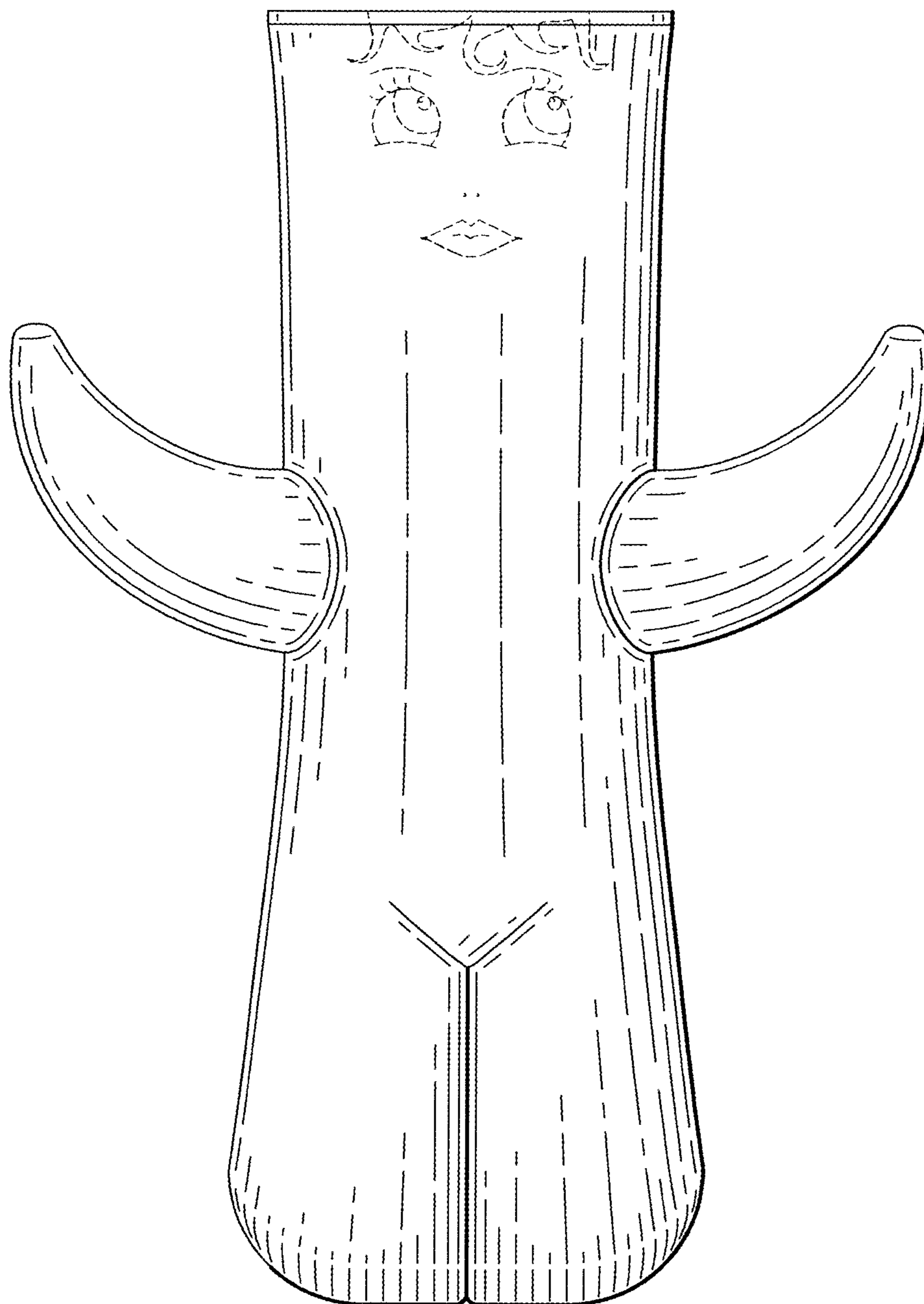

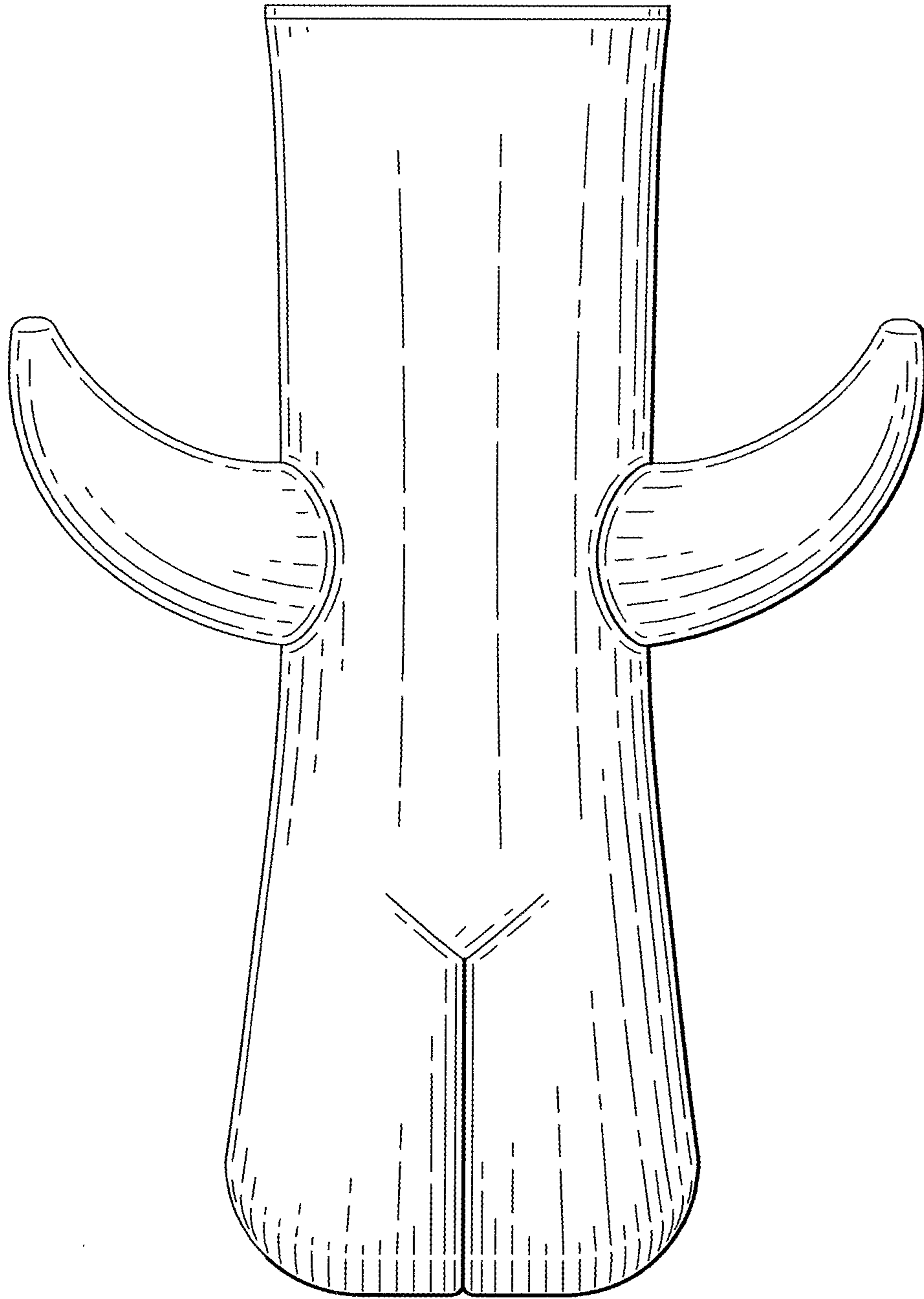

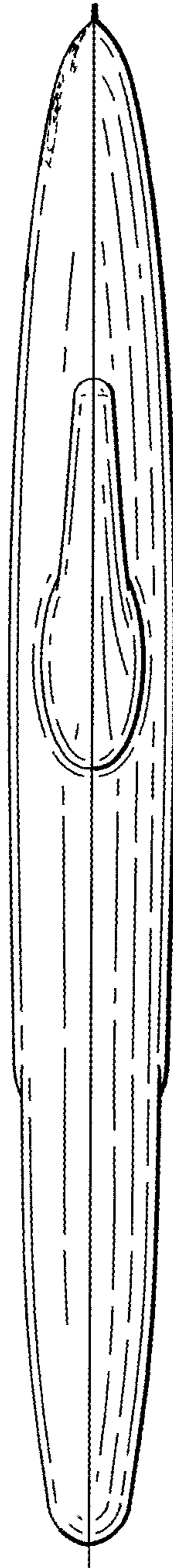

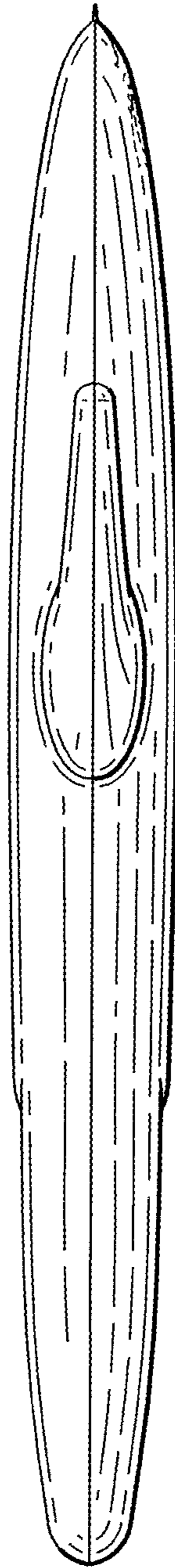

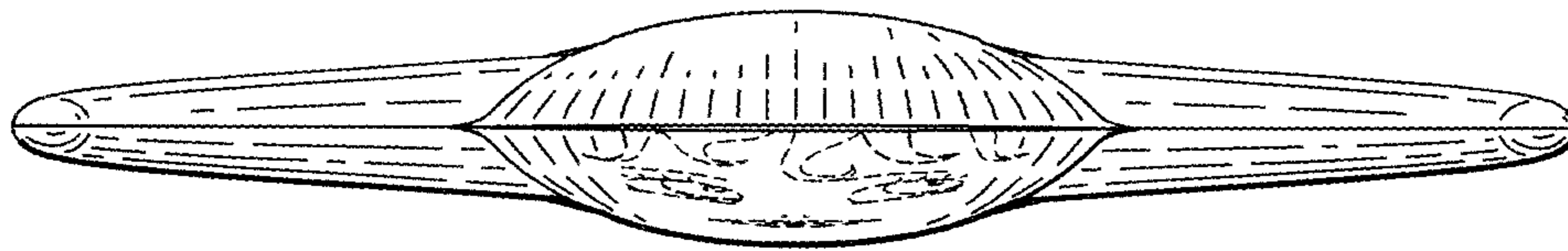

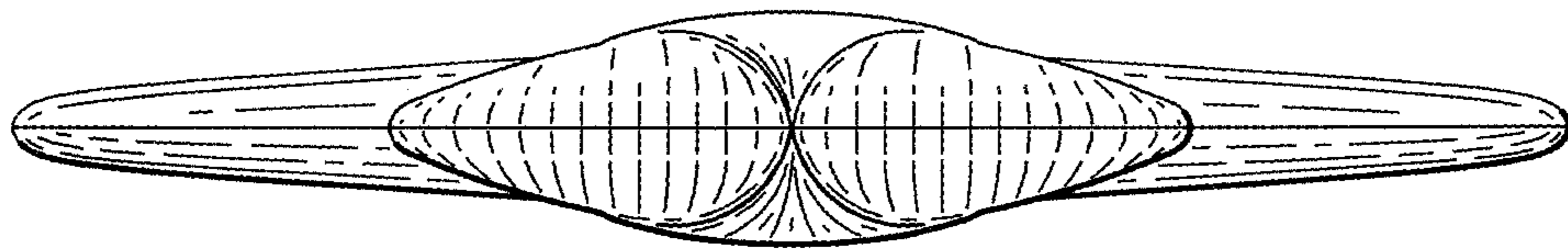
