FIG. 4 shows a third side view of the pouch of the present invention.

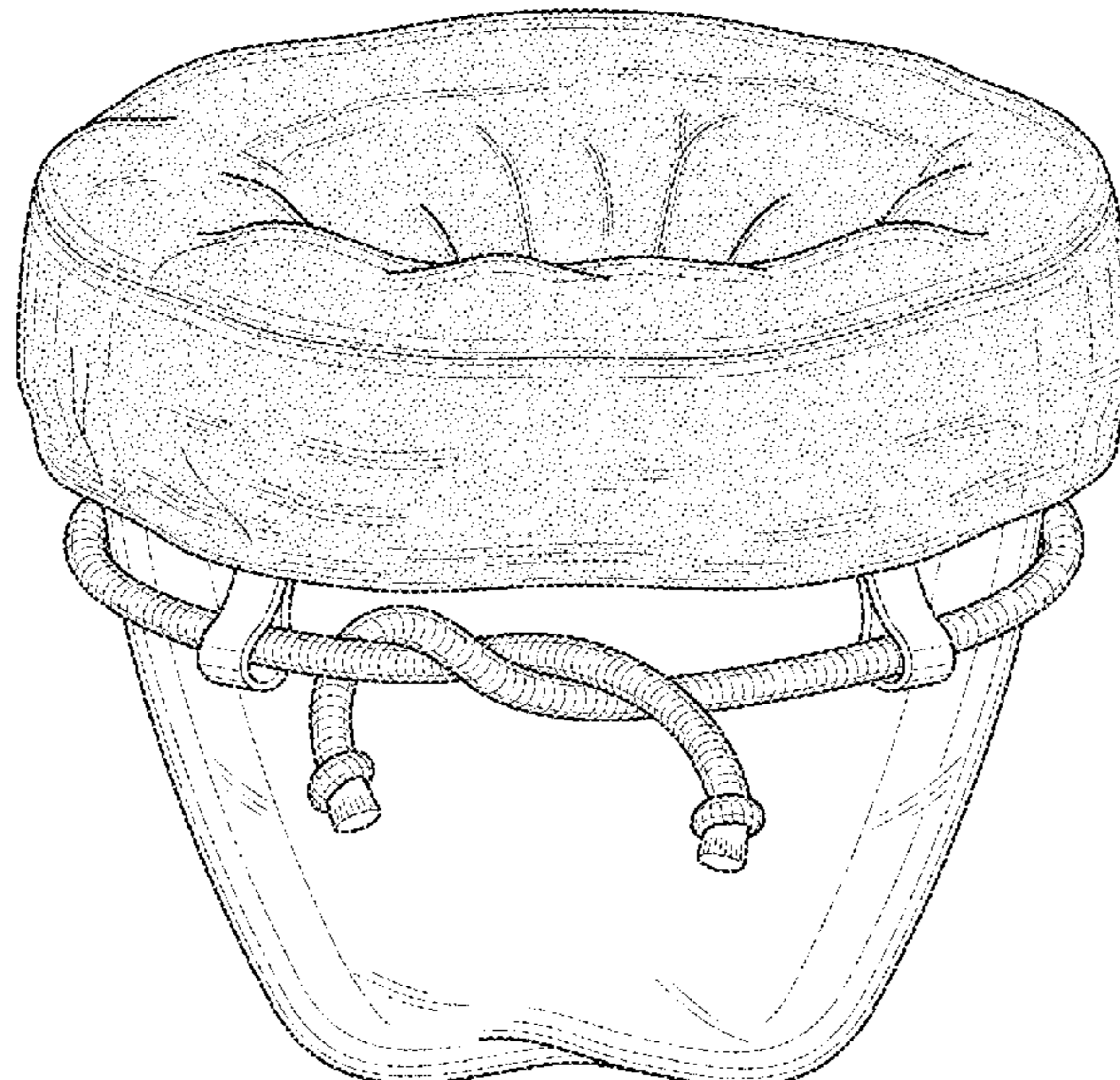
FIG. 5 shows a fourth side view of the pouch of the present invention.

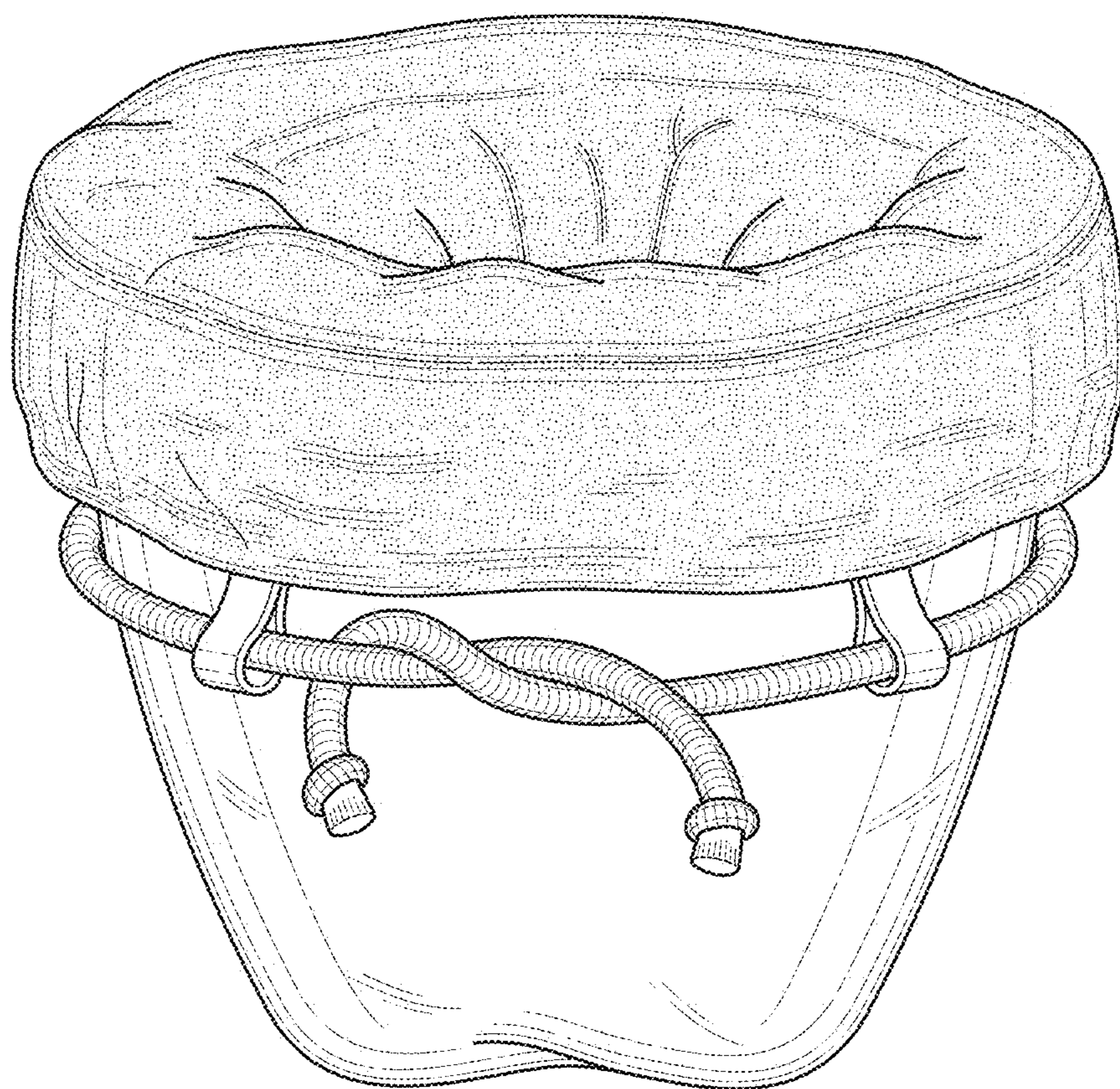

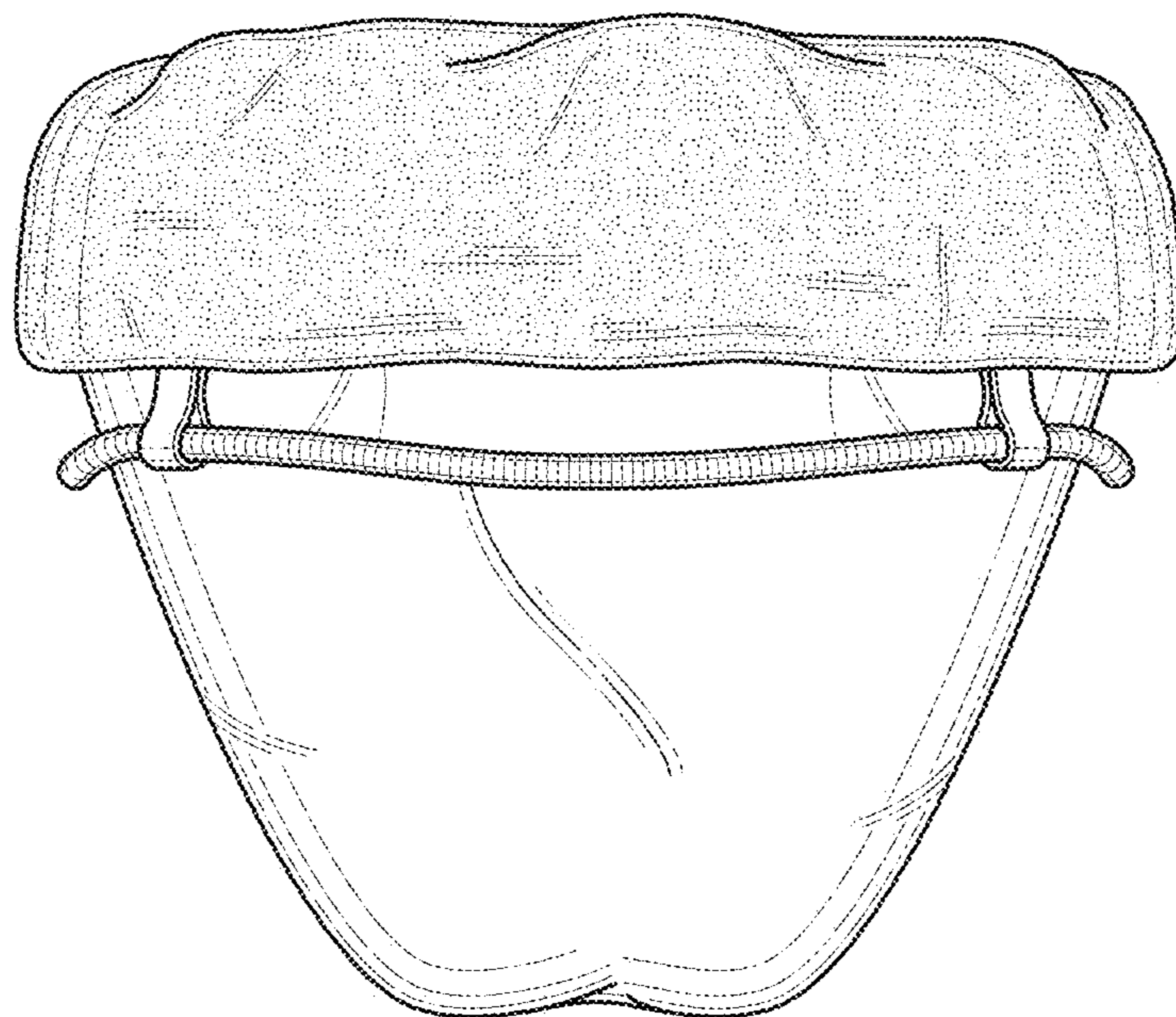

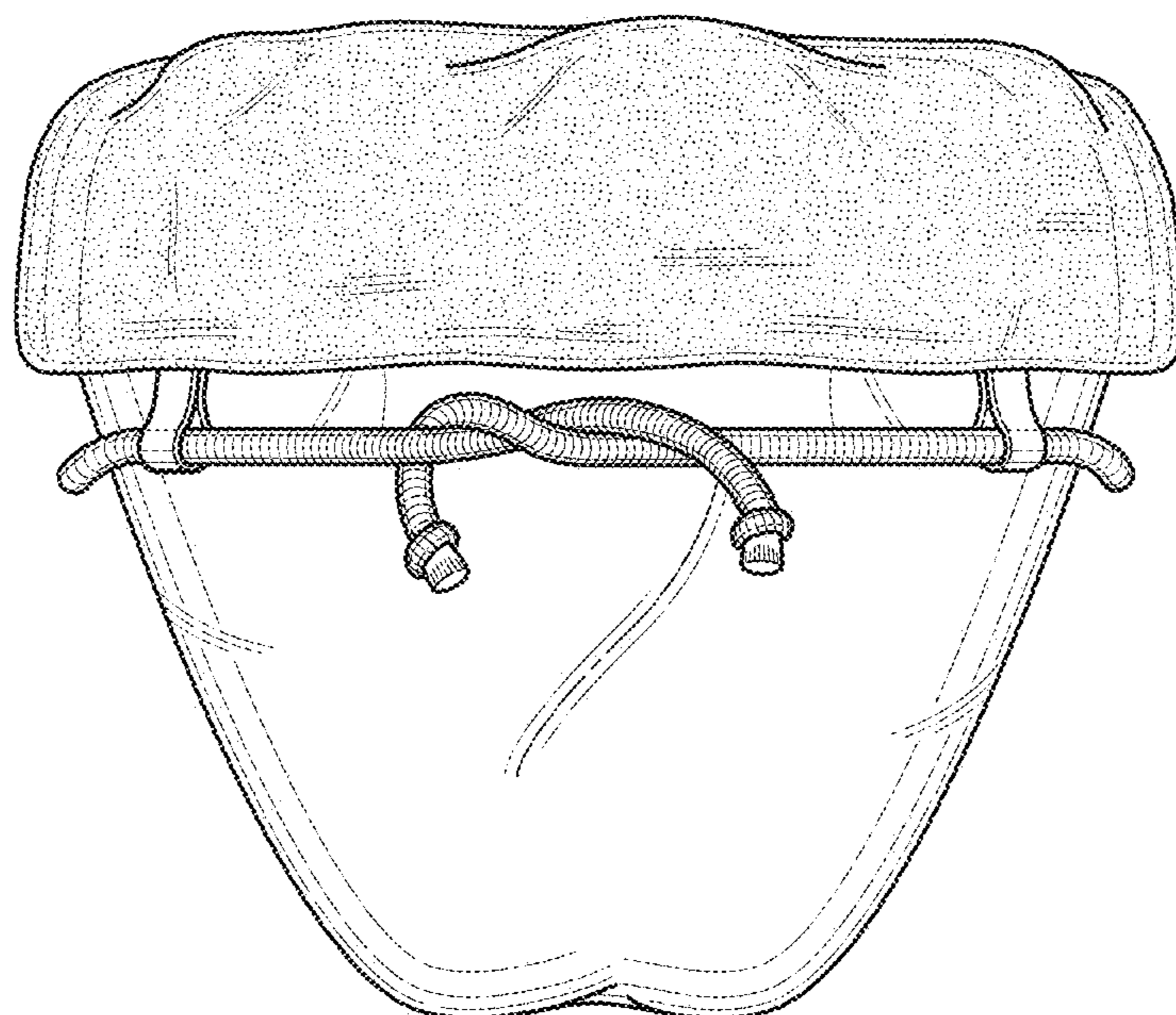

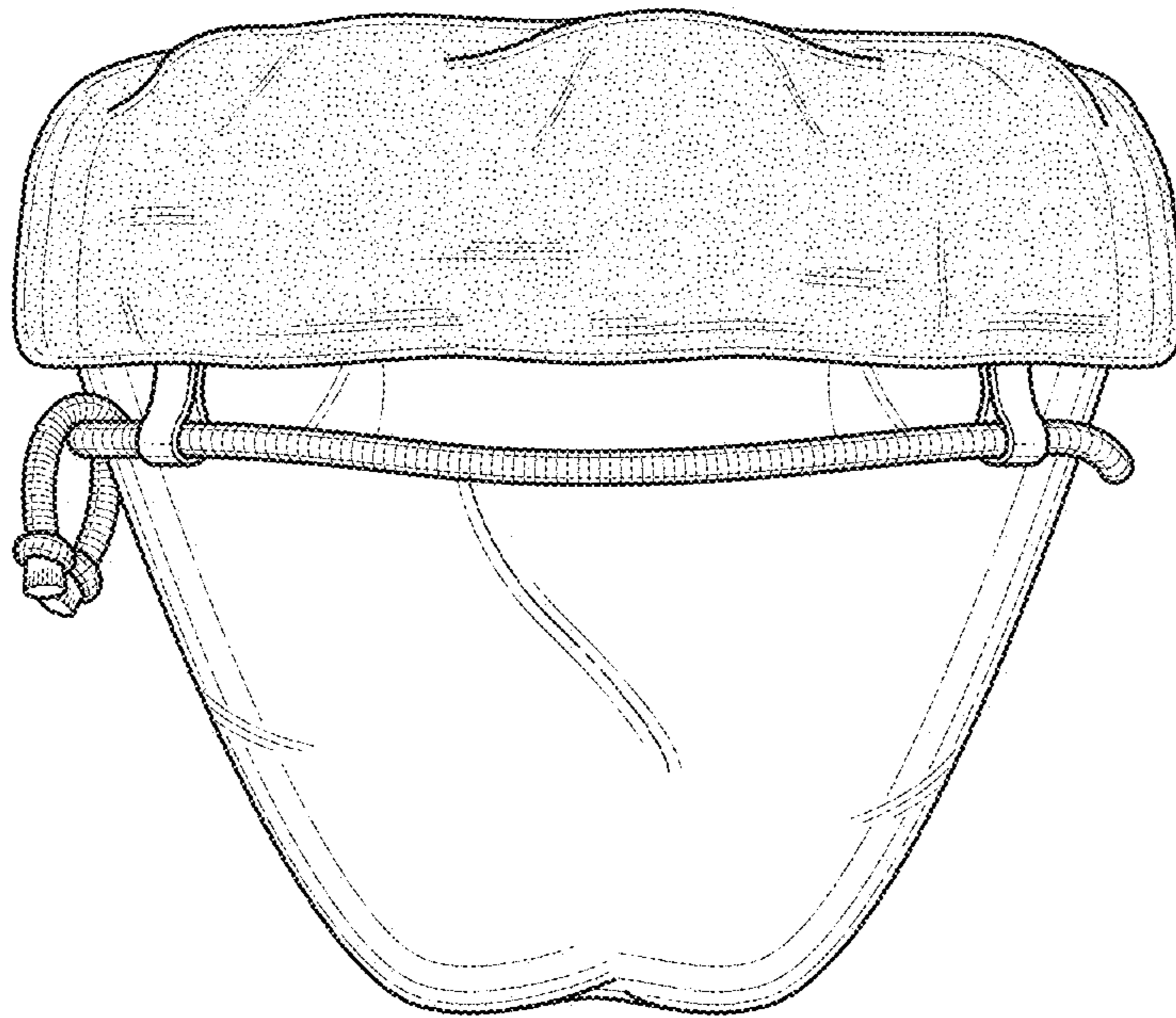

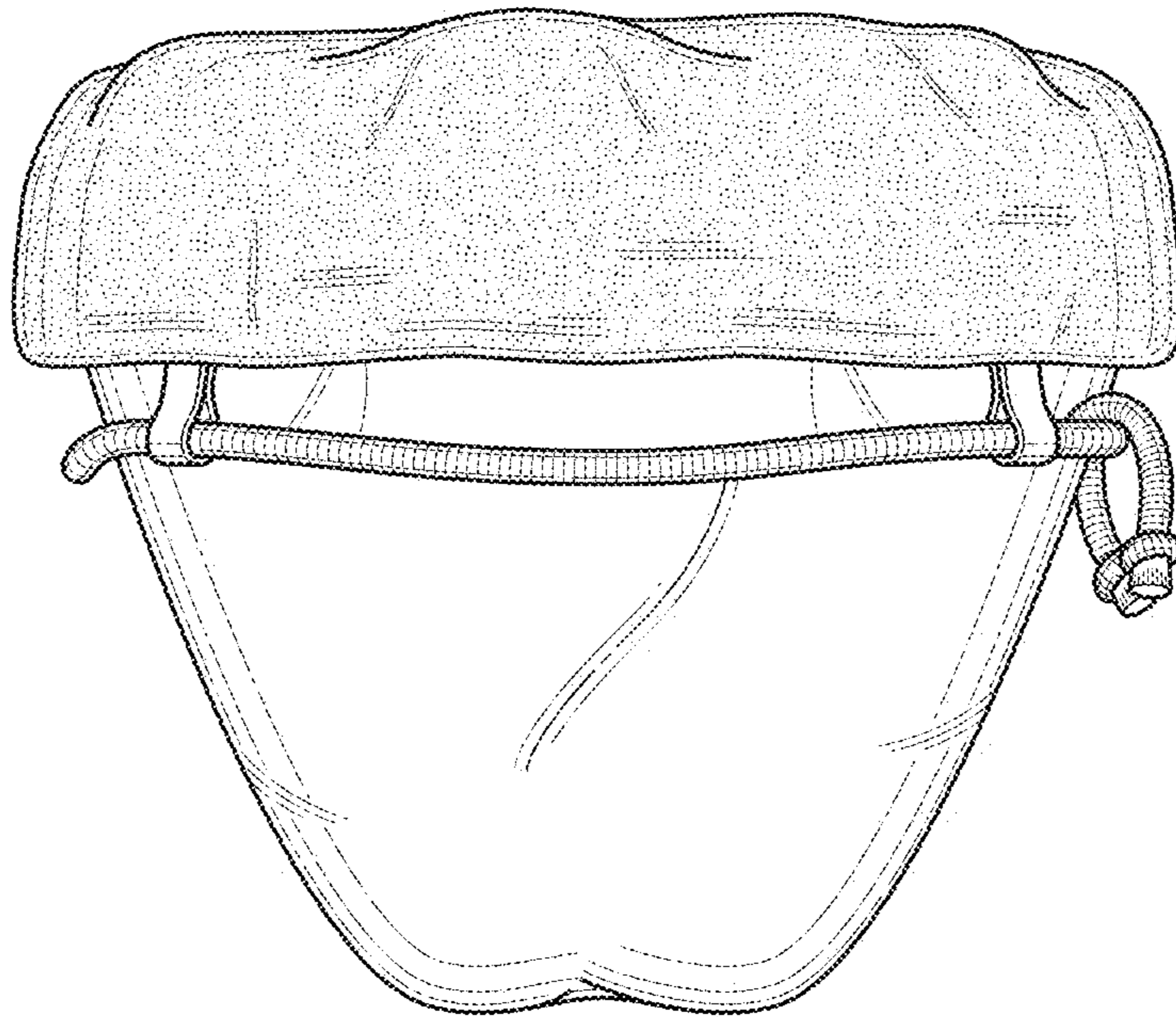

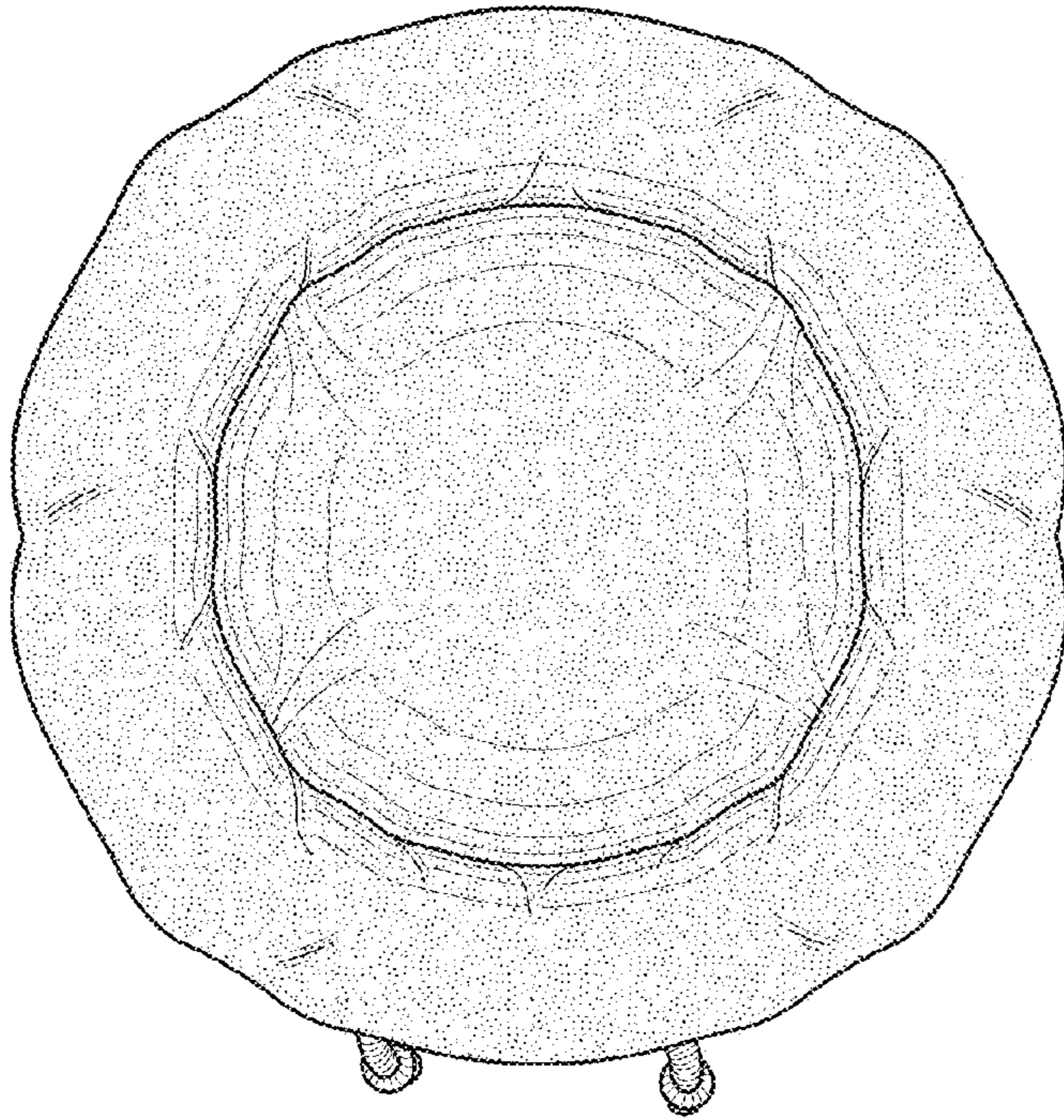

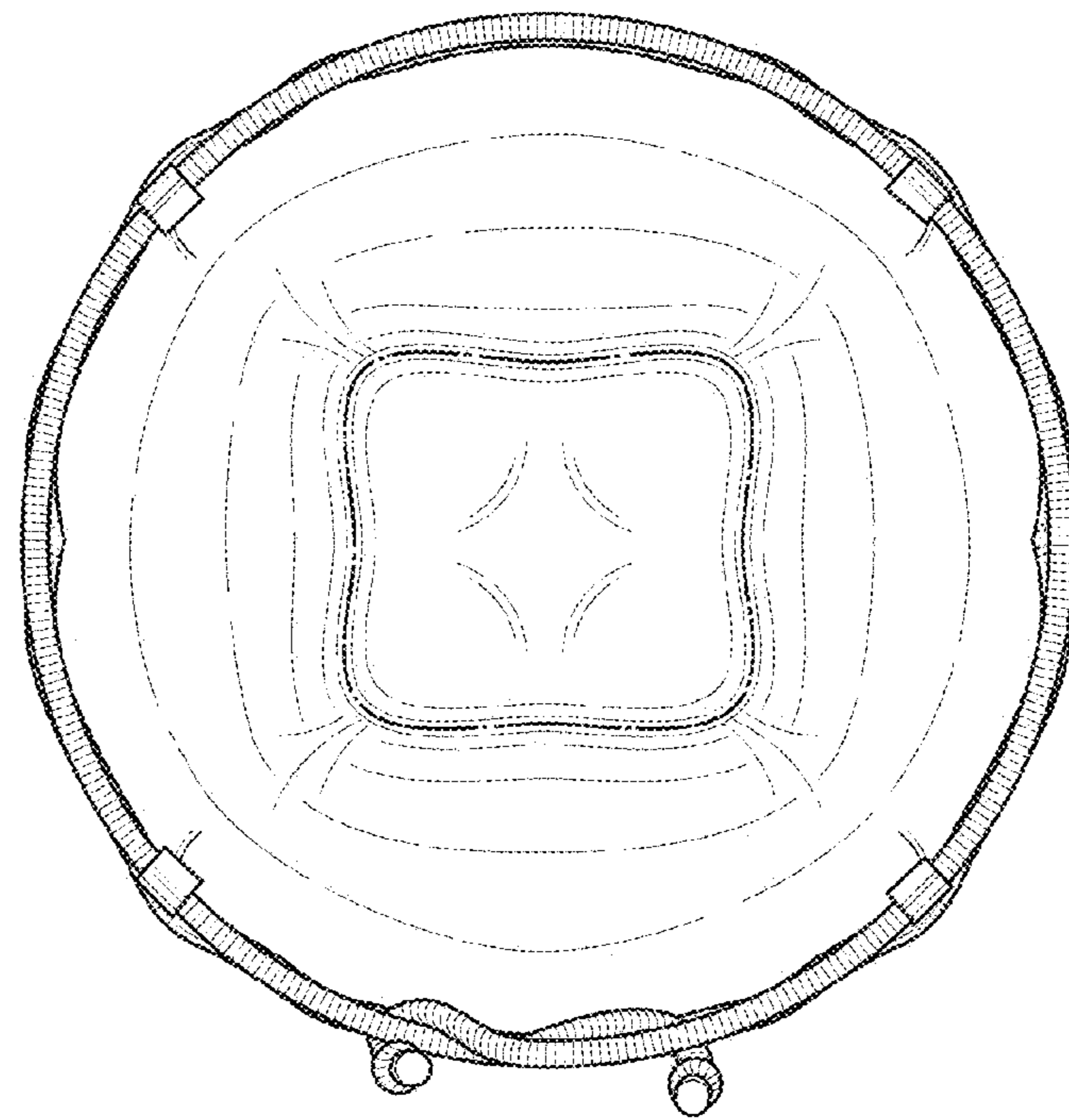

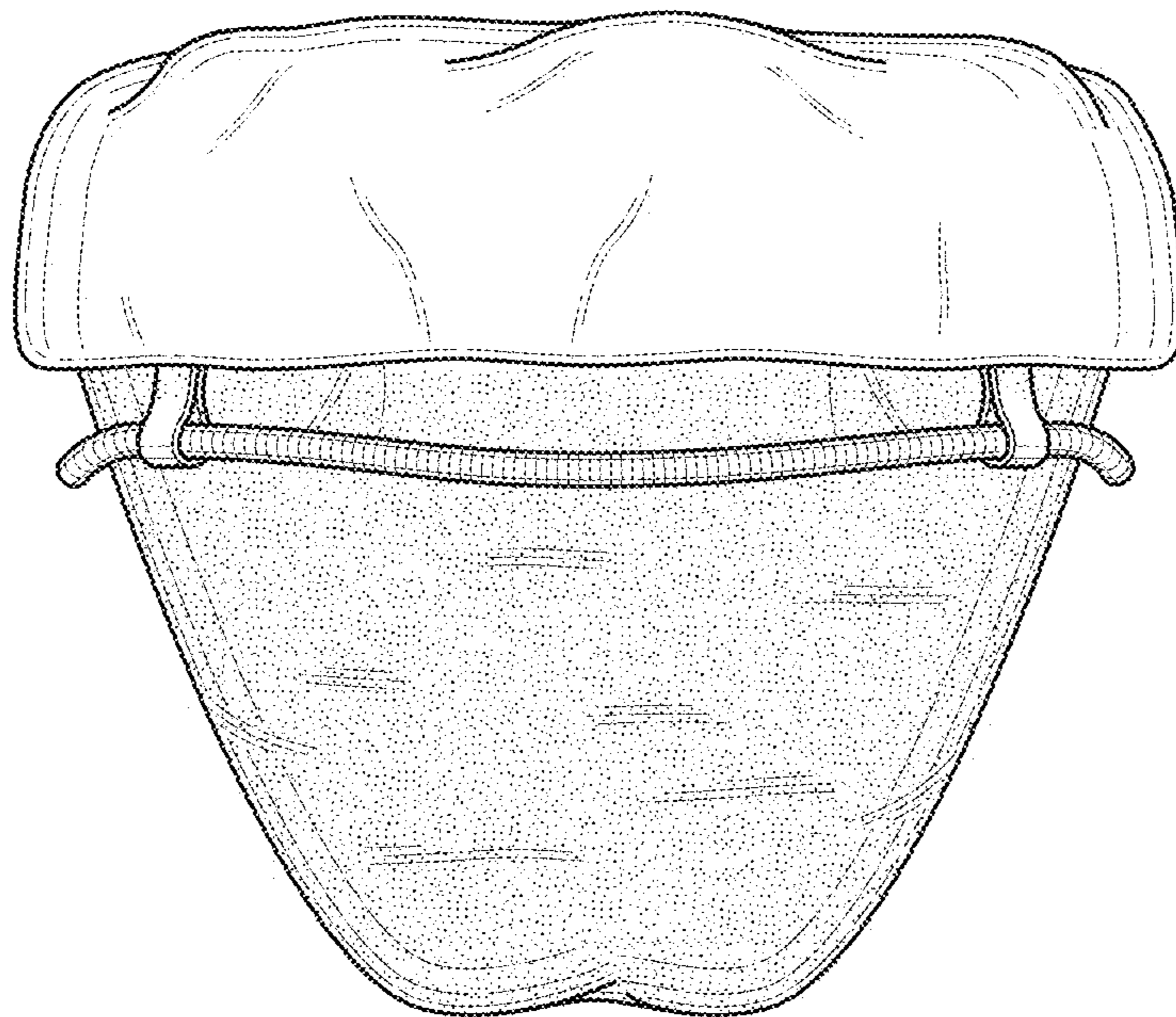
