FIG. 7 is a bottom plan view of the wheelchair frame of FIG. 1.

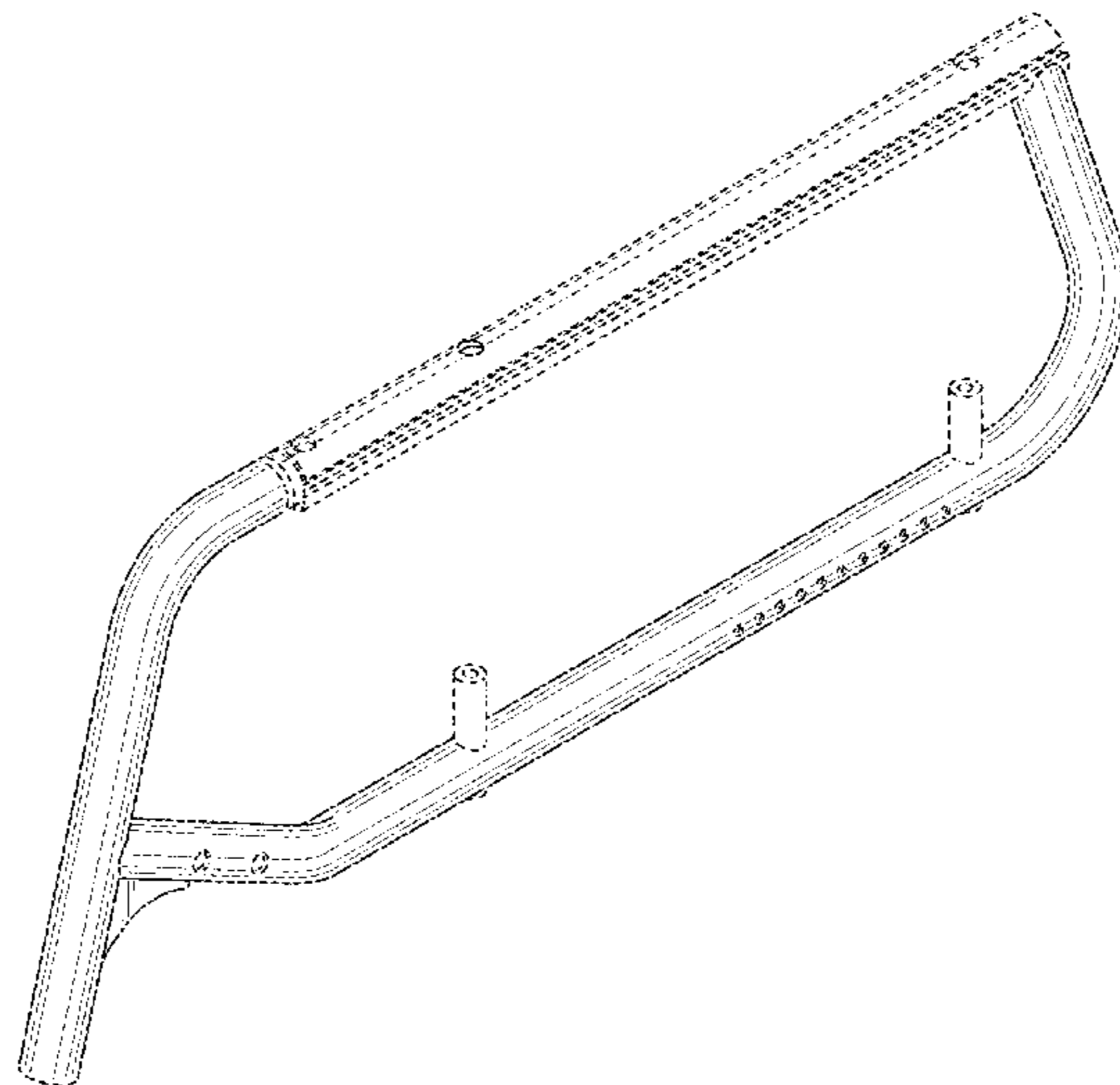

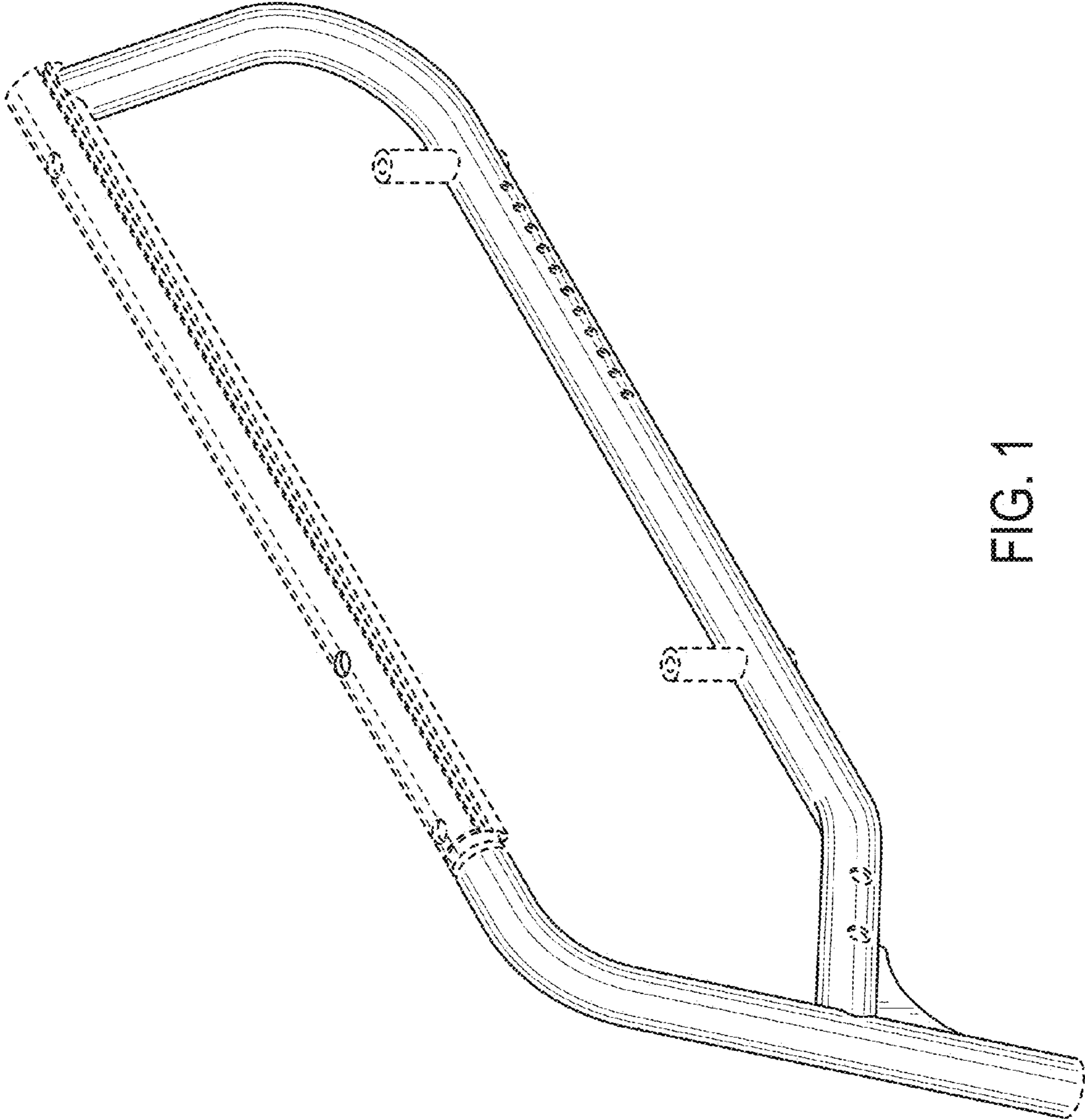

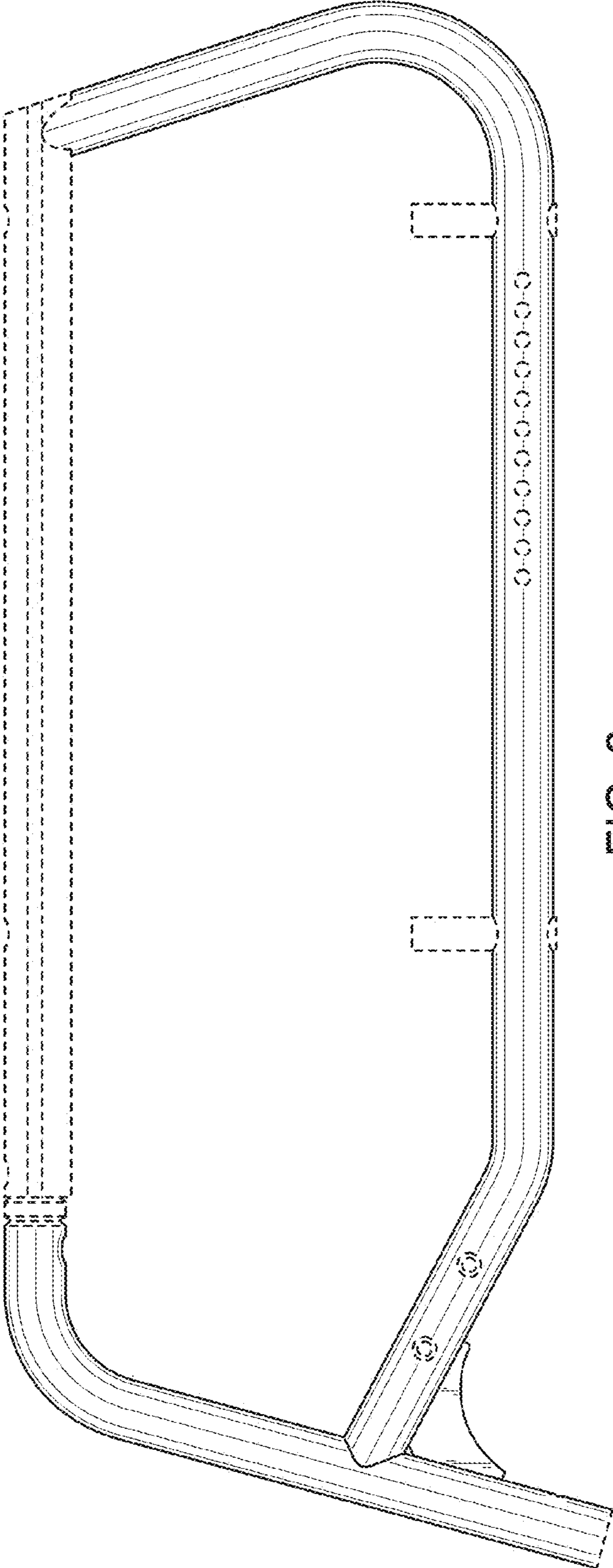

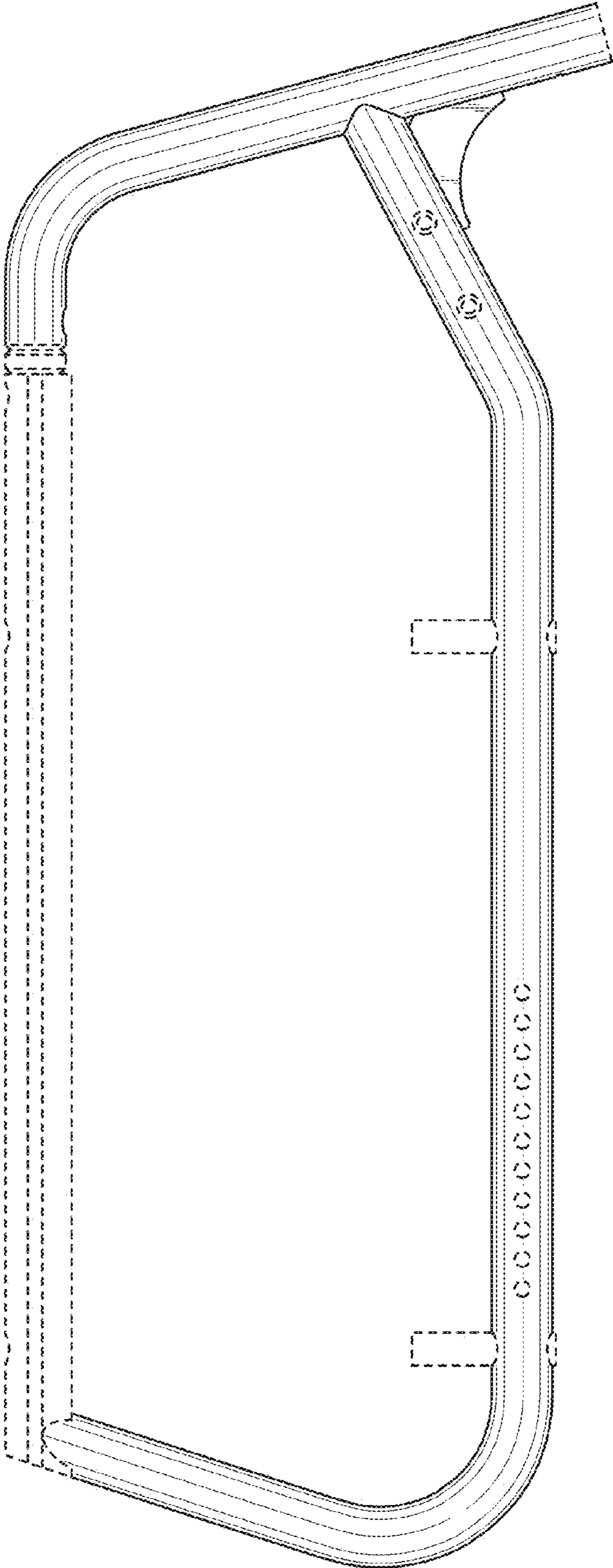

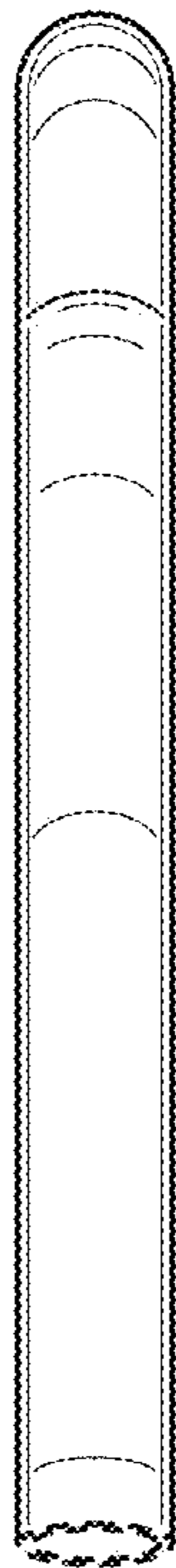

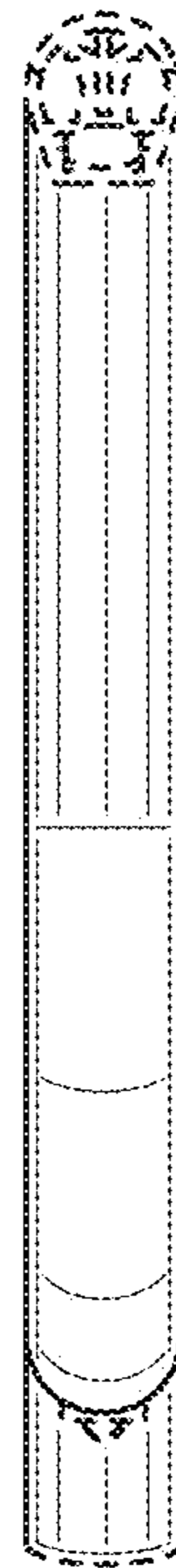

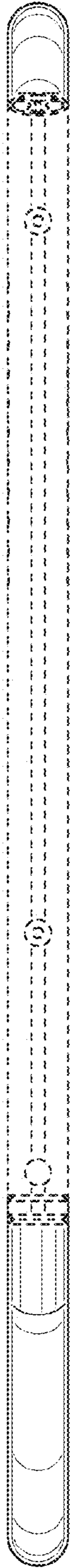

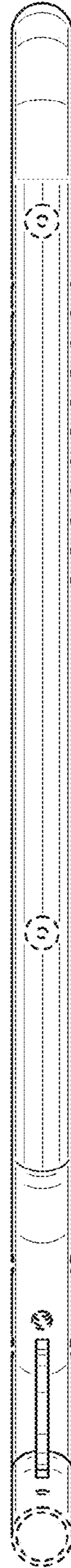
