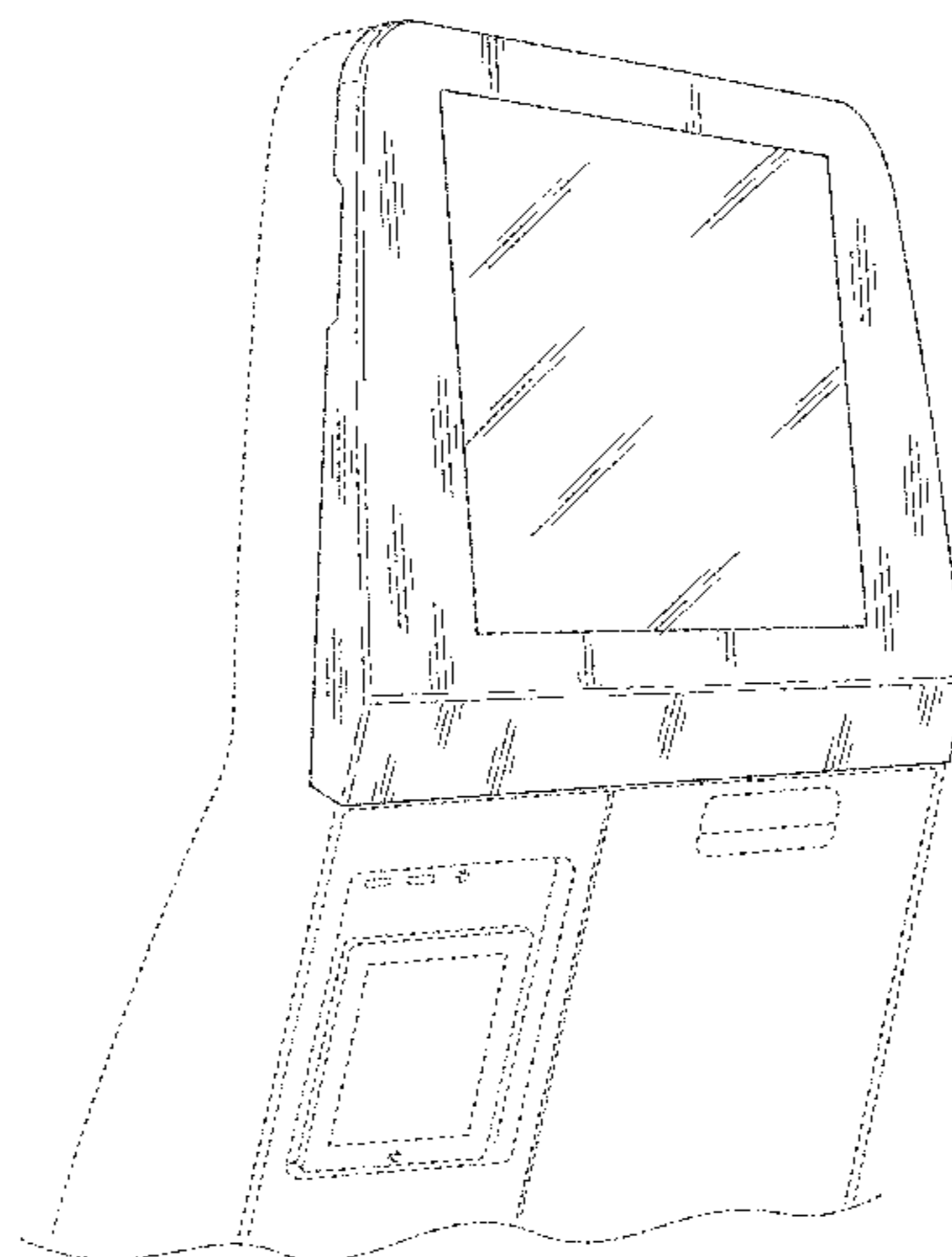
(57) **CLAIM**

The ornamental design for a display system for seatback mounting, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a display system for seatback mounting embodying the new design, shown mounted in a seatback for illustrative purposes only; FIG. 2 is a front perspective view of the display system for seatback mounting, shown separate from the seatback; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. Features drawn in broken lines are shown for illustrative purposes only, and form no part of the claimed design.

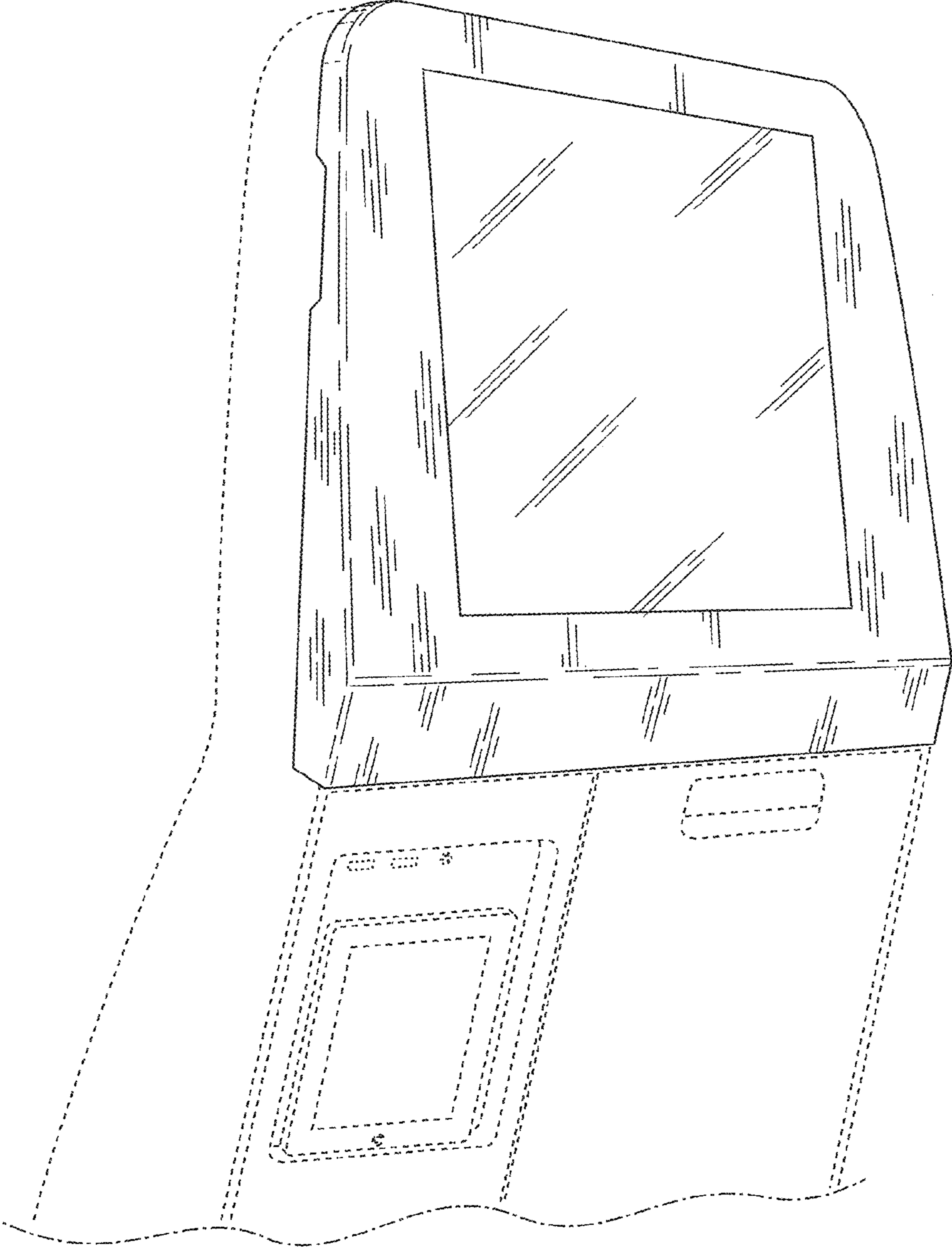
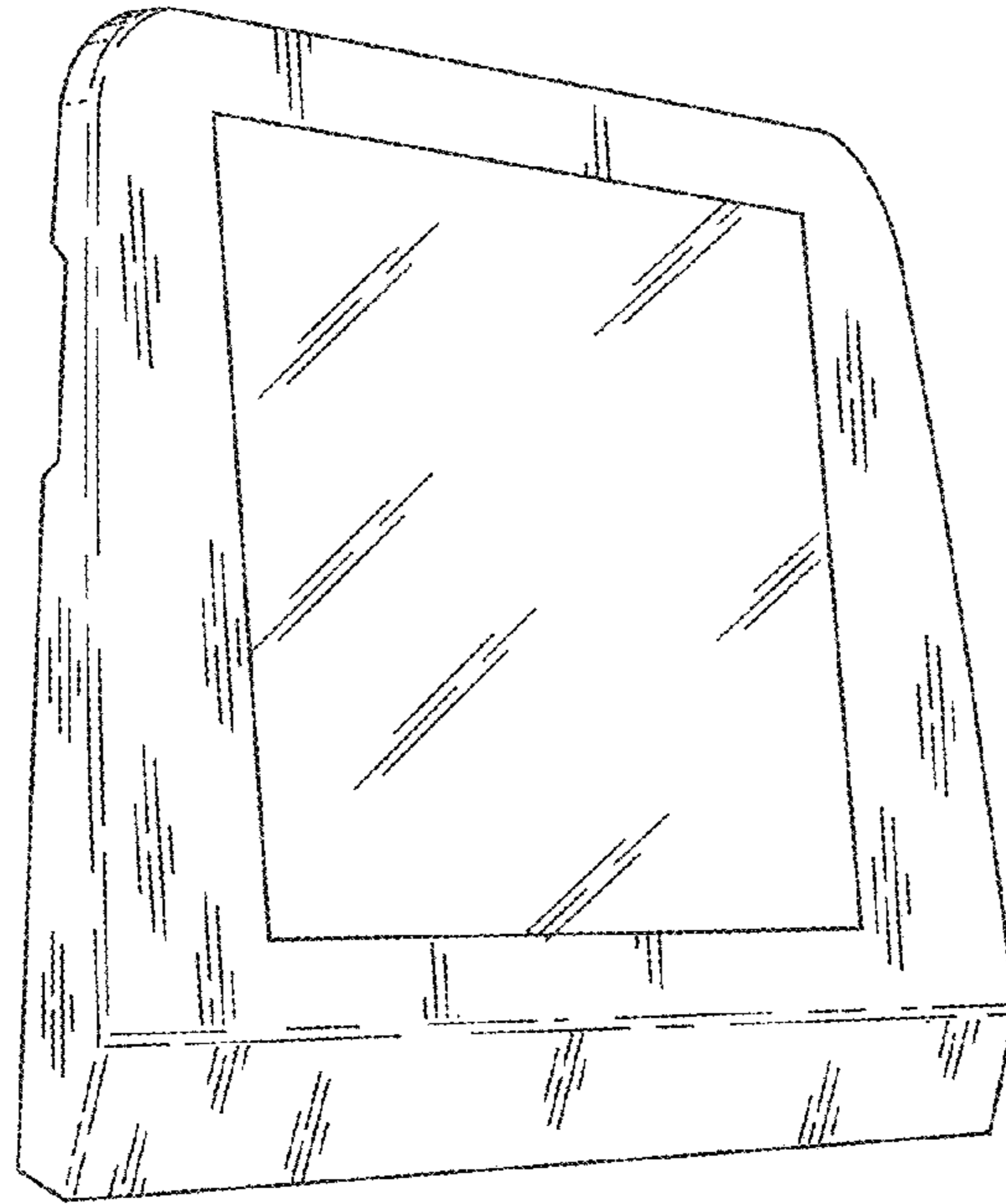
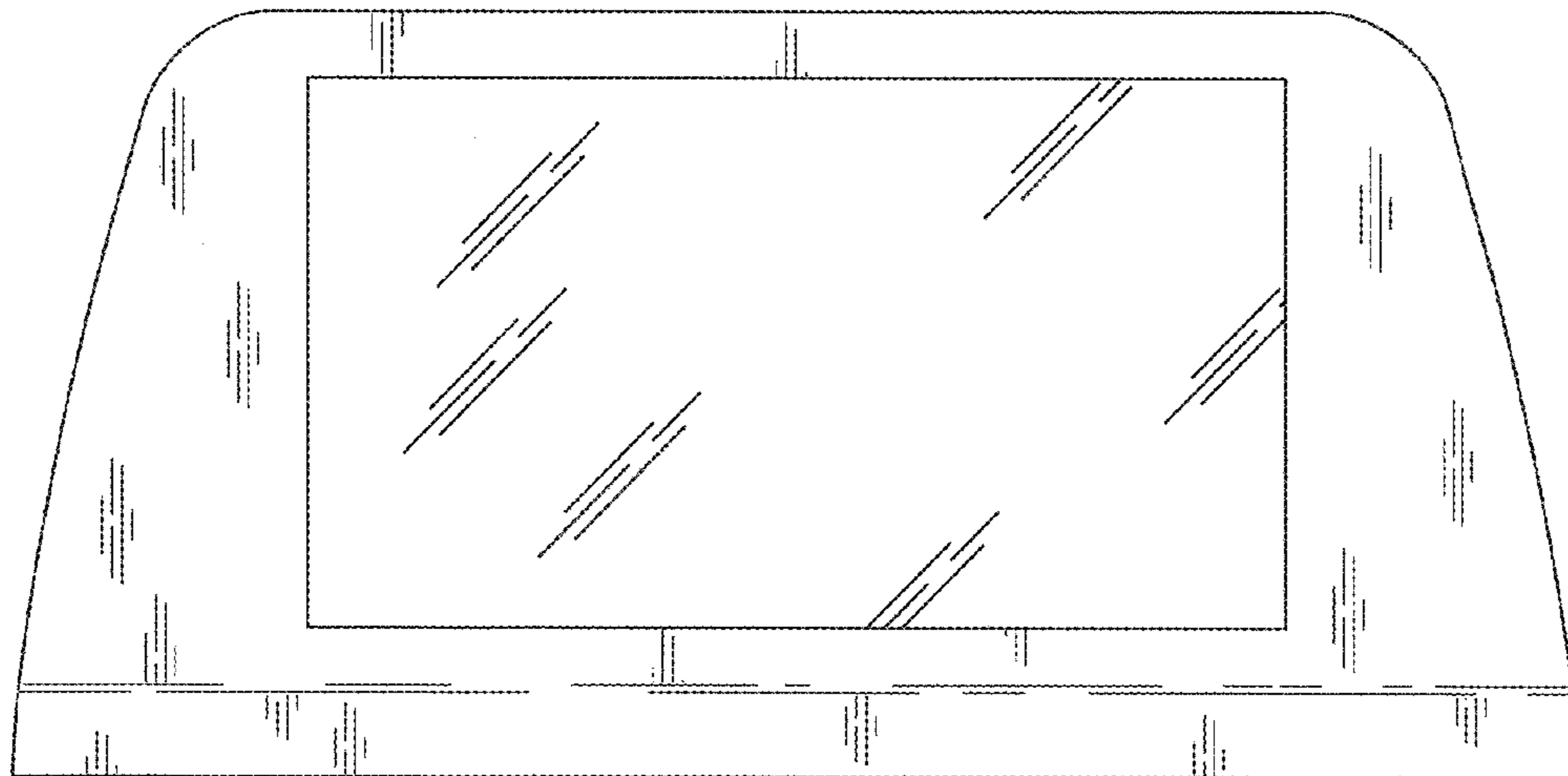

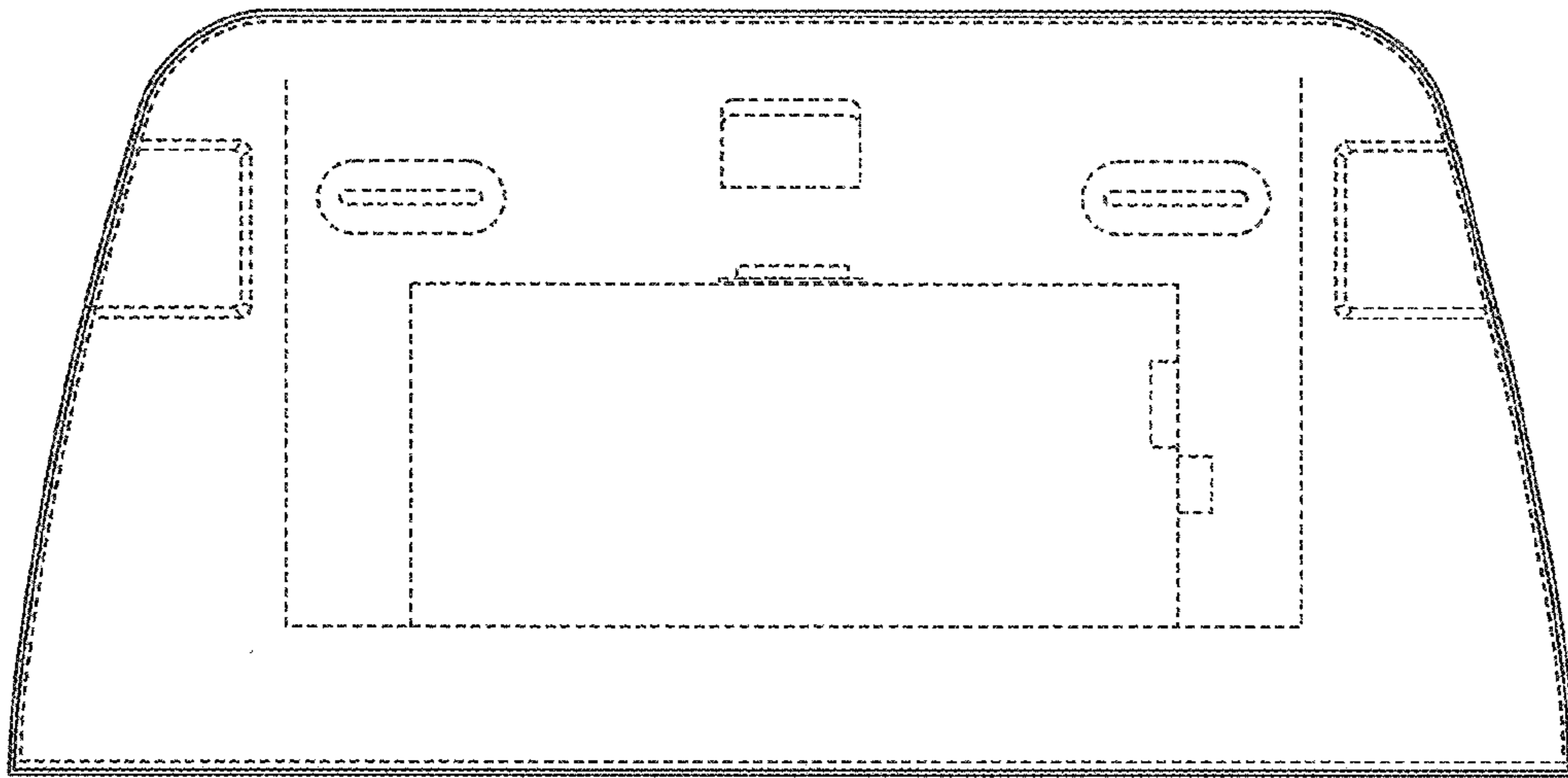

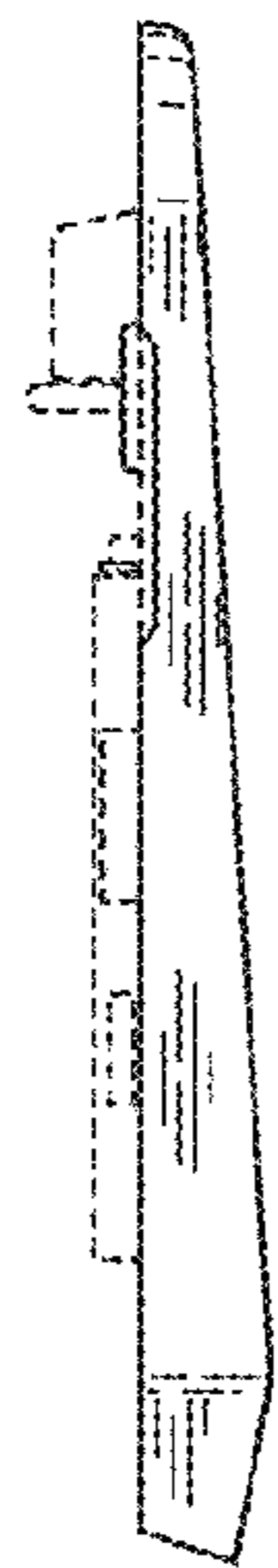

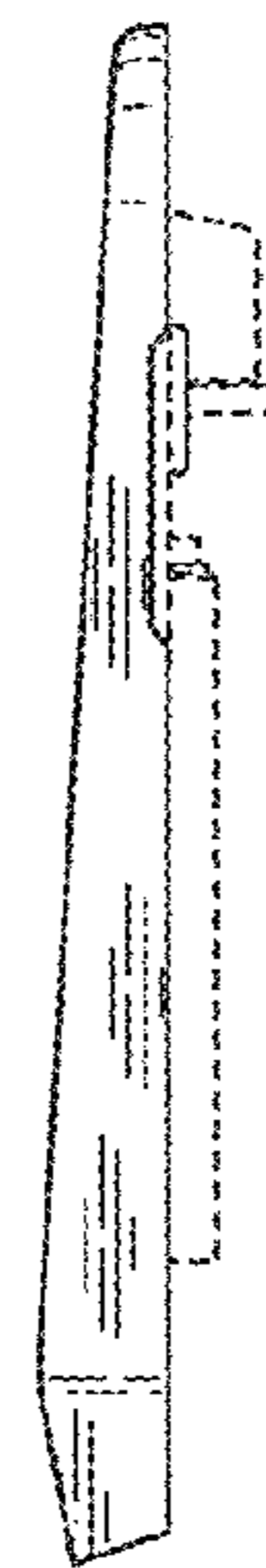




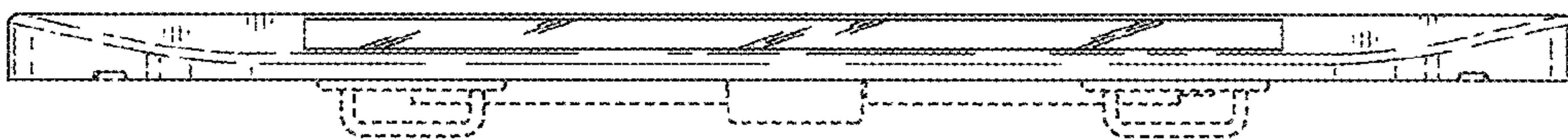

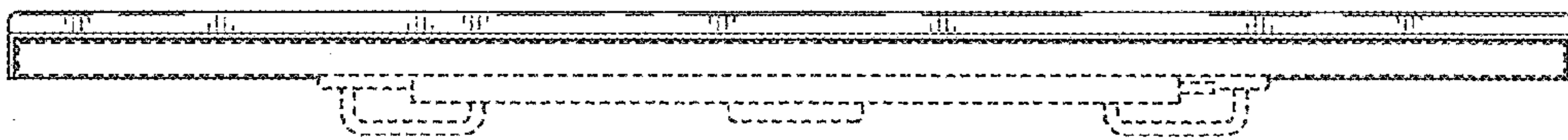
