FIG. 5 is a left side view of the accessory for portable electronic device having rectangular base;

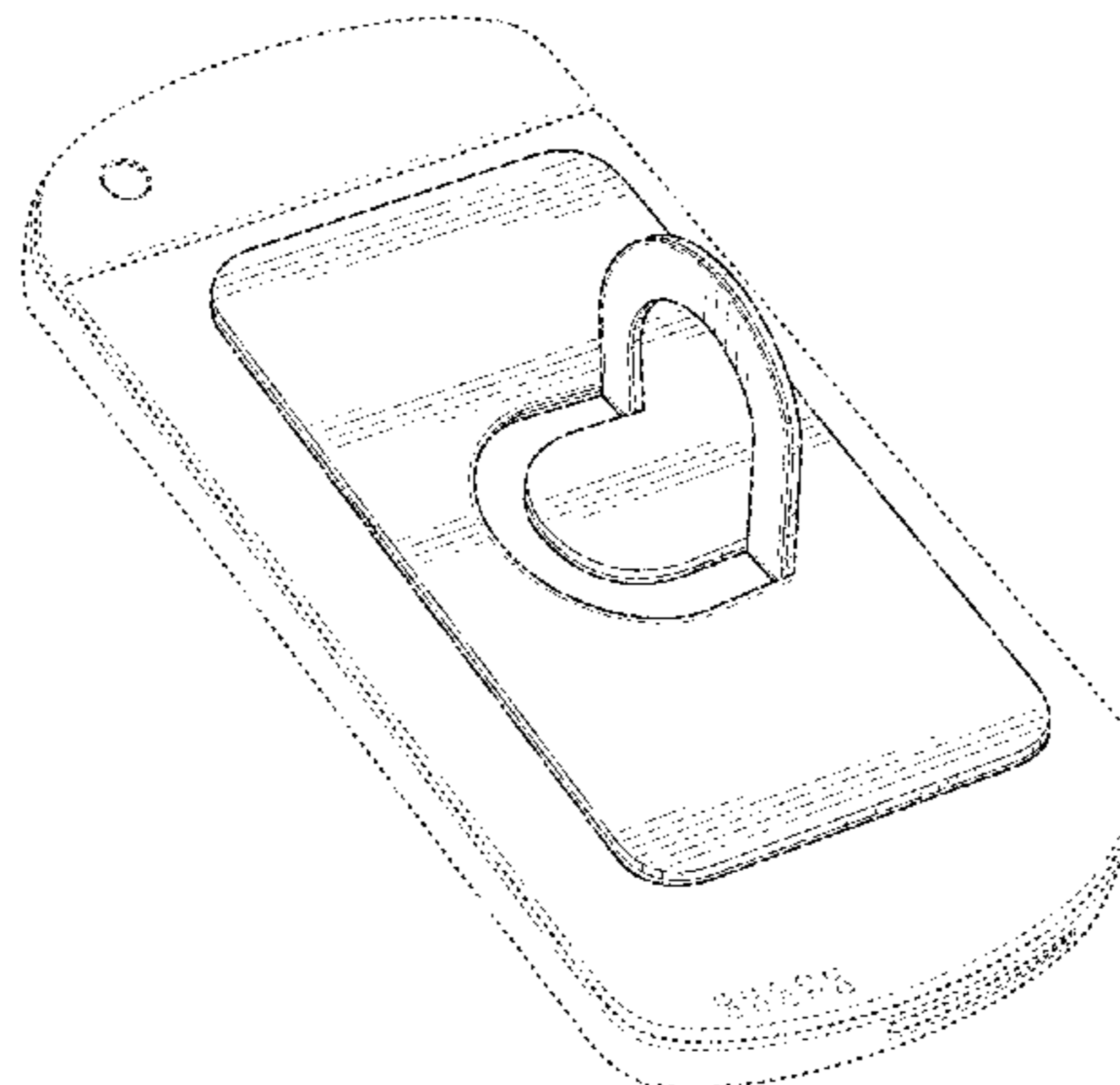
FIG. 6 is a top view of the accessory for portable electronic device having rectangular base;

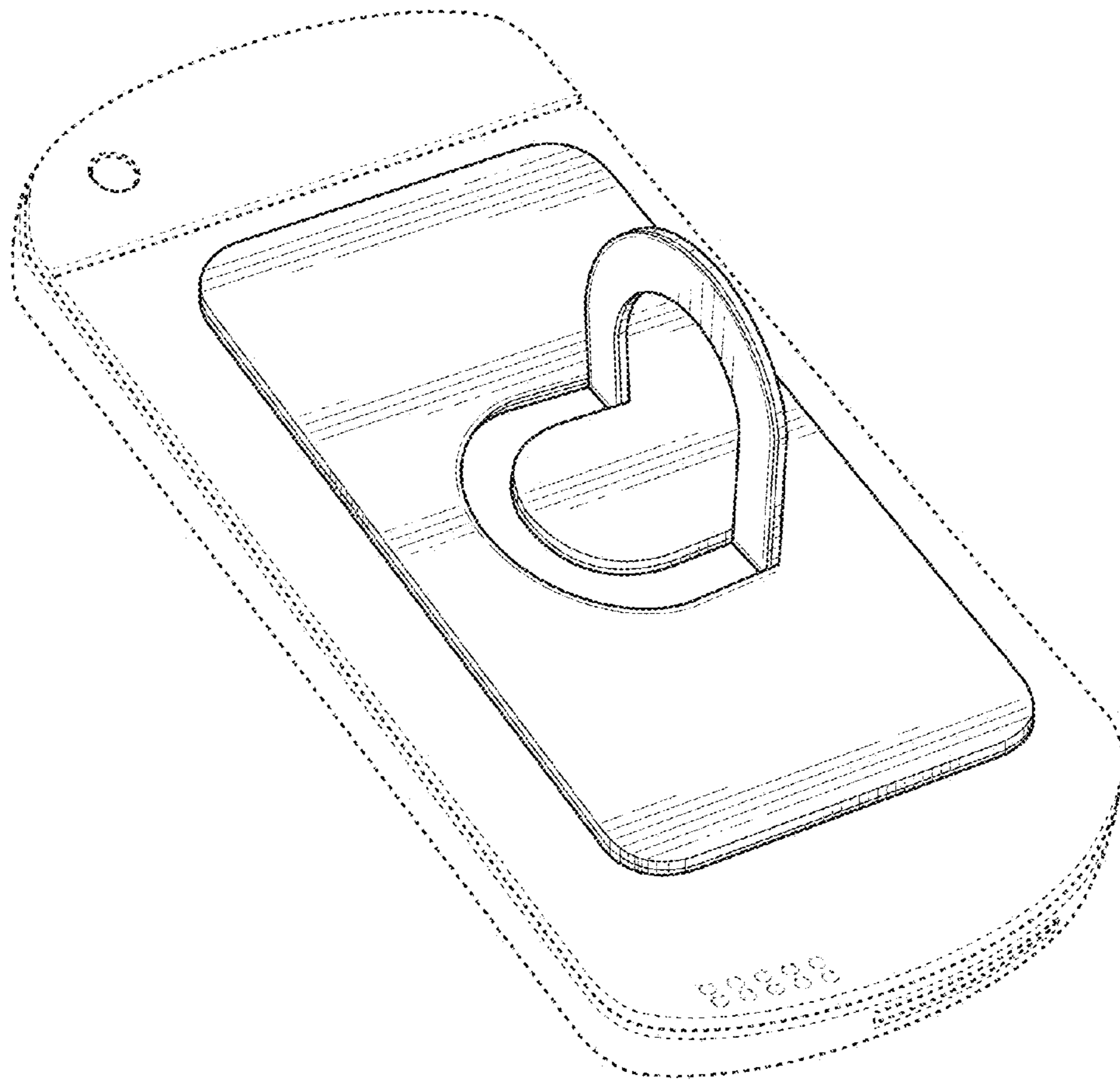

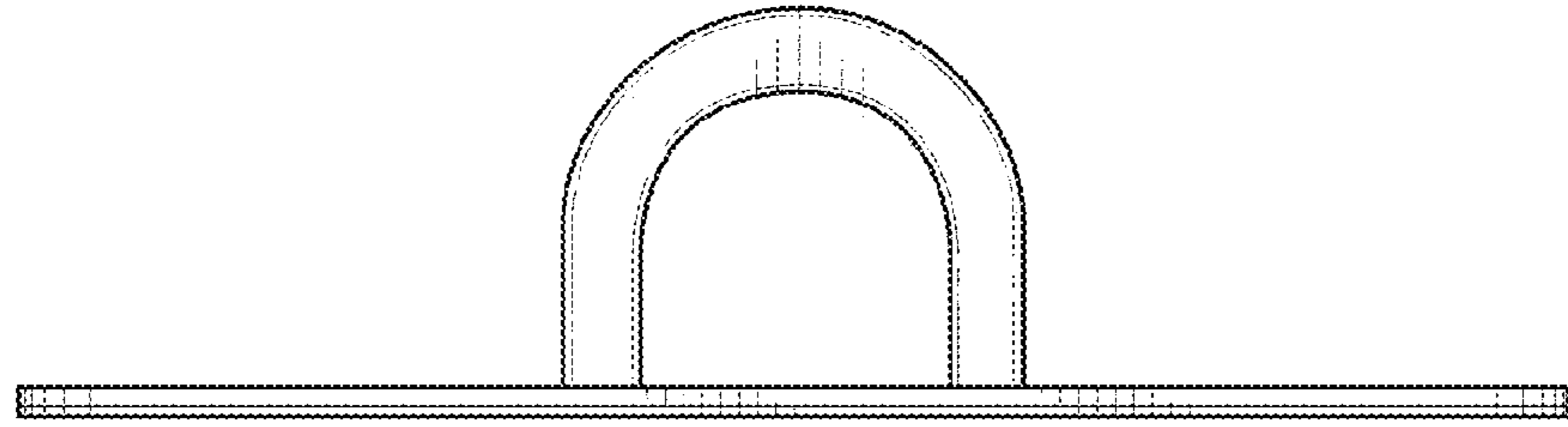

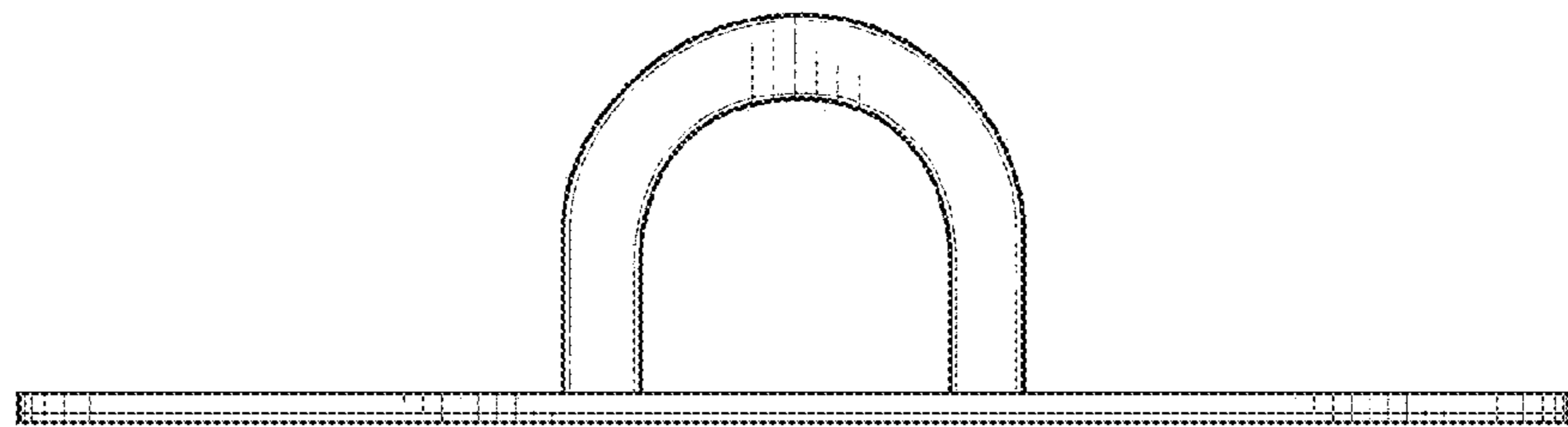

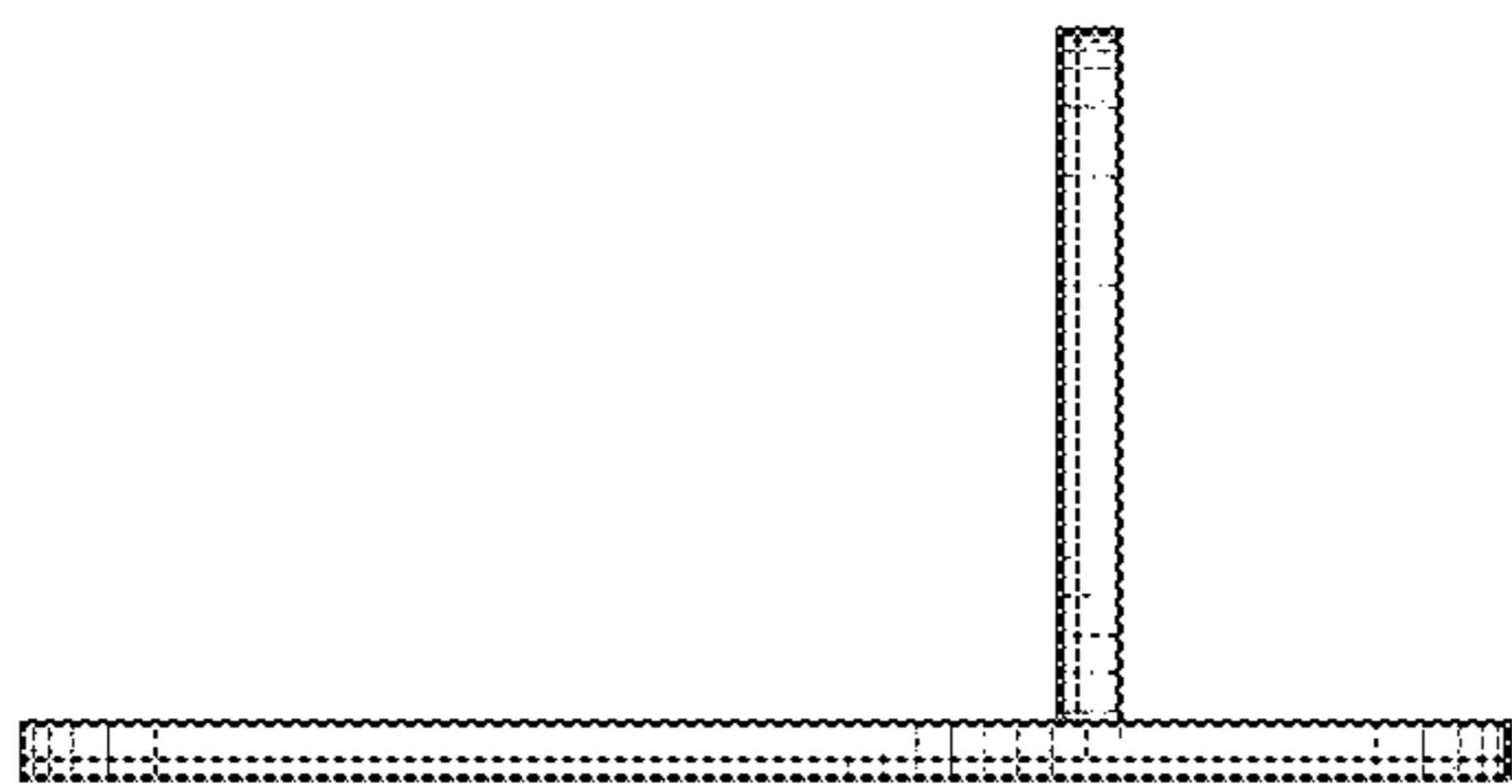

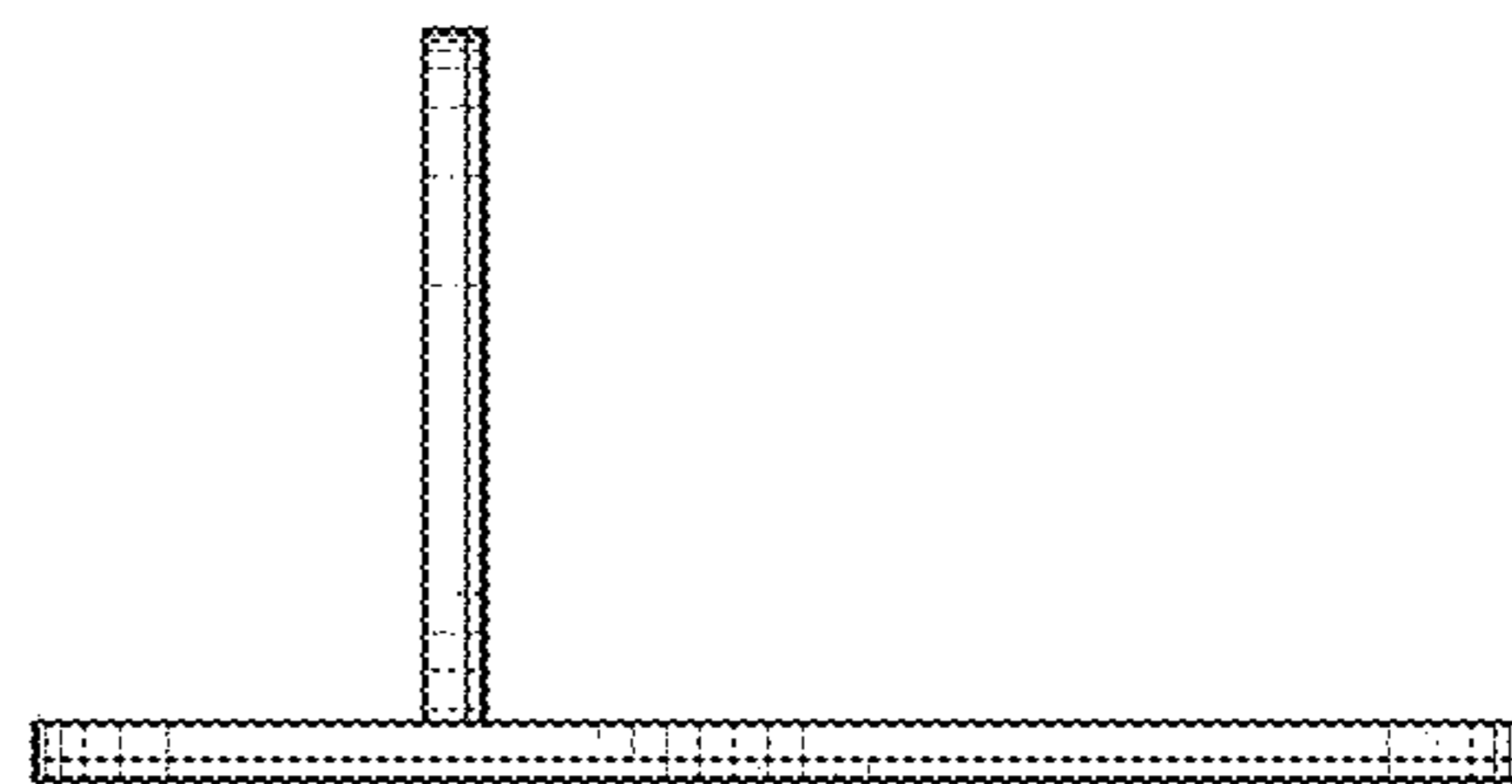

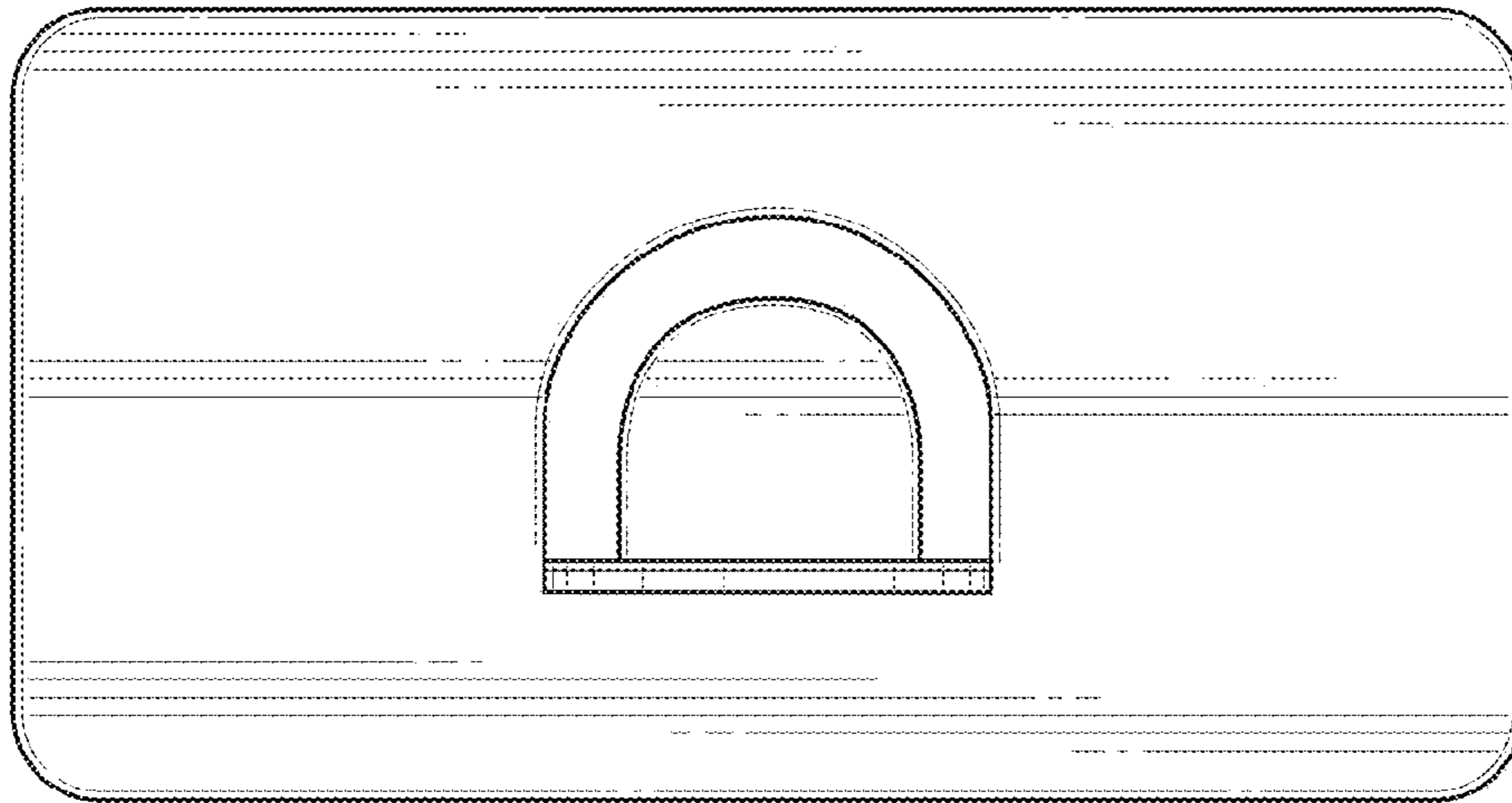

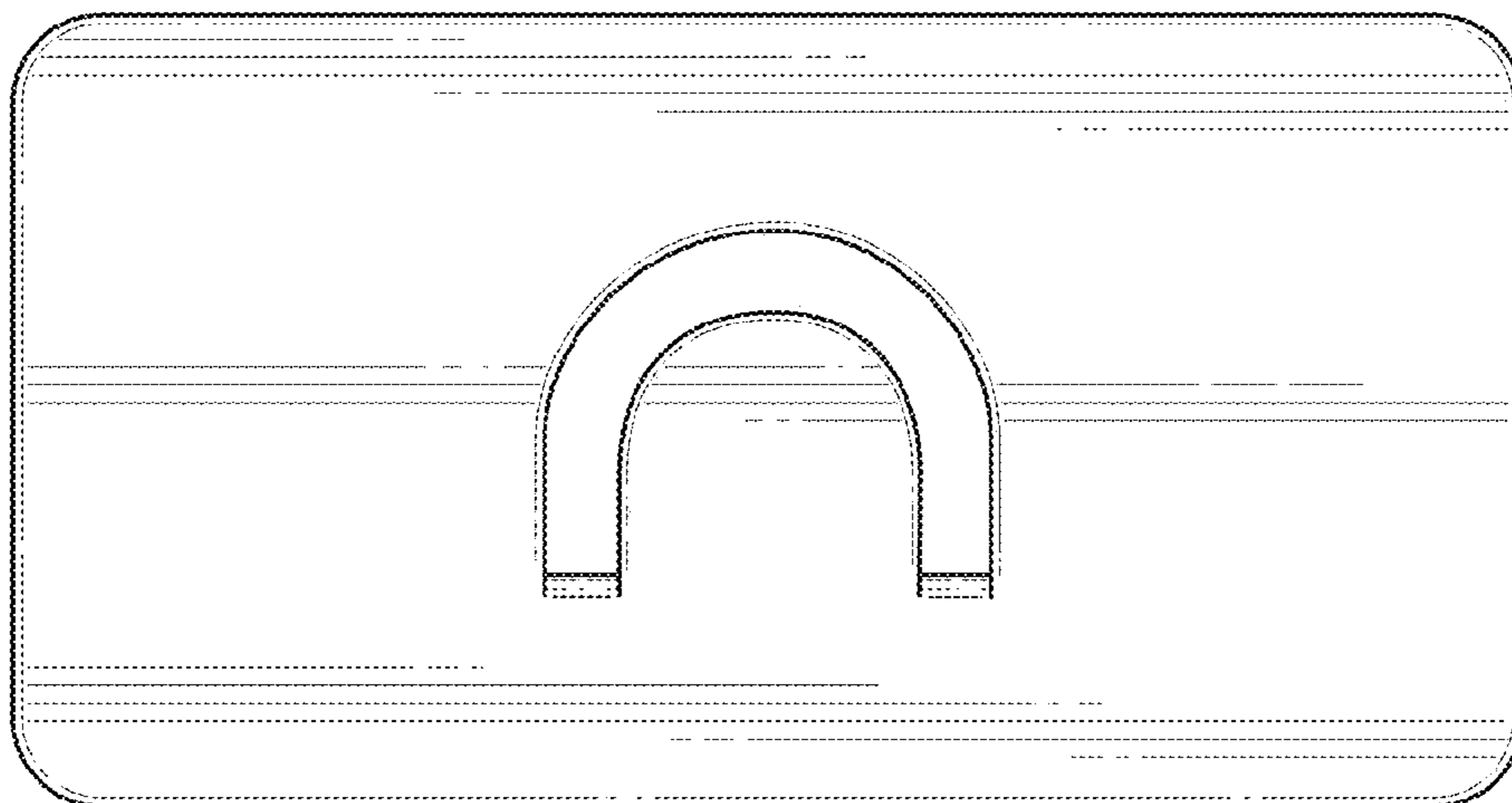

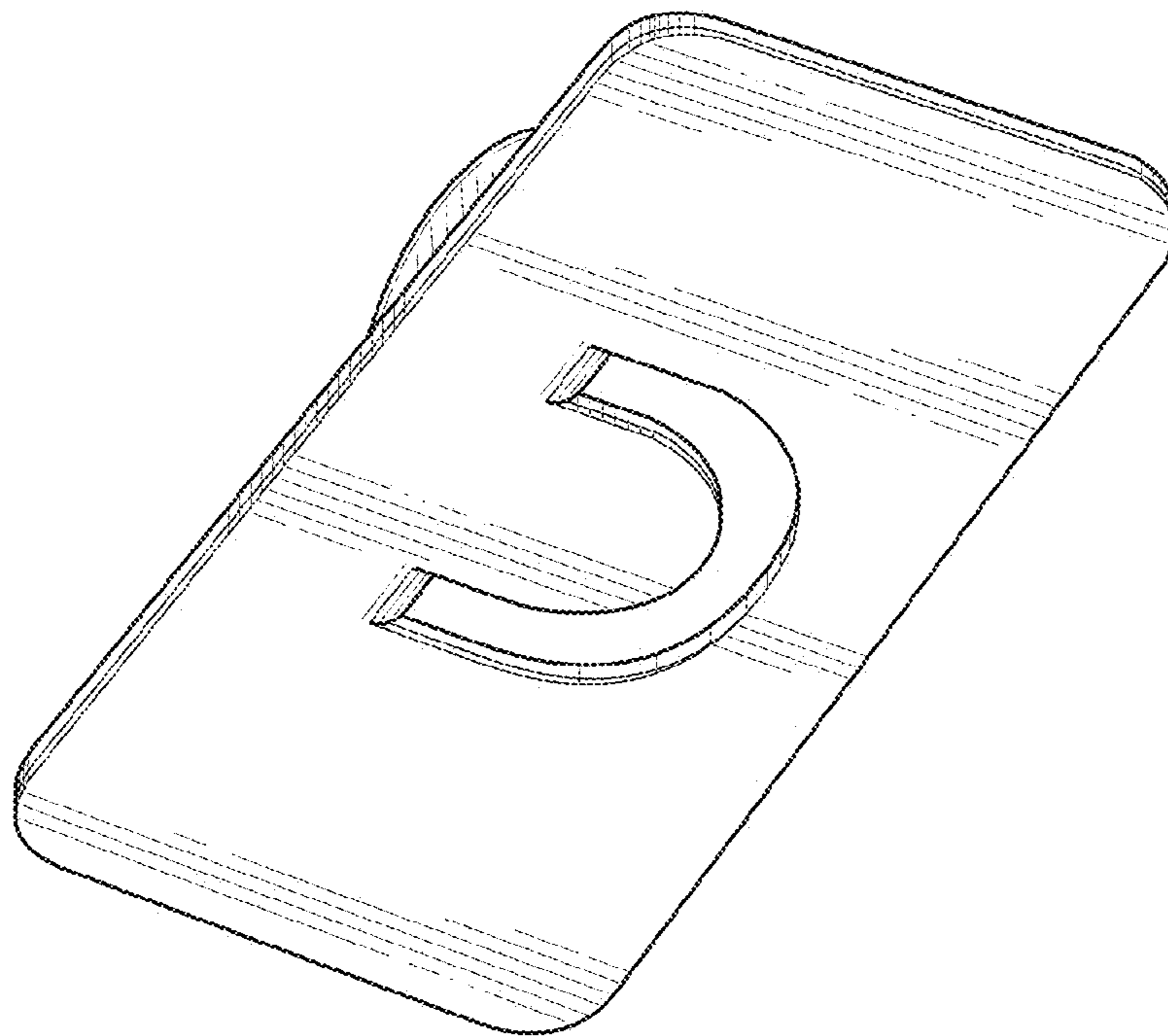
