I claim, the ornamental design for a tablet PC, as shown and described.

**DESCRIPTION**

FIG. 13 is an additional top plan view thereof, with a portion of a stand of the tablet PC in an open position;

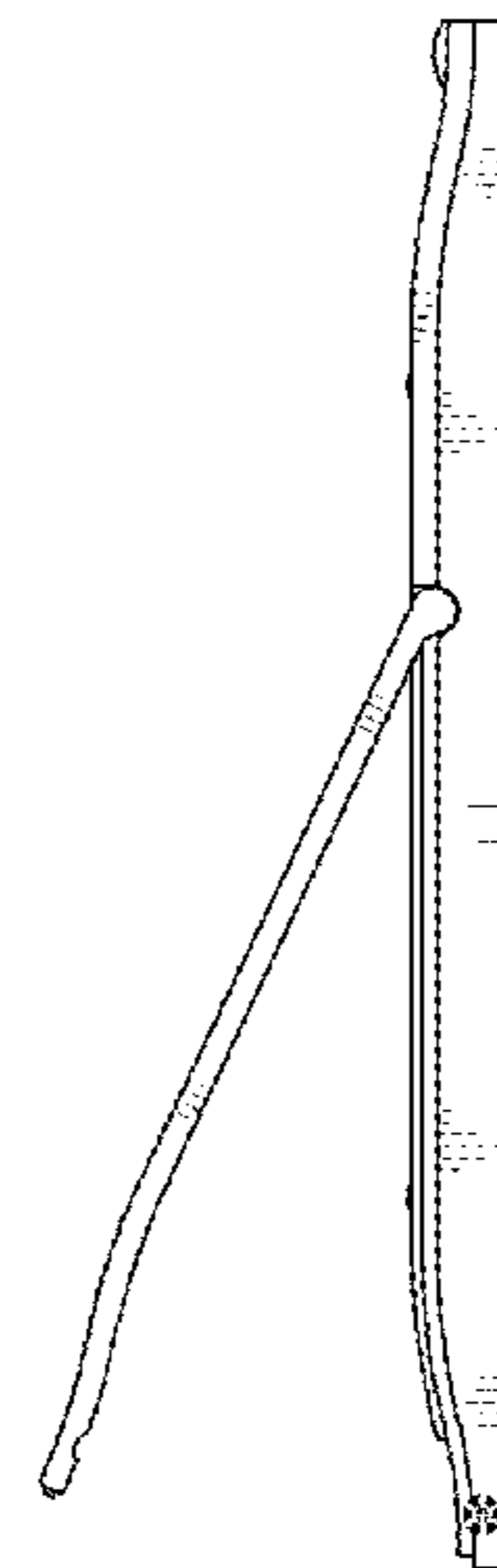
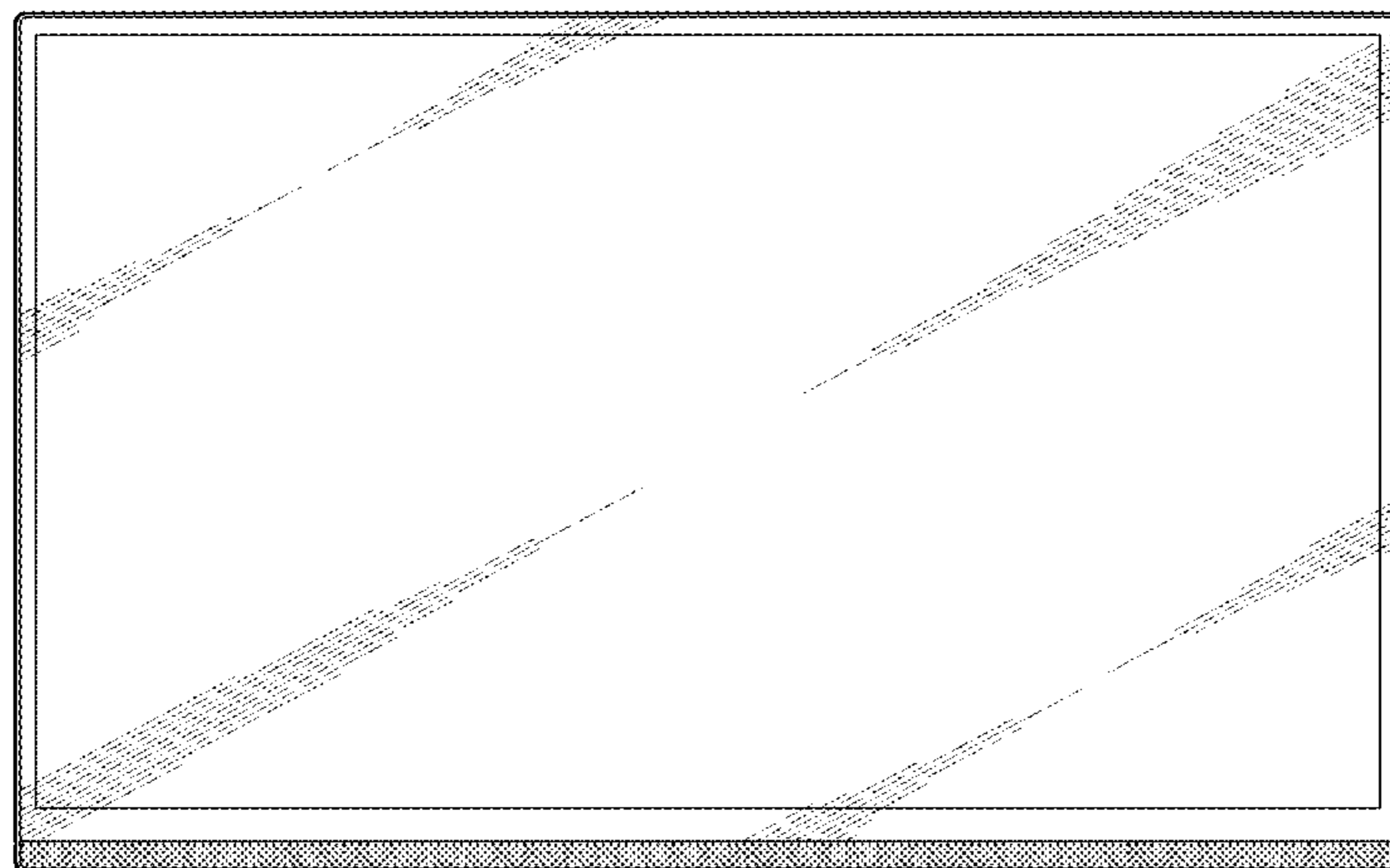
FIG. 14 is an additional bottom plan view thereof, with a portion of a stand of the tablet PC in an open position; and,

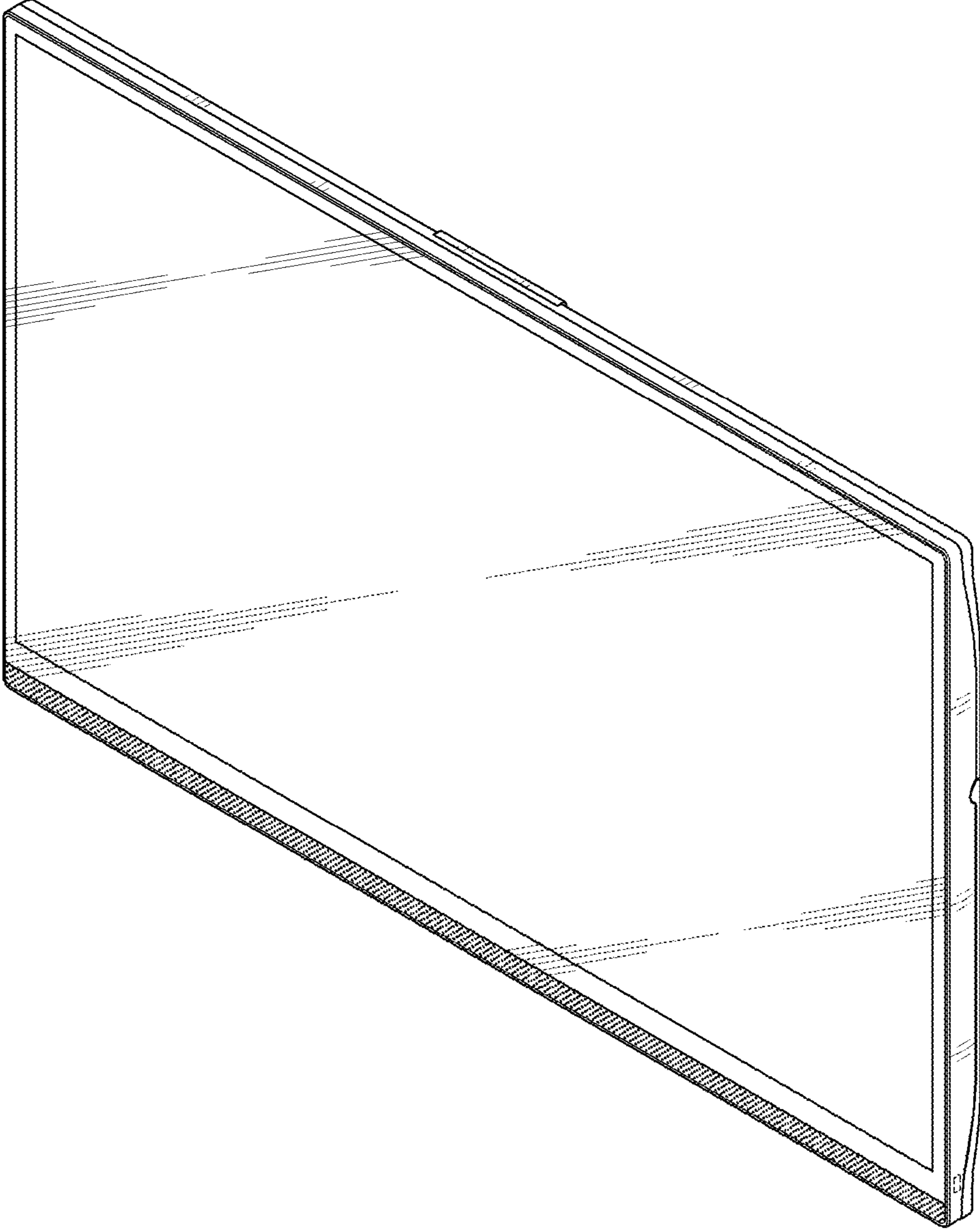

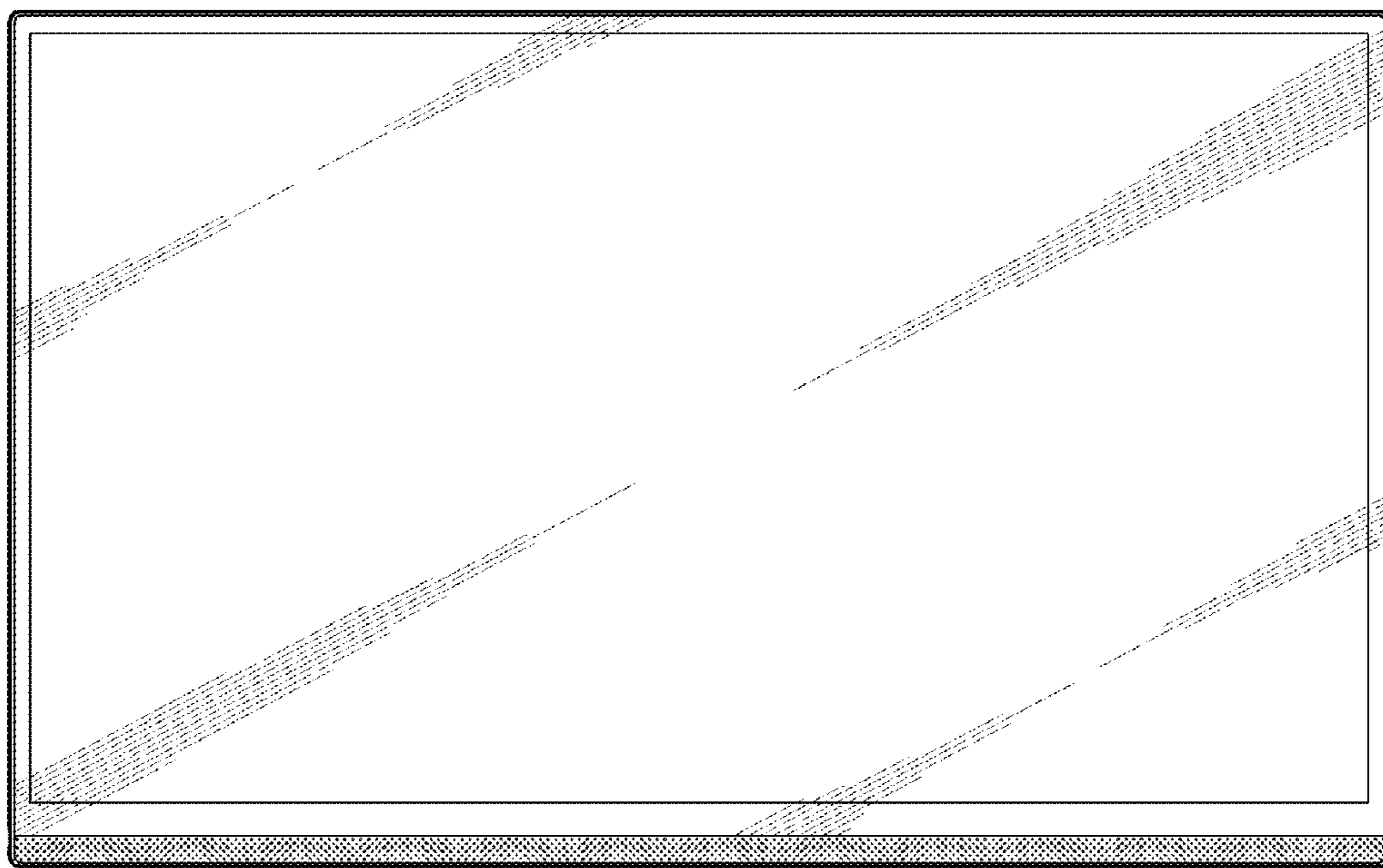

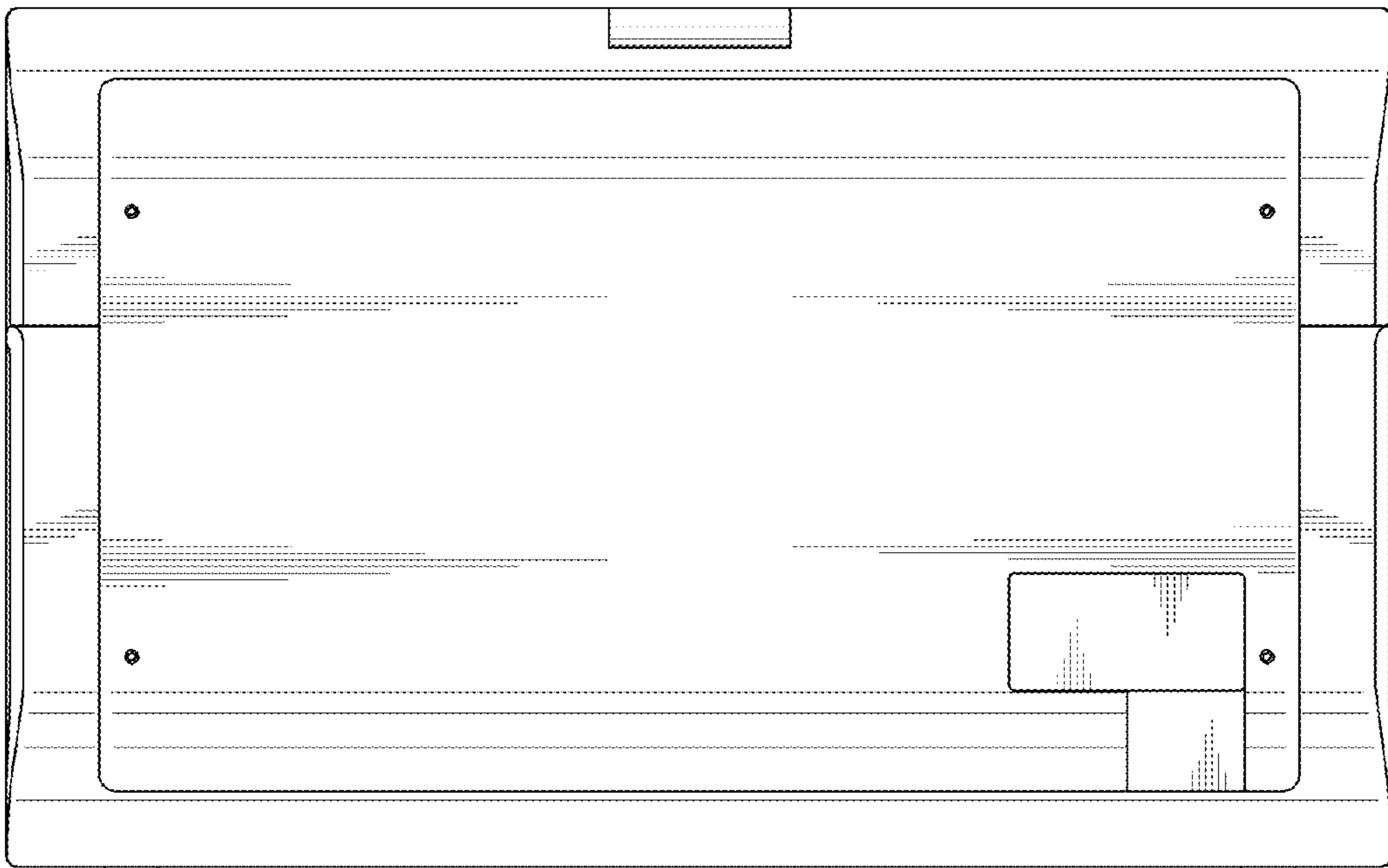

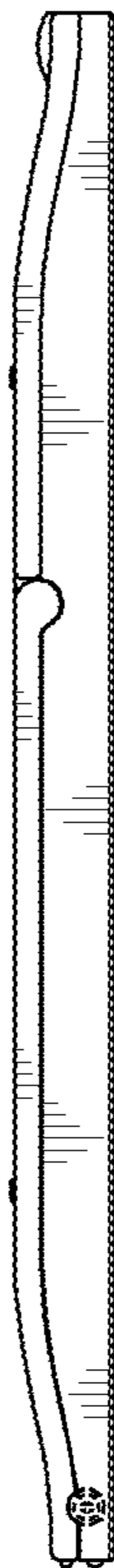

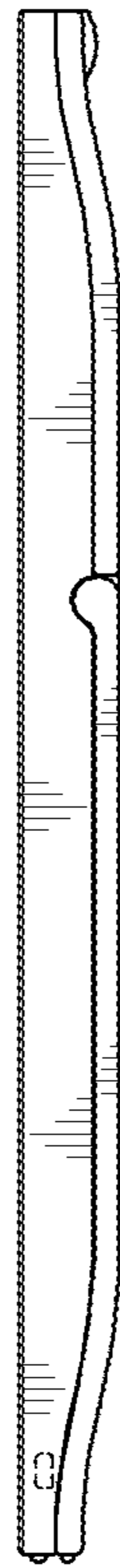

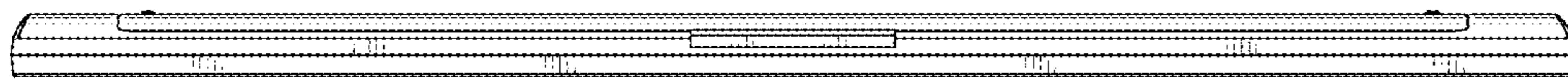

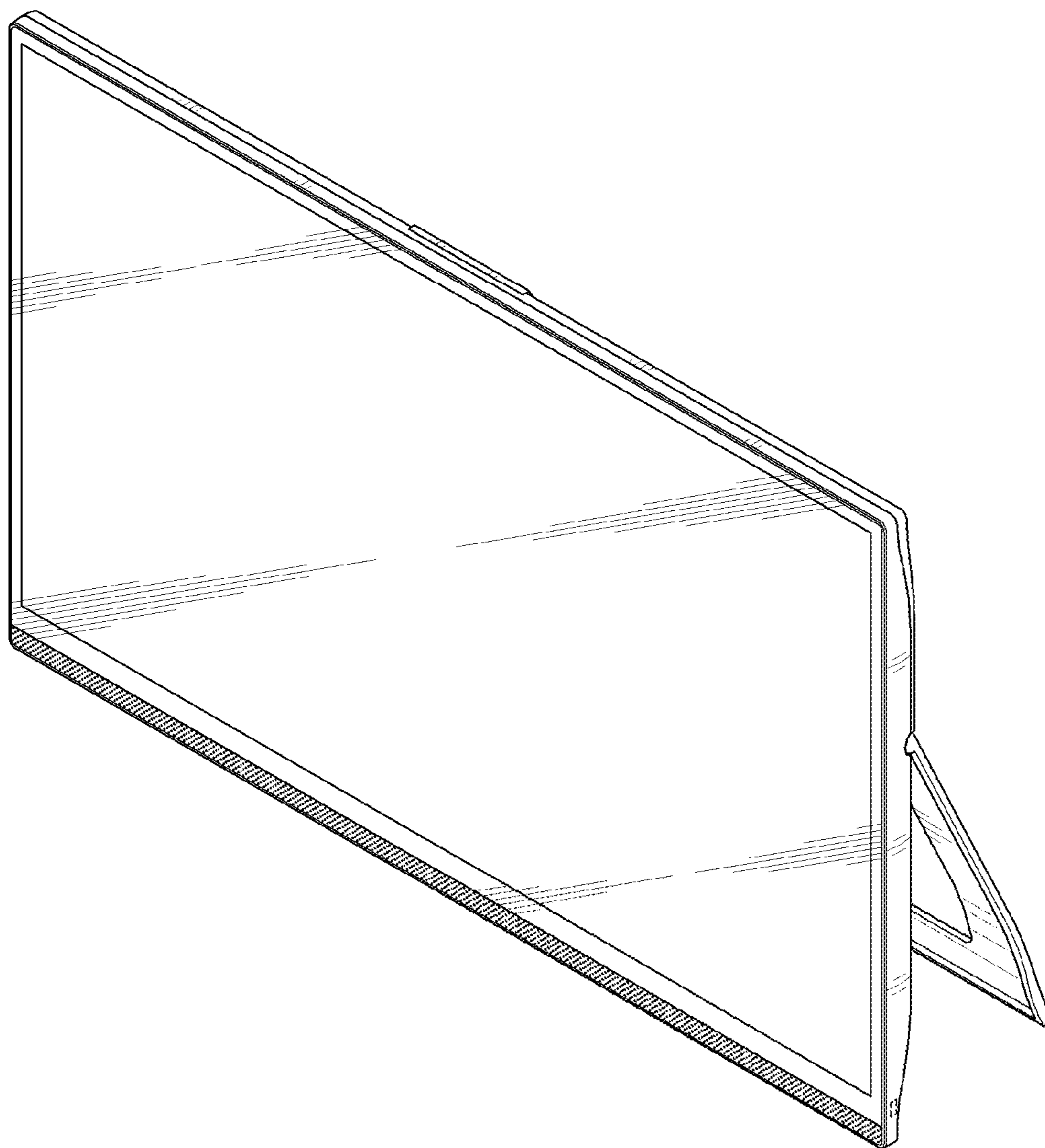

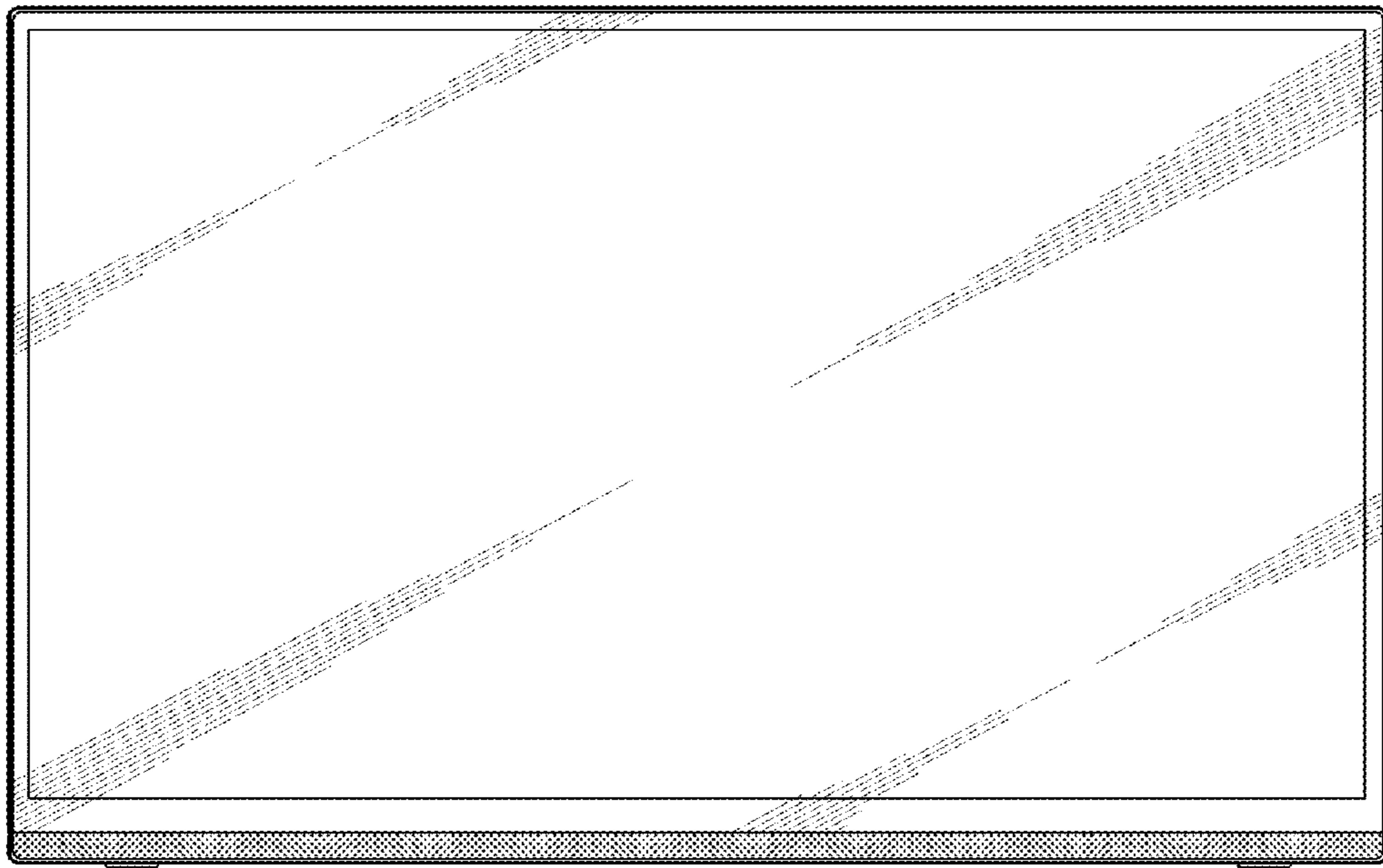

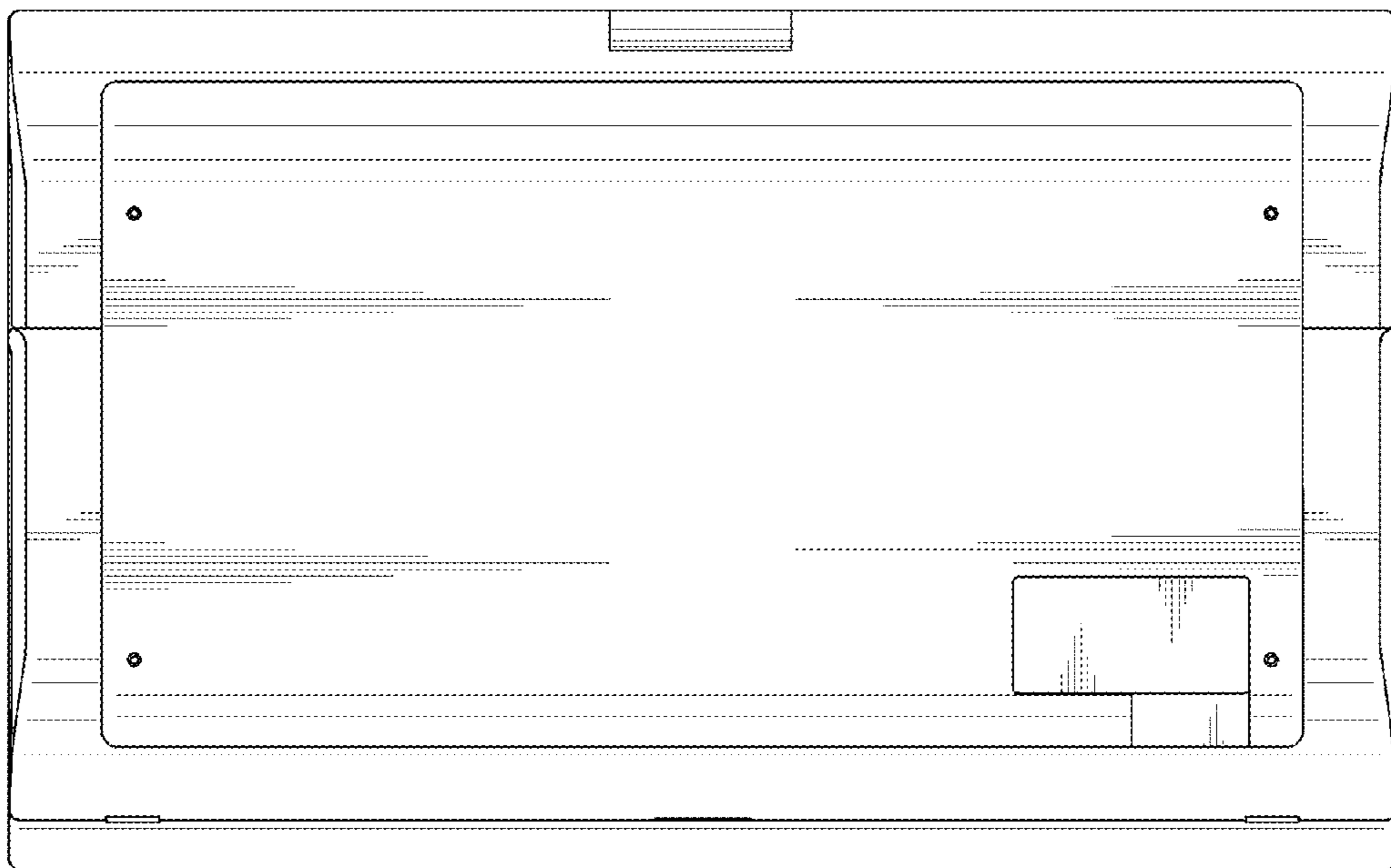

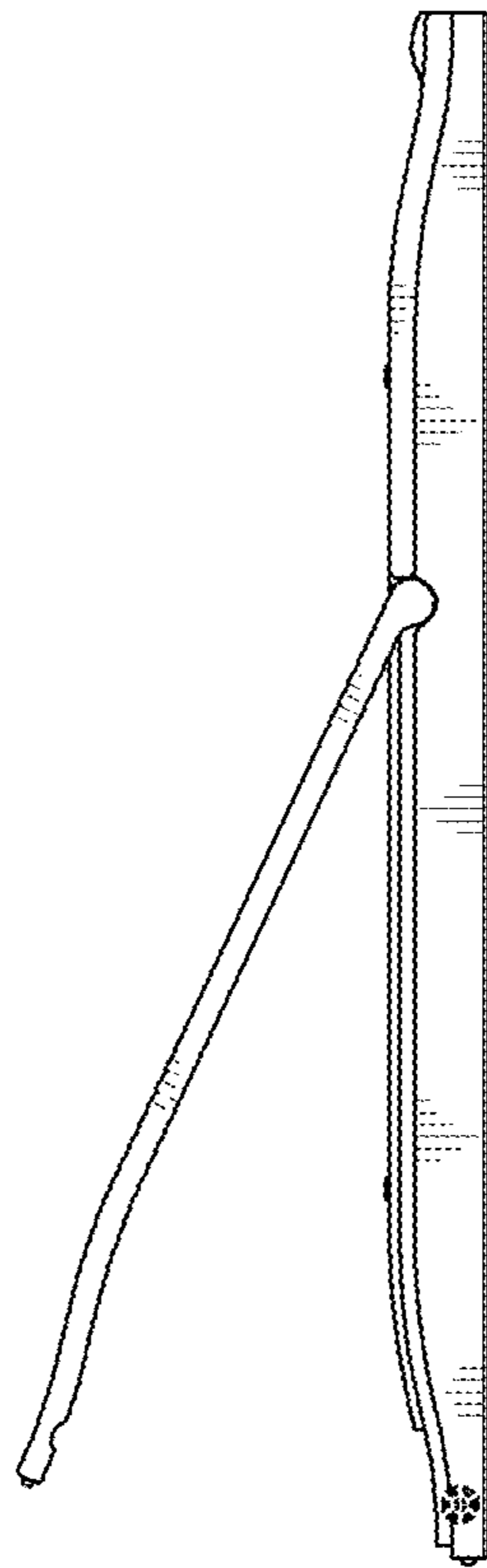

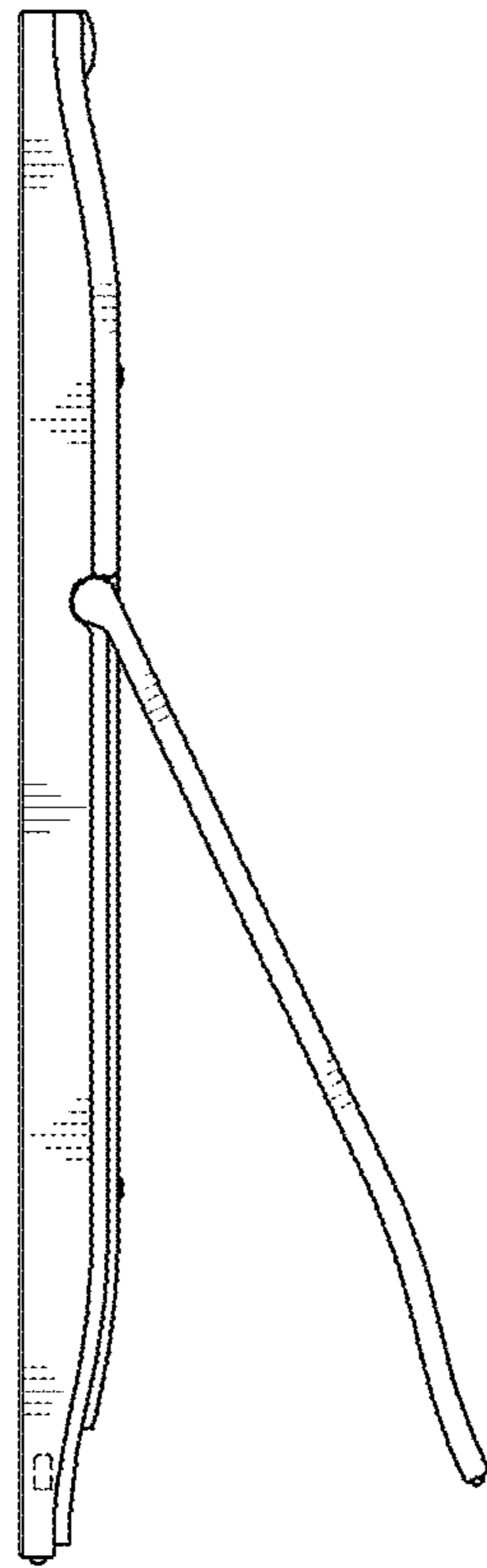

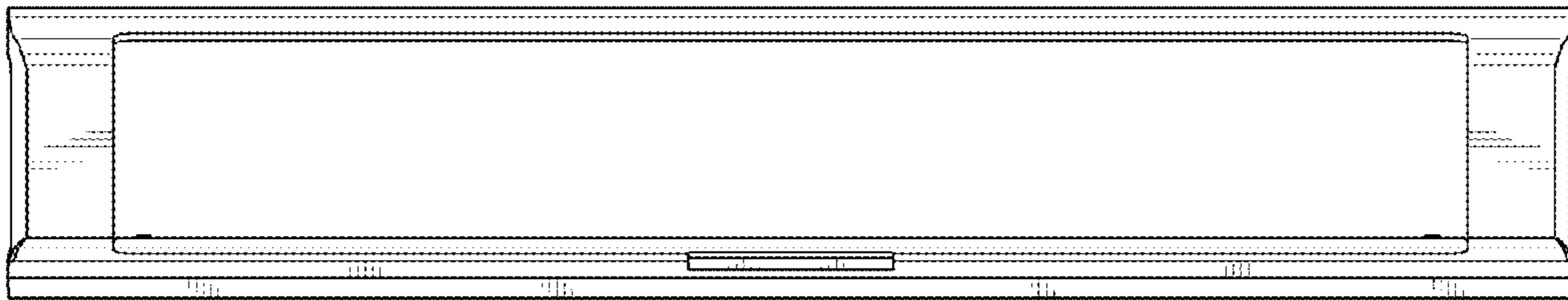

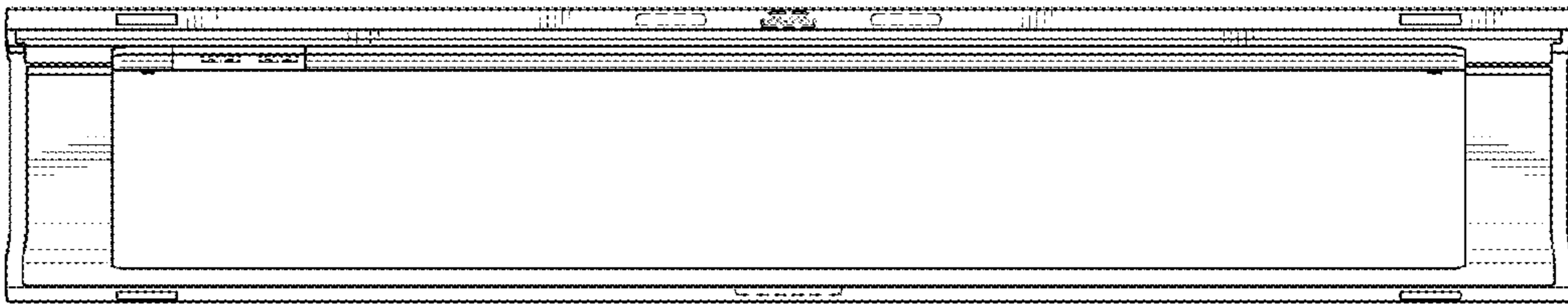
