(57) **CLAIM**

The ornamental design for an electronic device or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

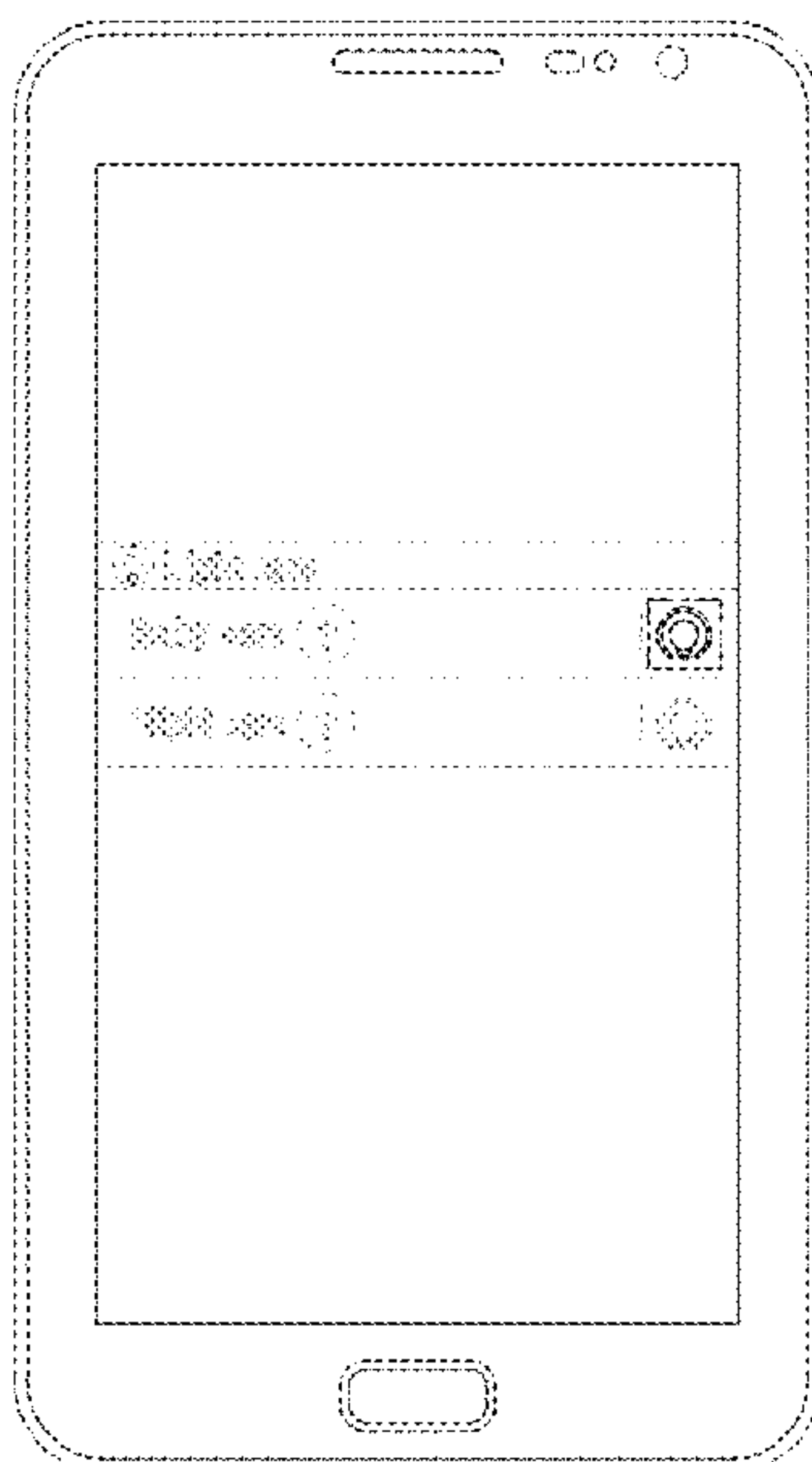

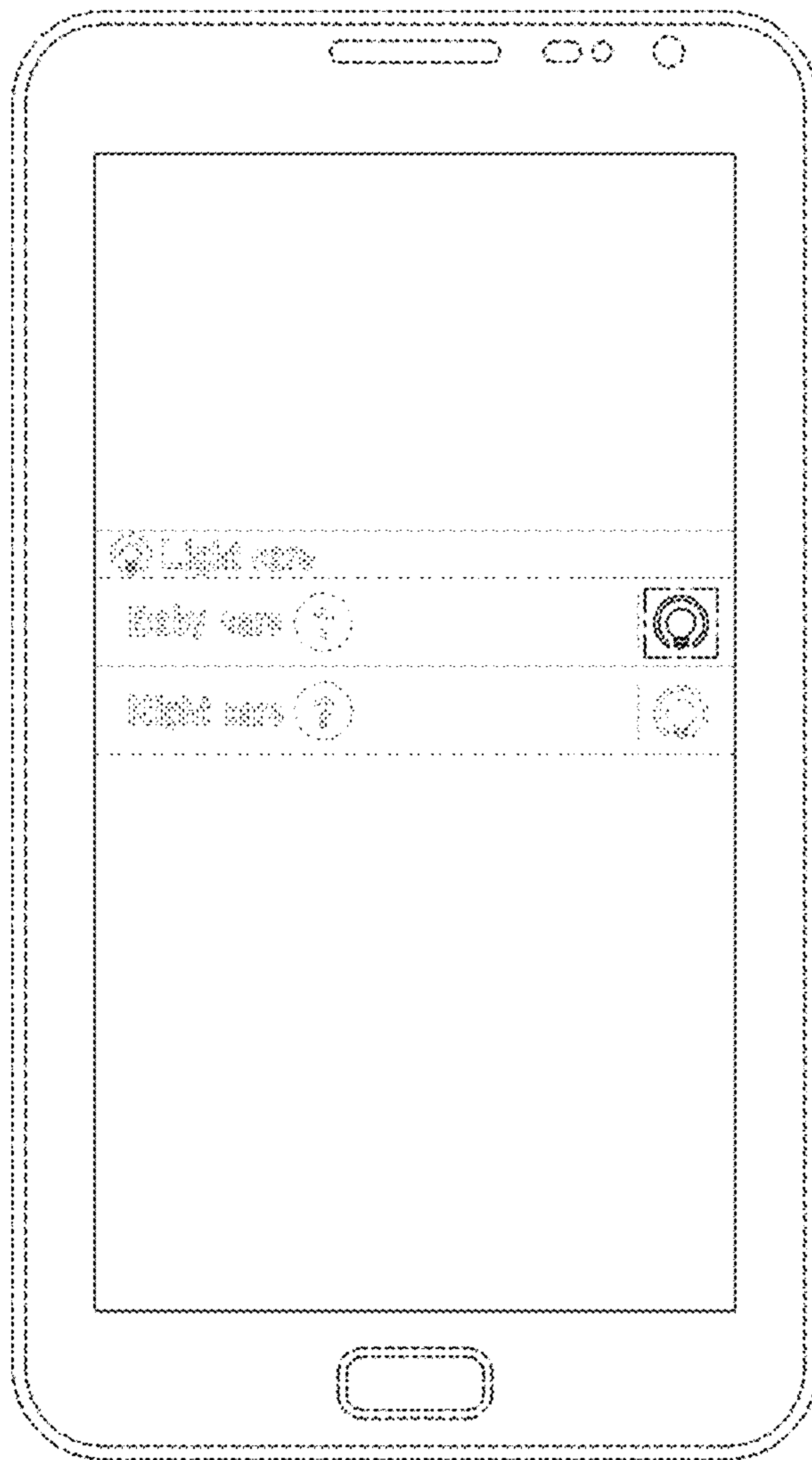
